DESCRIPTION

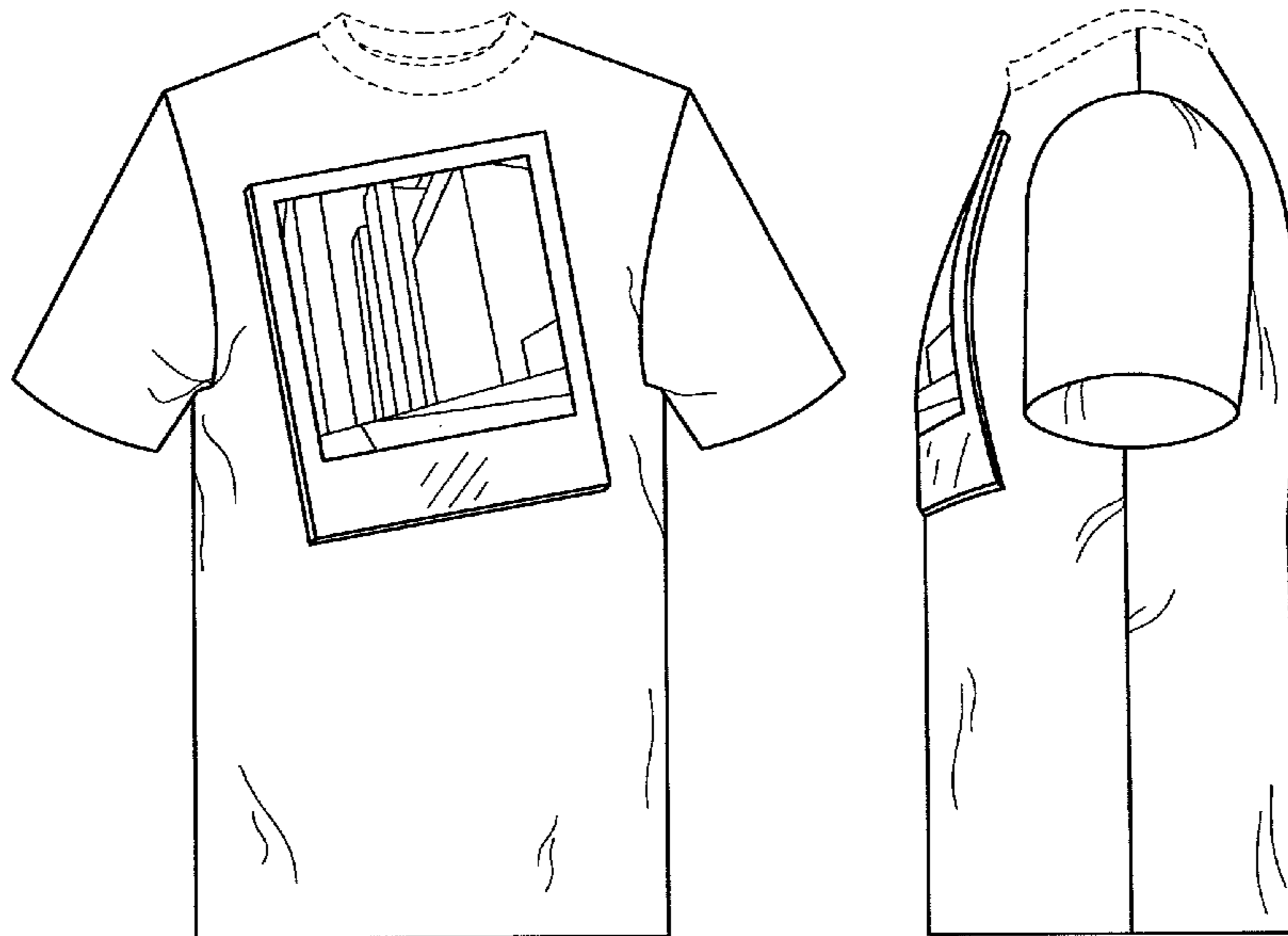
FIG. 1 is a front view of an shirt with image of instant photograph showing my new design;

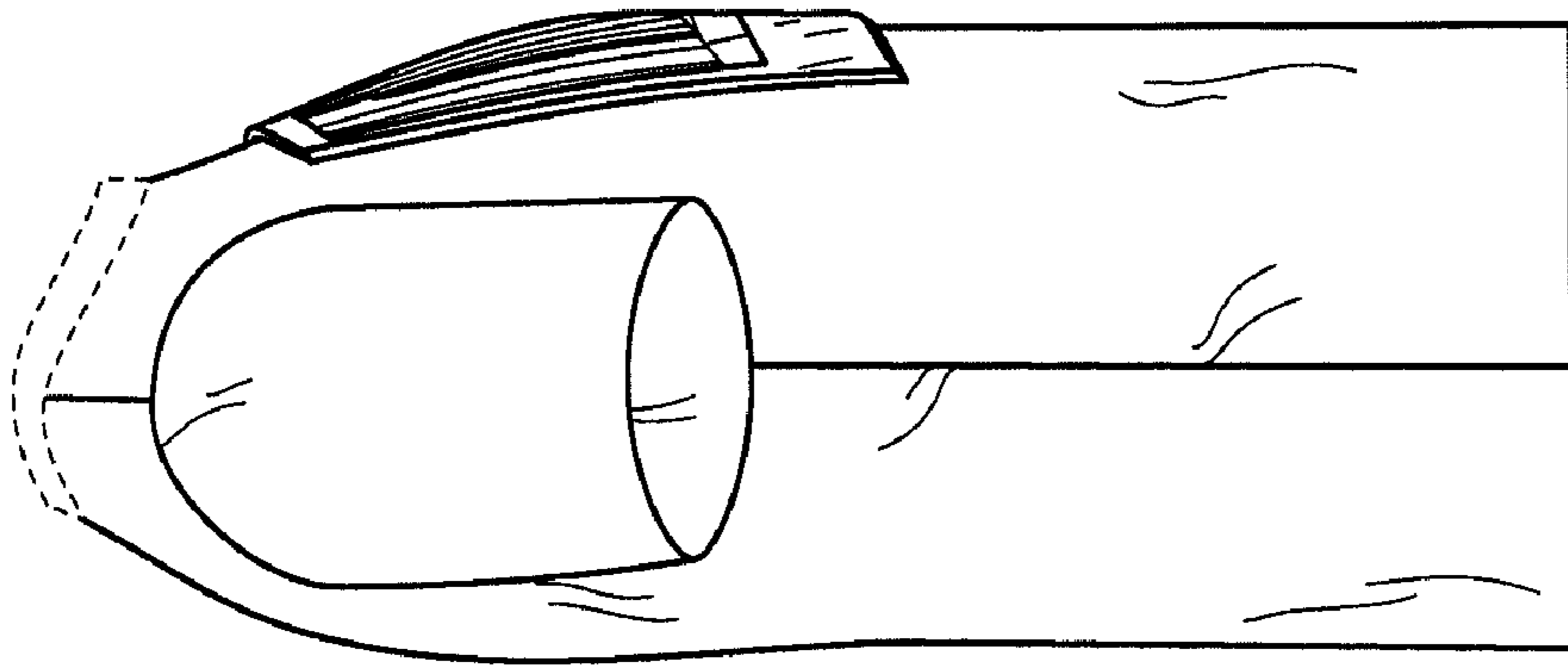

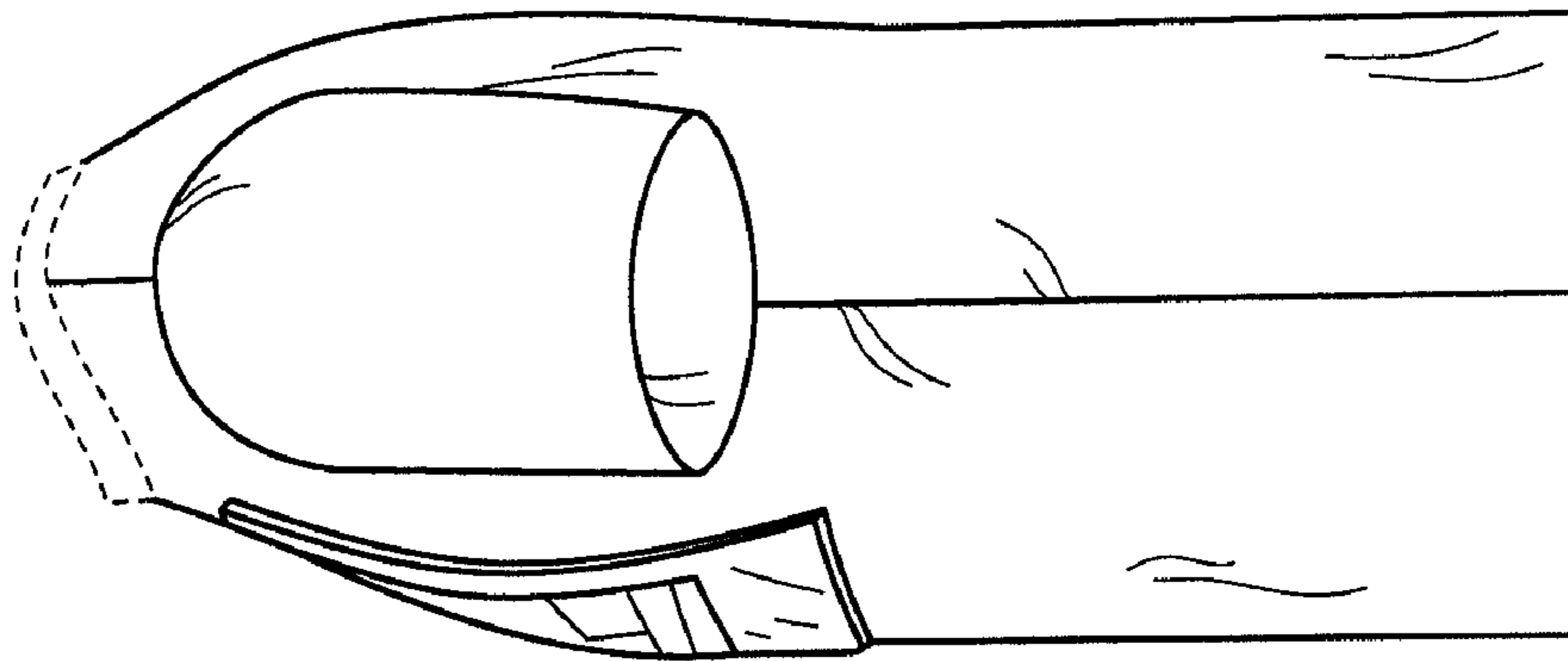

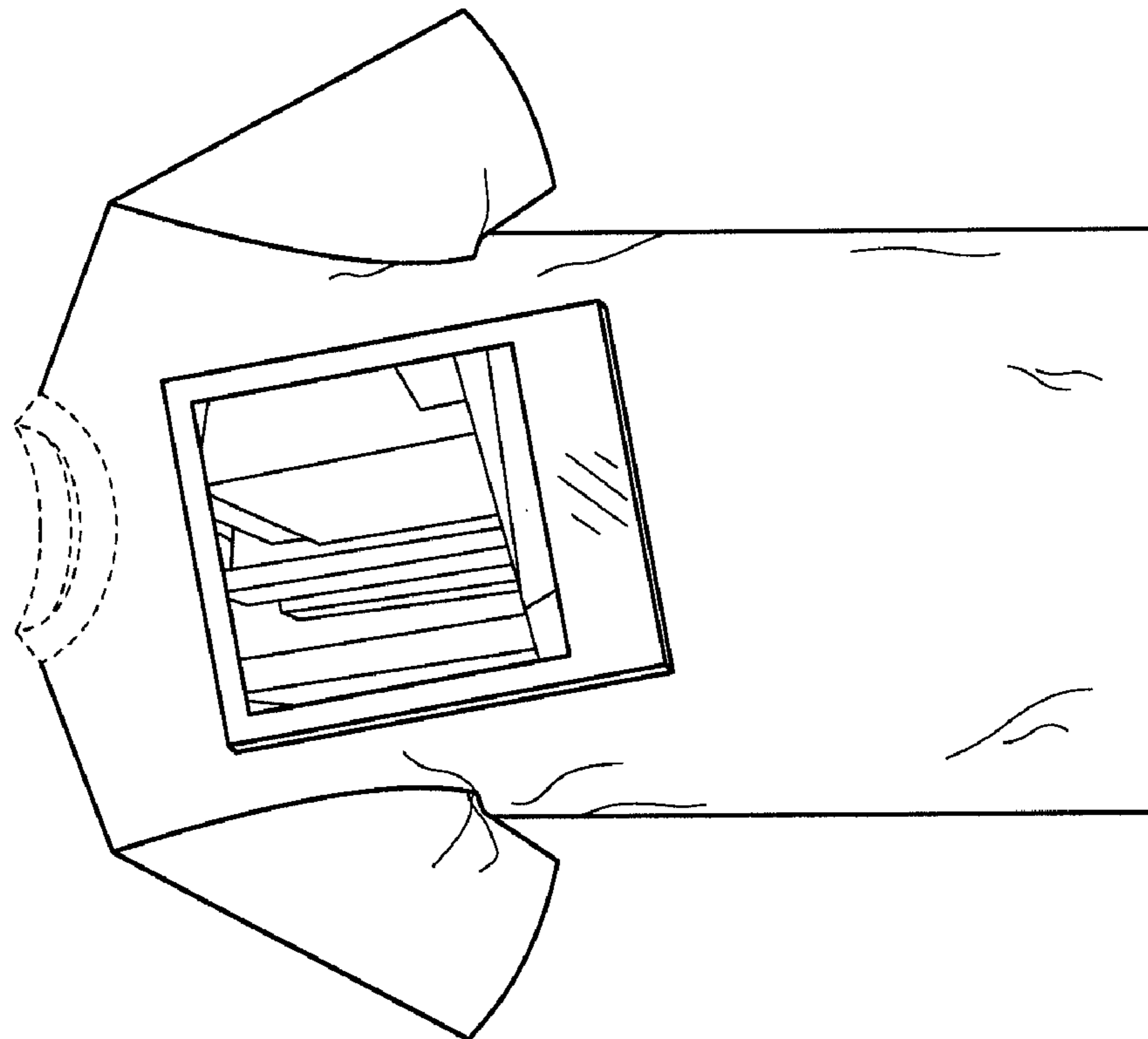
