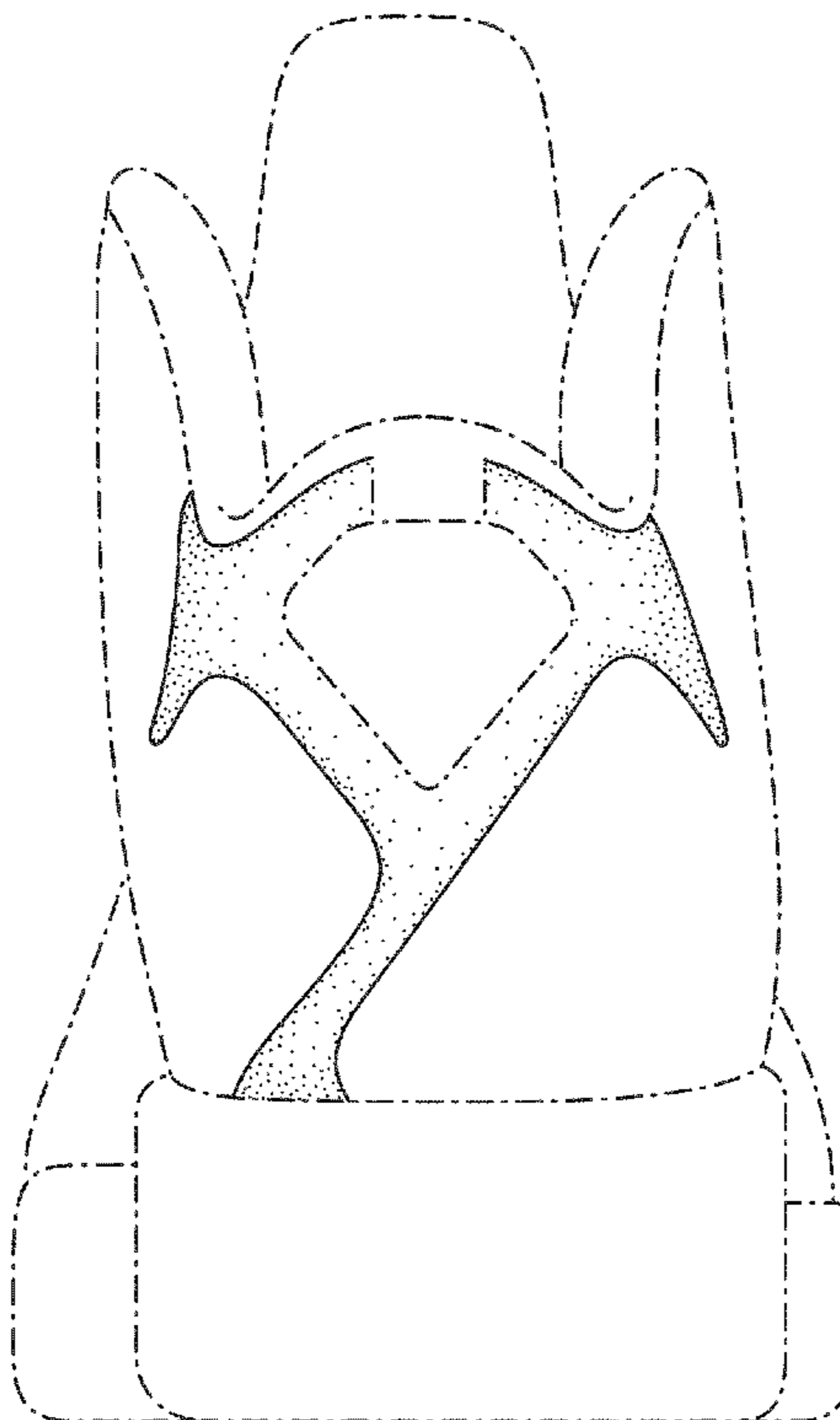
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of a shoe showing my new design; and, FIG. 2 is a rear perspective view thereof. The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. 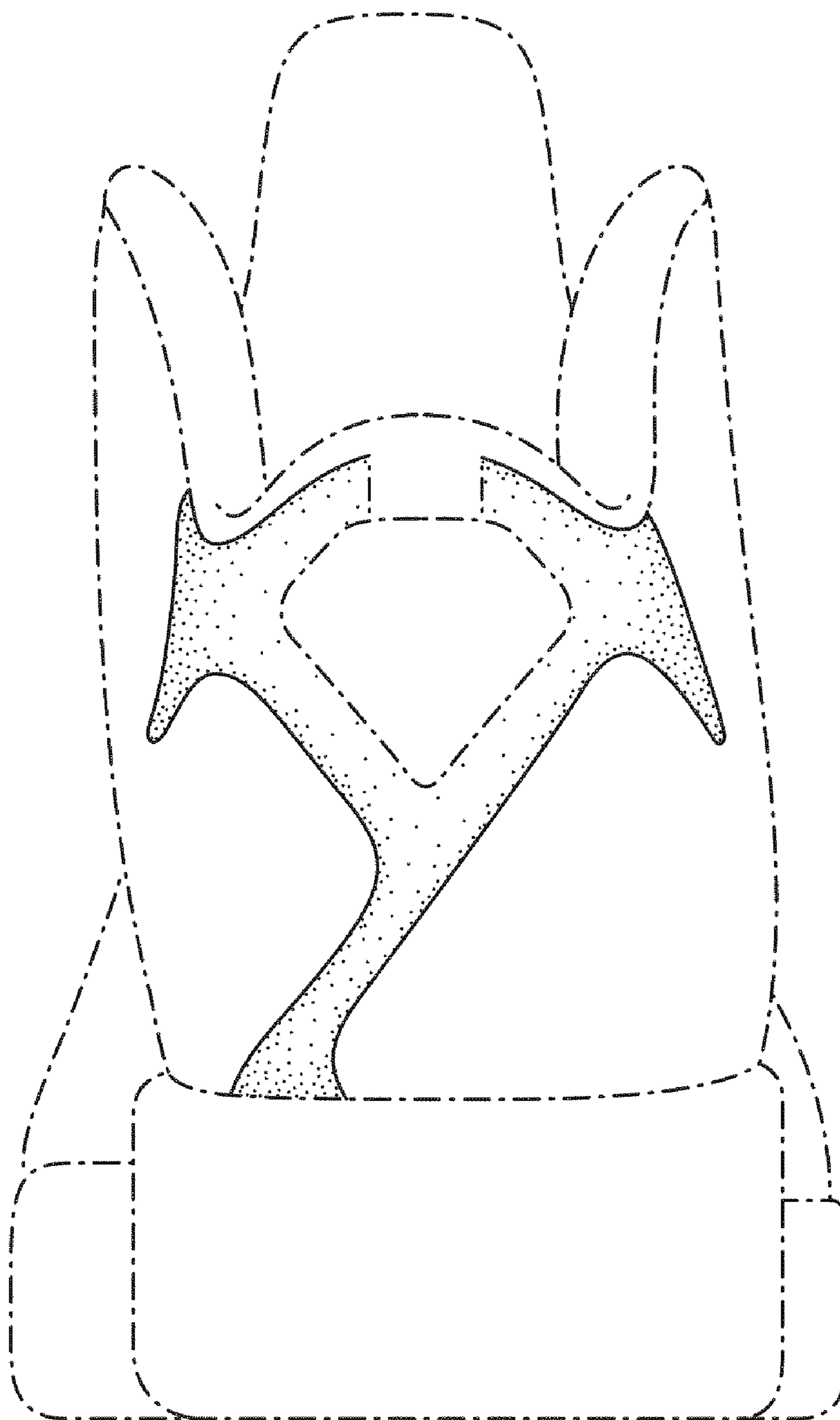

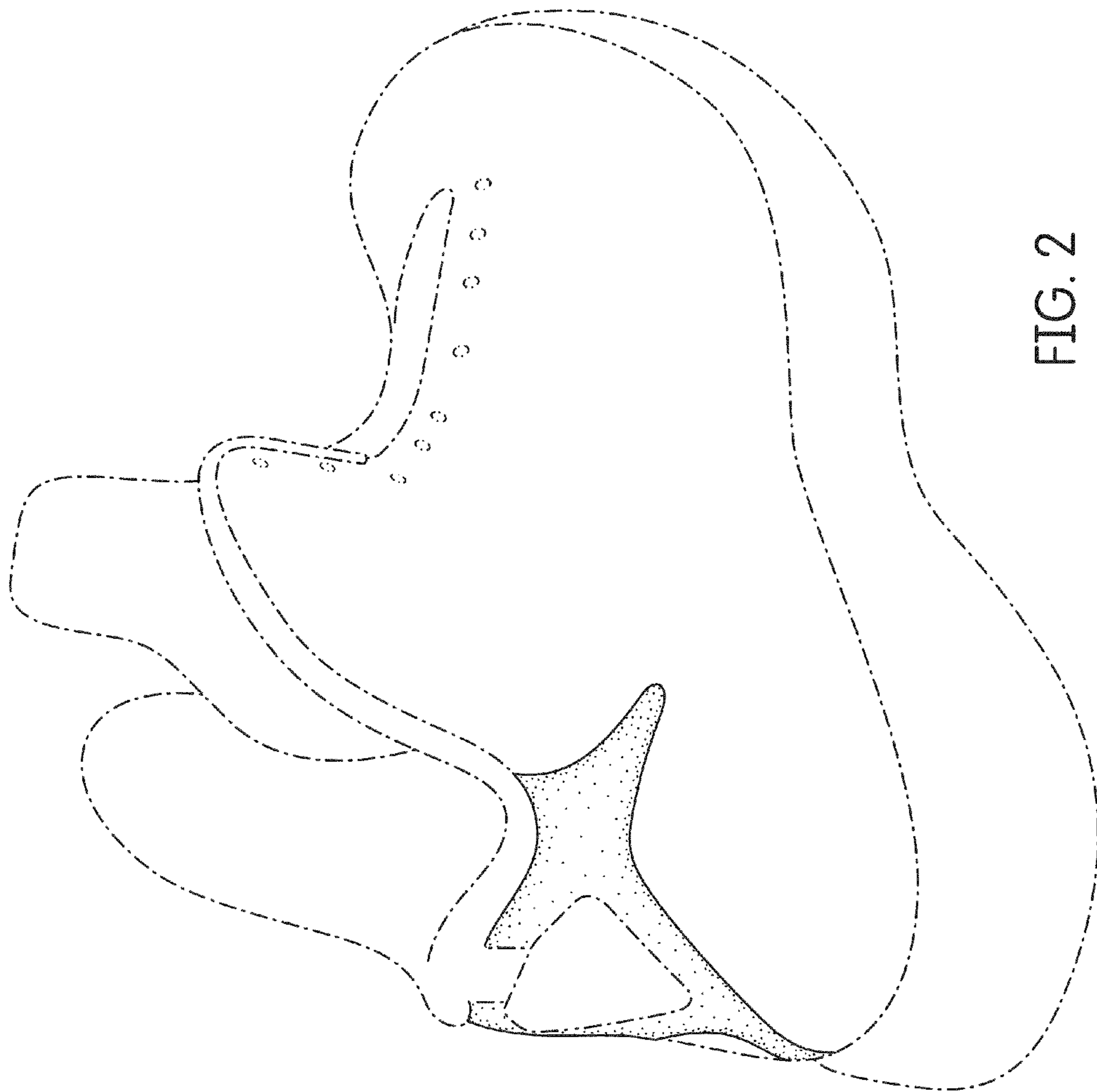
