The ornamental design for the assembly of sock components, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a first embodiment of an assembly of sock components showing my new design;

FIG. 2 is a rear, bottom and right side perspective view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a front, top and left side perspective view of a second embodiment of the assembly of sock components;

FIG. 5 is a rear, bottom and right side perspective view thereof; and,

FIG. 6 is a left side view thereof.

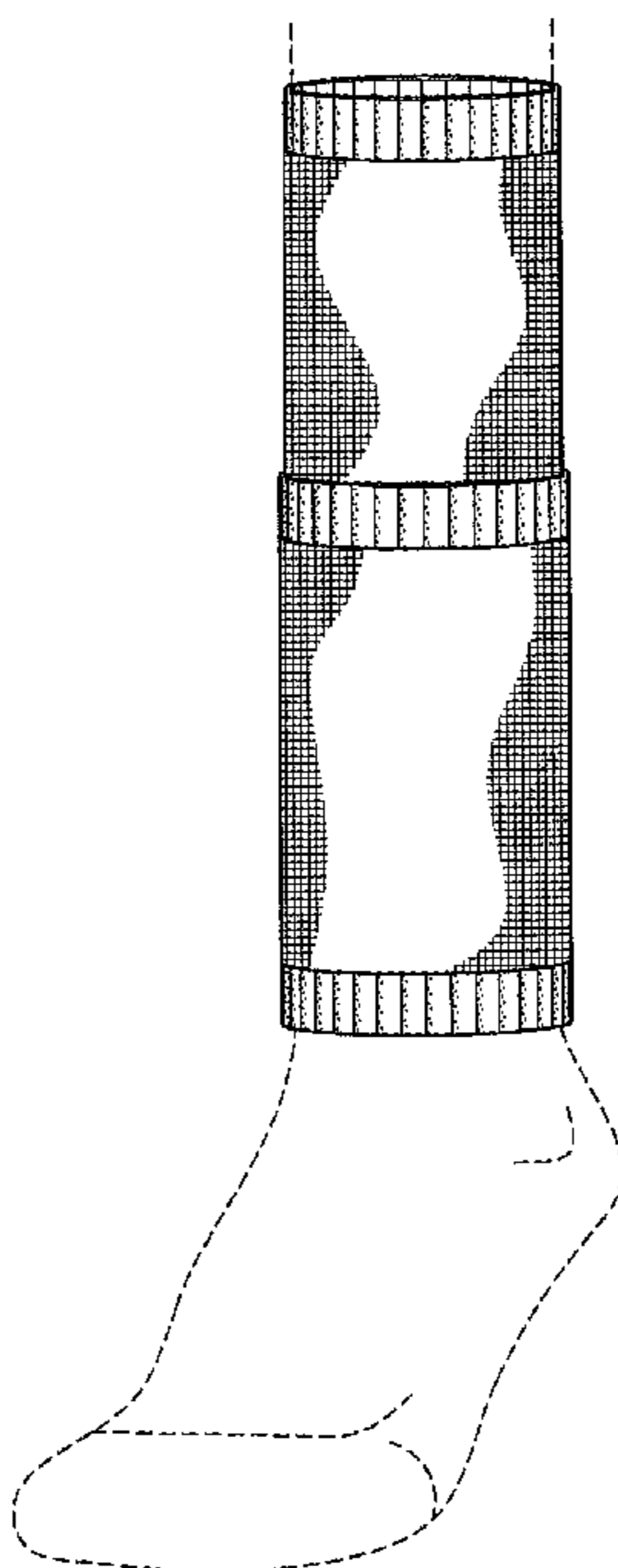

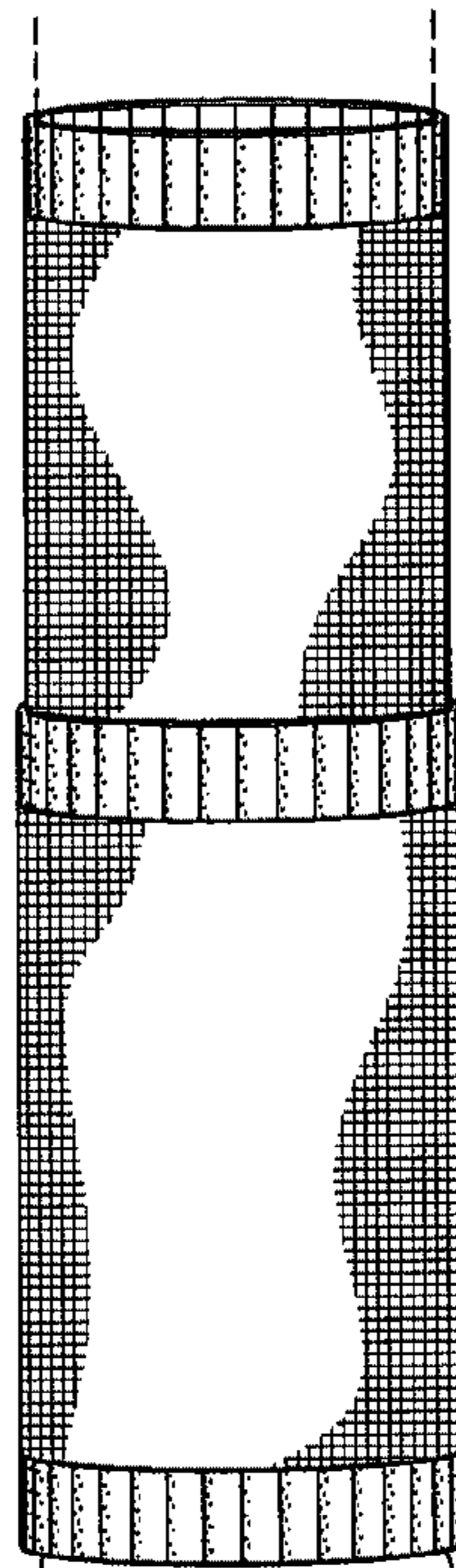

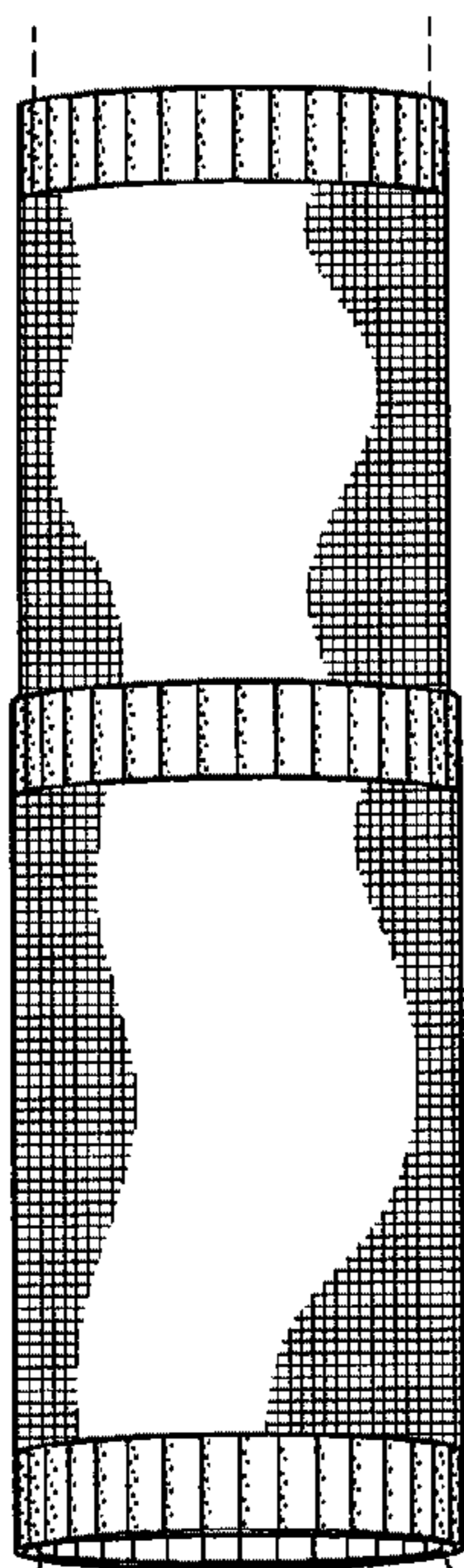

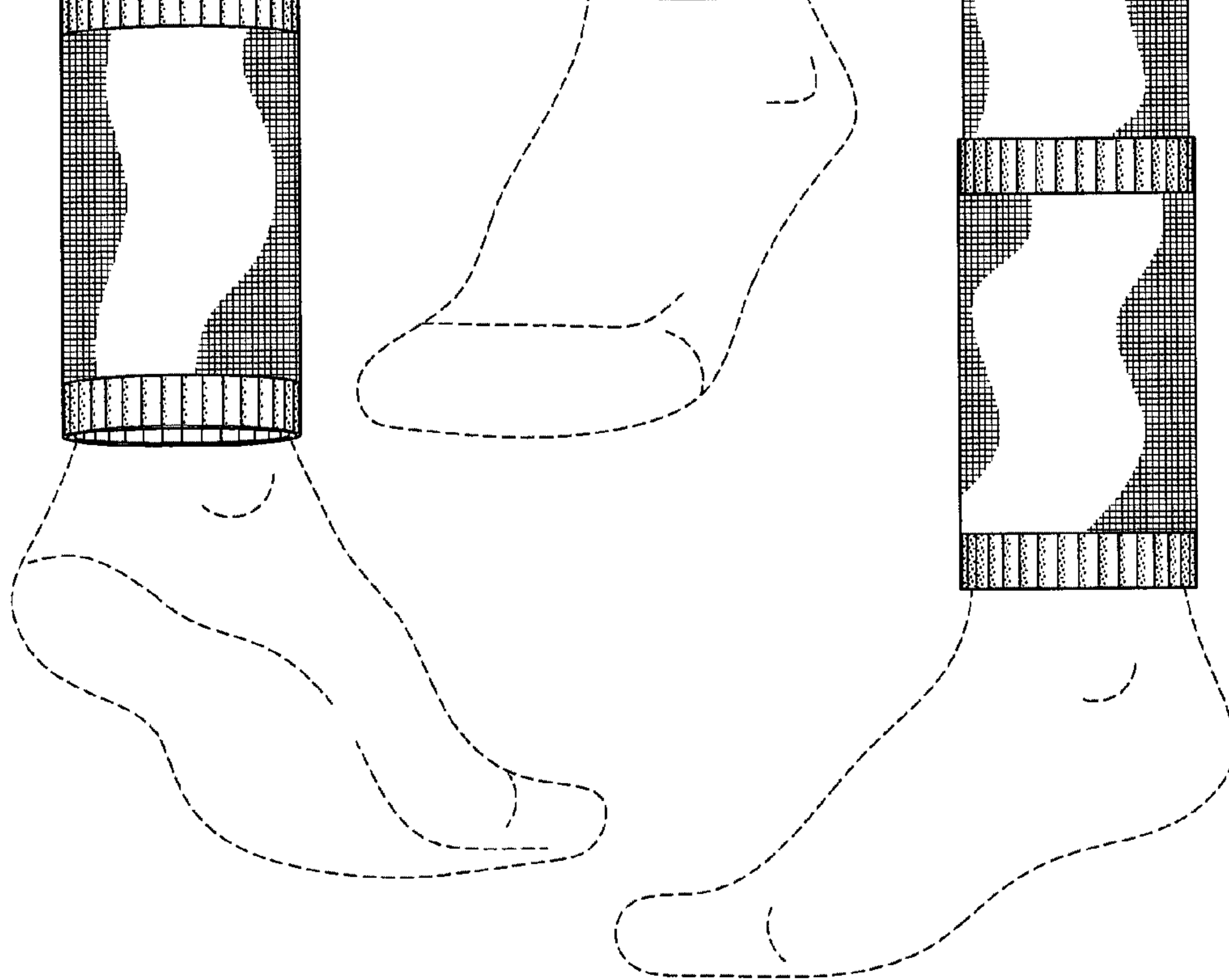
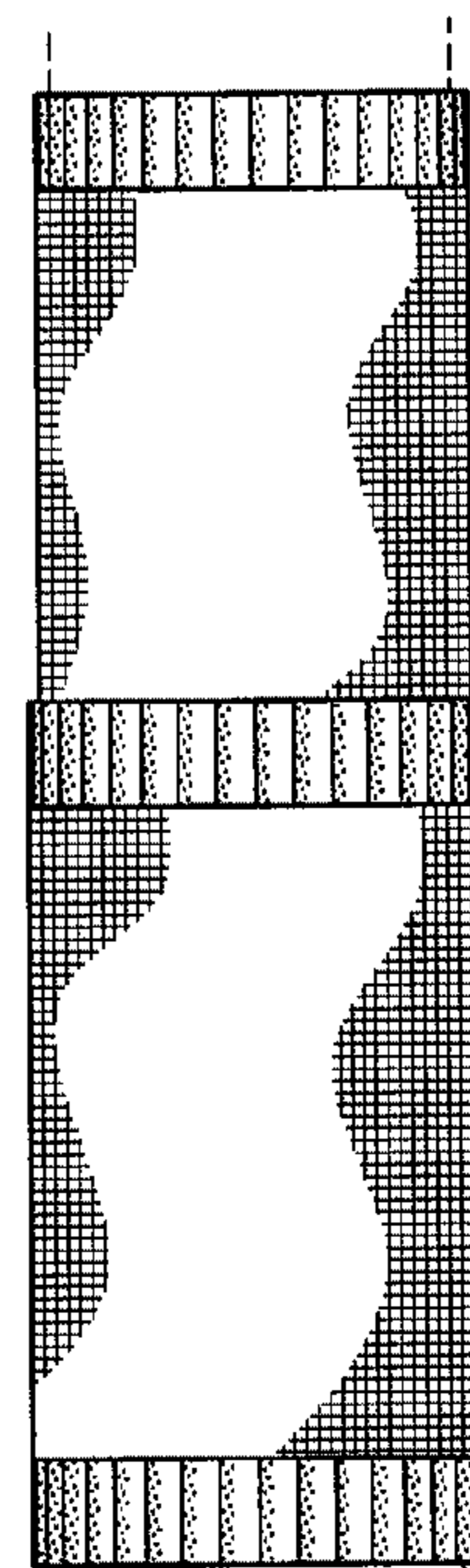

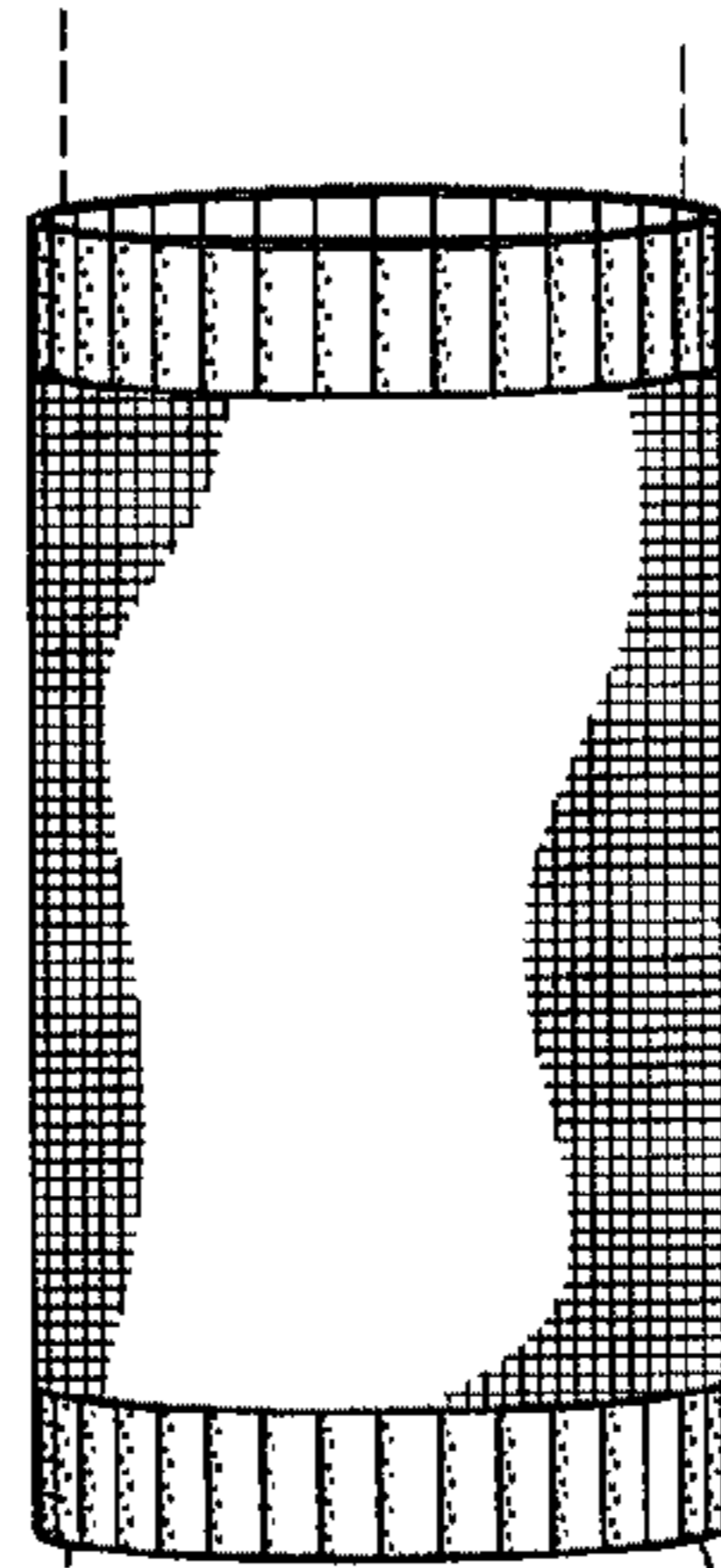

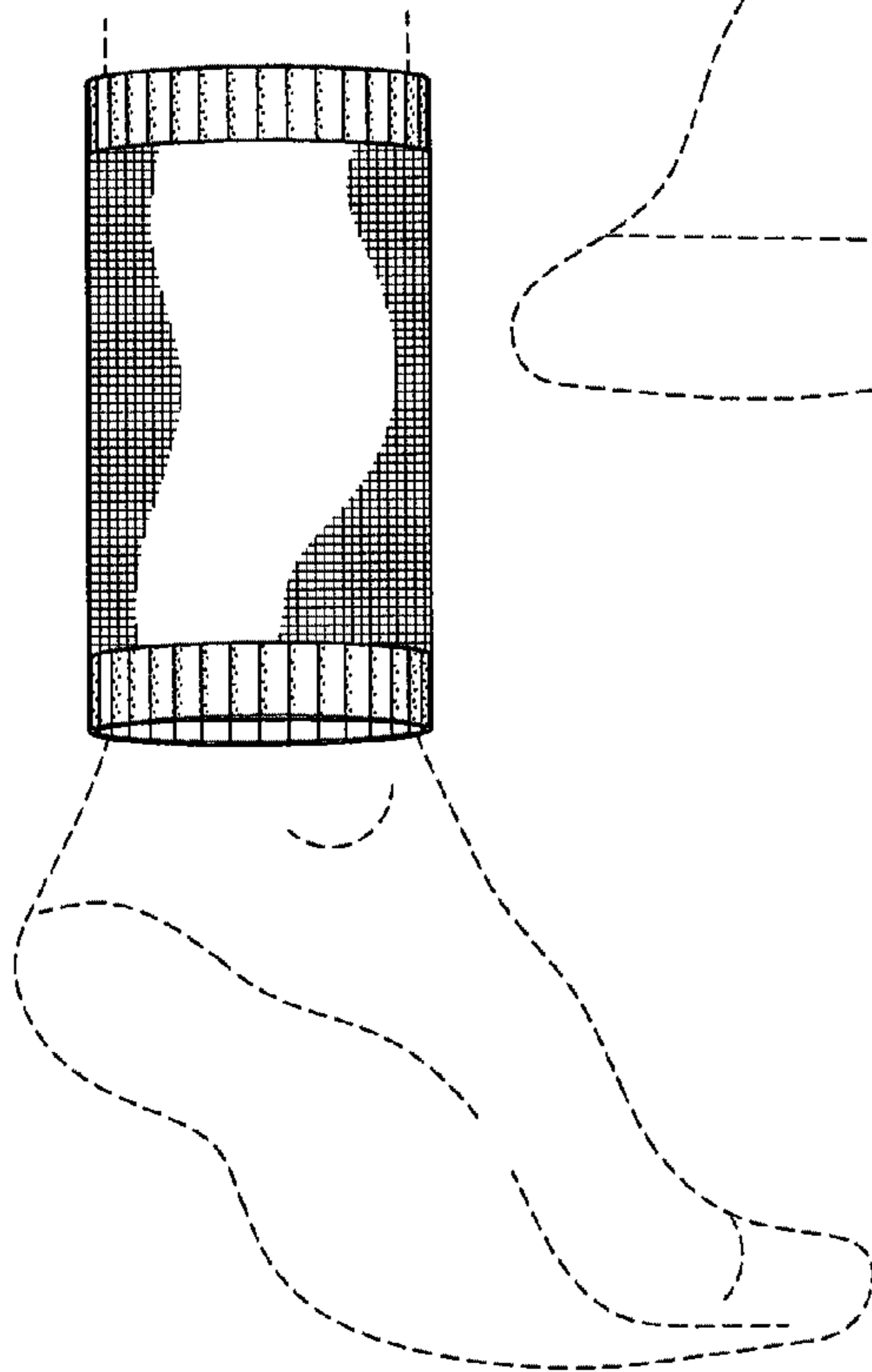
