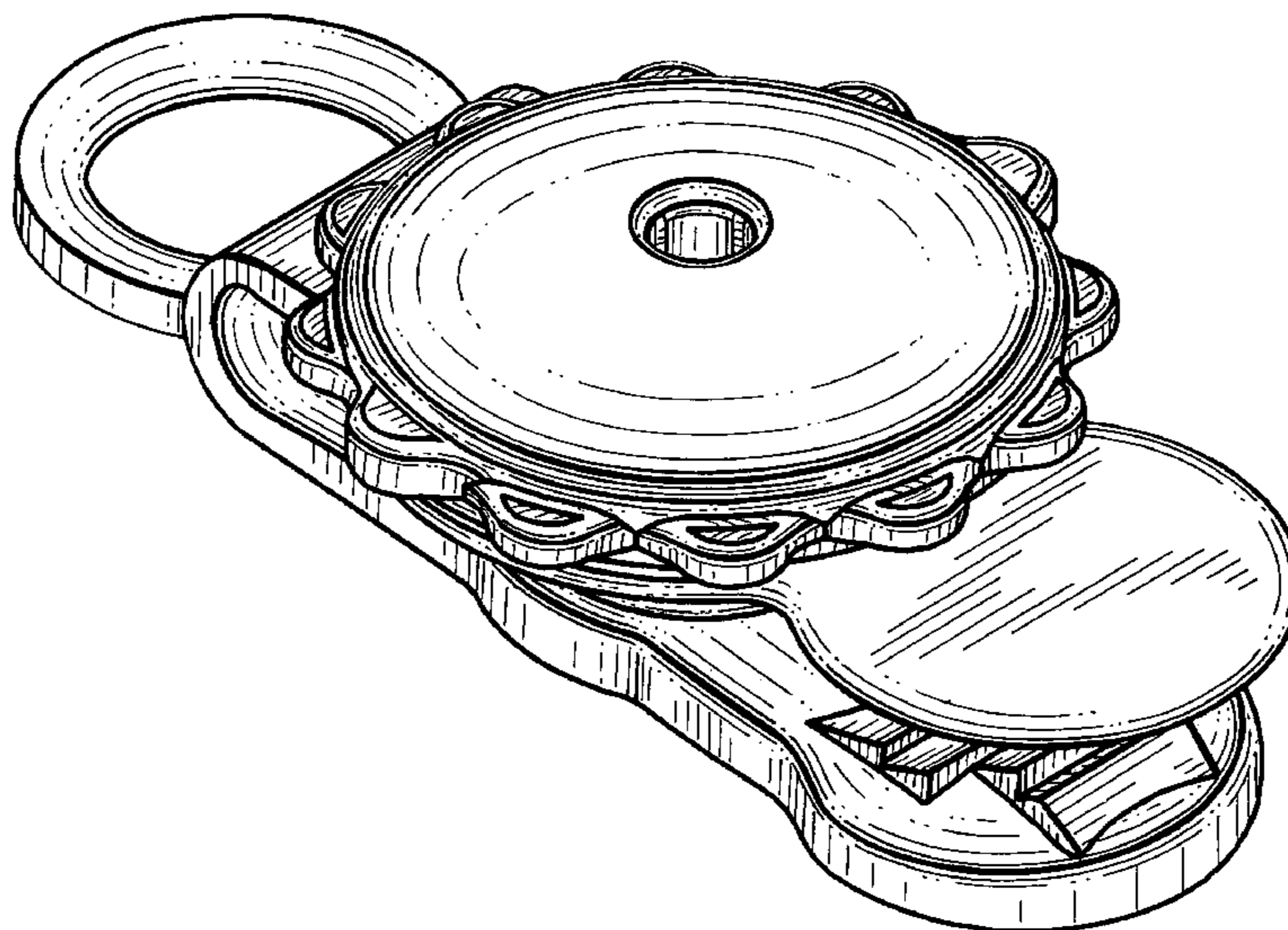
(57) **CLAIM**

The ornamental design for a twist clip, as shown and described.

DESCRIPTION

FIG. 1 is a top front and left side perspective view of the twist clip showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a bottom, rear and left side perspective view thereof.

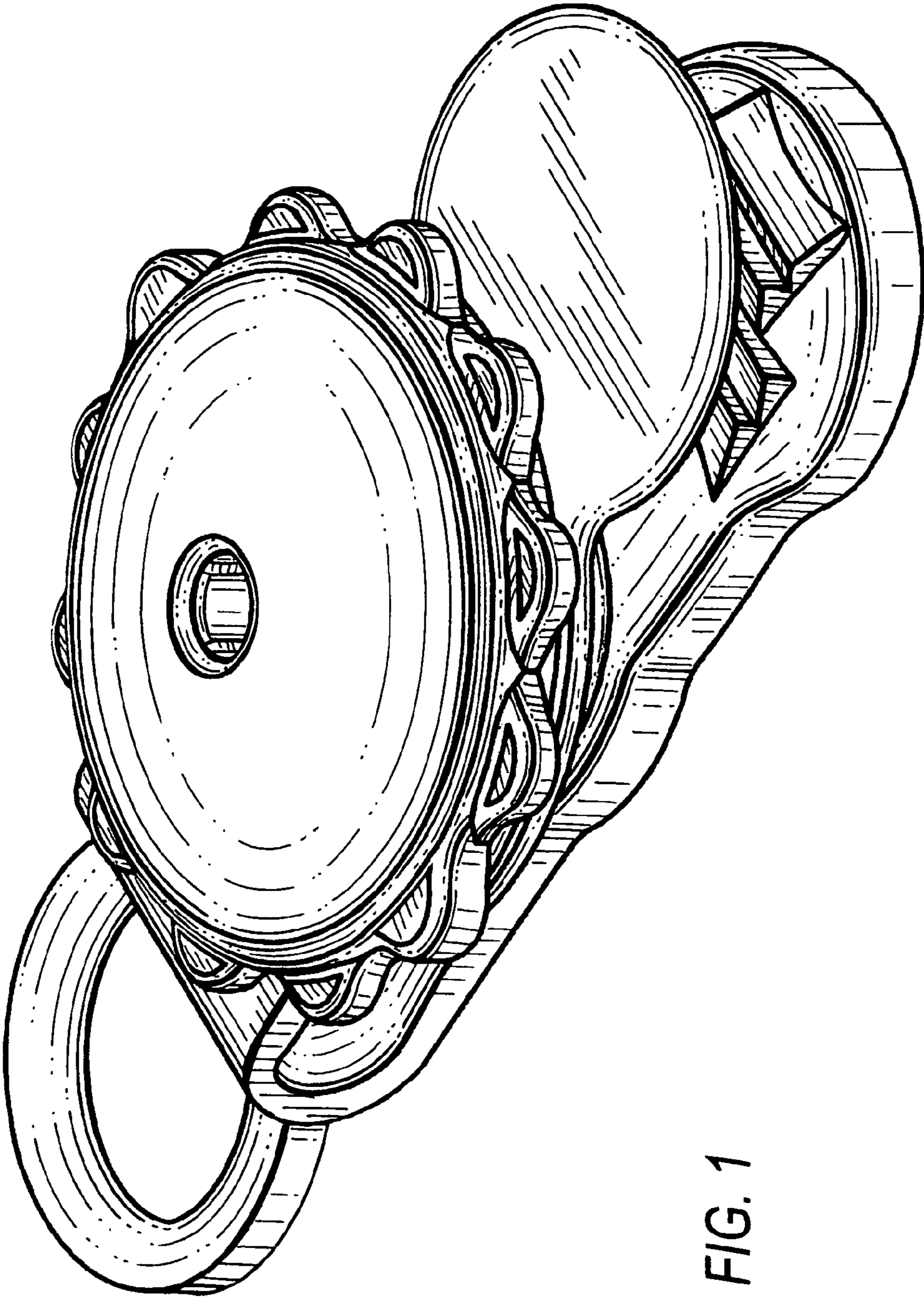

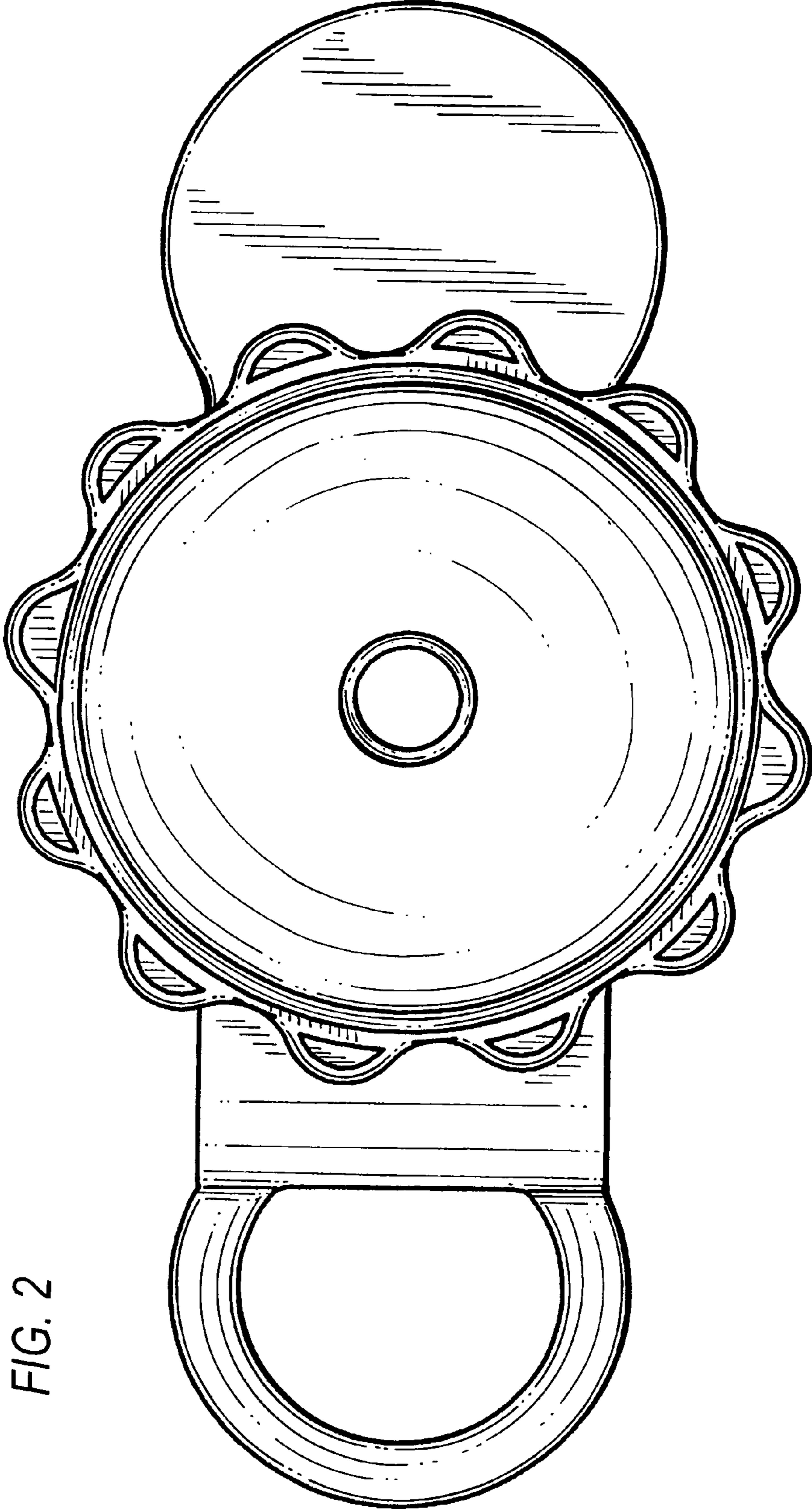

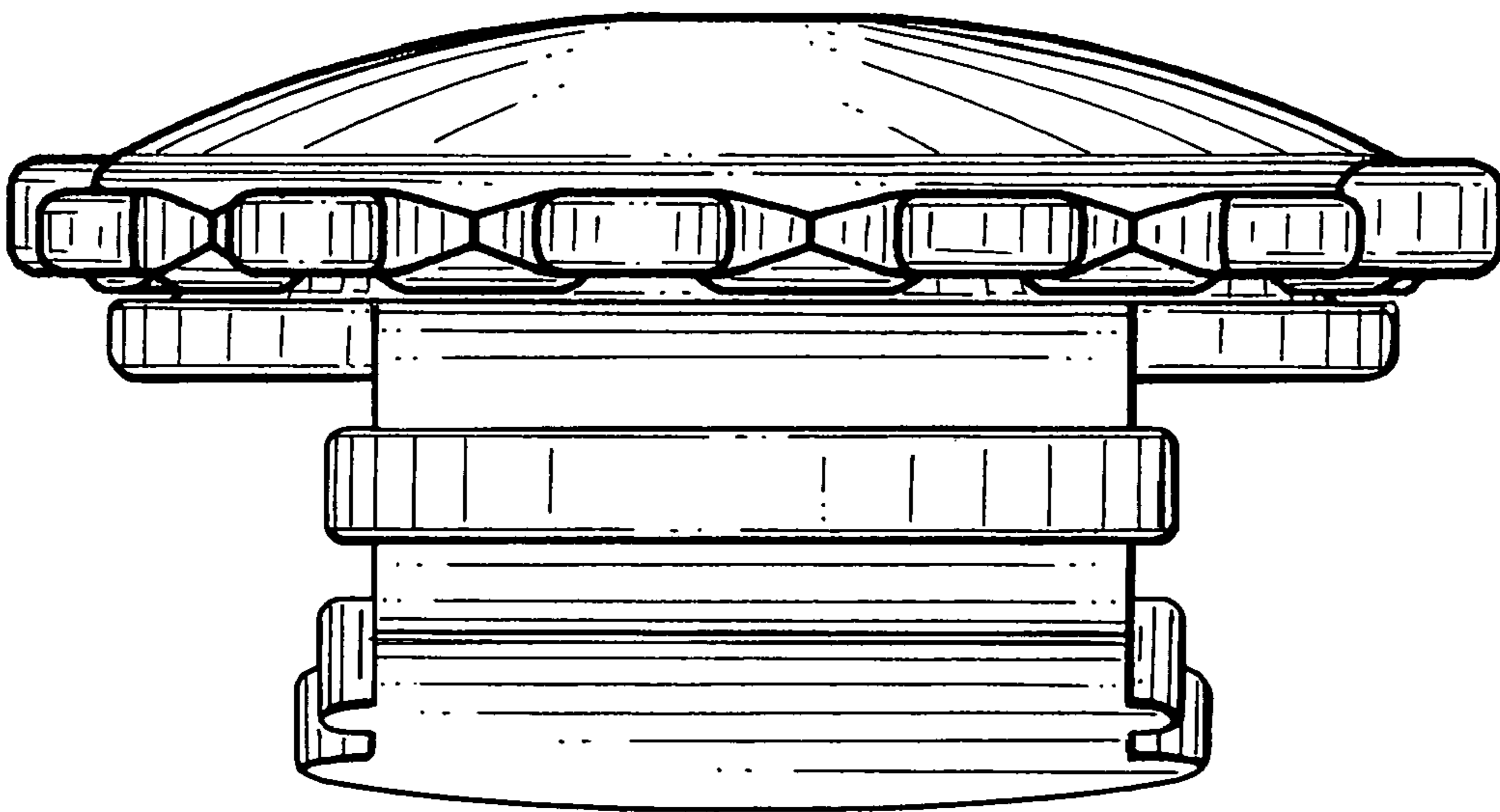
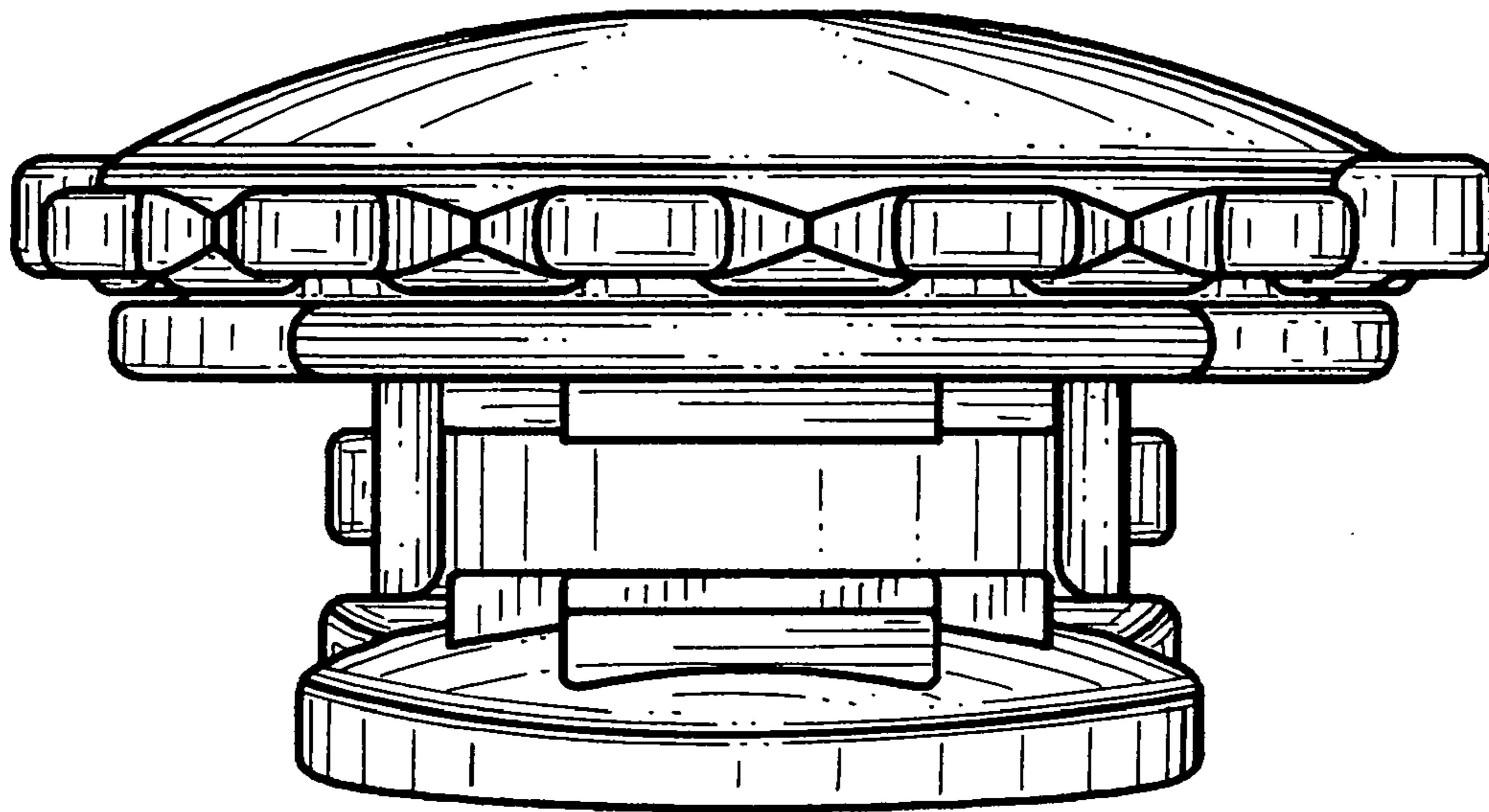

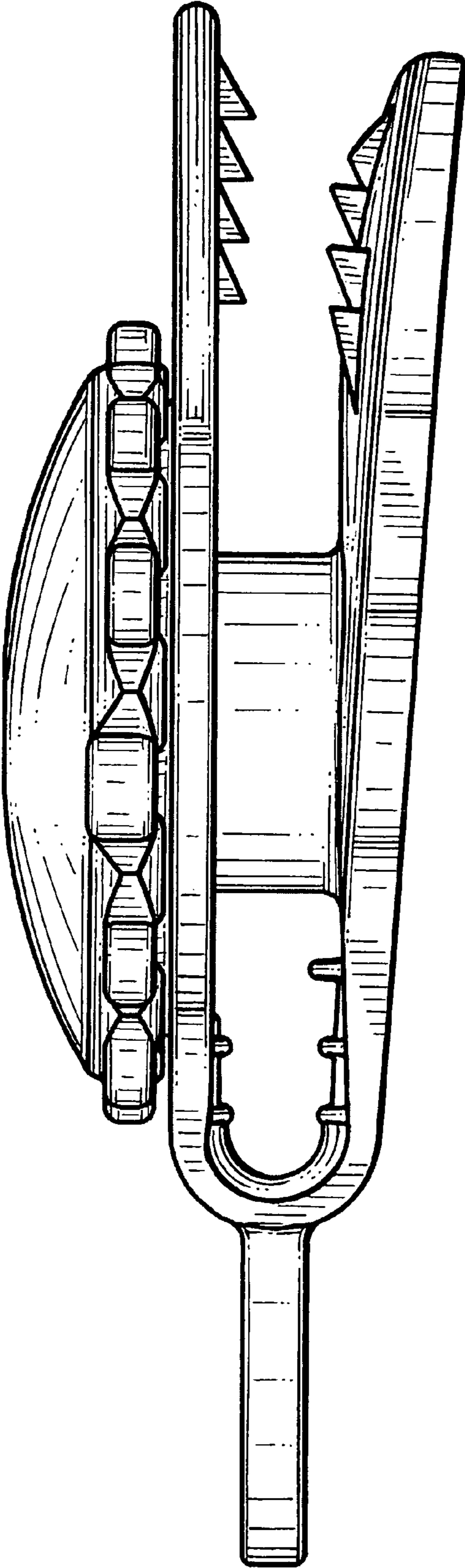

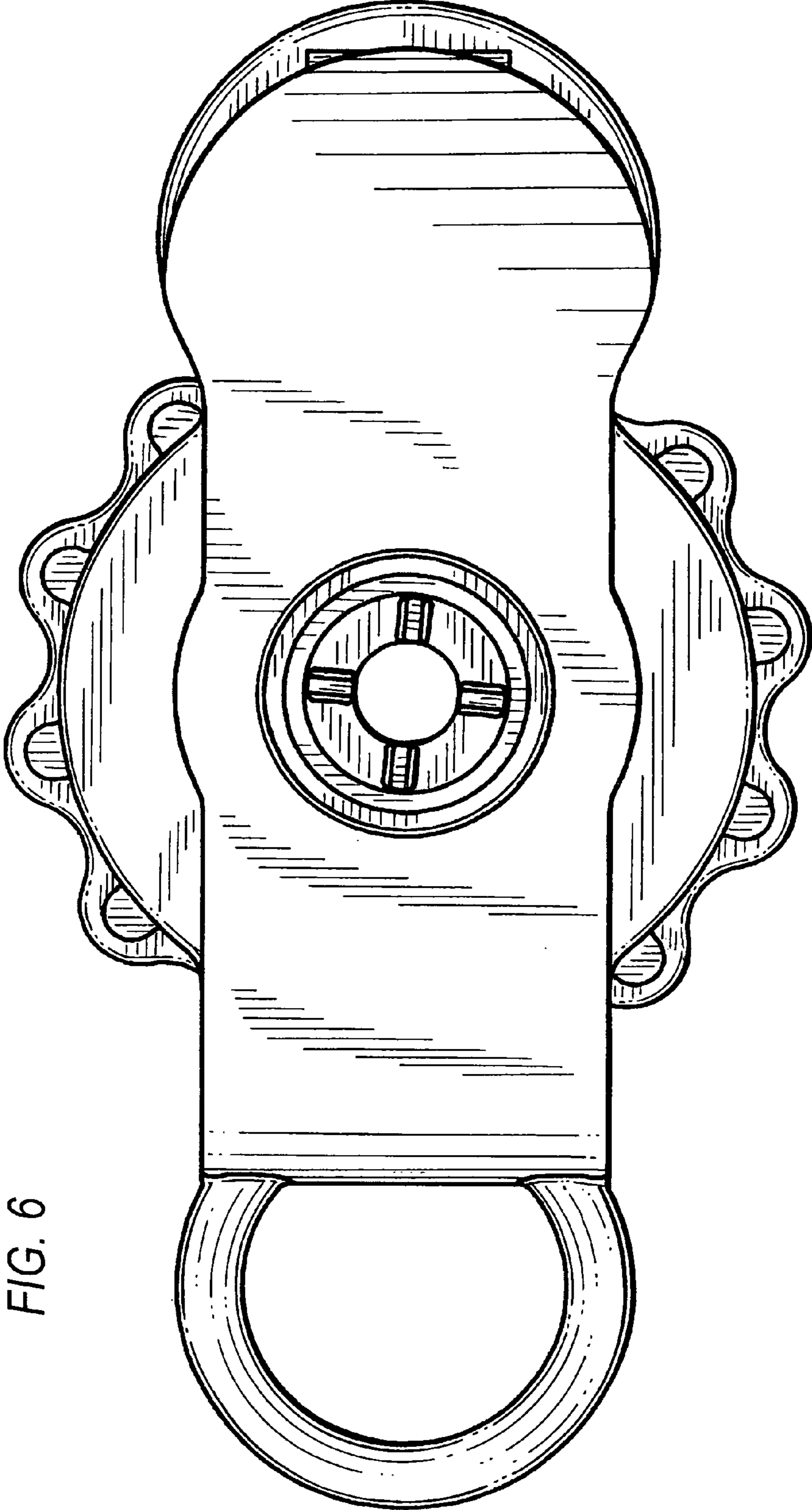

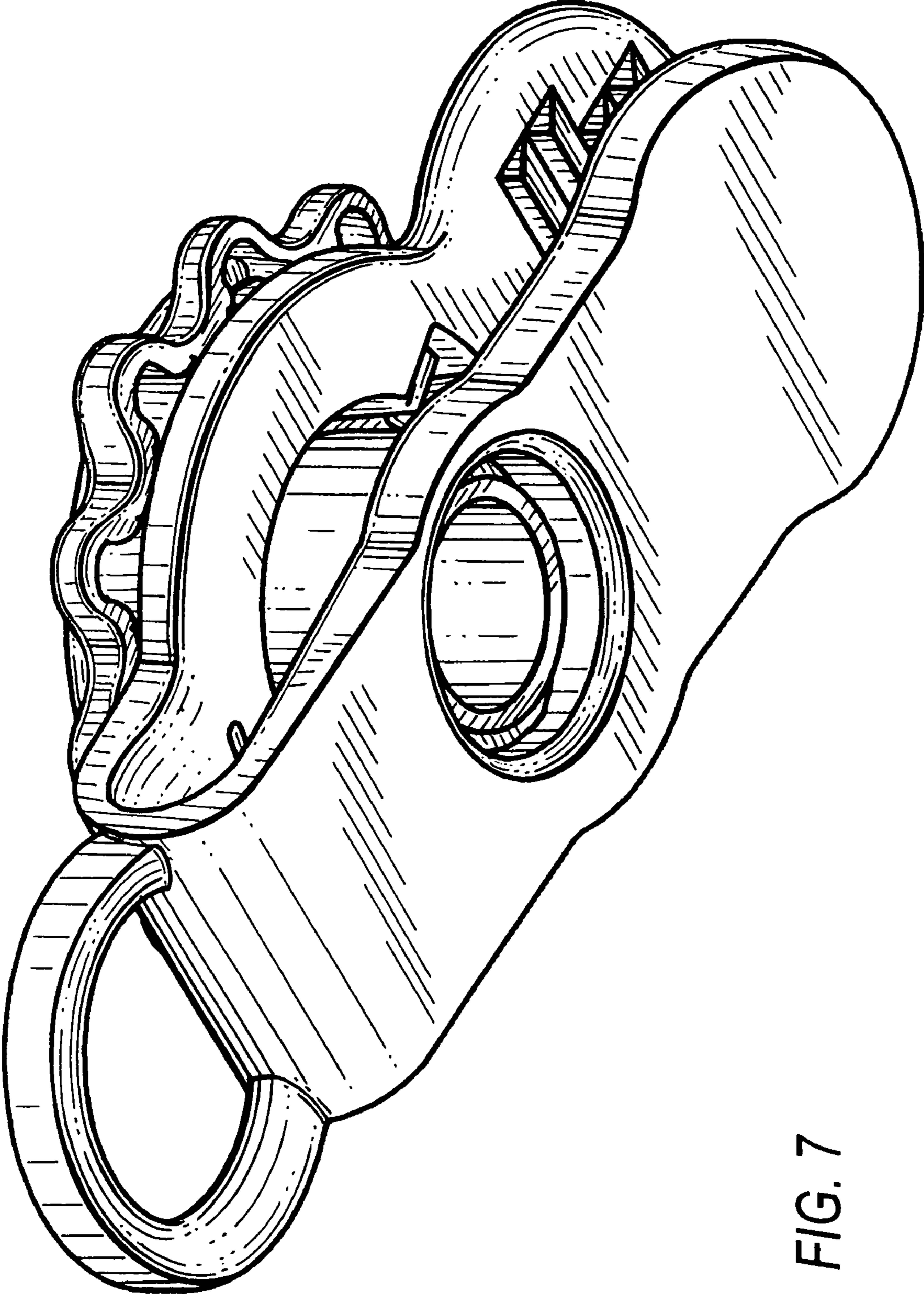
