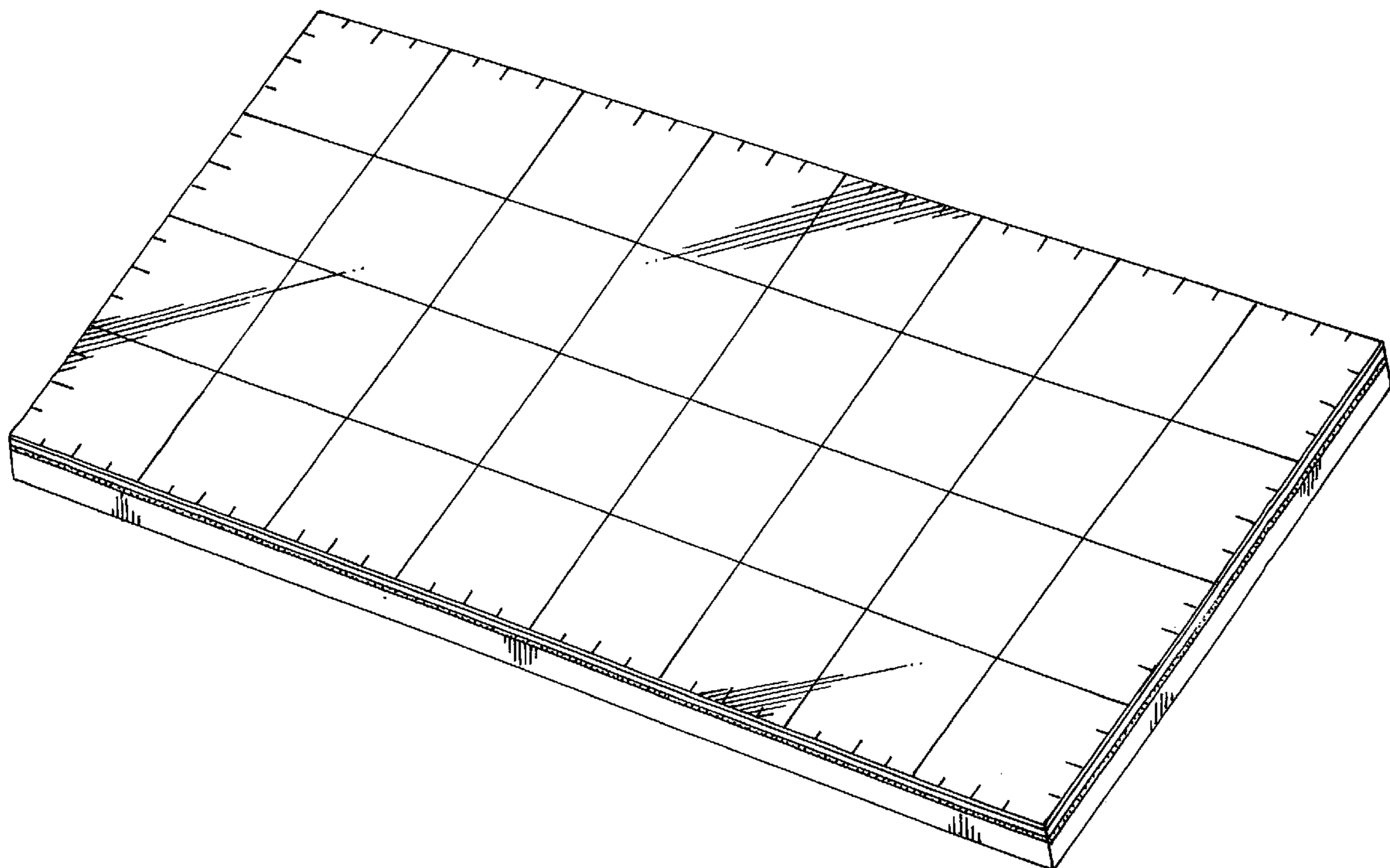
(57) **CLAIM**

The ornamental design for a window and countertop protection board, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a window and countertop protection board showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevational view thereof, the rear being the same in appearance; and,  
FIG. 5 is a right side elevational view thereof, the opposite side being the same in appearance.

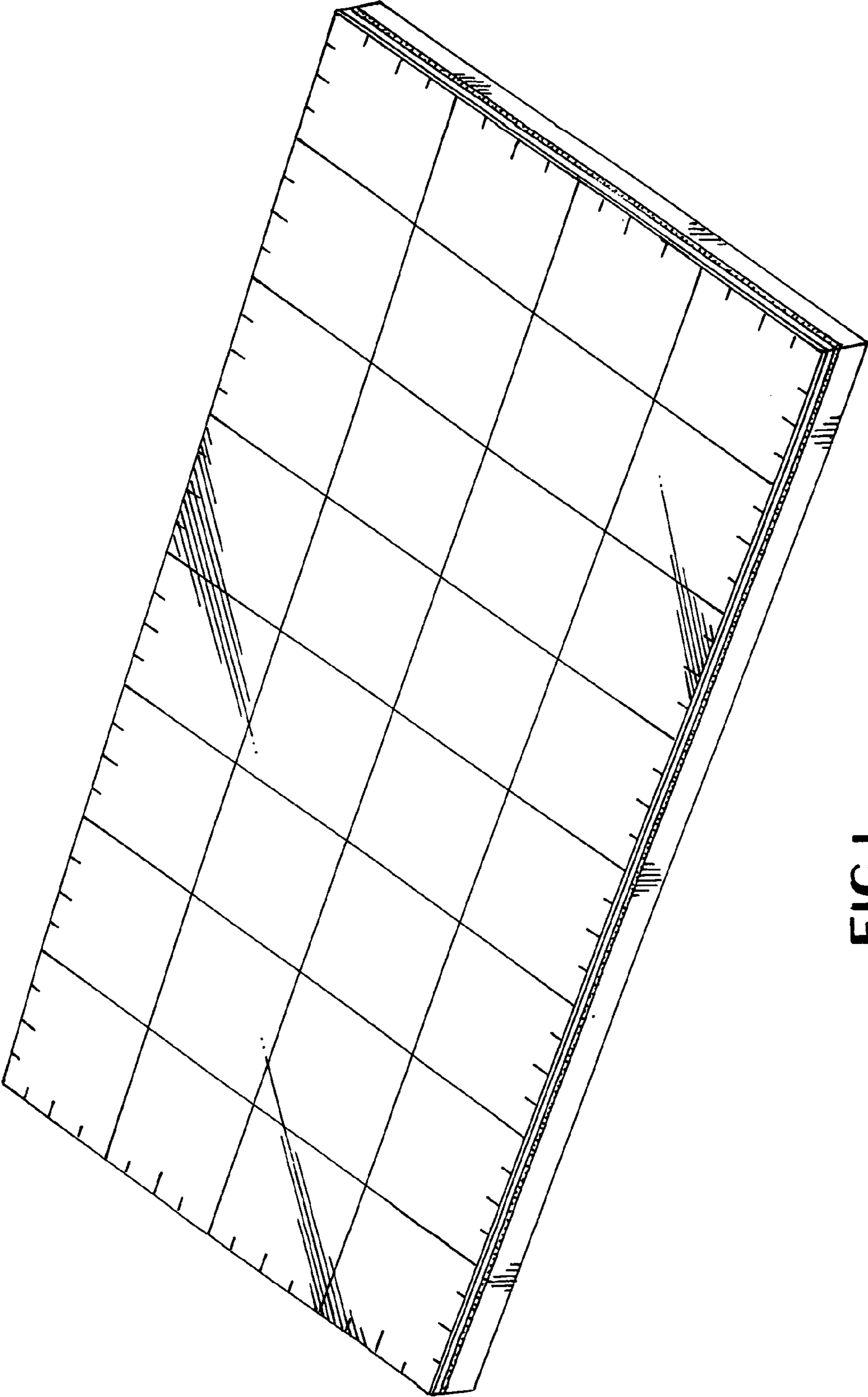

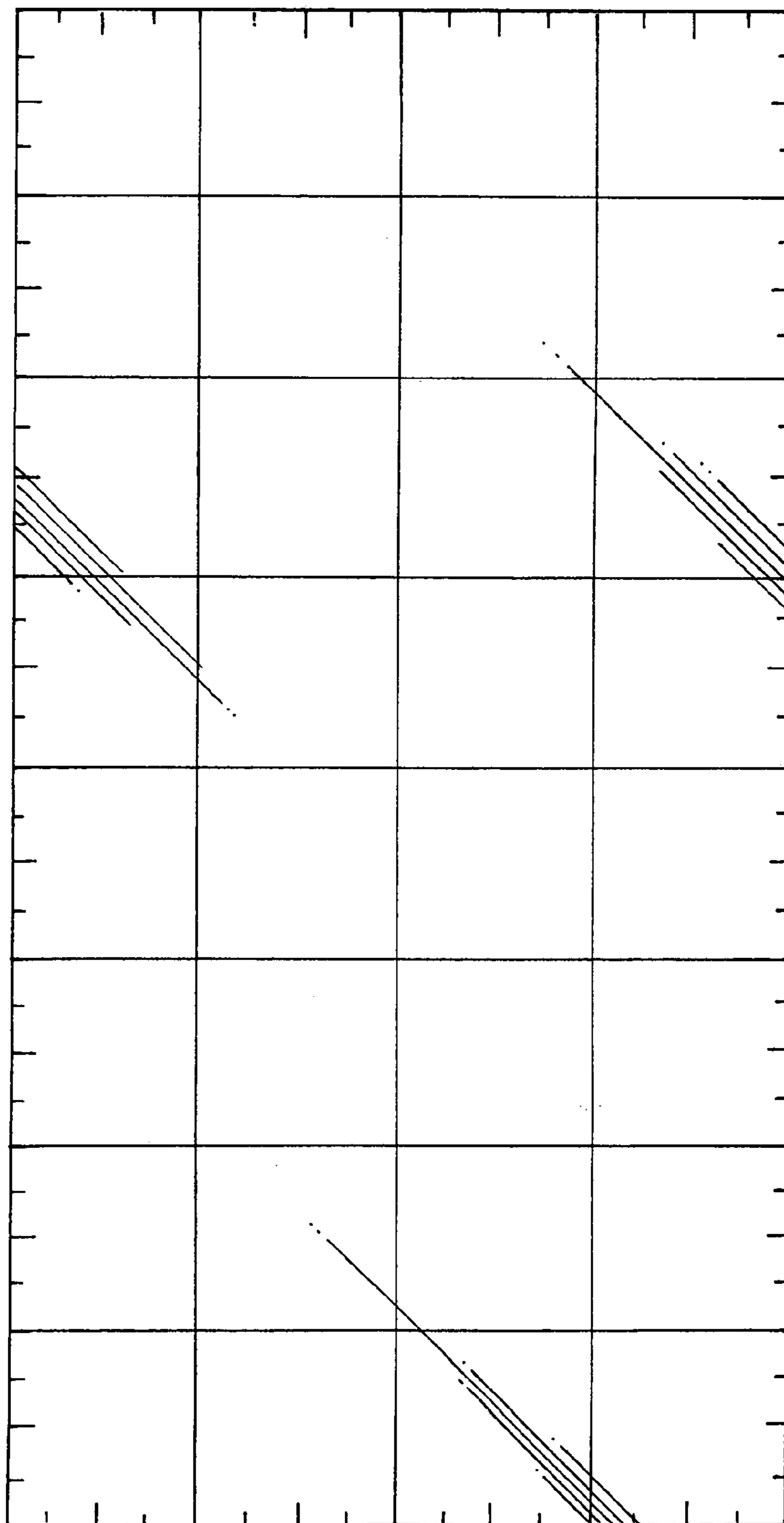

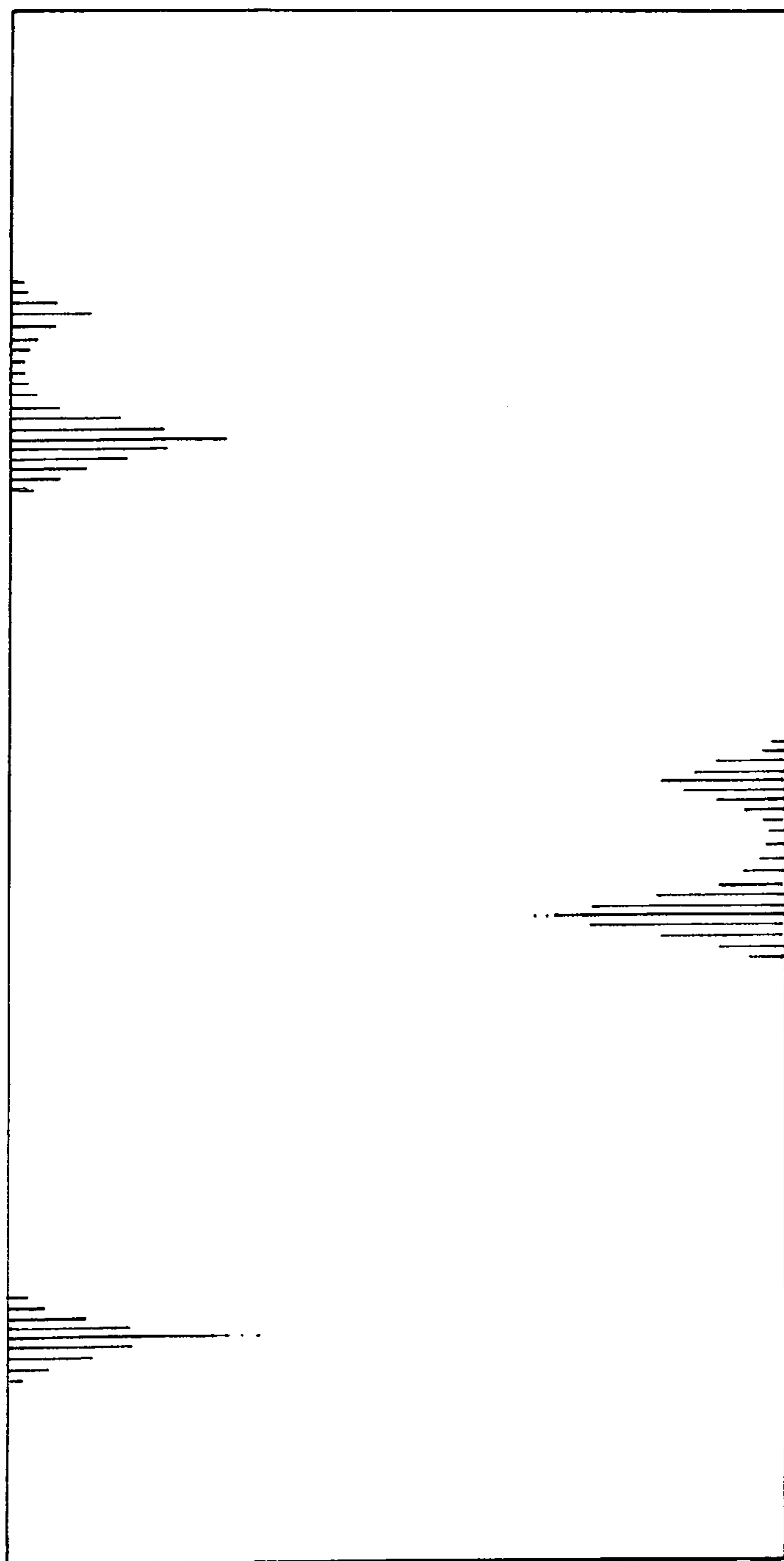

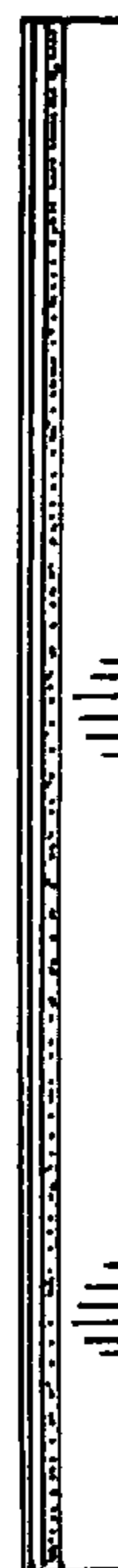
