(57) **CLAIM**

The ornamental design for a cylinder package, as shown and described.

DESCRIPTION

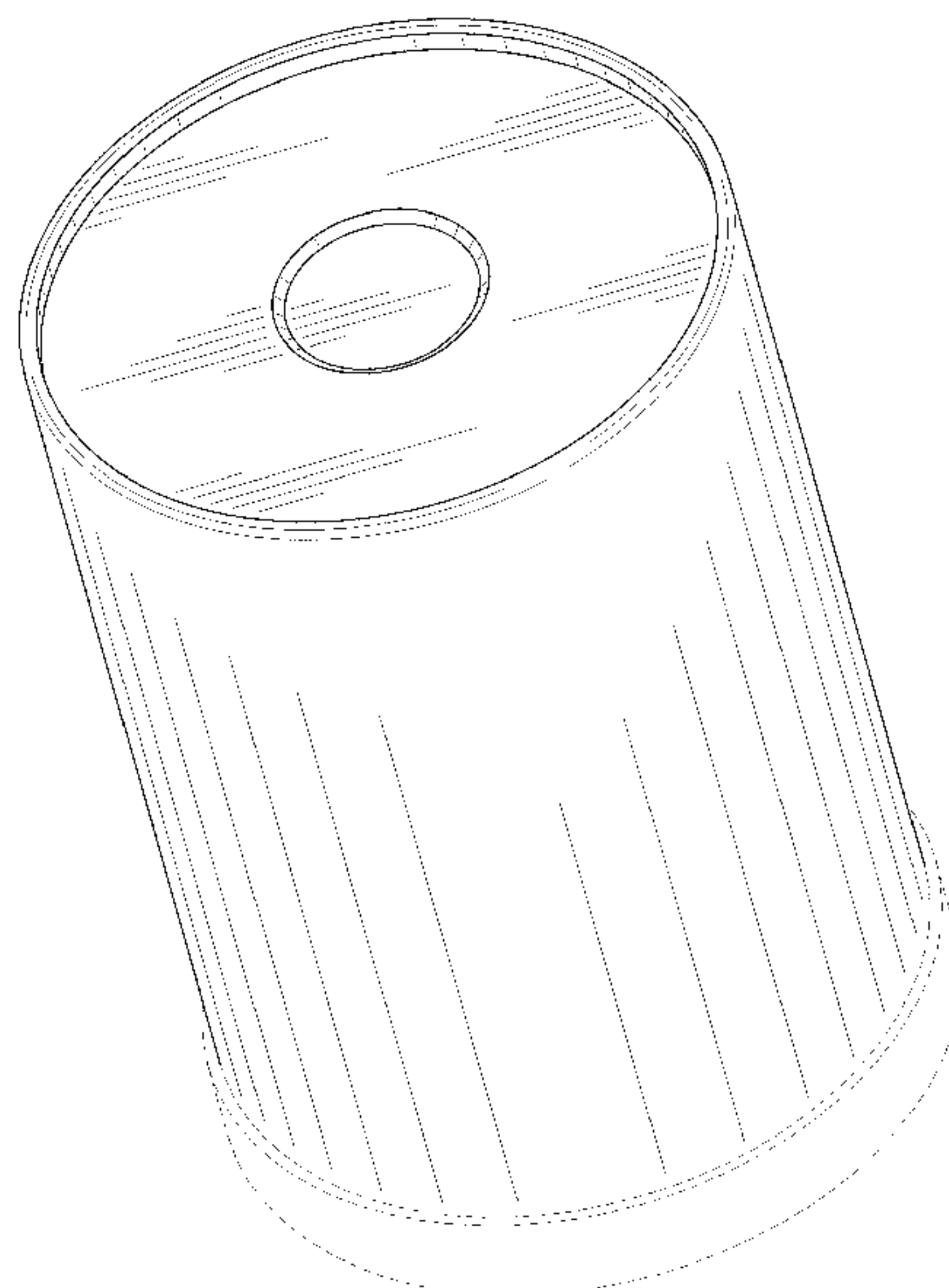

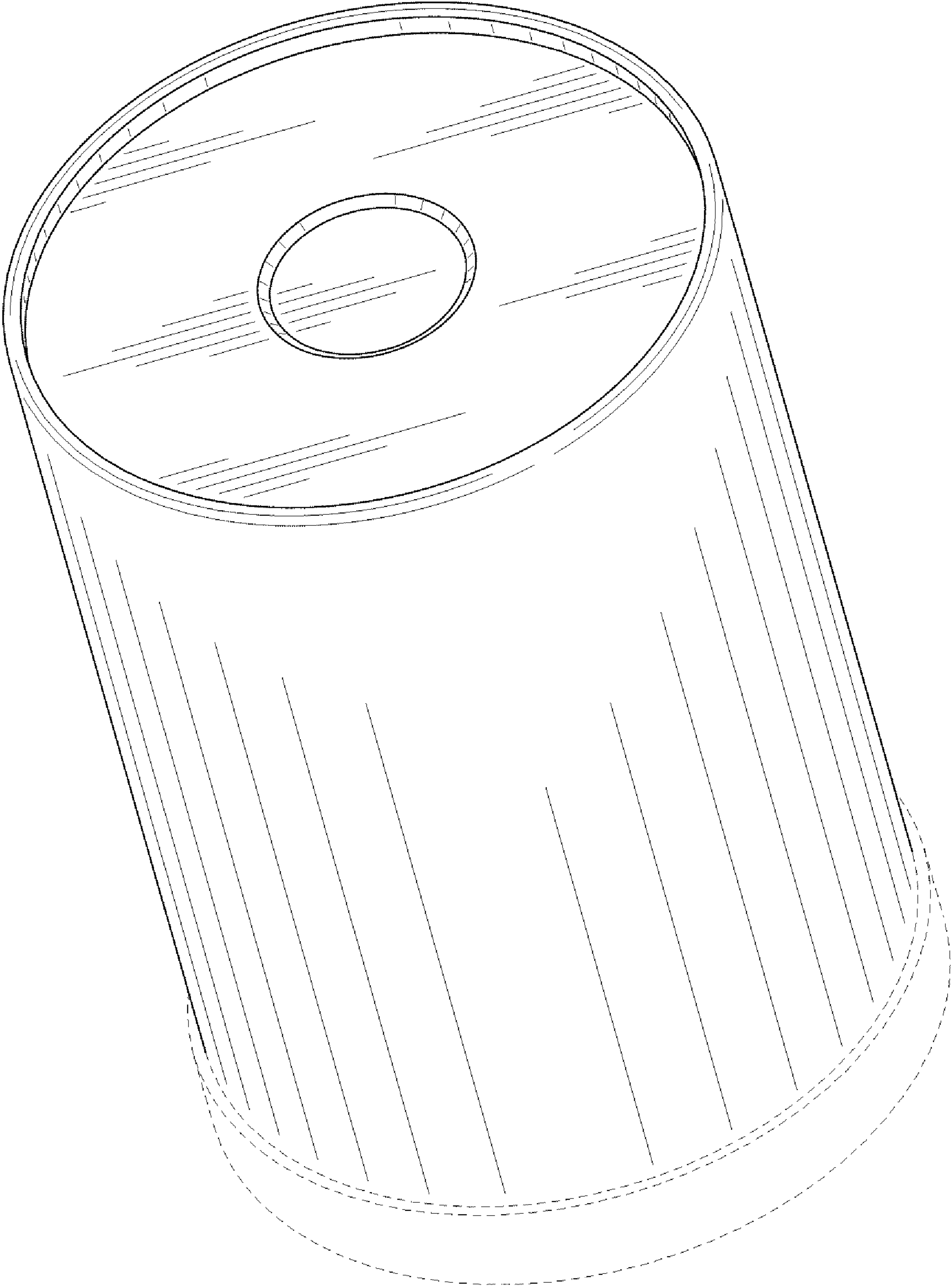

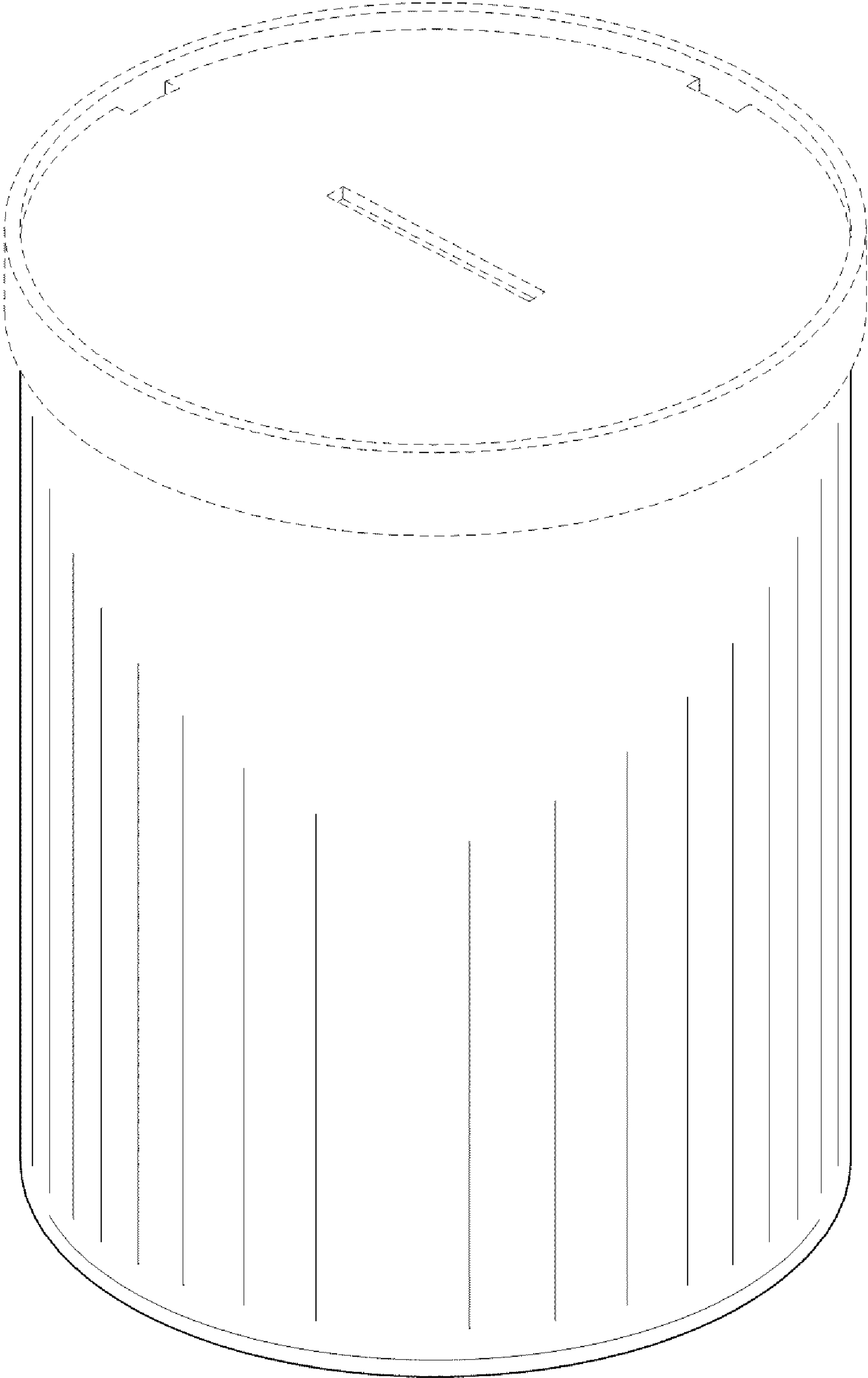

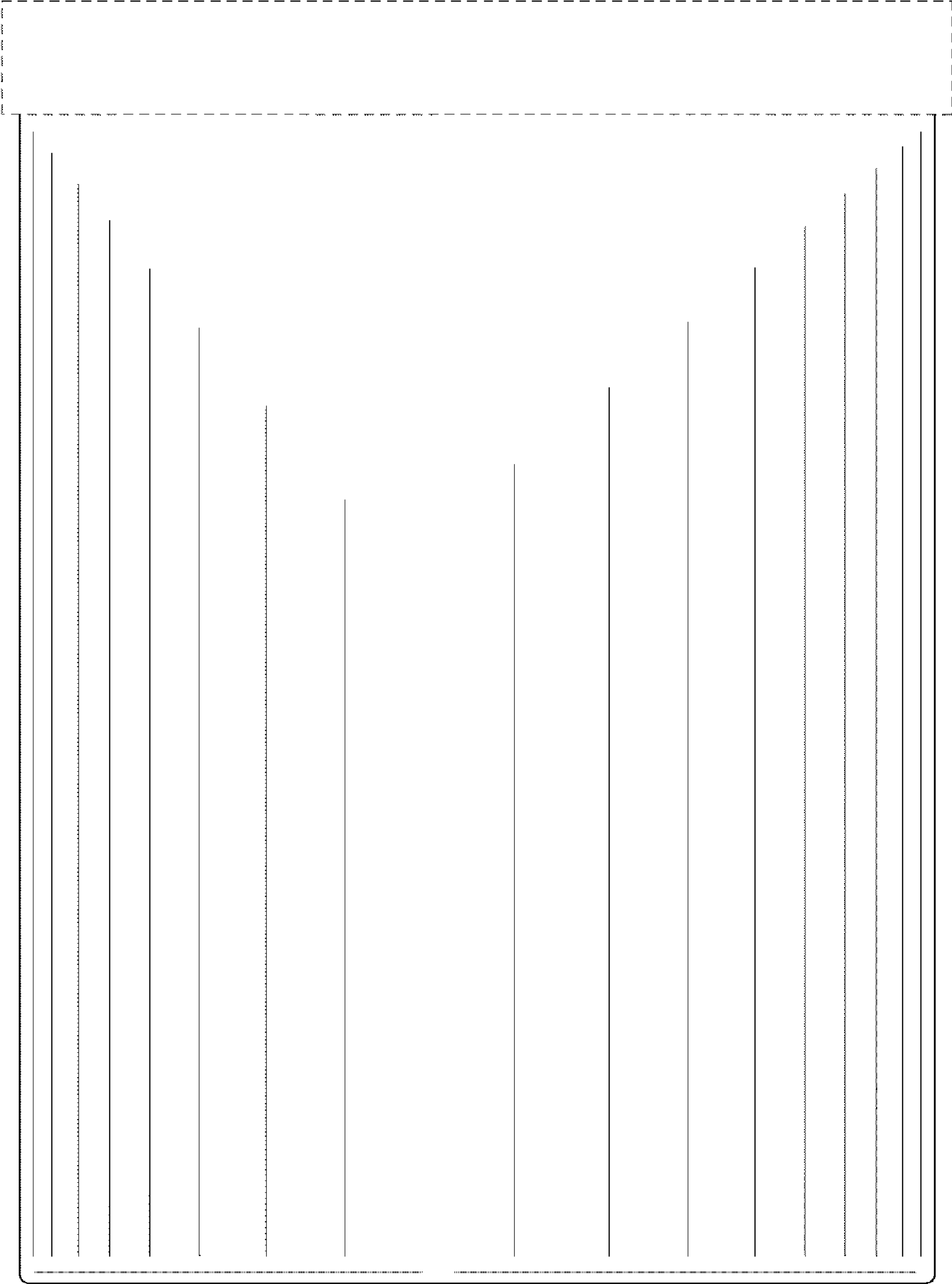

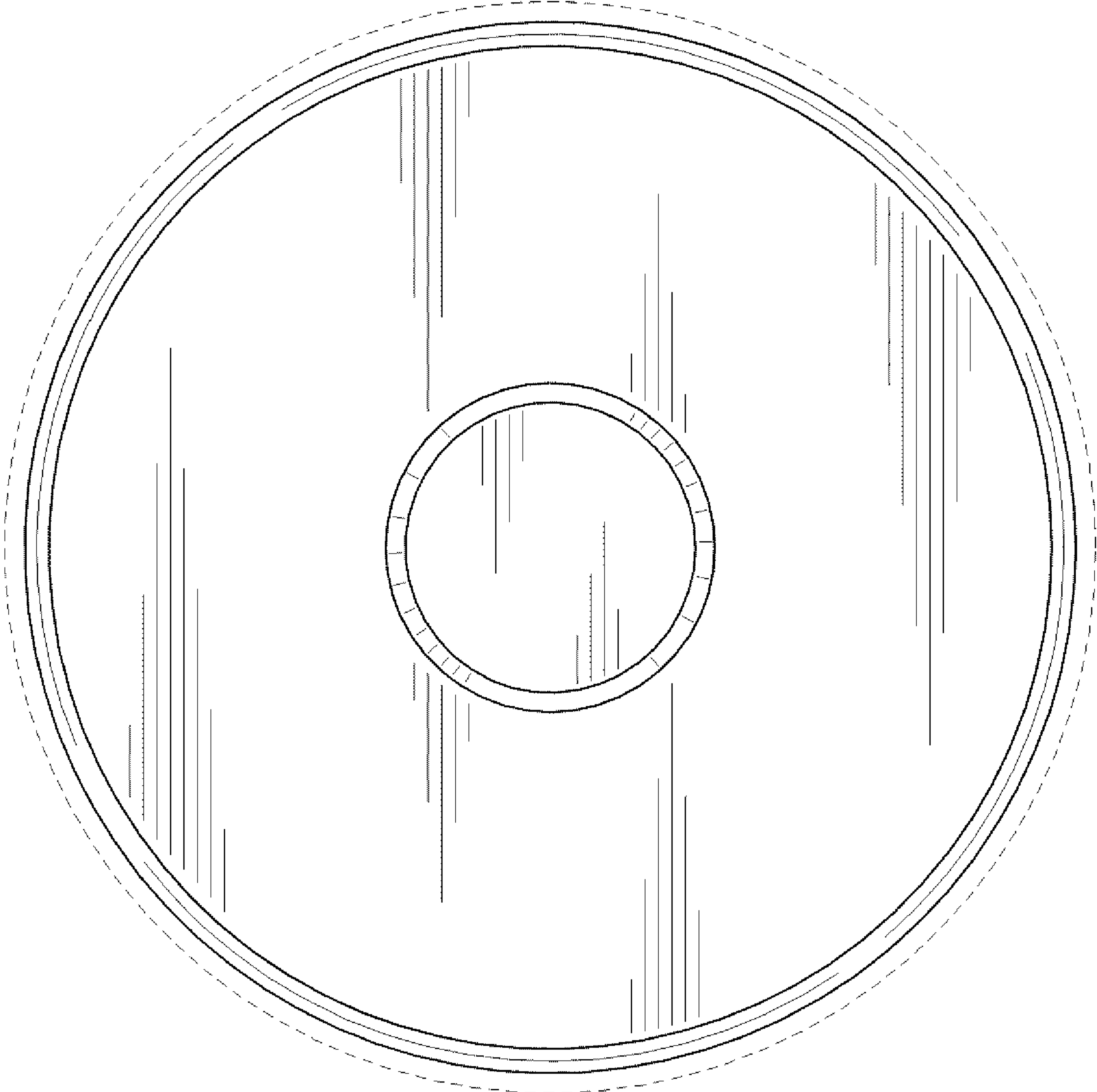
