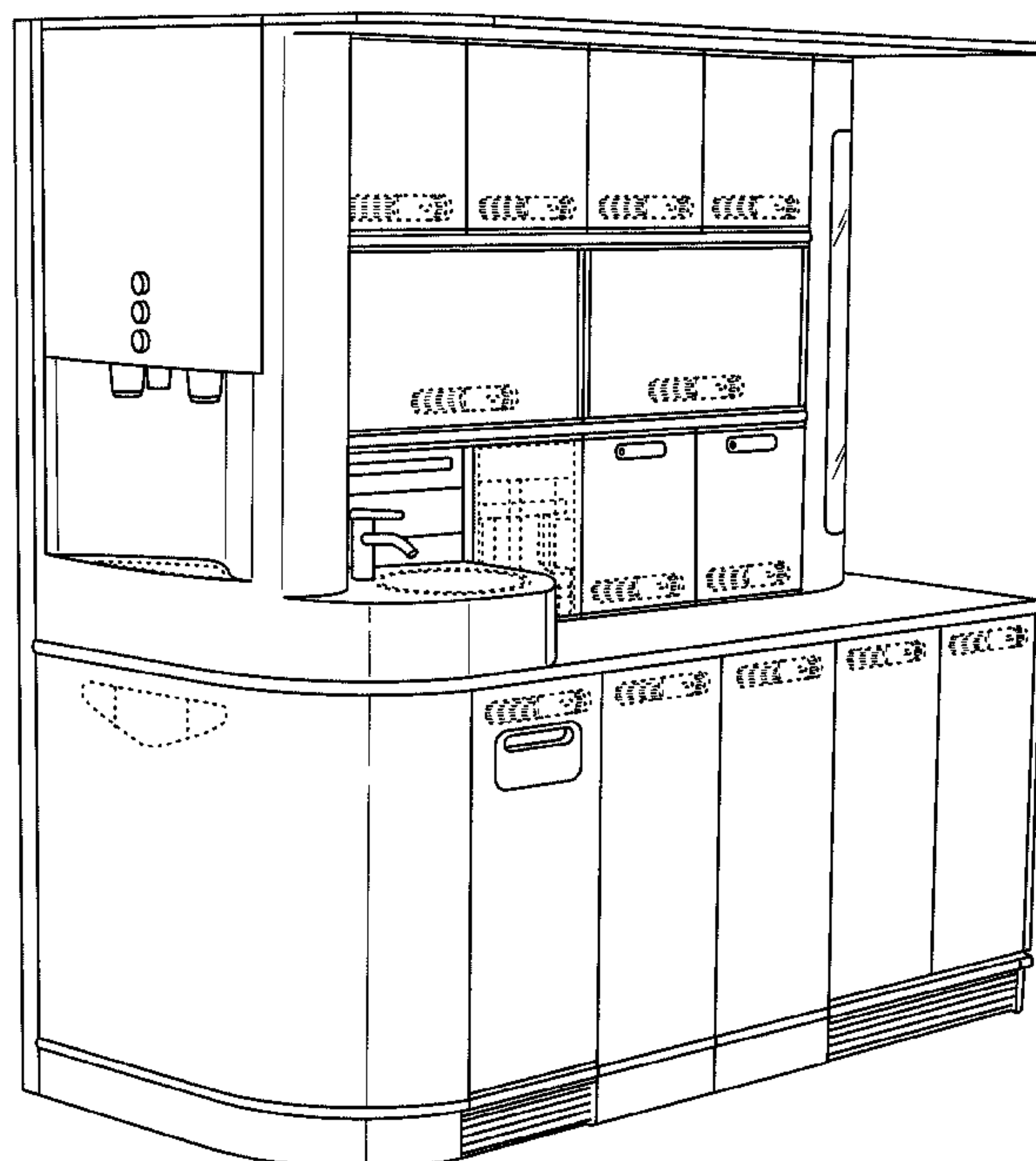
**CLAIM**

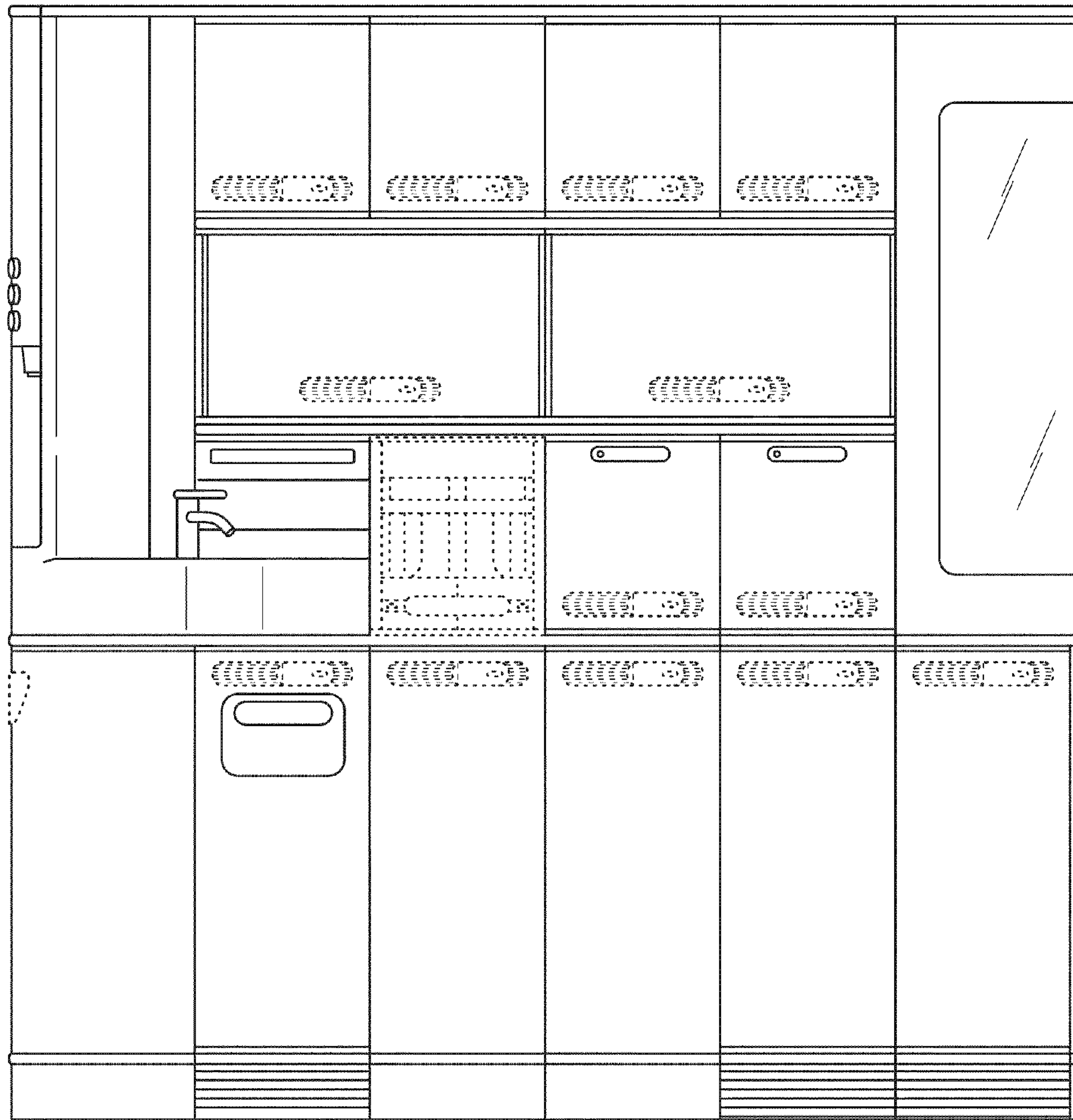

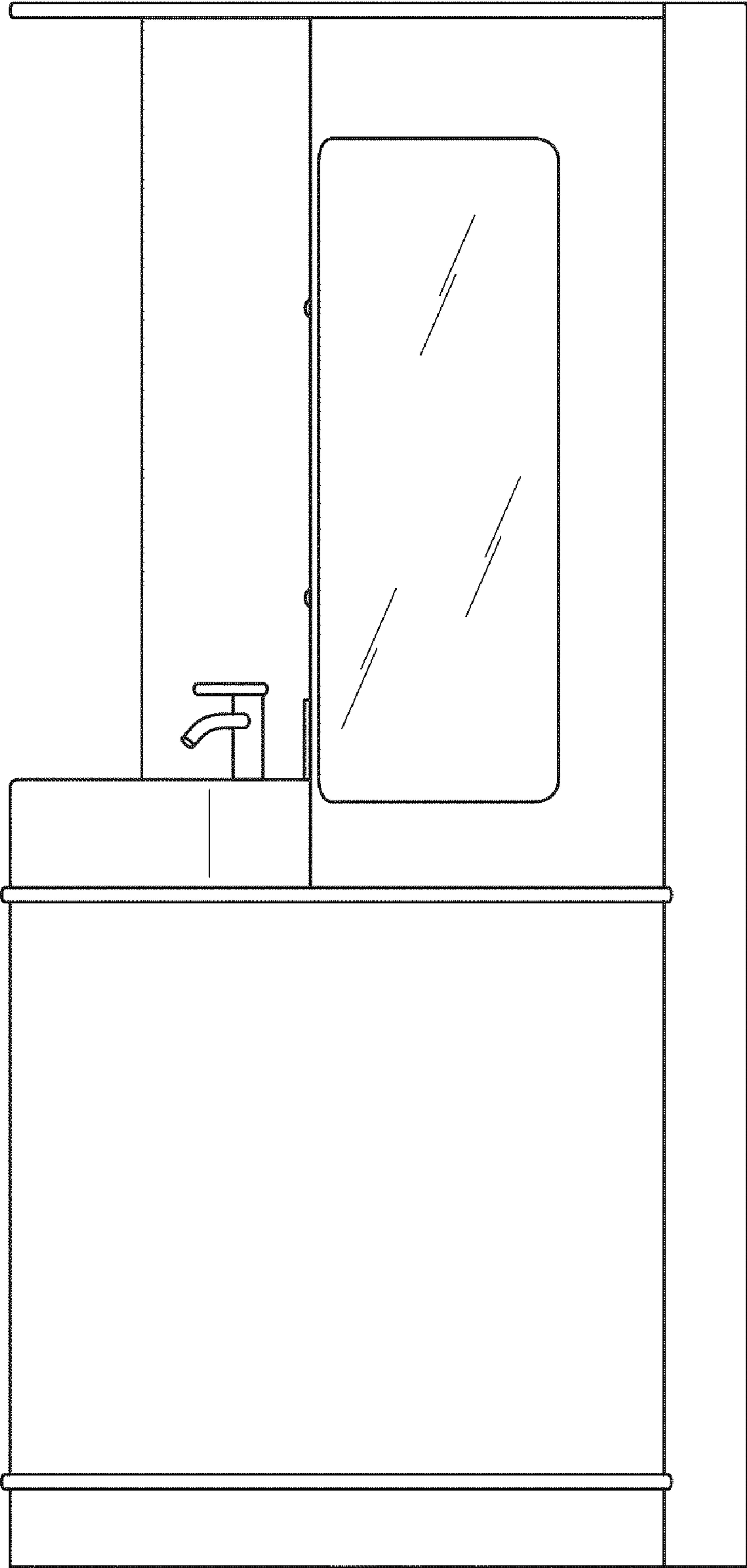

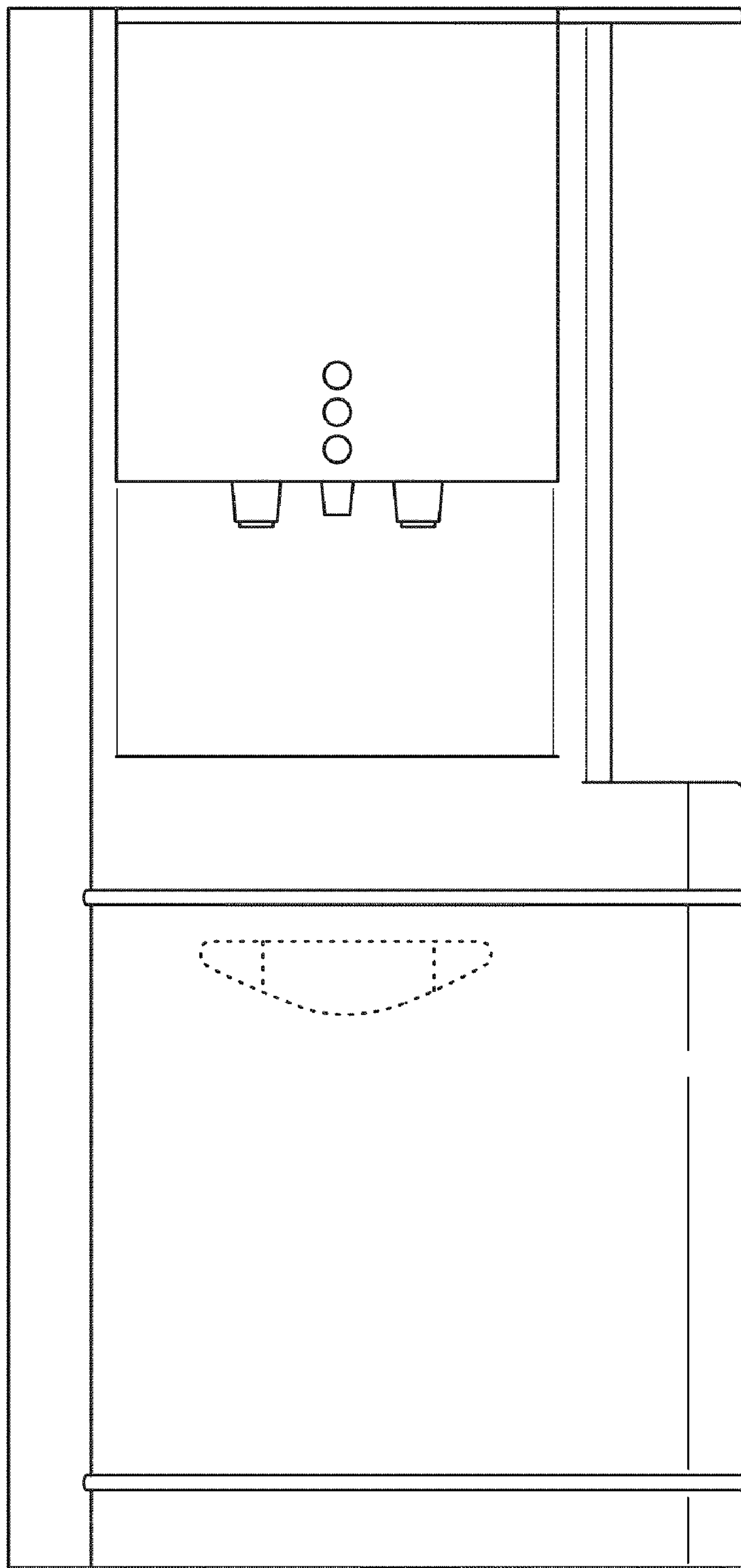

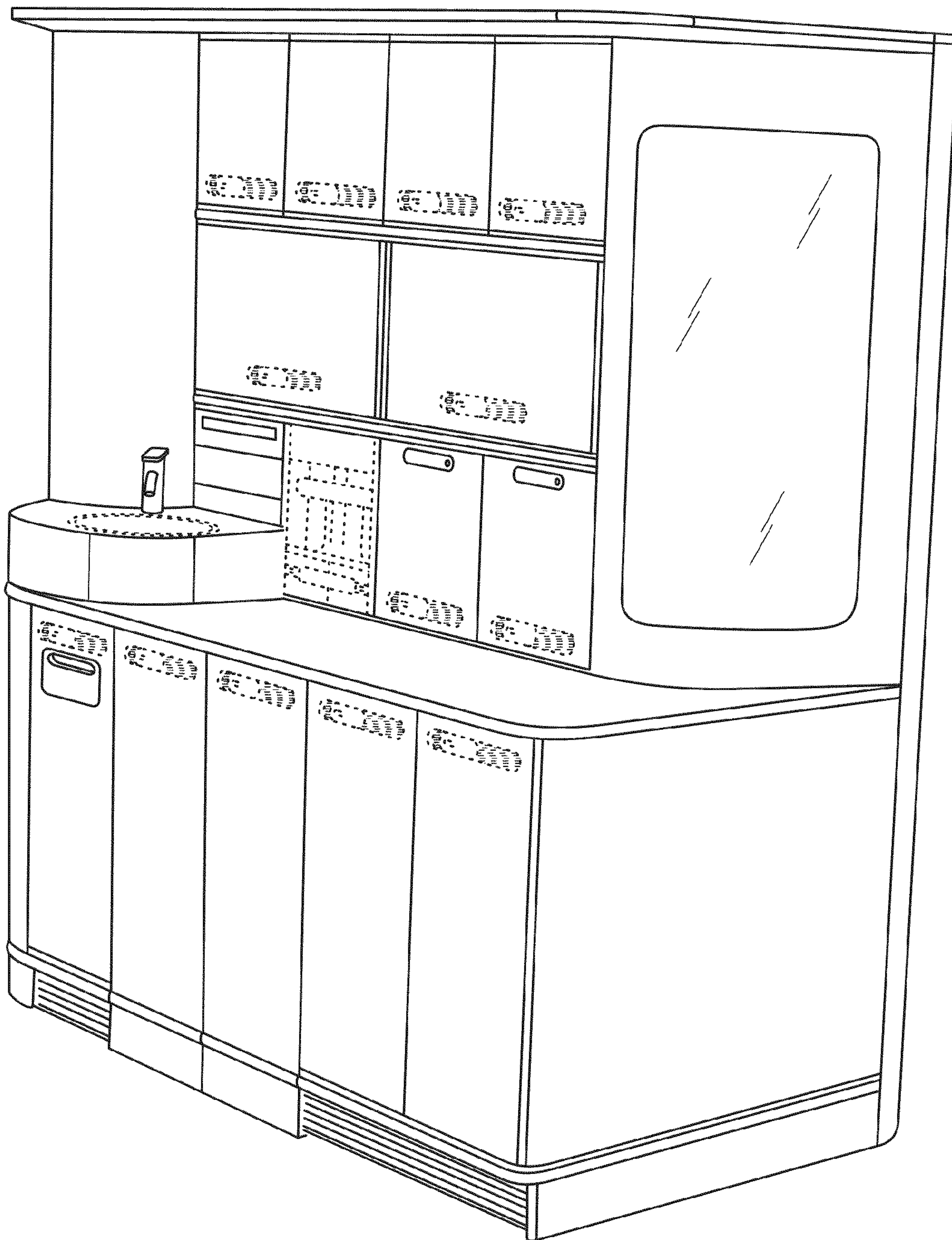

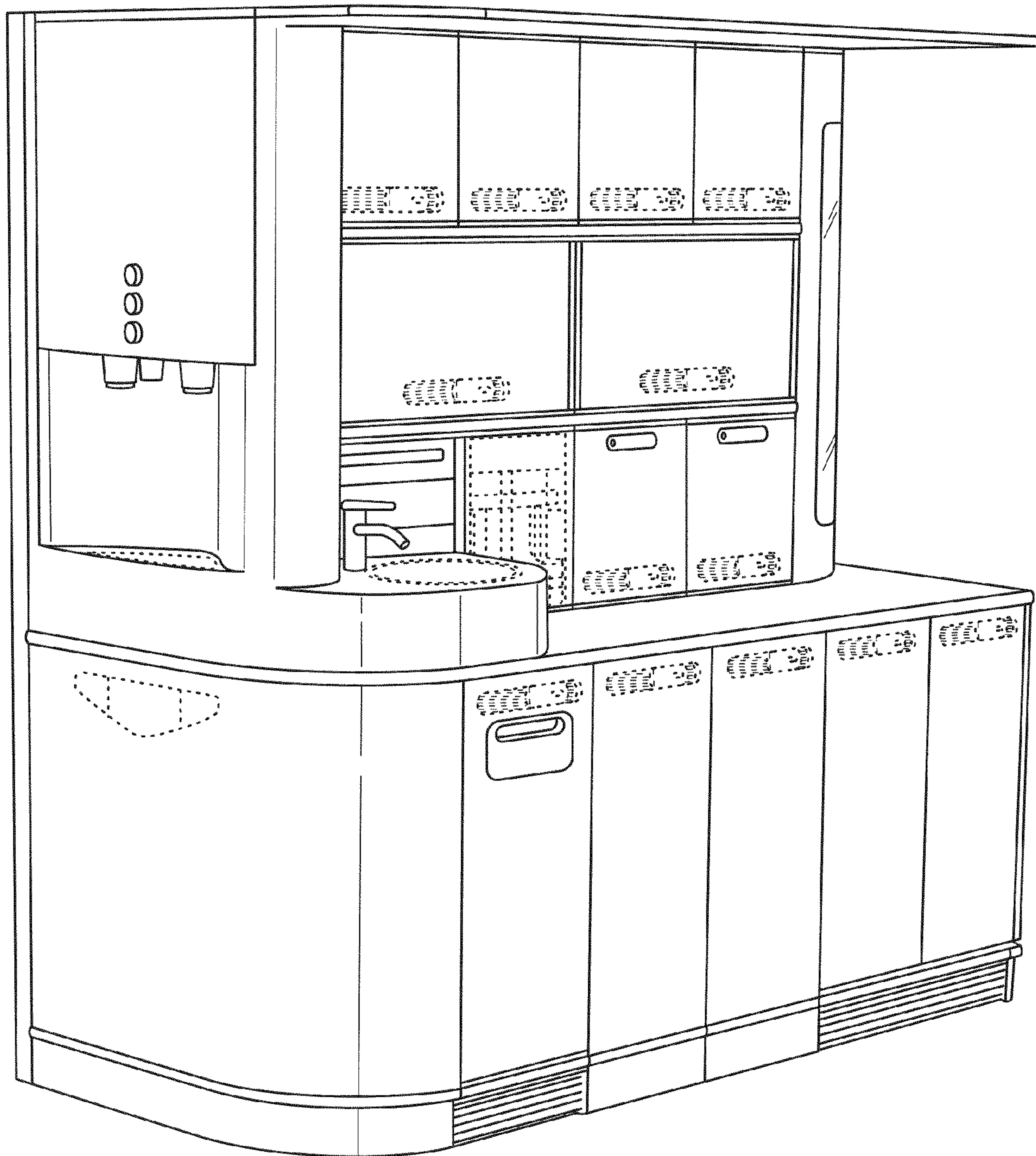
