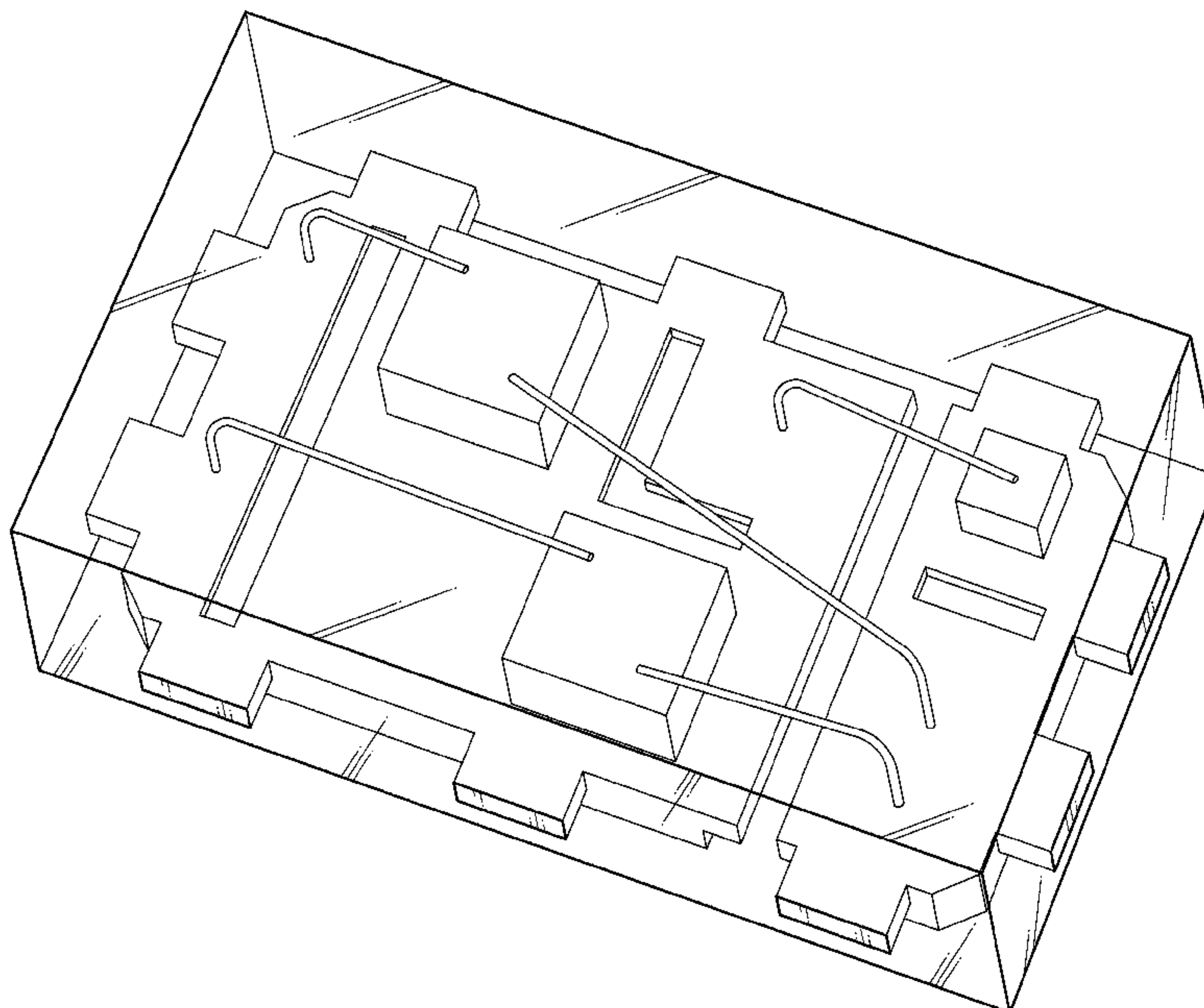
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a light-emitting diode, showing our new design;

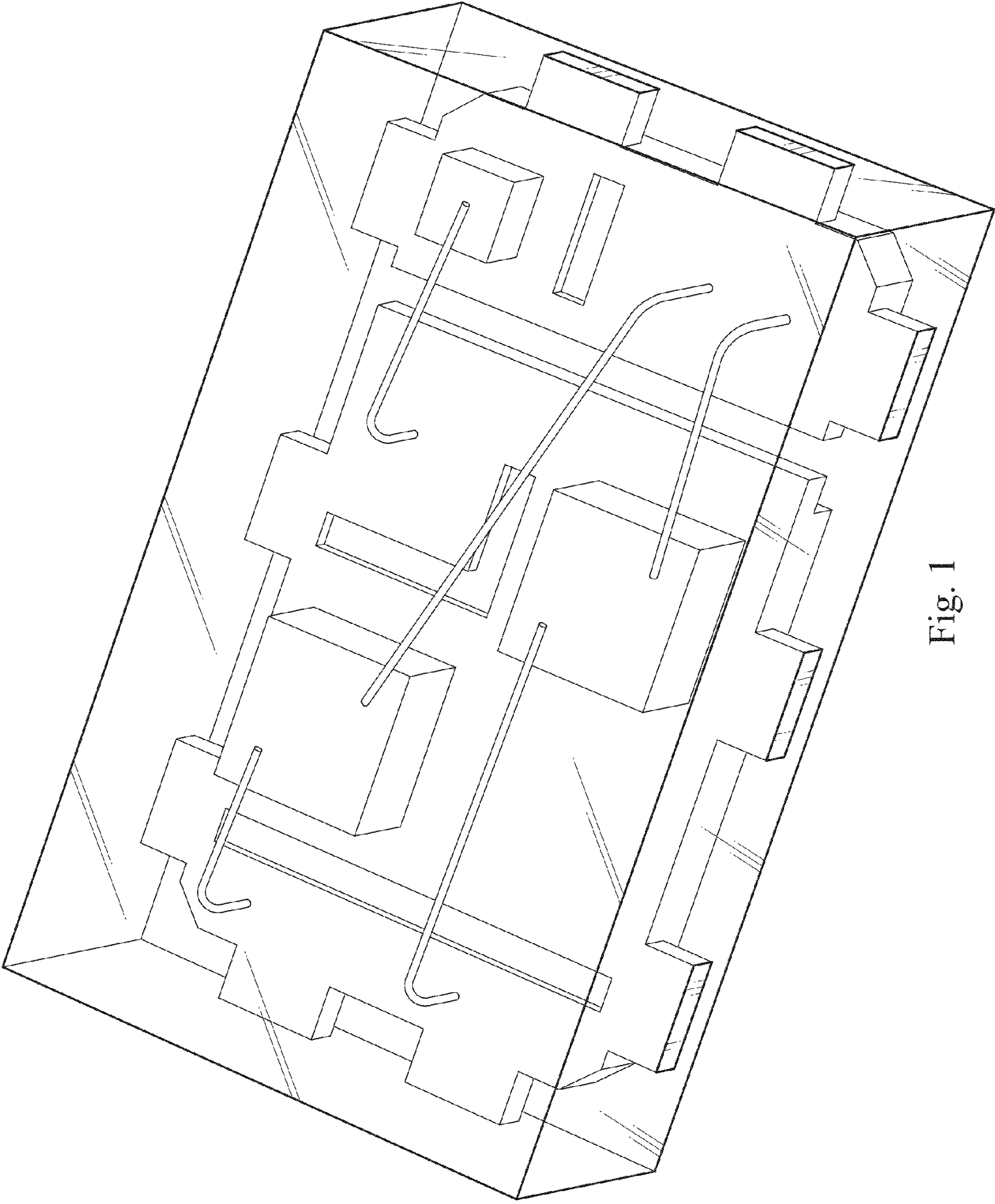

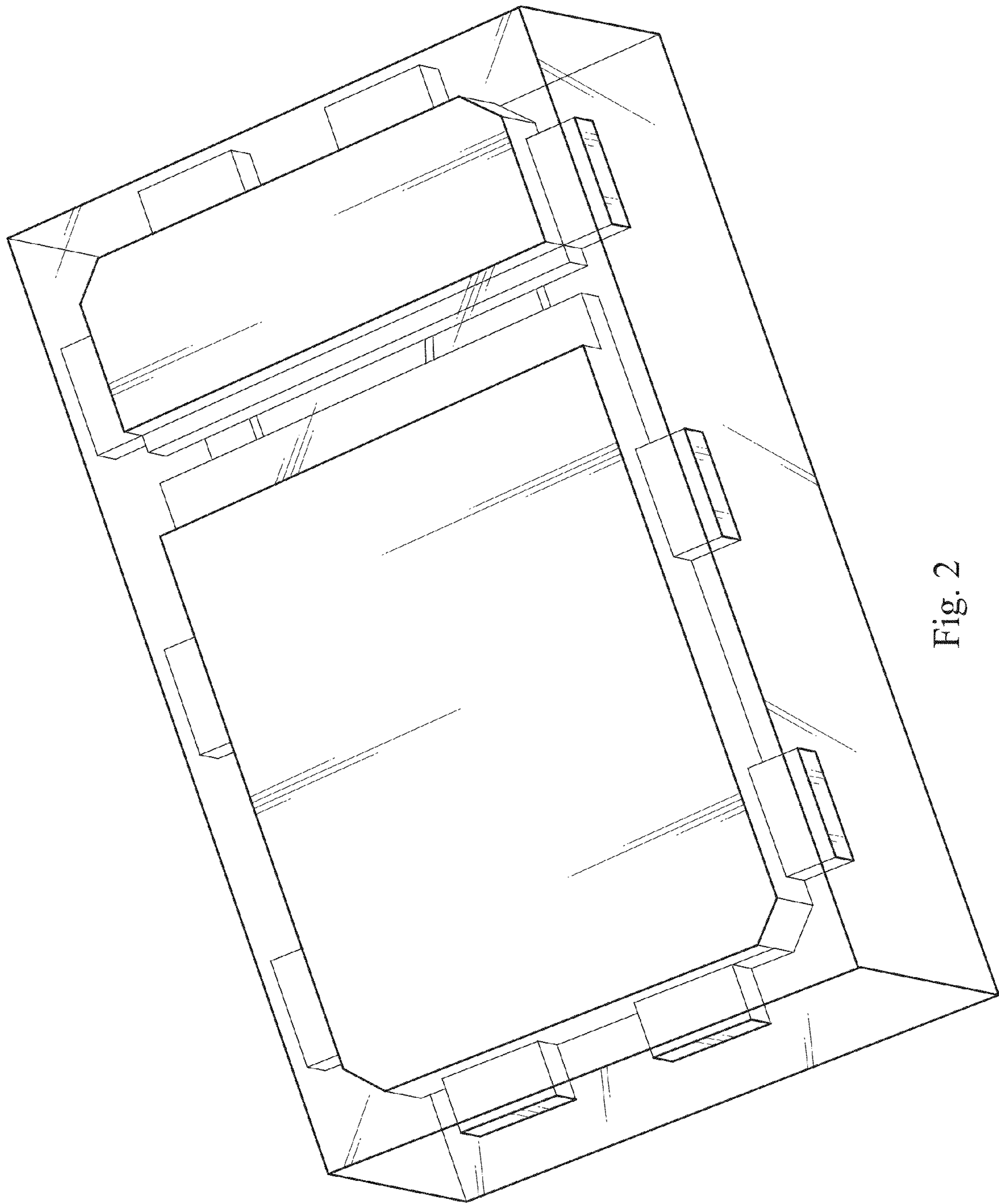

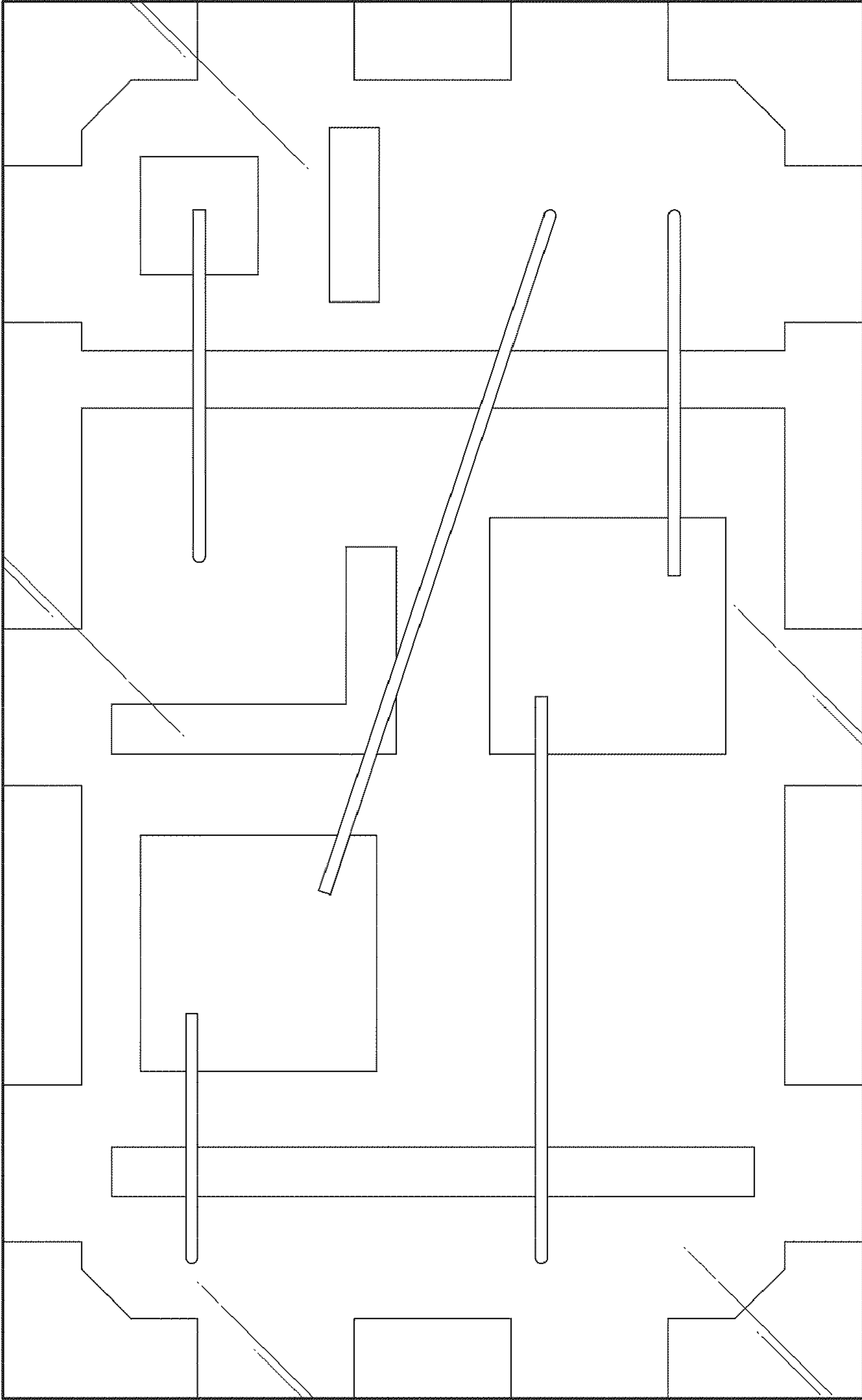

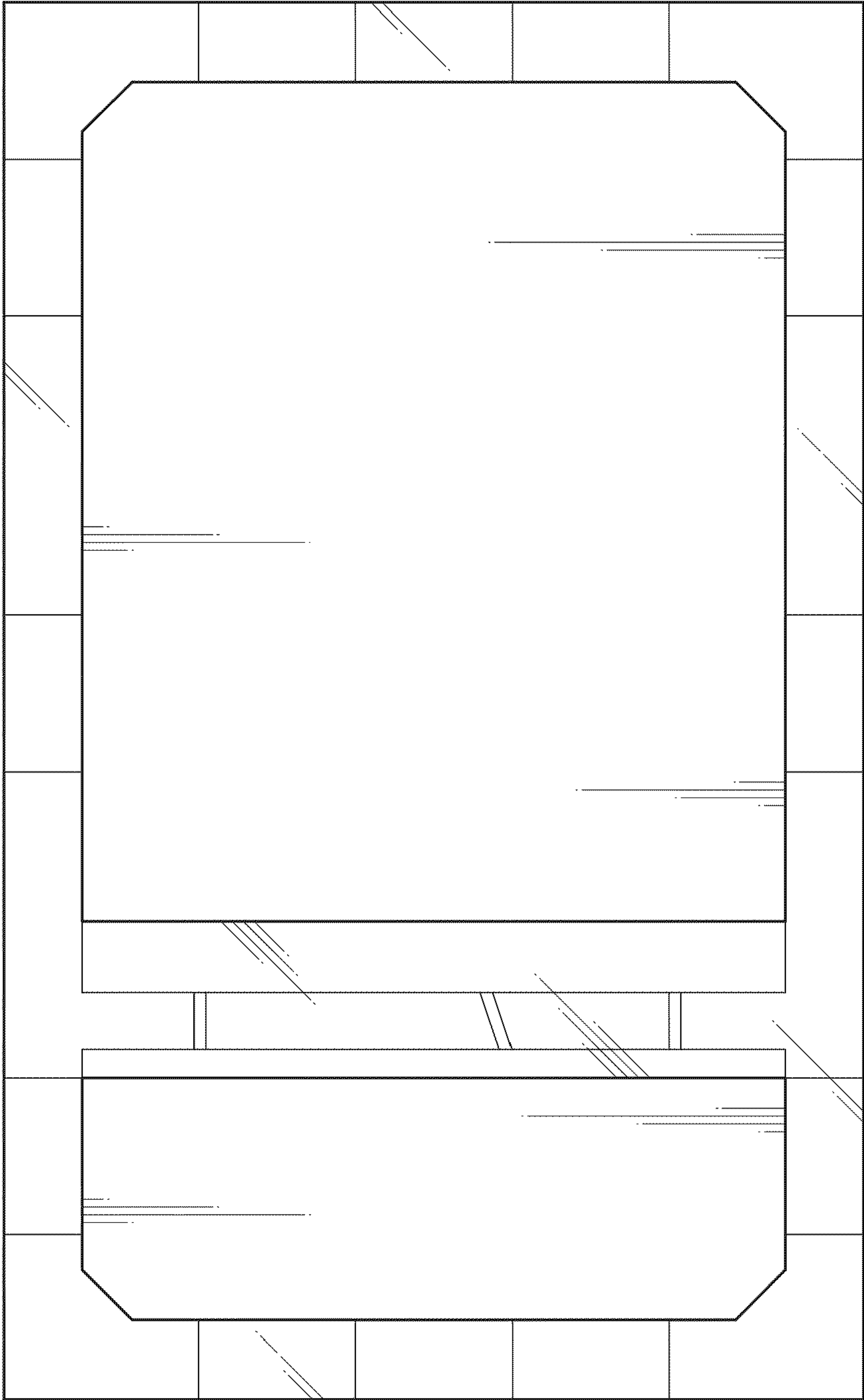

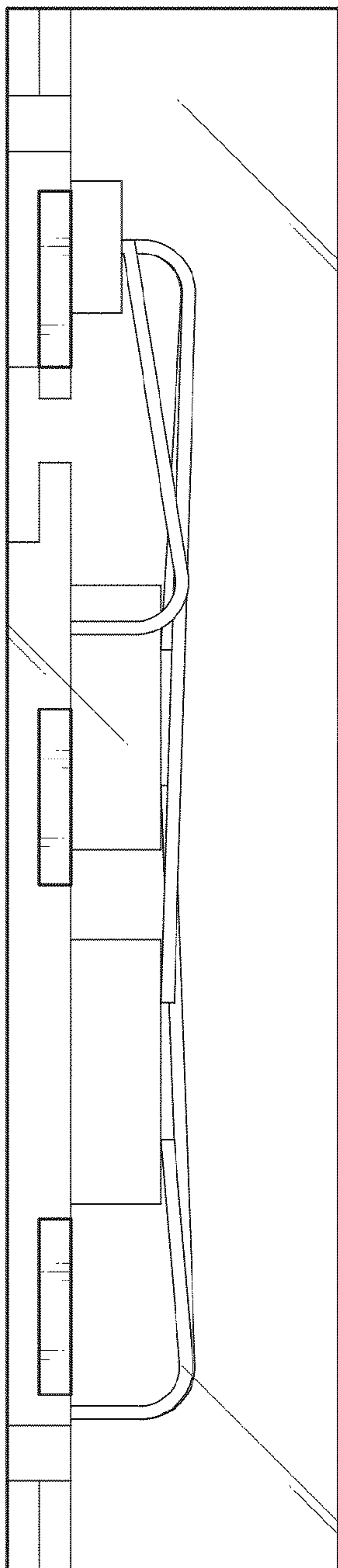

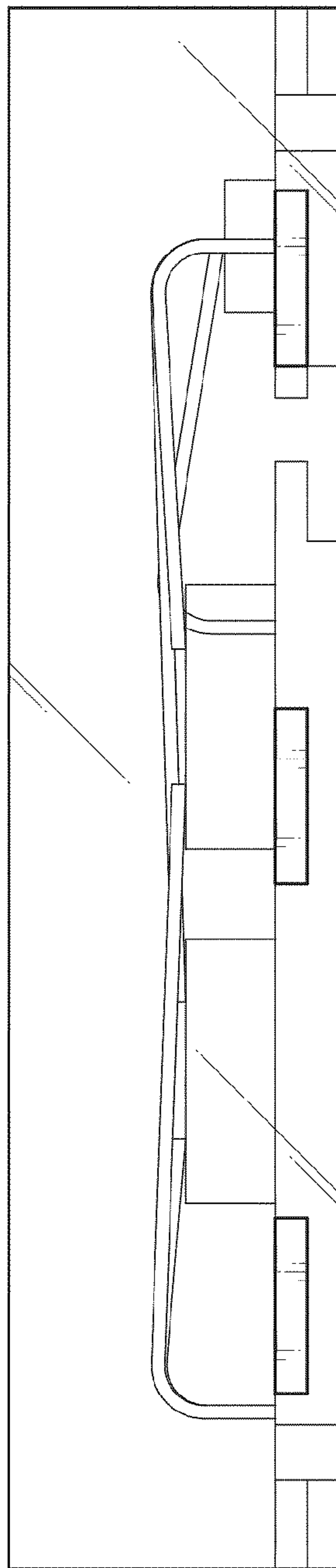

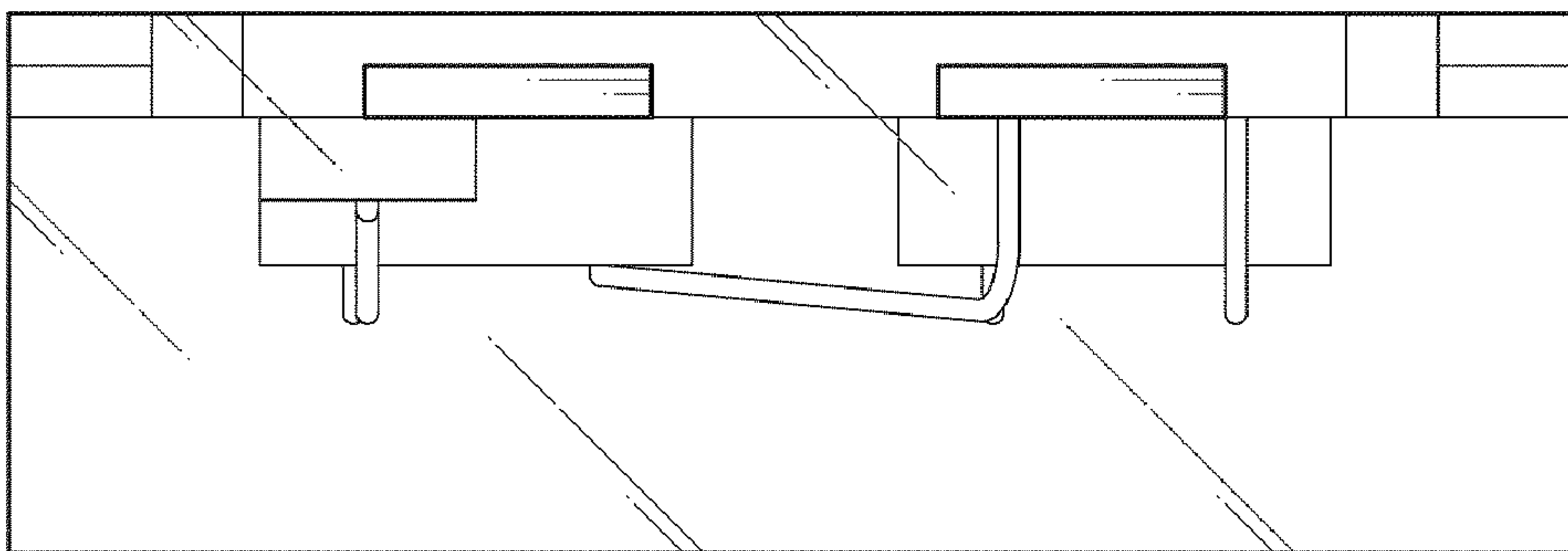

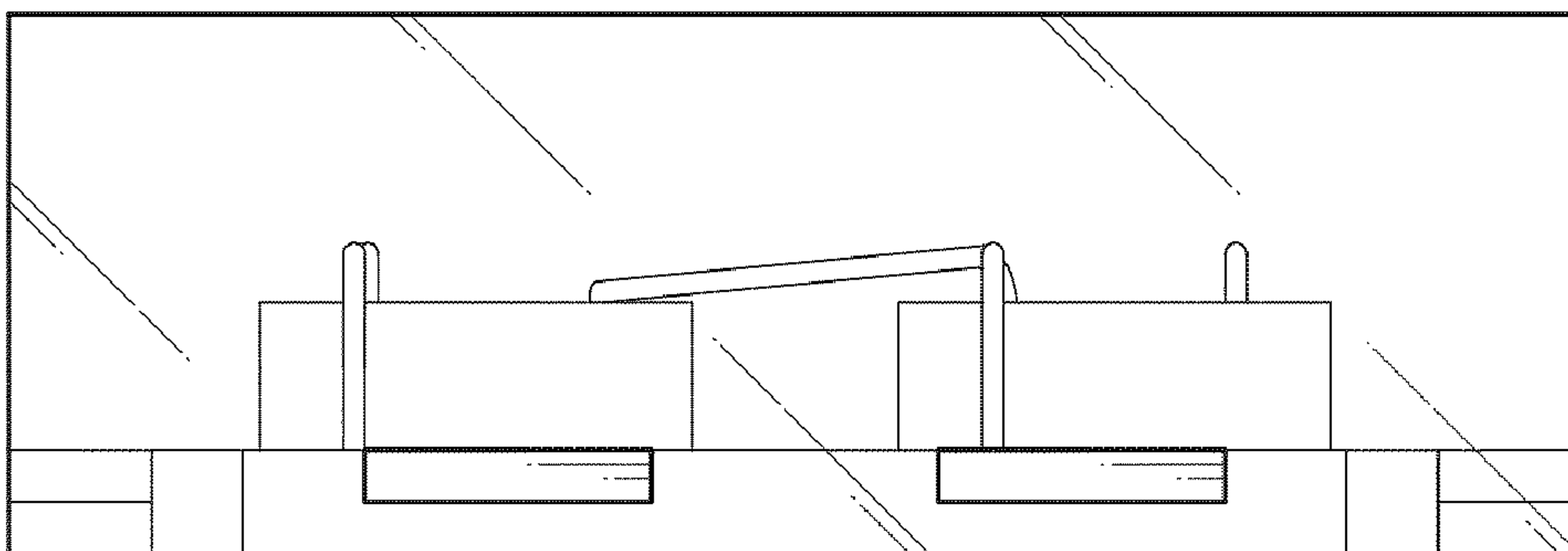
