(57) **CLAIM**

The ornamental design for a pedicure basin stand, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the pedicure basin stand. FIG. 2 is a front perspective view of the pedicure basin stand. FIG. 3 is a top plan view of the pedicure basin stand.

FIG. 4 is a right side elevation view of the pedicure basin stand.

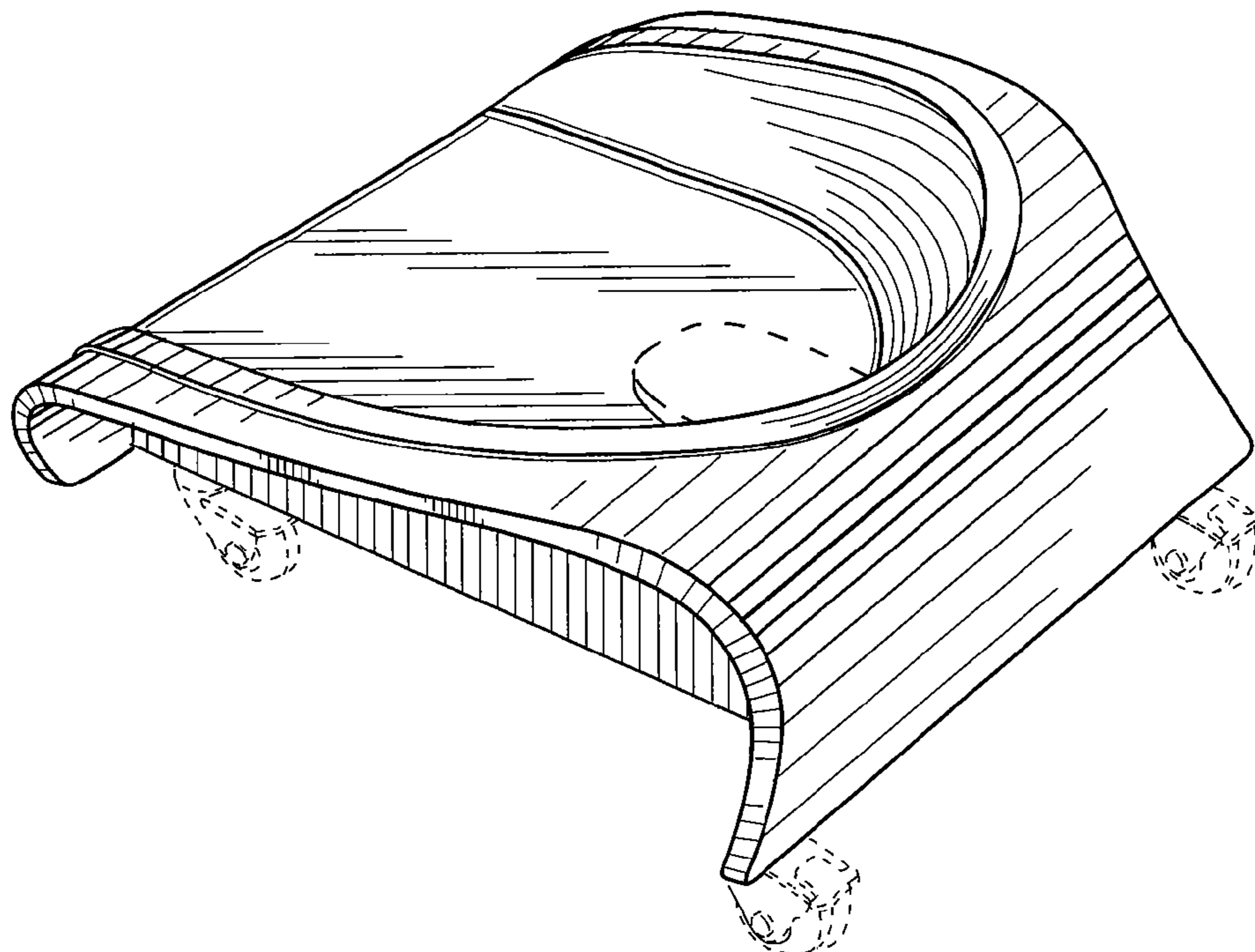
FIG. 5 is a left side elevation view of the pedicure basin stand.

FIG. 6 is a front elevation view of the pedicure basin stand. FIG. 7 is a rear elevation view of the pedicure basin stand; and,

FIG. 8 is a top perspective view of the pedicure basin stand, shown in conjunction with a pedicure spa chair, basin and footrest, the pedicure spa, basin and footrest being shown in broken lines.

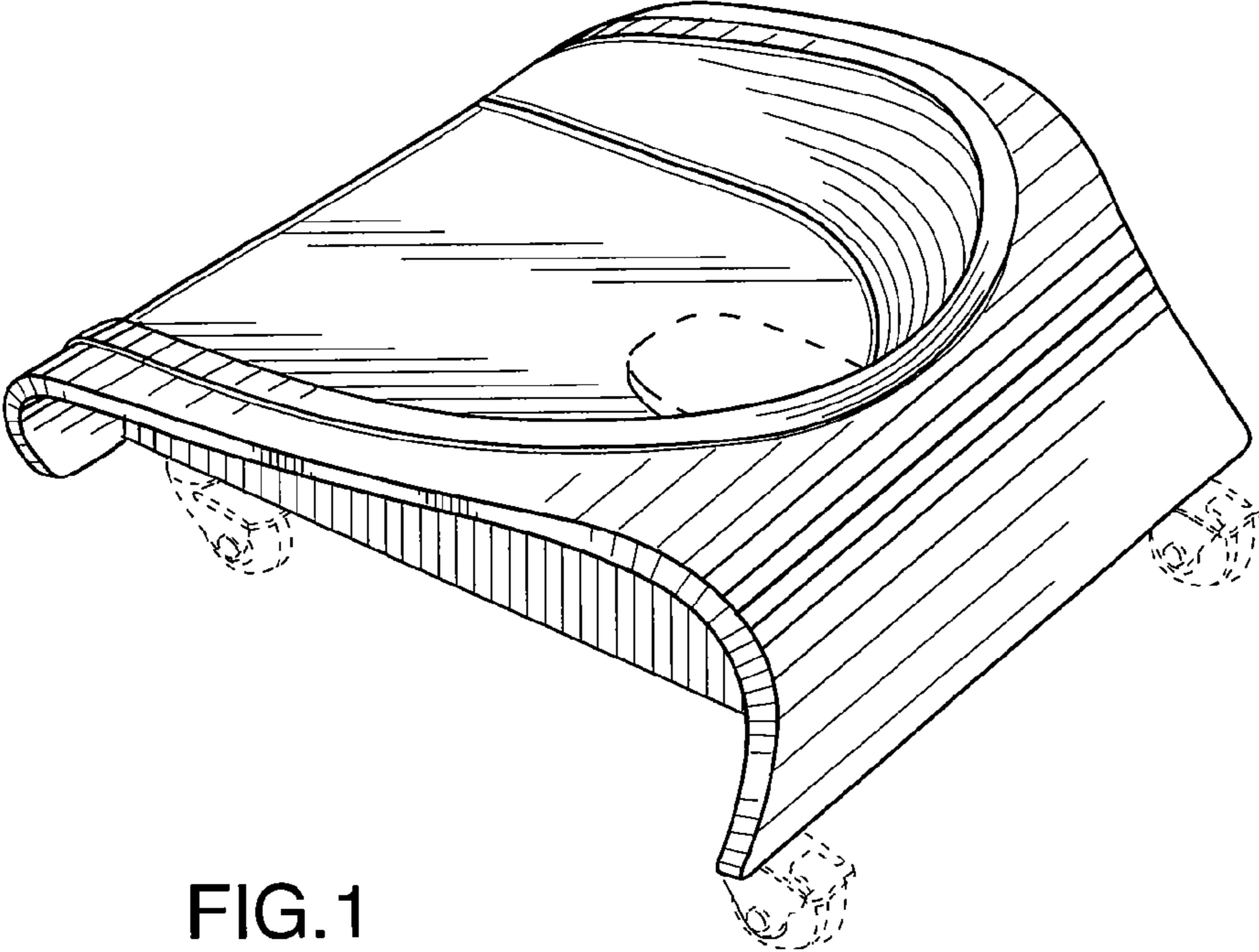

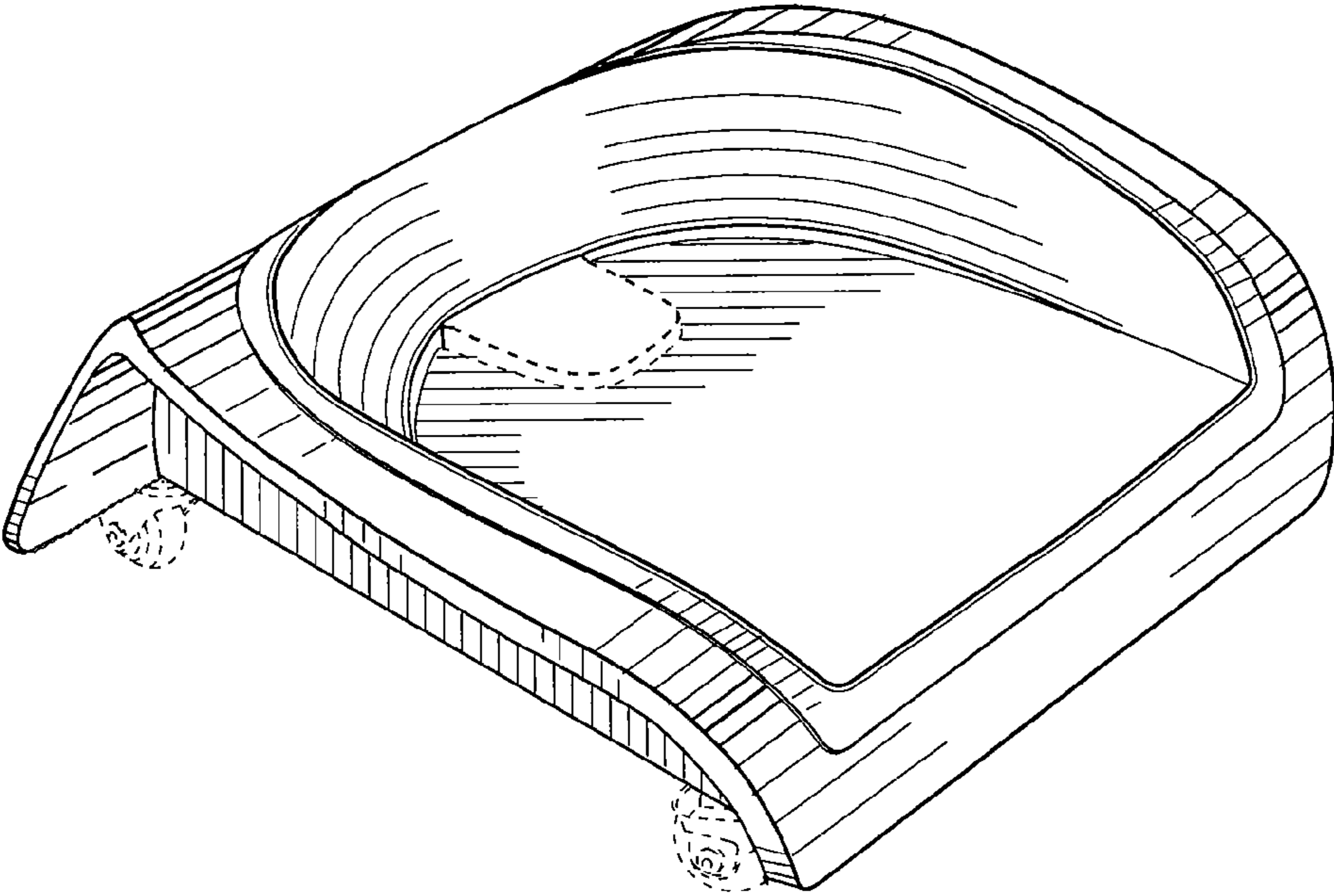

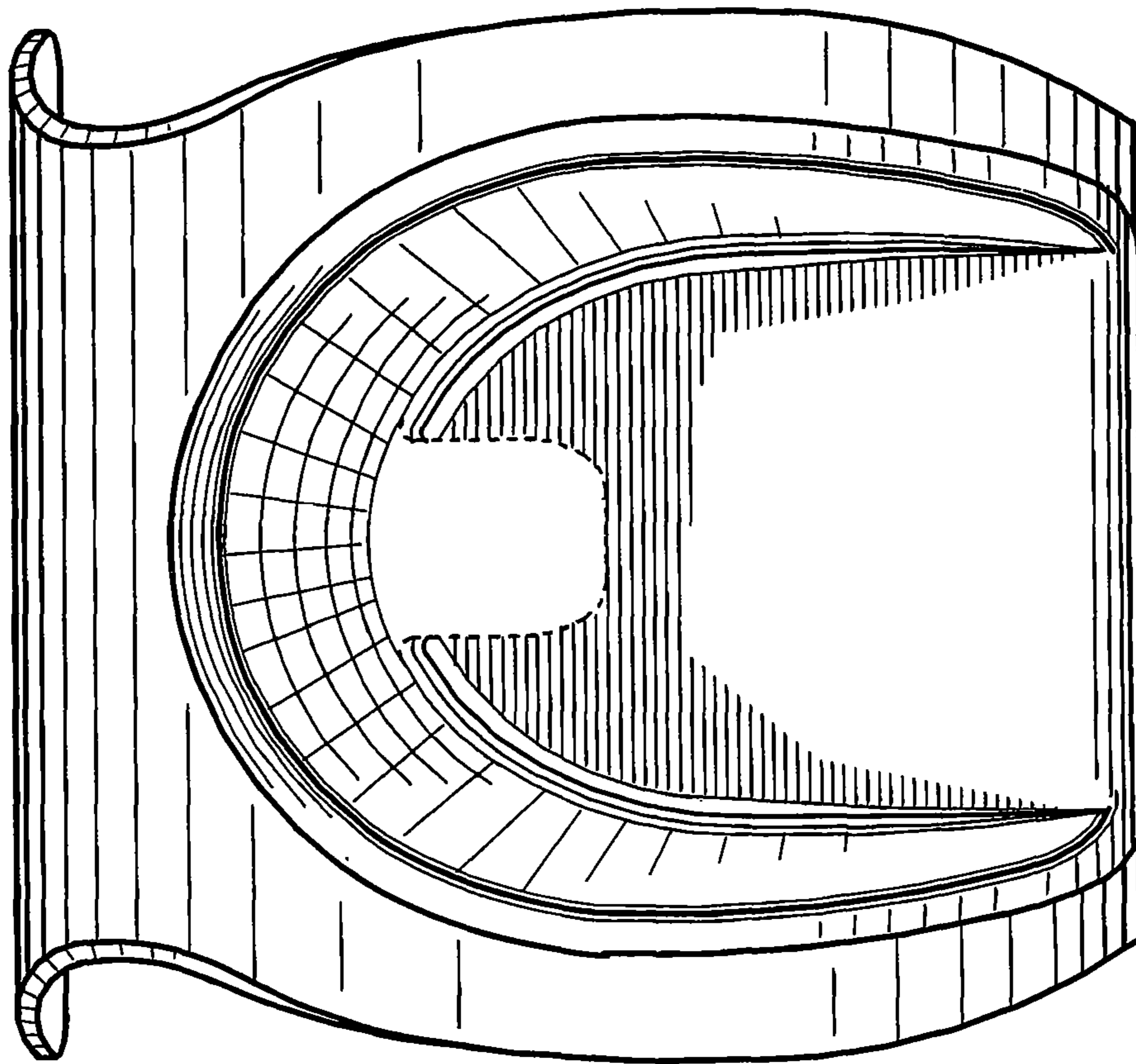

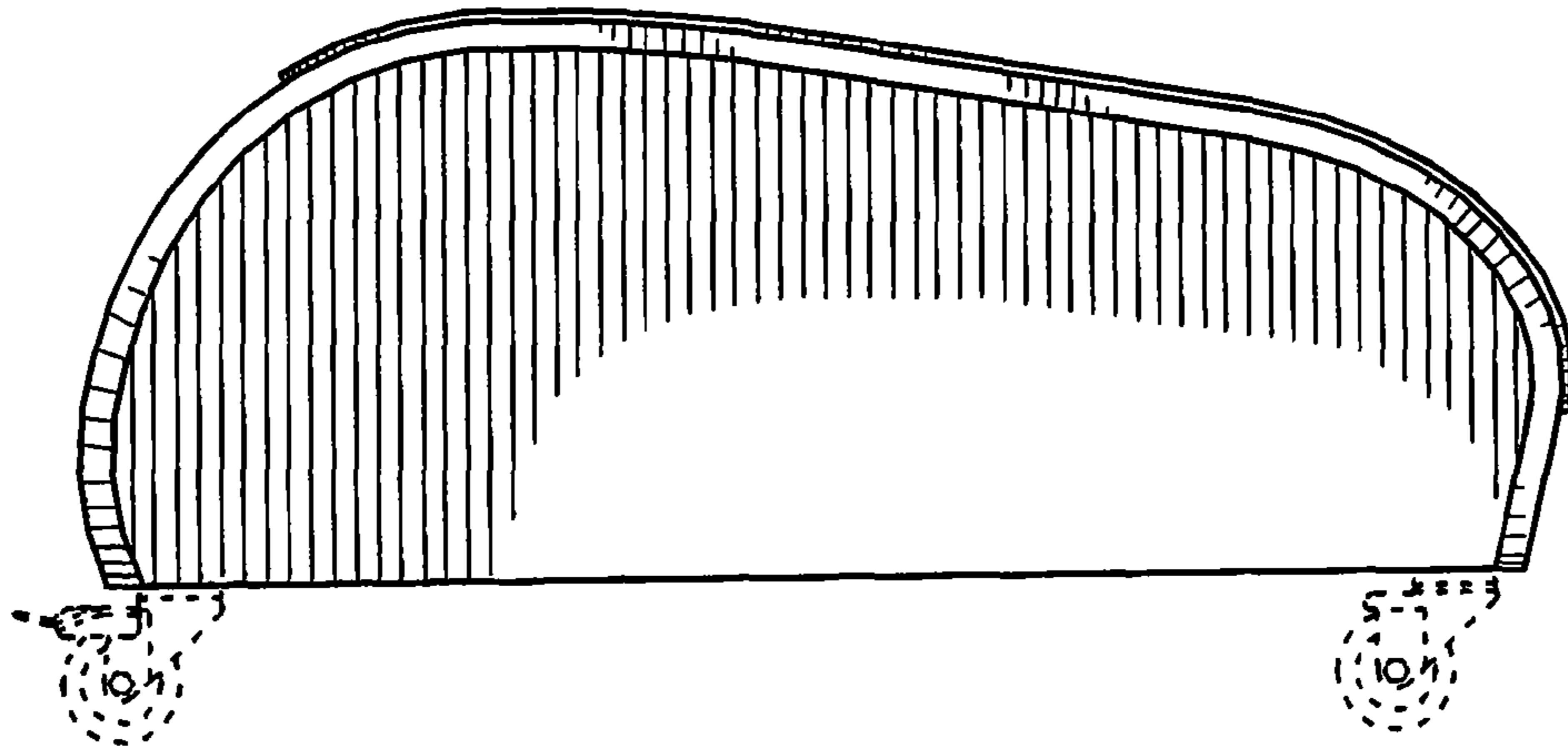

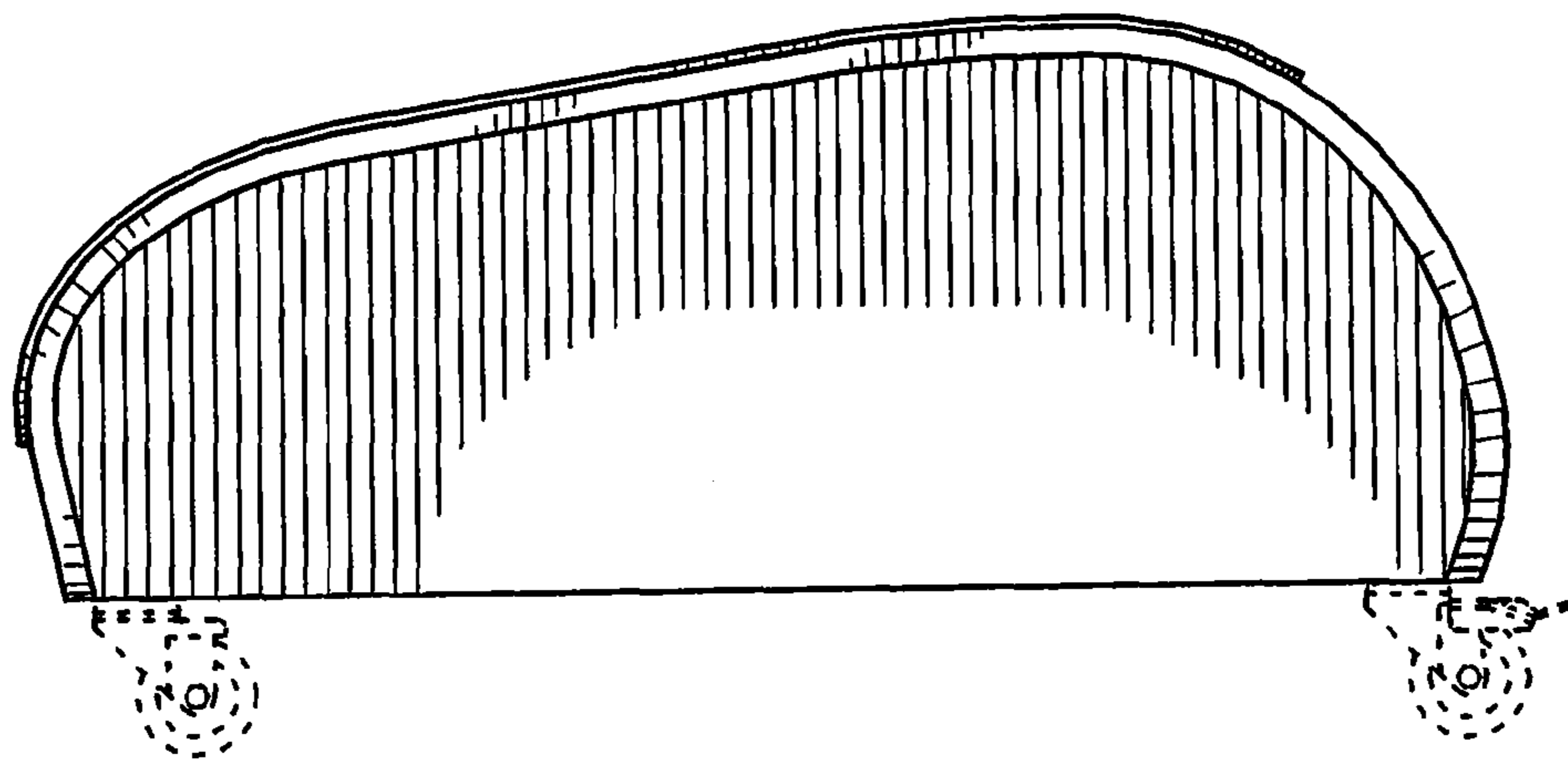

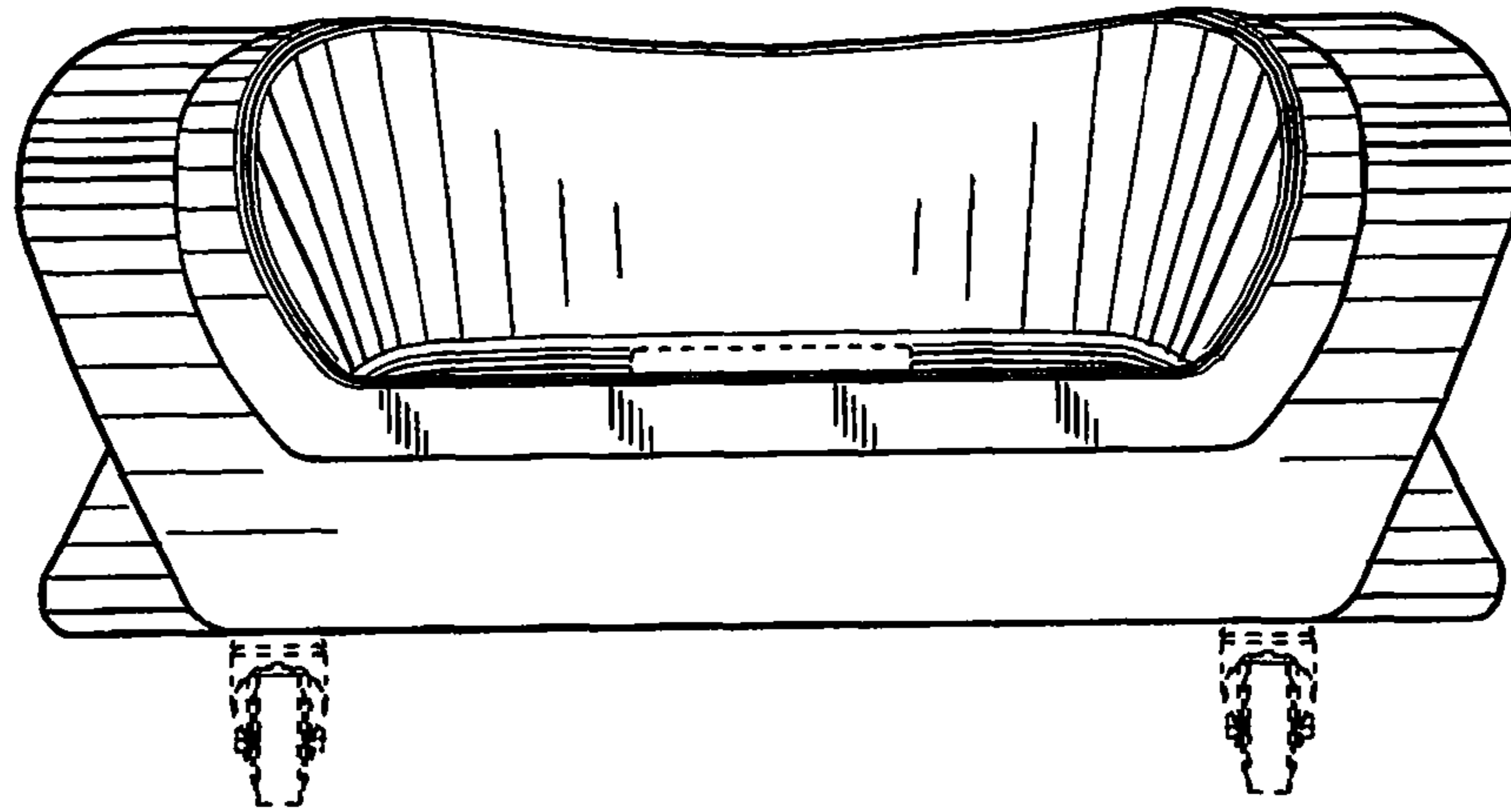

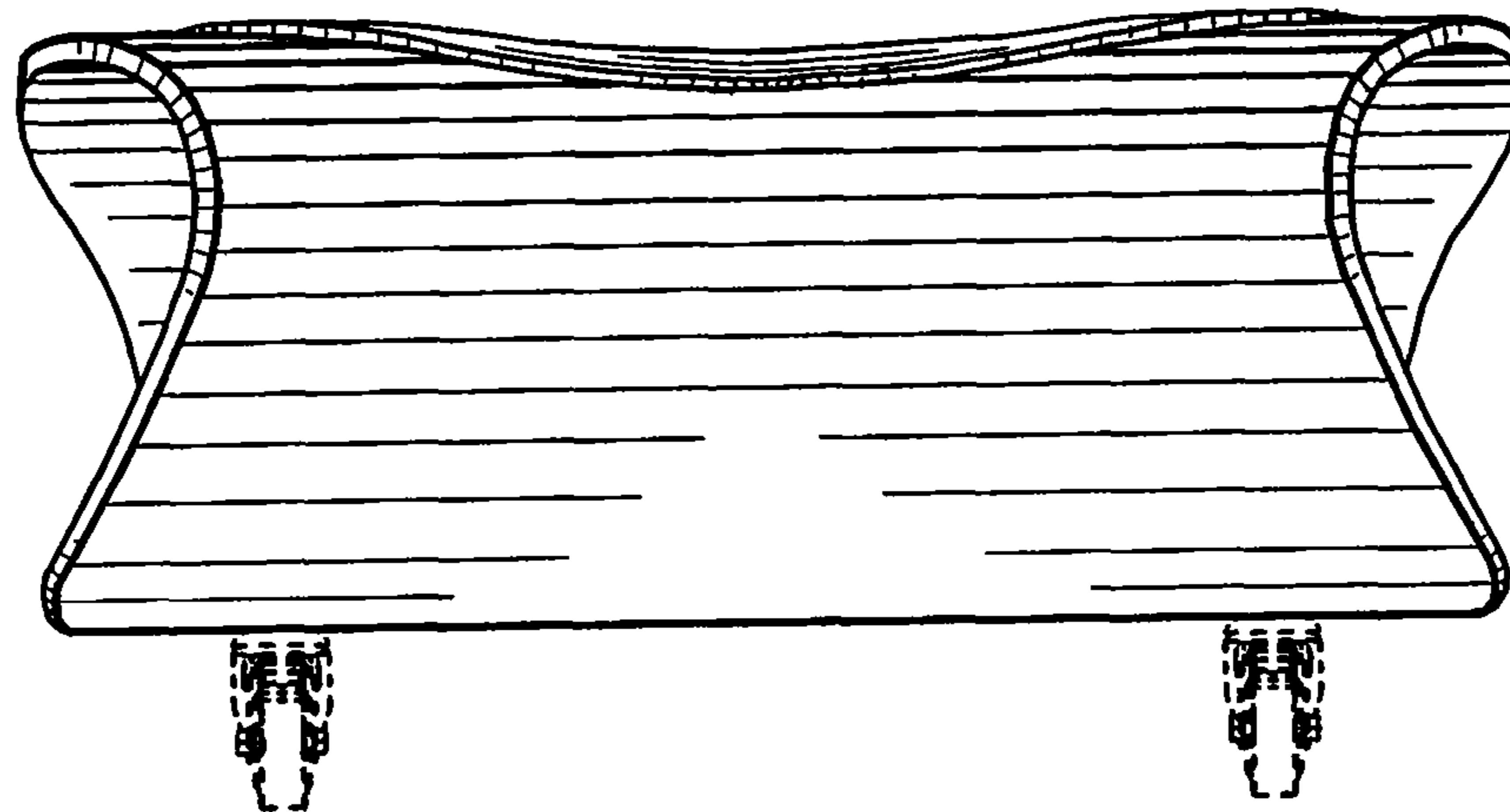

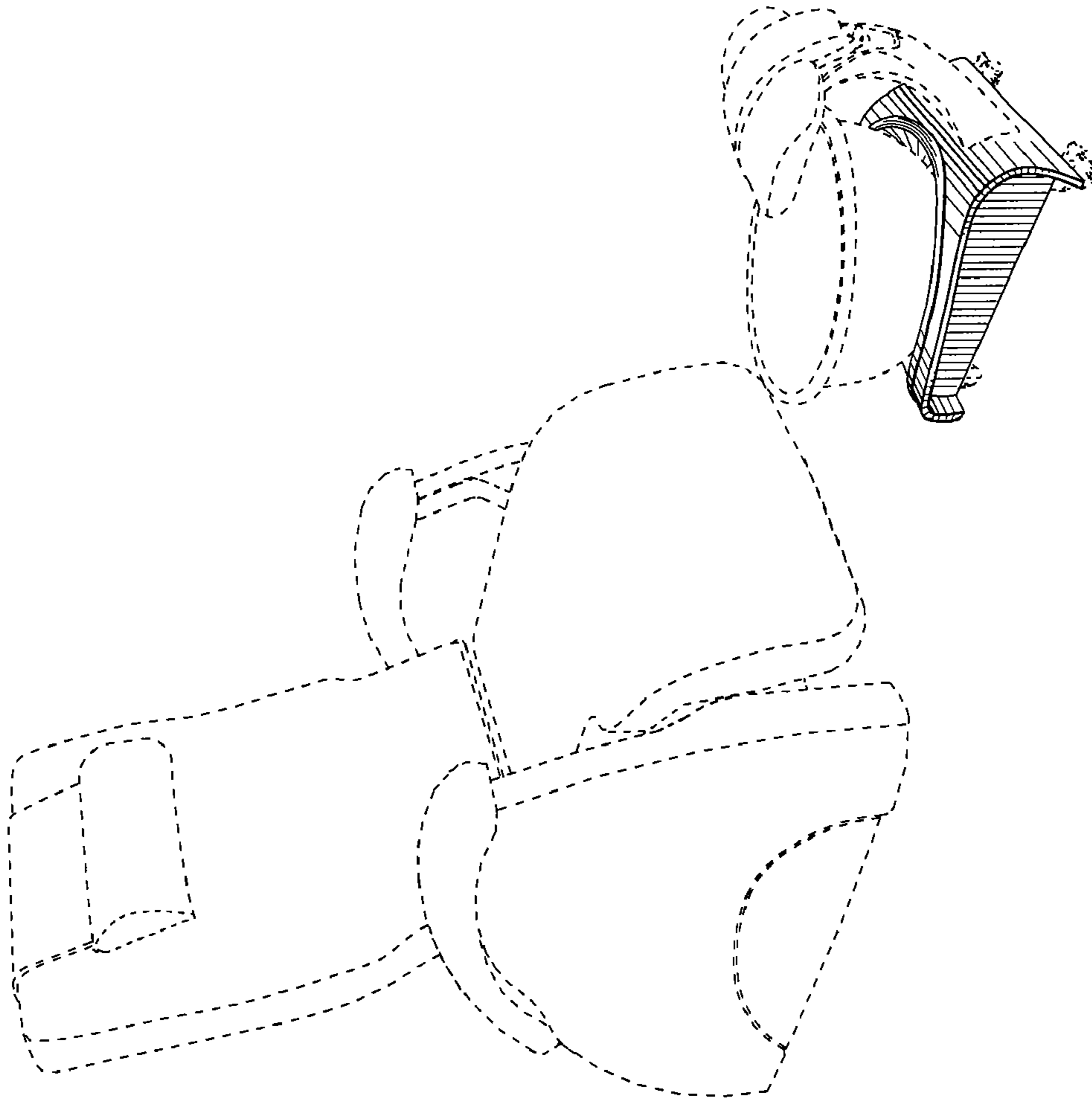
