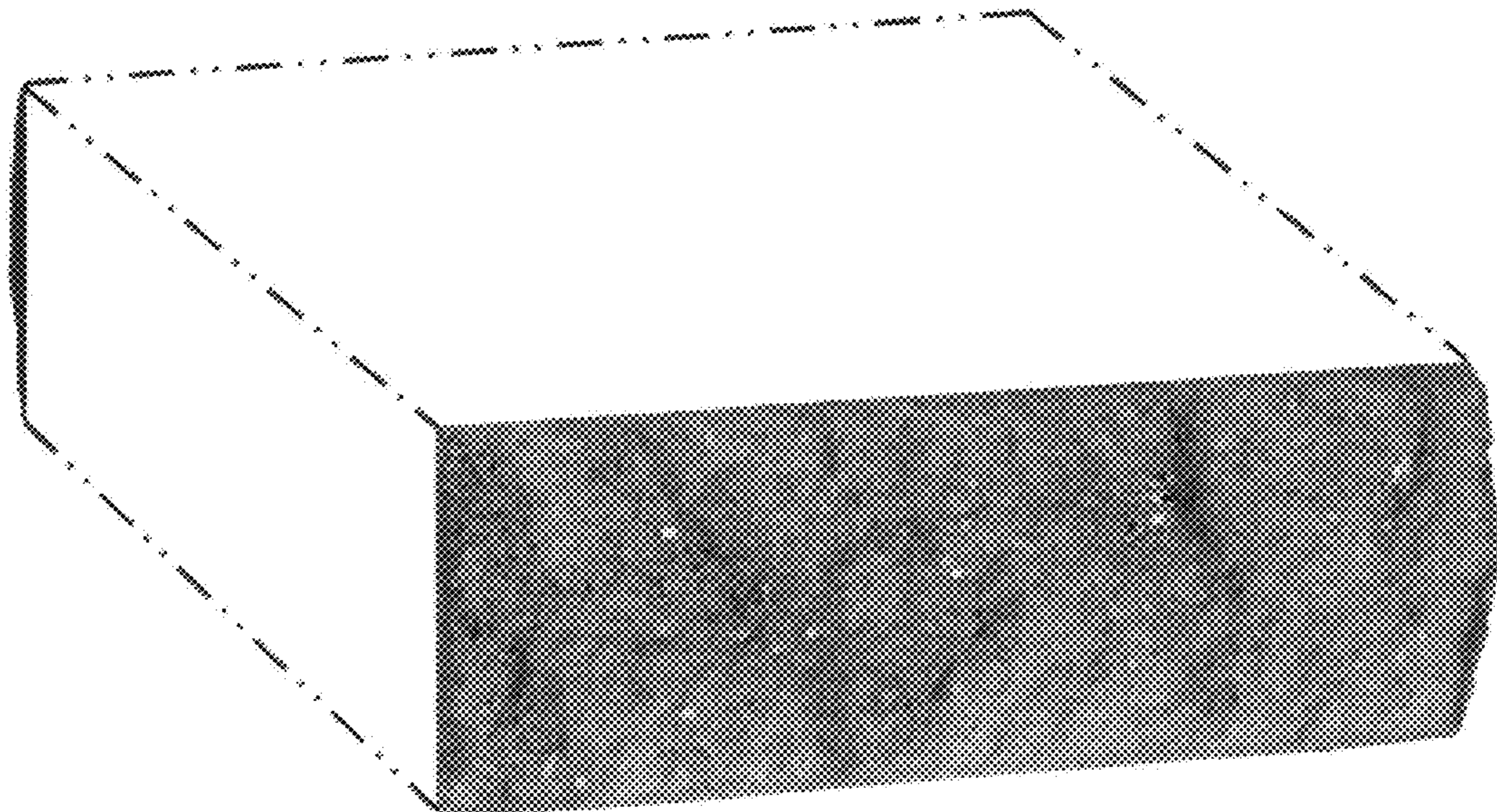
The ornamental design for a sculpted cap block, as shown and described.

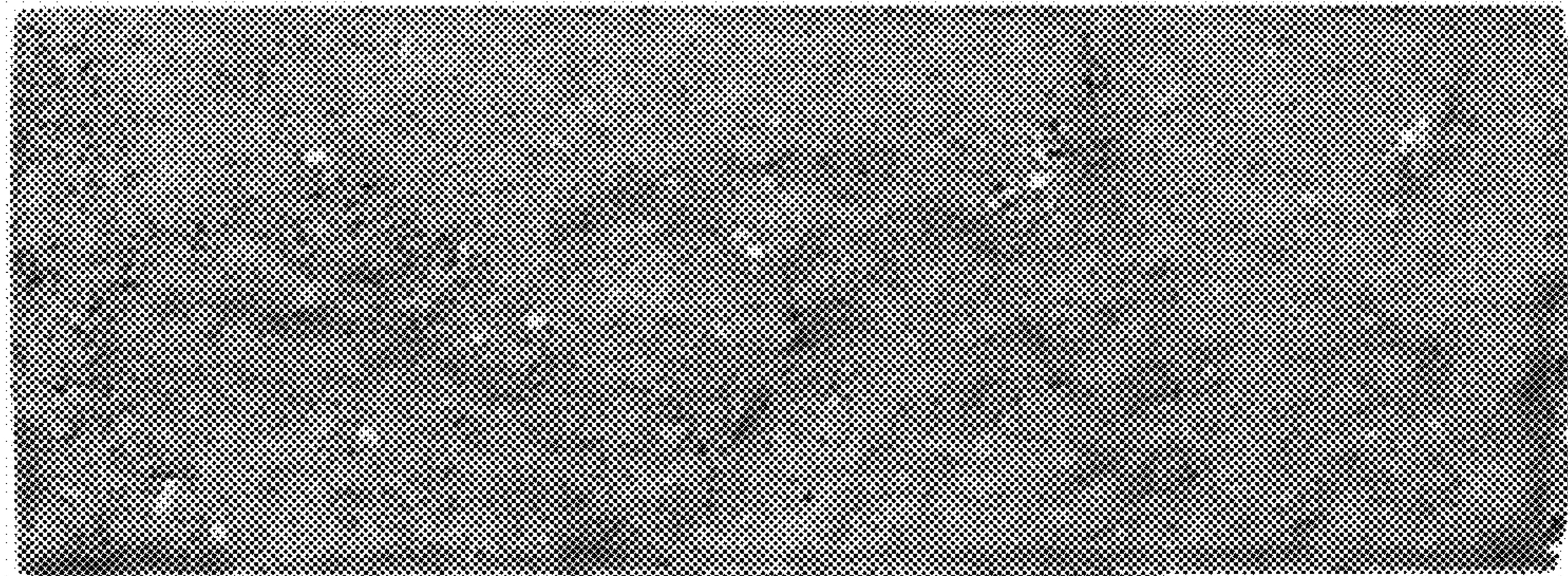

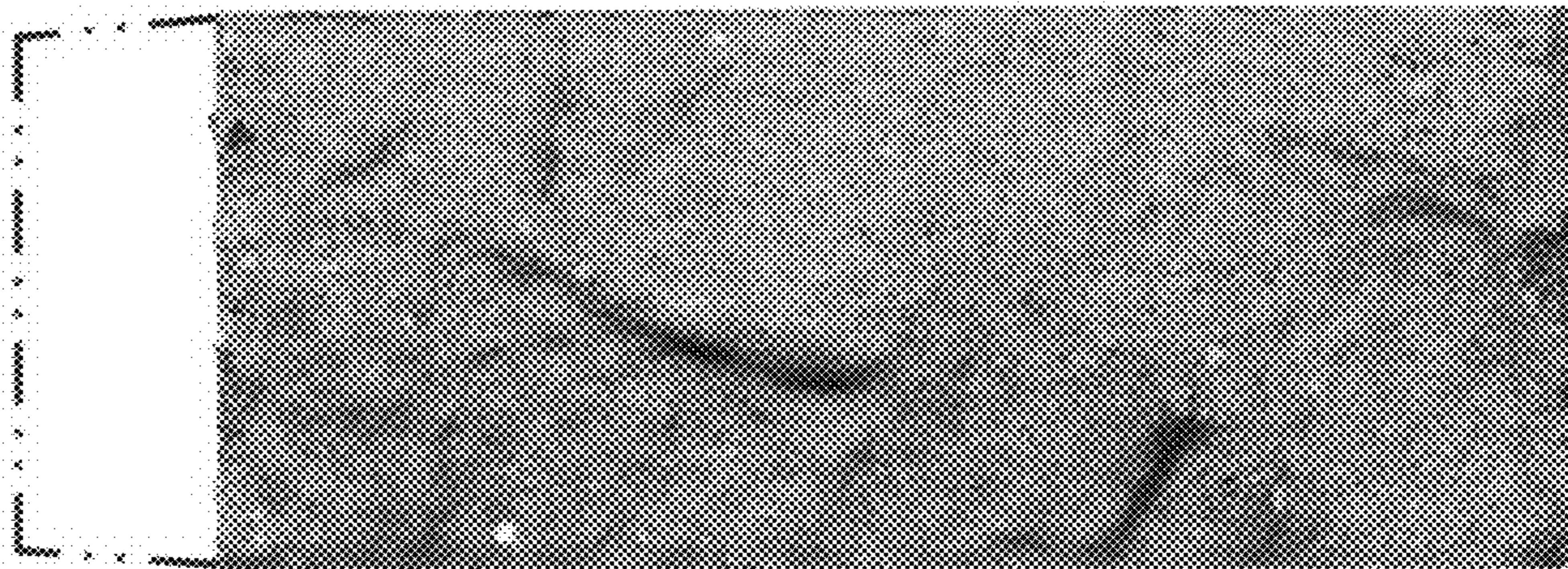

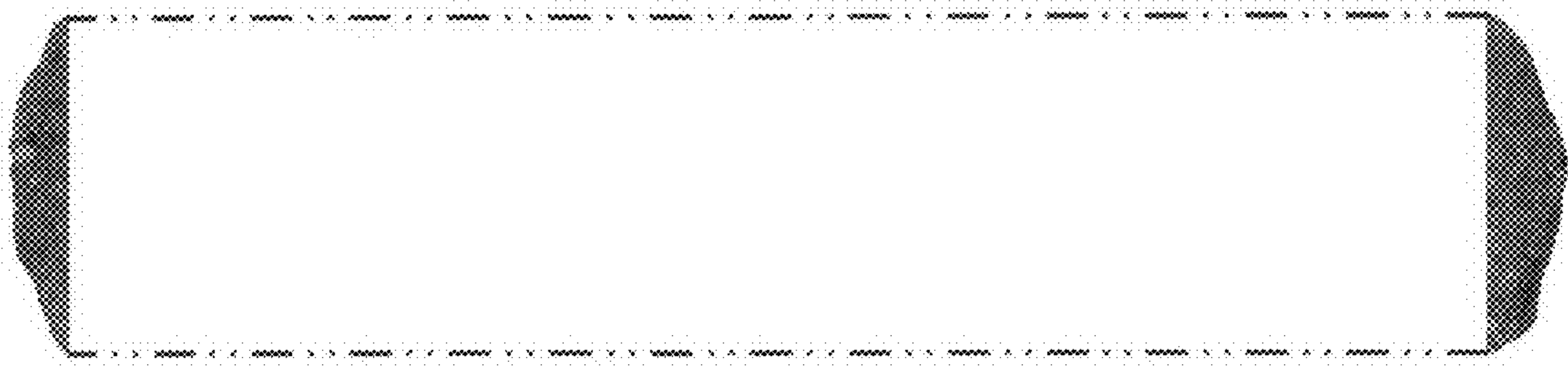

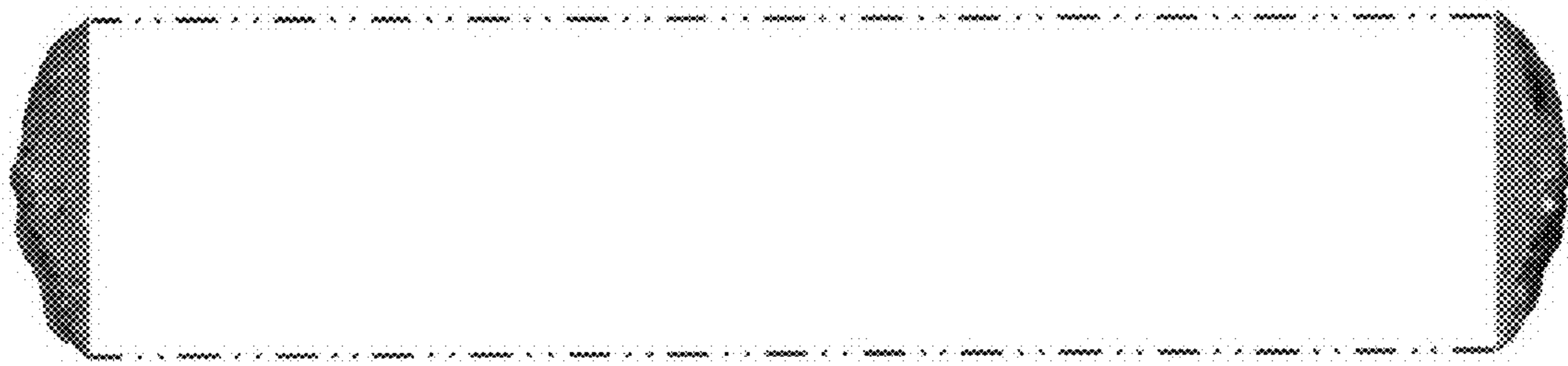

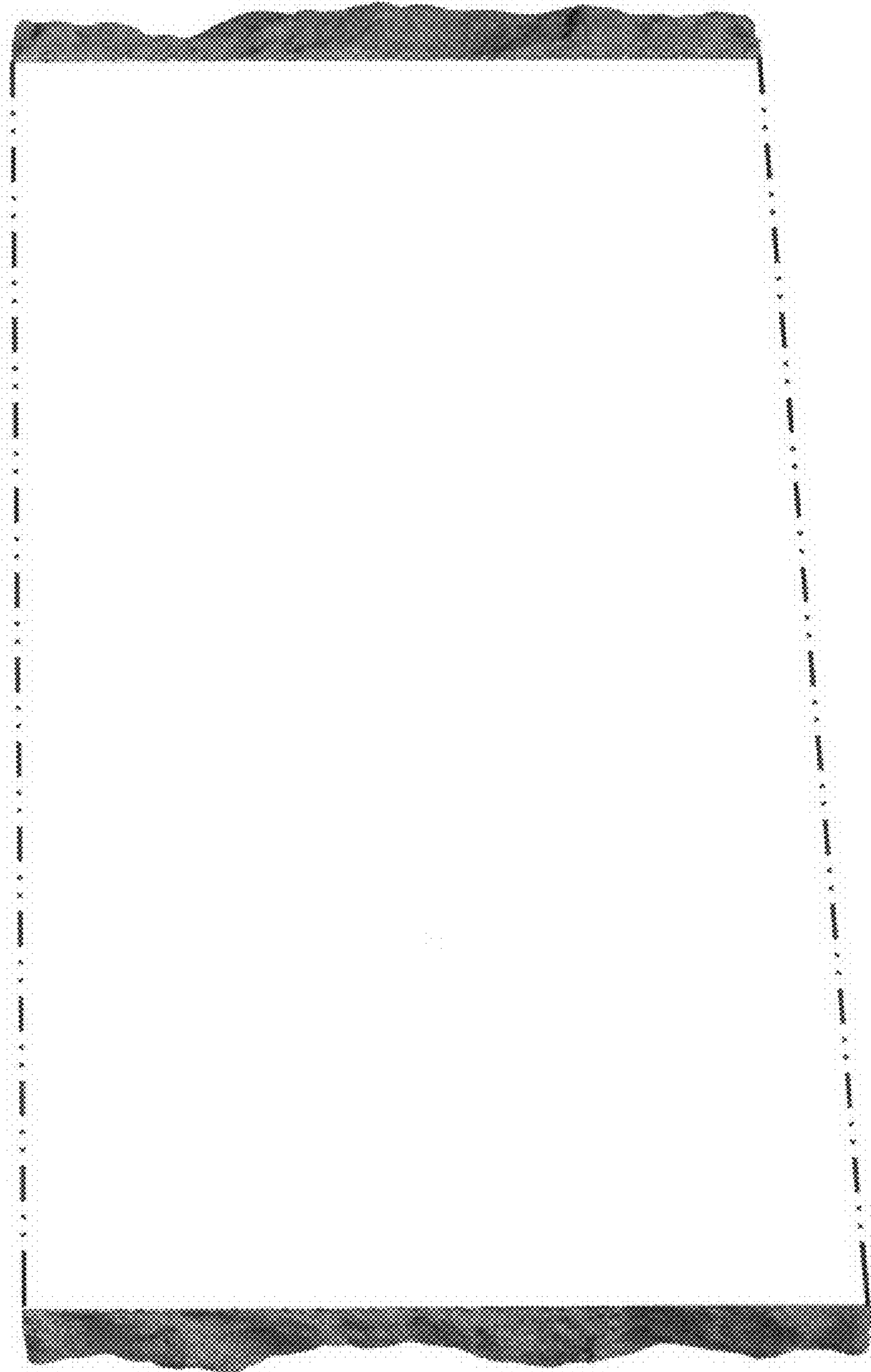

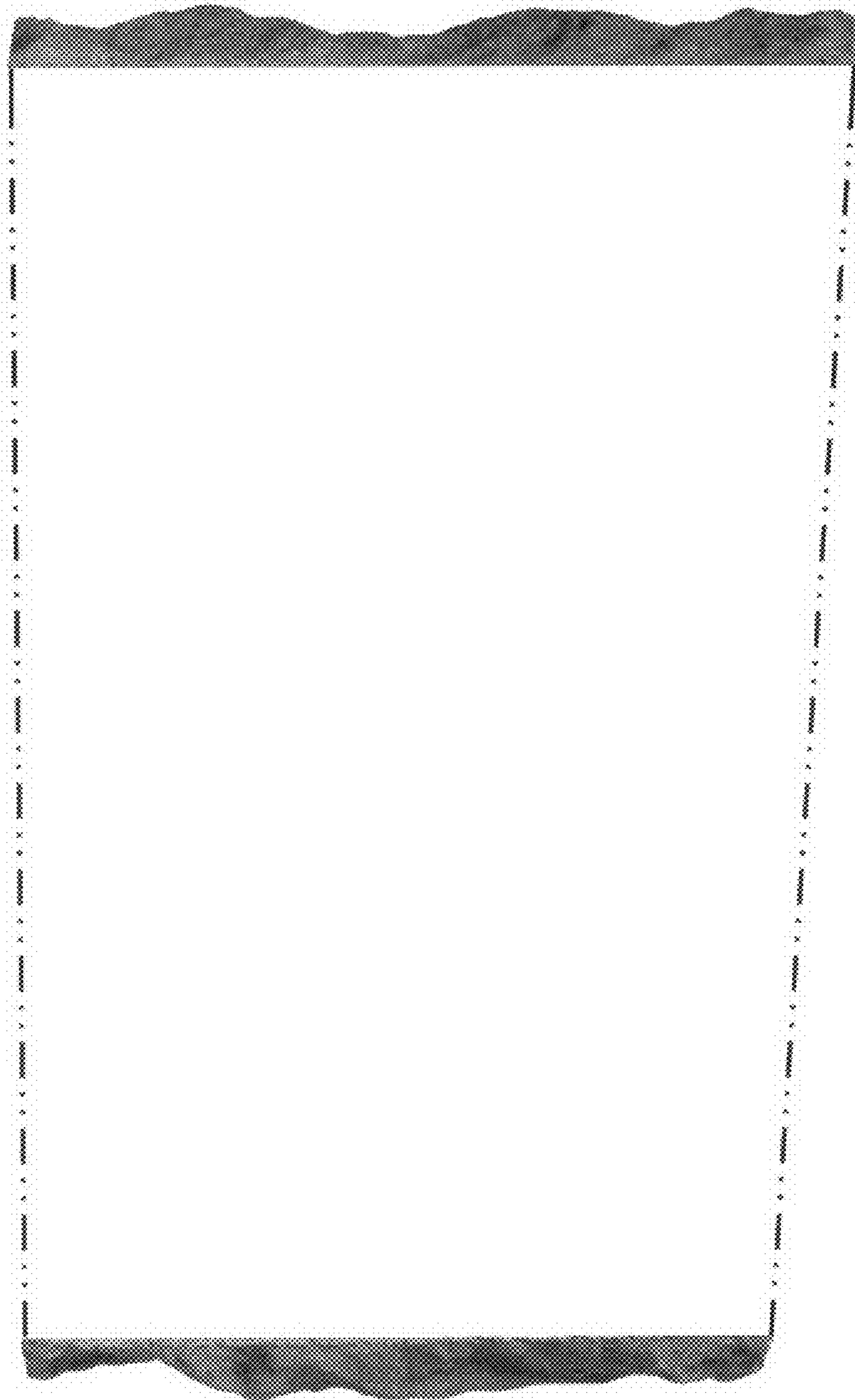
