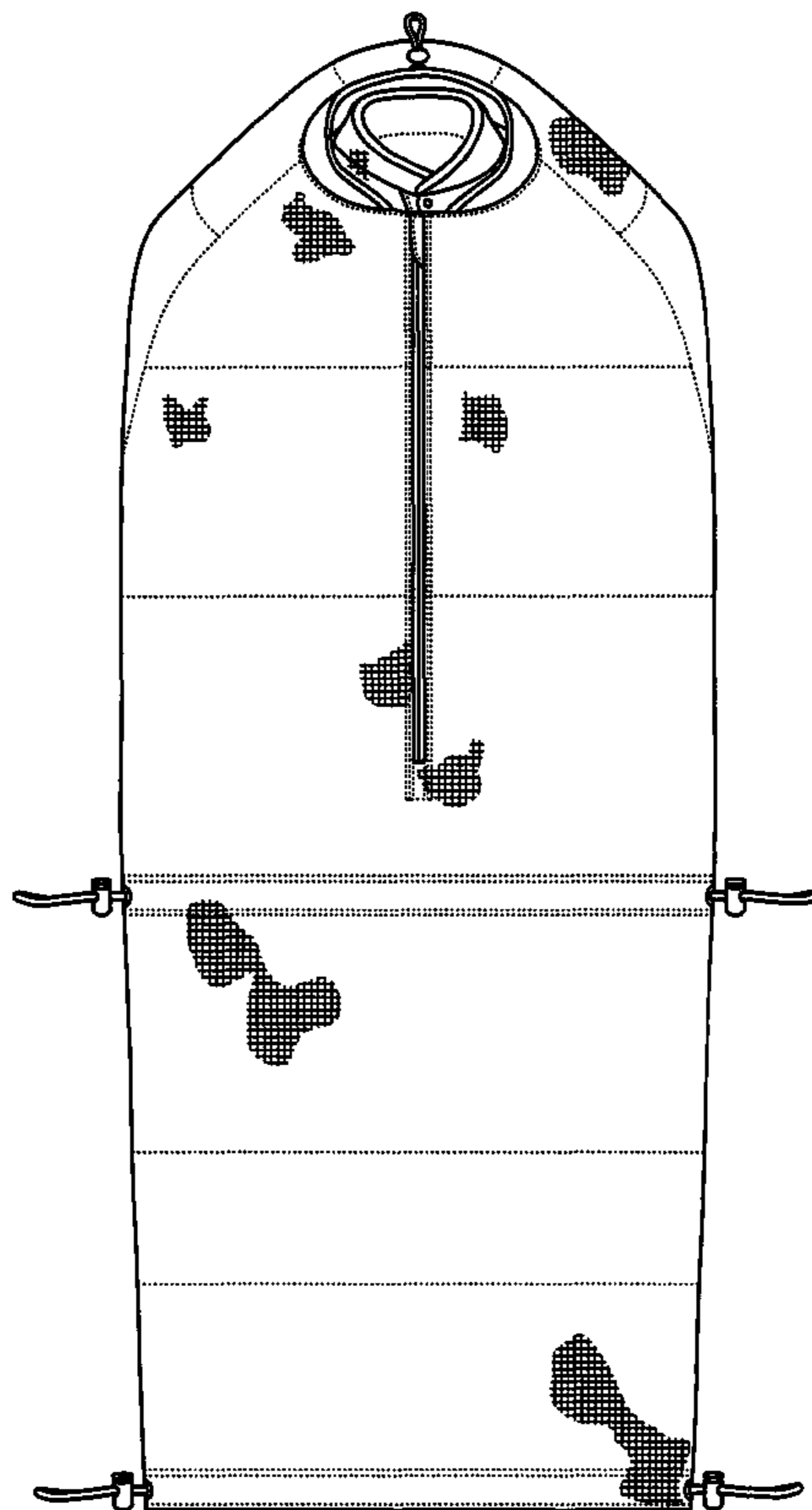
The ornamental design for a mobility sleeping bag, substantially as shown and described.

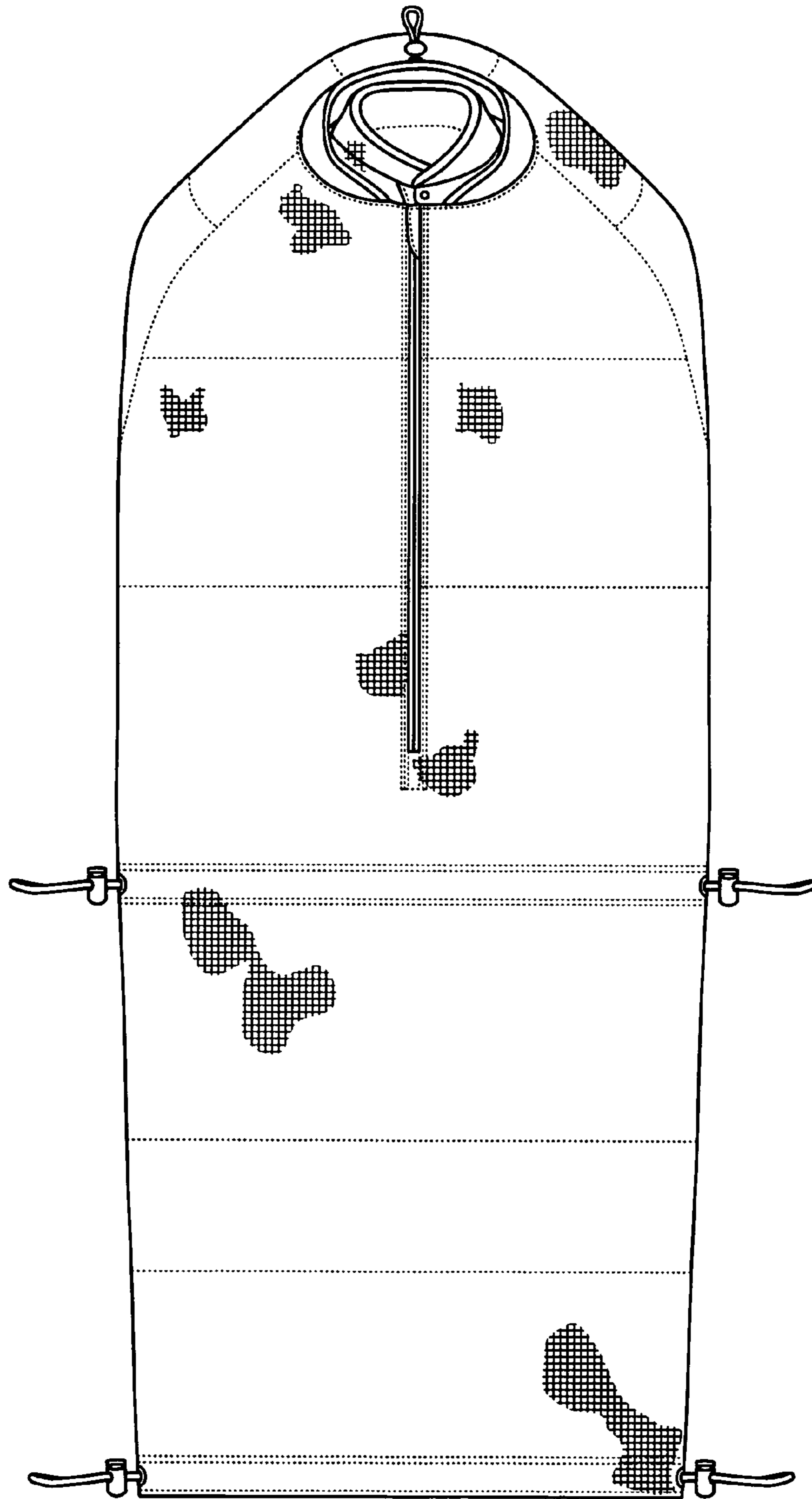
**DESCRIPTION**

FIG. 1 is a front elevational view of a mobility sleeping bag, showing our new design;

FIG. 7 is a front elevational view thereof, showing the inner collar in a retraced position.

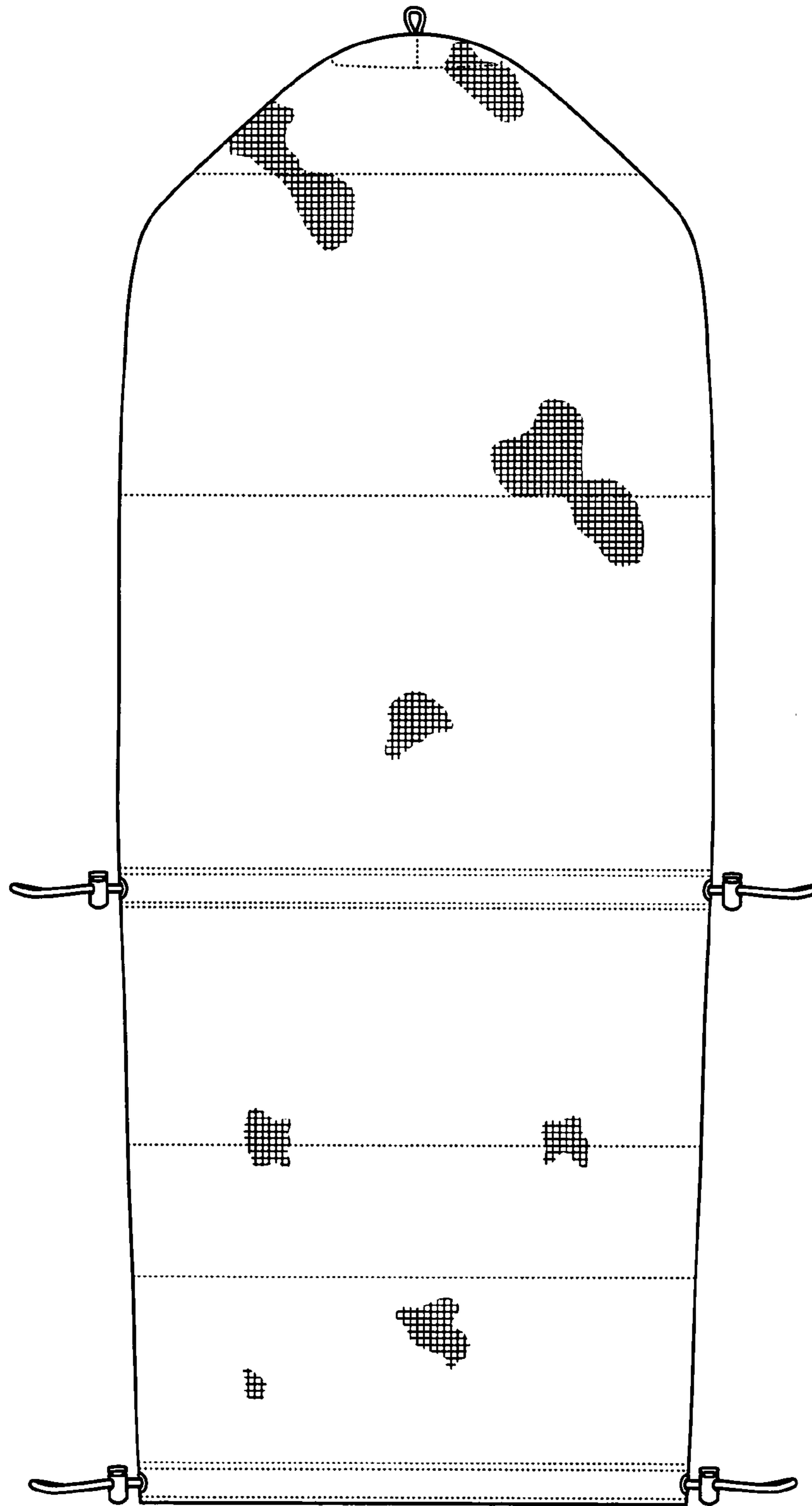
The broken lines shown throughout the various figures represent stitching.

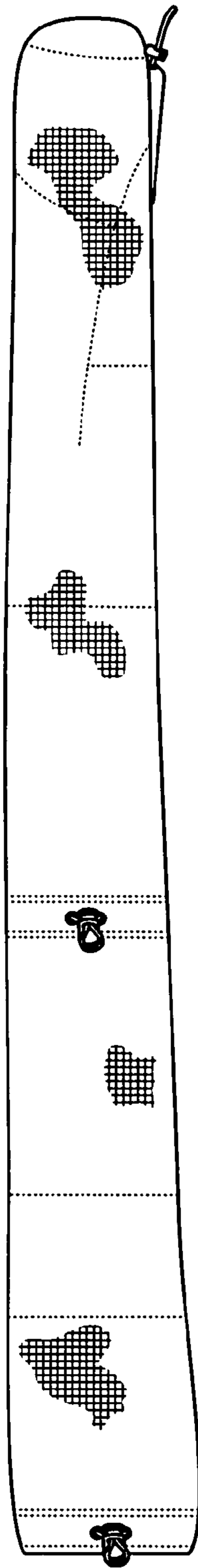




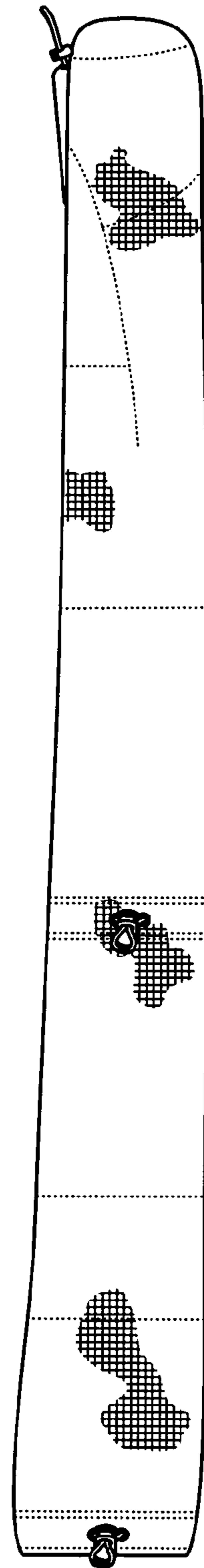

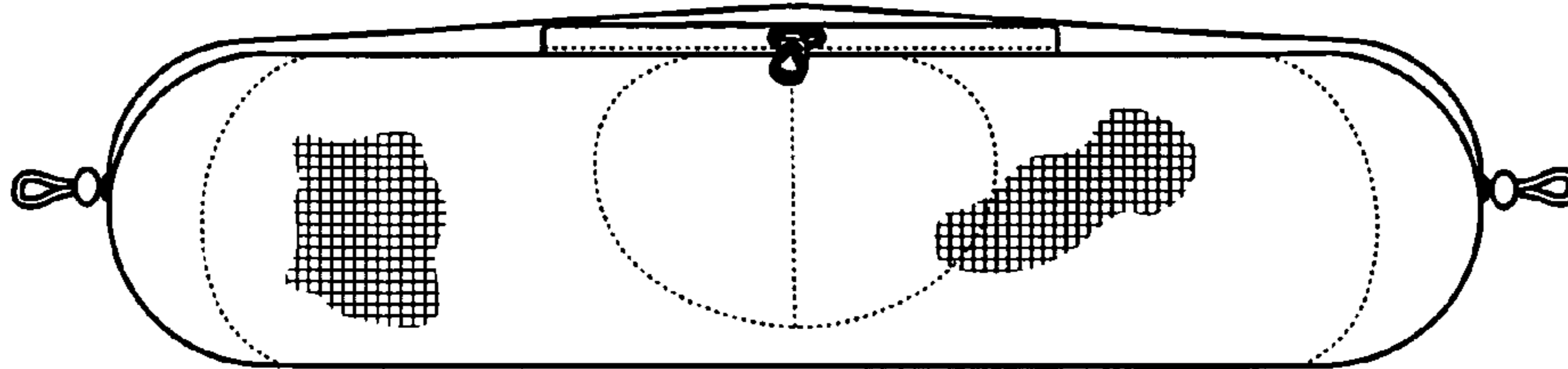

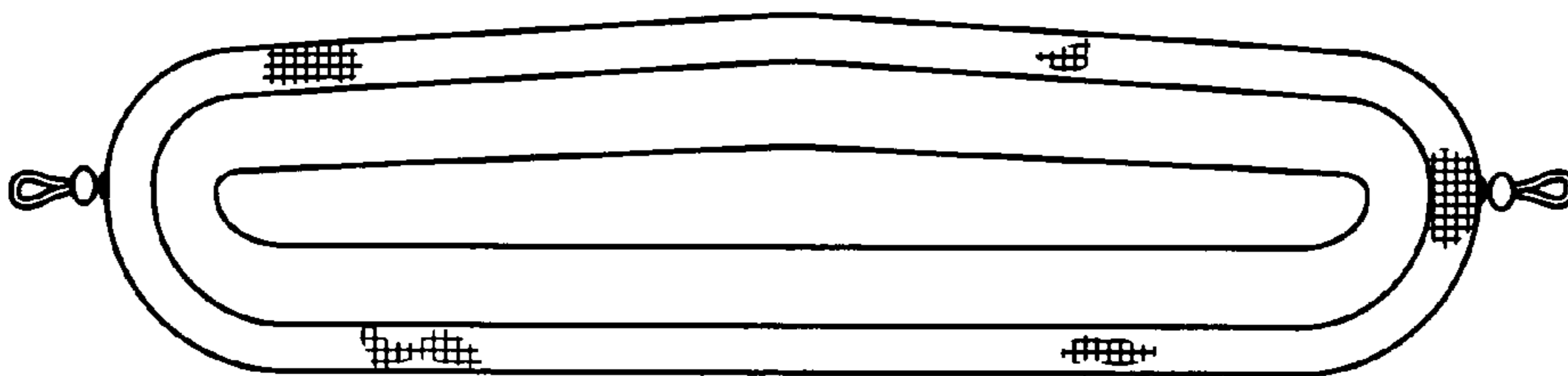

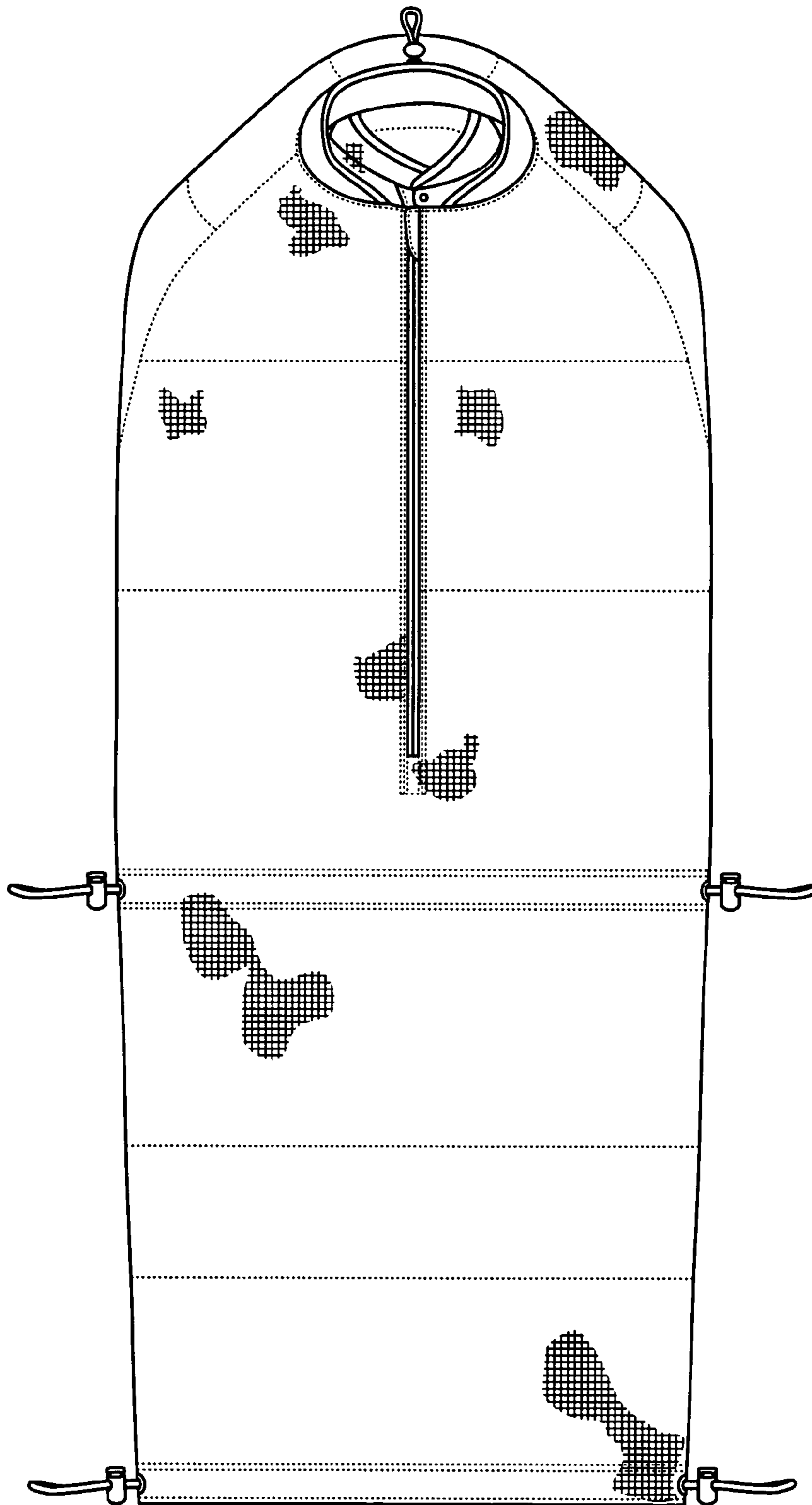
