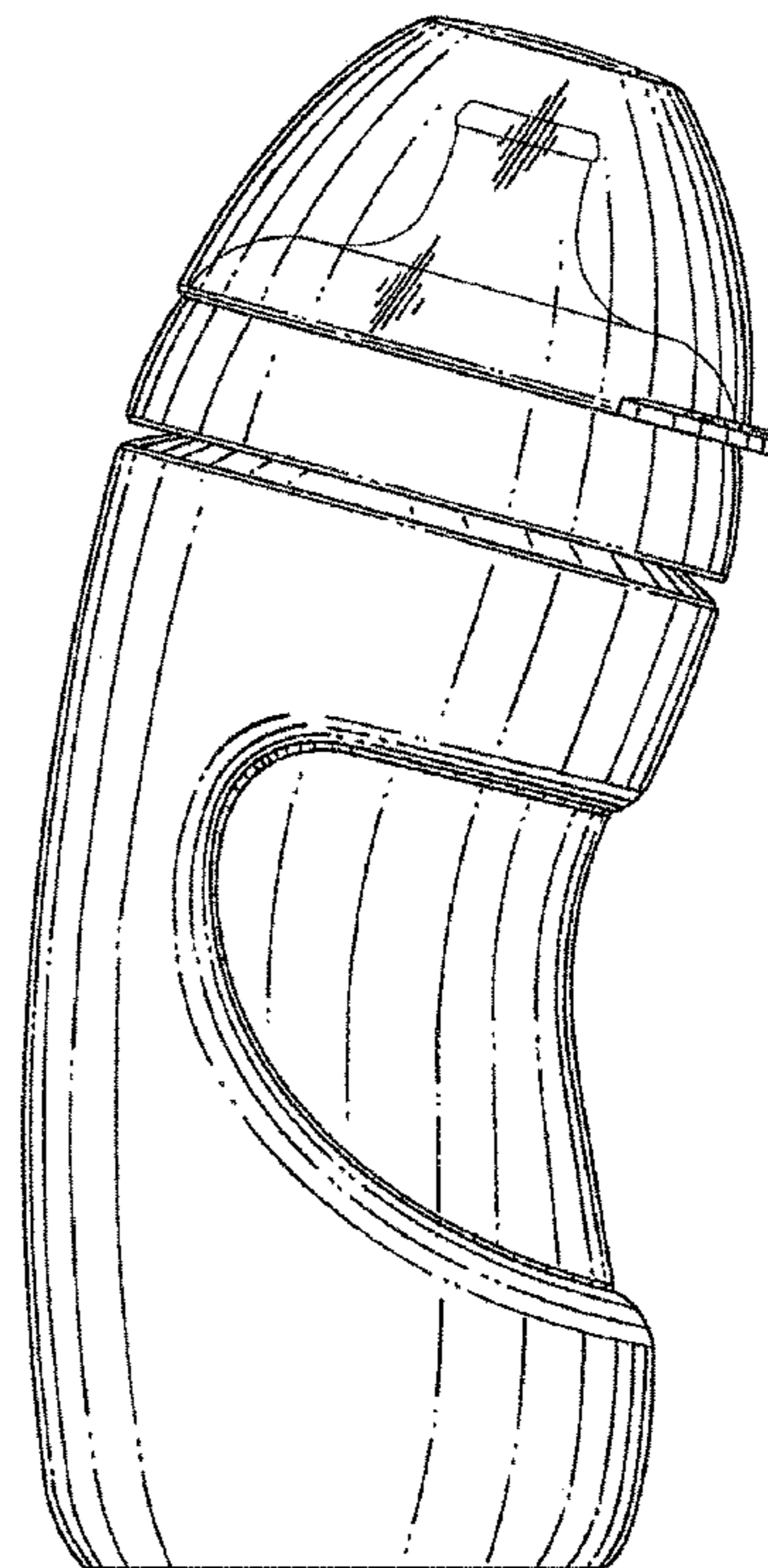
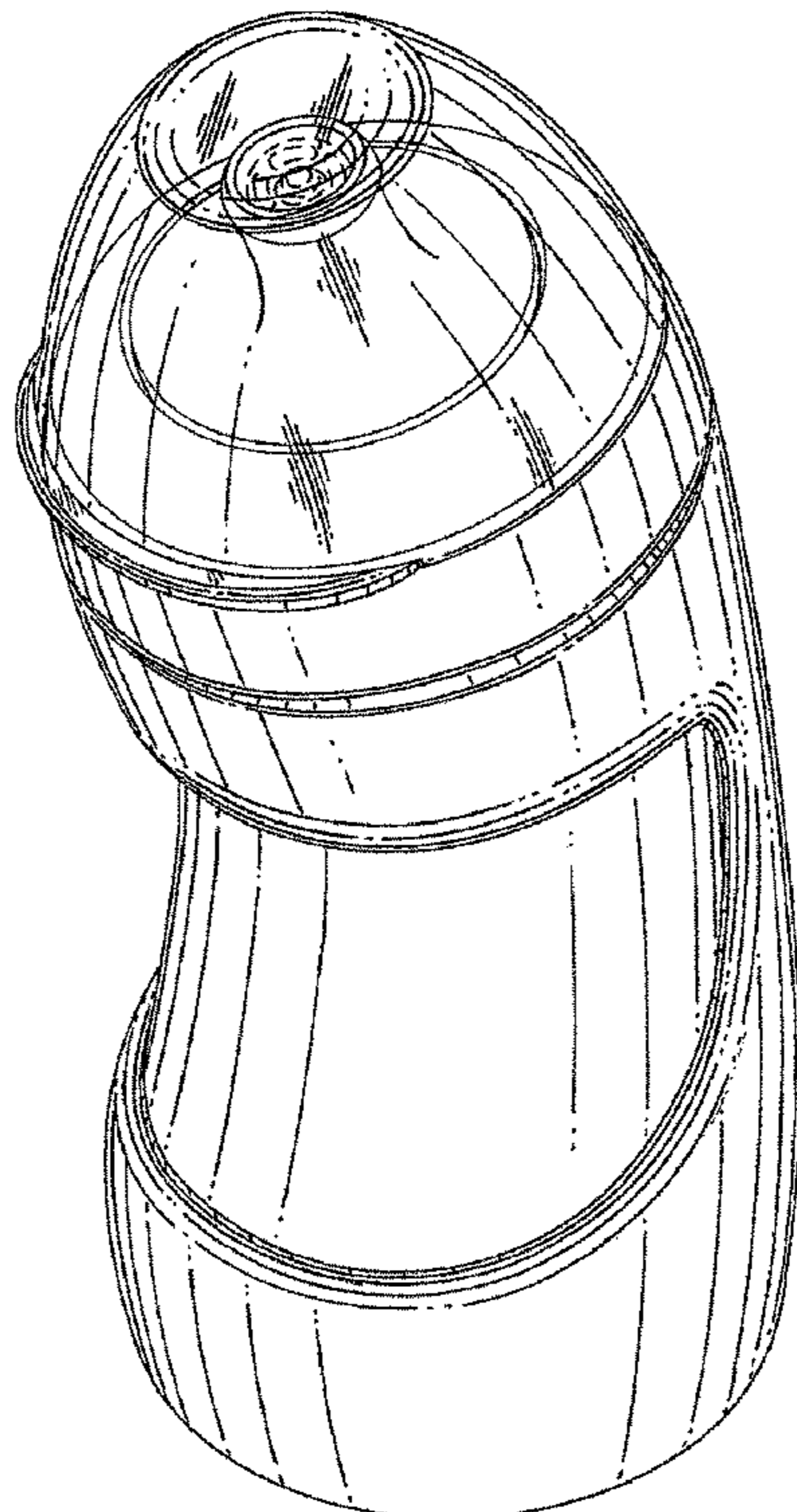
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, left side and front perspective view showing a drinking cup of our new invention, FIG. 2 is a front elevation view thereof, FIG. 3 is a right side elevation view thereof, FIG. 4 is a left side elevation view thereof, FIG. 5 is a rear elevation view thereof, FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings are included for the purpose of illustration and form no part of the claimed design.

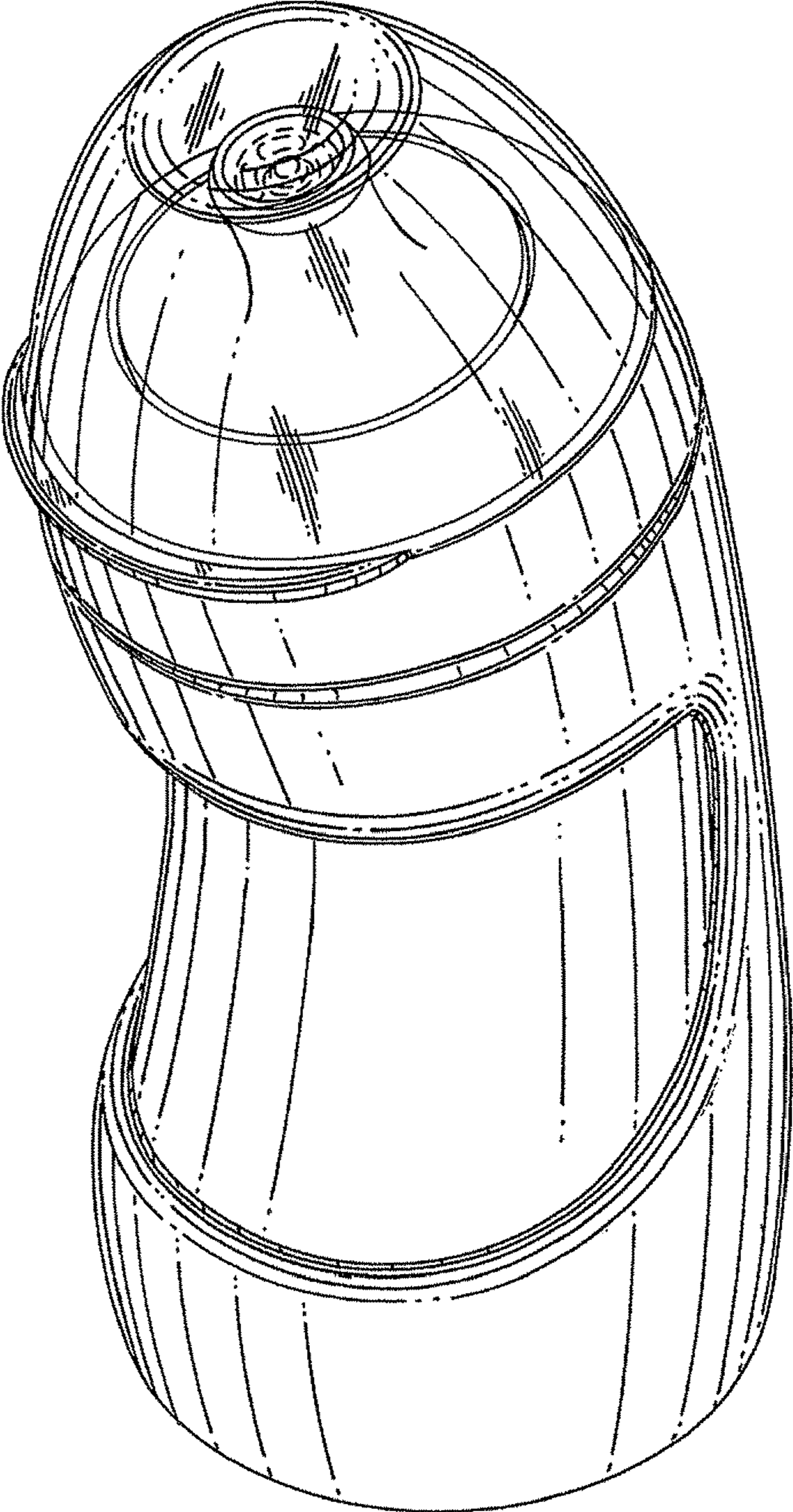
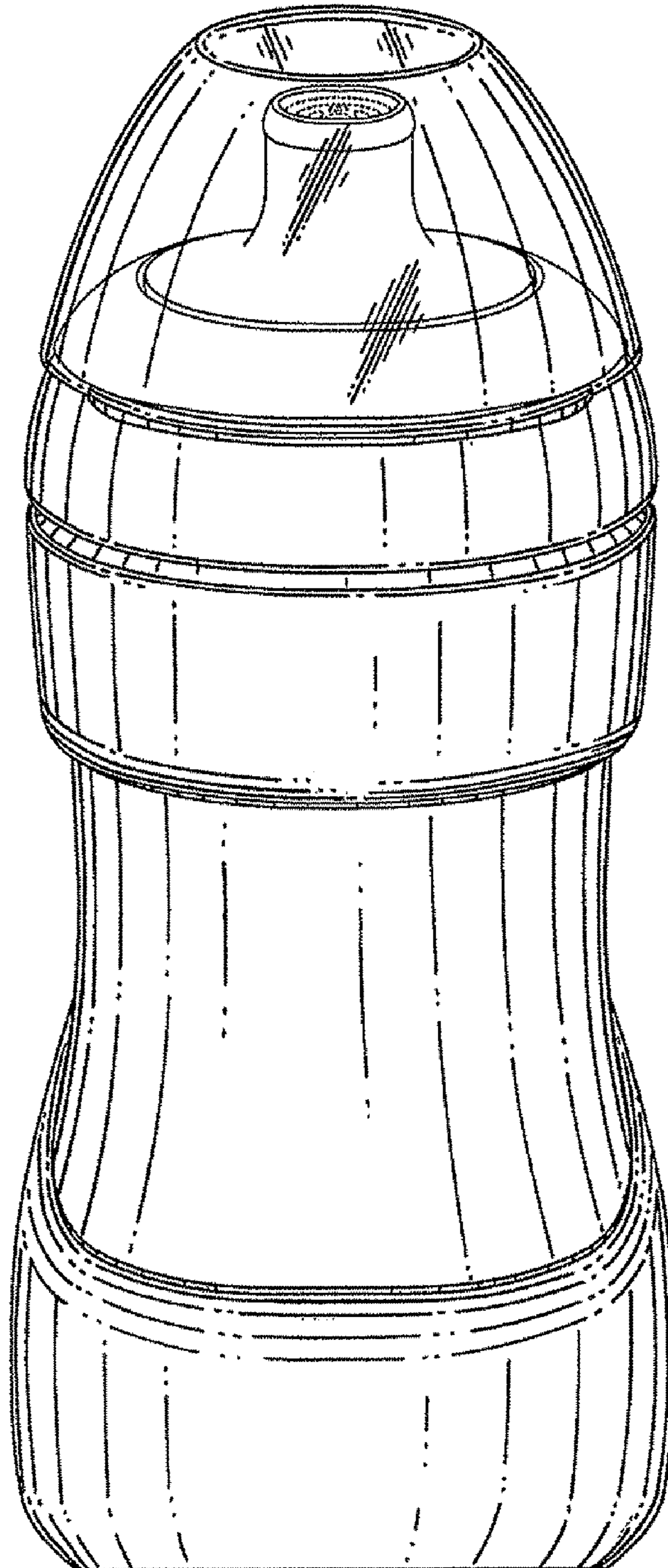

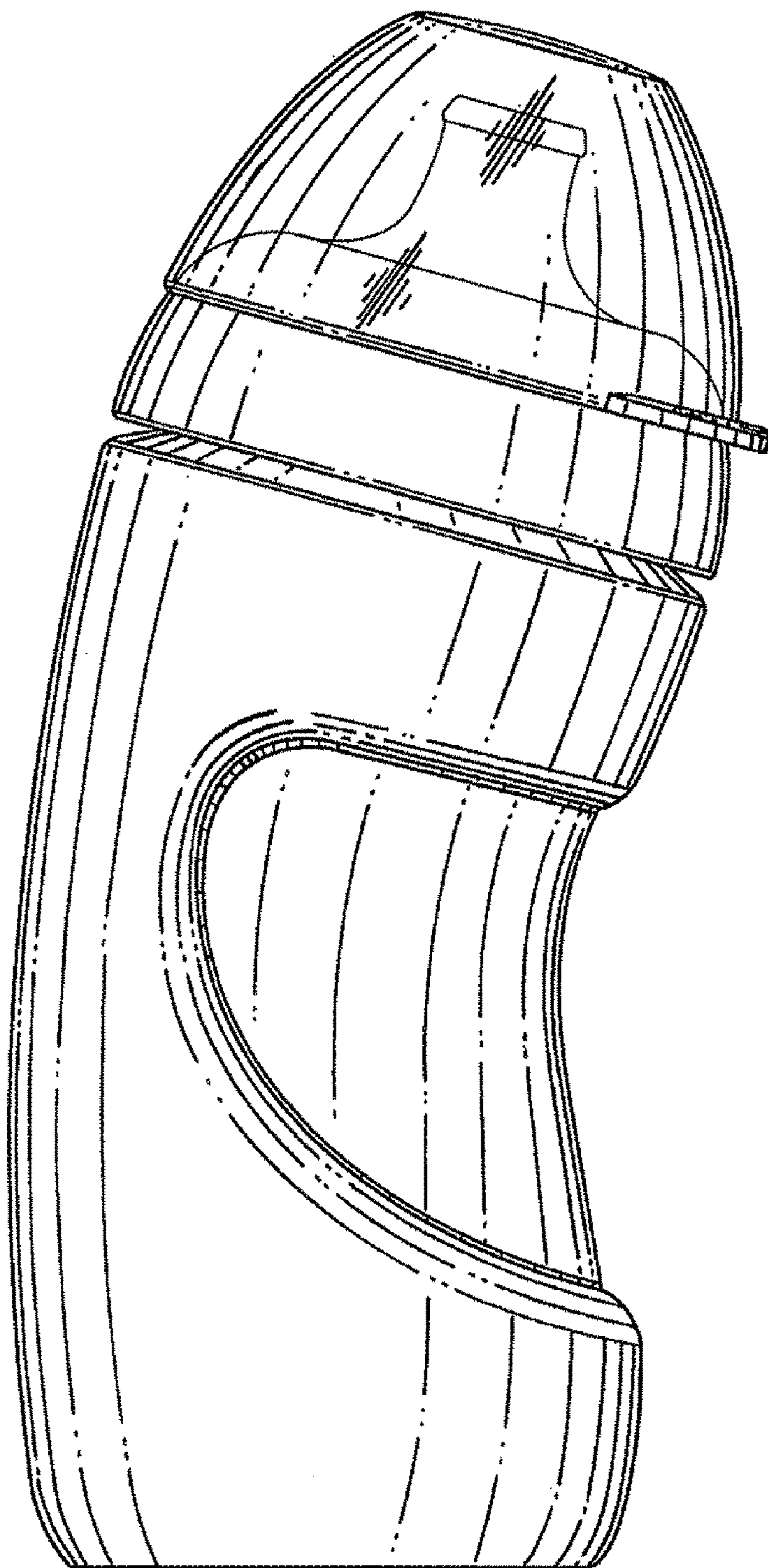

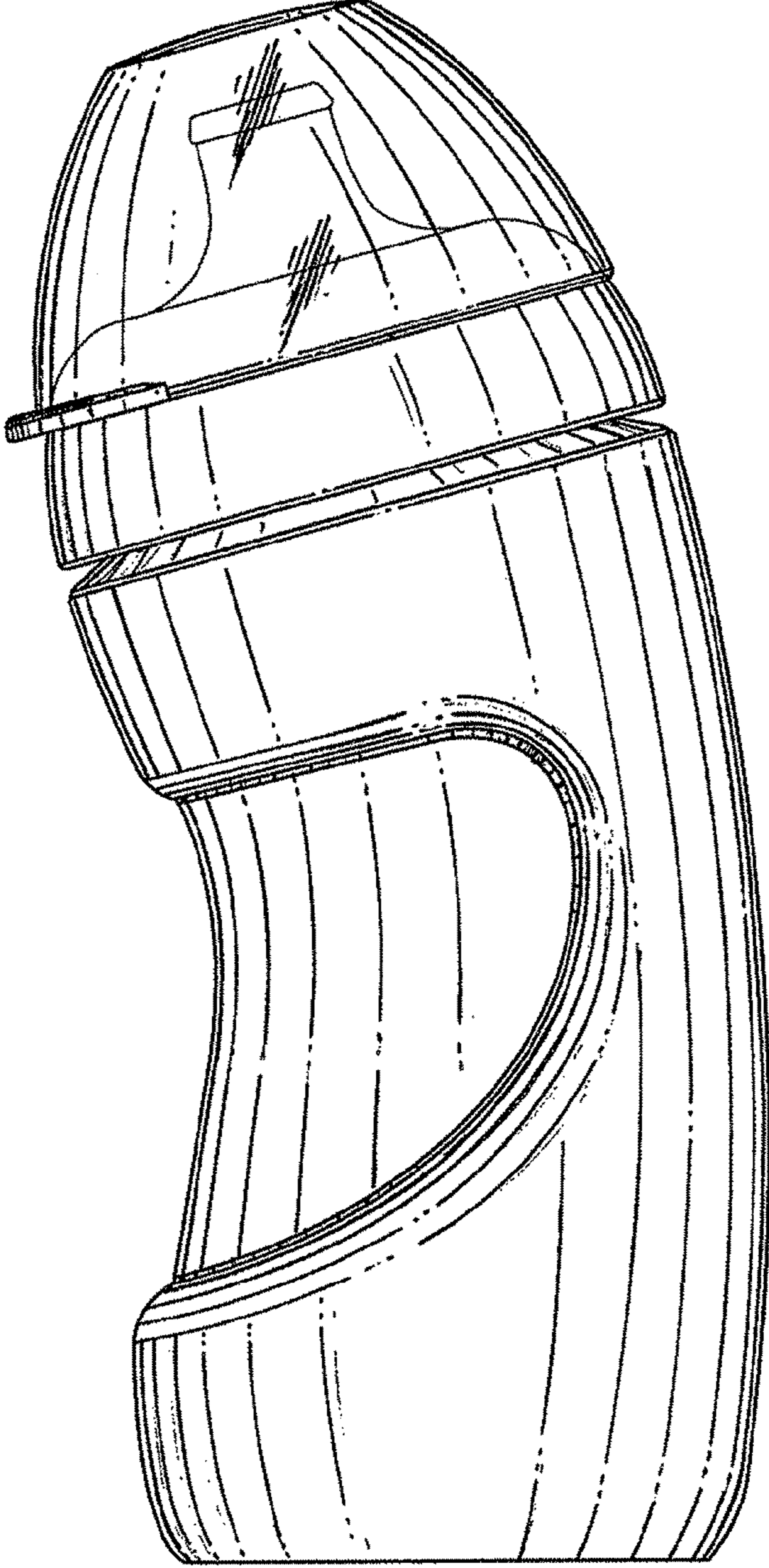
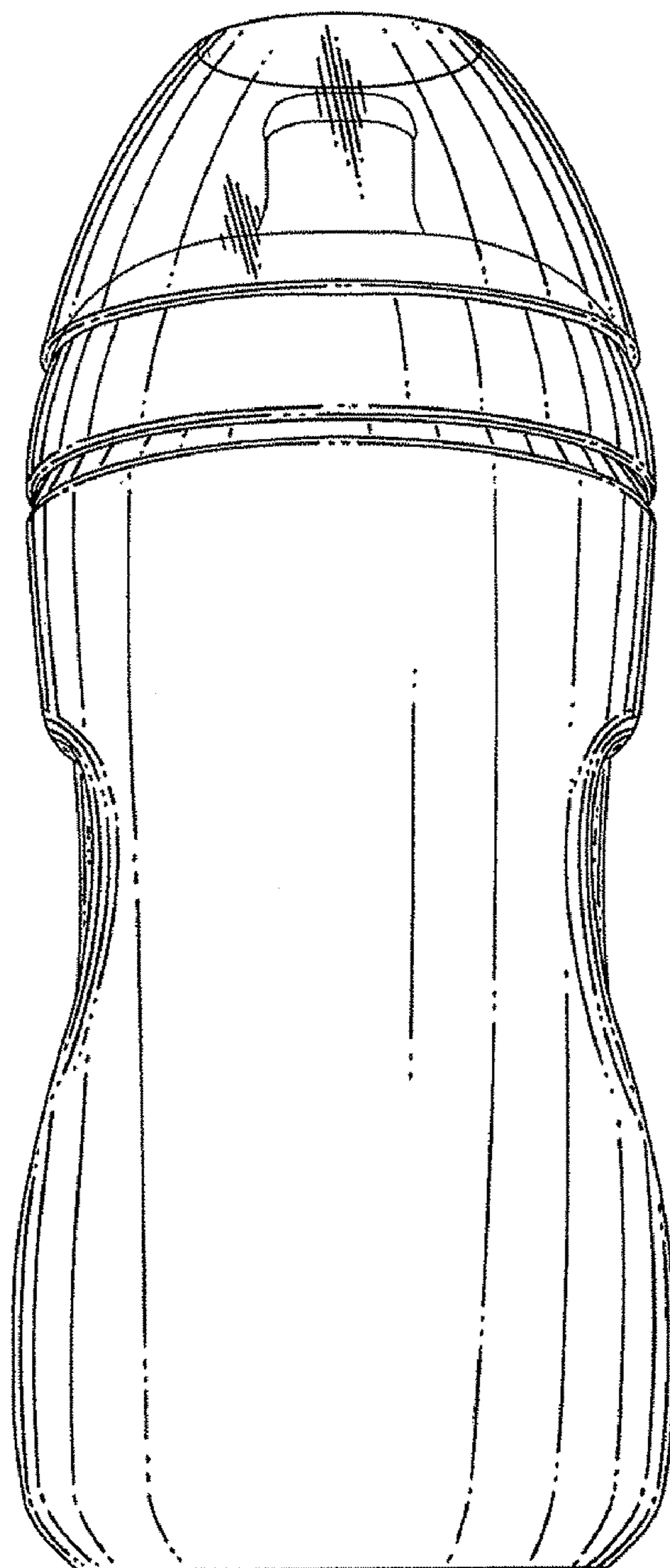
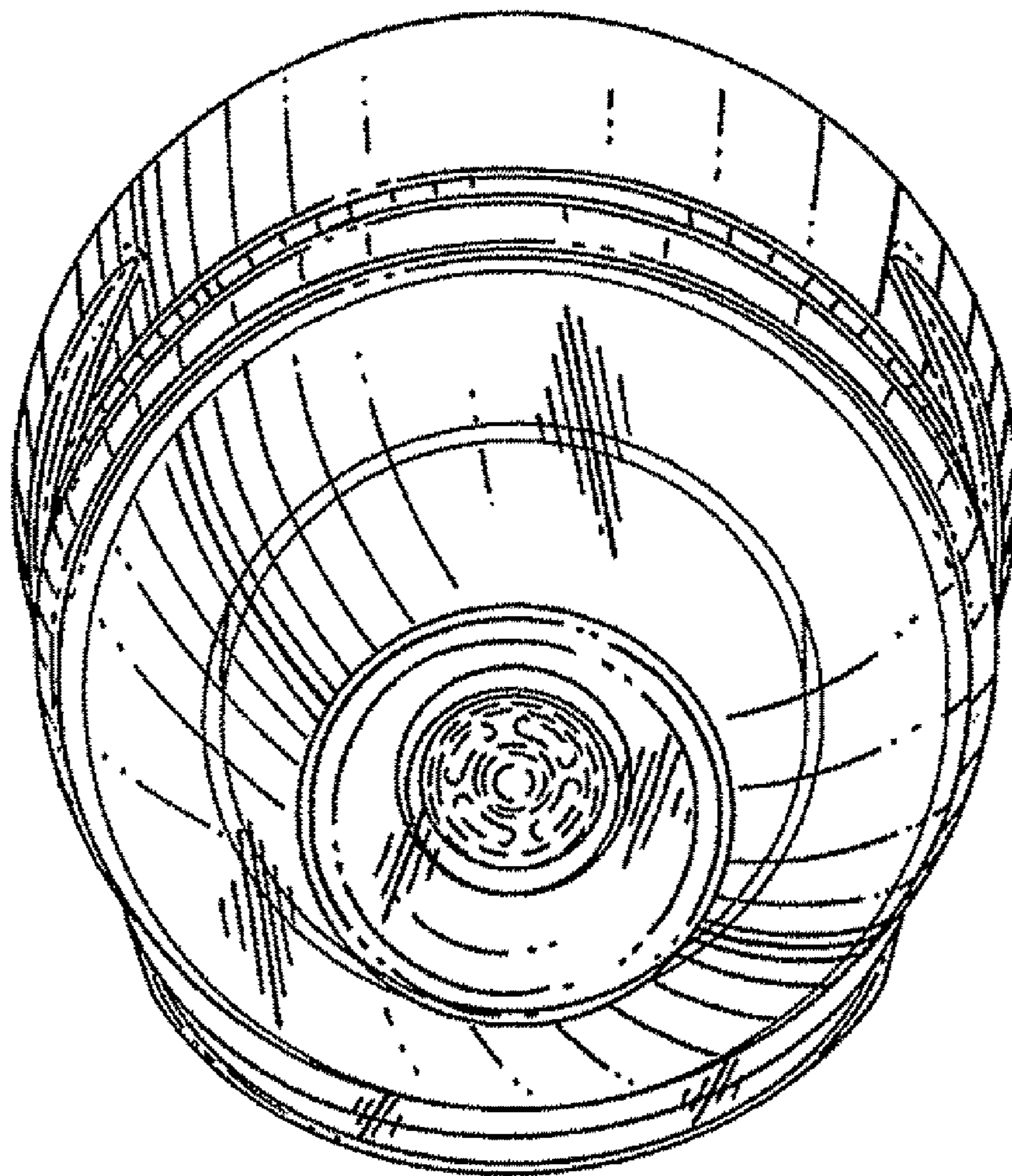


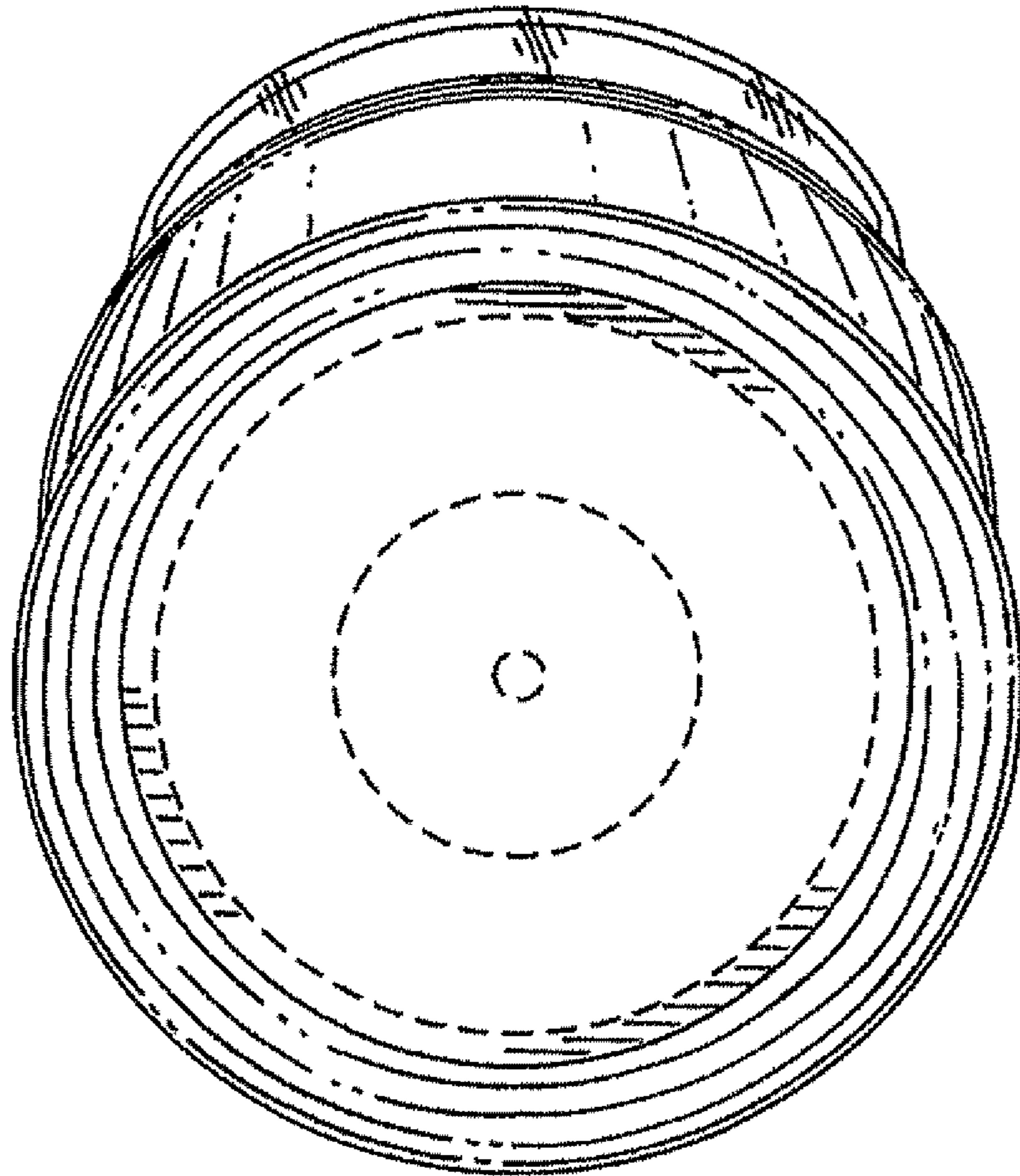
