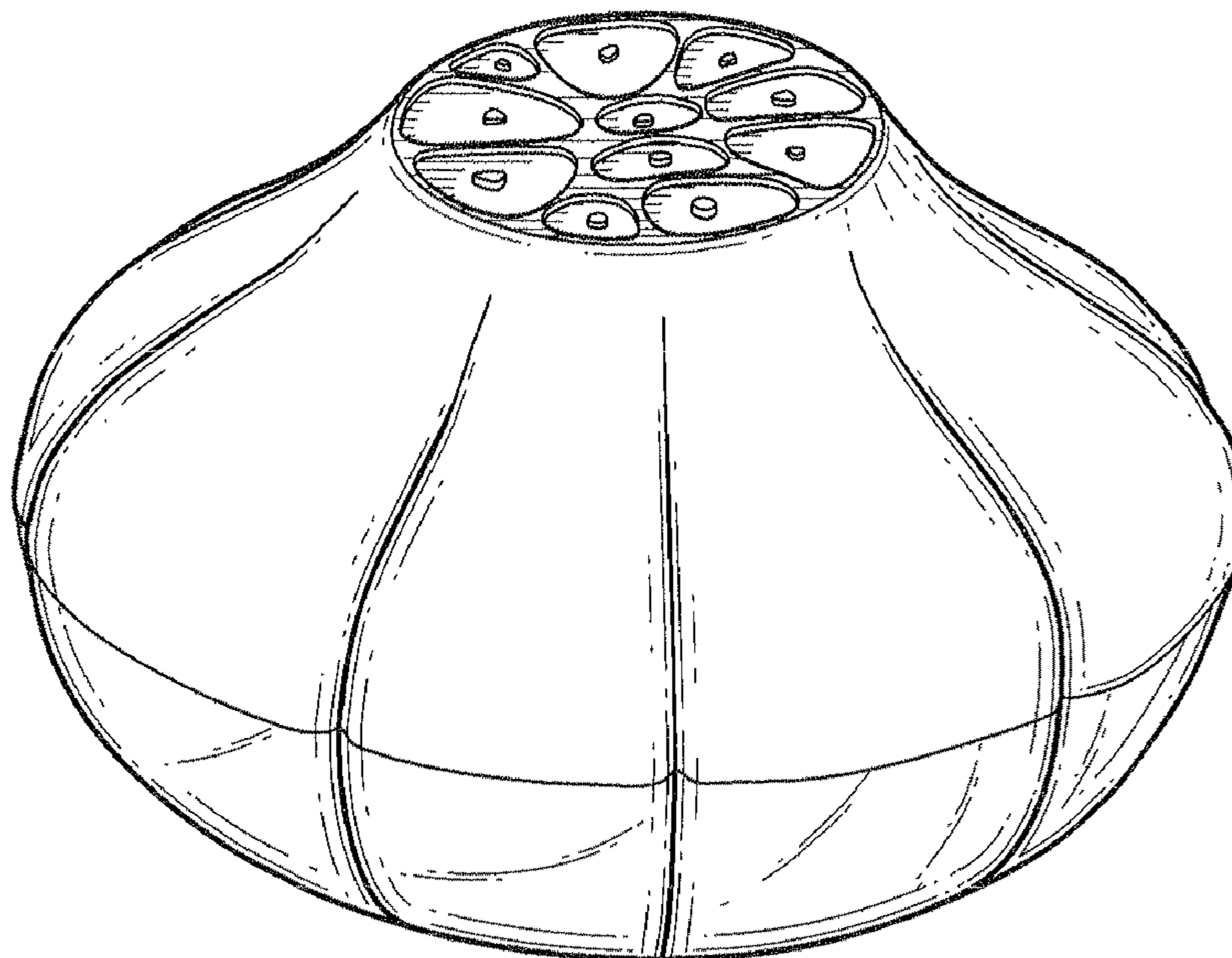
(57) **CLAIM**

We claim the ornamental design for a garlic saver, as shown and described.

**DESCRIPTION**

FIG. 1 is a three-quarter top, front, right side perspective view of a garlic saver showing our new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a left side view thereof;  
 FIG. 4 is a right side view thereof;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is a cross sectional view taken along line VIII-VIII of FIG. 4 of an interior view of the base of the garlic saver shown separately from the top;  
 FIG. 9 is an interior view of the top of the garlic saver shown separately from the base;  
 FIG. 10 is a cross sectional view taken along line x-x of FIG. 6; and,  
 FIG. 11 is a three-quarter bottom perspective view thereof.

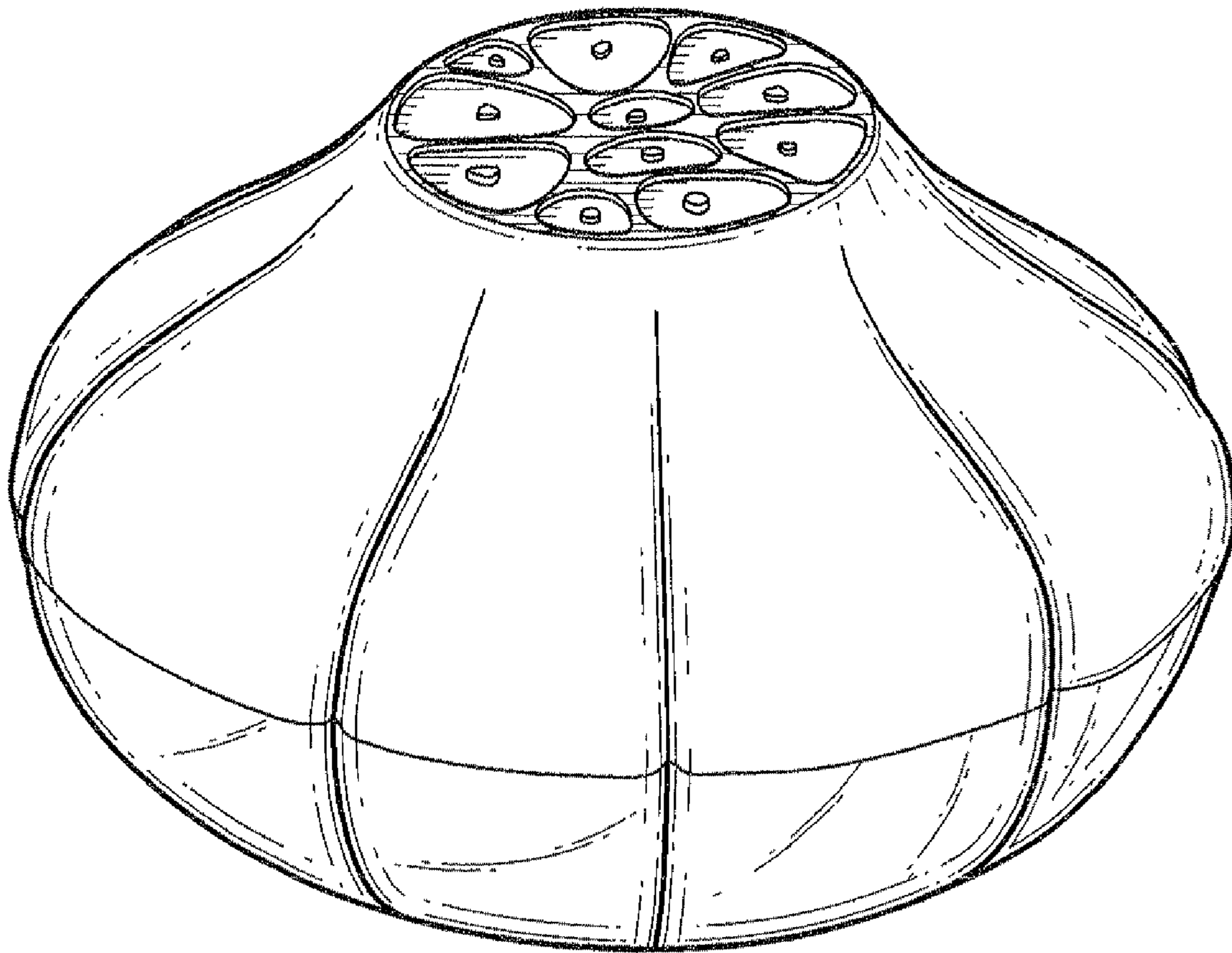

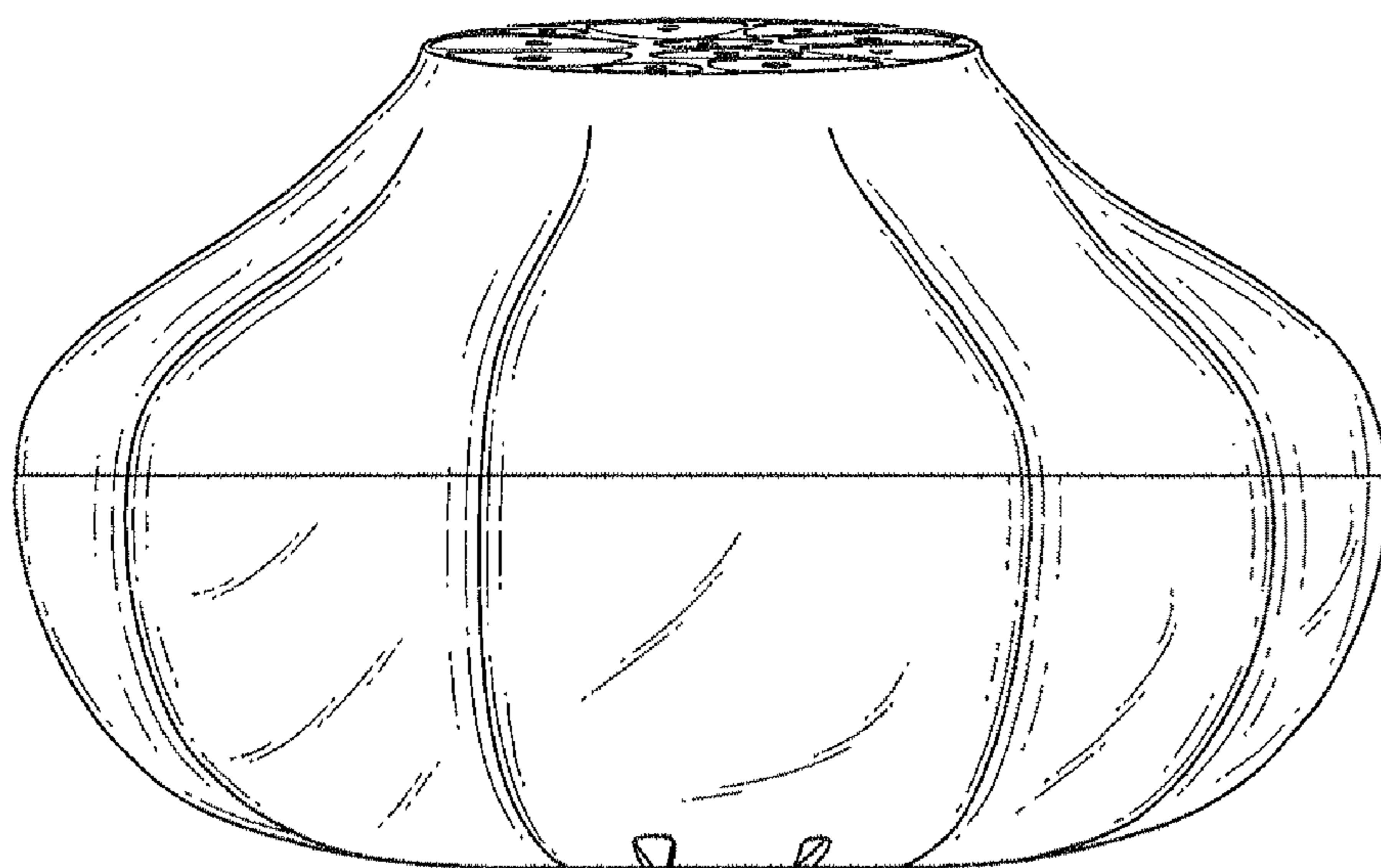

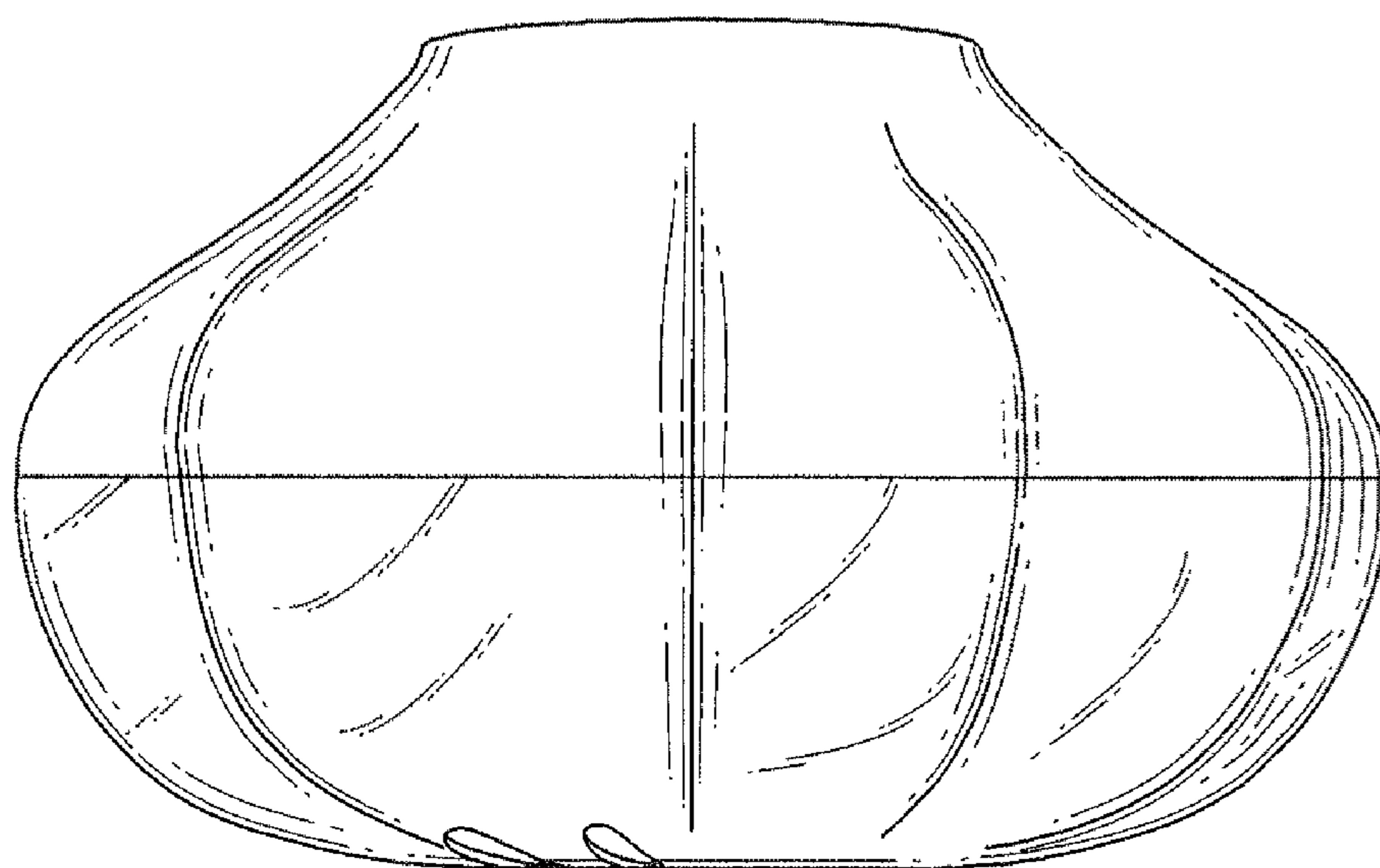

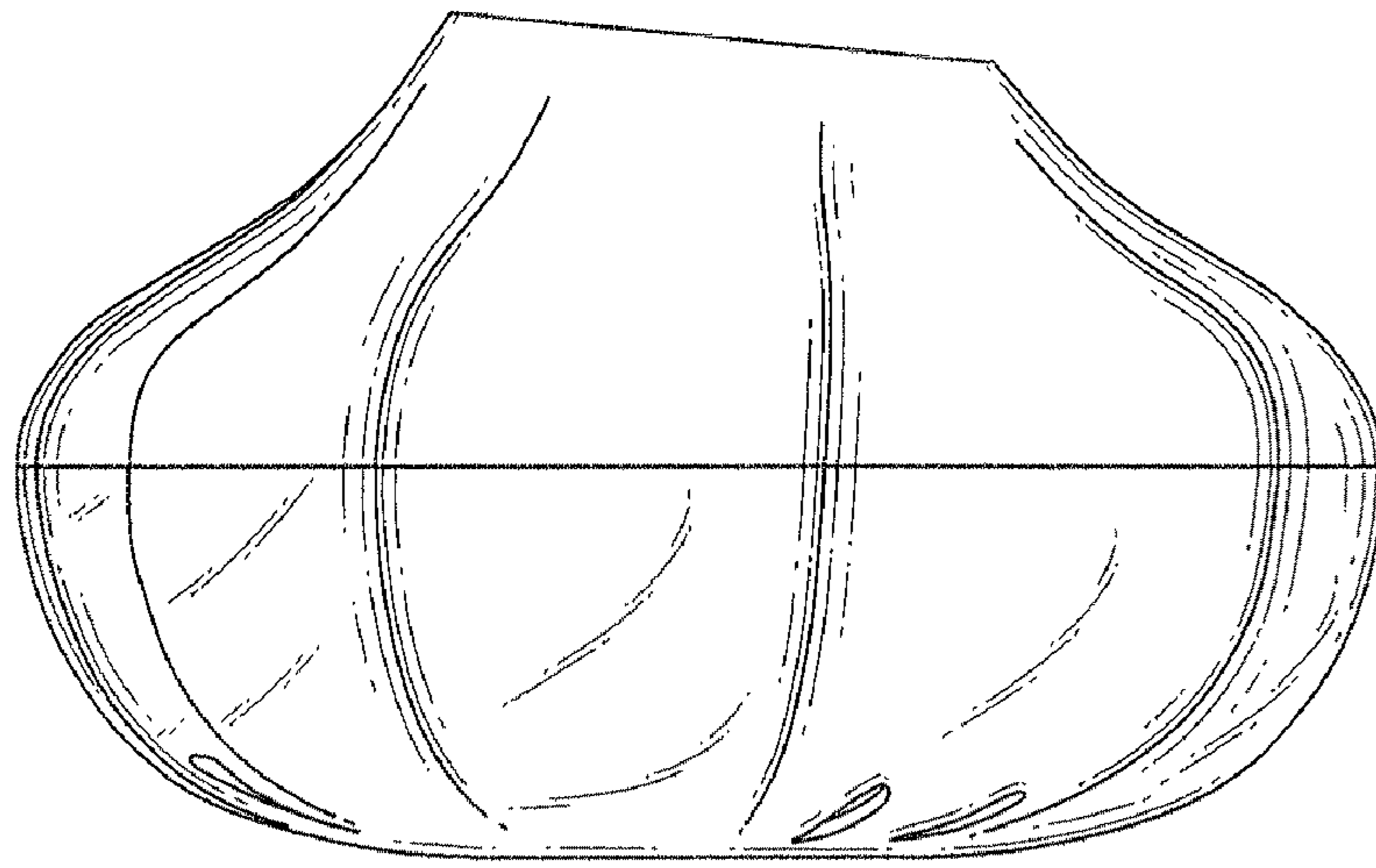

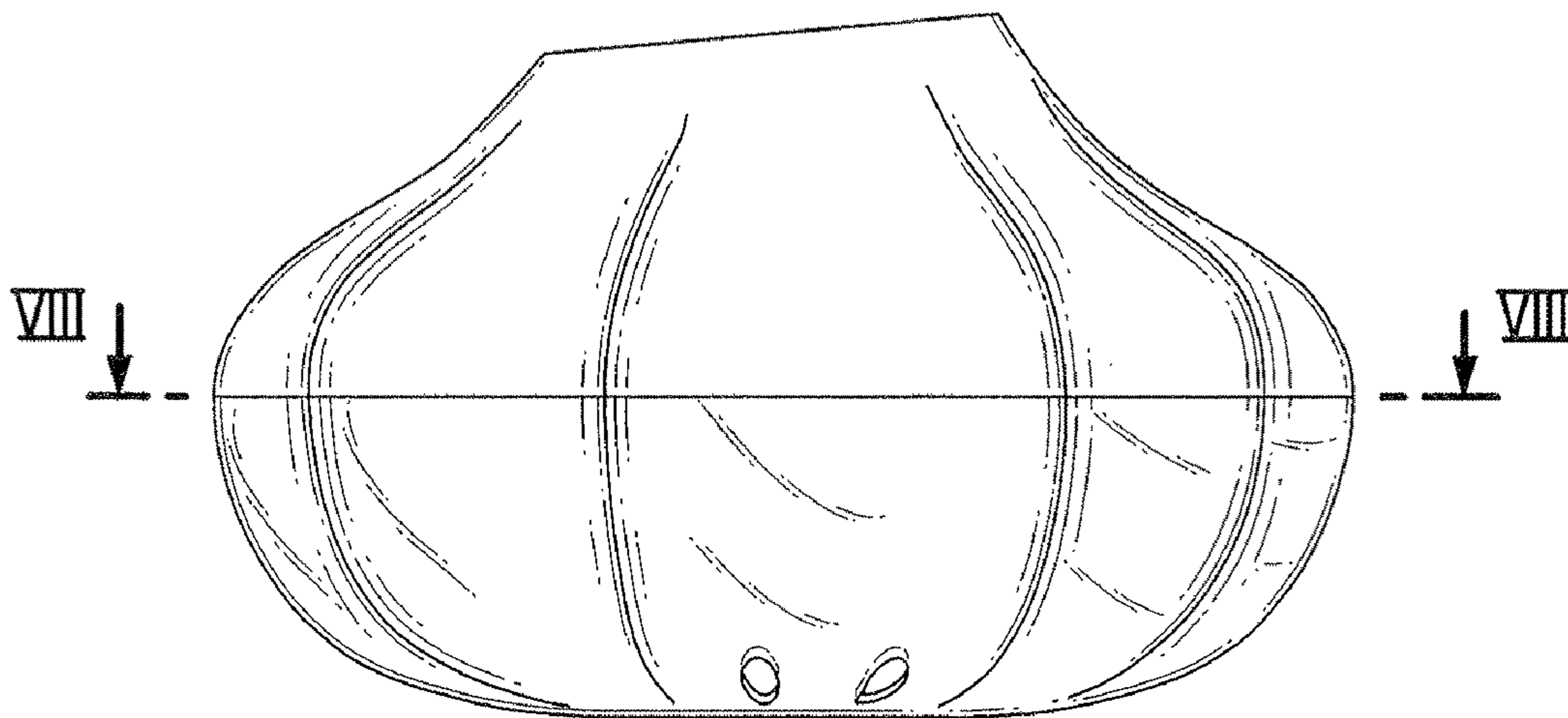
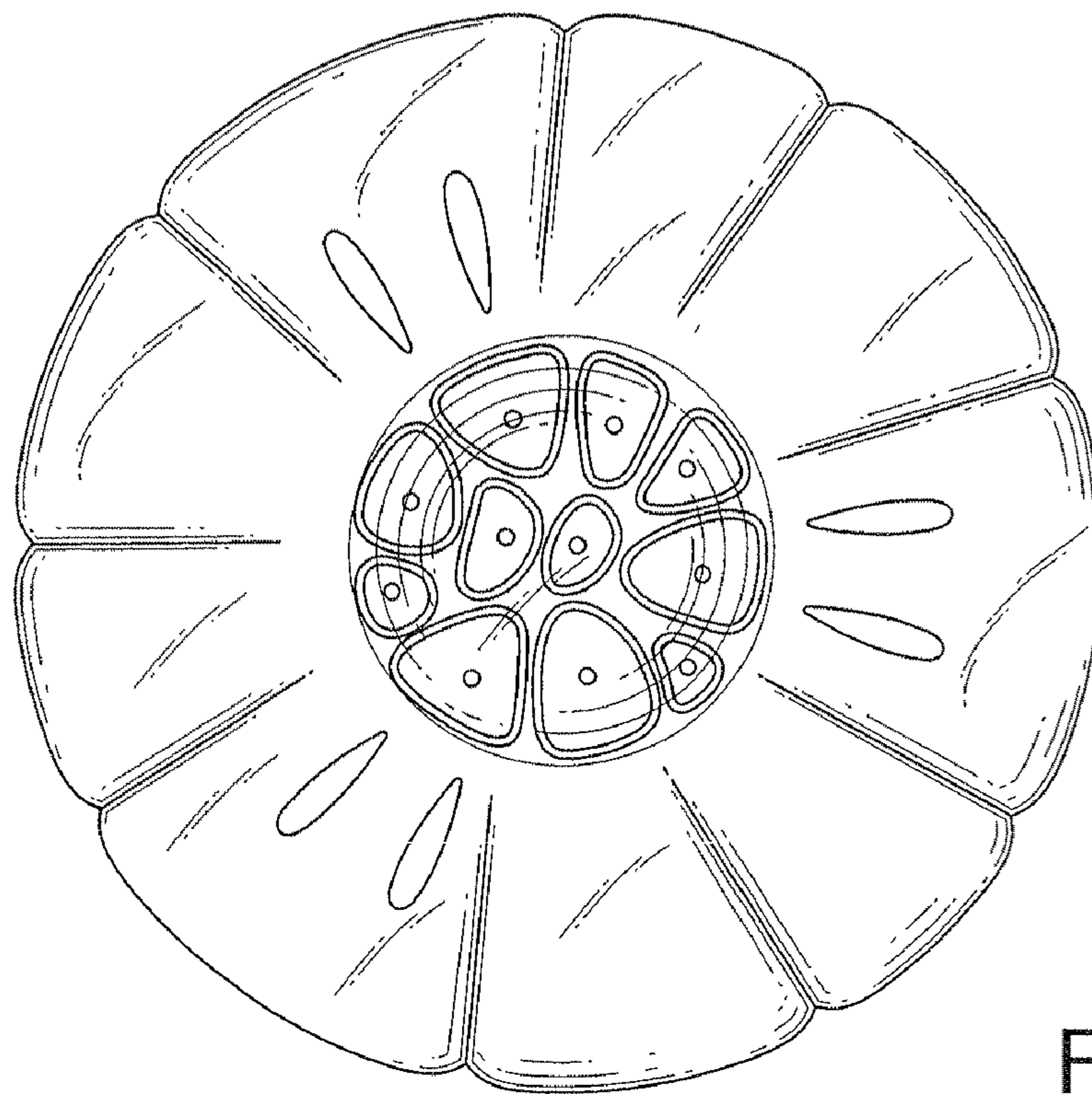
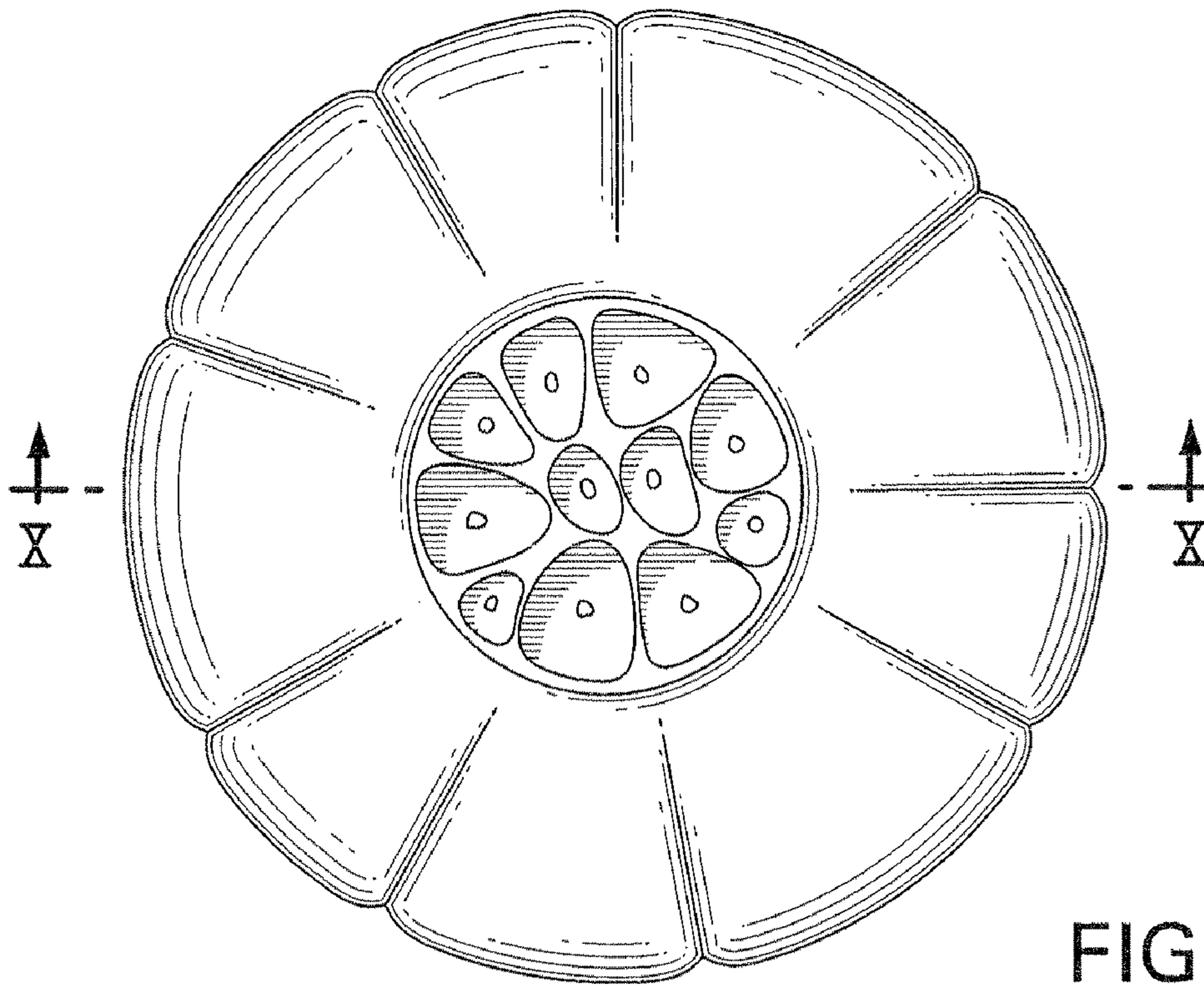

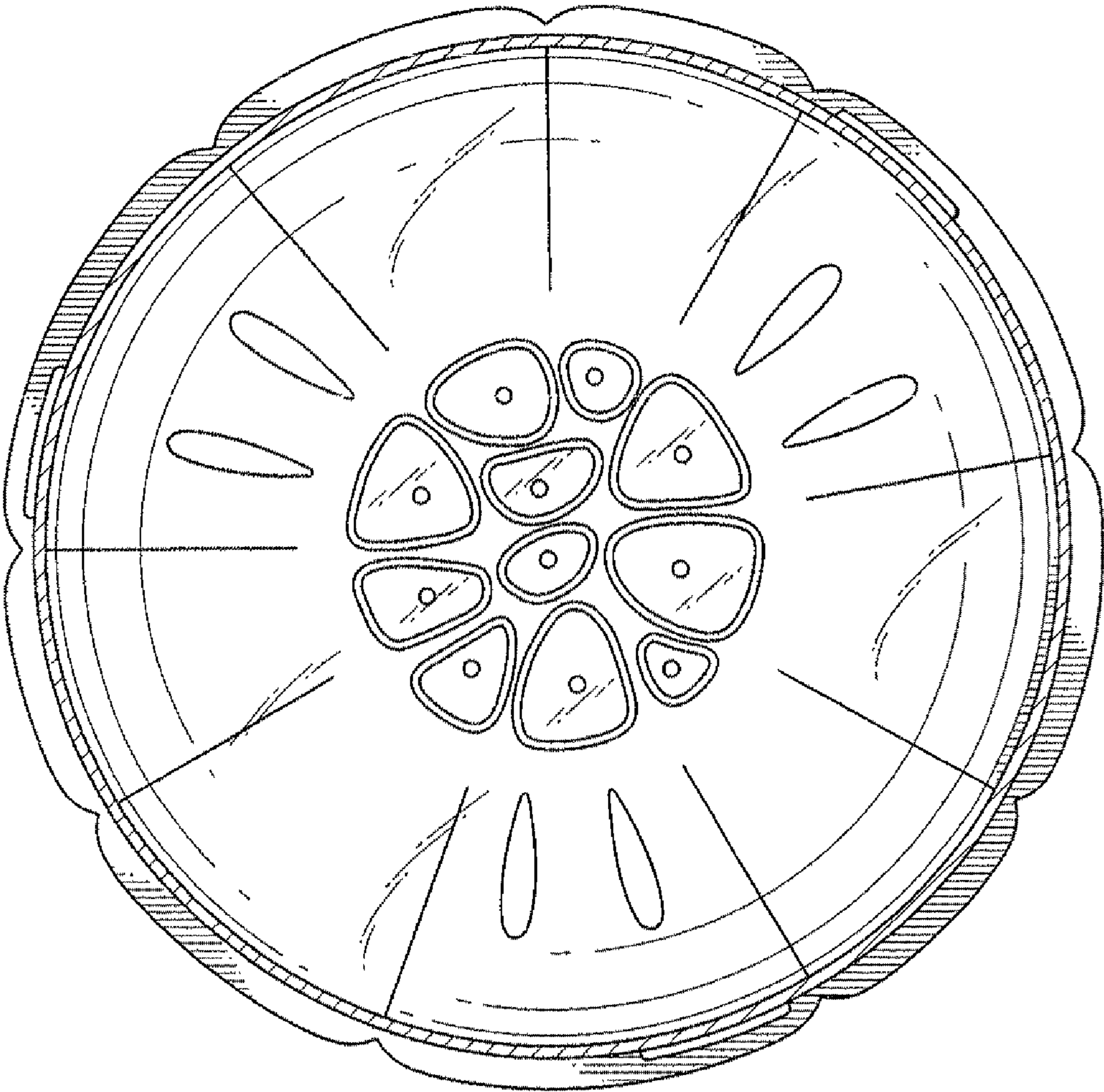

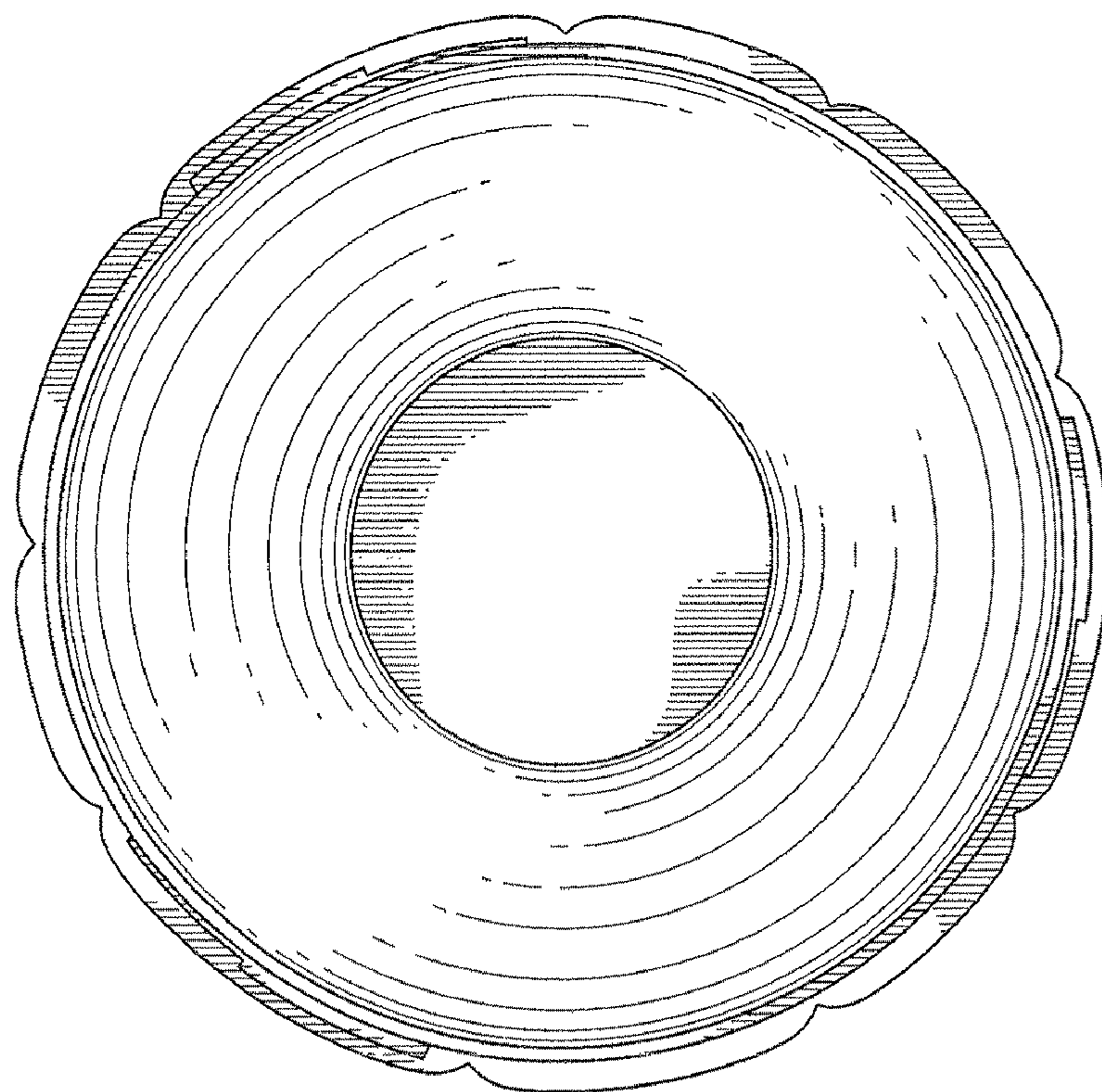

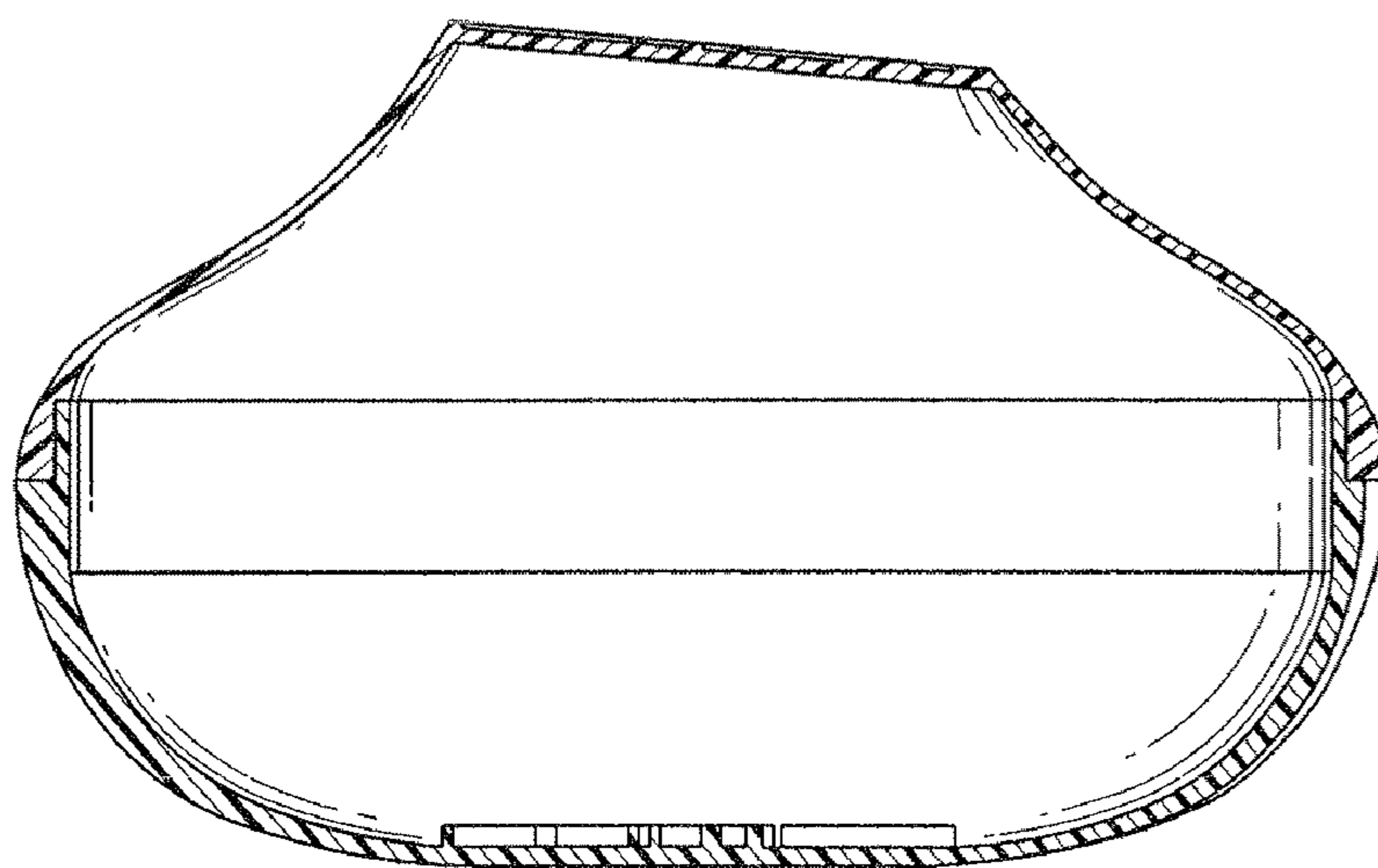

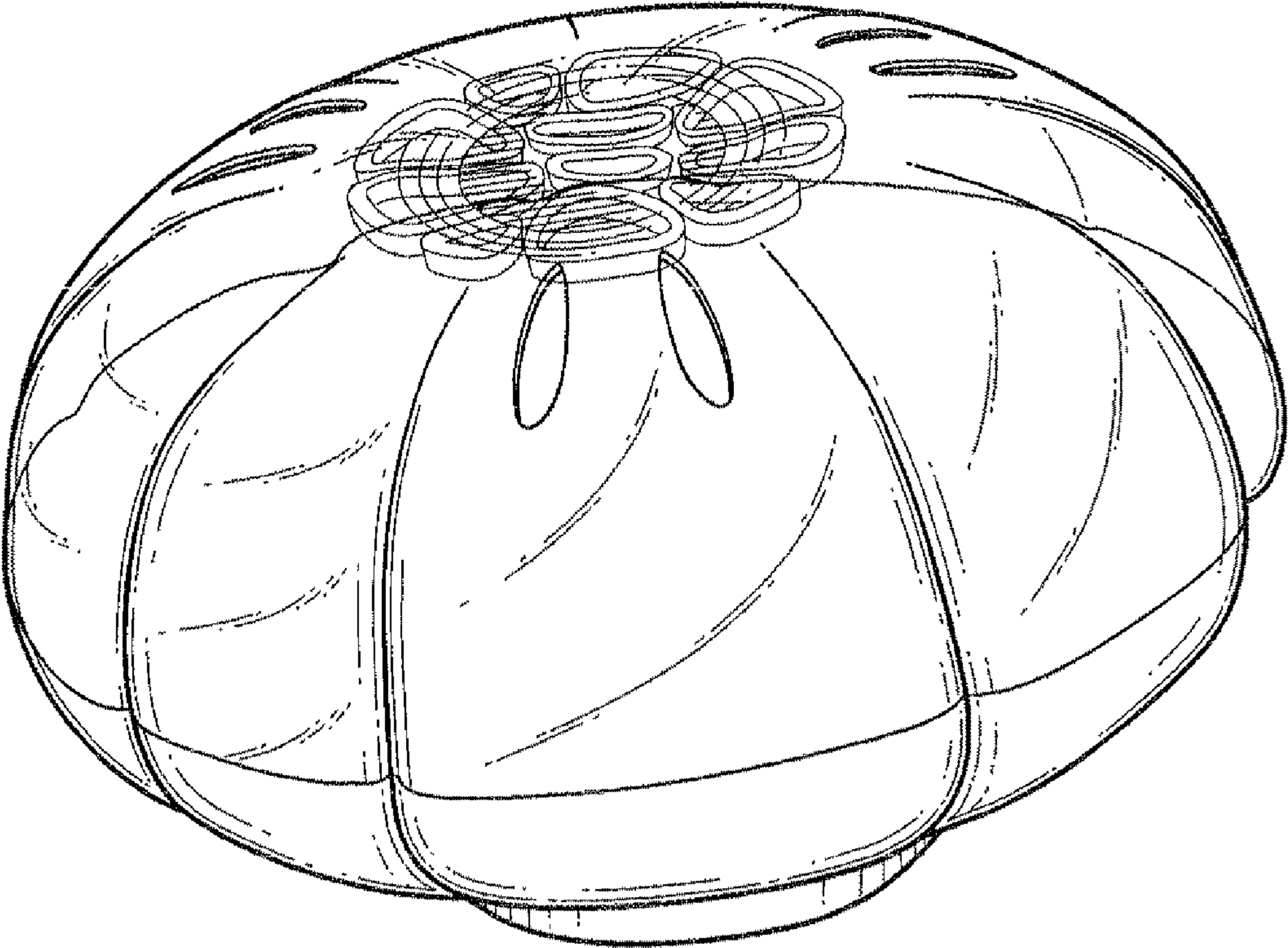
