The ornamental design for a tire tread handle grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire tread handle grip showing our new design;
 FIG. 2 is a front elevation view thereof, with the rear, left and right elevations being identical;
 FIG. 3 is a top plan view thereof, with the bottom plan being identical;
 FIG. 4 is a perspective view thereof, shown in an alternate environmental use than FIG. 1; and,
 FIG. 5 is another perspective view thereof, shown in an alternate environmental use than FIGS. 1 and 4.

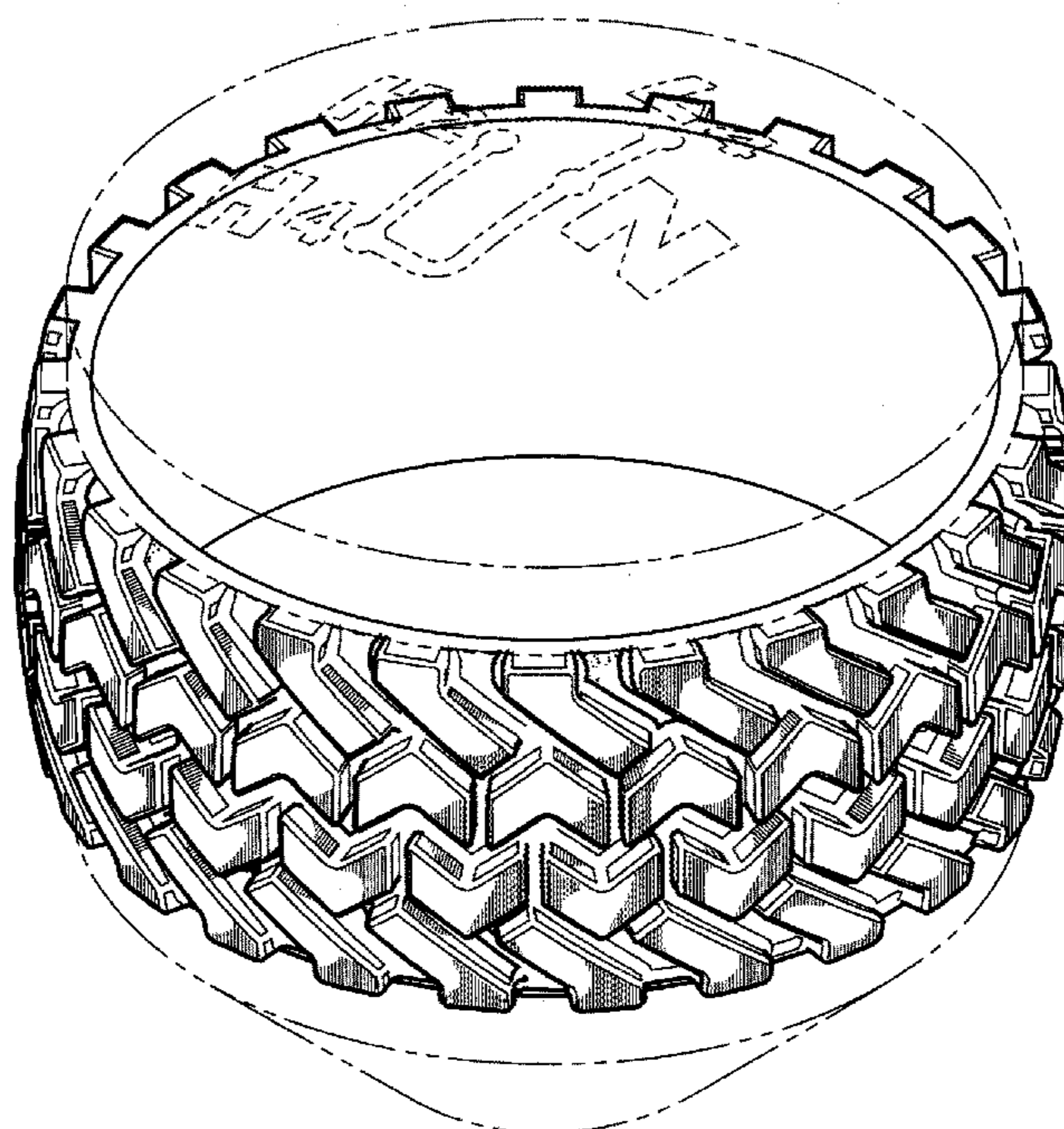
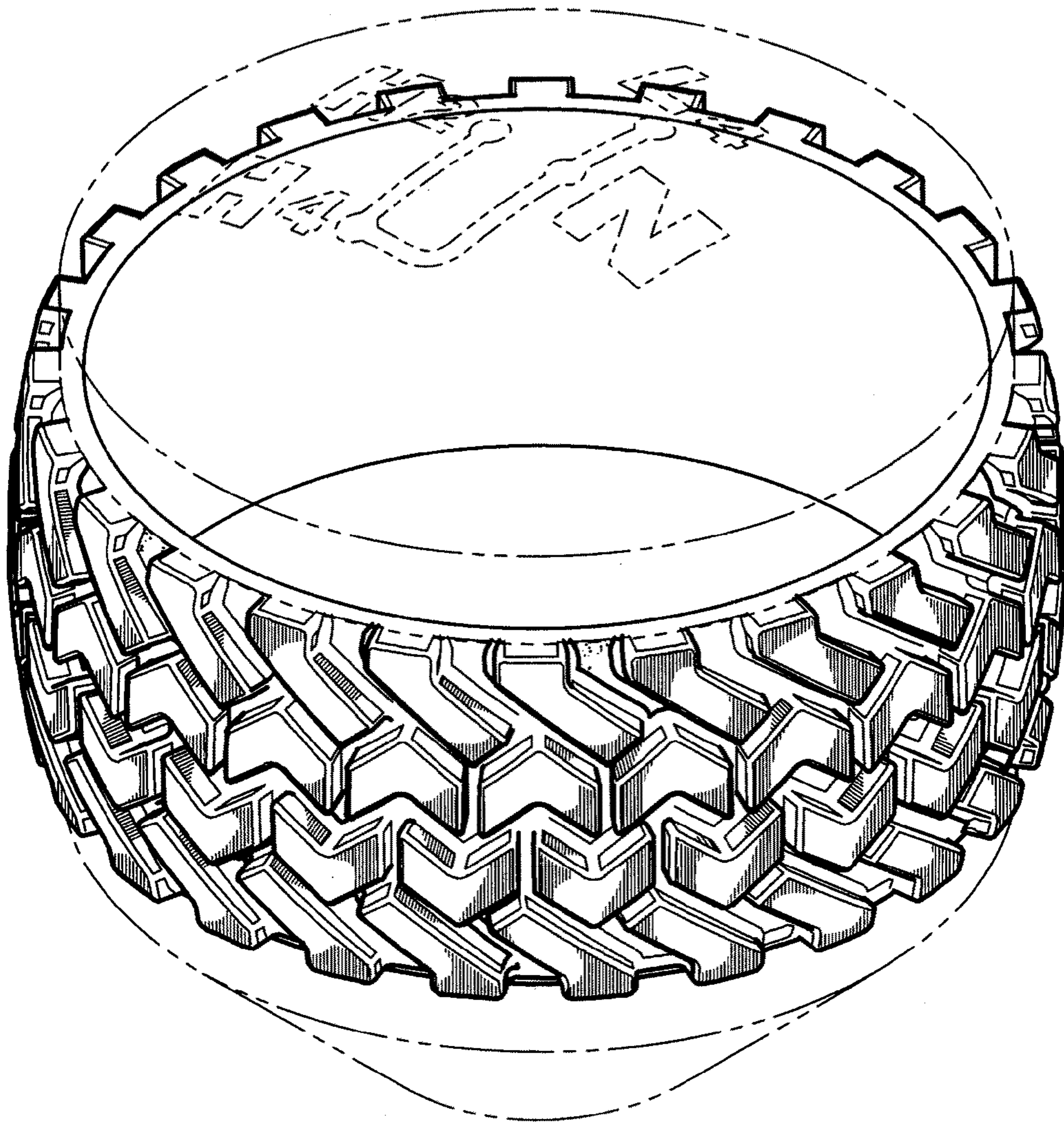

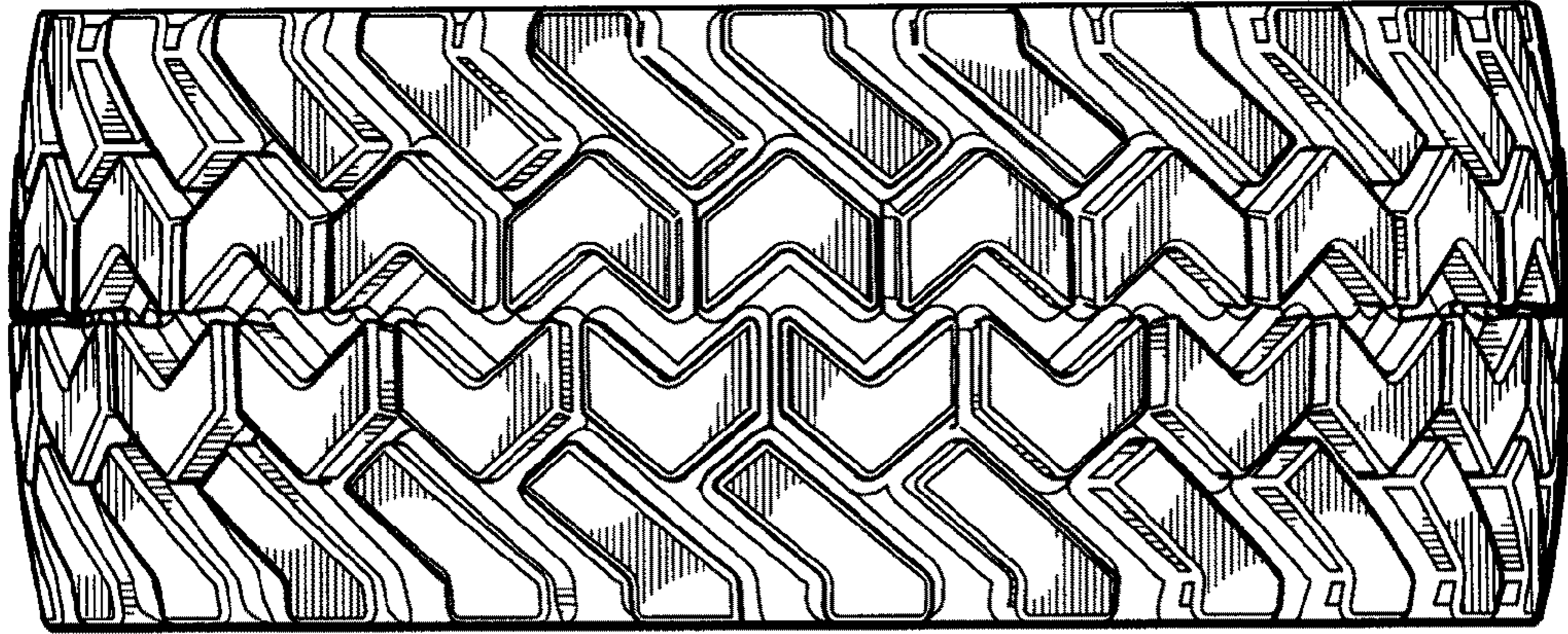

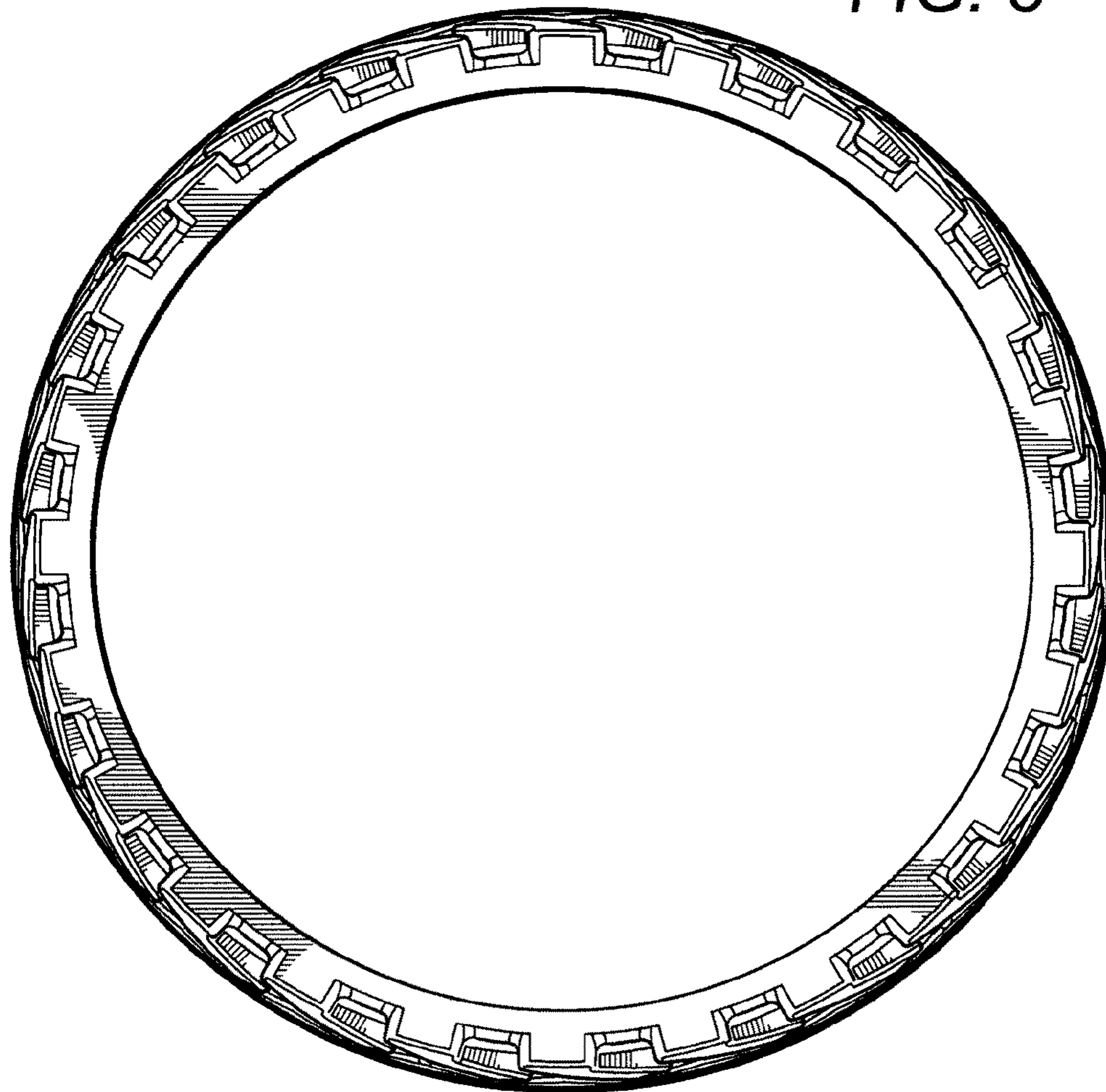

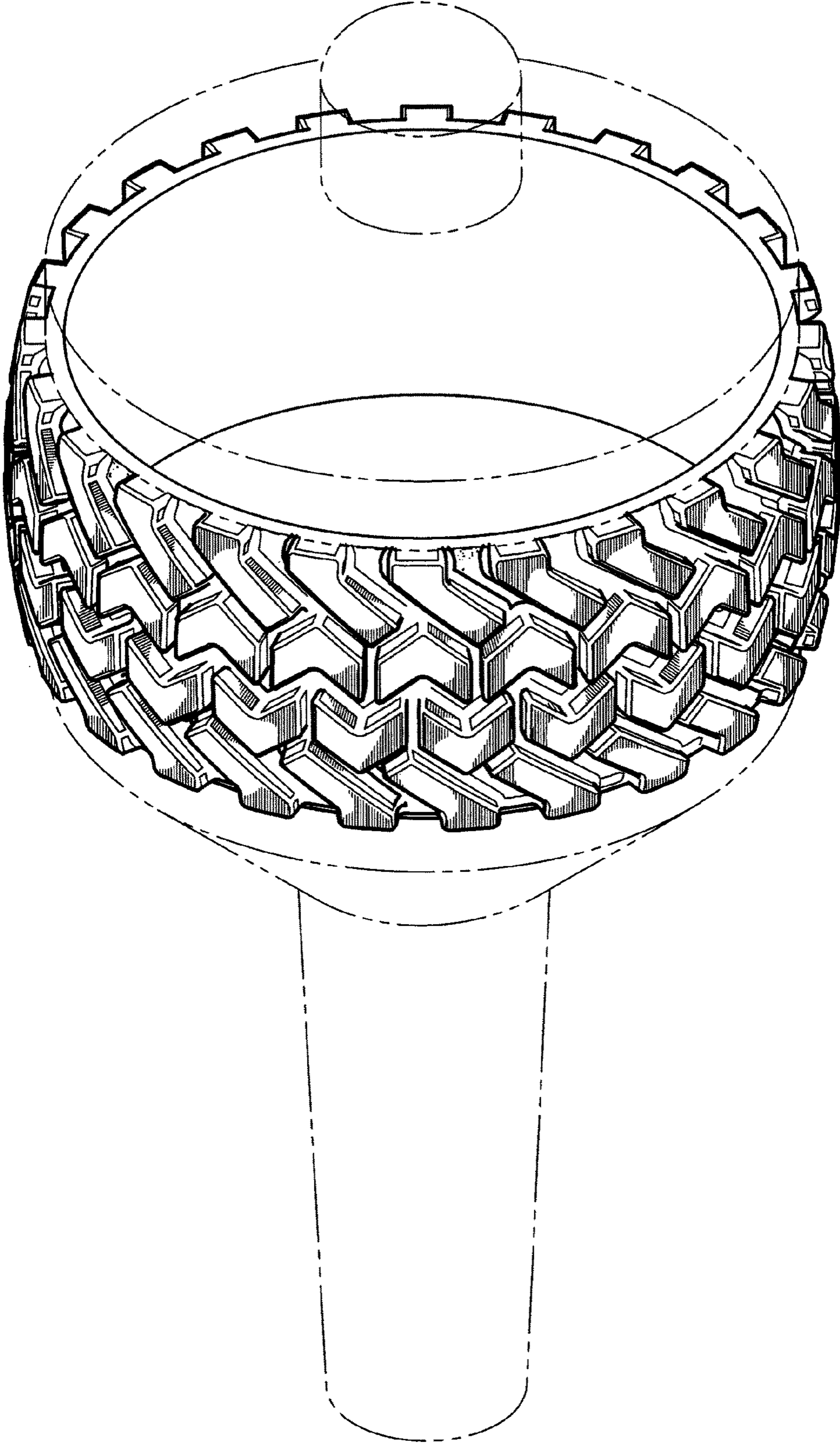
