FIG. 2 is a front perspective view of a dispenser package set showing an alternate embodiment of the design with the attachment shown in FIG. 12 added to the design;

FIG. 3 is a cut-away front perspective view of the design of FIG. 1 with the insert shown in FIG. 14 positioned within the design;

FIG. 4 is a front perspective view of the hinged lid of the design of FIG. 1 shown in an open position;

FIG. 5 is a front perspective view of the tag feature shown removed from the top opening of the design of FIG. 1;

FIG. 6 is a top plan view of the design of FIG. 1;

FIG. 7 is a front elevation view thereof;

FIG. 8 is a right side elevation view thereof;

FIG. 9 is a bottom plan view thereof;

FIG. 10 is a back elevation view thereof;

FIG. 11 is a left side elevation view thereof;

FIG. 12 is a plan view of the attachment which is shown in position in FIG. 2;

FIG. 13 is a plan view of the design of FIG. 1 shown unassembled; and,

FIG. 14 is a plan view of the unassembled insert which is shown within the design in FIG. 3.

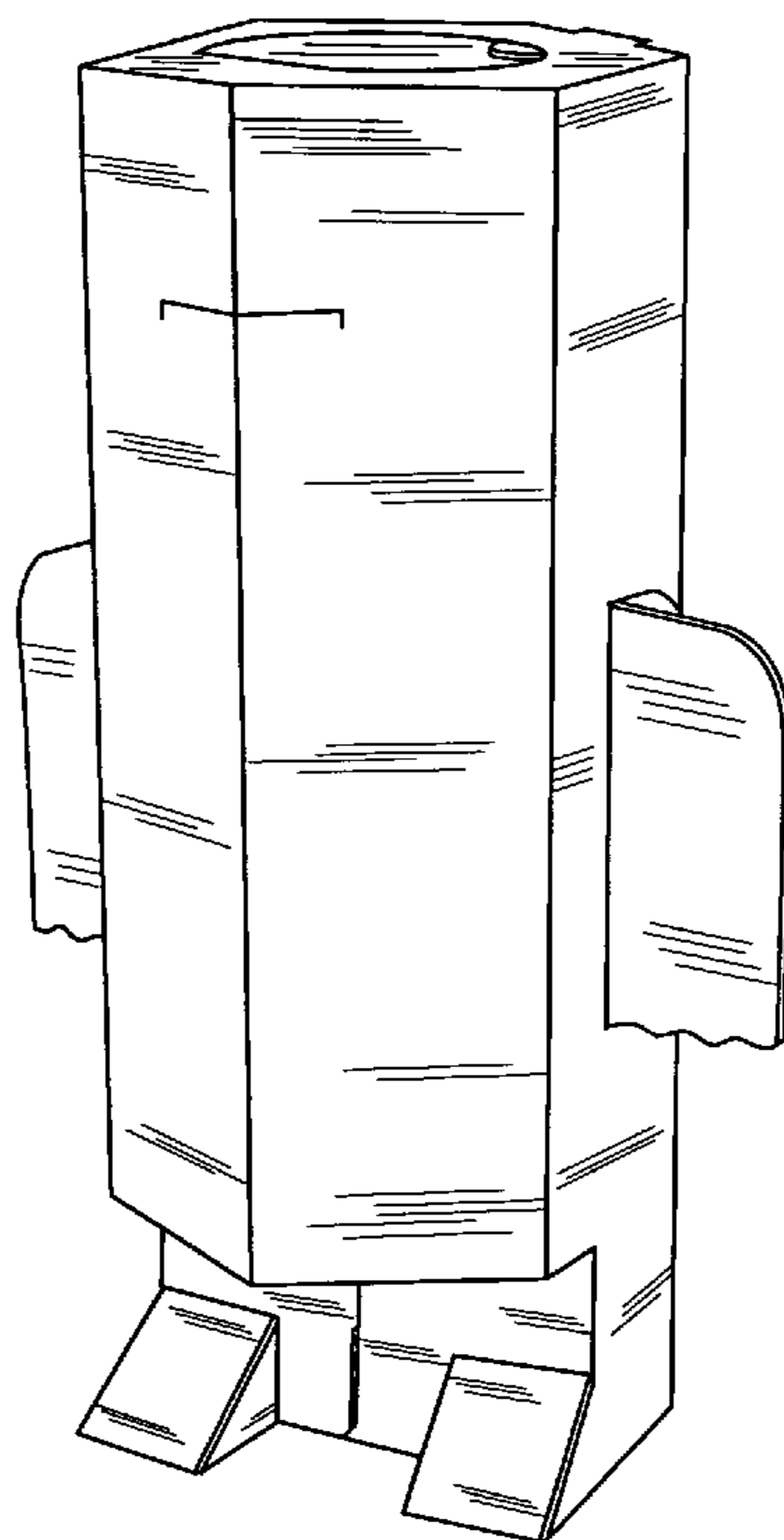

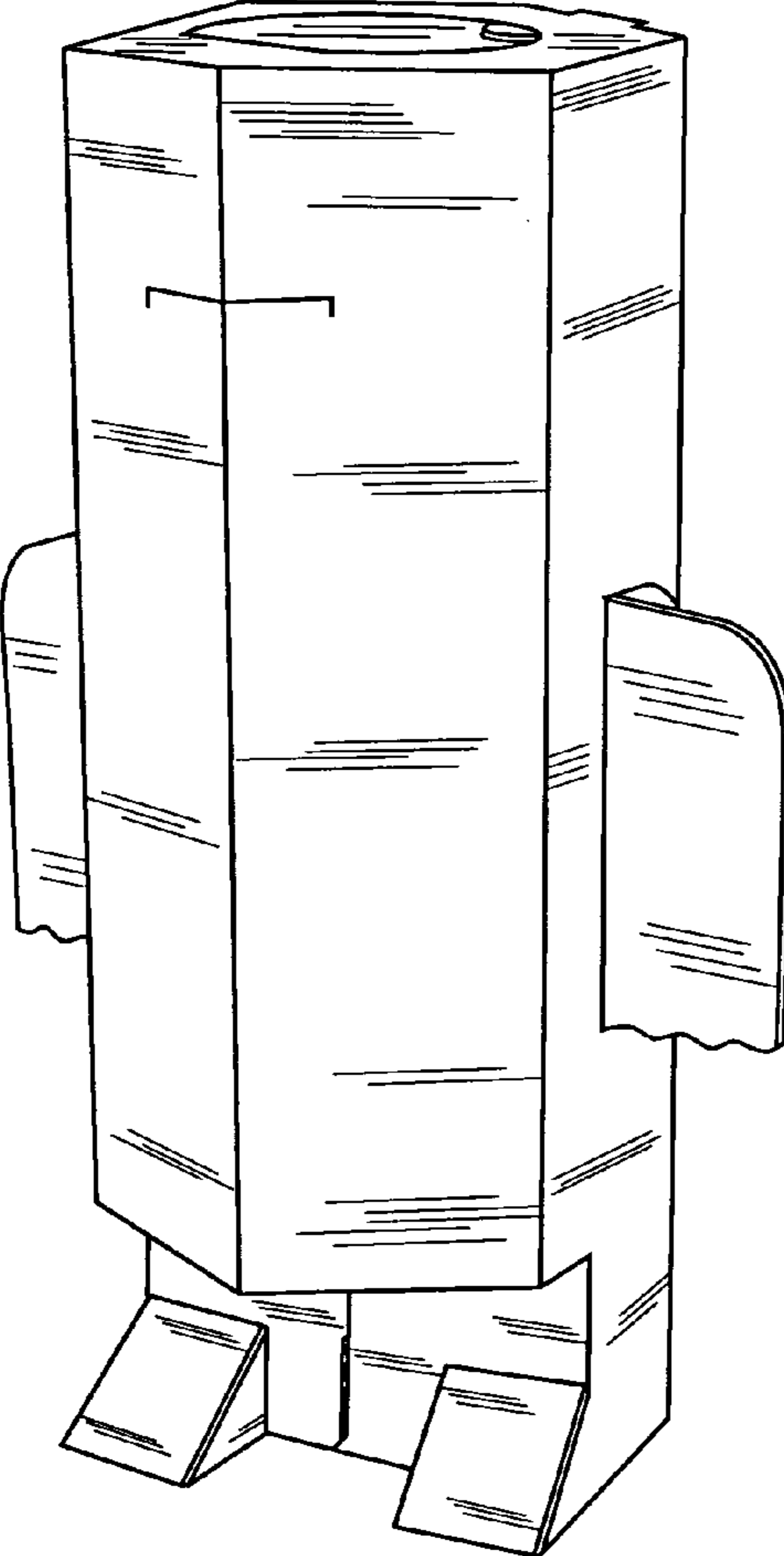

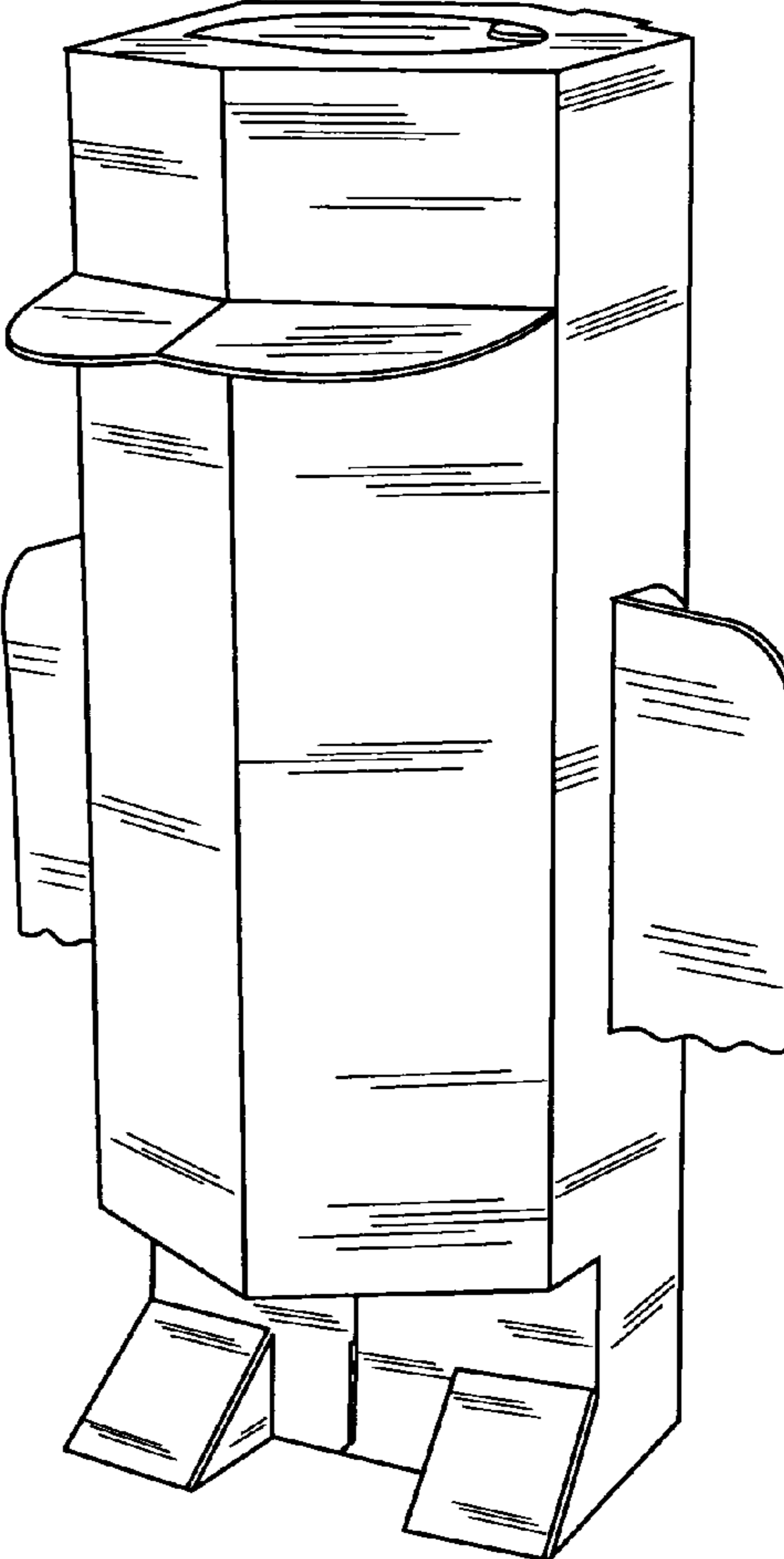

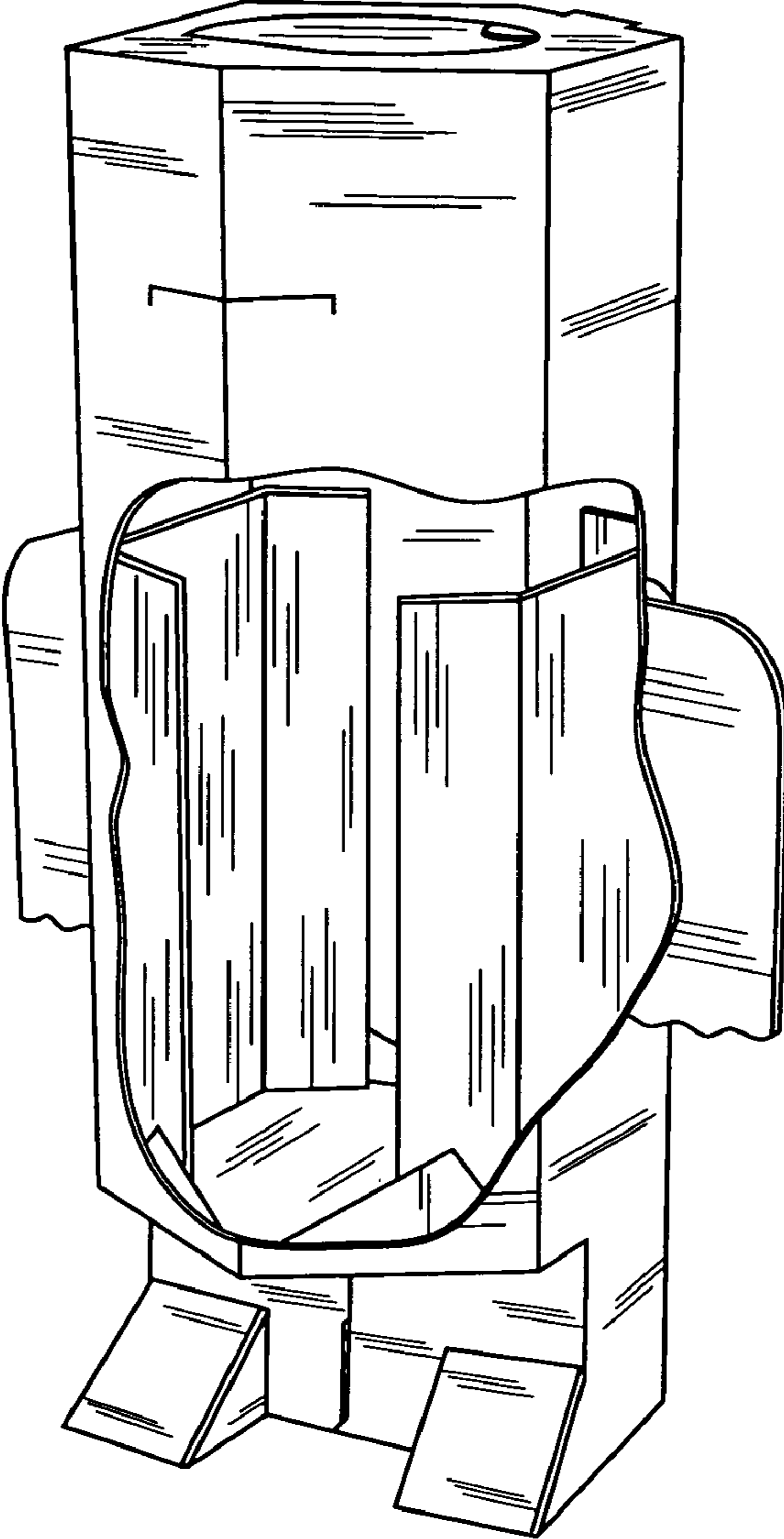
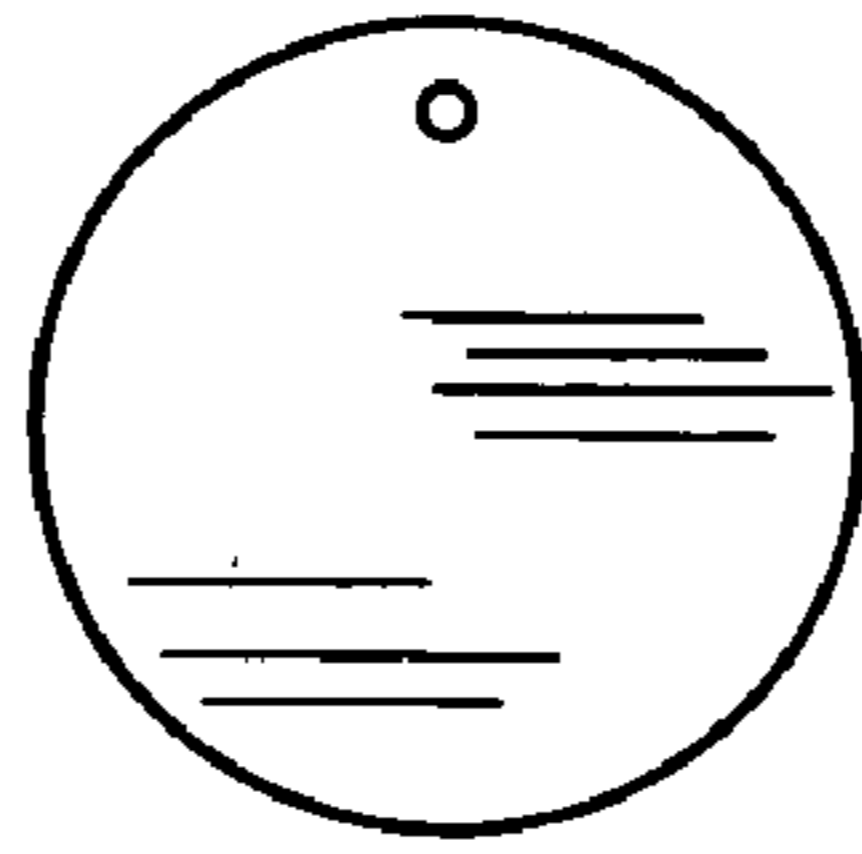
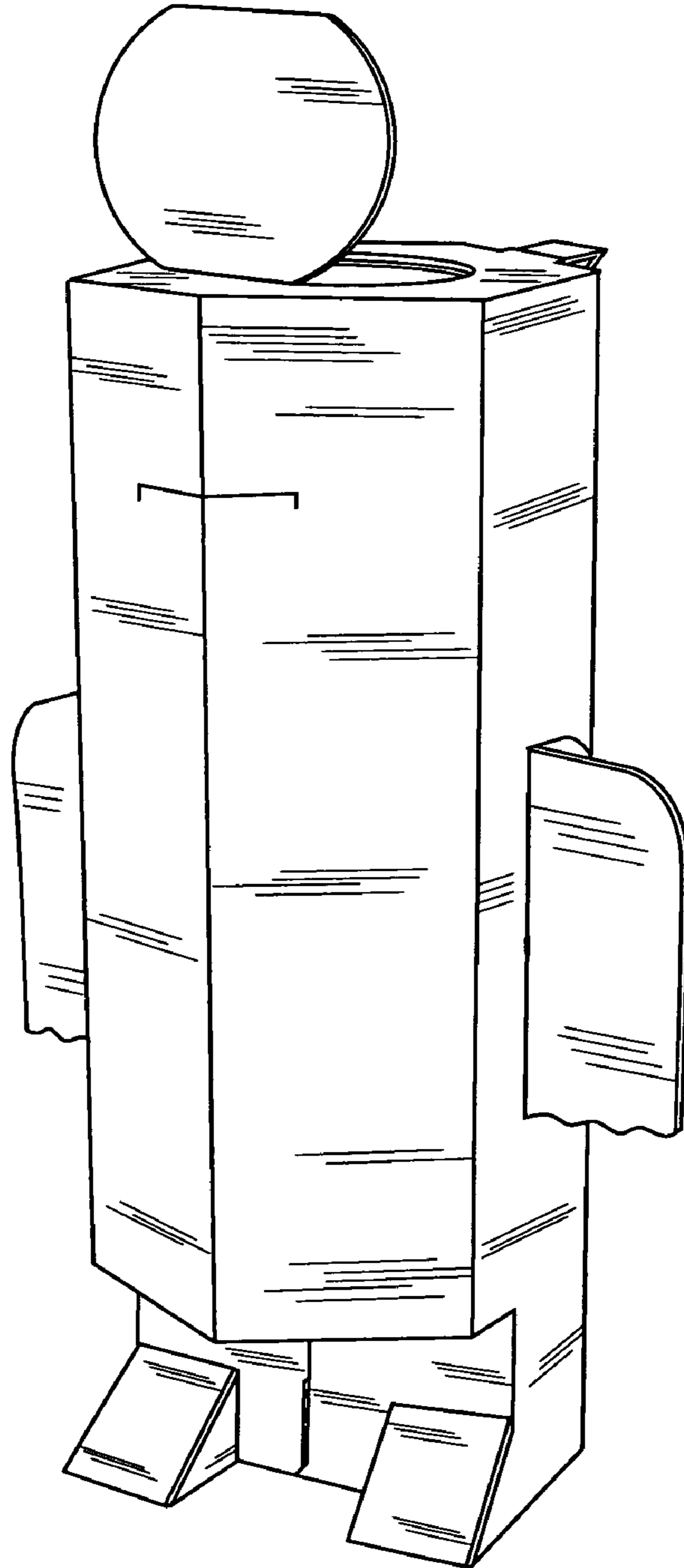

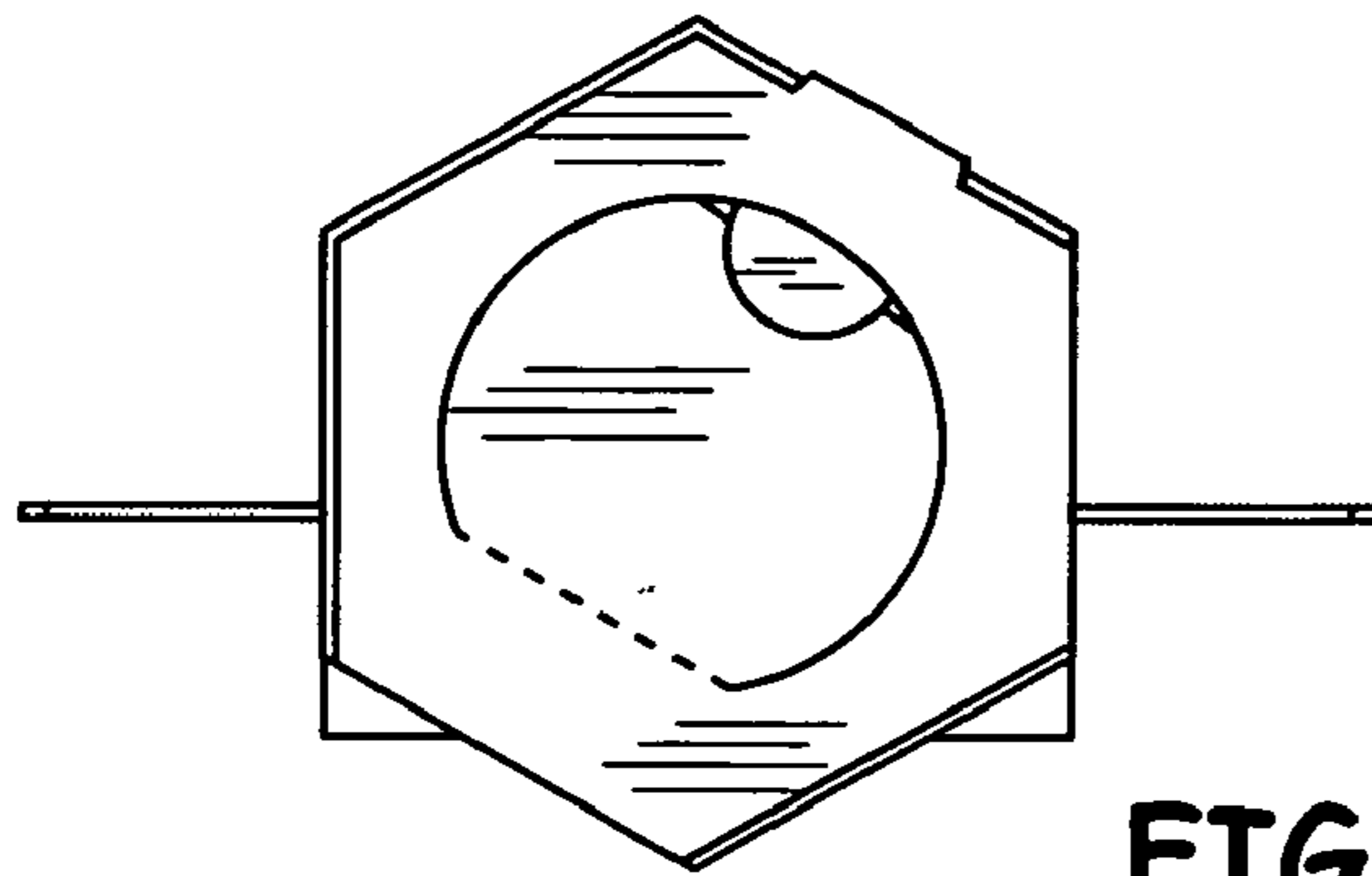

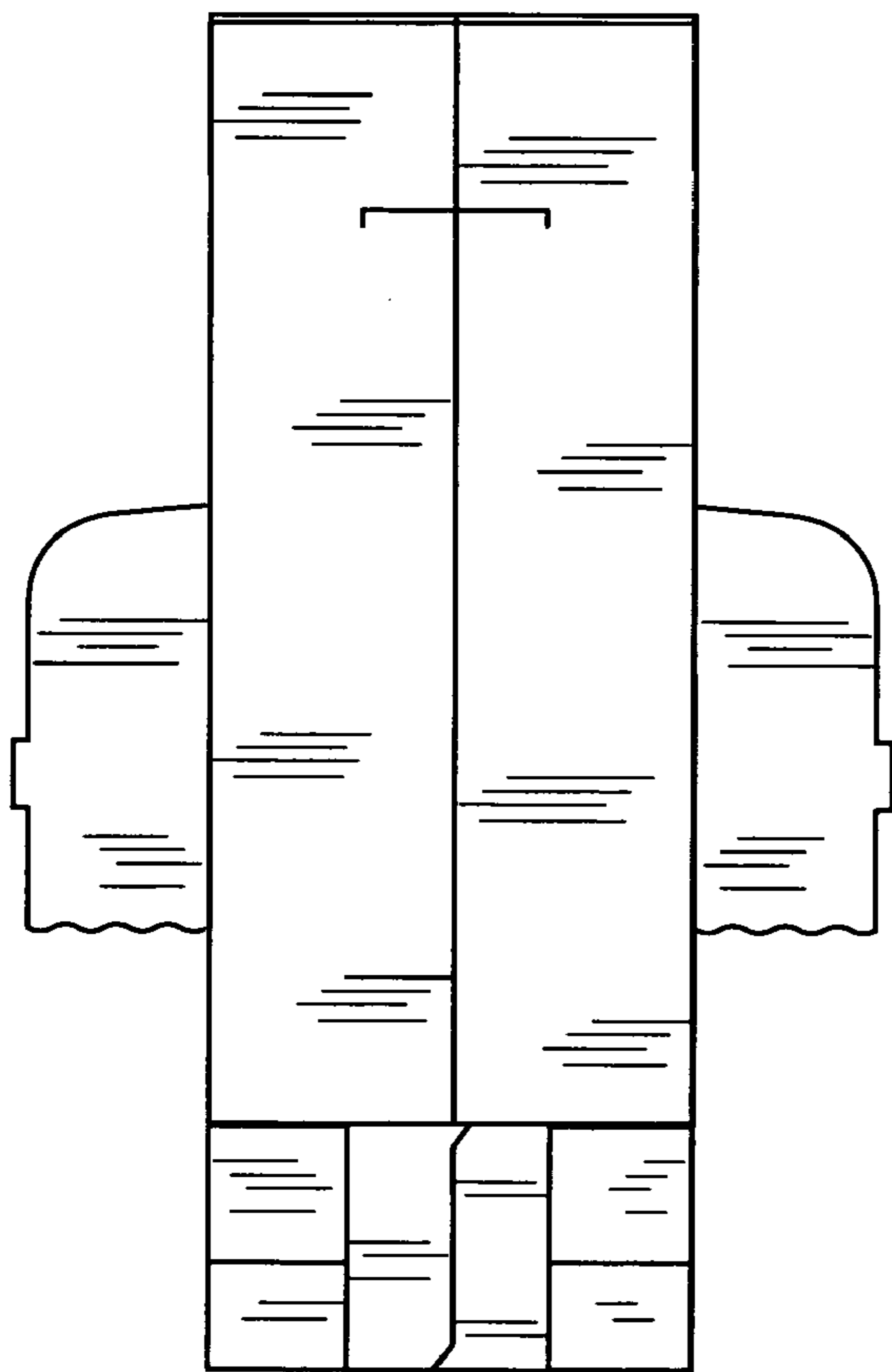

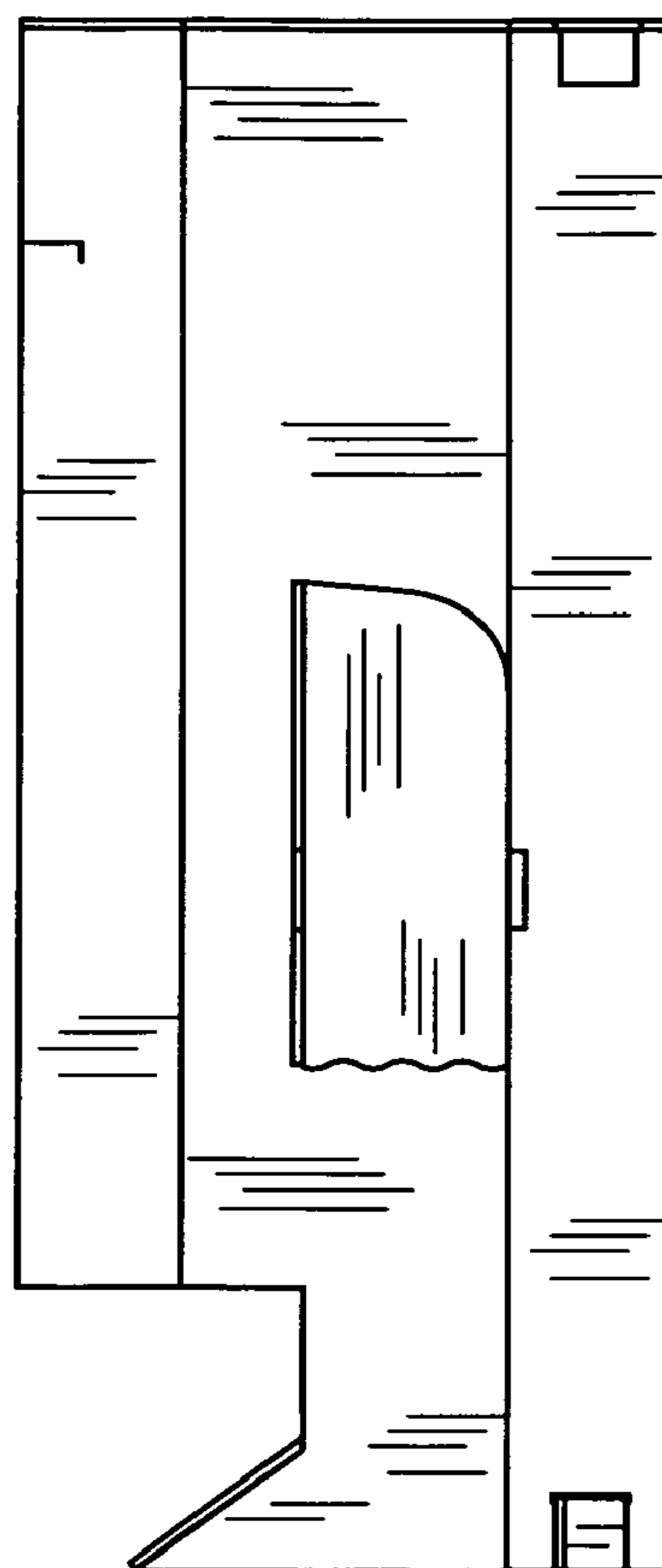

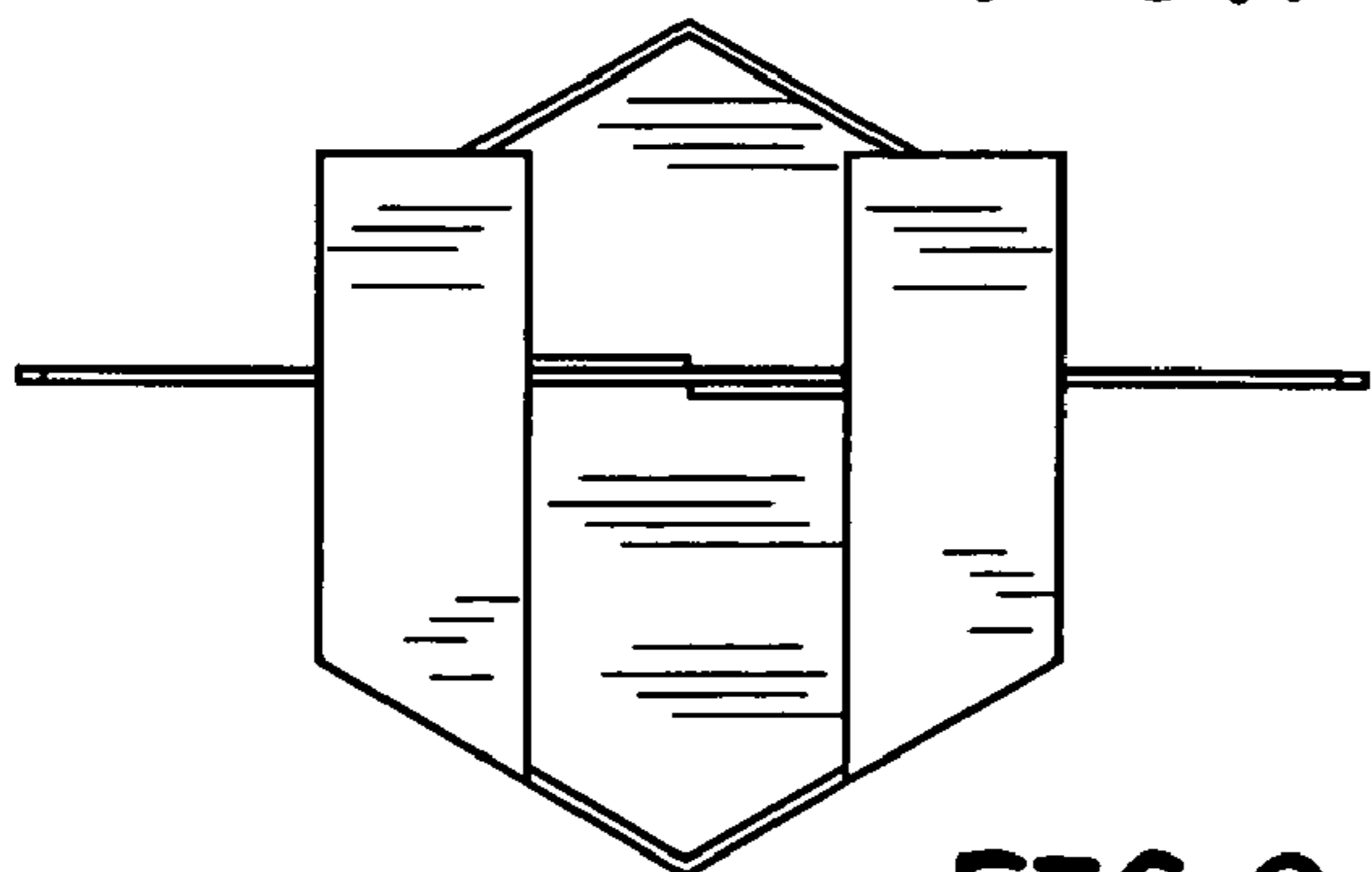

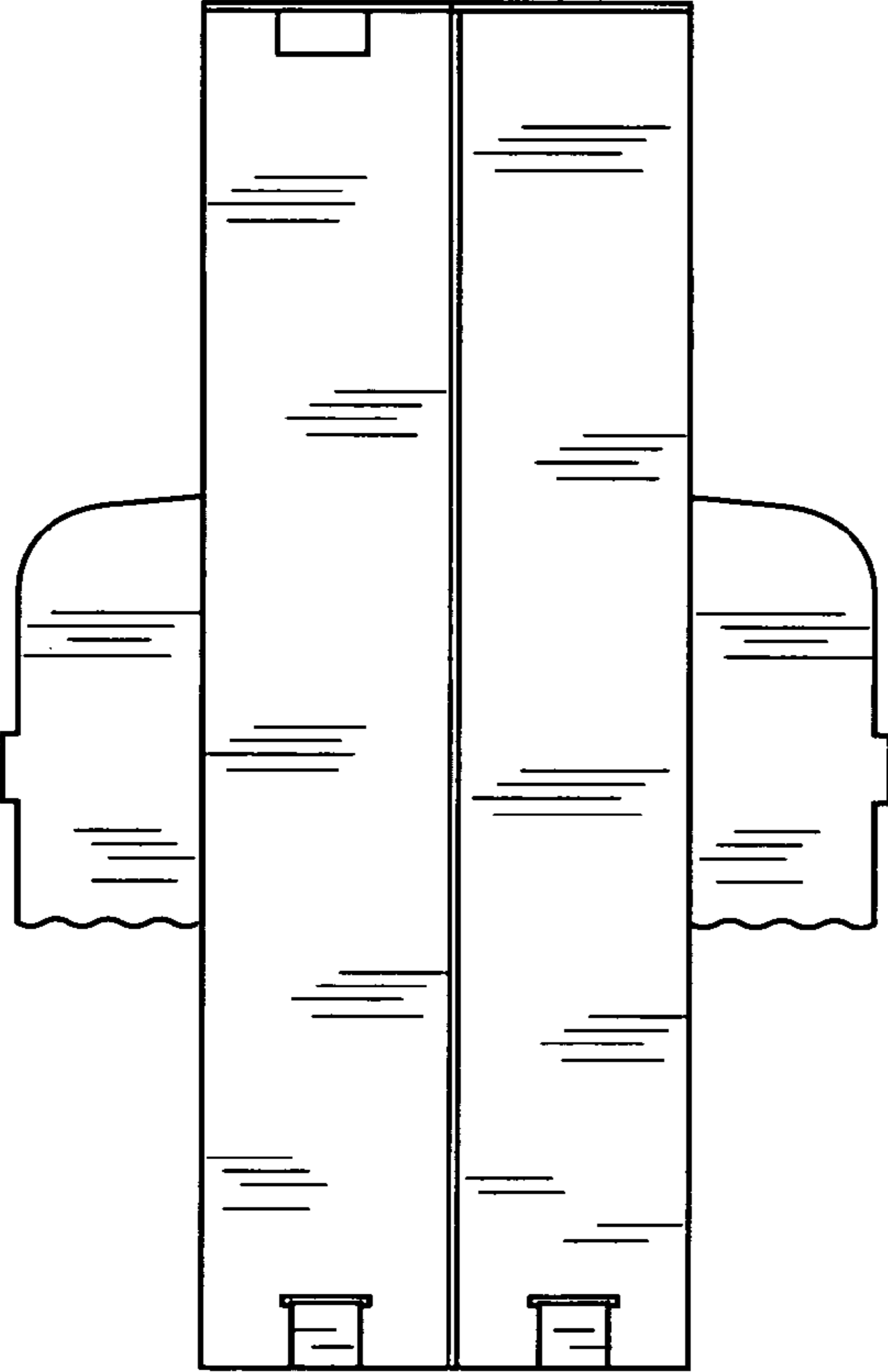

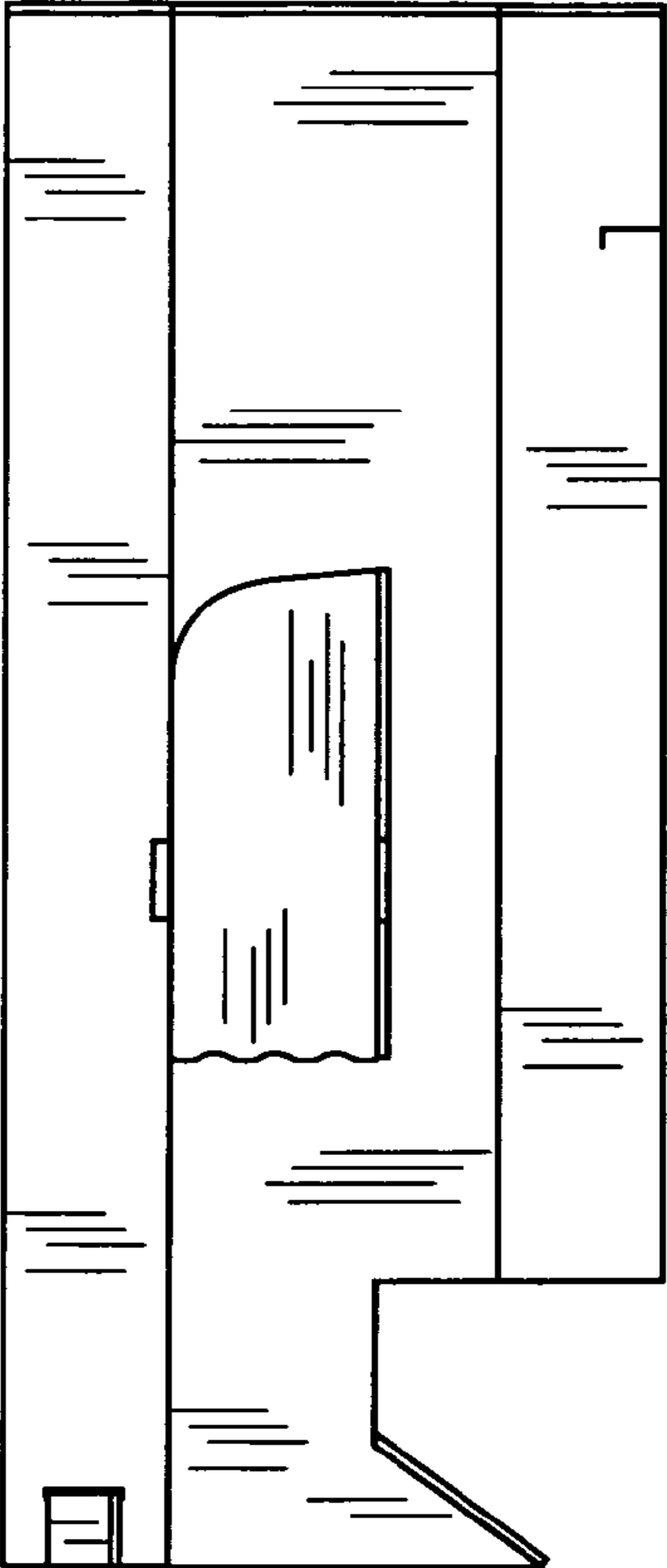

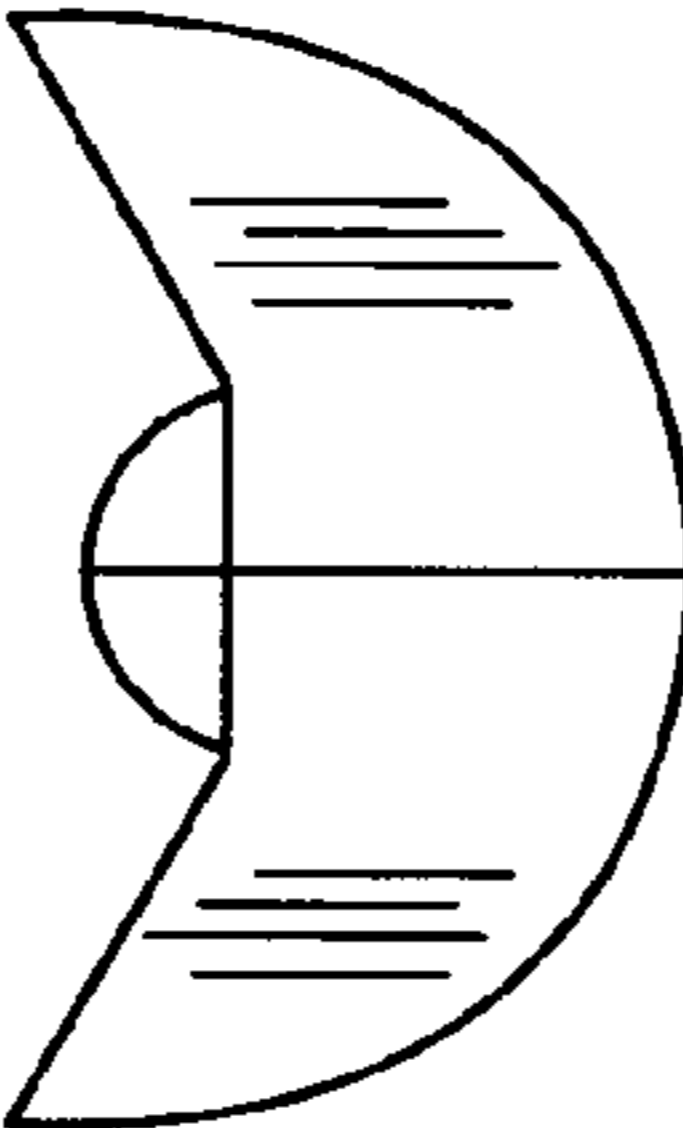

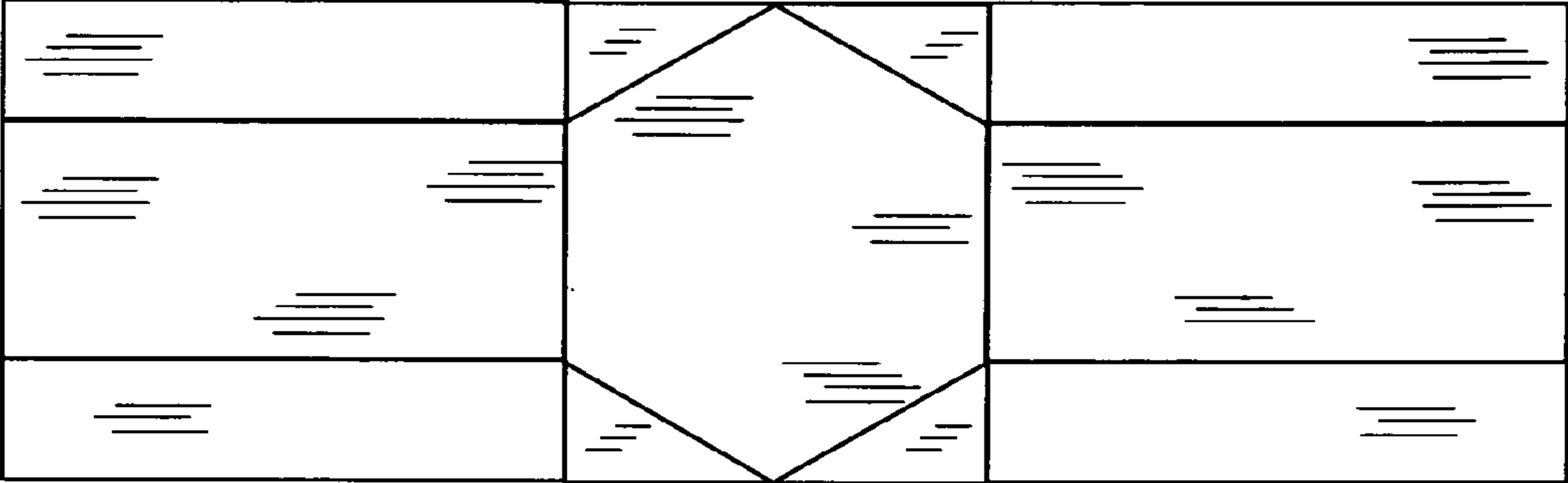

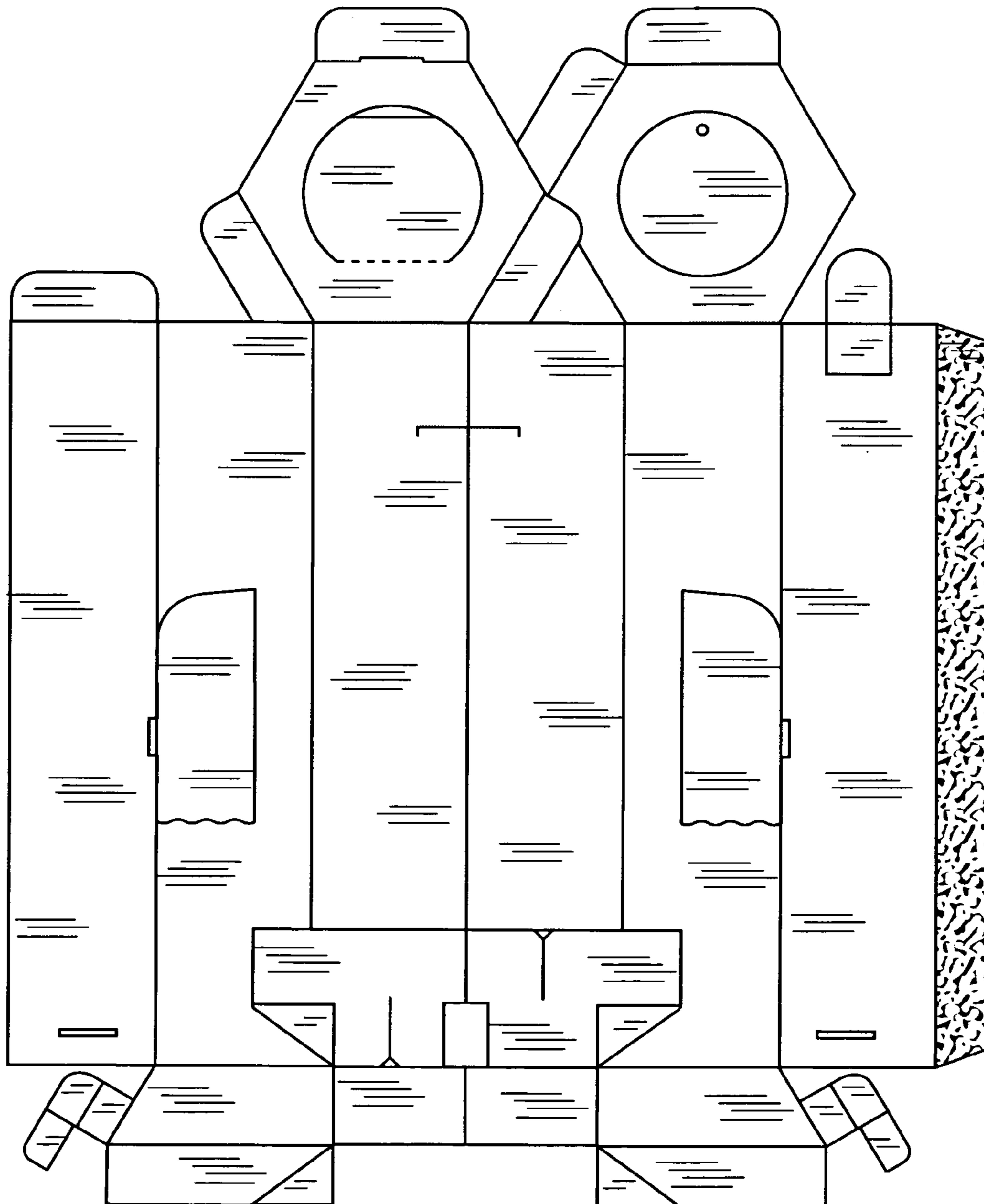
