FIG 1 is a front-left-top perspective view of the of a blister pack for pharmaceuticals showing our new design;

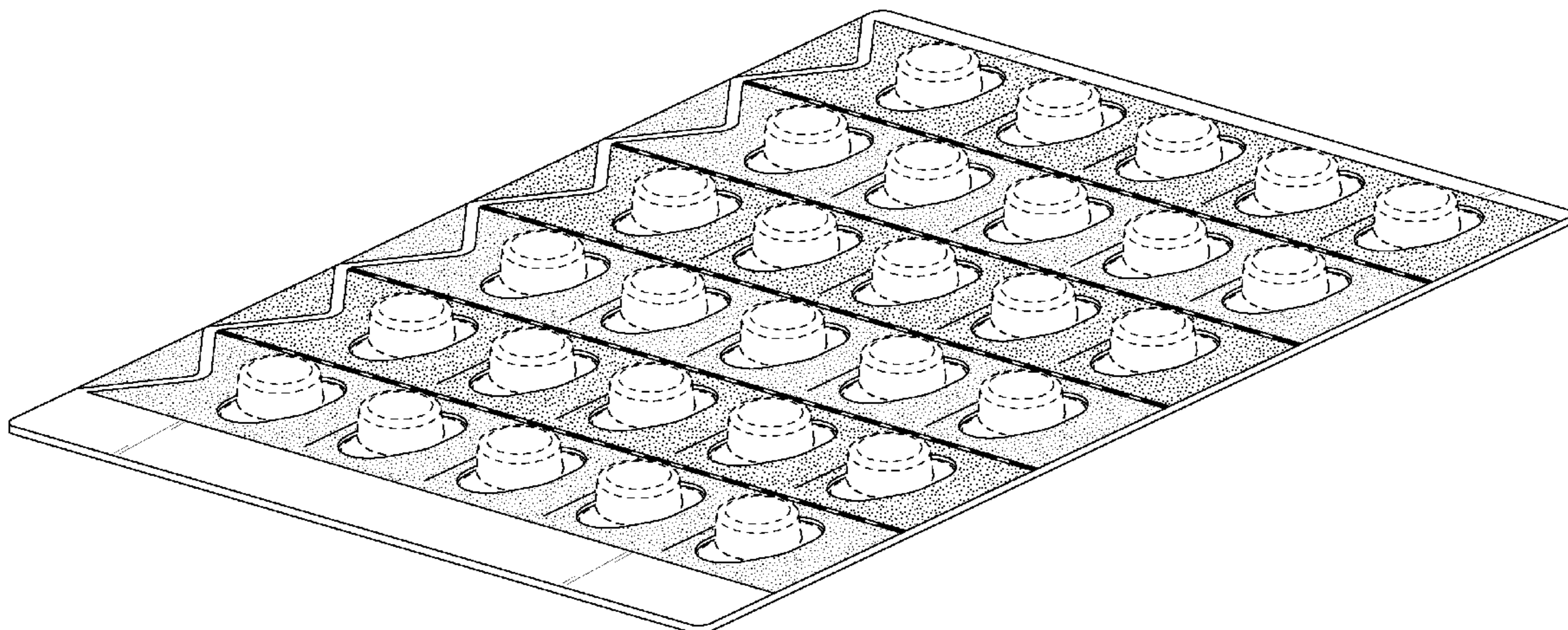
FIG. 2 is a view from the top side thereof;

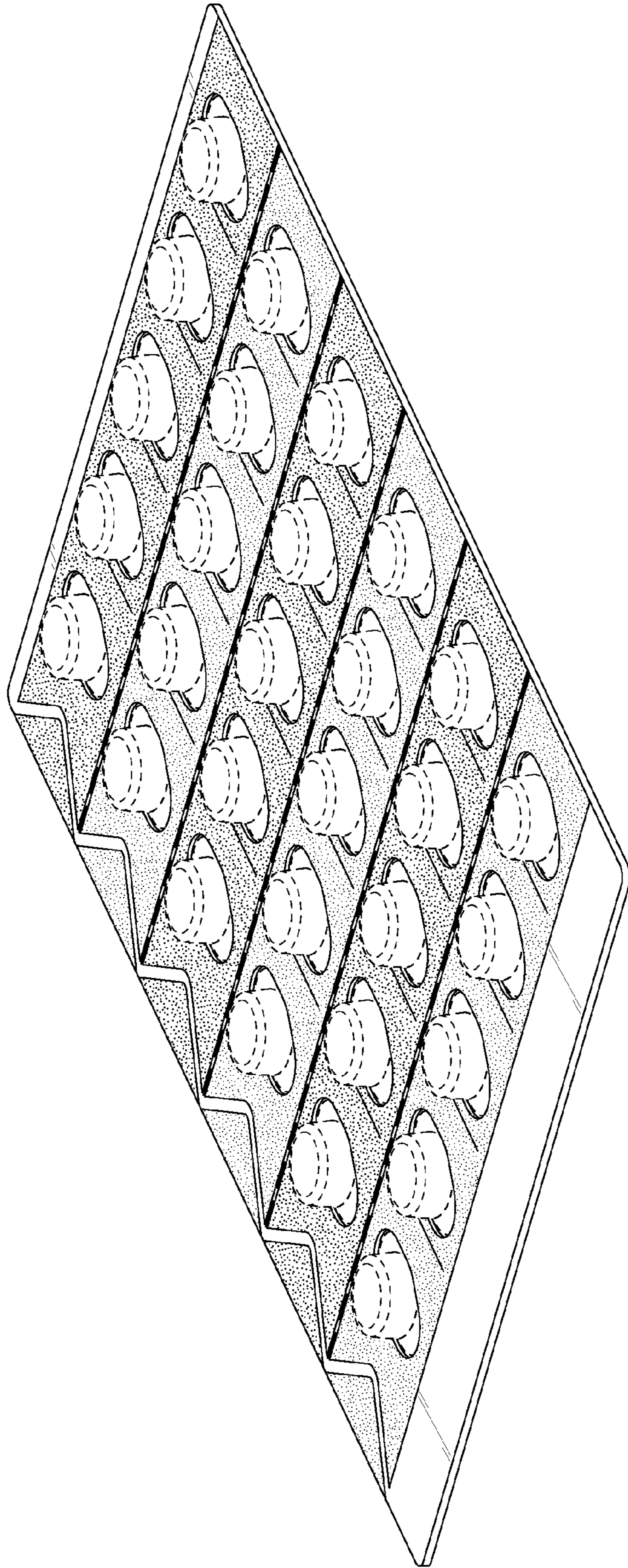

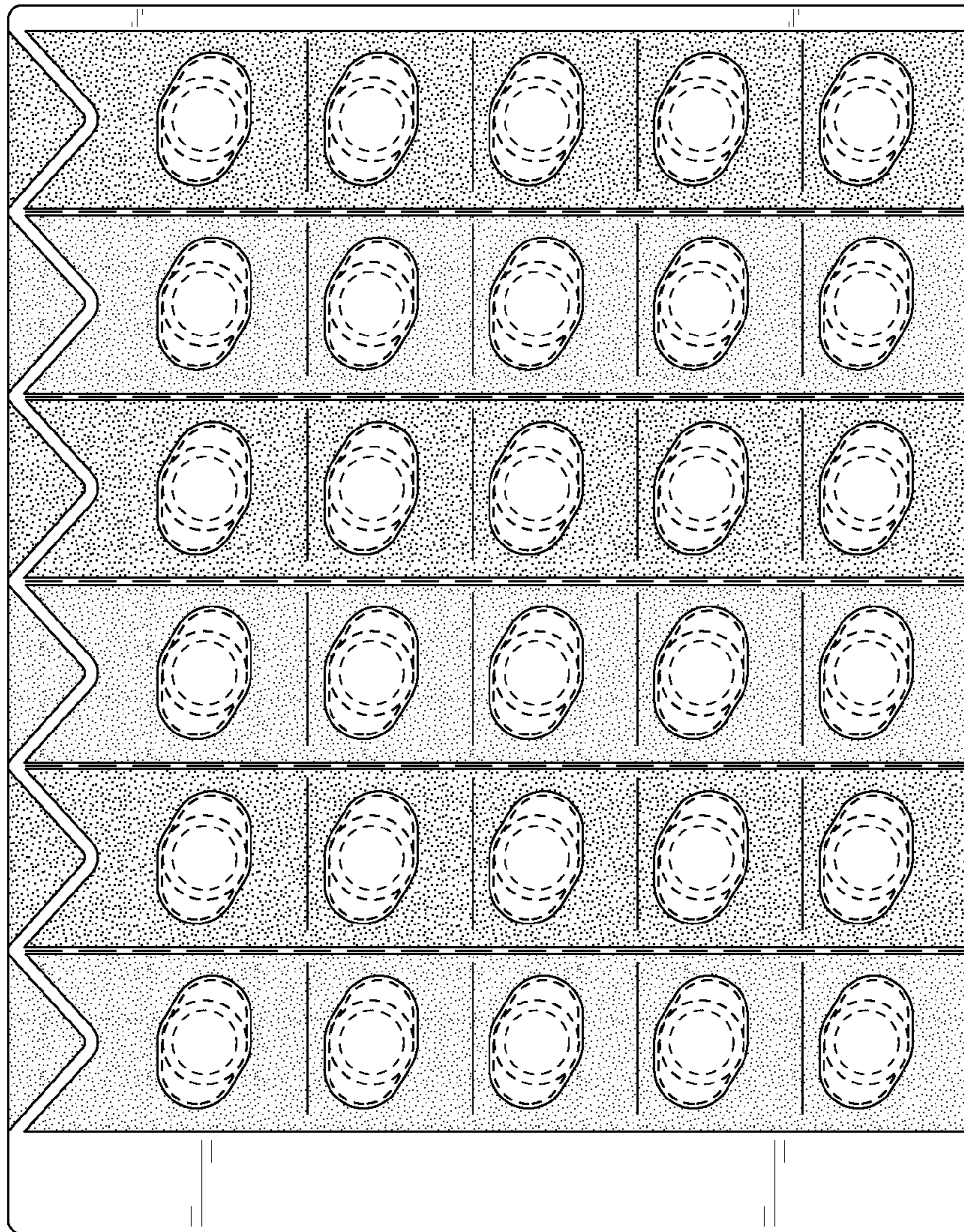

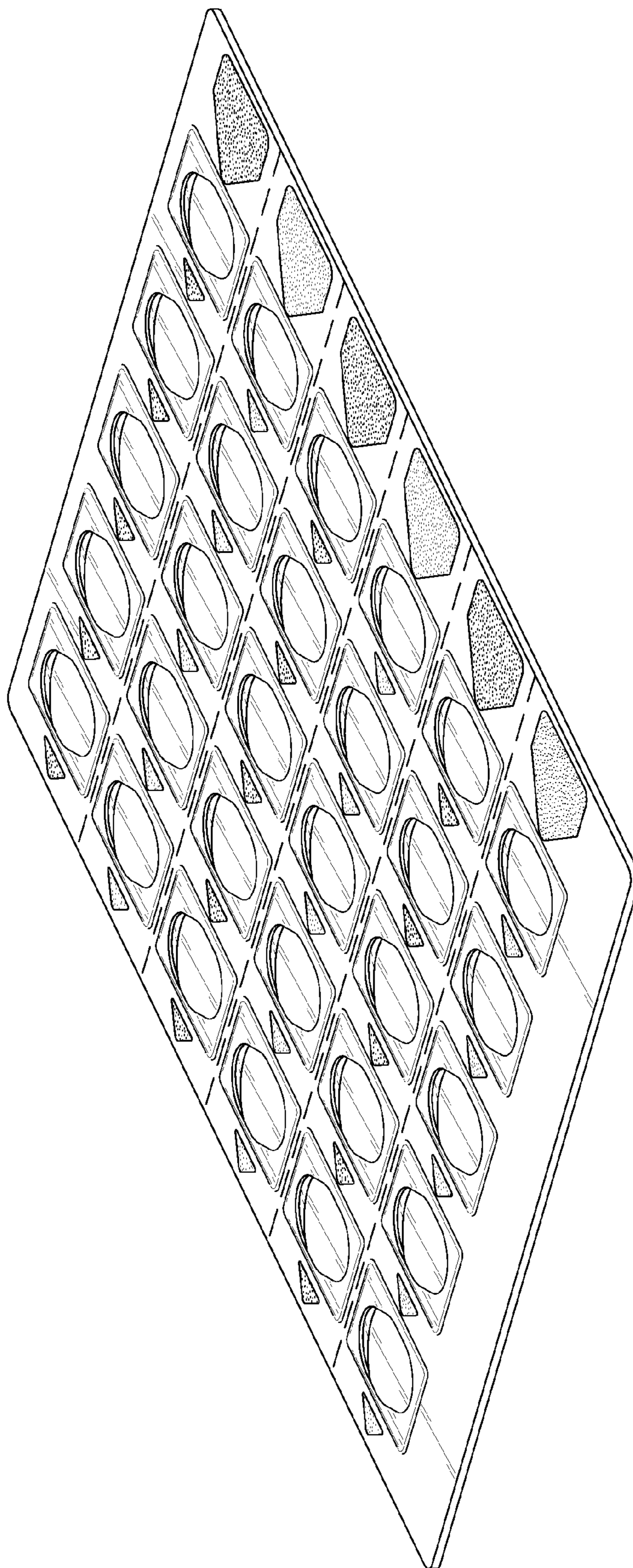

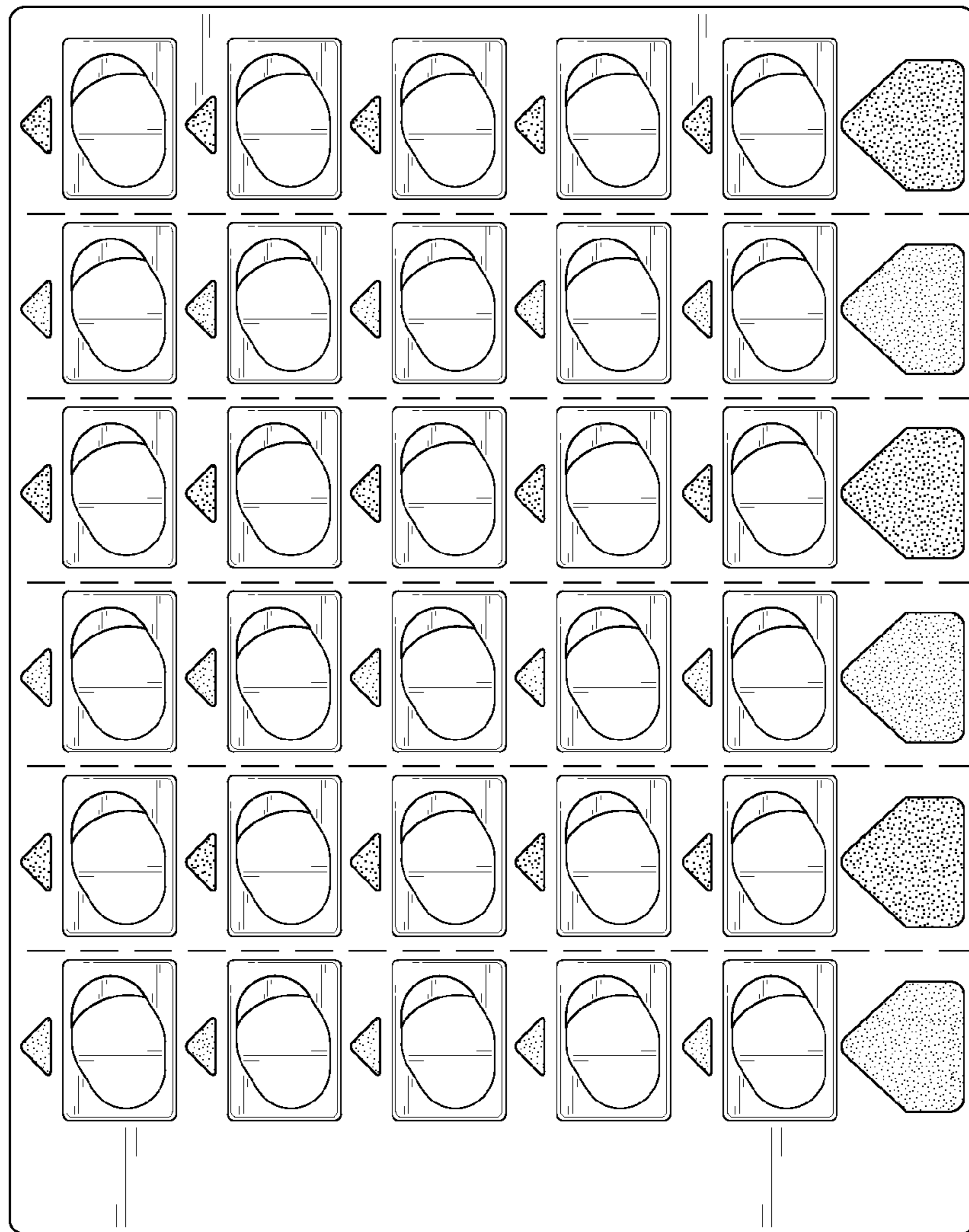
