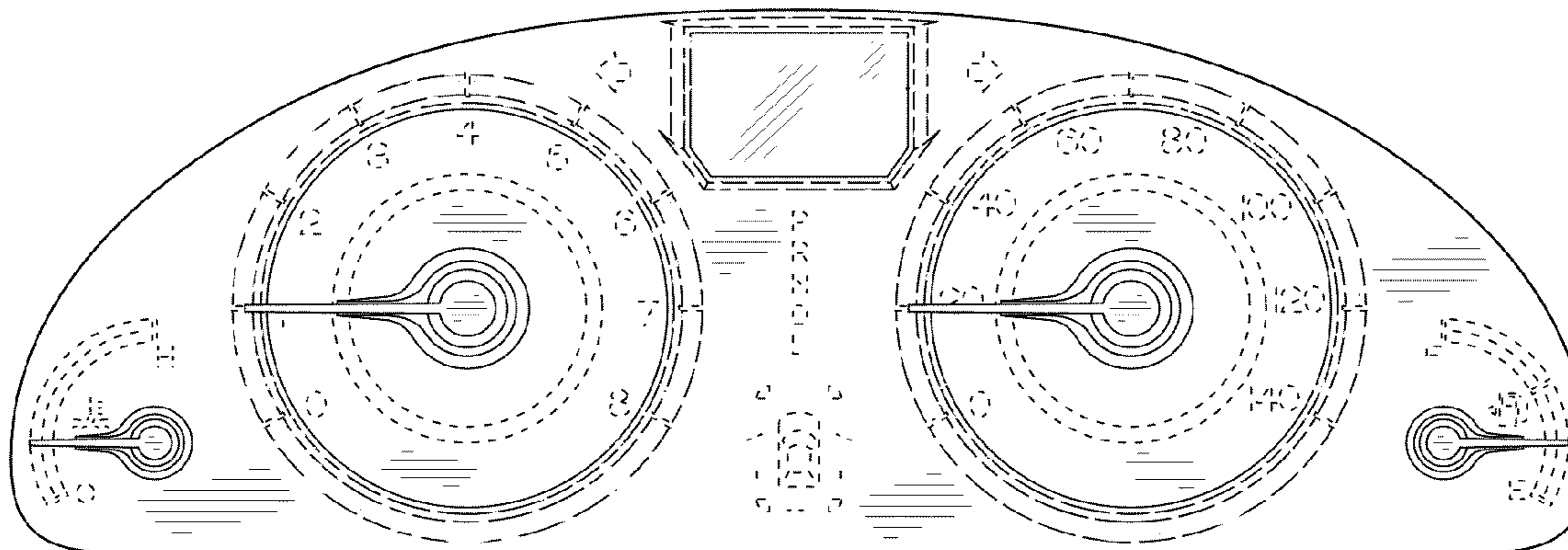
The ornamental design for a vehicle meter face, as shown and described.

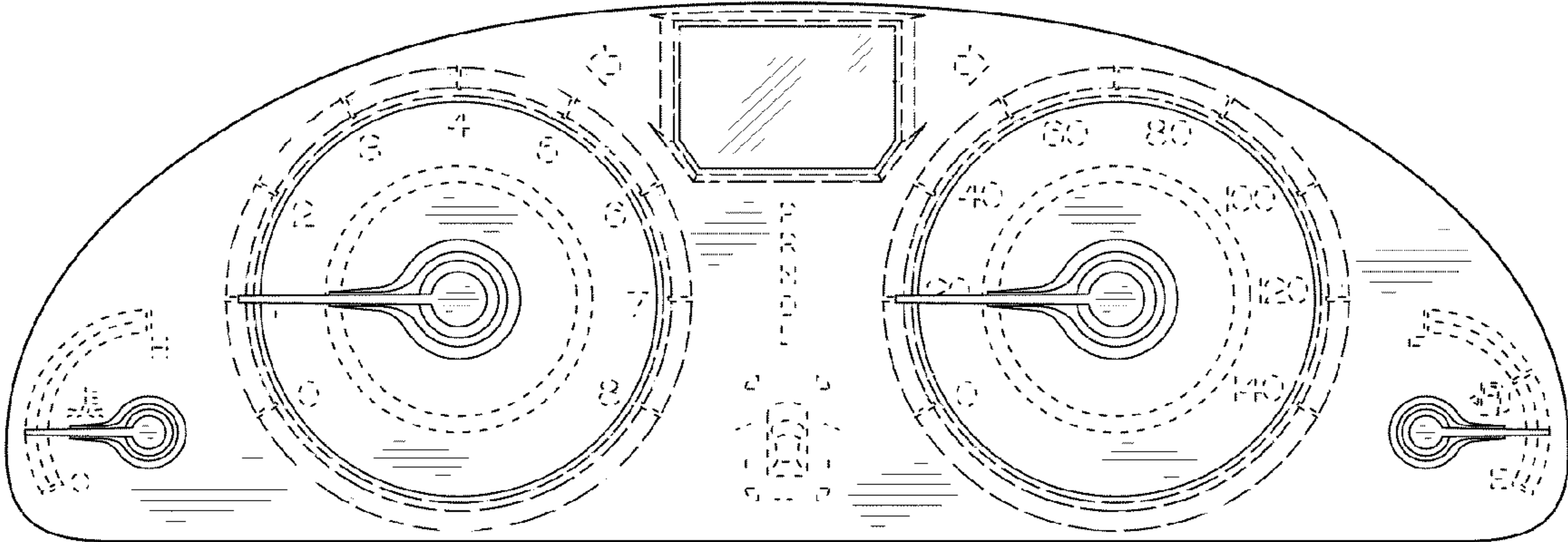
DESCRIPTION
