**DESCRIPTION**

FIG. 1 is a left, front perspective view of the license plate holder, showing my new design;

FIG. 6 is a left side view thereof;

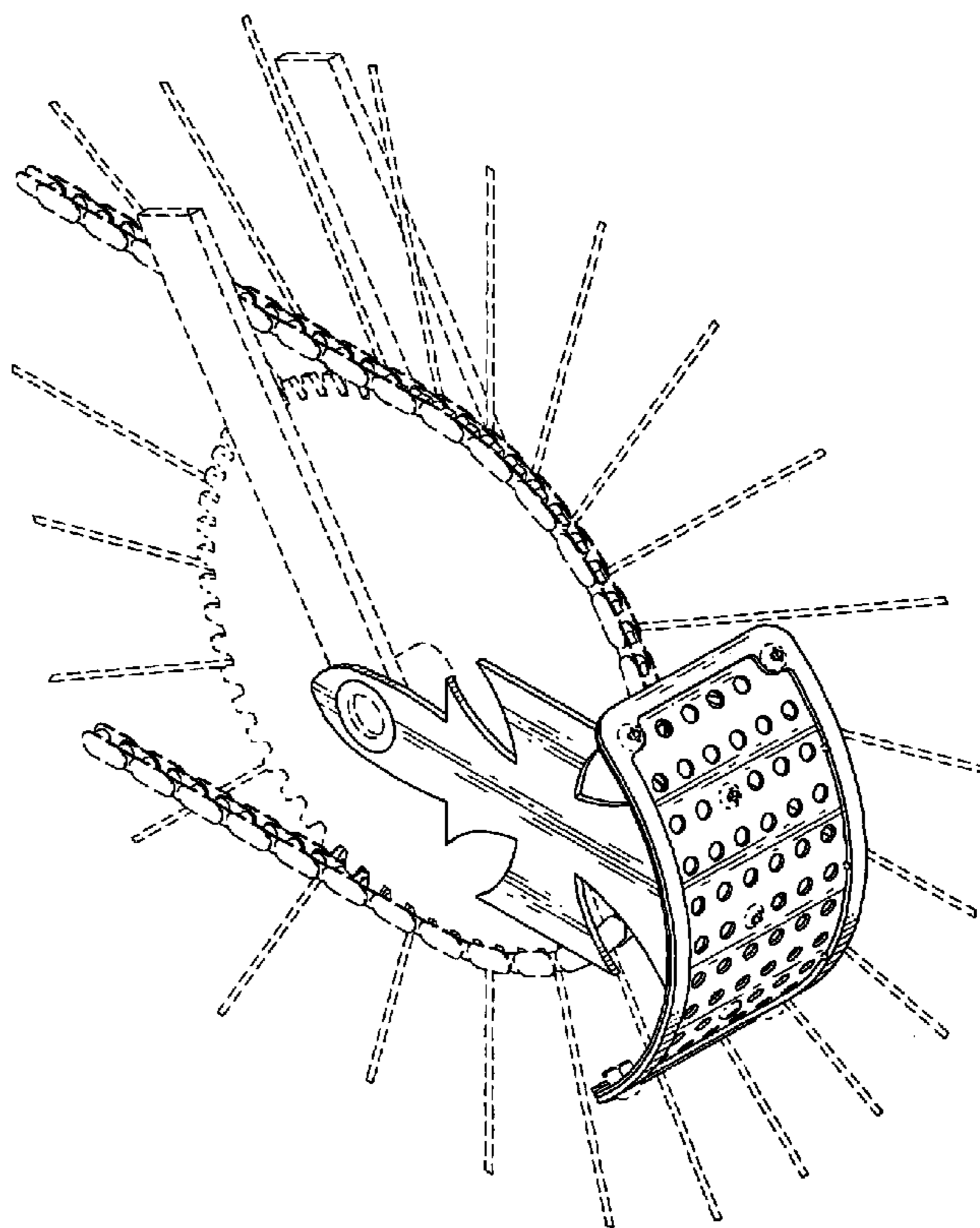
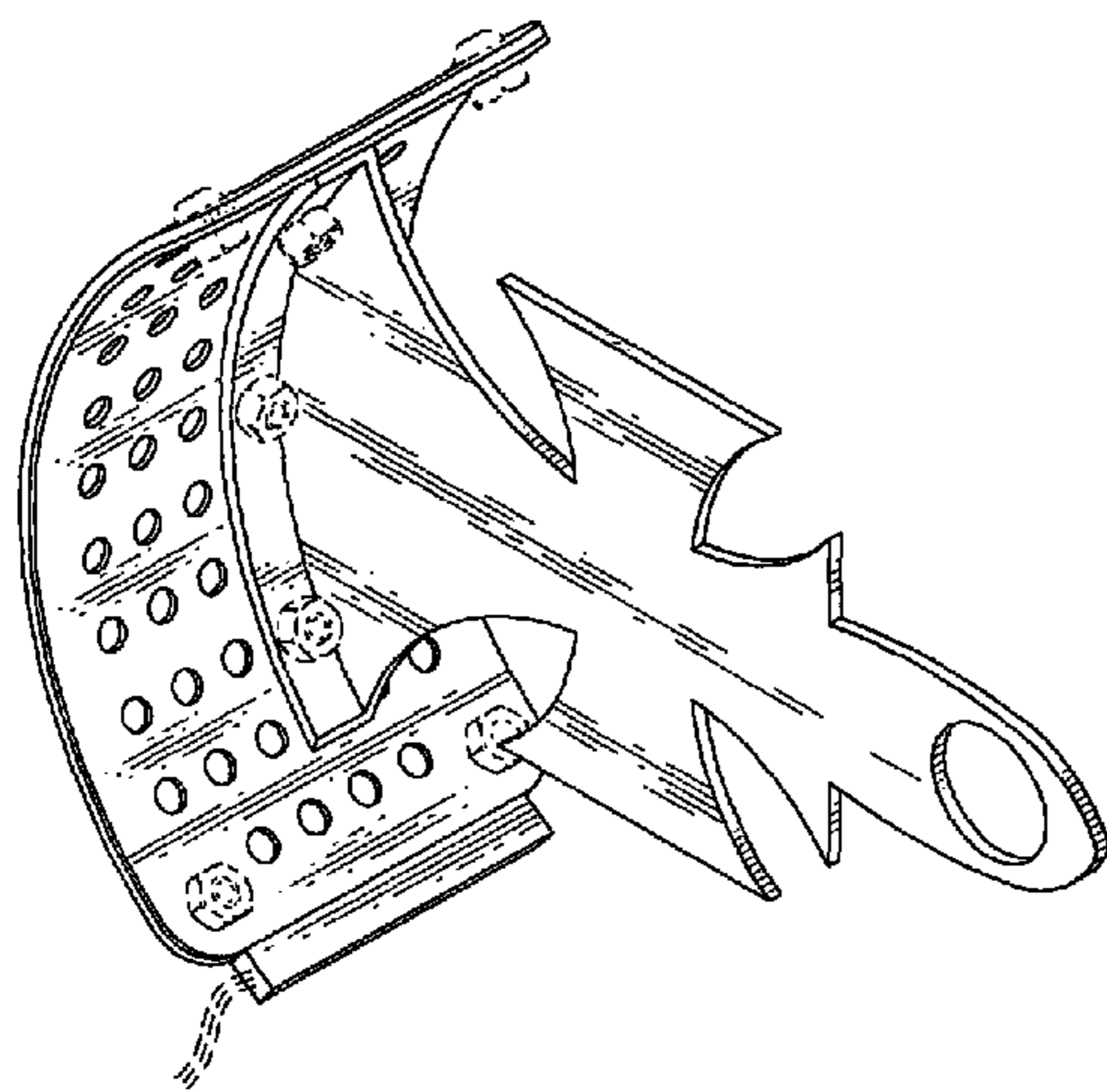
FIG. 7 is a top plan view thereof;

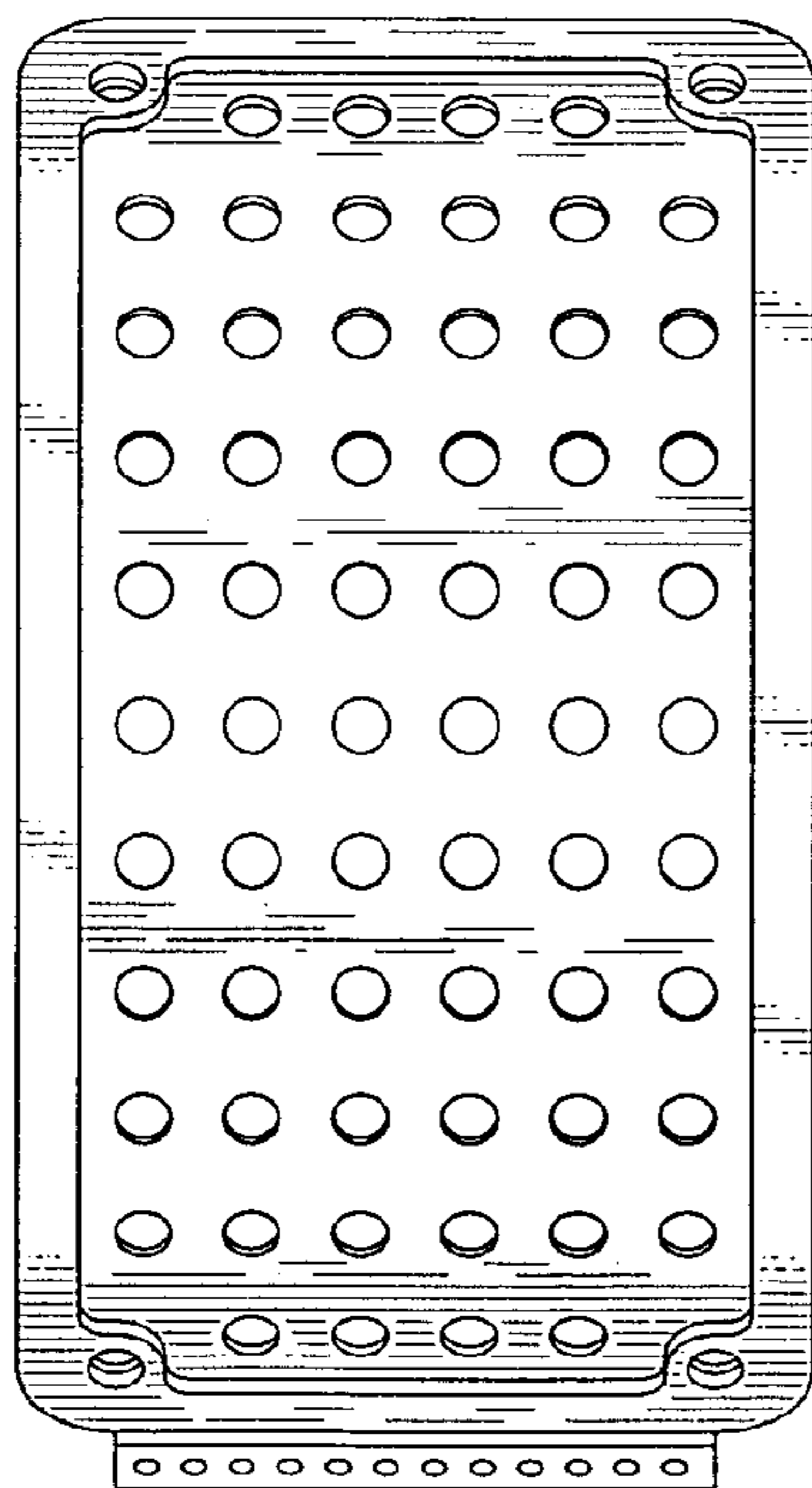
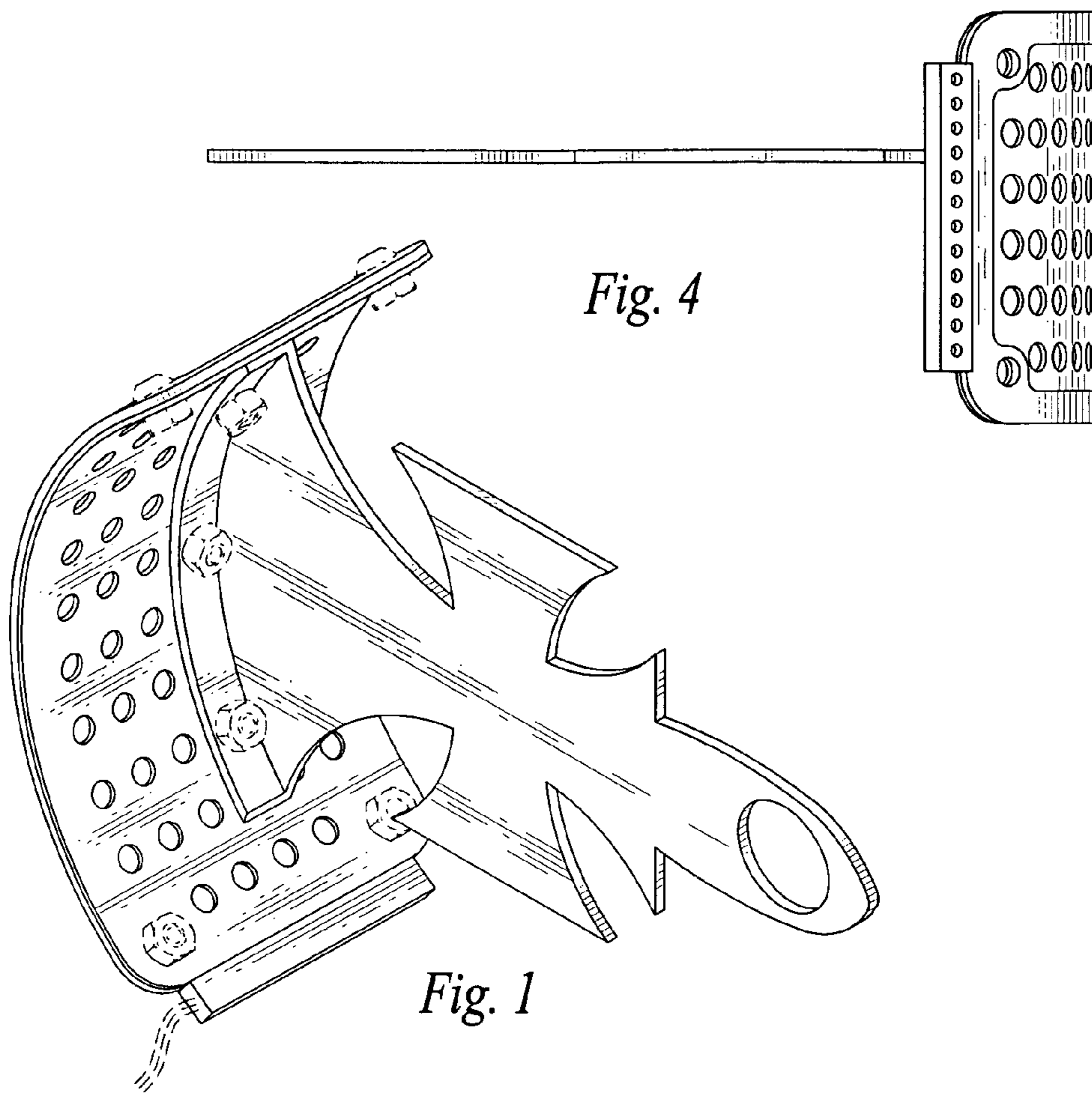

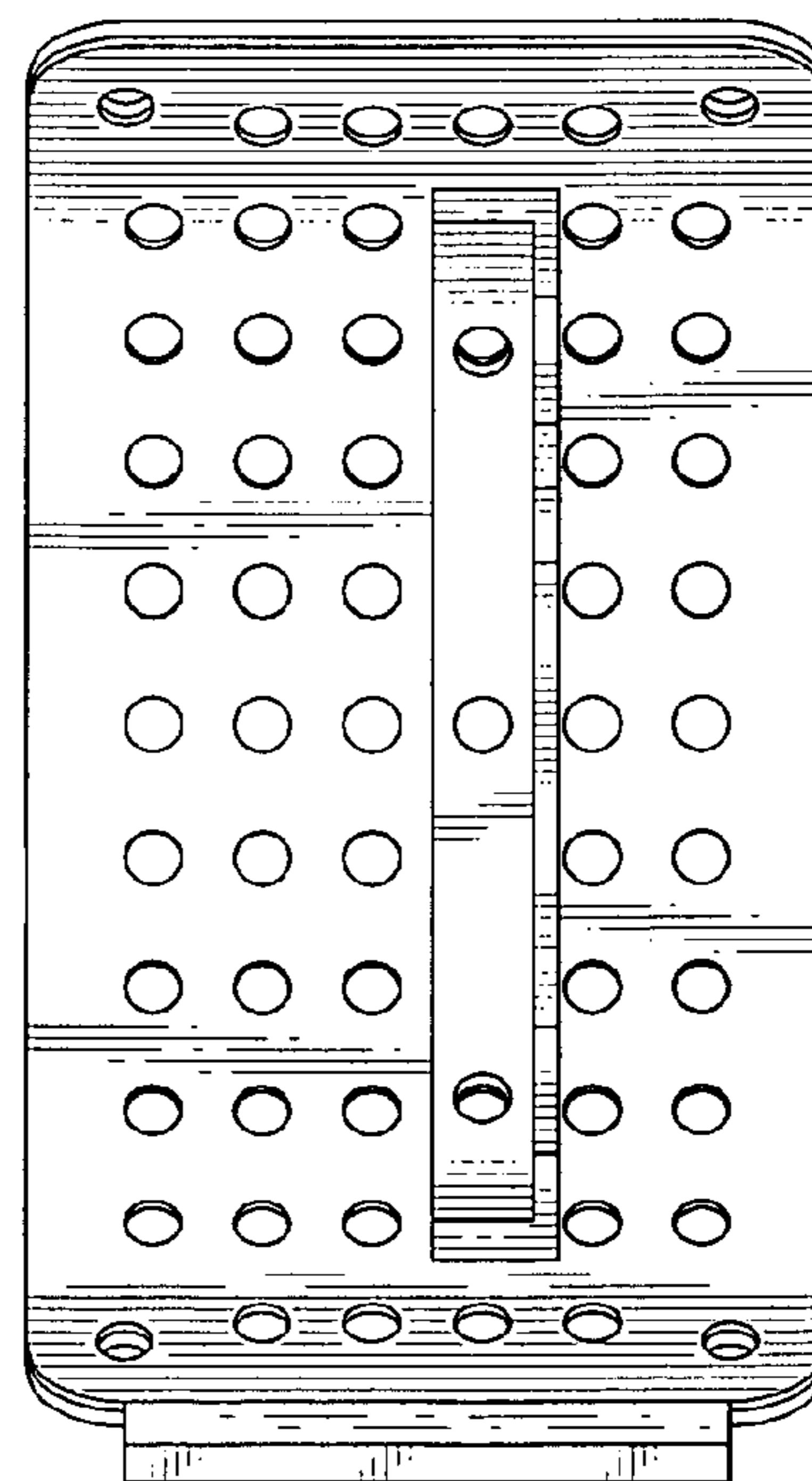
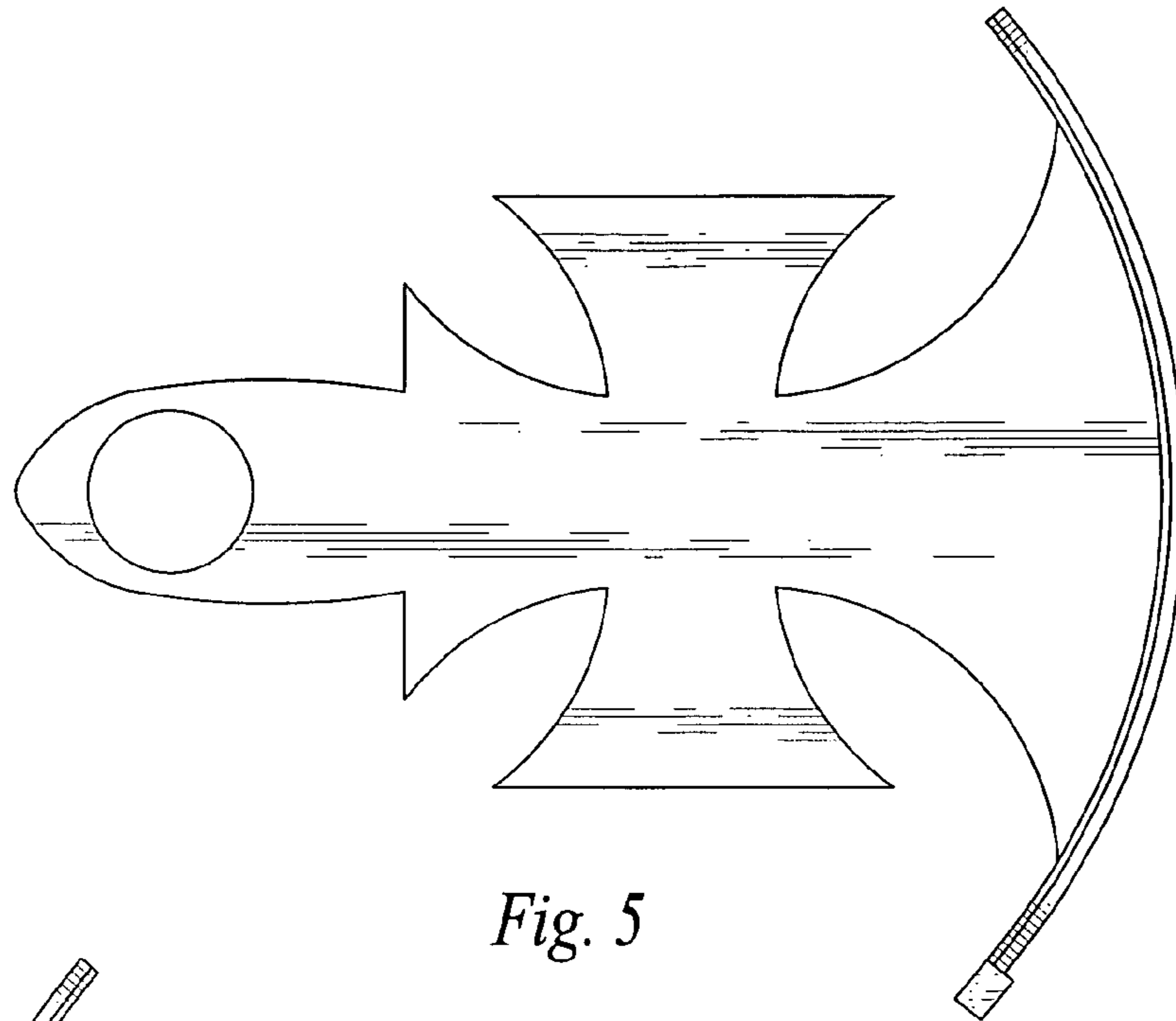
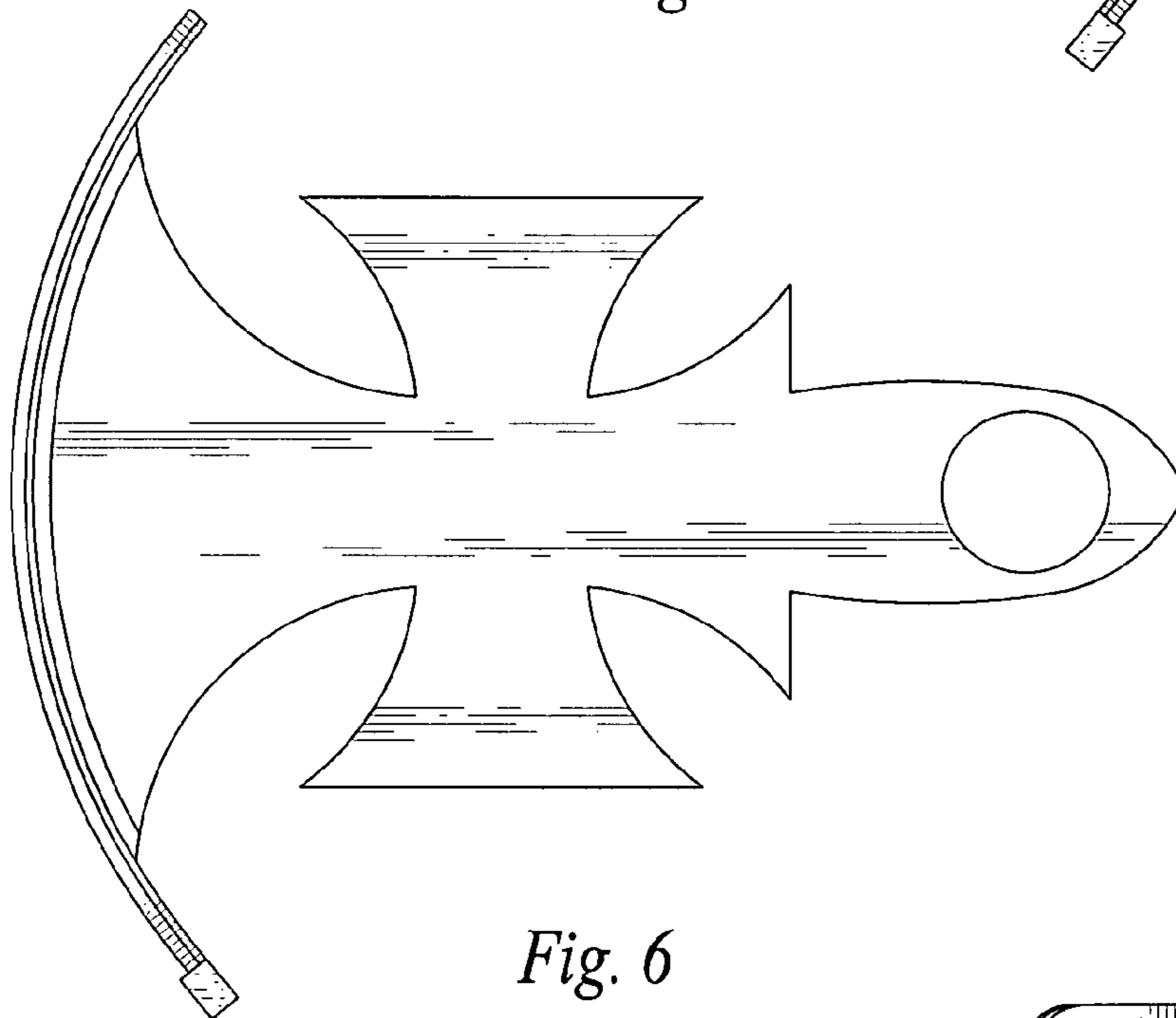


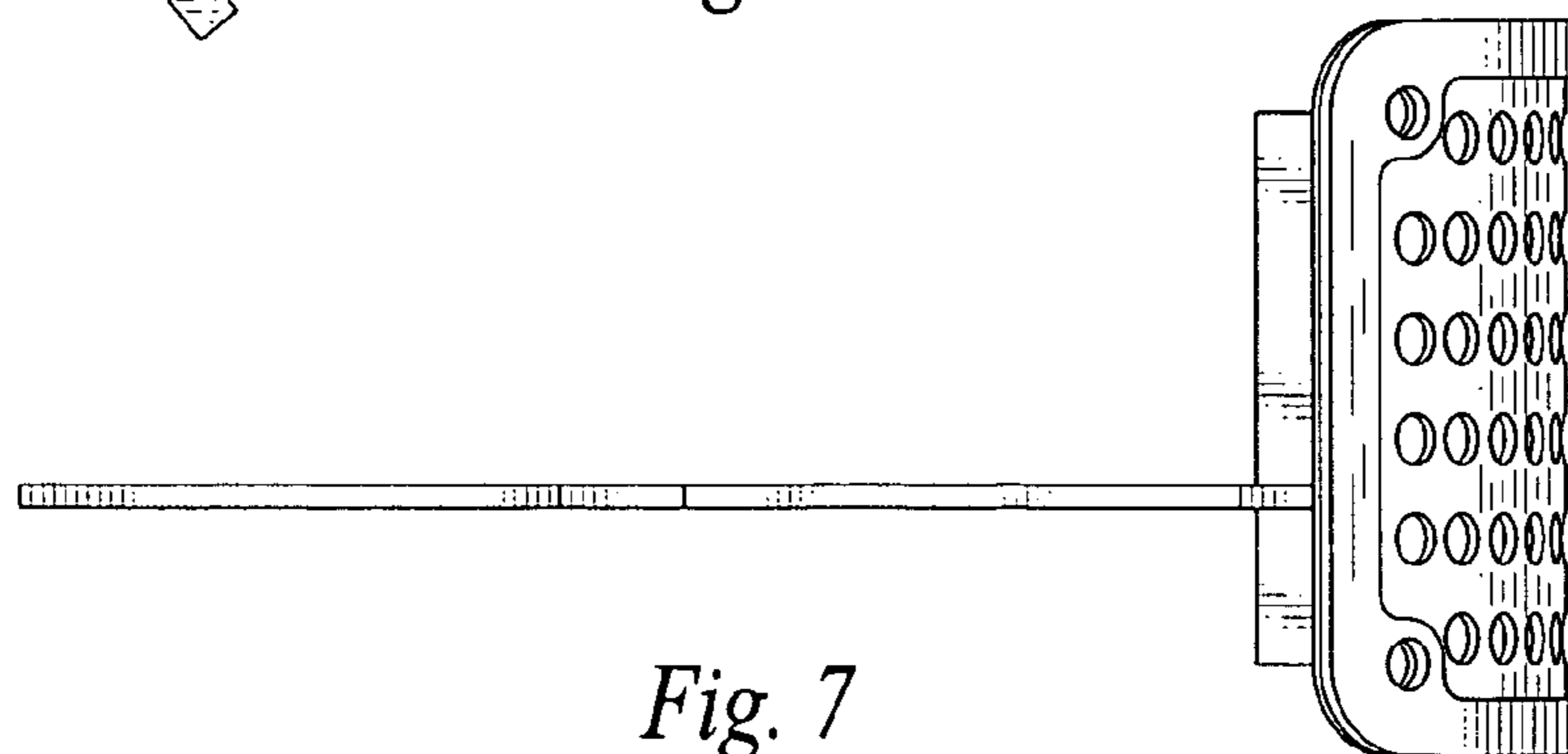

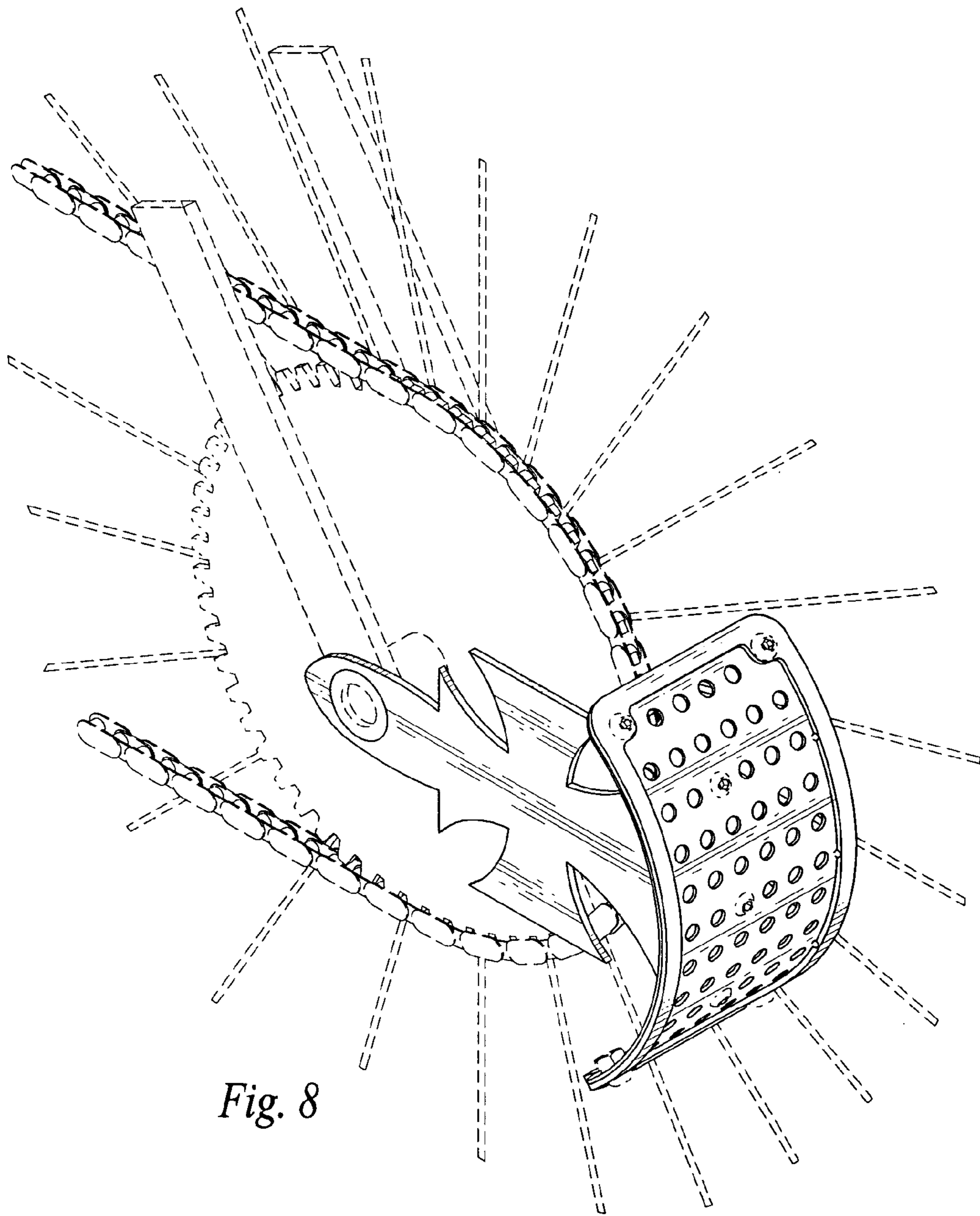

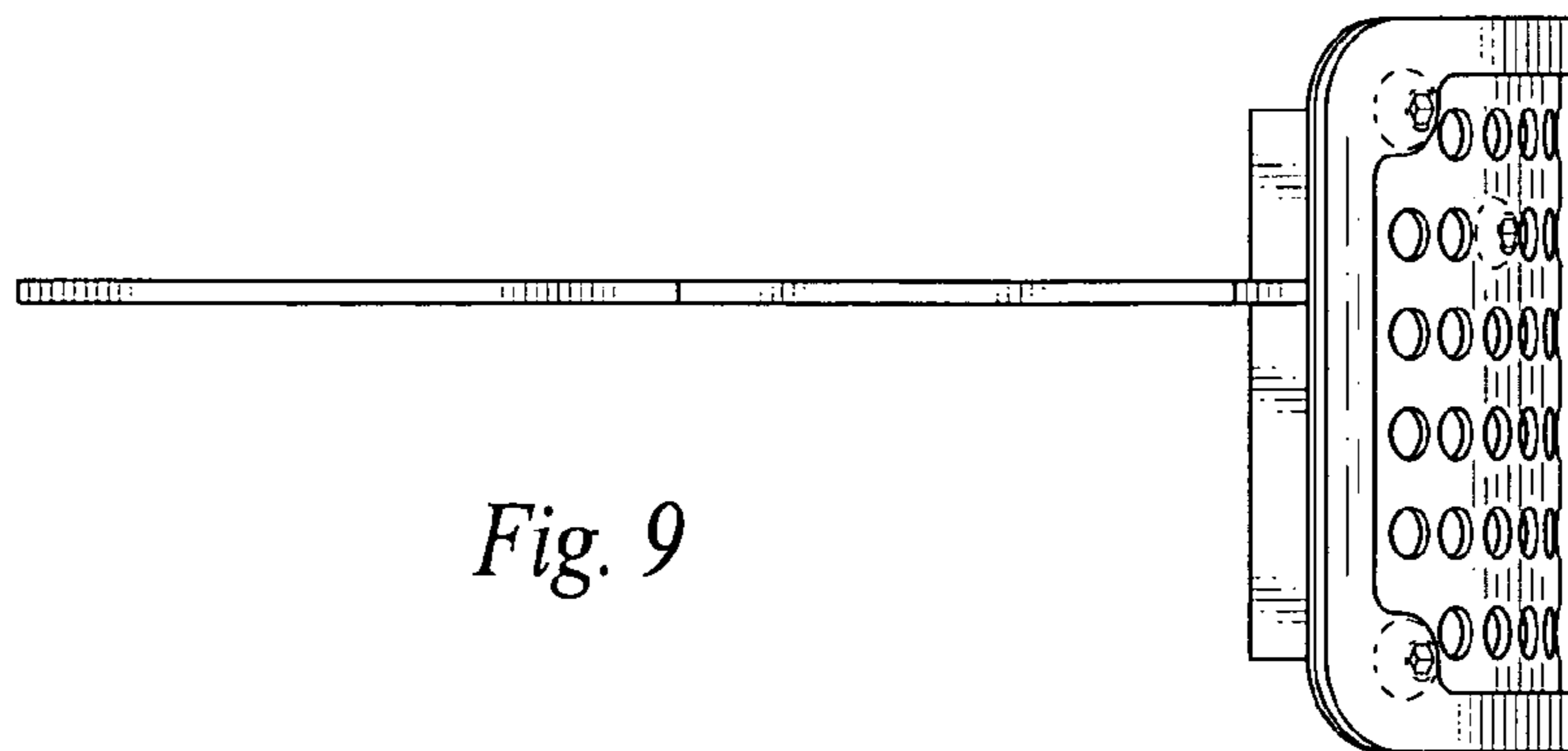
