FIG. 3 shows a left side elevation view thereof;

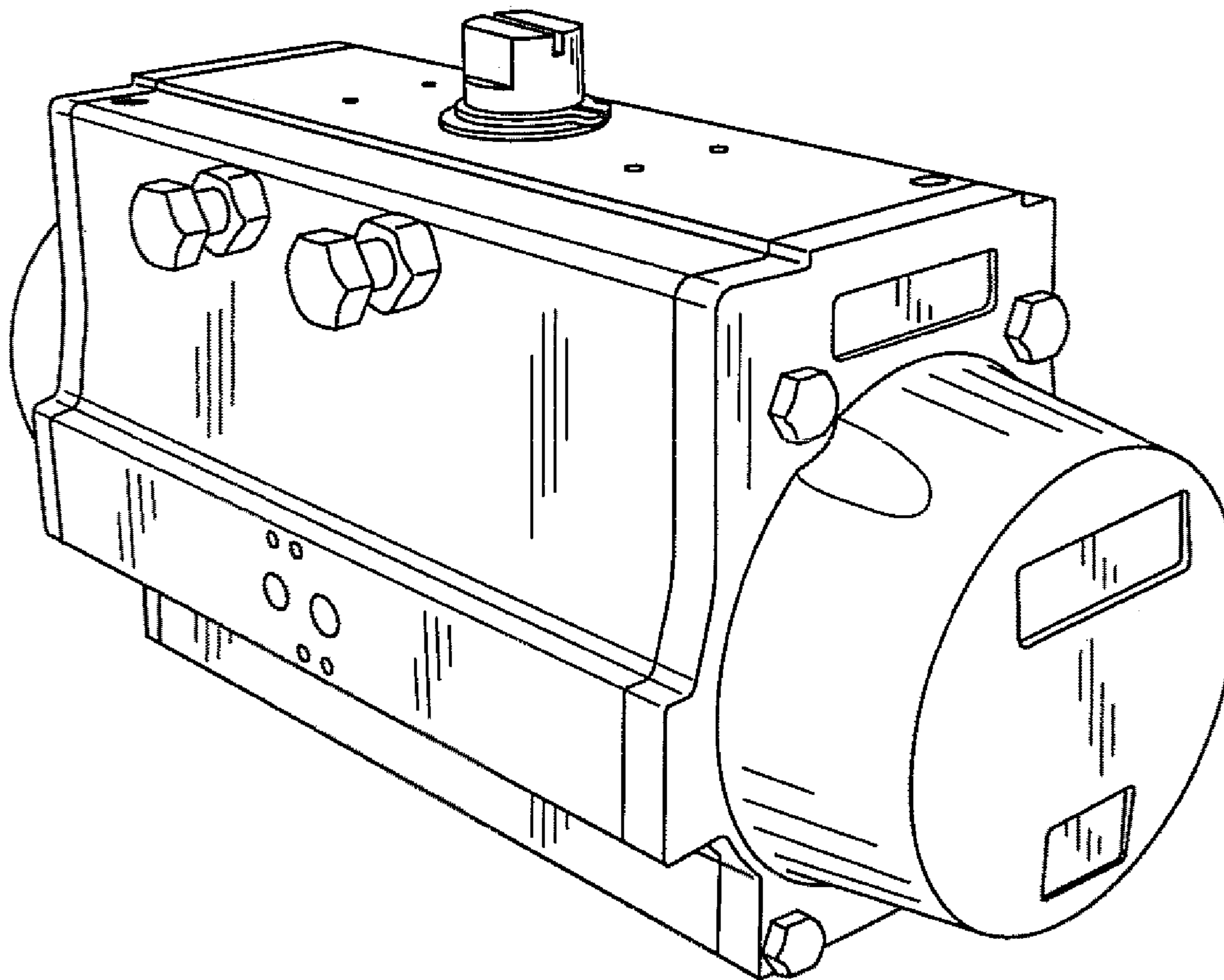
FIG. 4 shows a bottom plan thereof;

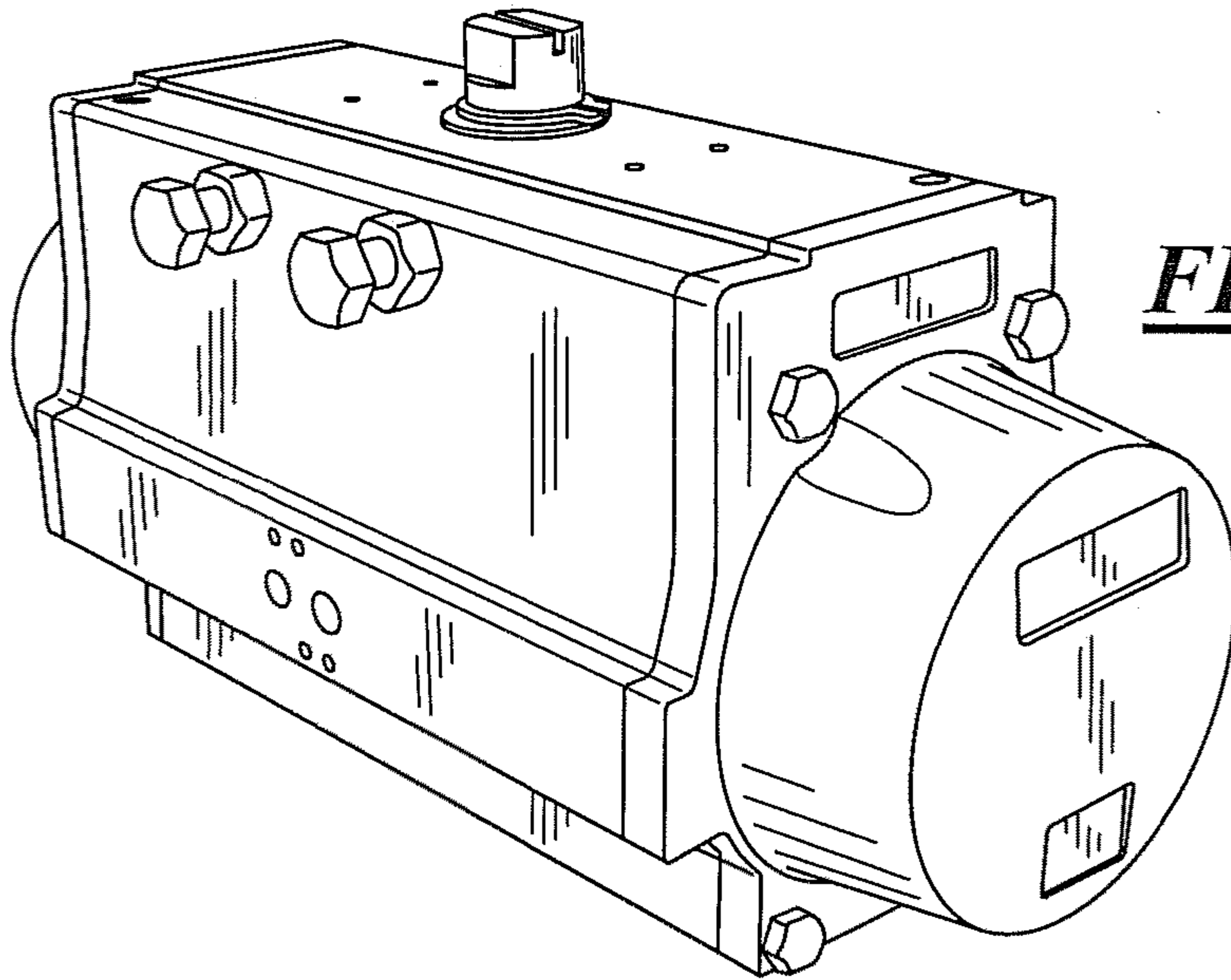
FIG. 5 shows a right side elevation view thereof;

FIG. 6 shows an end elevation view thereof; and,

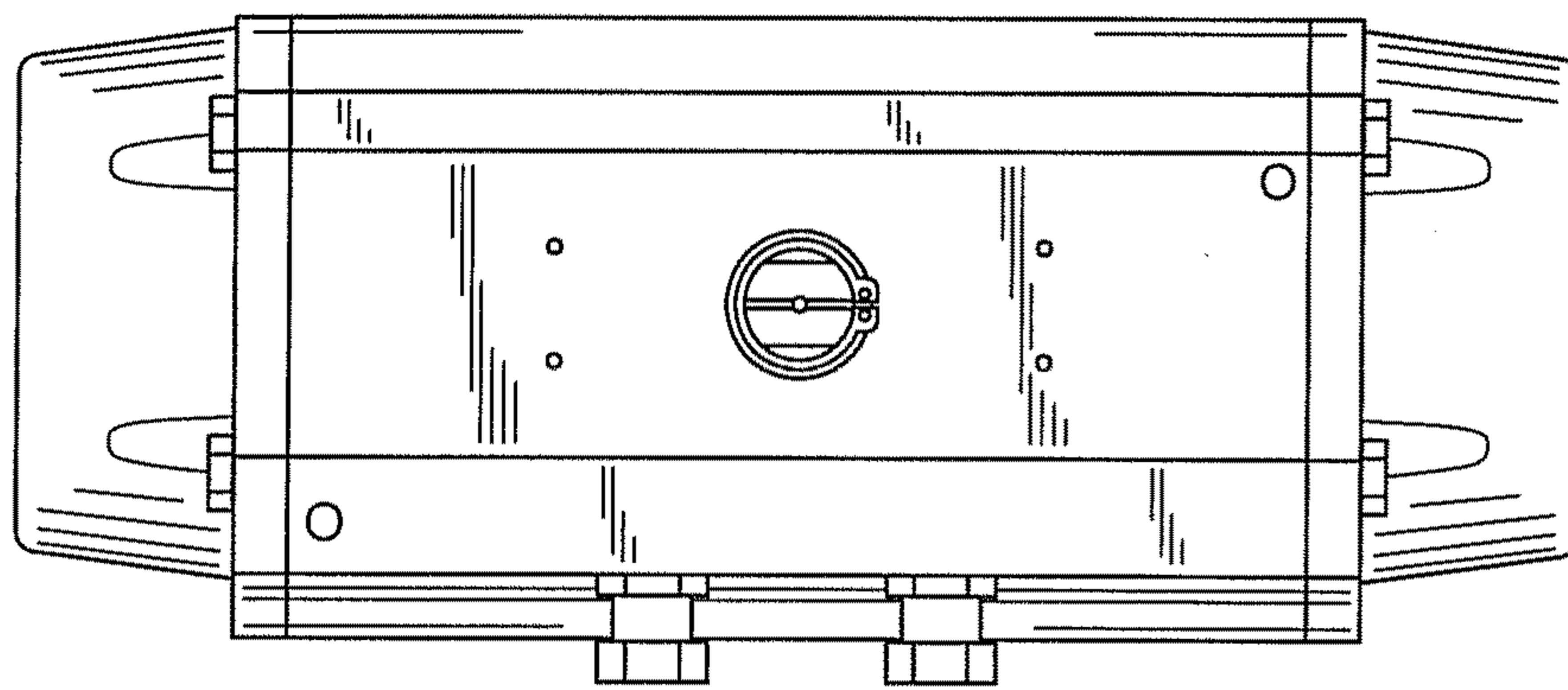
FIG. 7 shows an opposite end elevation view thereof.

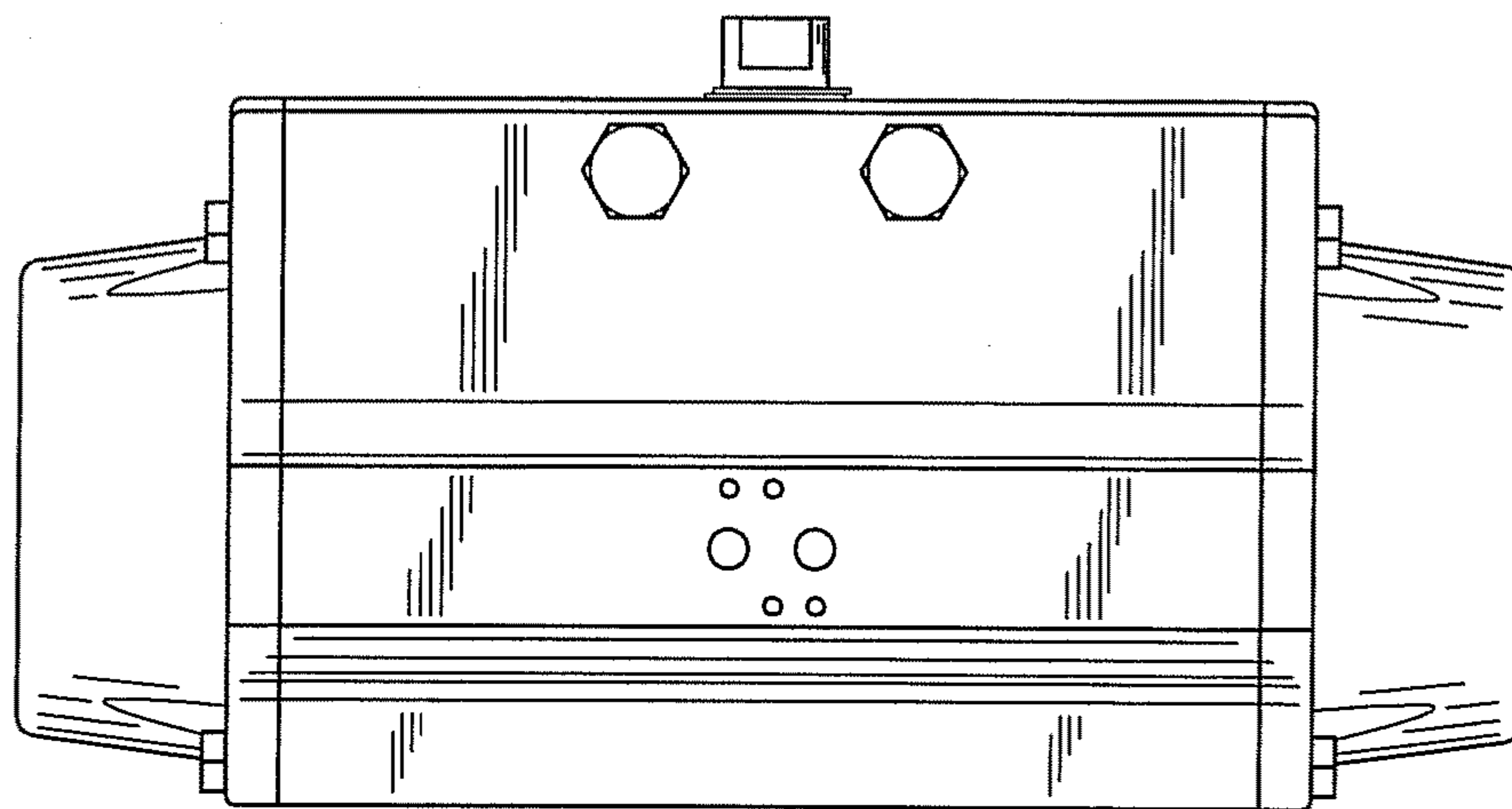




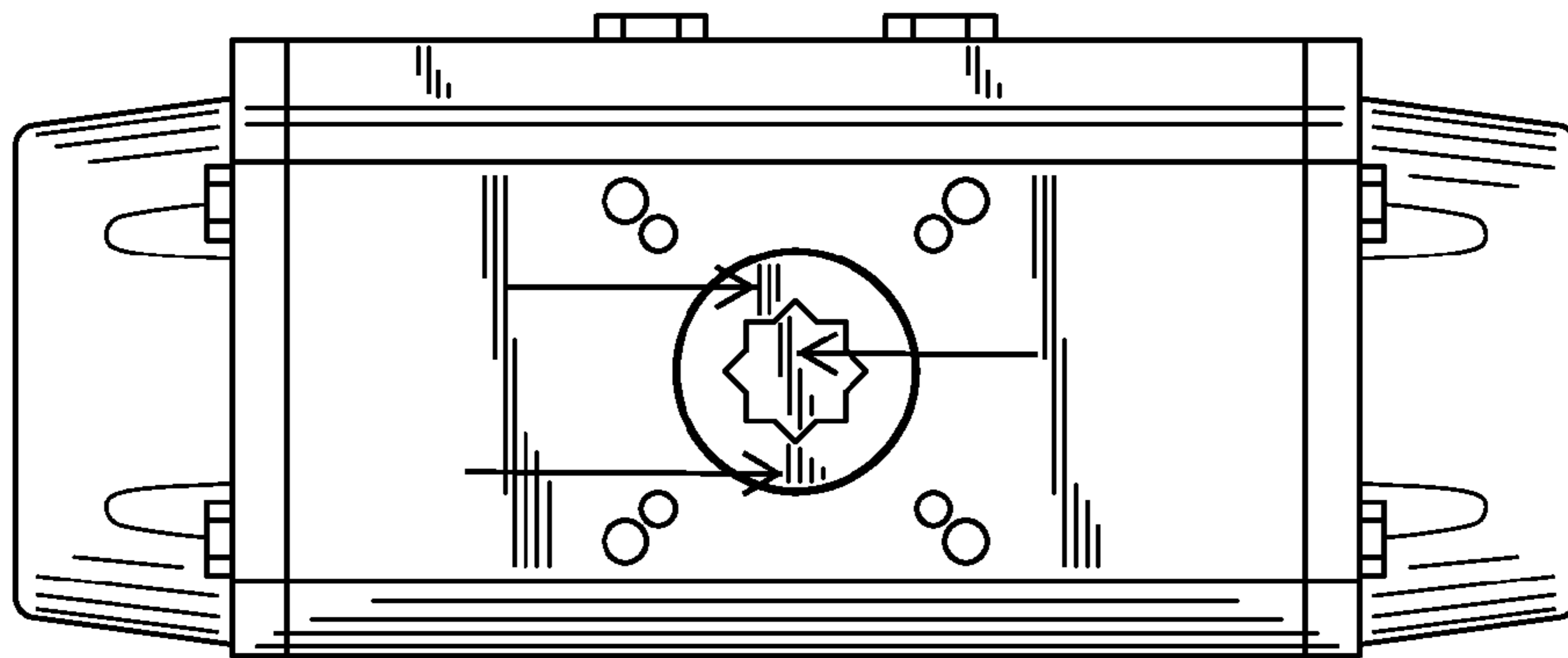

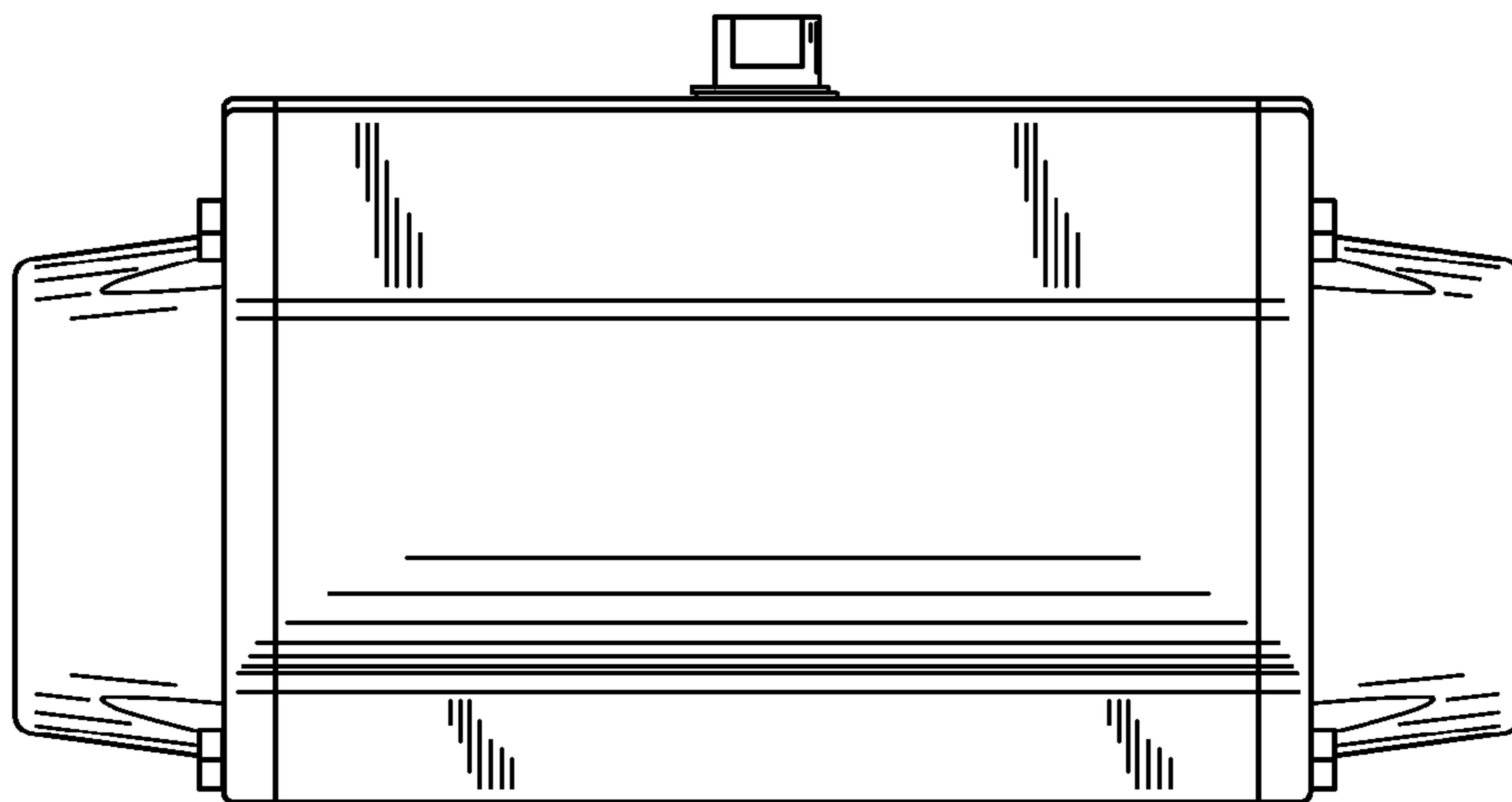

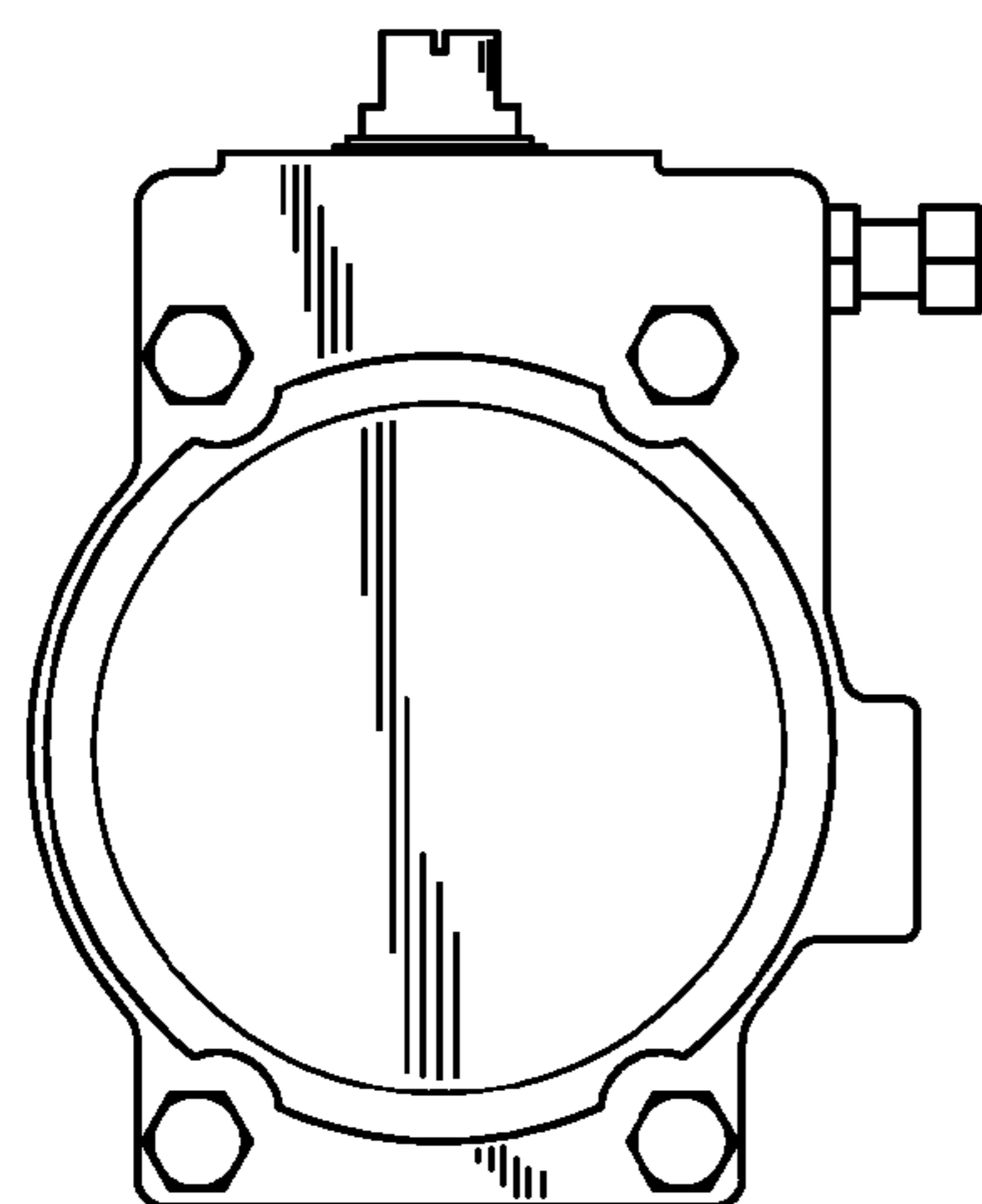

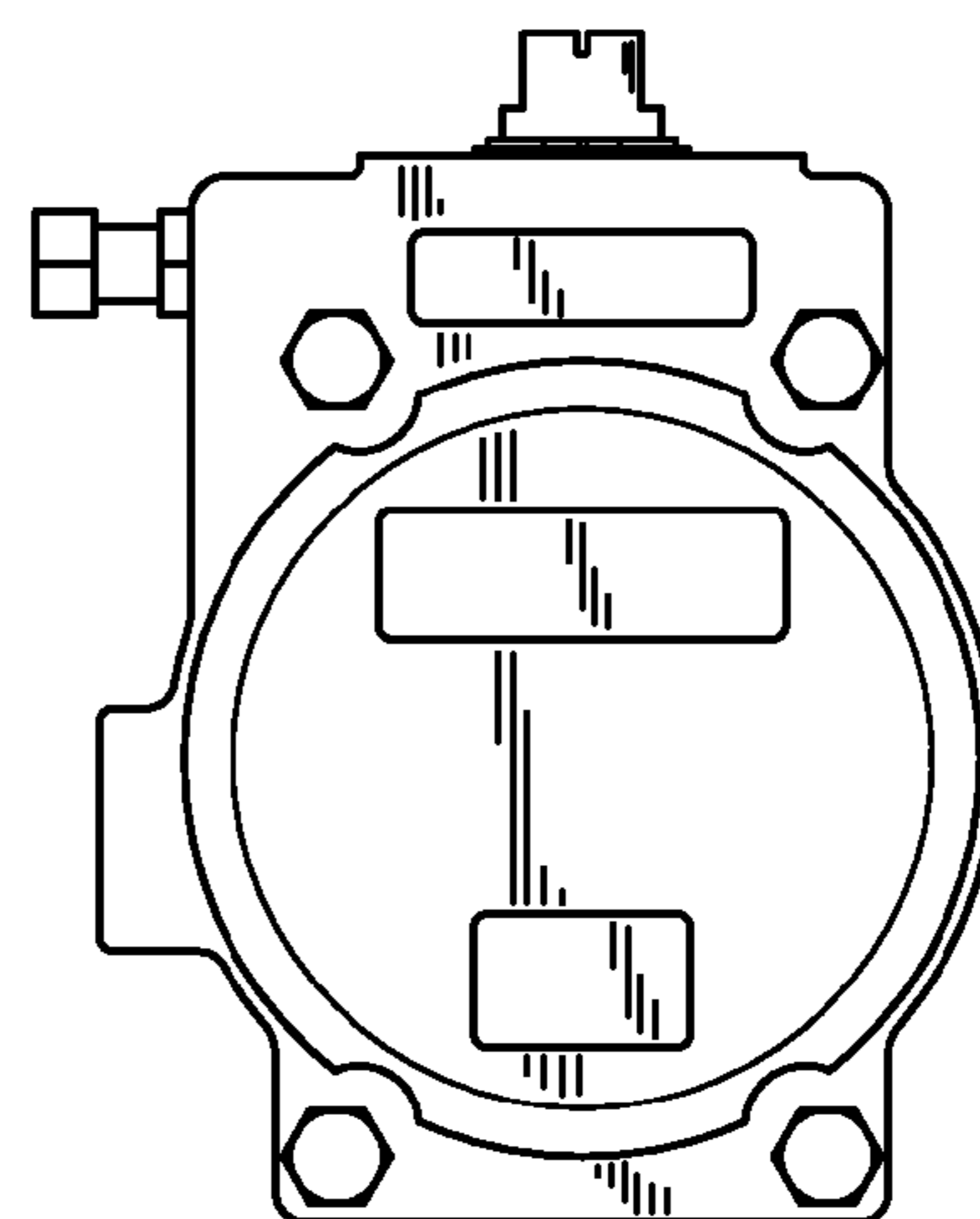

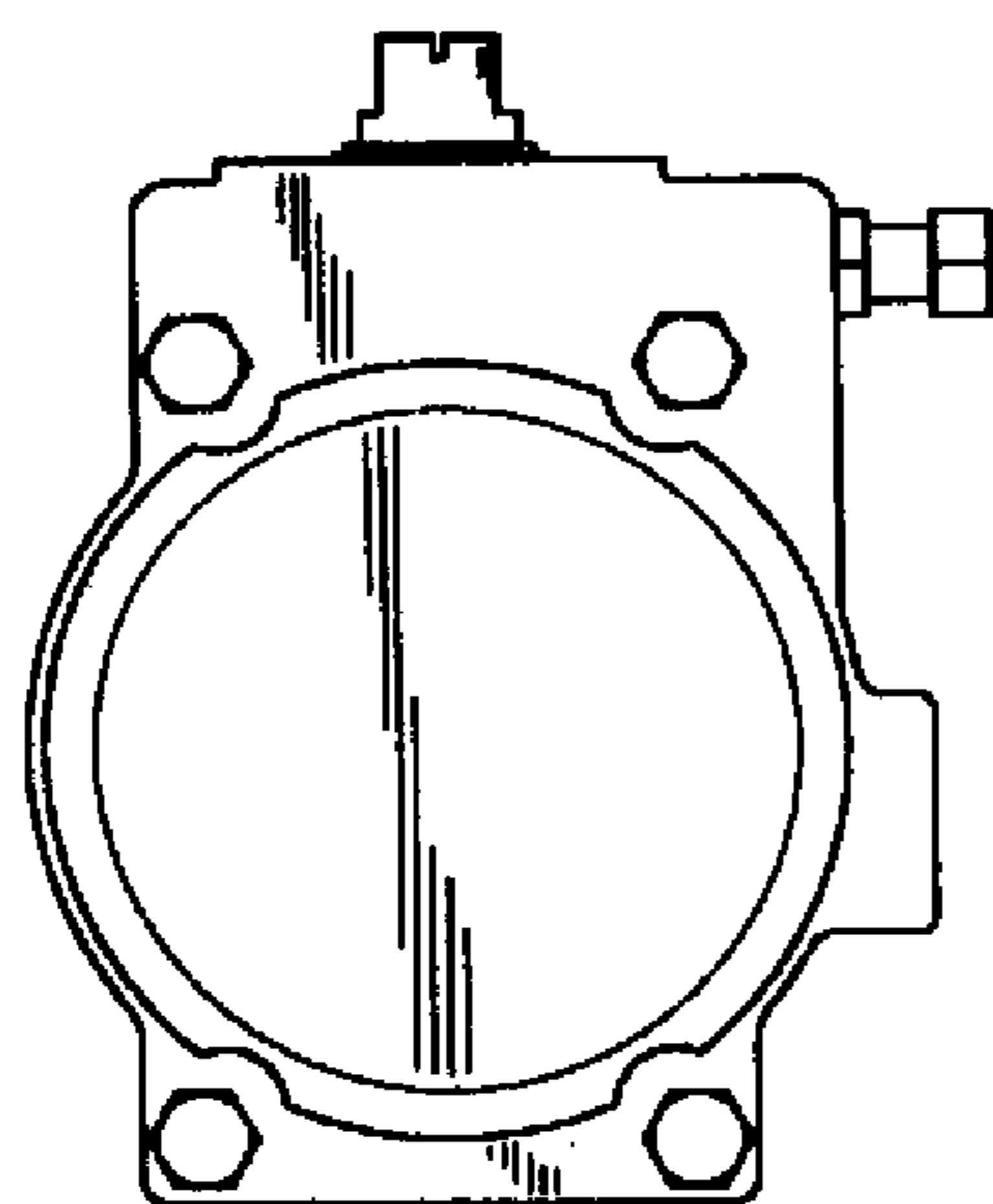

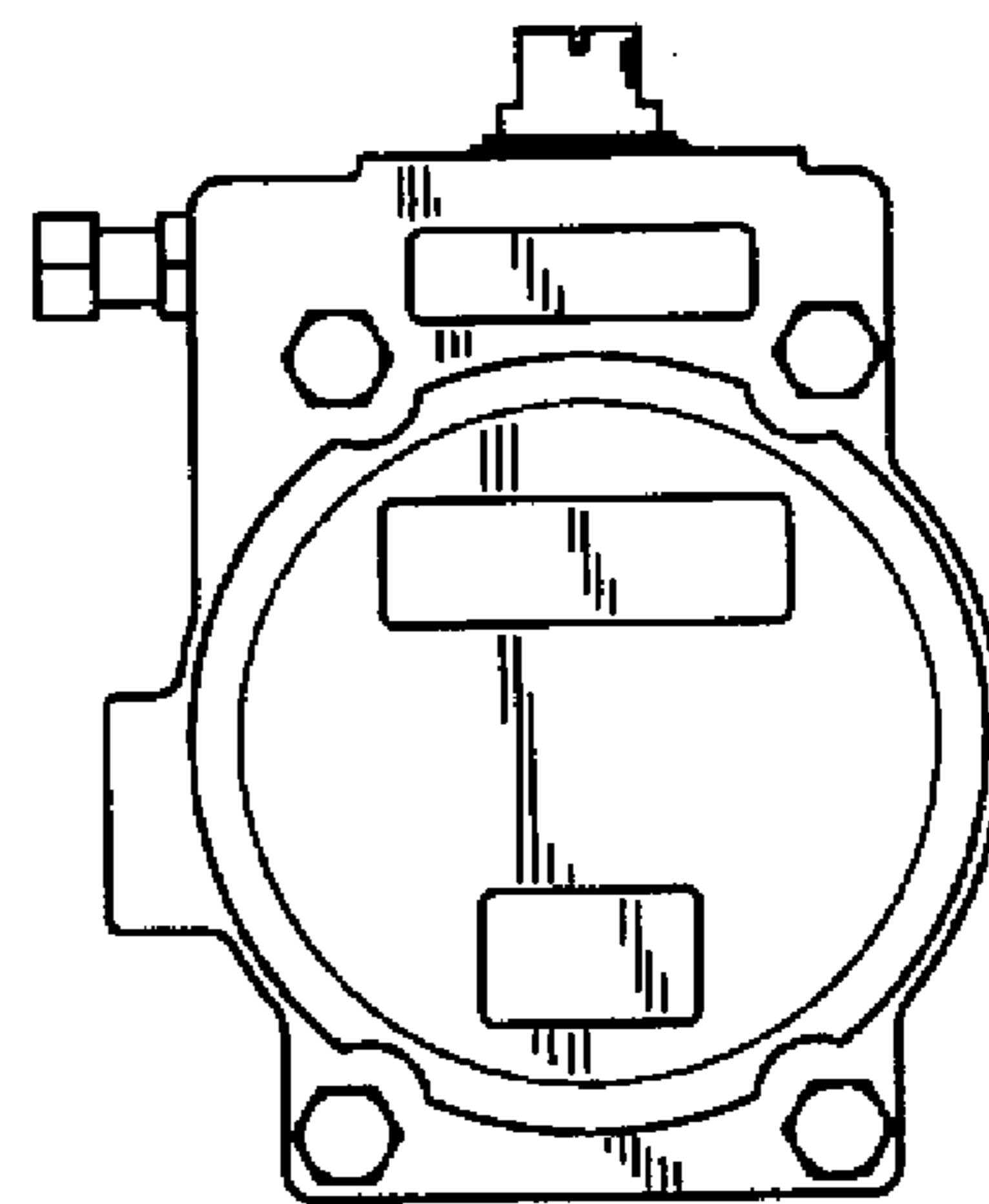
