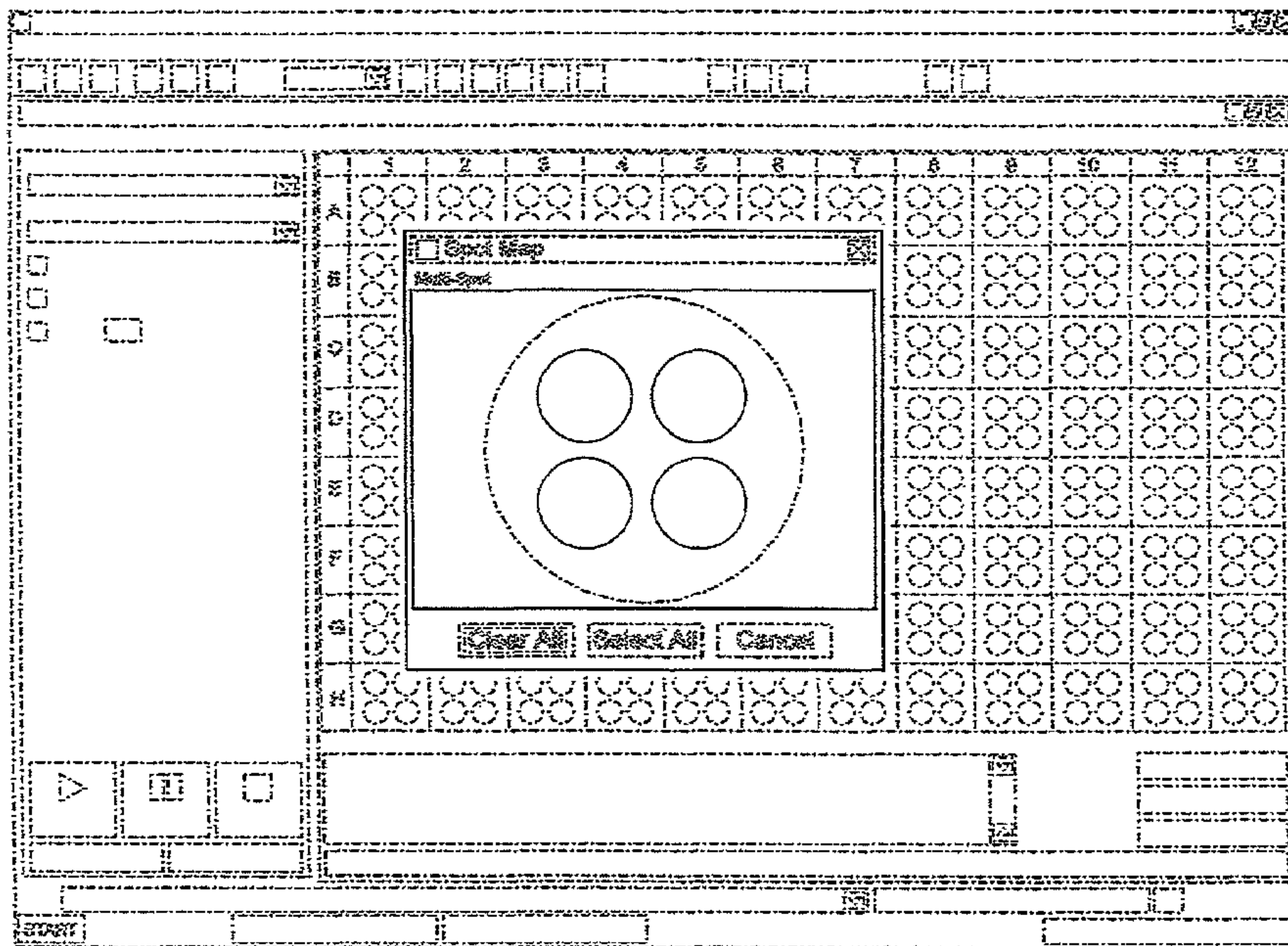
(57) **CLAIM**

The ornamental design for a graphic user interface for a display panel or screen for representing assay domains, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a graphic user interface for a display panel or screen showing our new design;

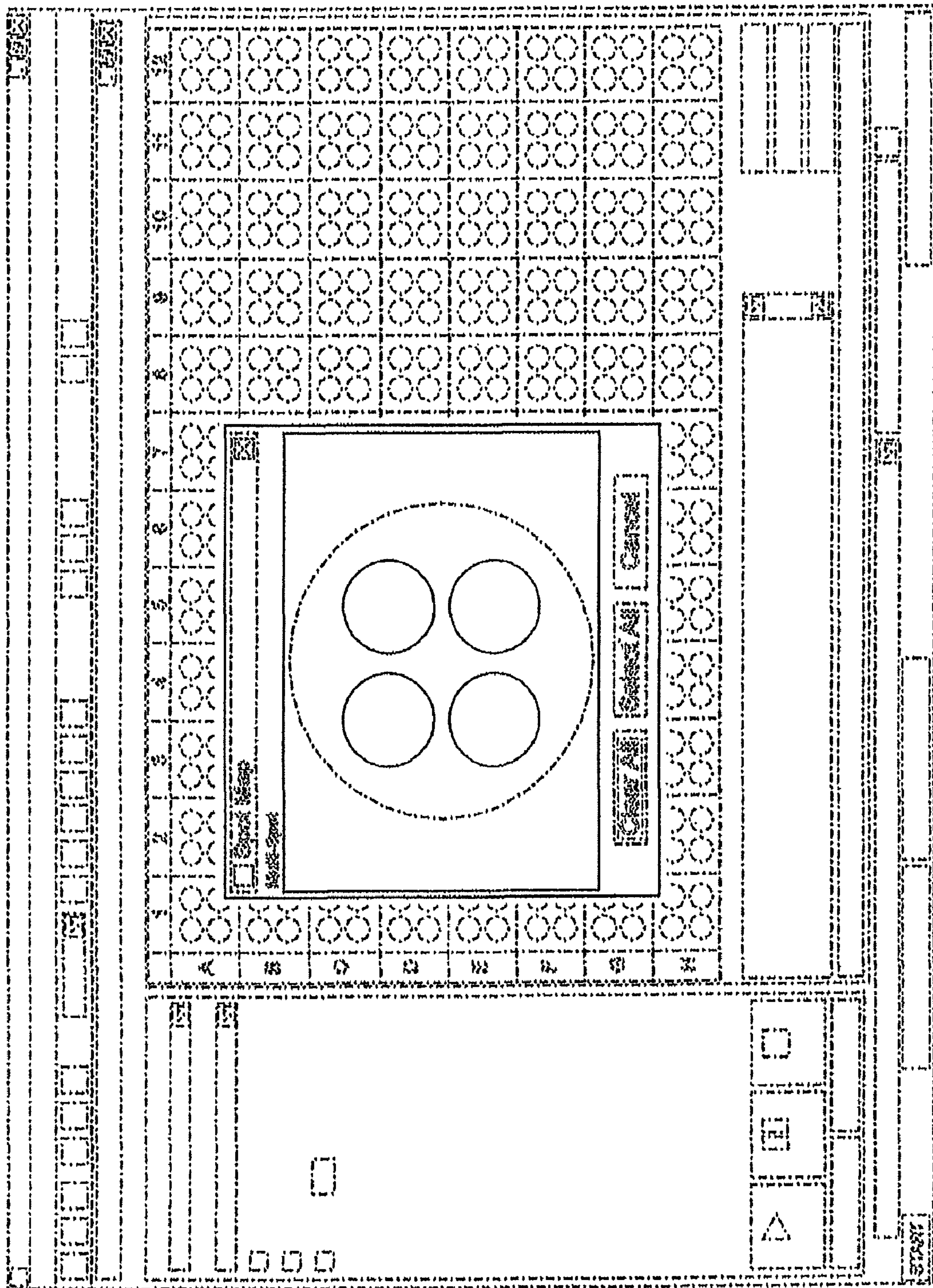

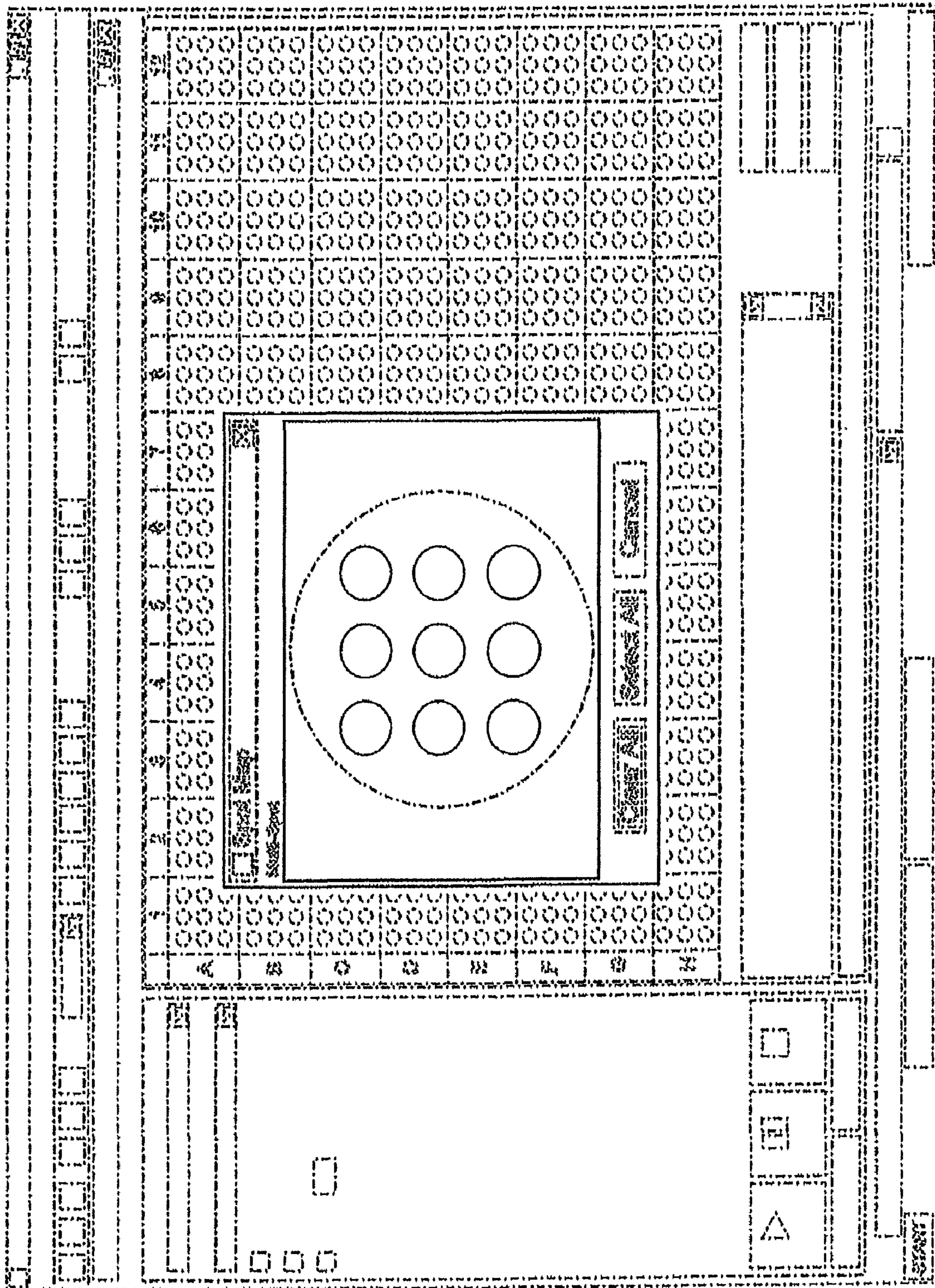
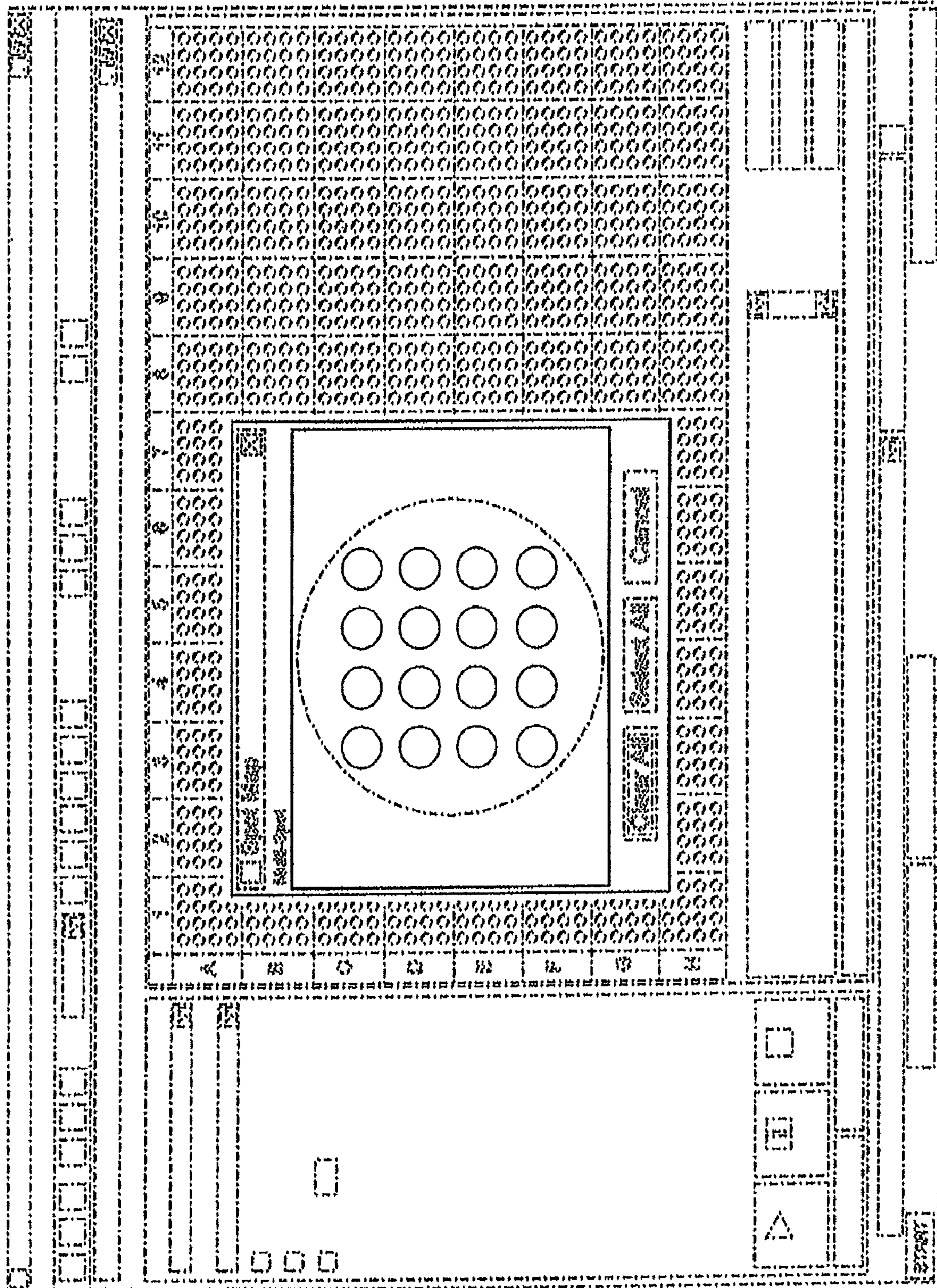

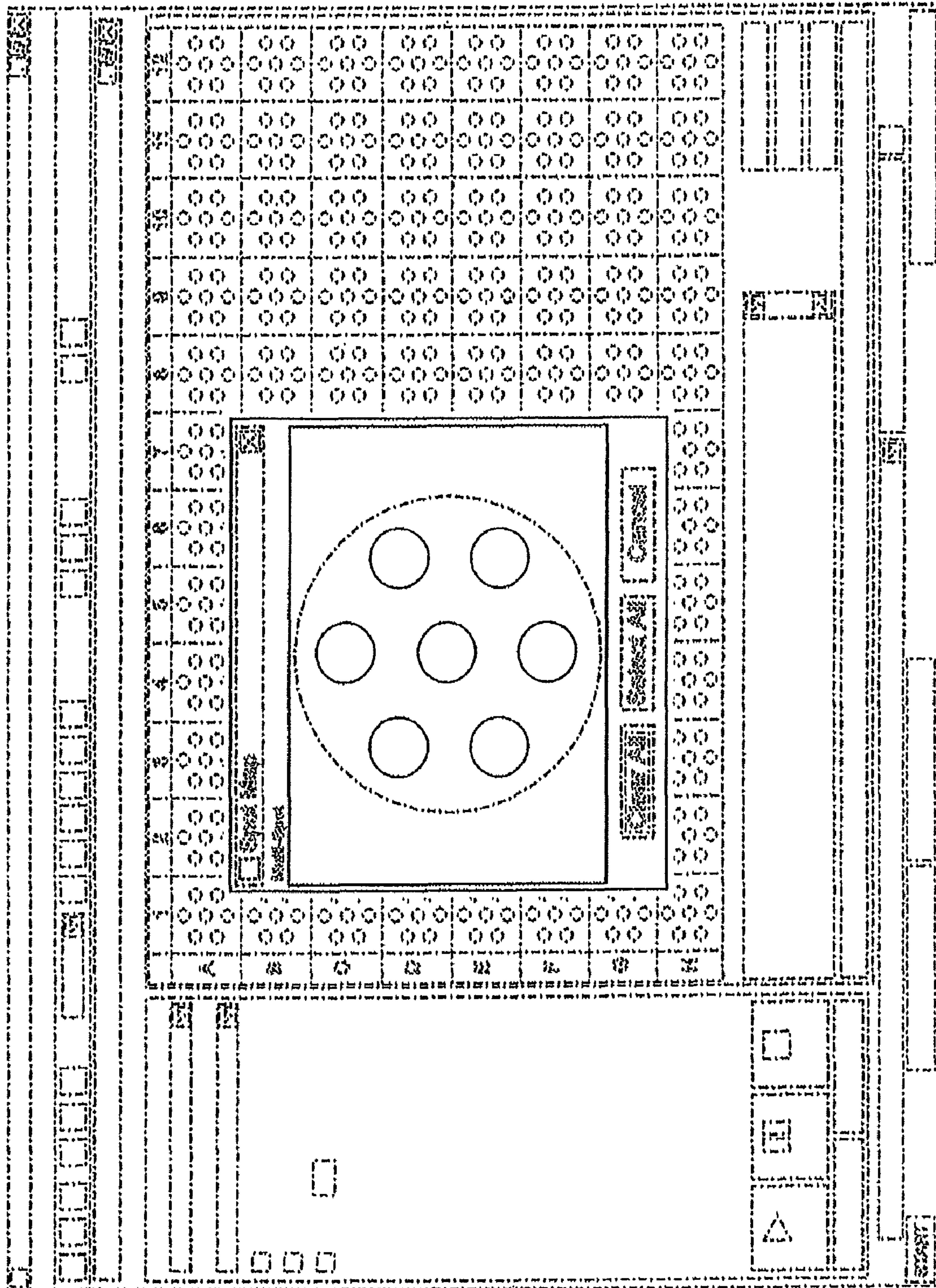
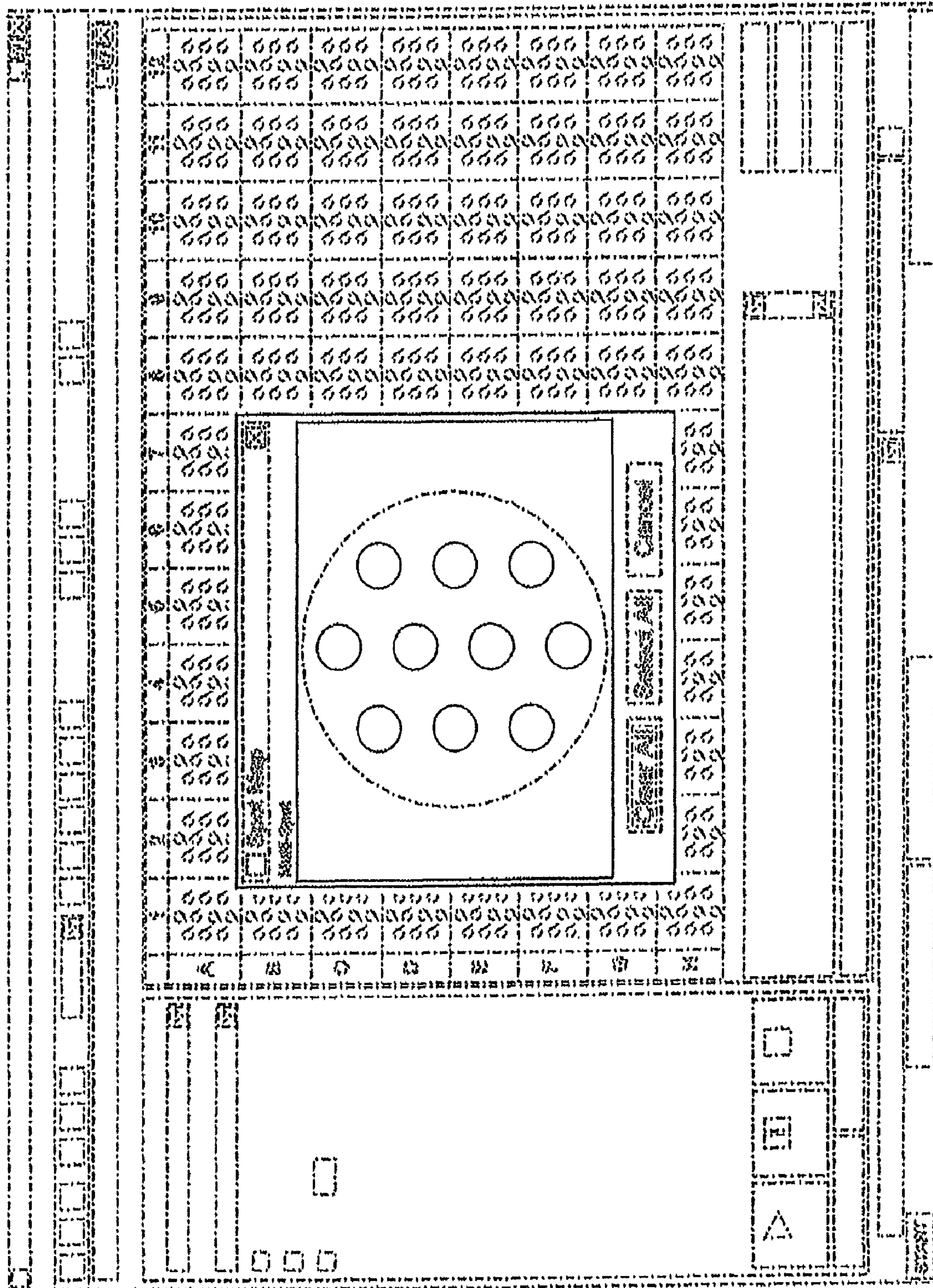

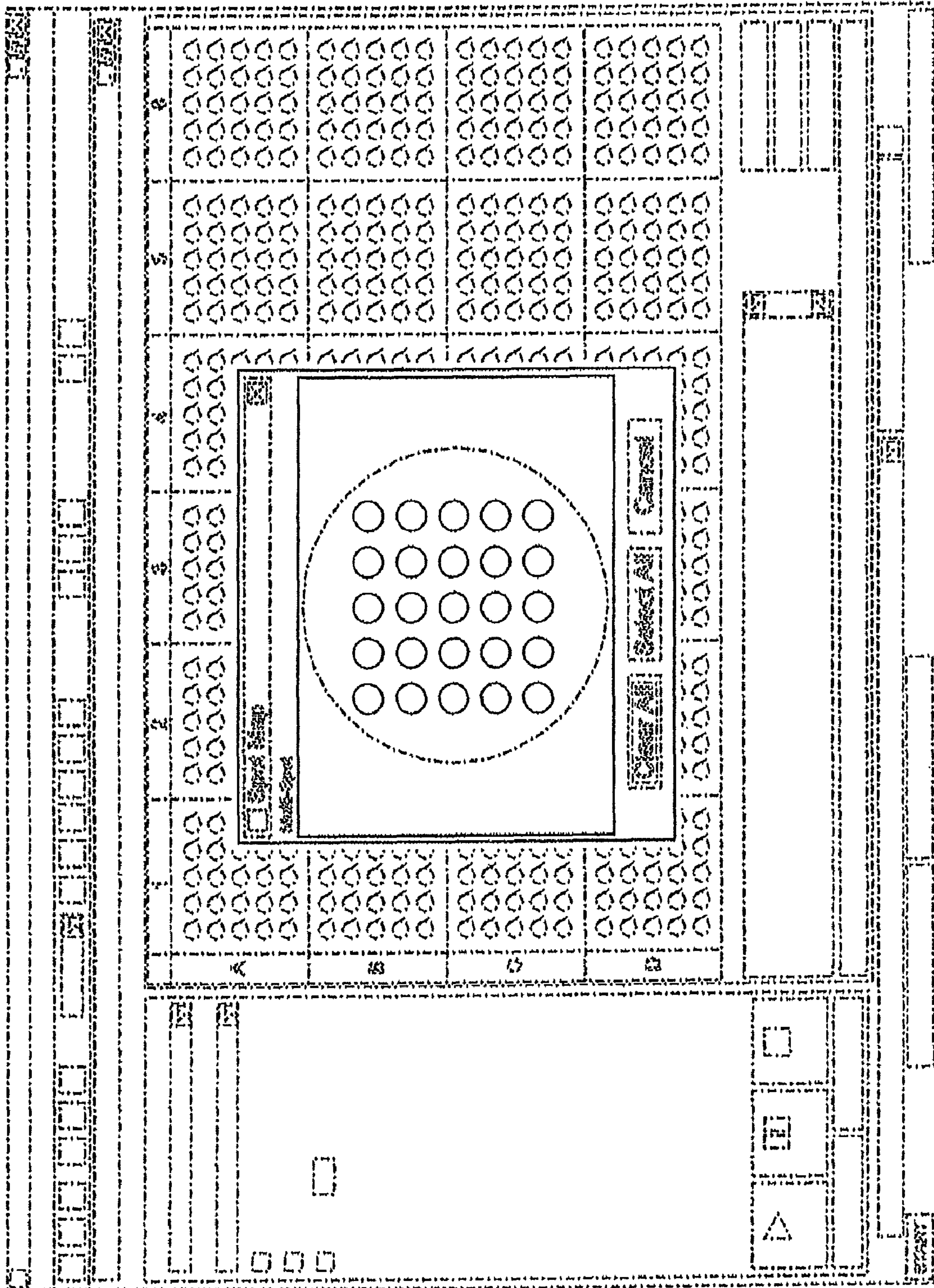

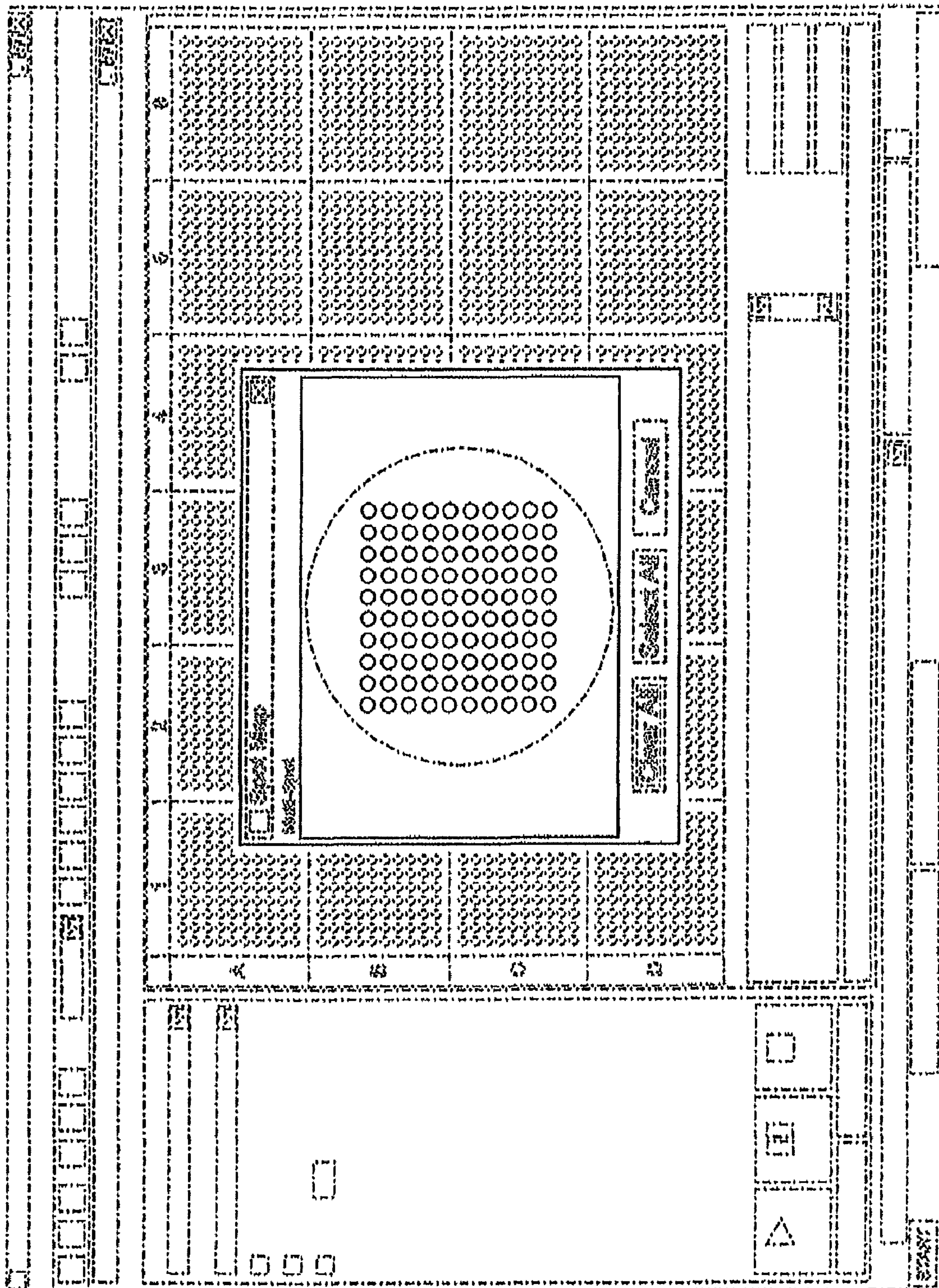
