DESCRIPTION

FIG. 1 is a perspective view of a continuous feed printer in accordance with the present invention;

FIG. 4 is a rear view thereof;

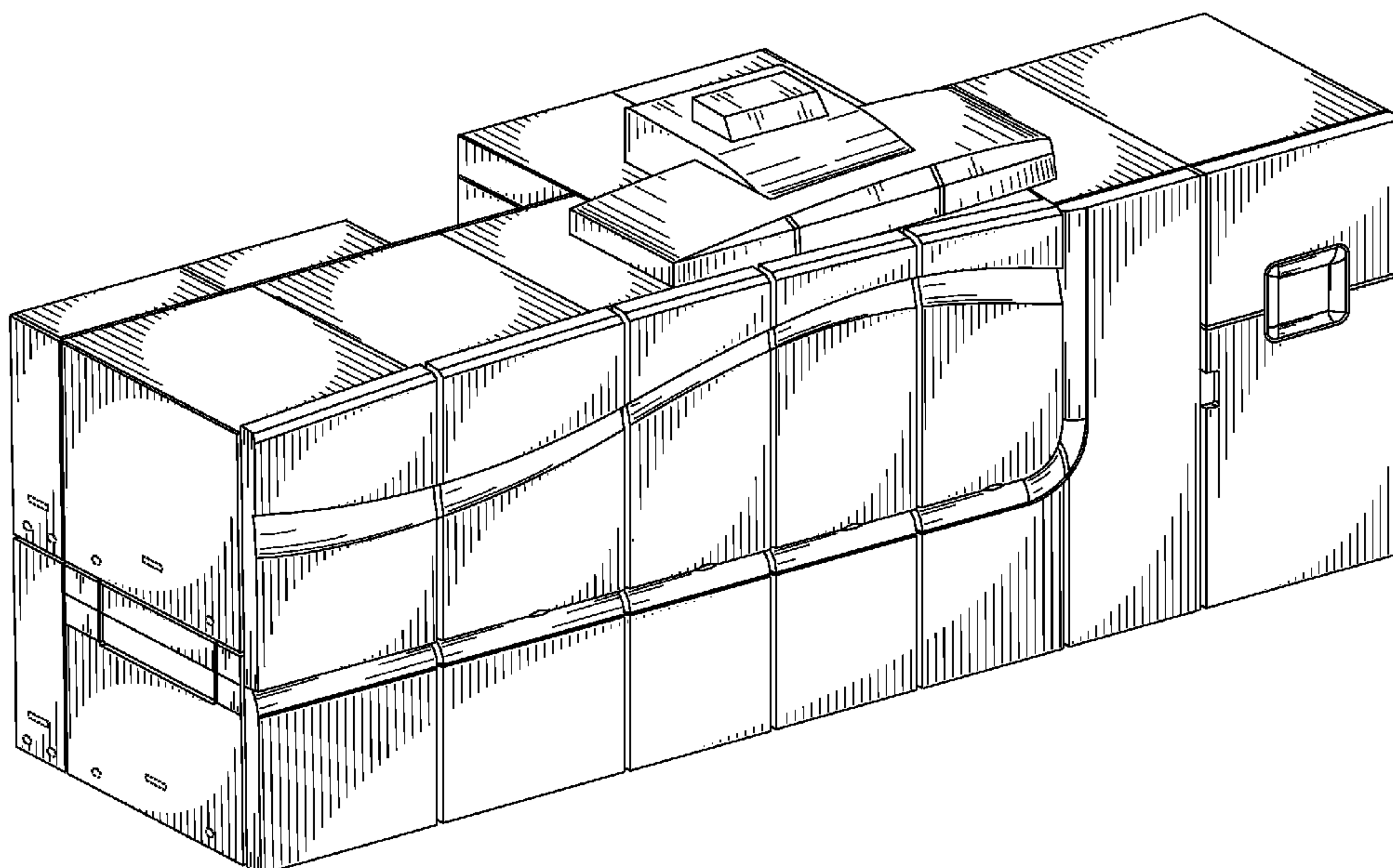
FIG. 5 is a left side view thereof;

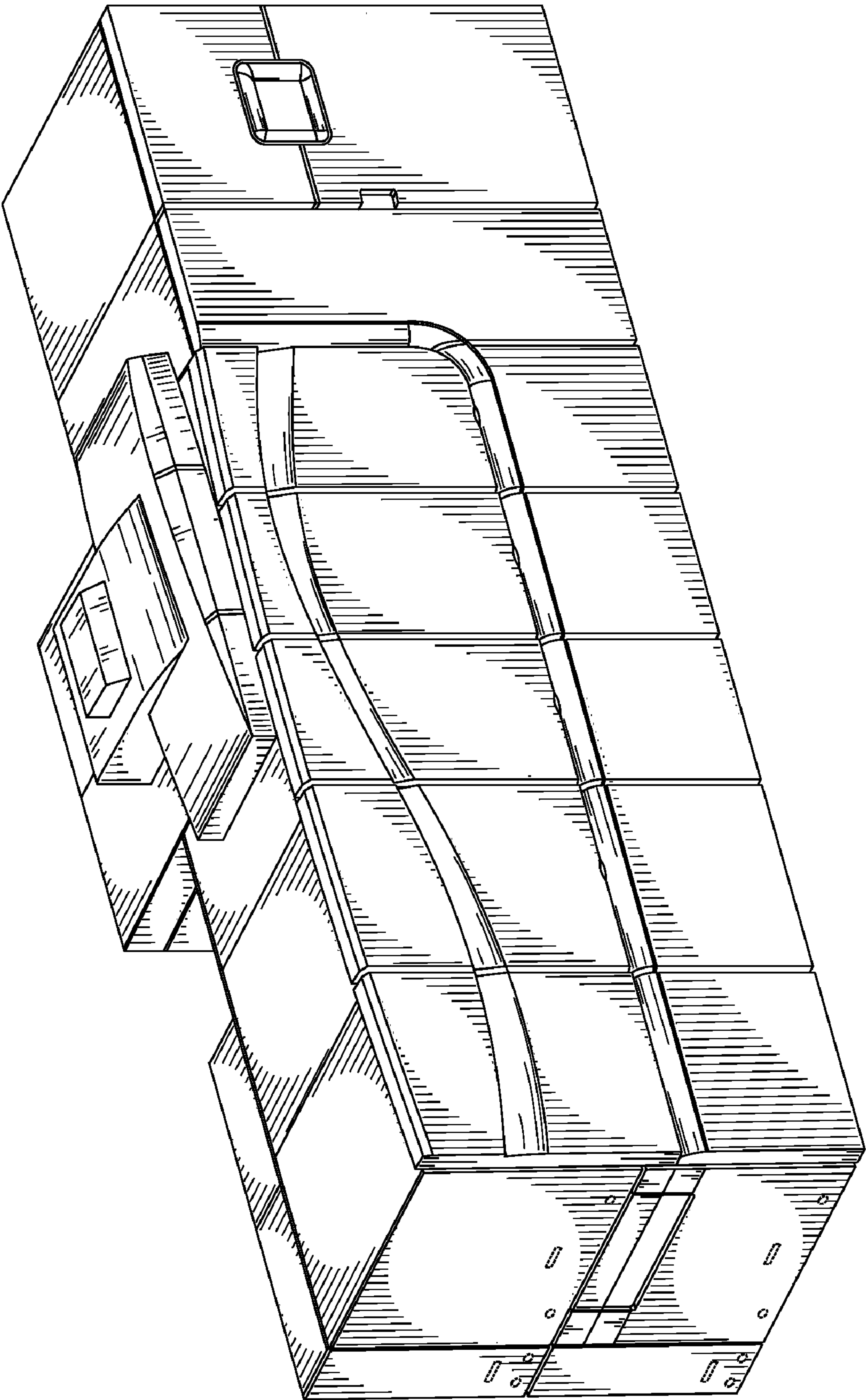

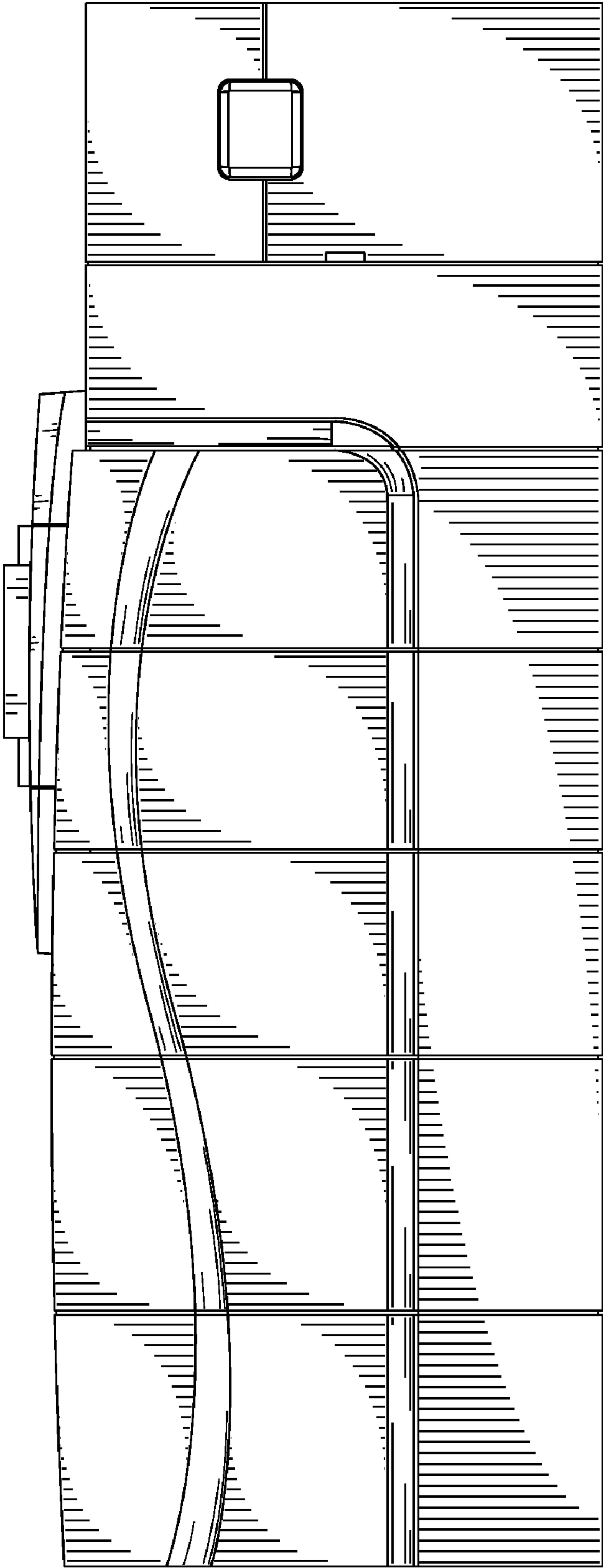

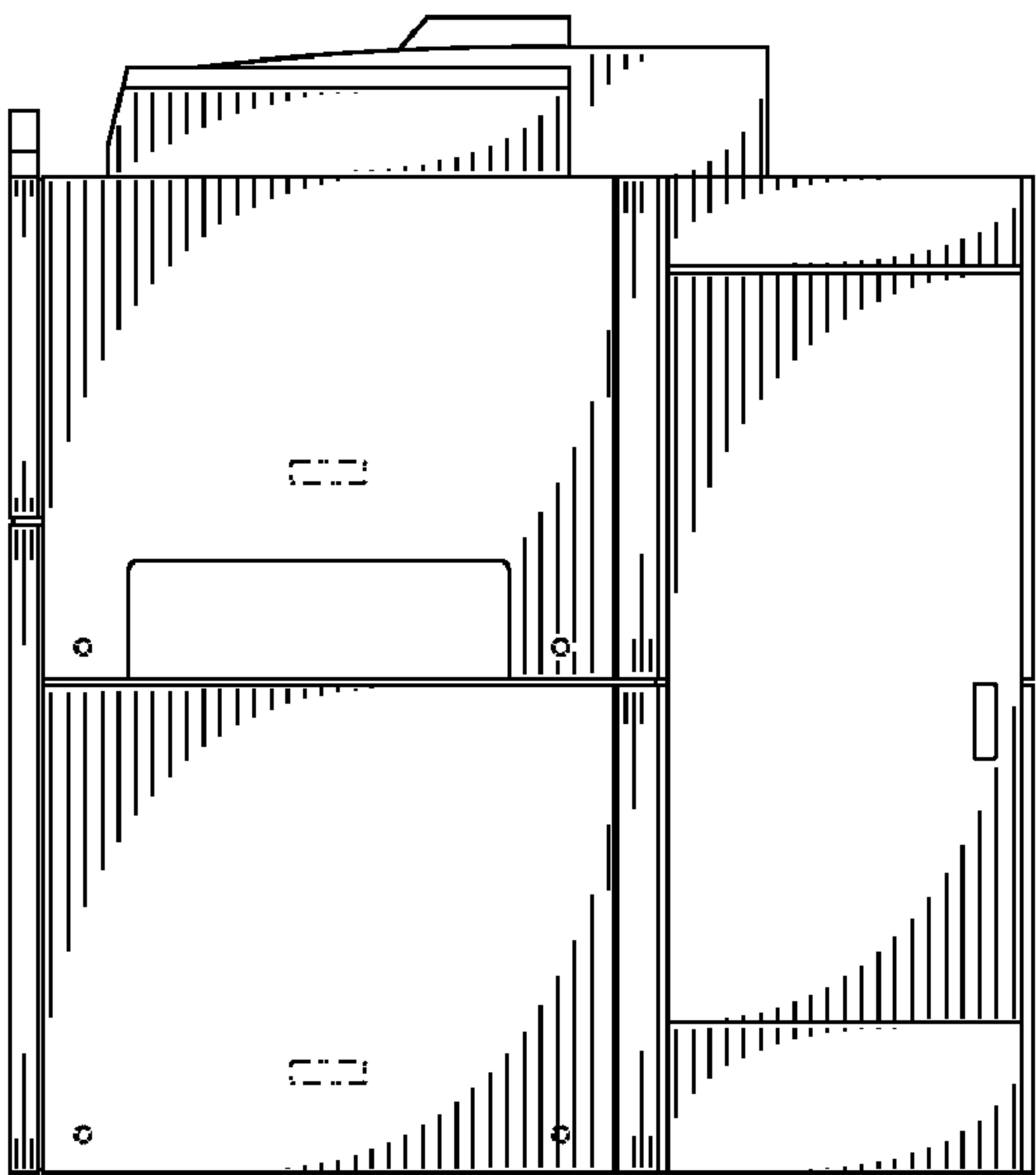

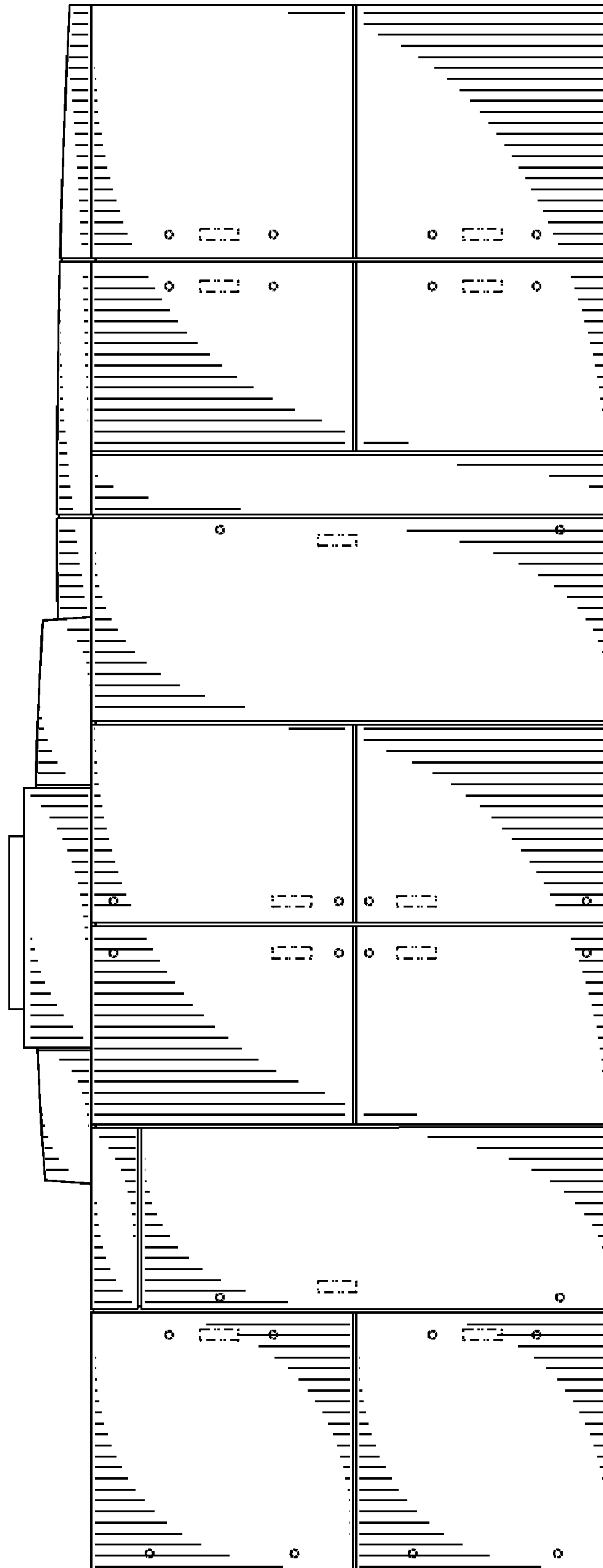

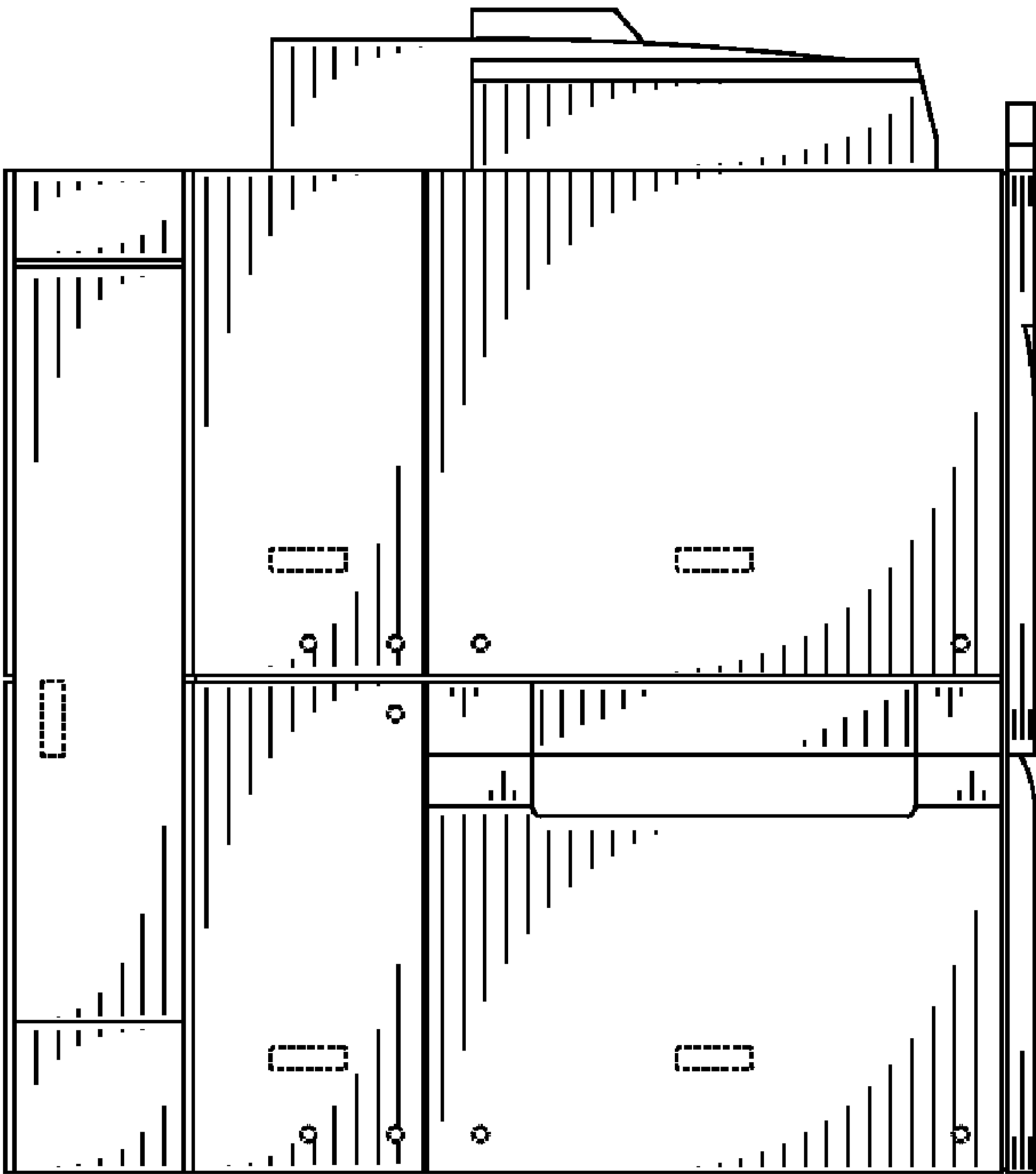

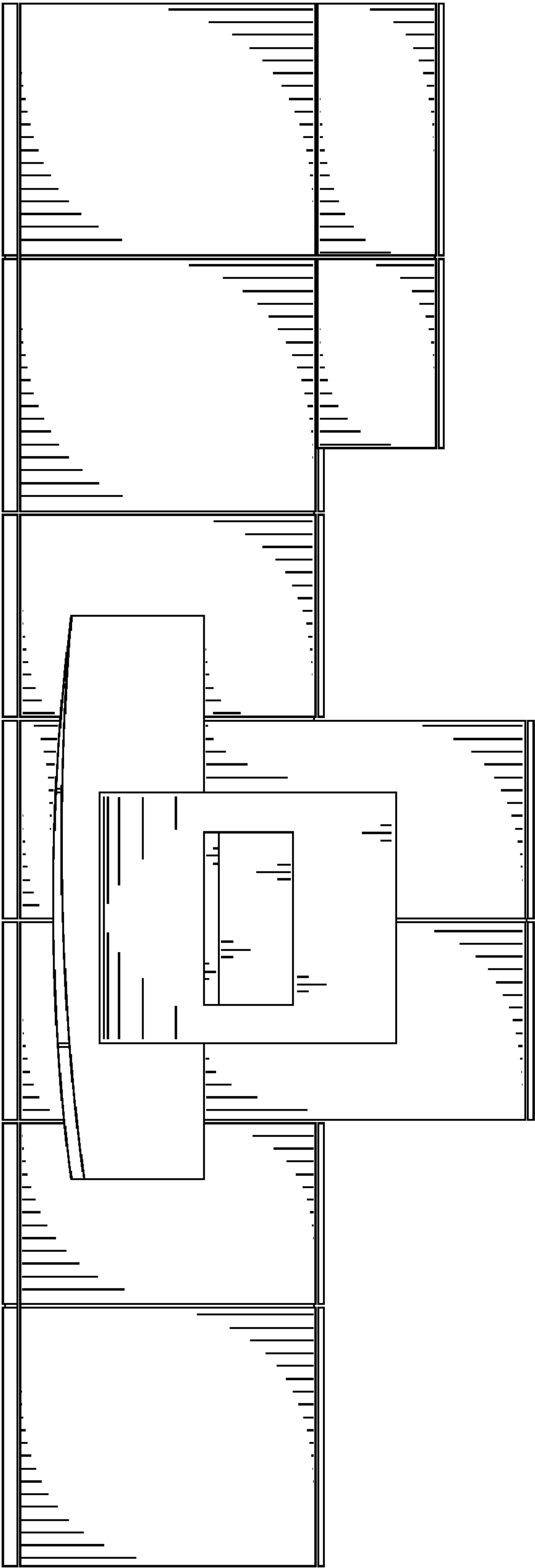

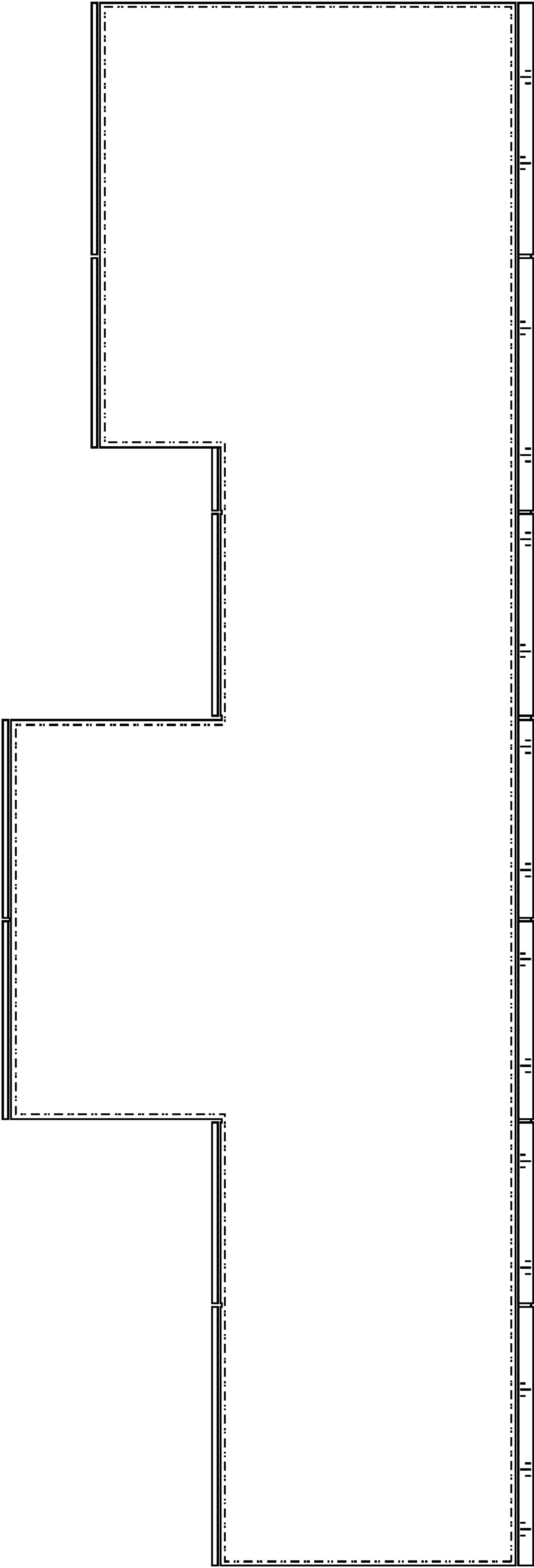
