(57) **CLAIM**

The ornamental design for an electronic computer stand, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and bottom perspective view of an electronic computer stand showing our new design;
FIG. 2 is a rear, left and top perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof.
FIG. 7 is a left side view thereof;
FIG. 8 is a right side view thereof;
FIG. 9 is a perspective view thereof in a state that an open-and-close portion is opened; and,
FIG. 10 is a perspective view thereof showing a state that an electronic computer is put on.

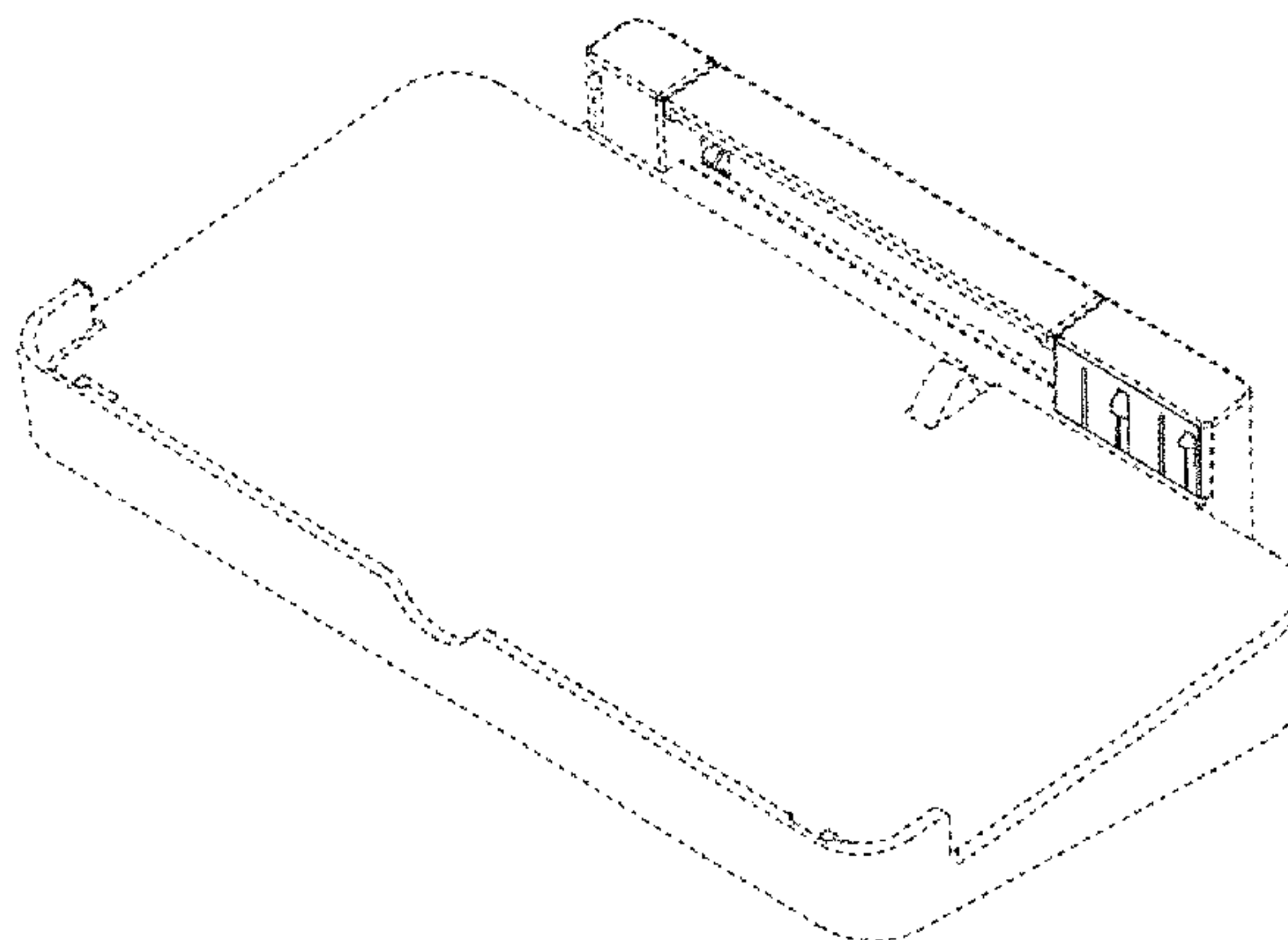

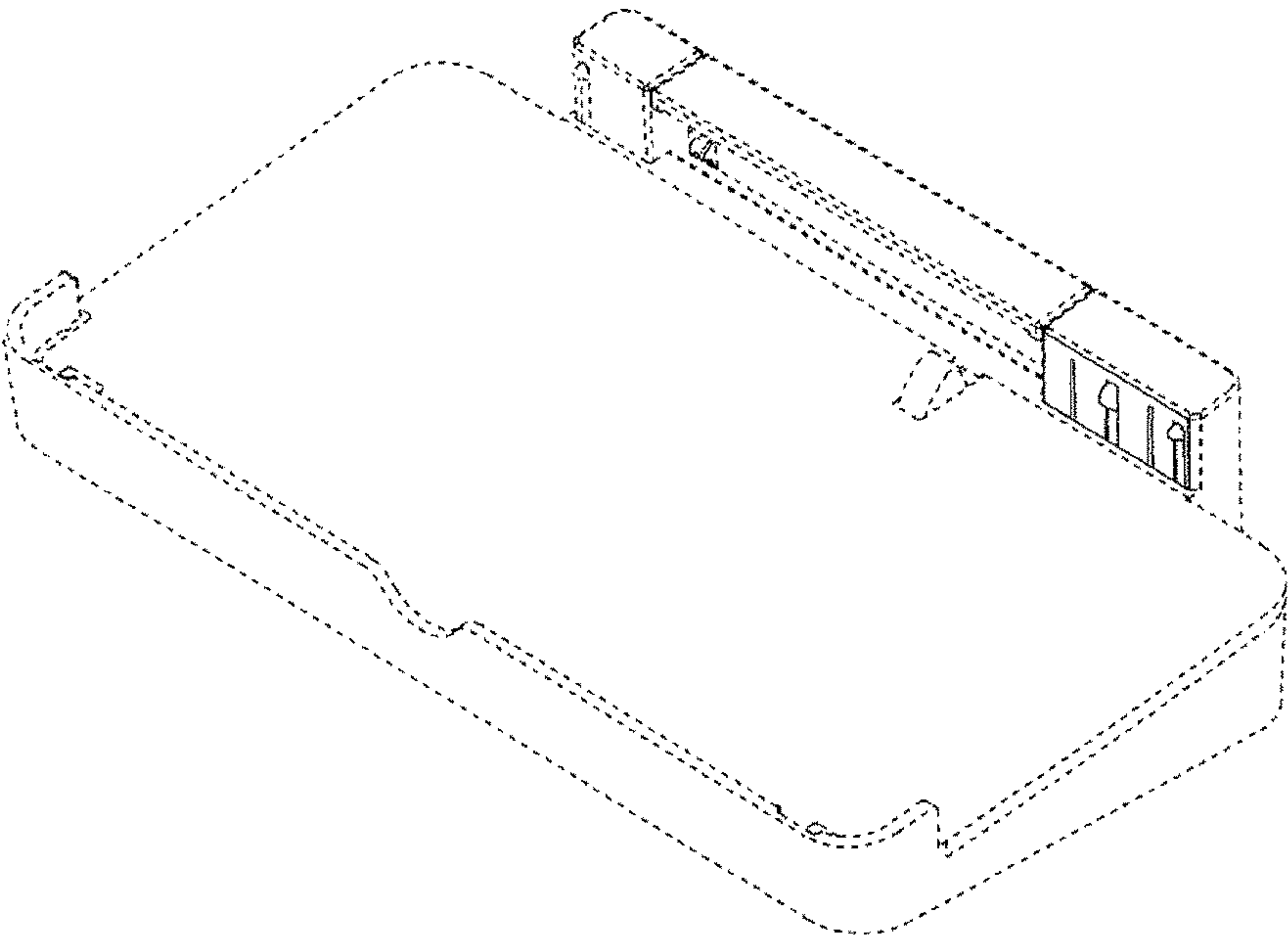

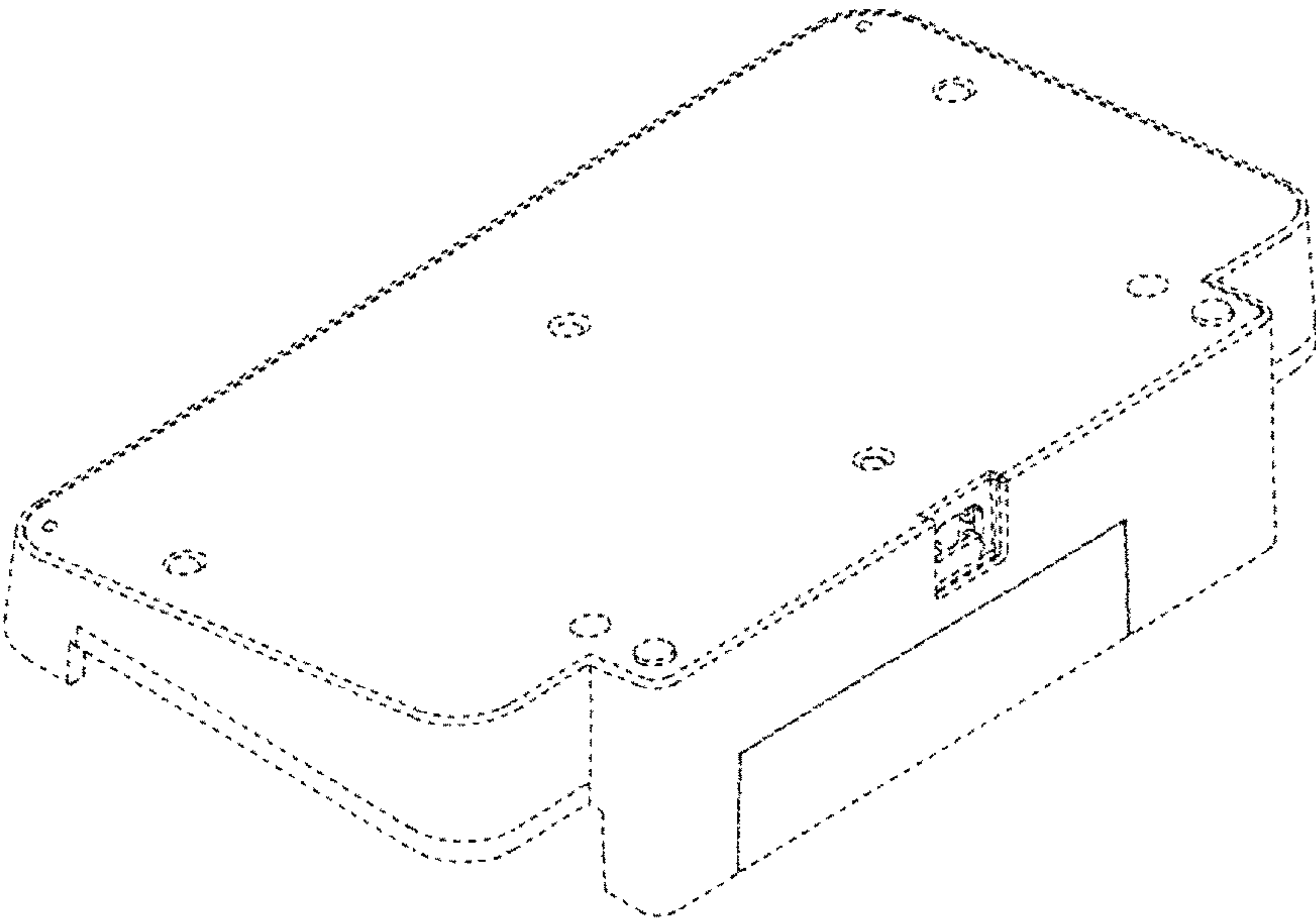

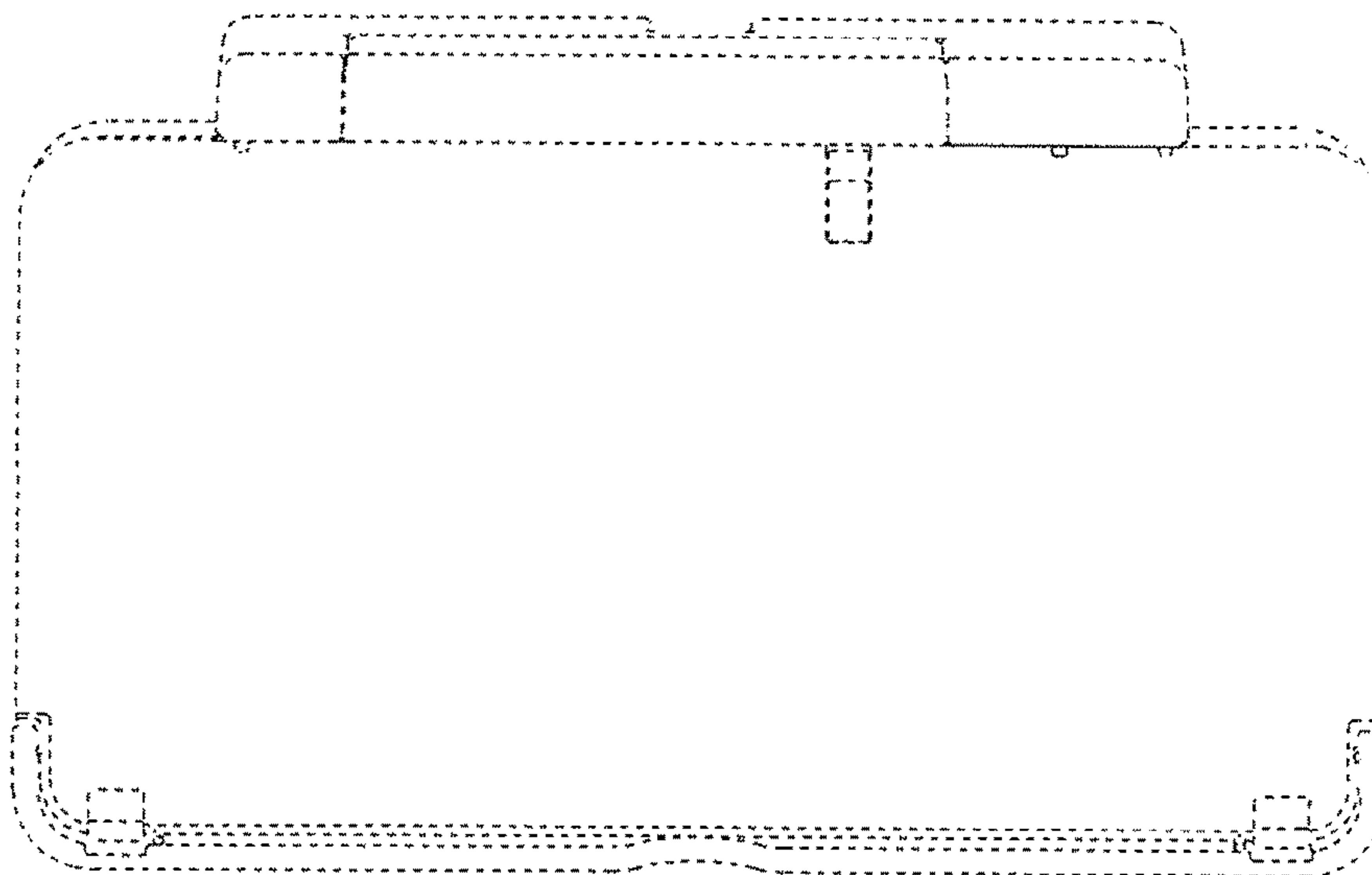

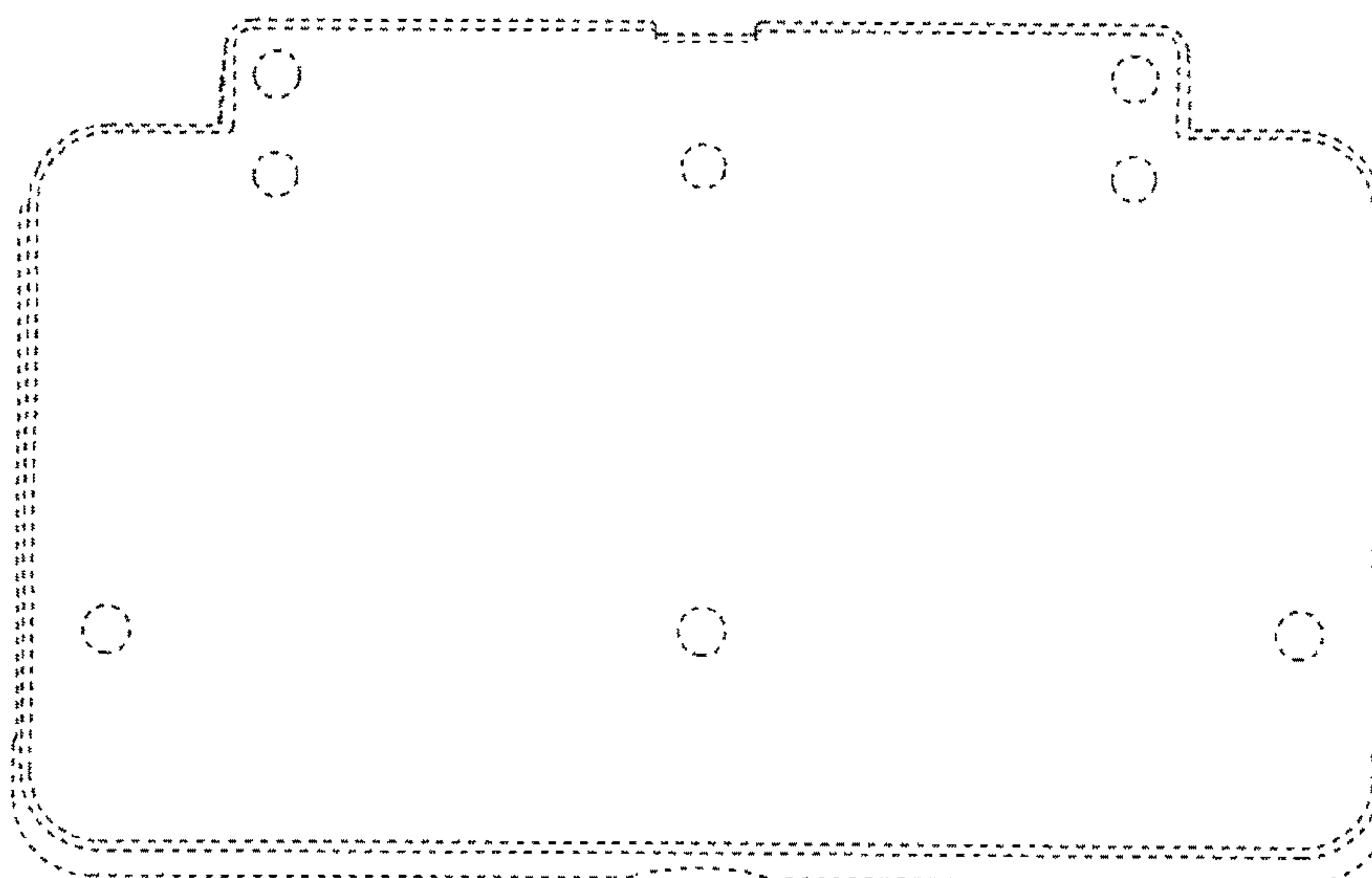

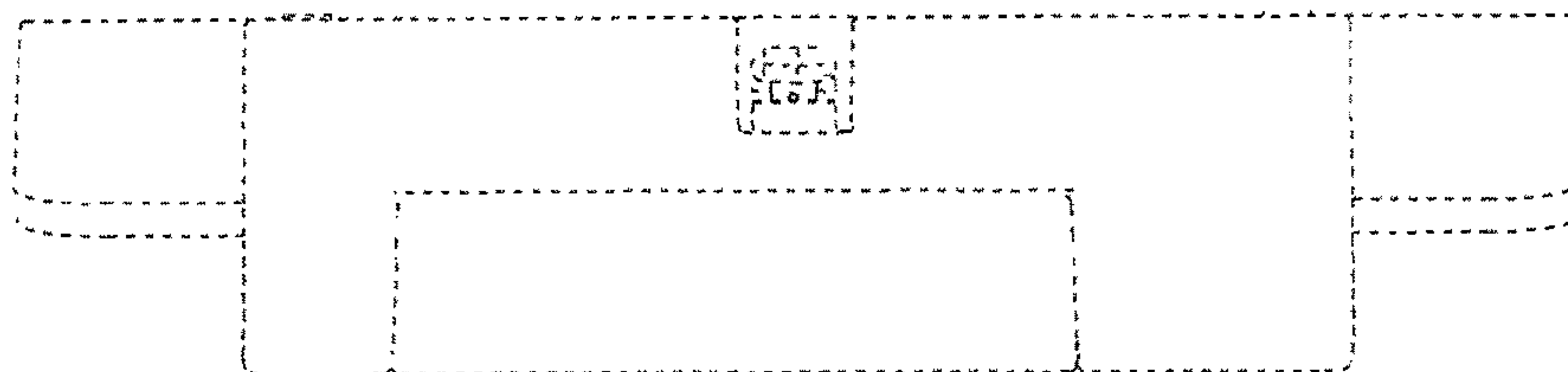

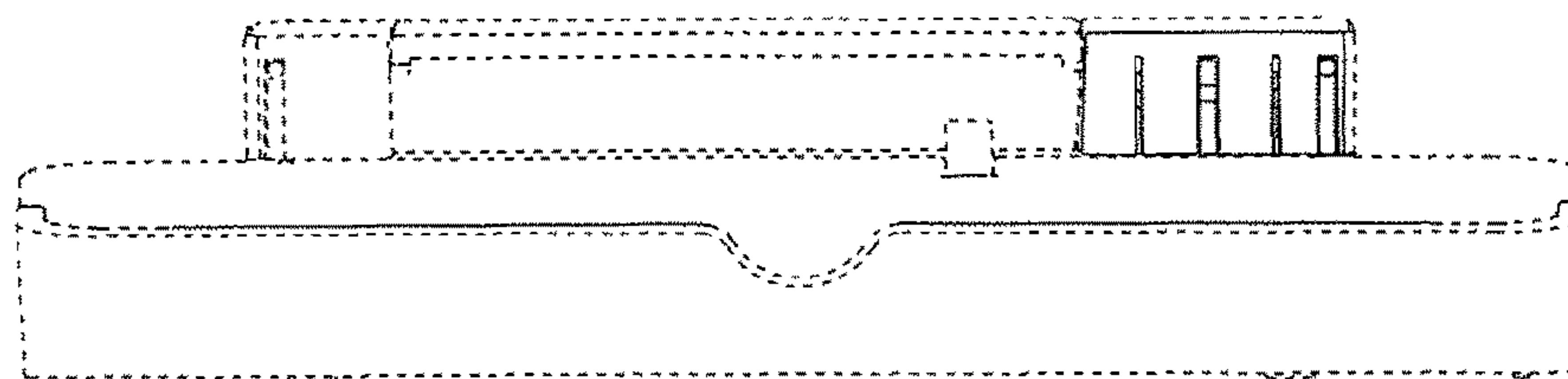

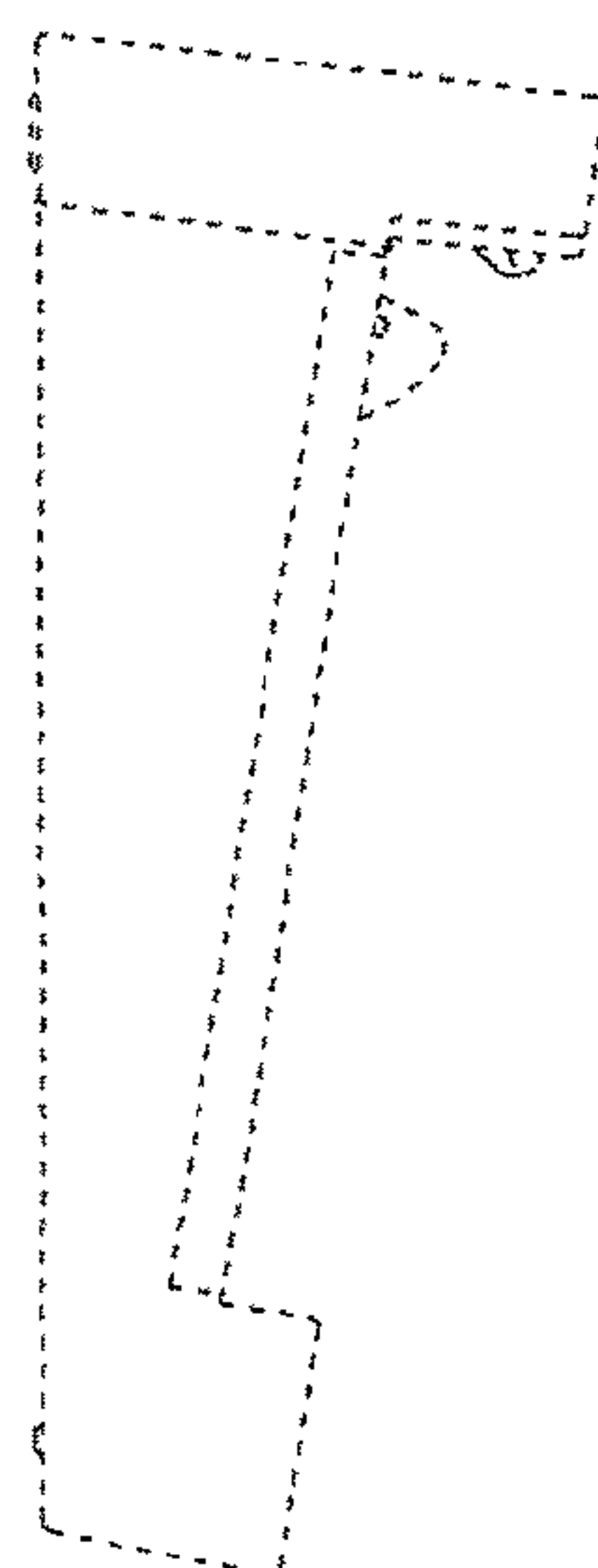

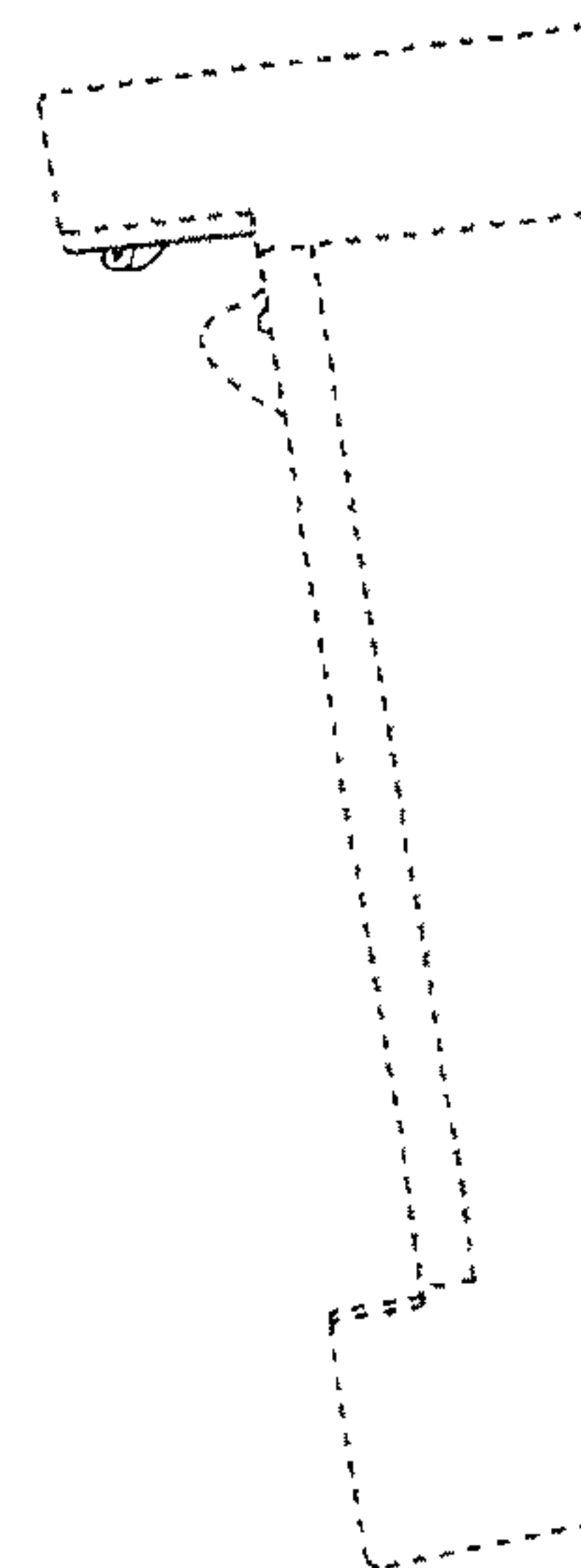

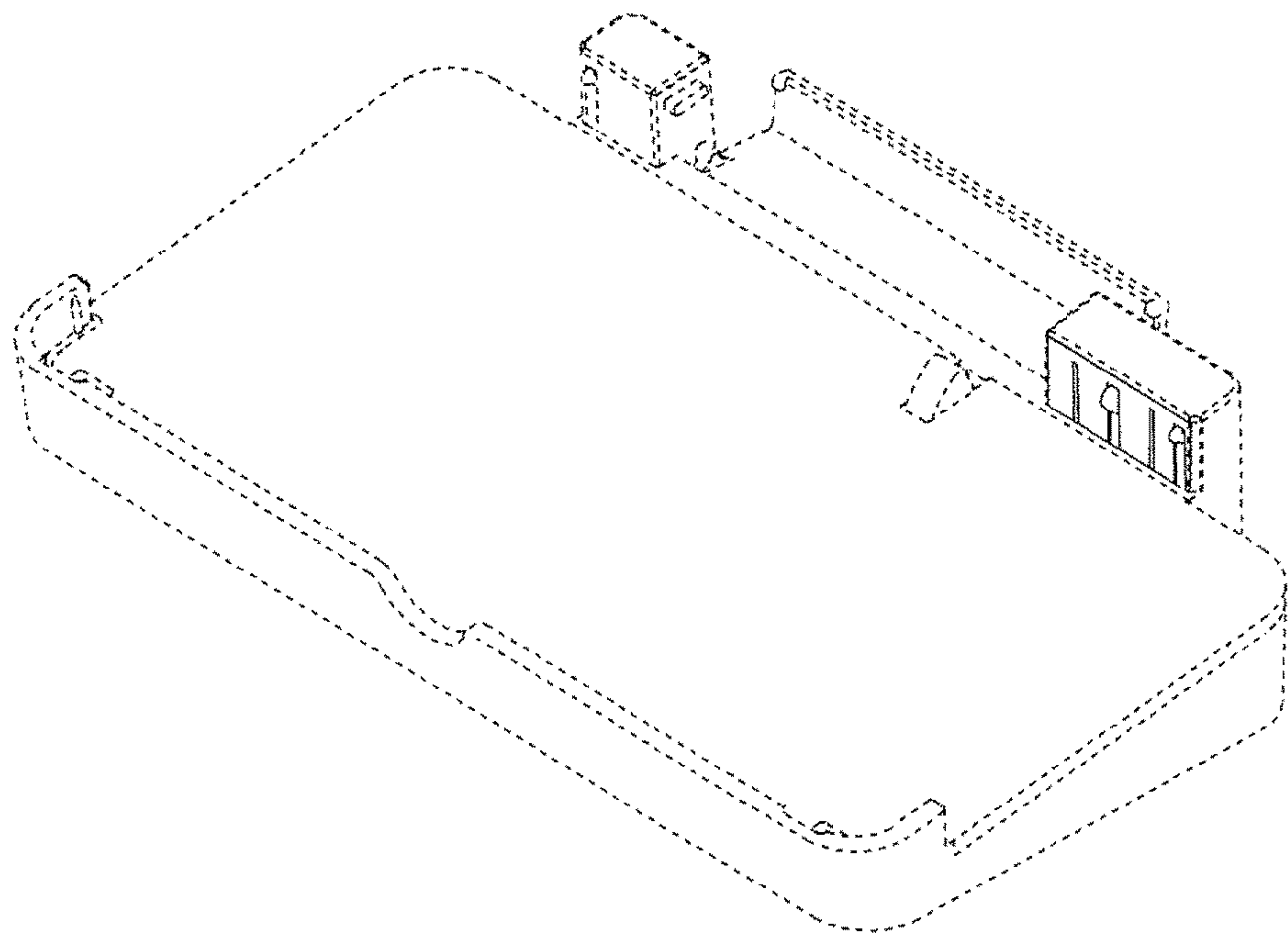
