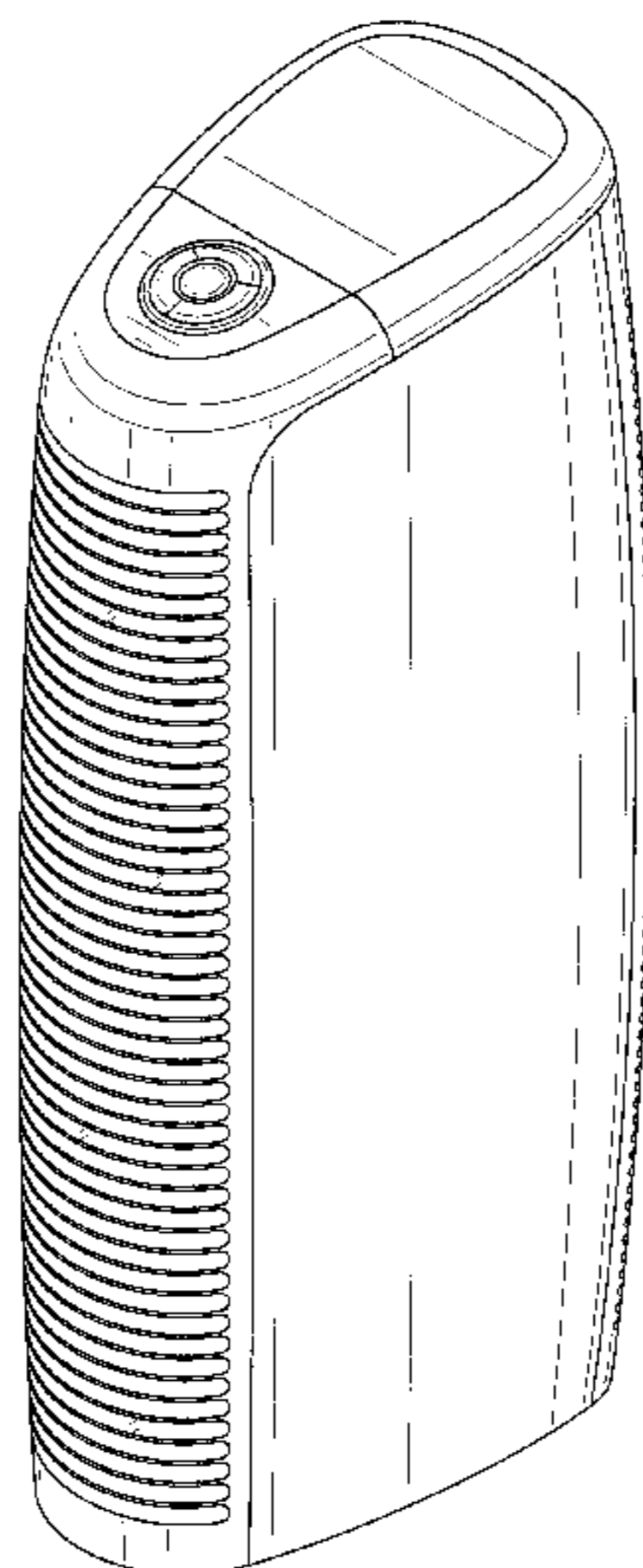
(57) **CLAIM**

The ornamental design for an air cleaner, as shown and

DESCRIPTION

FIG. 1 is a frontal perspective view of the air cleaner.
FIG. 2 is a rear perspective view thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a right side elevation view thereof.
FIG. 6 is a left side elevation view thereof.
FIG. 7 is a top plan view thereof, wherein the air cleaner is
shown in FIG. 7 on a larger scale than in FIGS. 1 through 6;
and,
FIG. 8 is a bottom plan view thereof, wherein the air cleaner
is shown in FIG. 8 in the same scale as FIG. 7 and on a larger

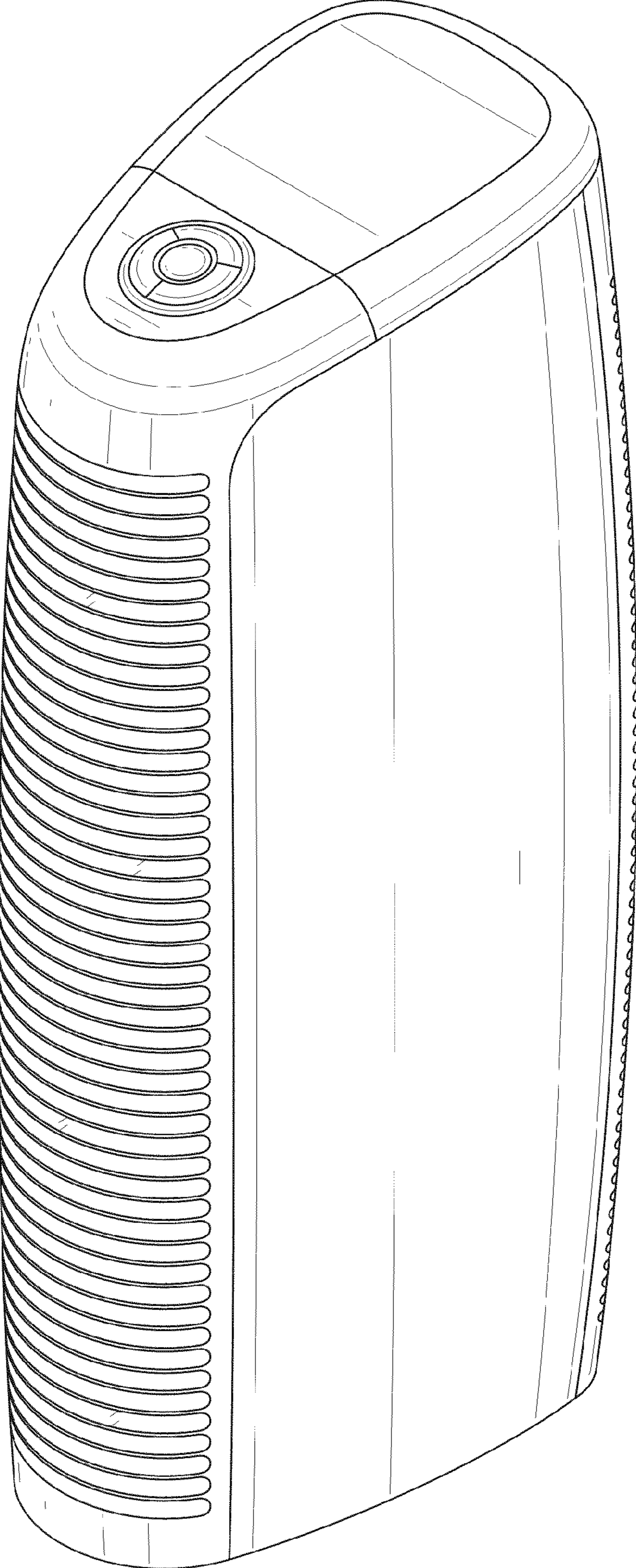

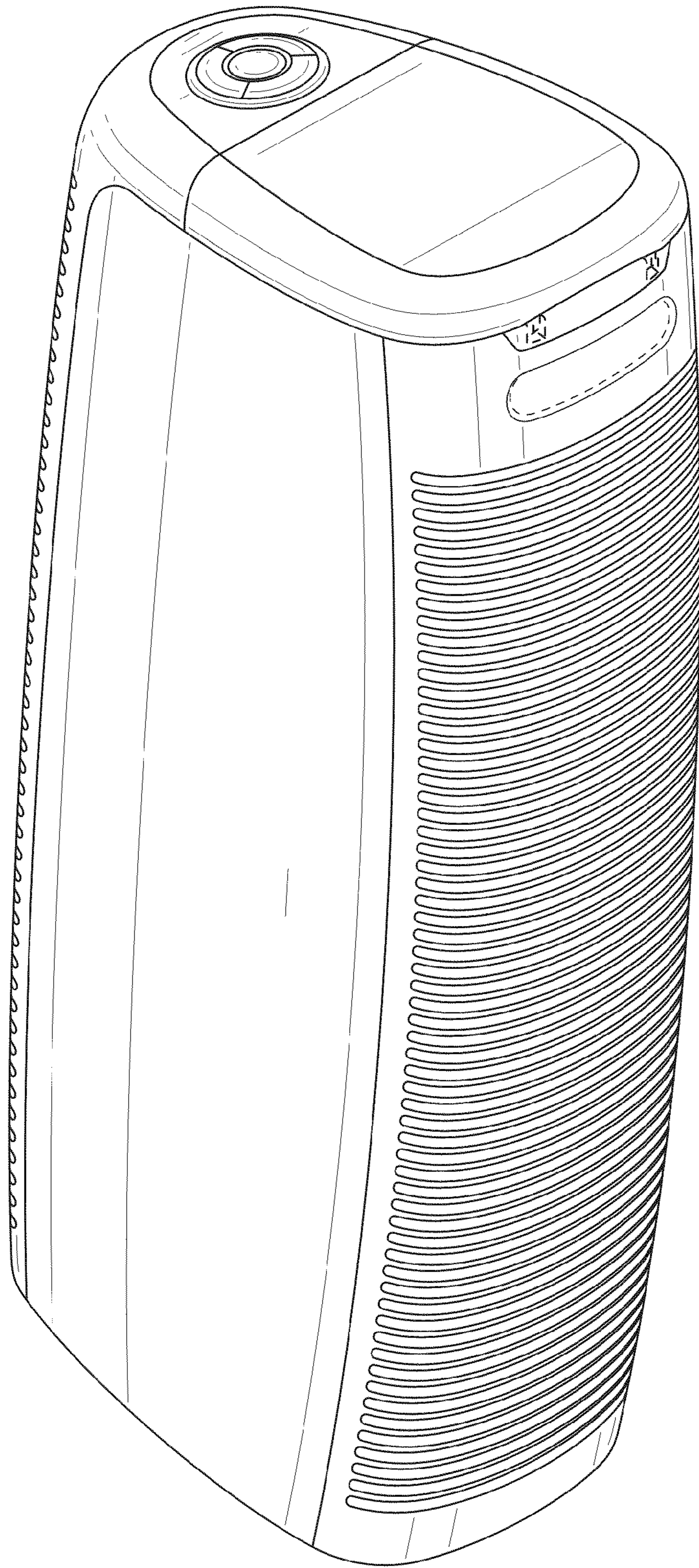

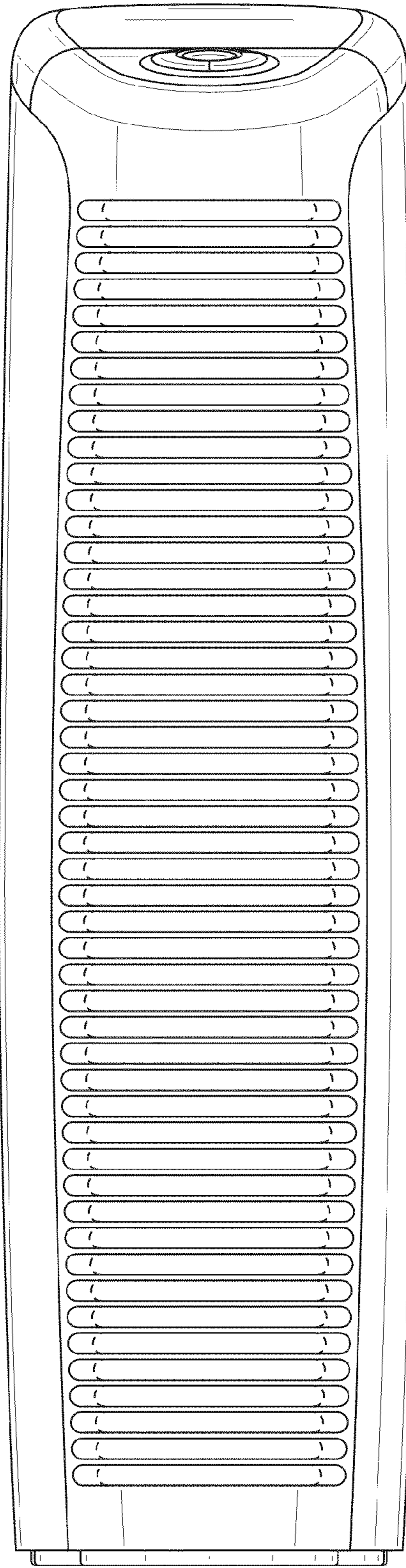

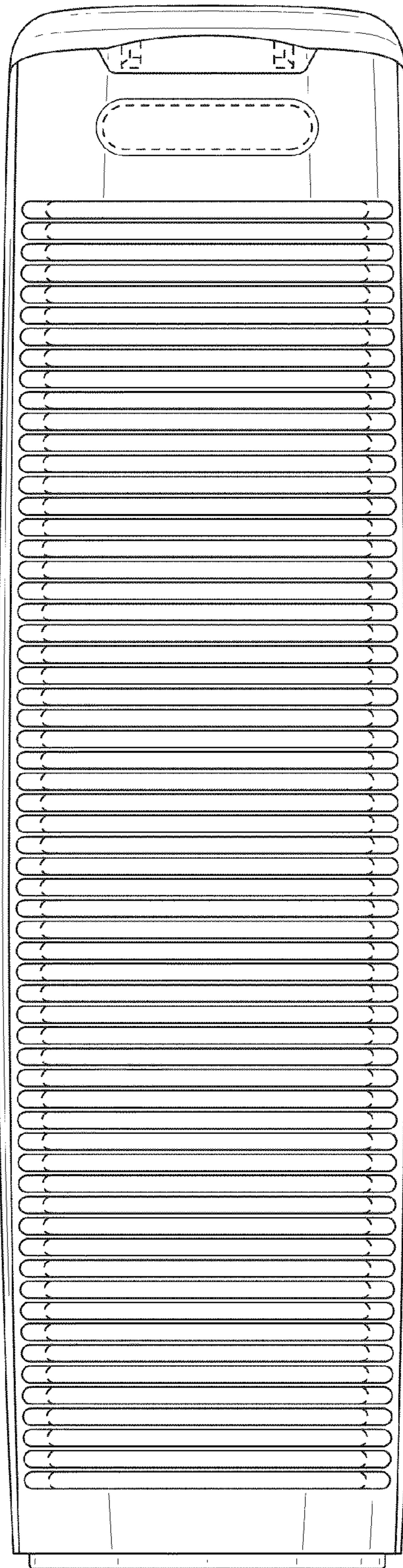

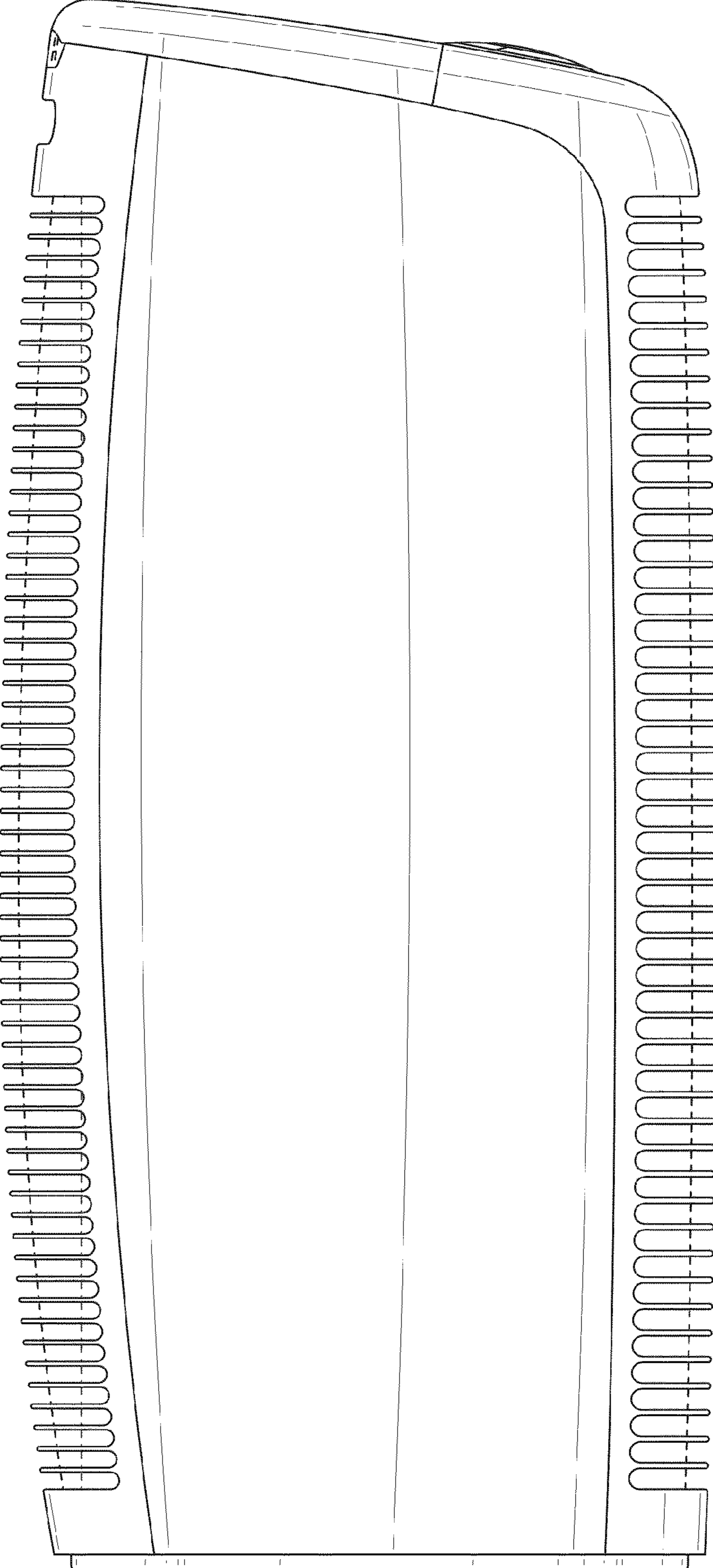

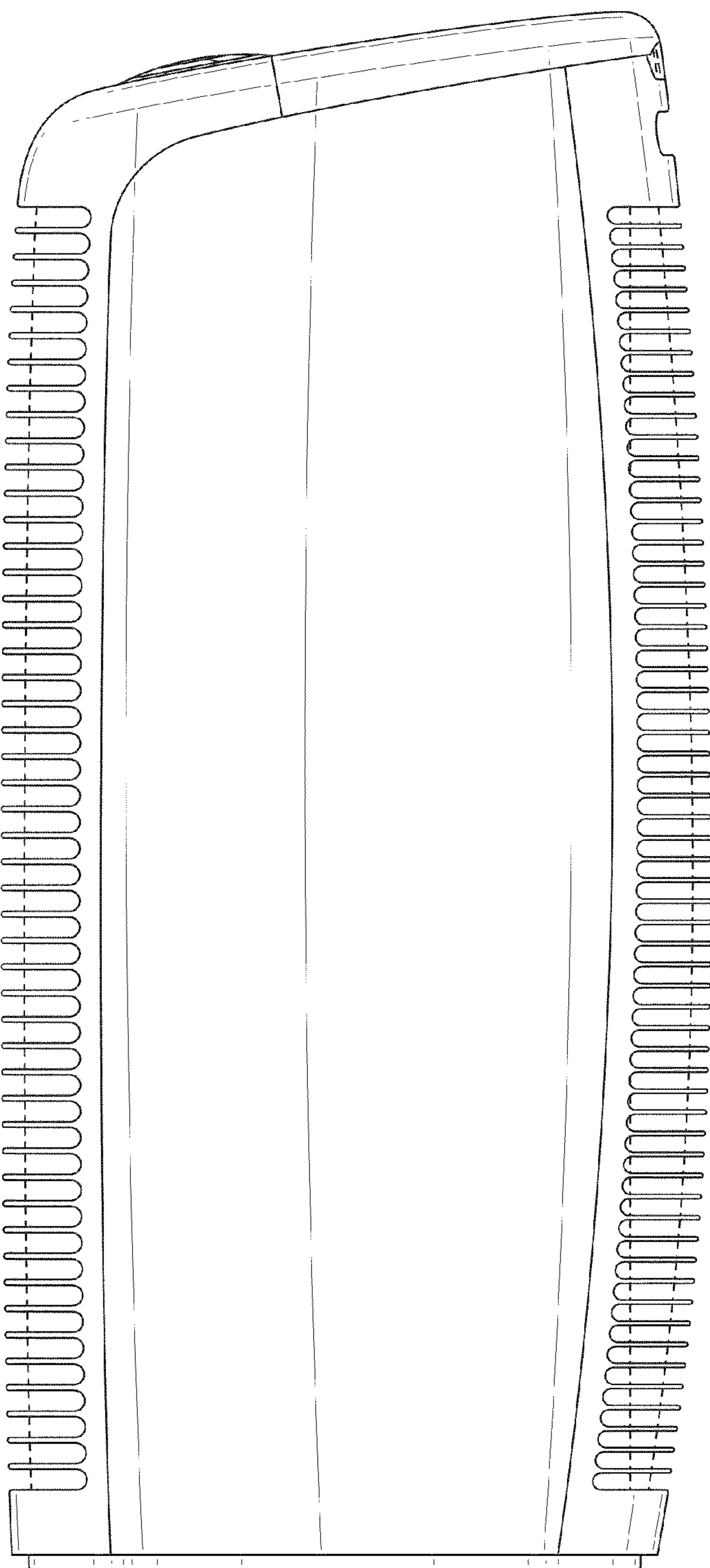

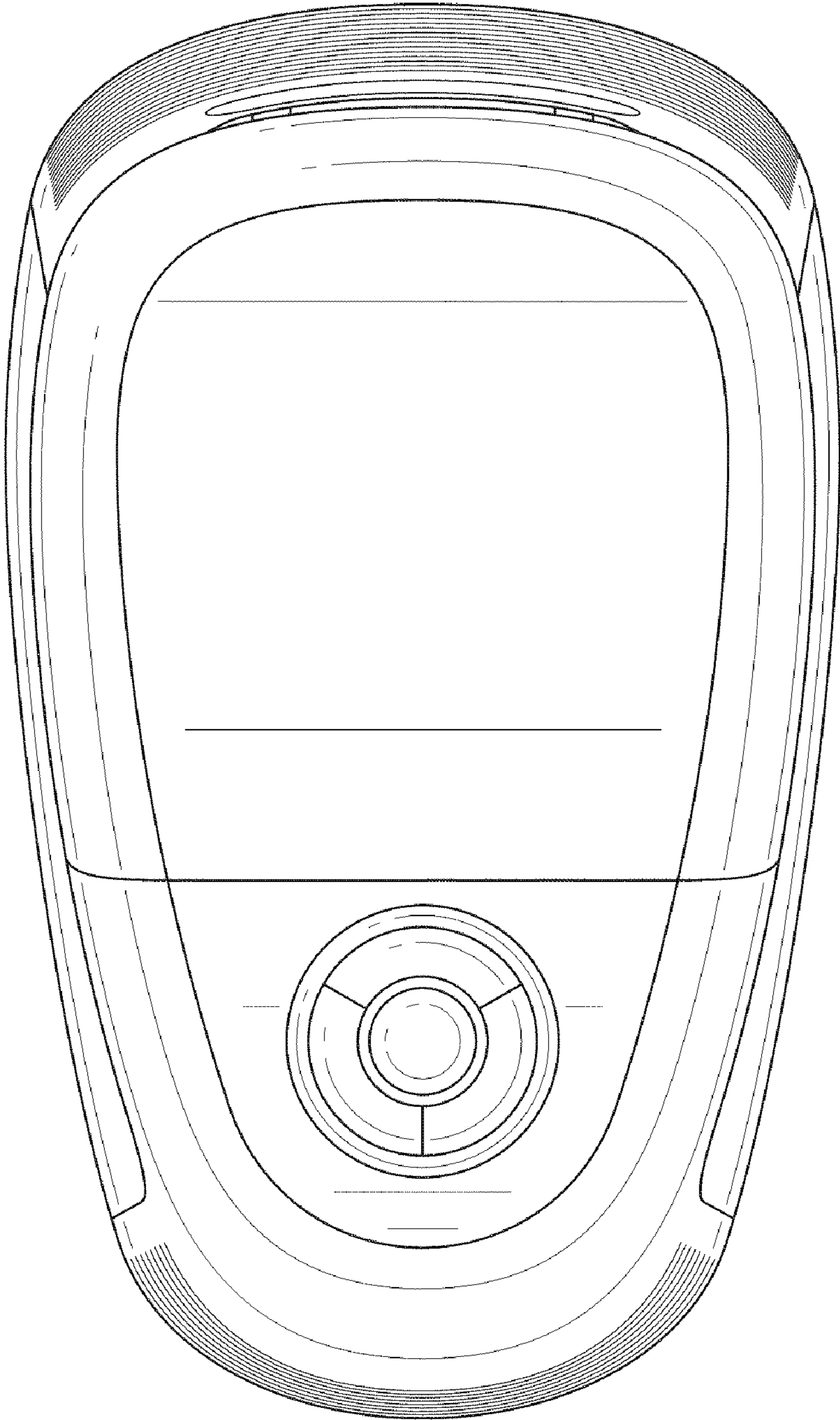

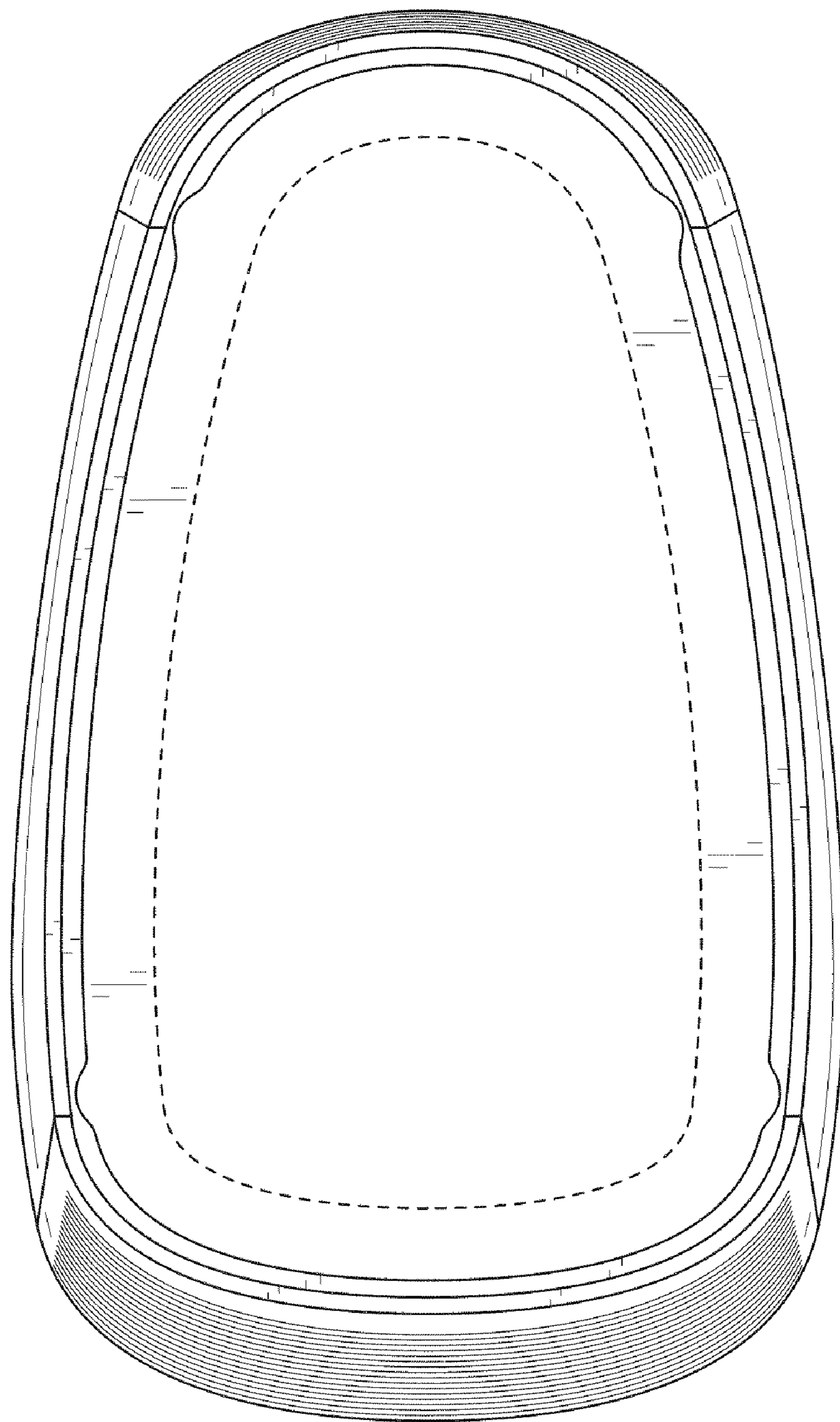
