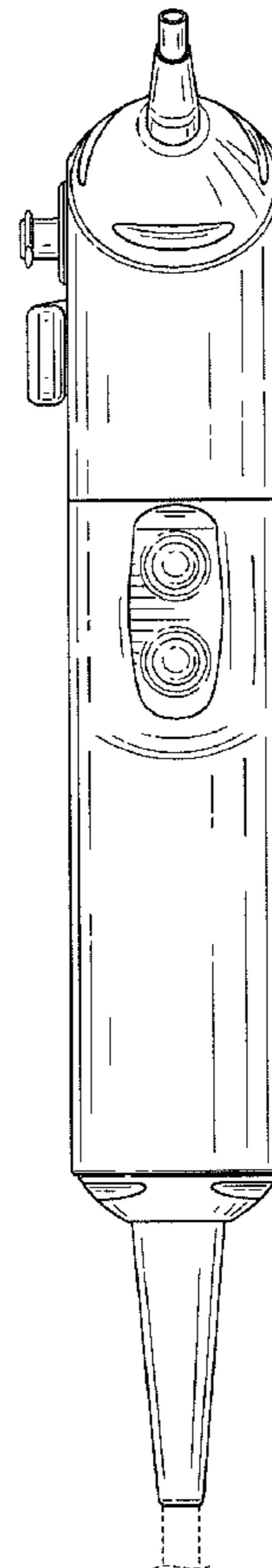
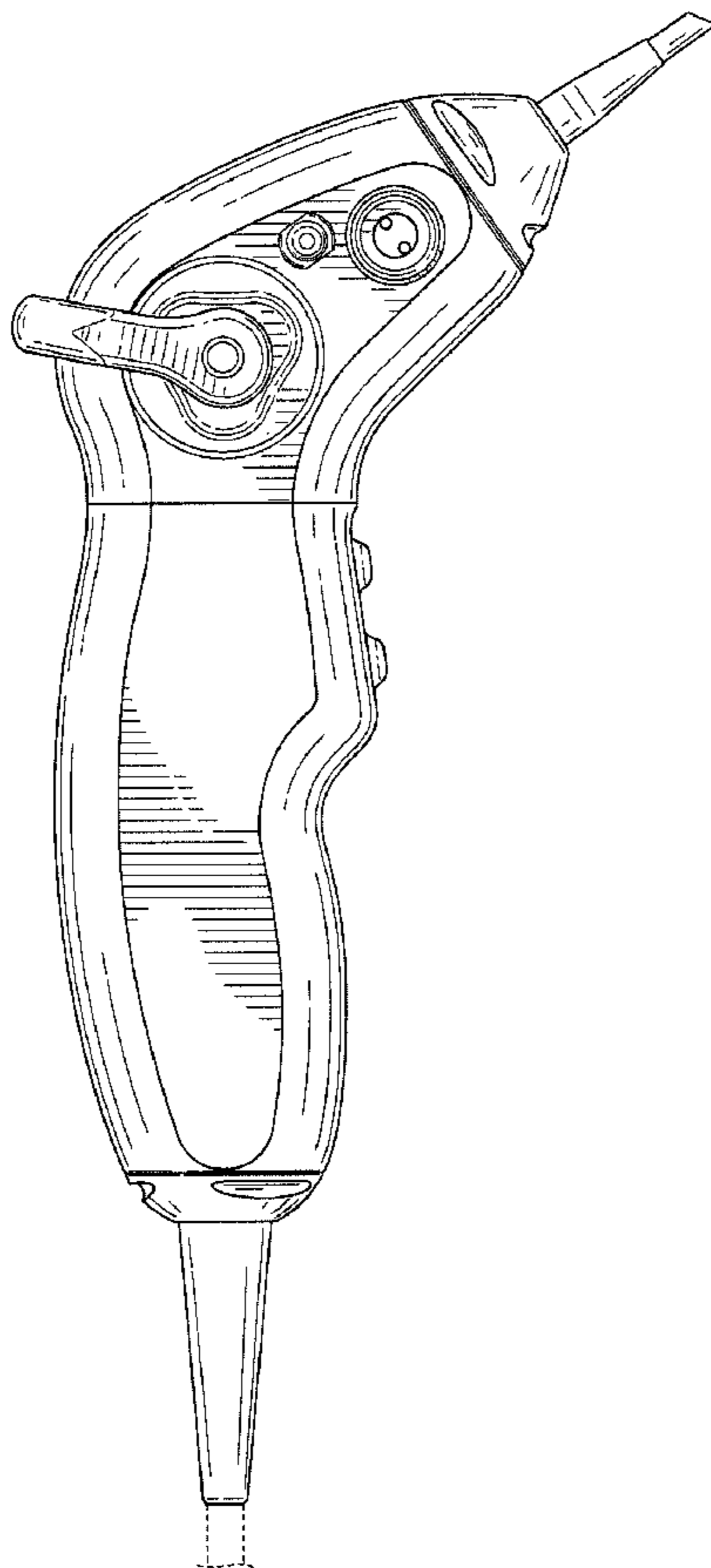
The ornamental design for handle for a deflectable endoscope, as shown and described.

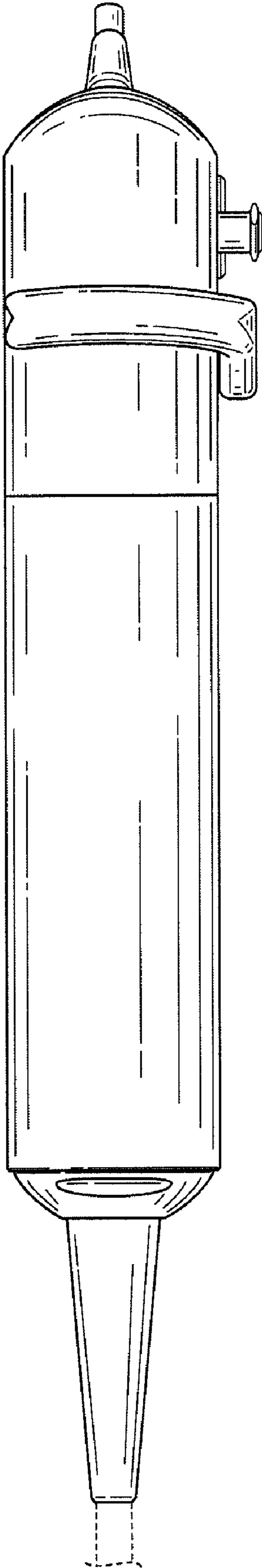
**DESCRIPTION**

FIG. 7 is a front, right perspective view thereof.

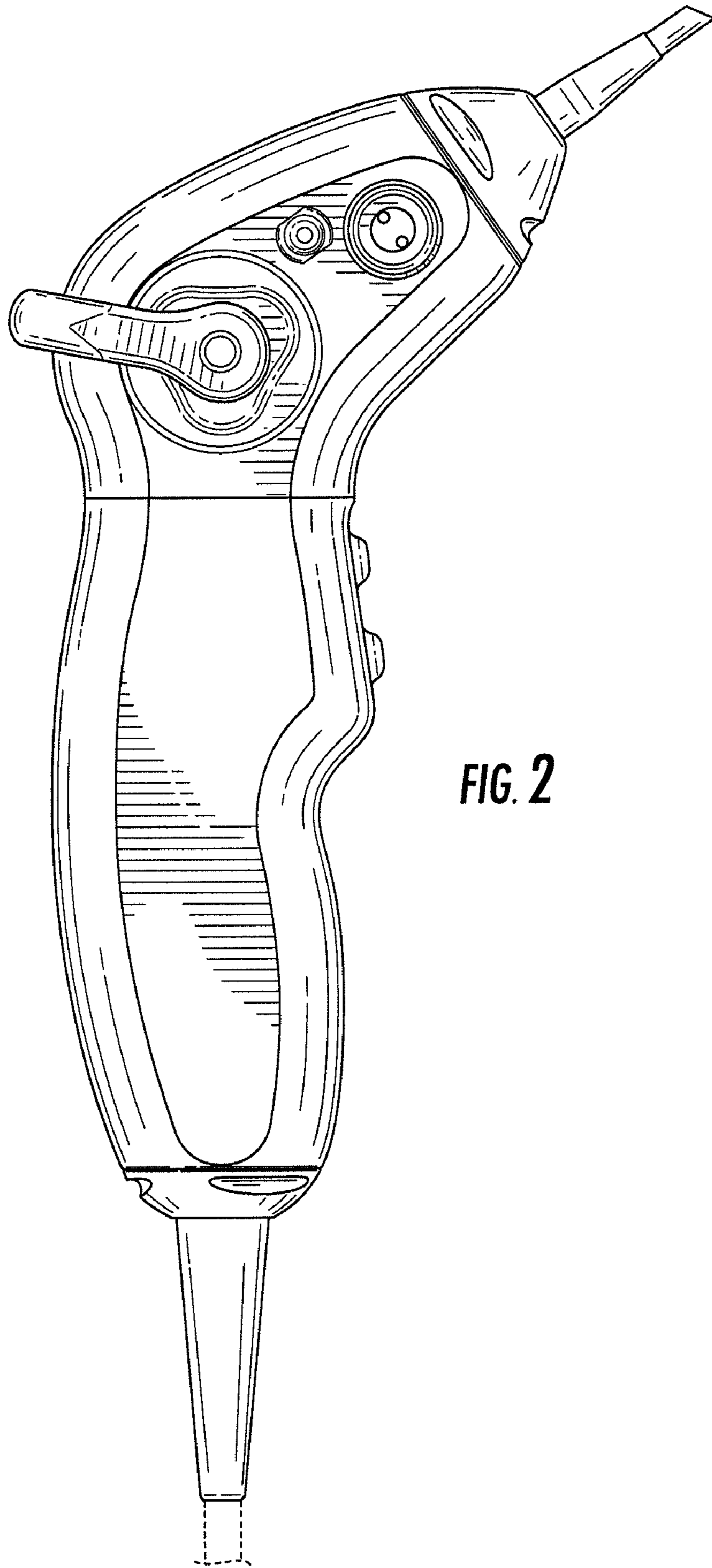

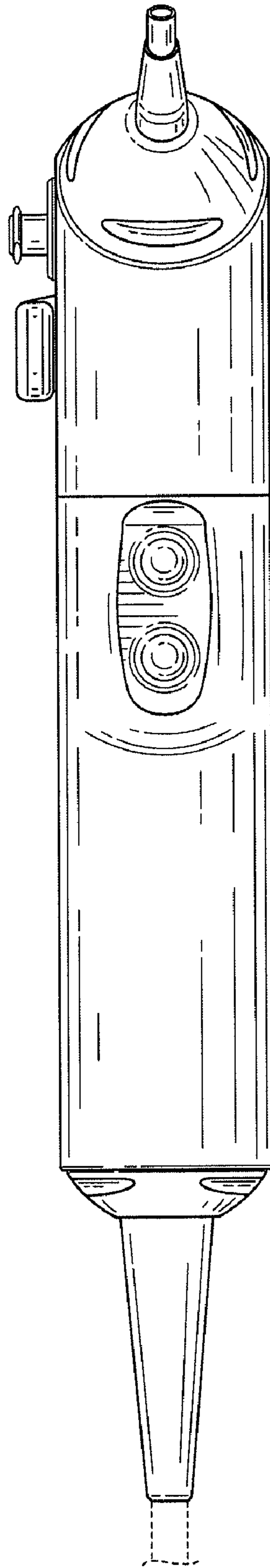

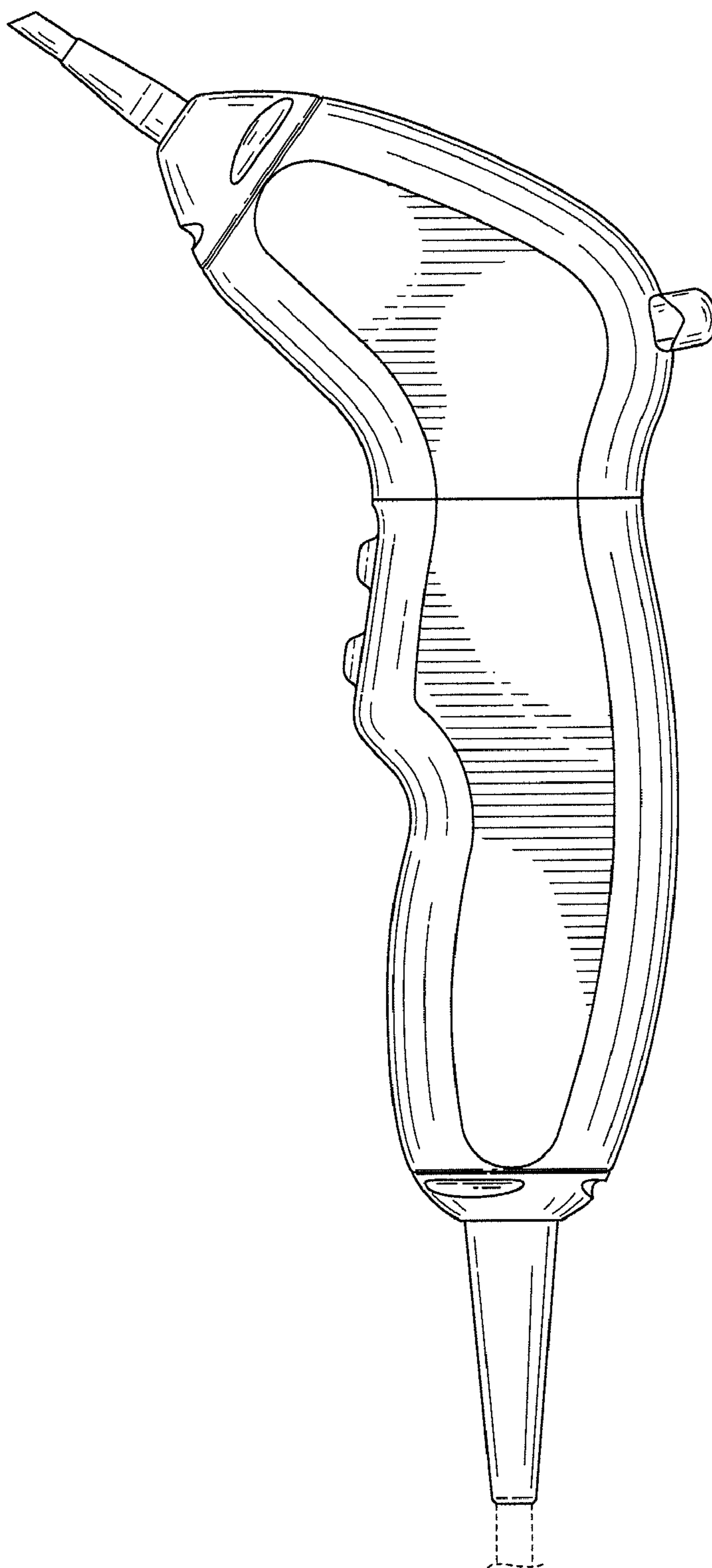
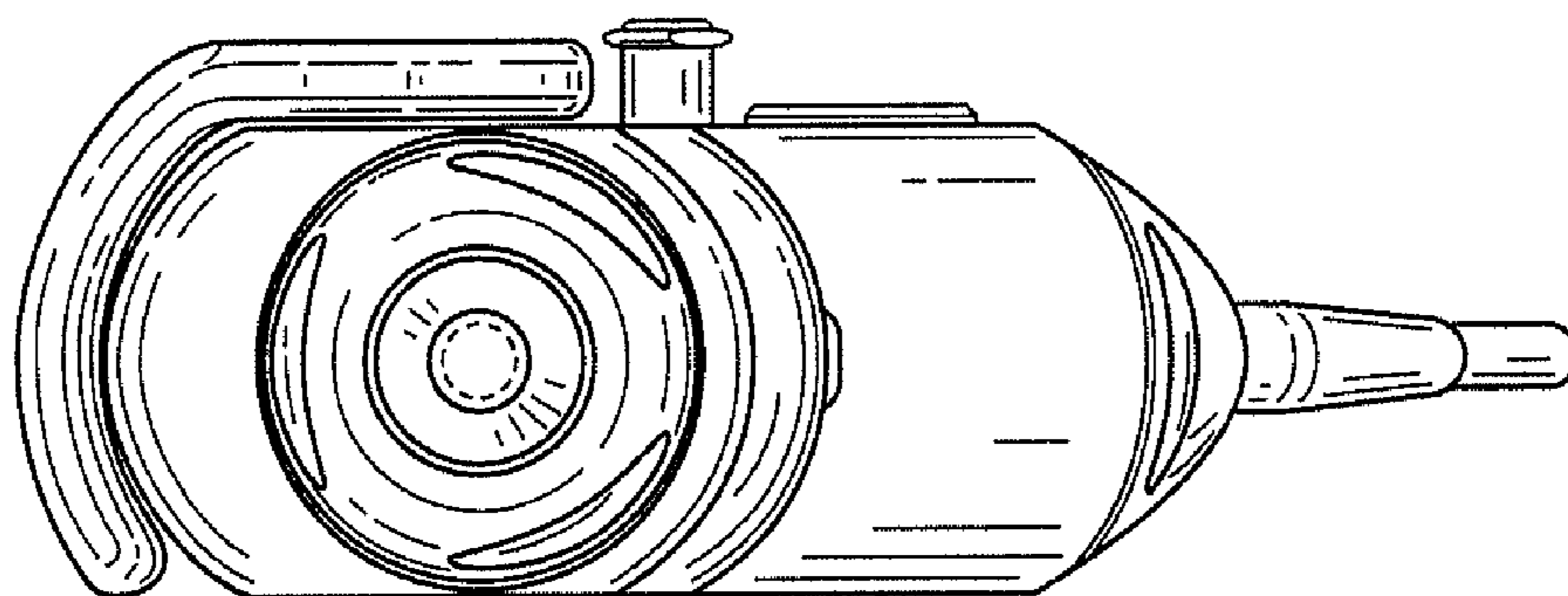
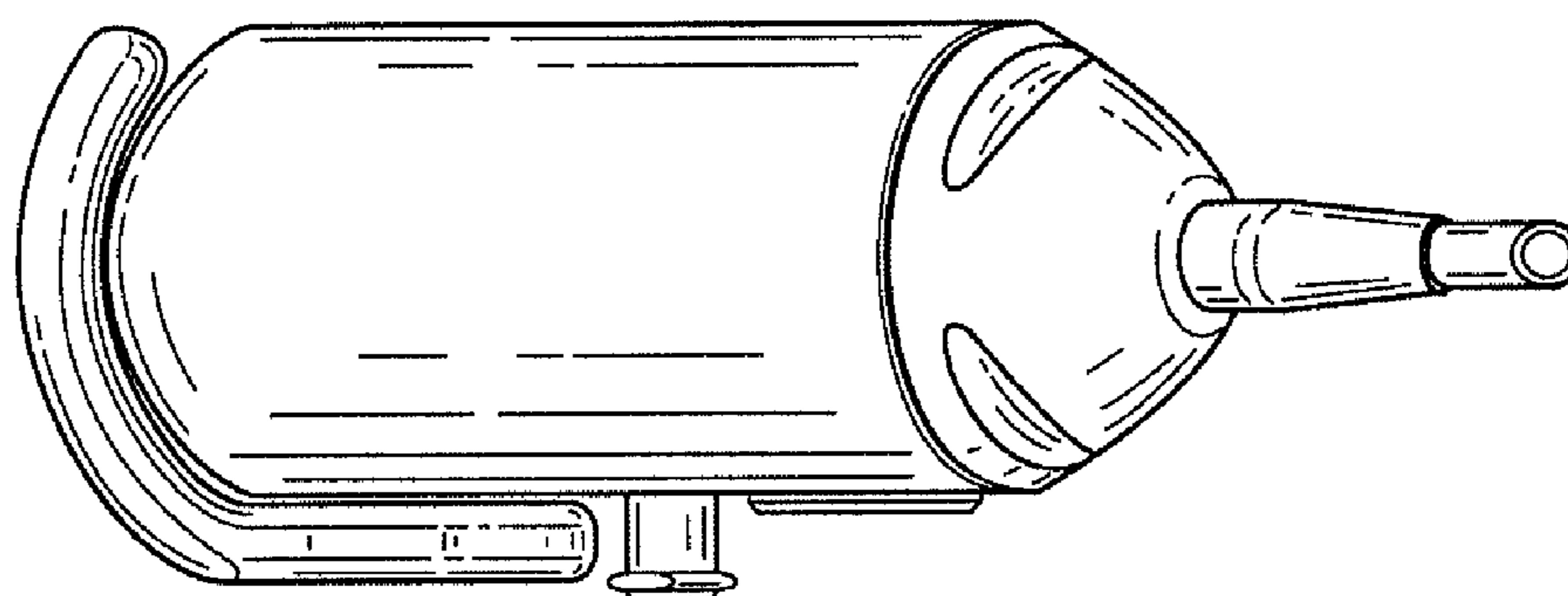

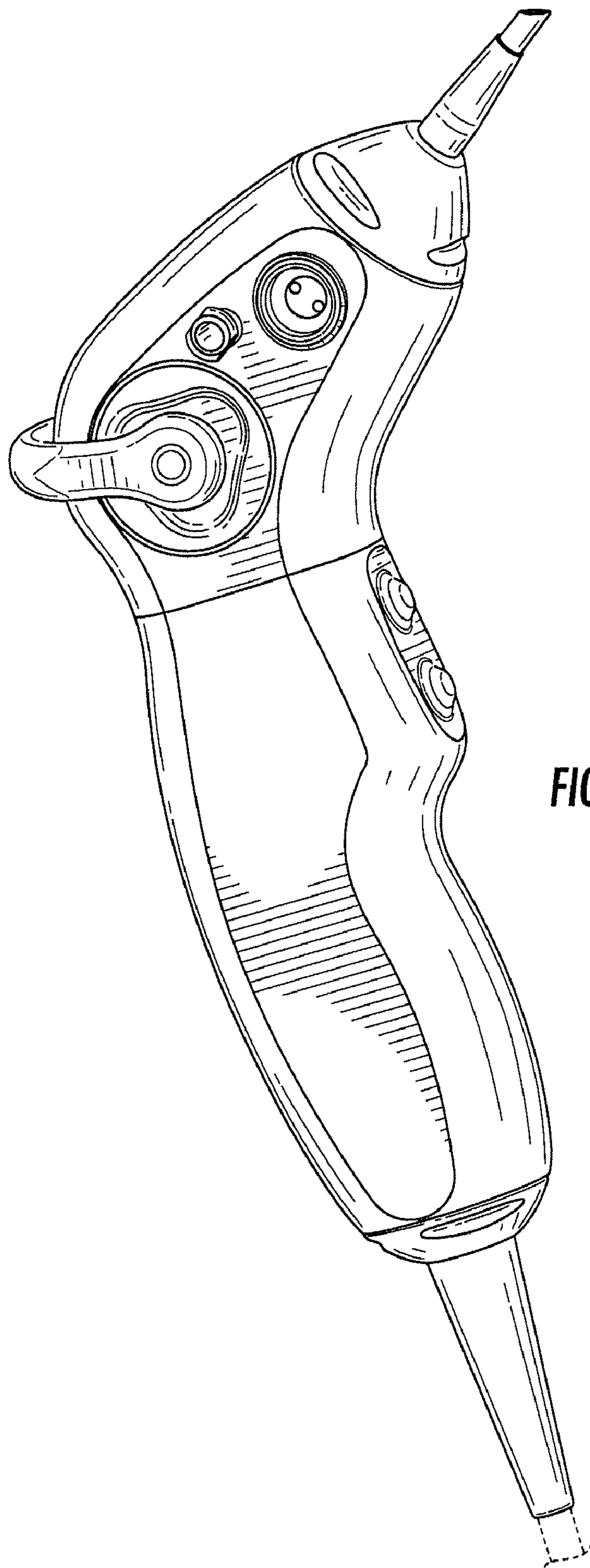
