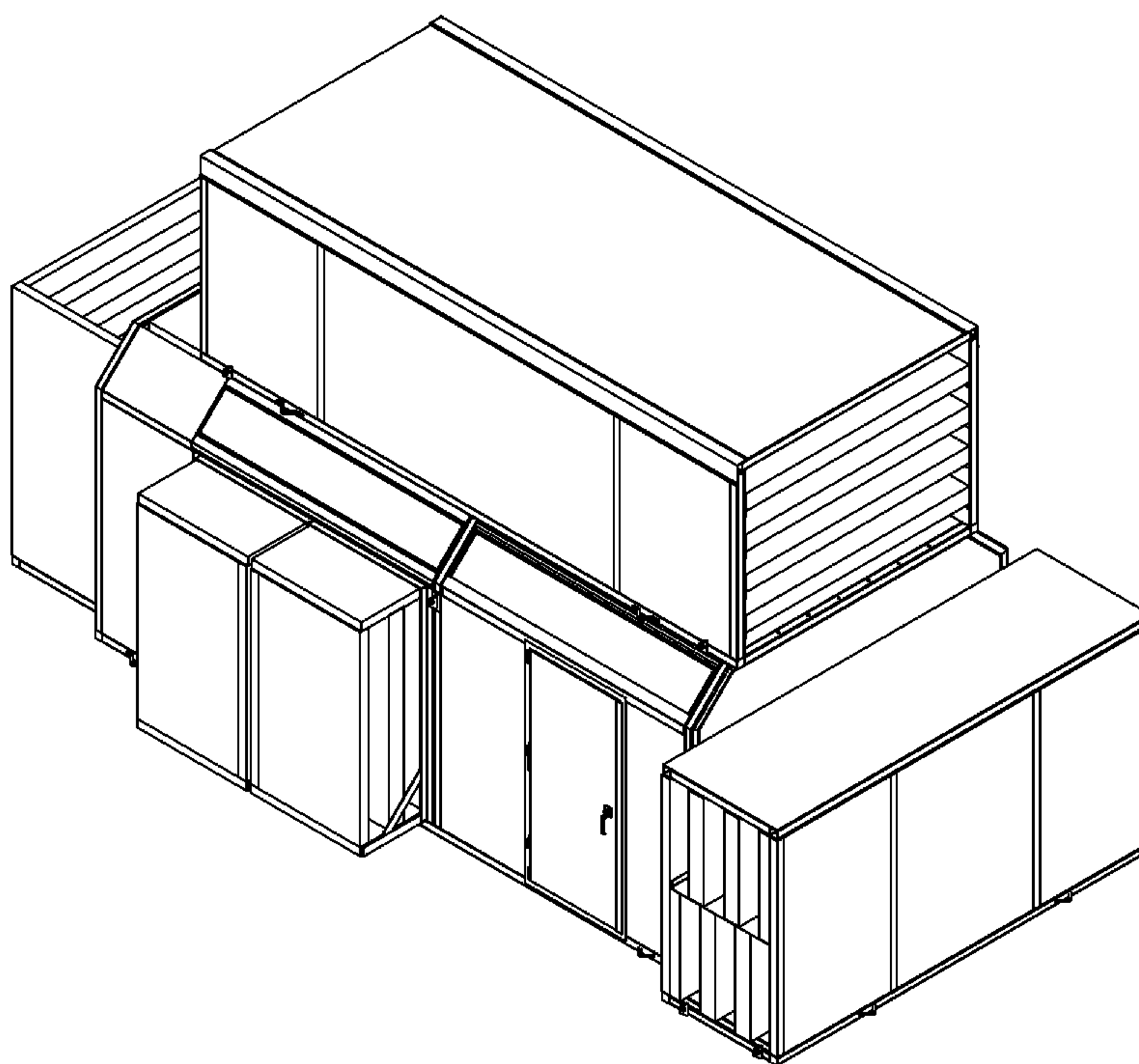
(57) **CLAIM**

The ornamental design for a noise suppression building, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a noise suppression building illustrating the present design;  
 FIG. 2 is a left side elevation view of the noise suppression building shown in FIG. 1;  
 FIG. 3 is a rear elevation view of the noise suppression building shown in FIG. 1;  
 FIG. 4 is a right side elevation view of the noise suppression building shown in FIG. 1;  
 FIG. 5 is a top plan view of the noise suppression building shown in FIG. 1;  
 FIG. 6 is a bottom plan view of the noise suppression building shown in FIG. 1 with the broken lines representing portions of the structure that forms no part of the claim.  
 FIG. 7 is a front perspective view of the noise suppression building shown in FIG. 1;  
 FIG. 8 is a rear perspective view of the noise suppression building shown in FIG. 1; and,  
 FIG. 9 is a front perspective view of the noise suppression building shown in FIG. 1 with the broken lines representing environment that forms no part of the claim.

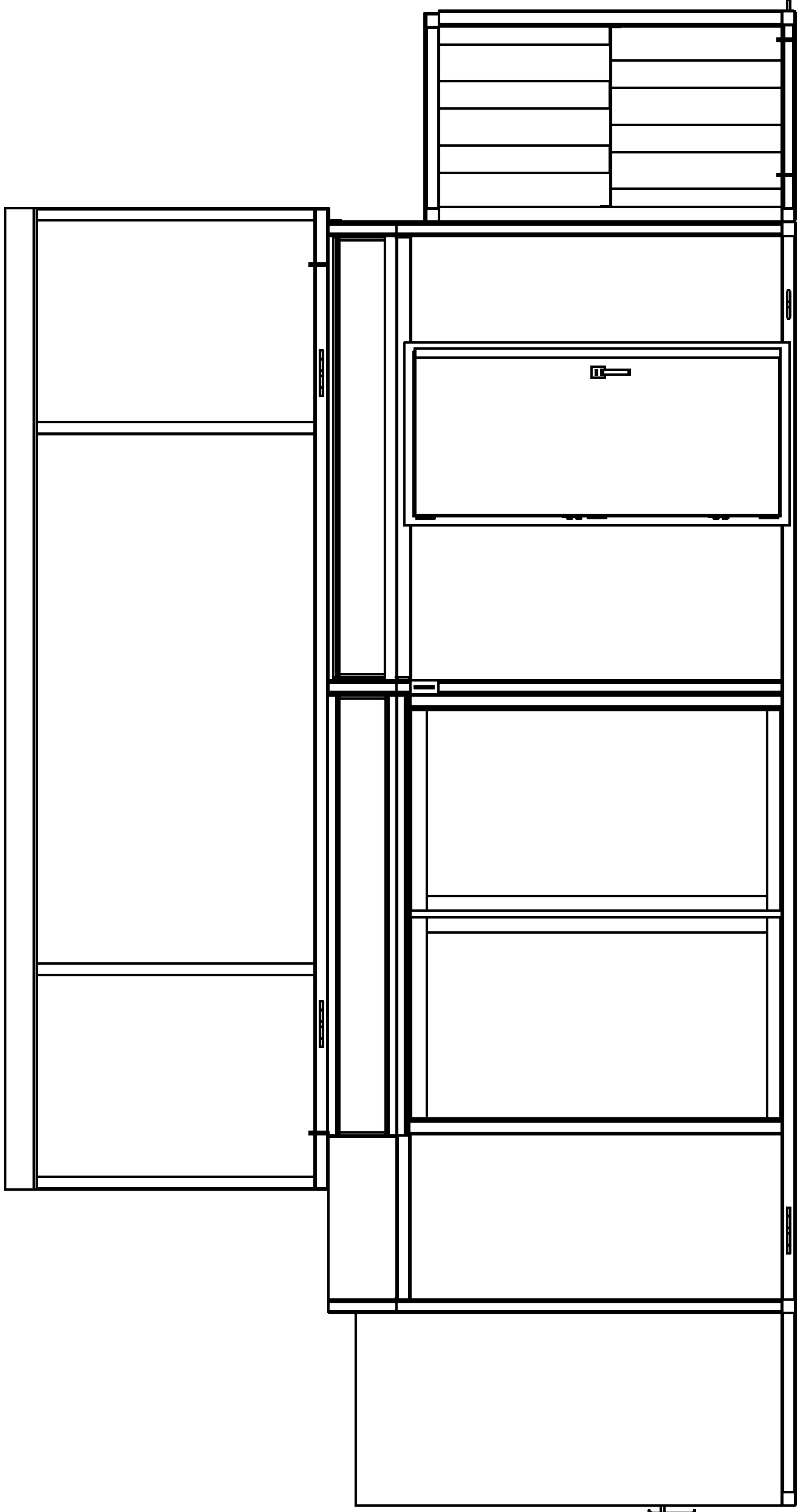

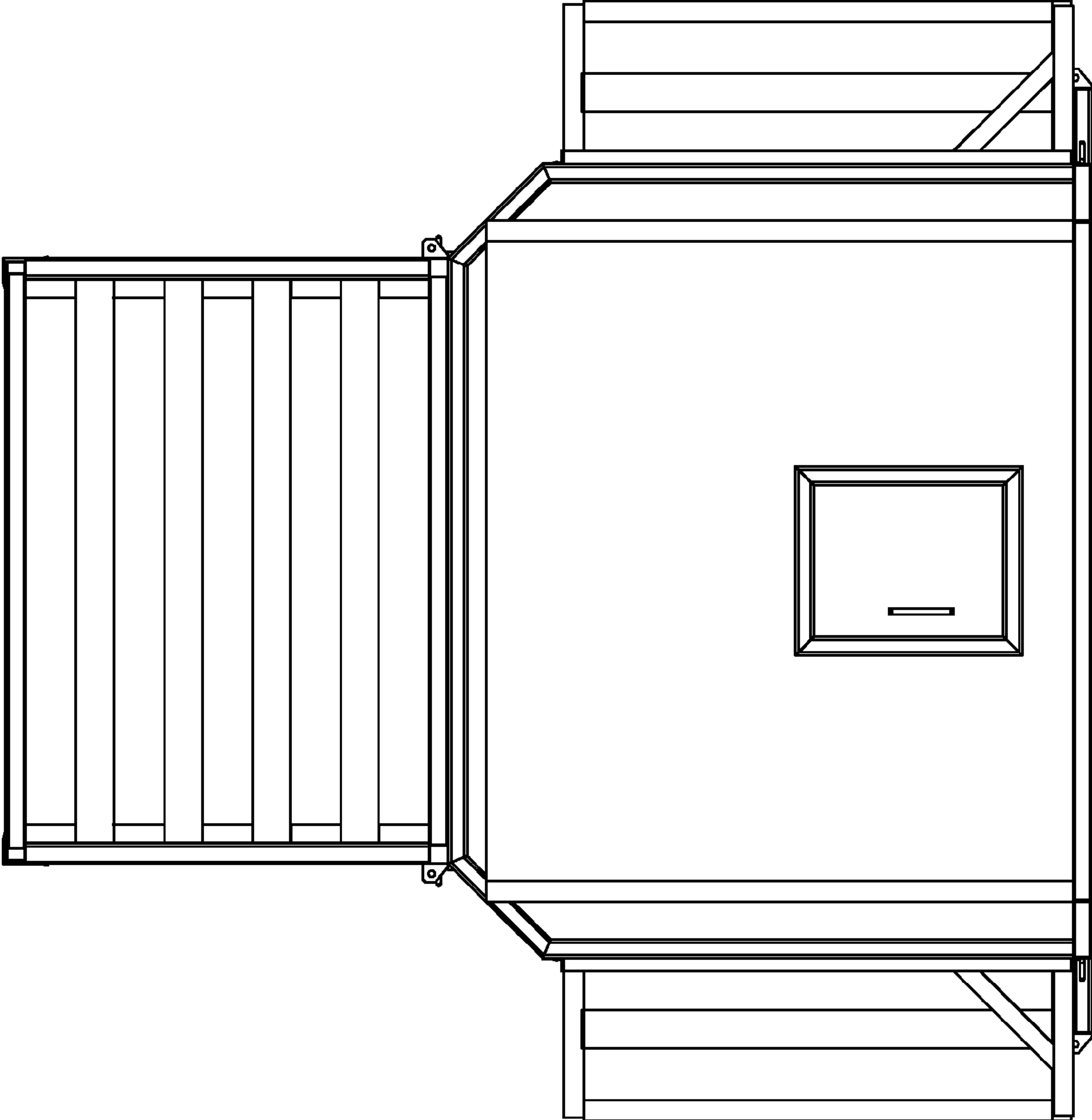

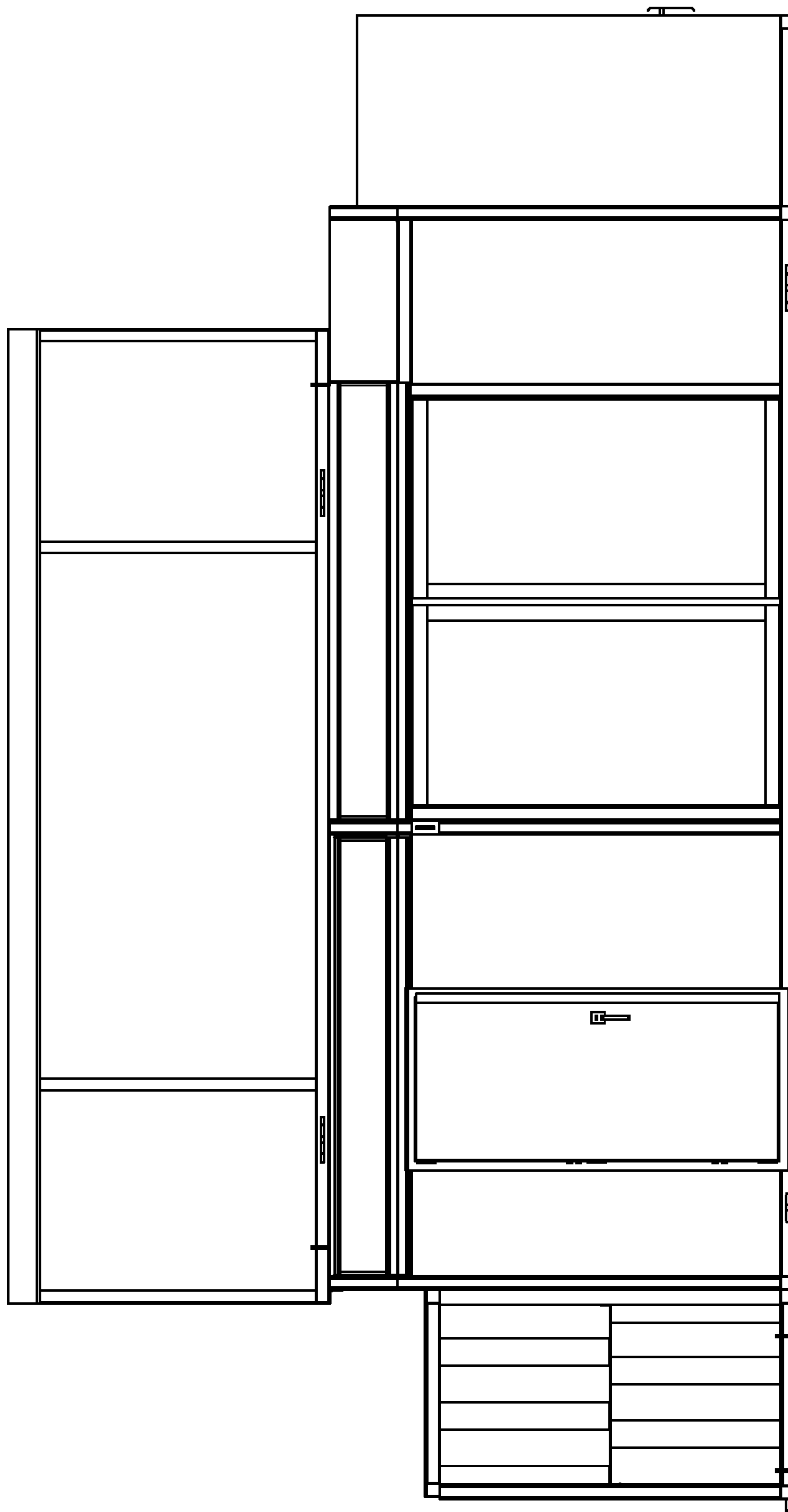

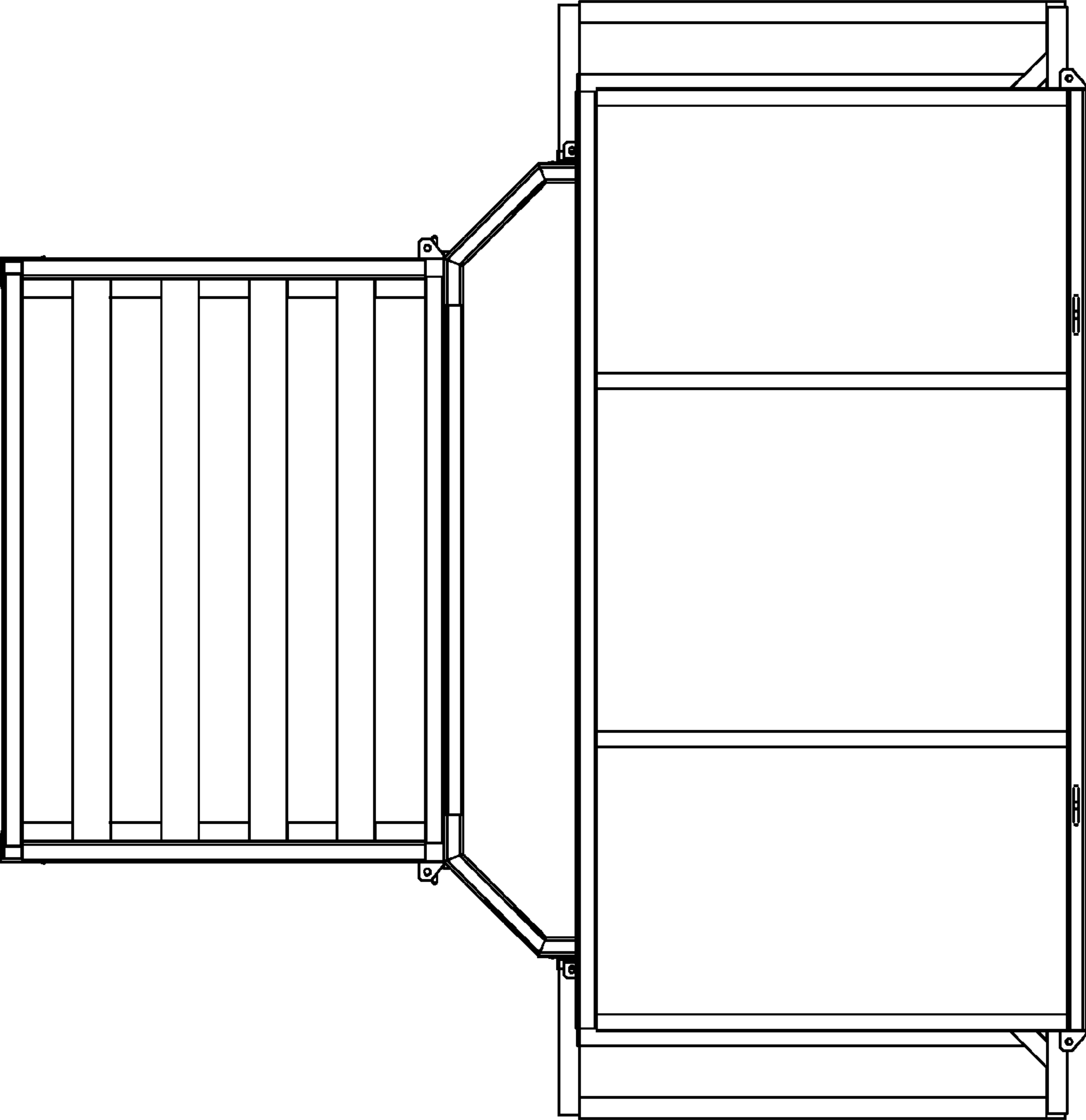

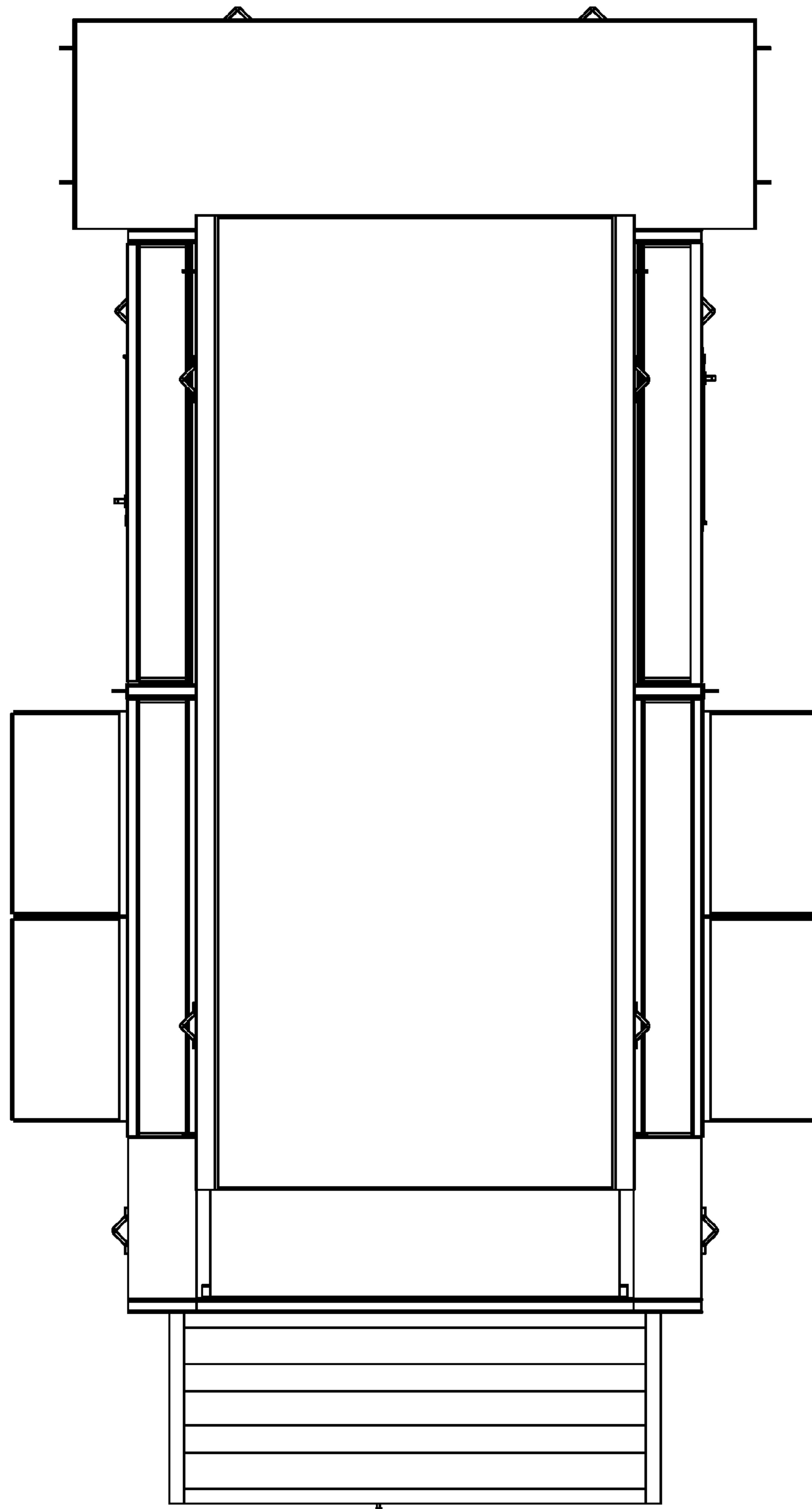

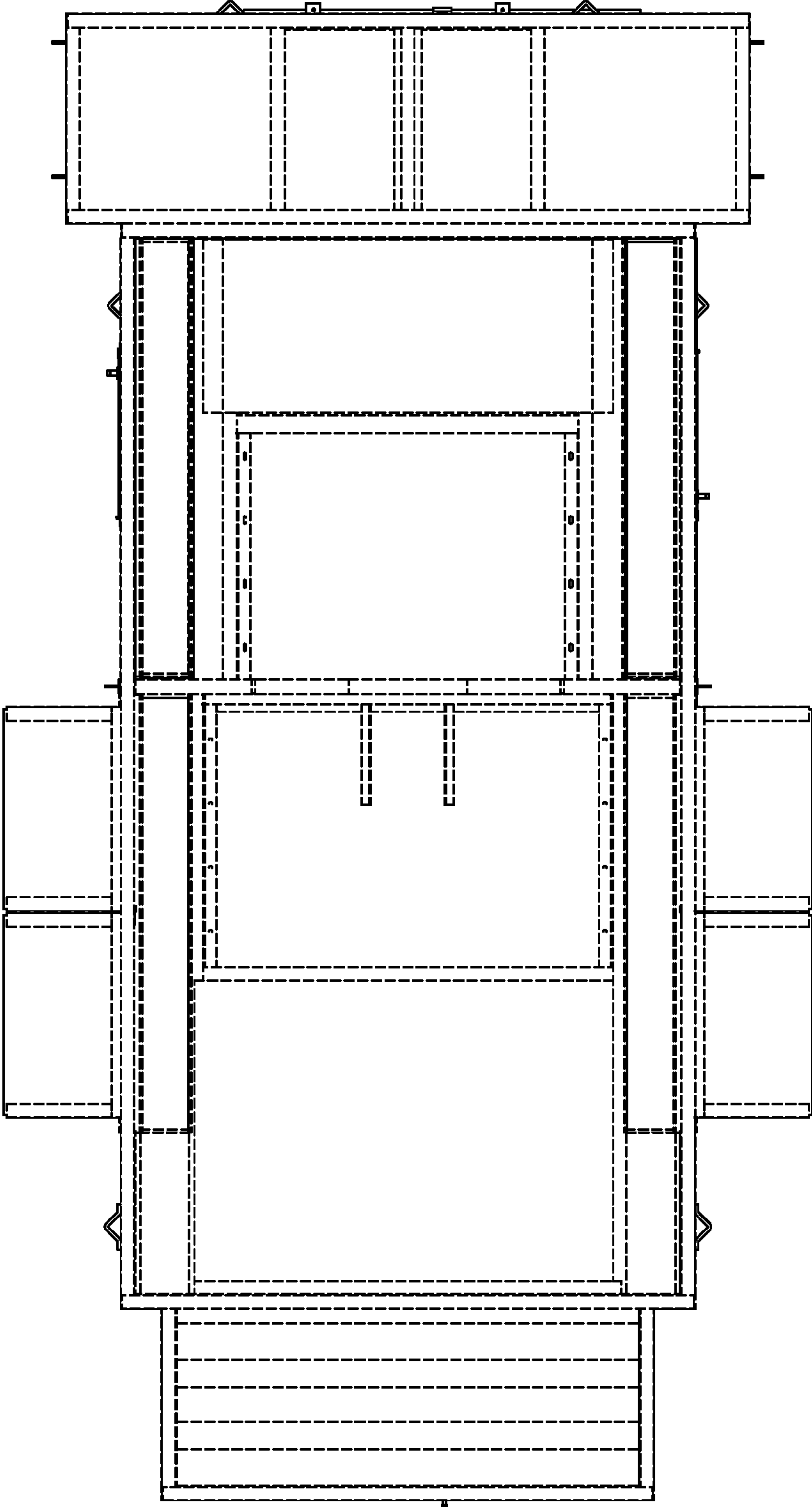

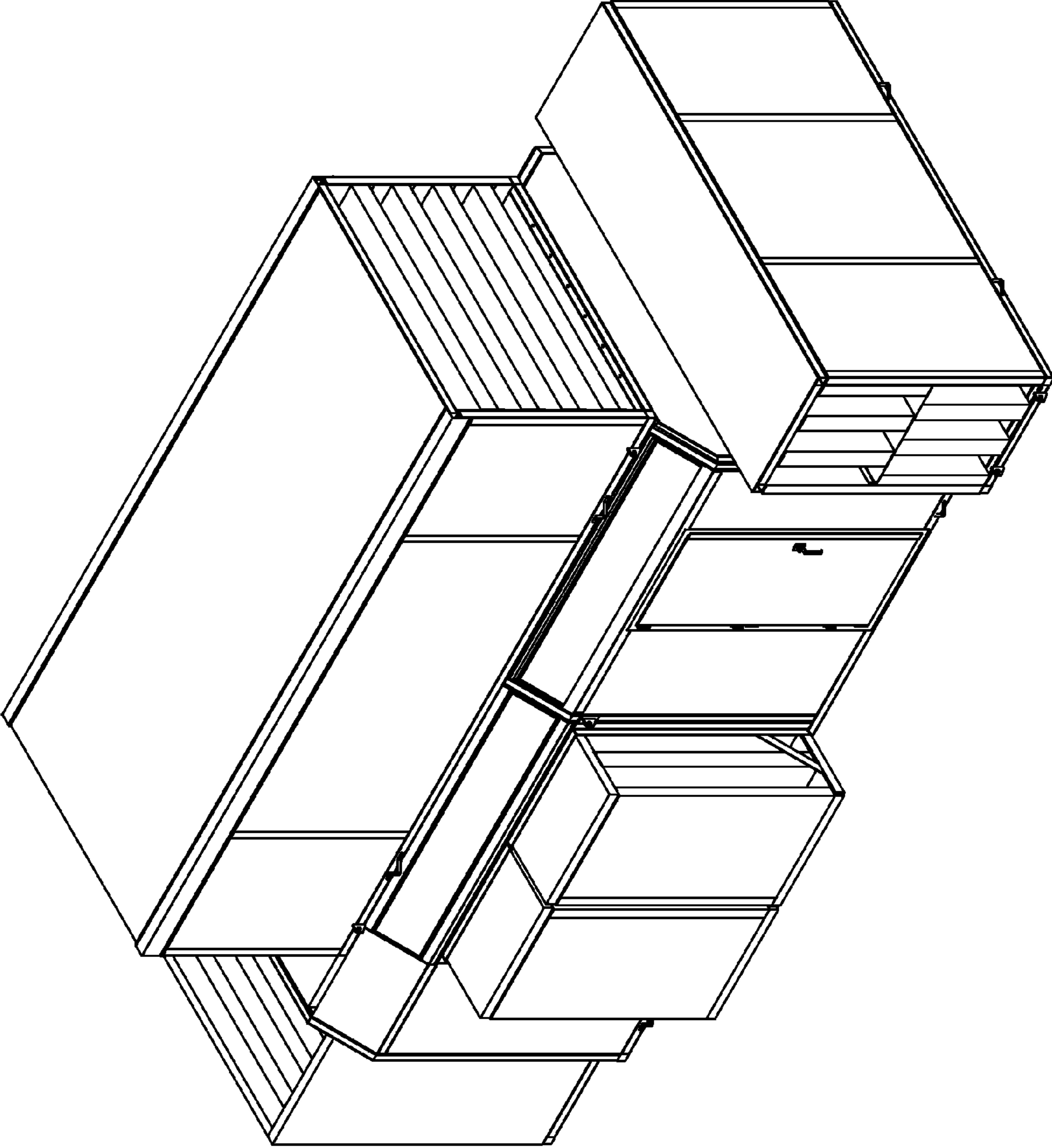

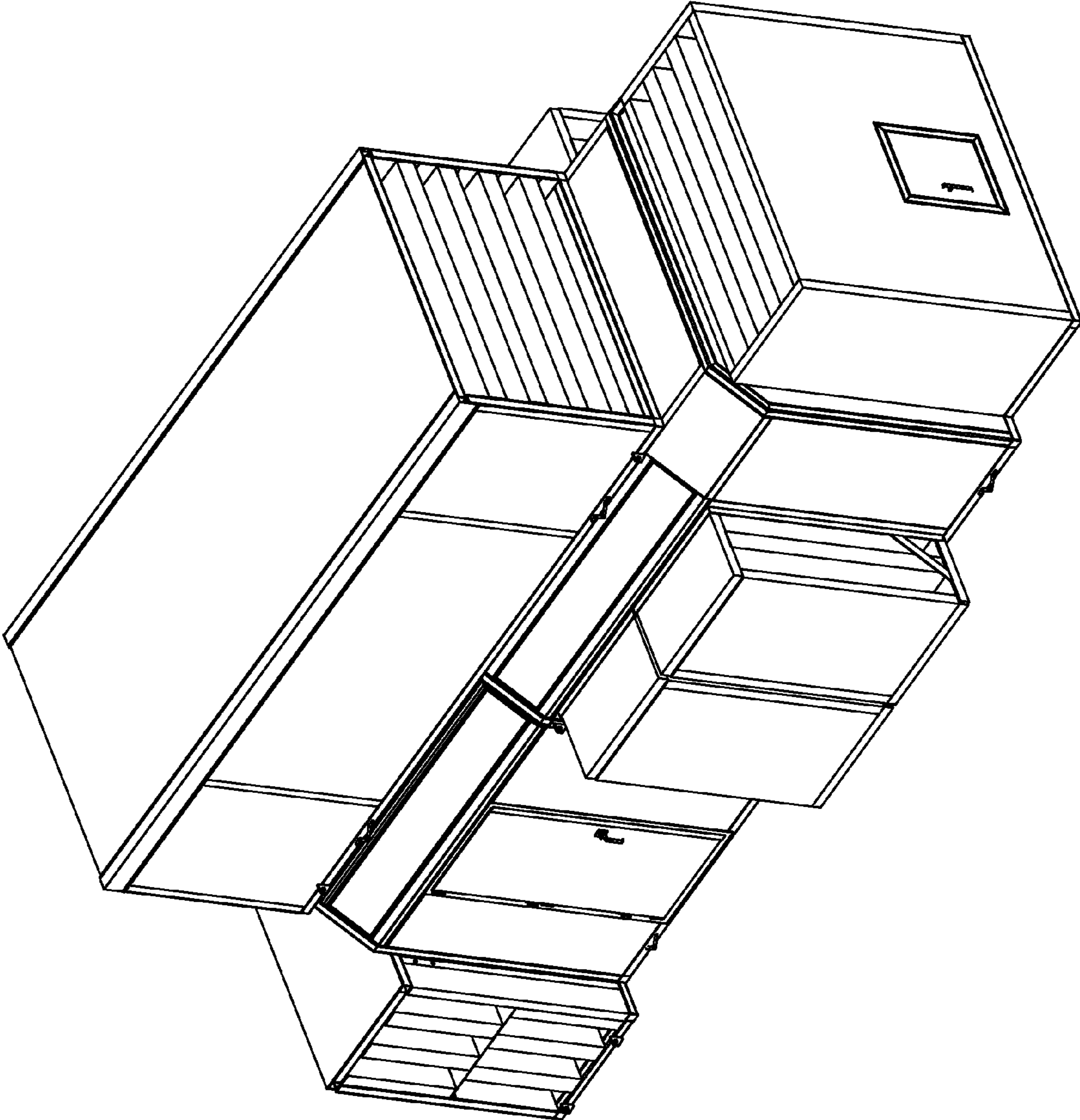

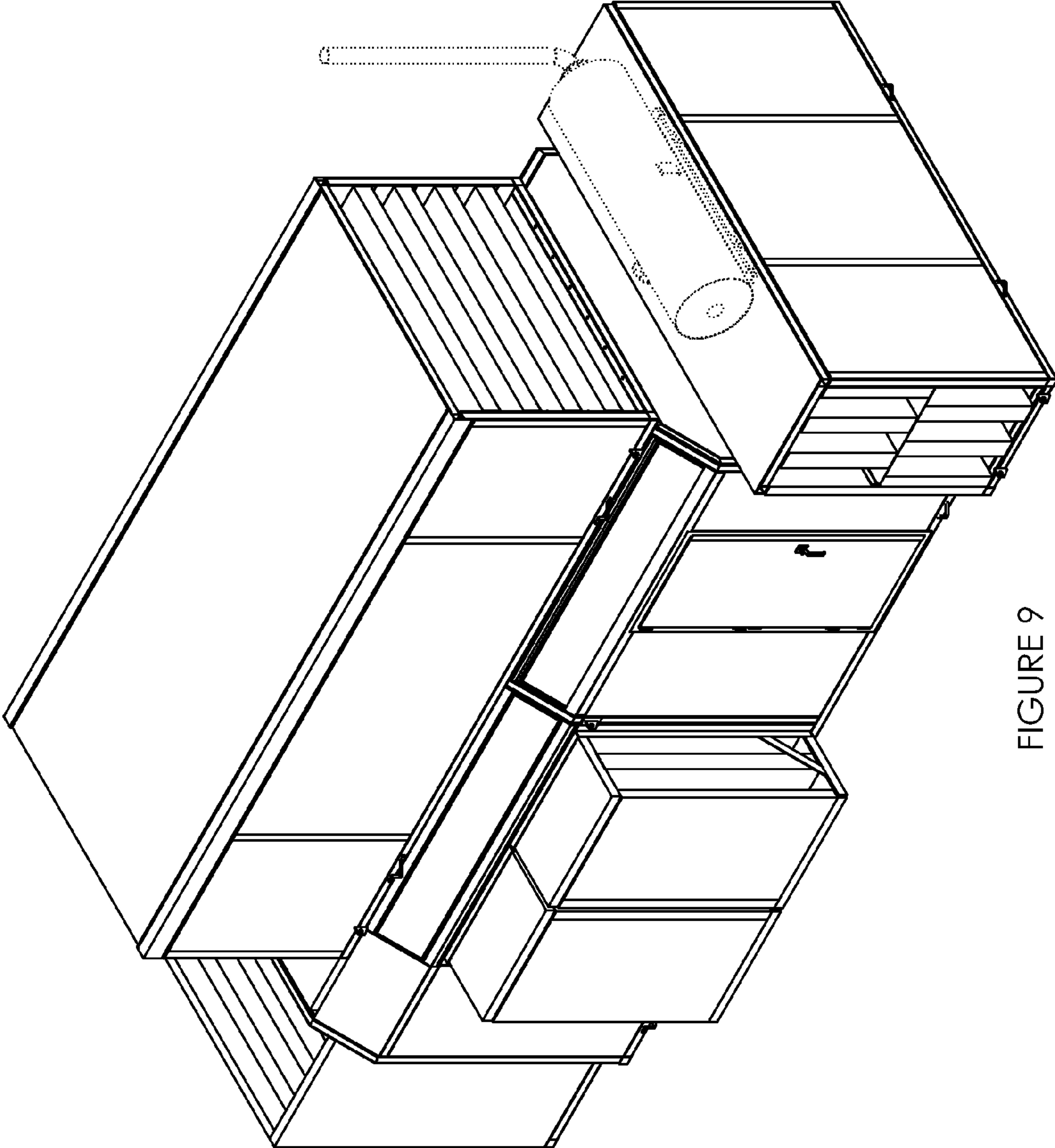
