The ornamental design for a taillight for a vehicle, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a taillight
for a vehicle according to our design;

FIG. 2 is a front view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a top view thereof; and

FIG. 5 is a bottom view thereof.

FIG. 6 is a perspective view of a second embodiment of the
taillight for a vehicle according to our design, with the tail-

FIG. 7 is a front view thereof;

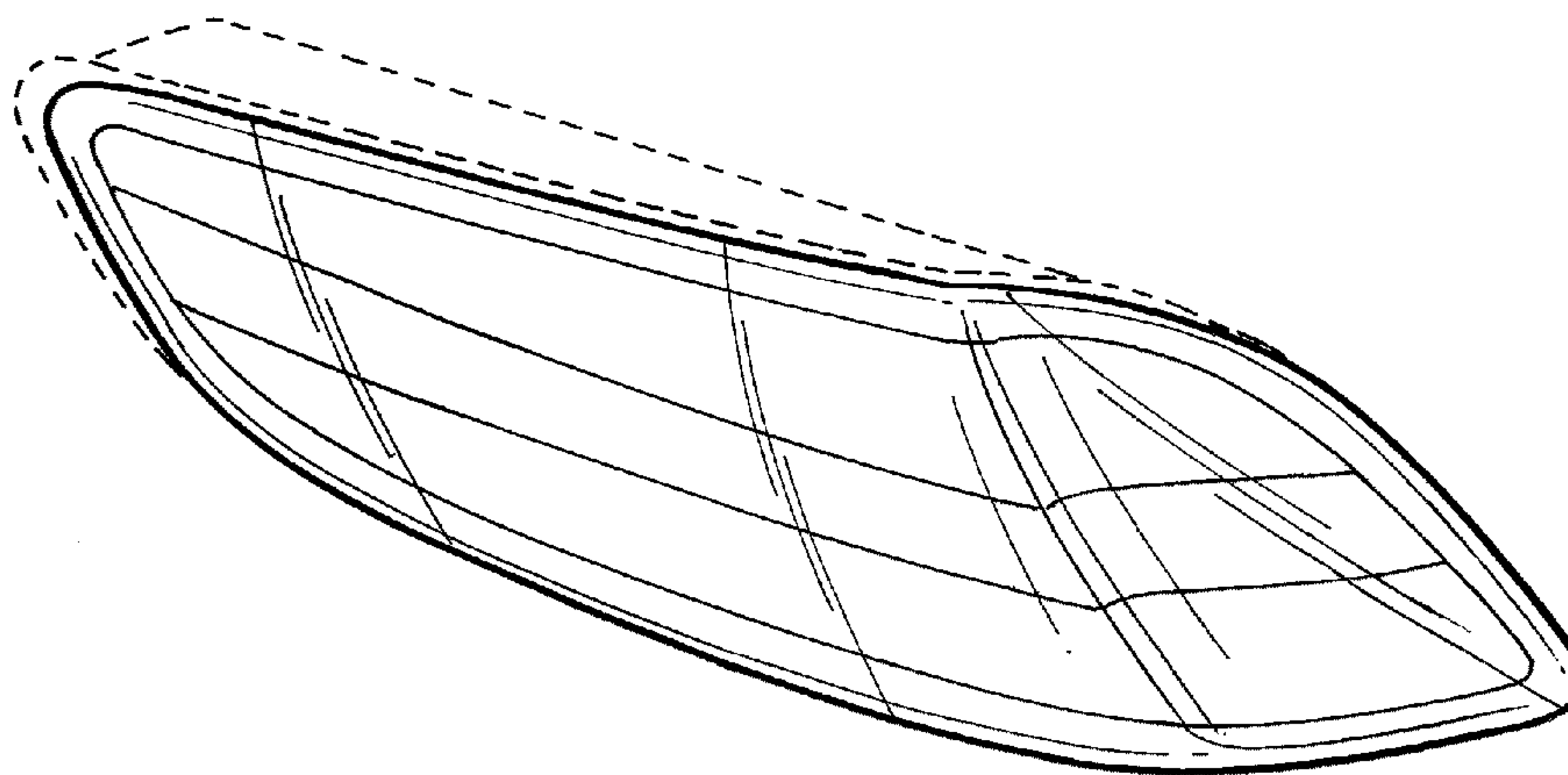
FIG. 8 is a side view thereof;

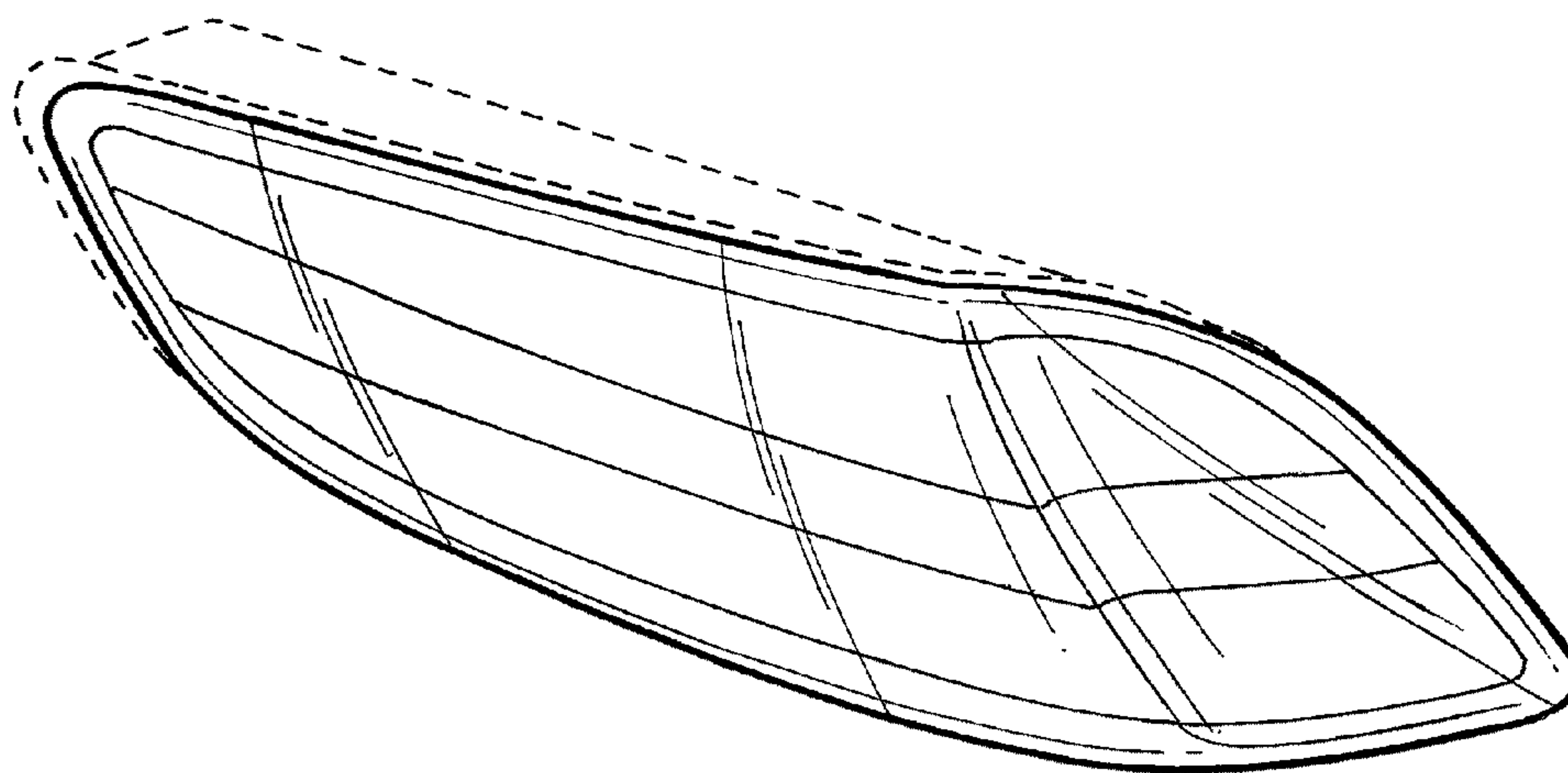

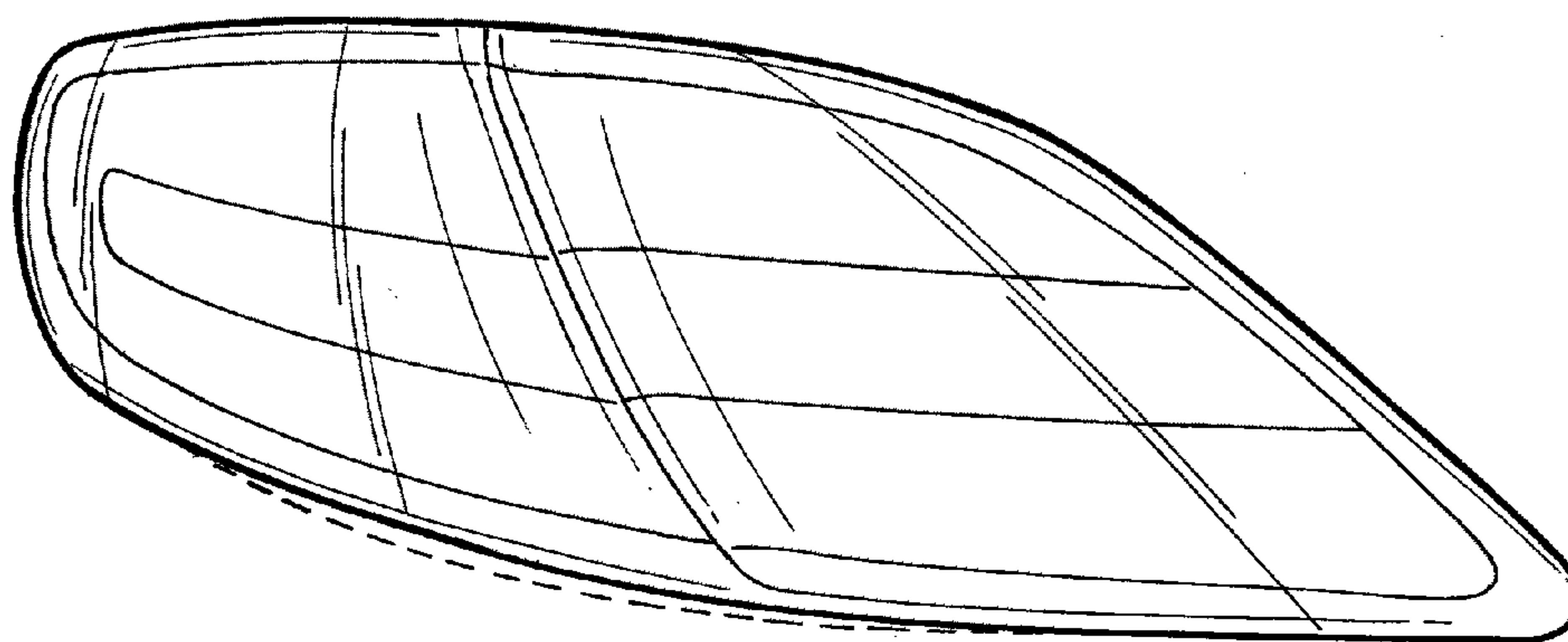

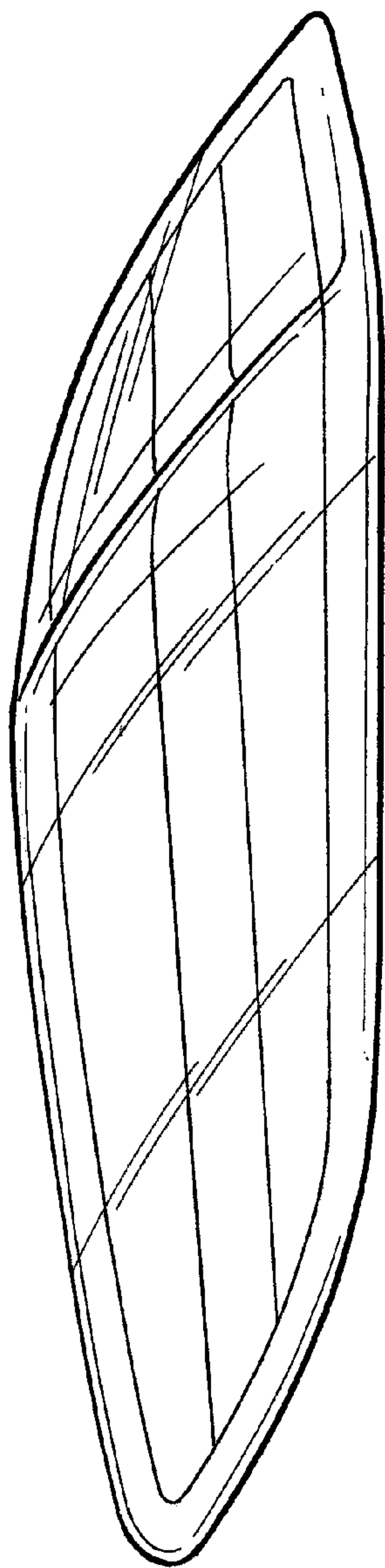

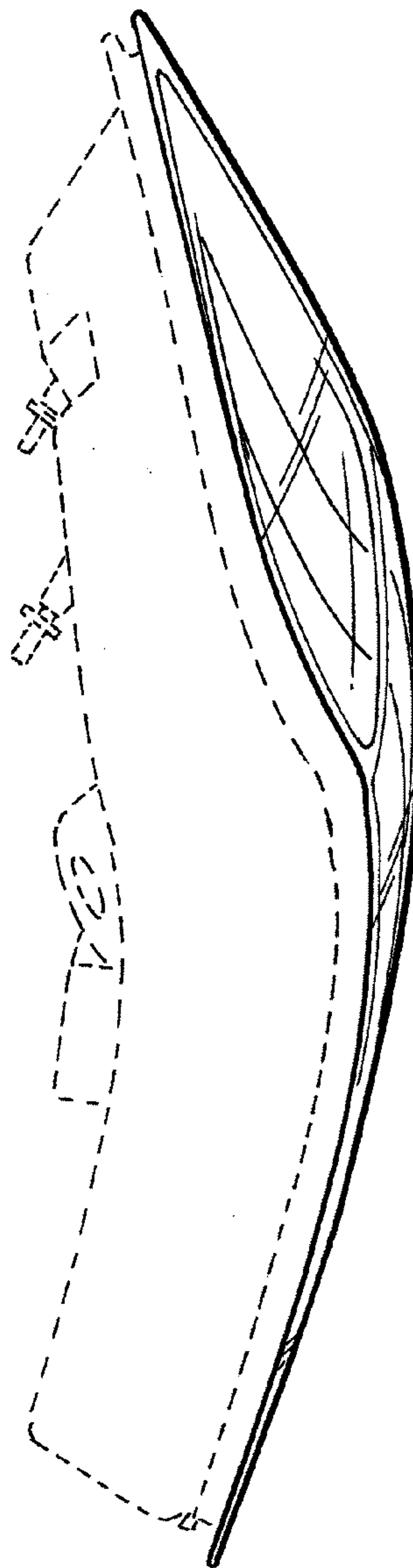

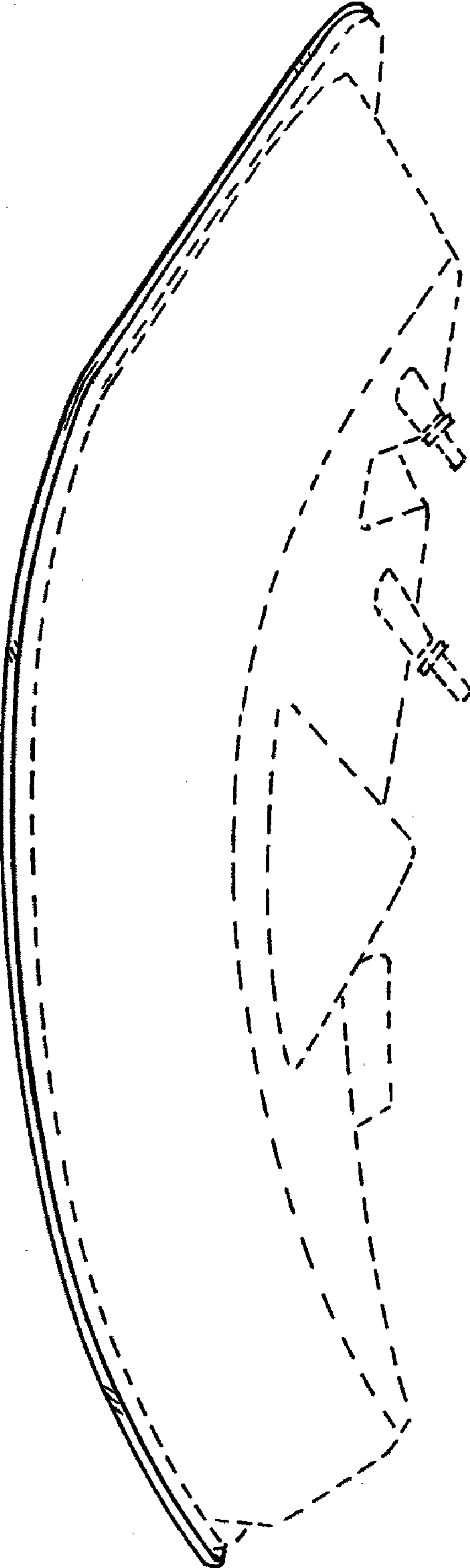

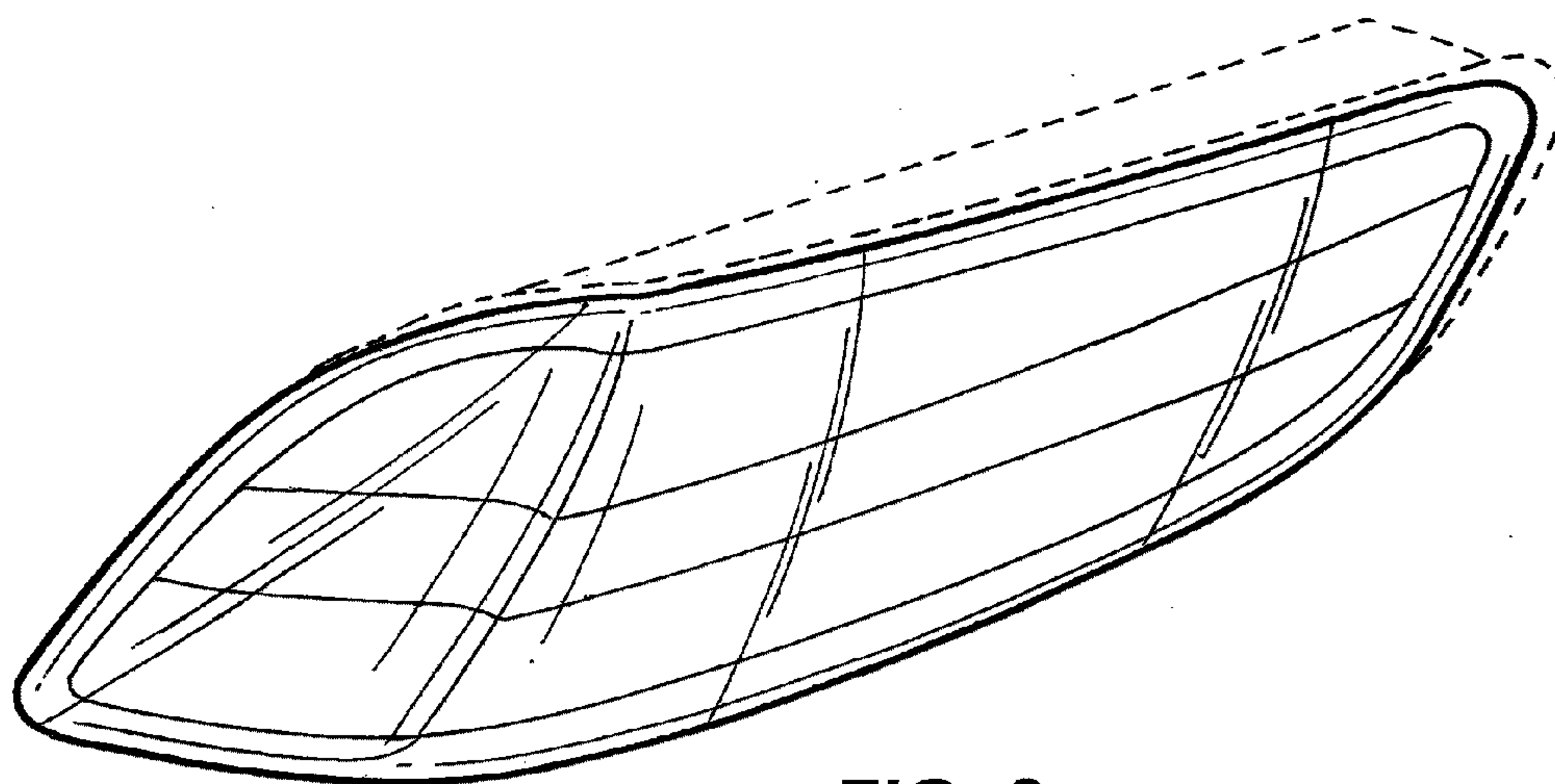

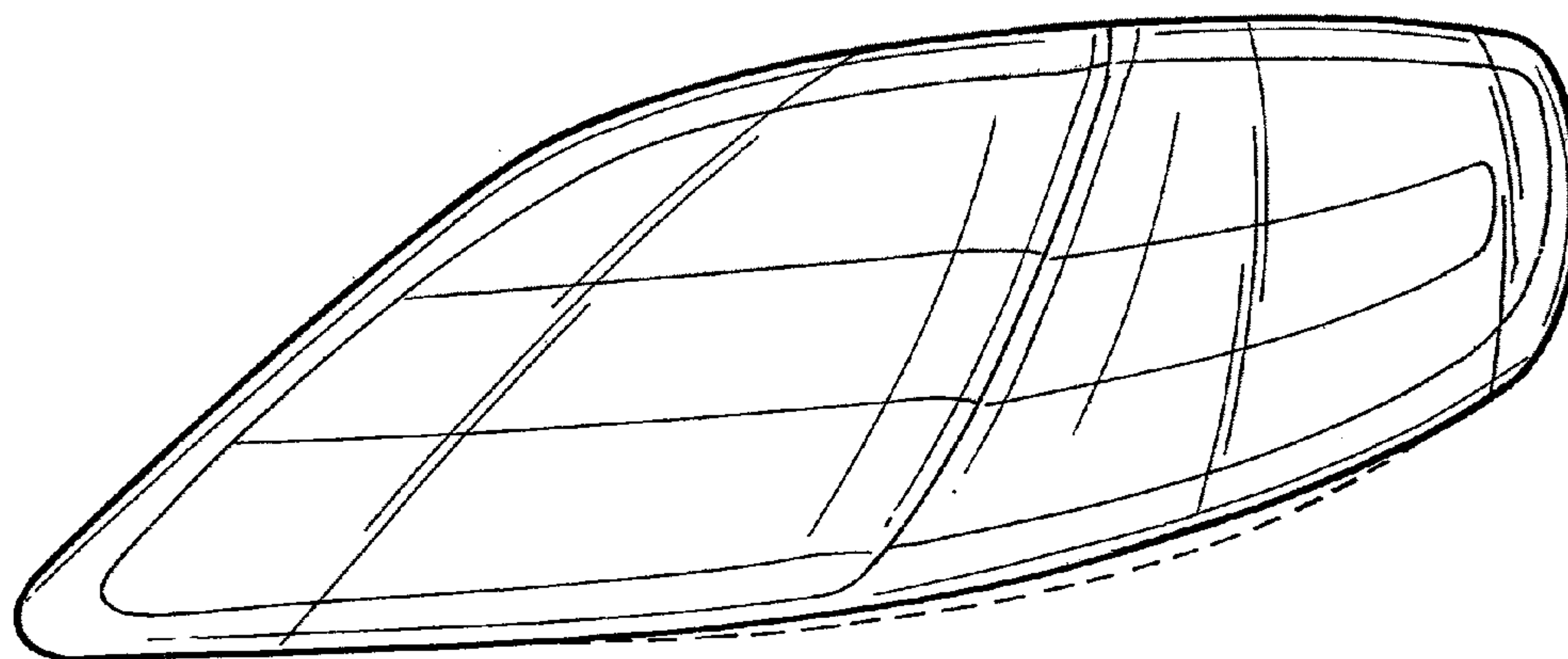

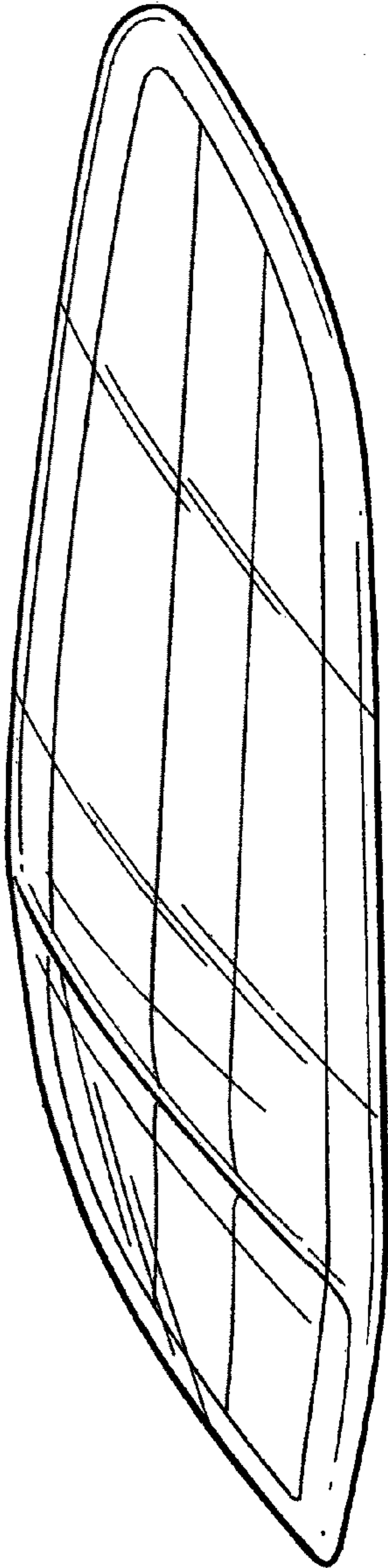

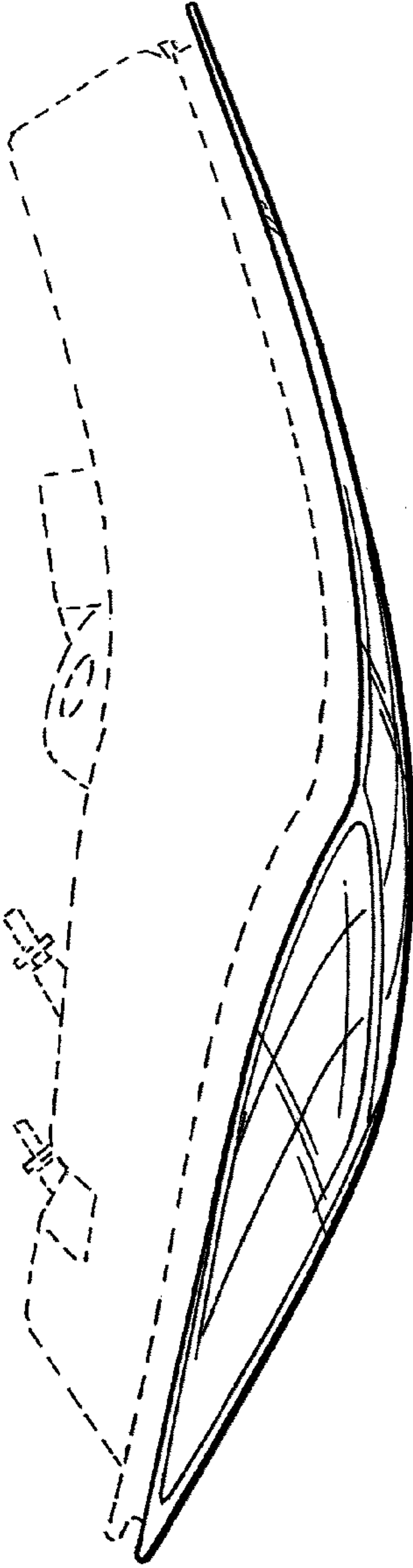

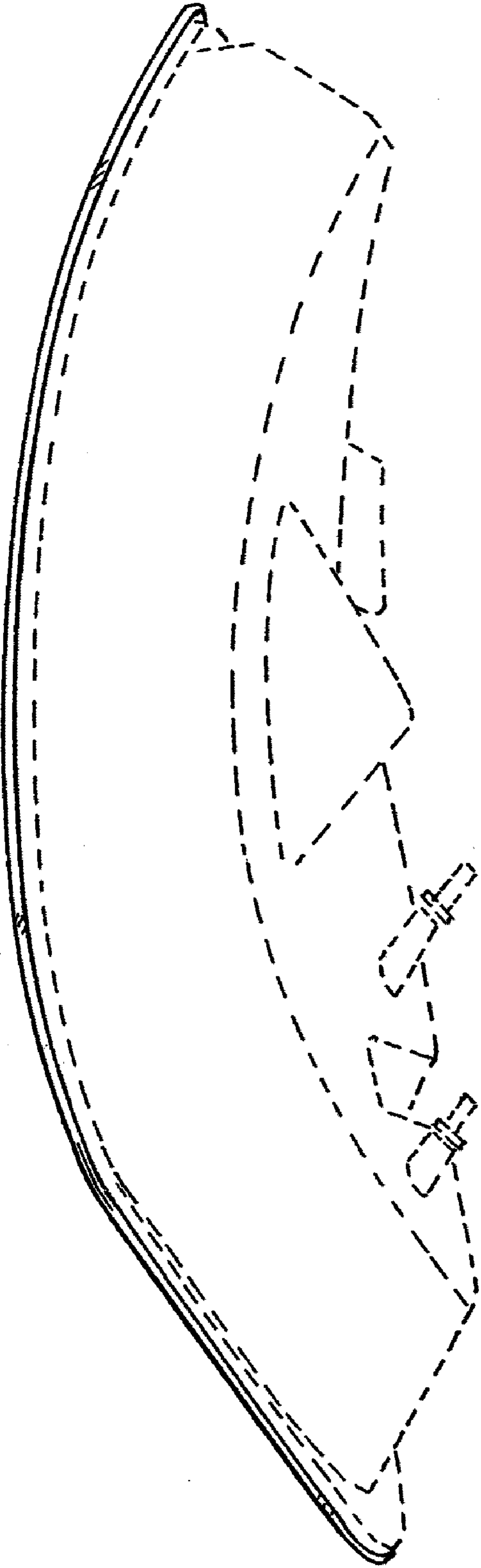
