The ornamental design for a dog carrier and shelter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a dog carrier and shelter showing my new design;

FIG. 2 is a front perspective view;

FIG. 3 is a top plan view;

FIG. 4 is a back elevation view;

FIG. 5 is a bottom plan view;

FIG. 6 is a right side elevation view; and,

FIG. 7 is a left side elevation view.

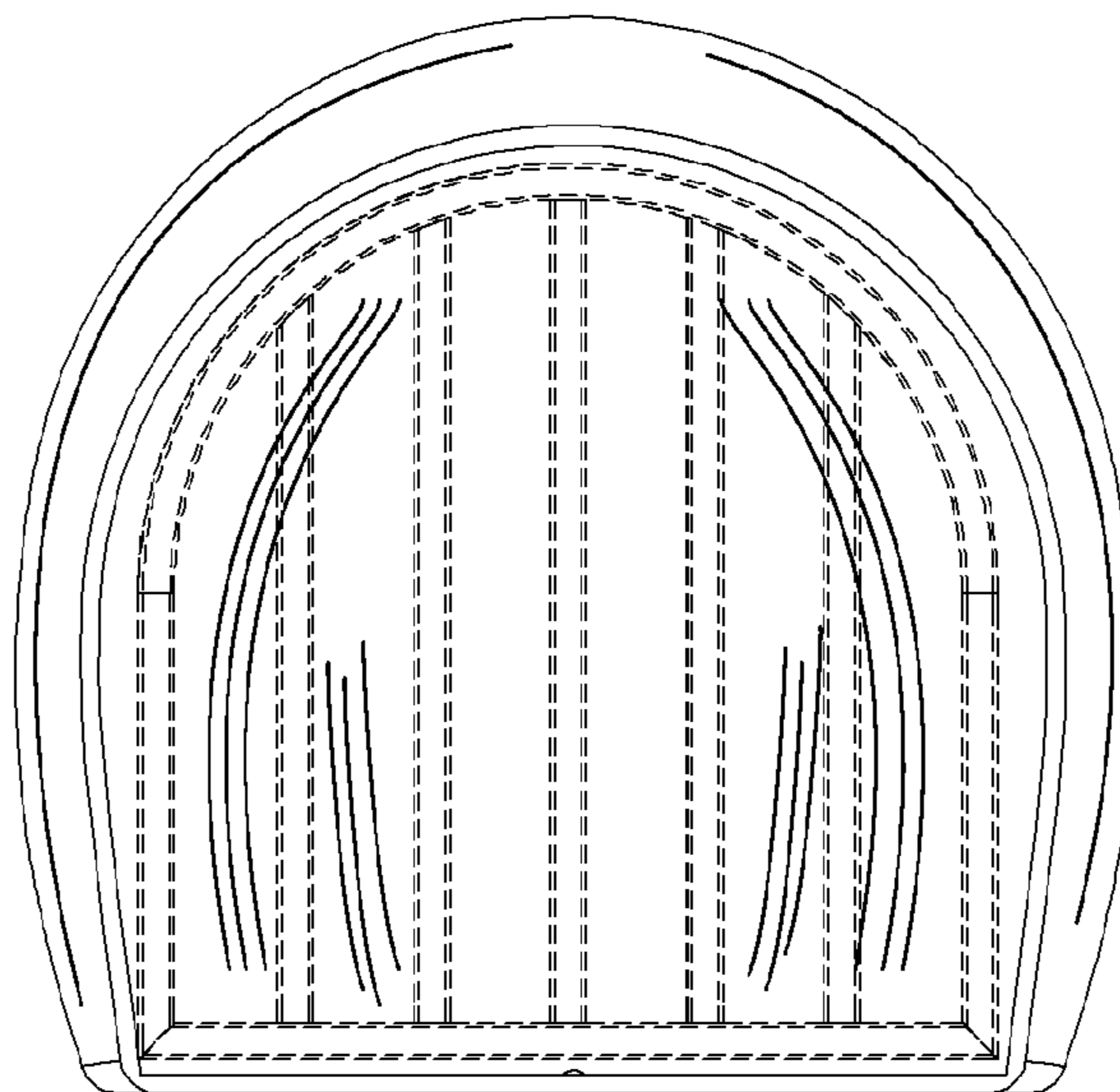

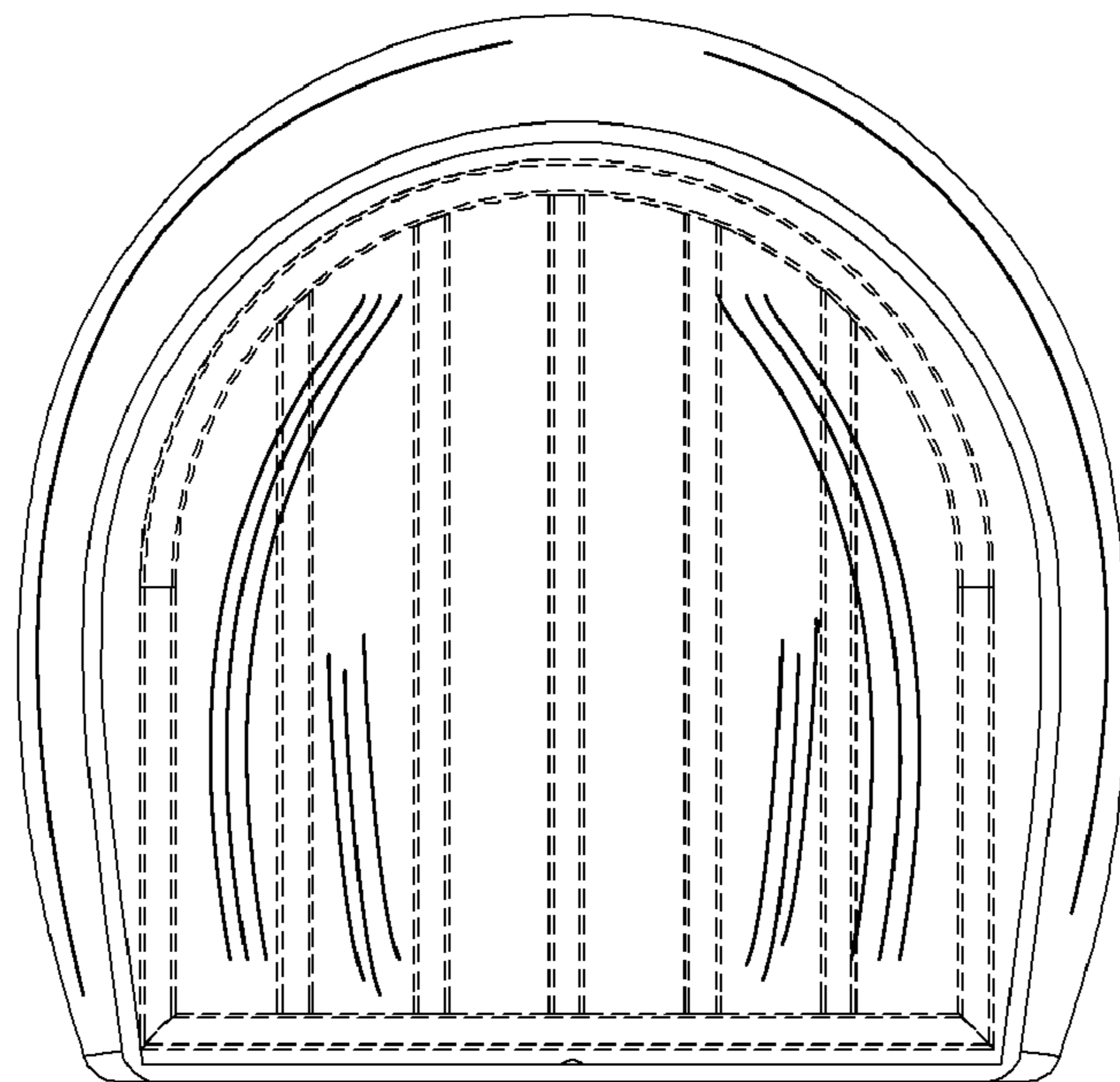

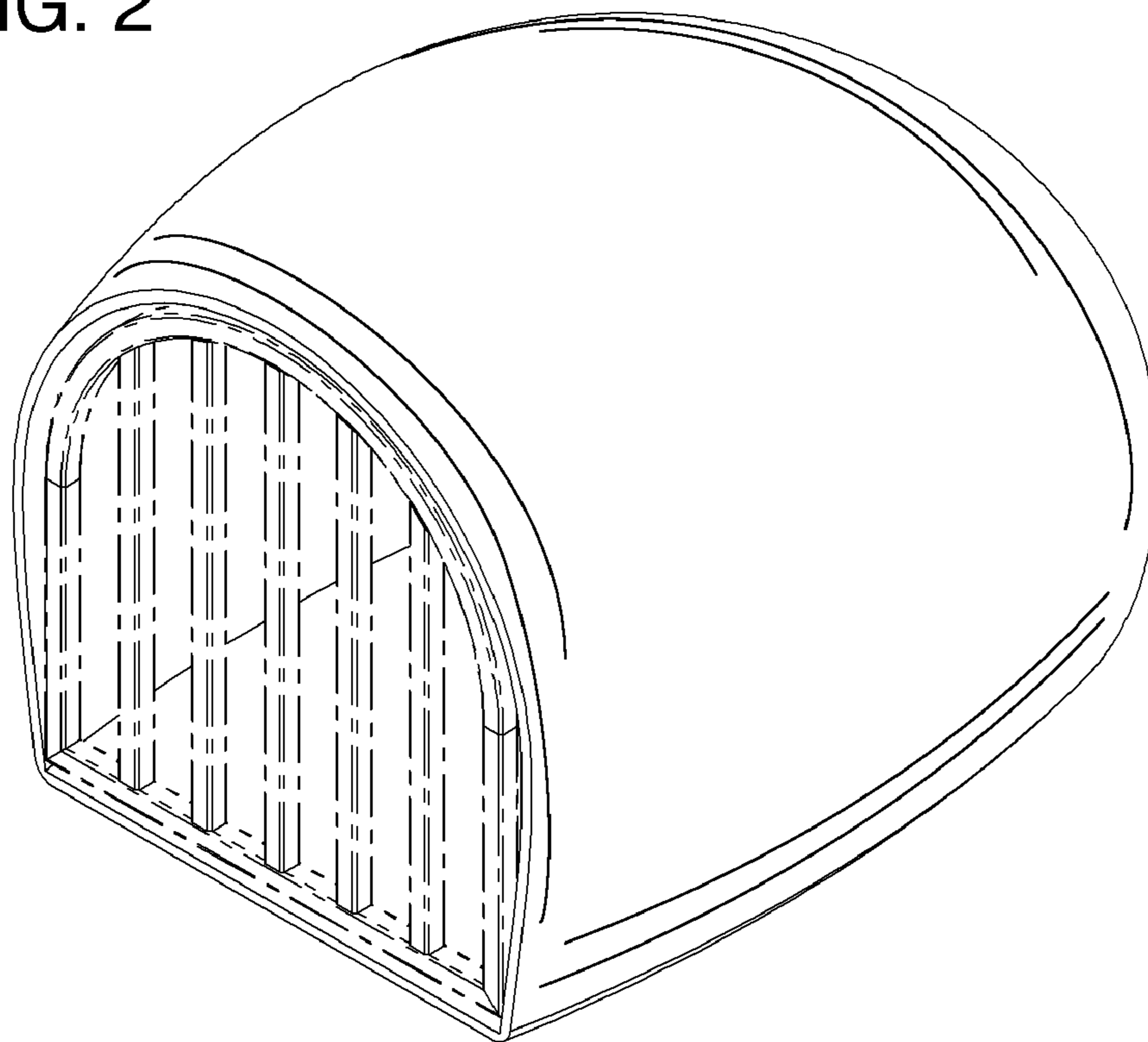

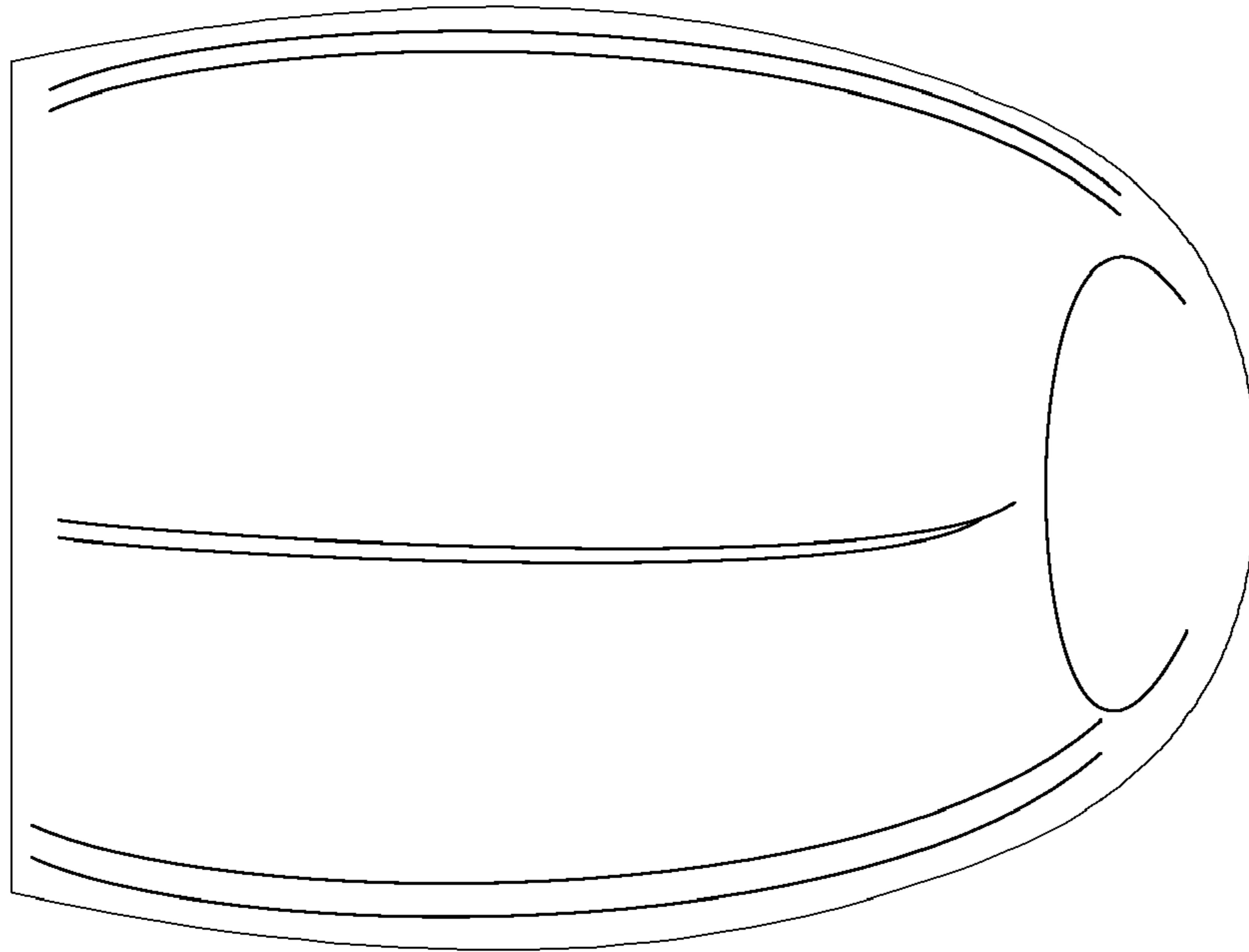

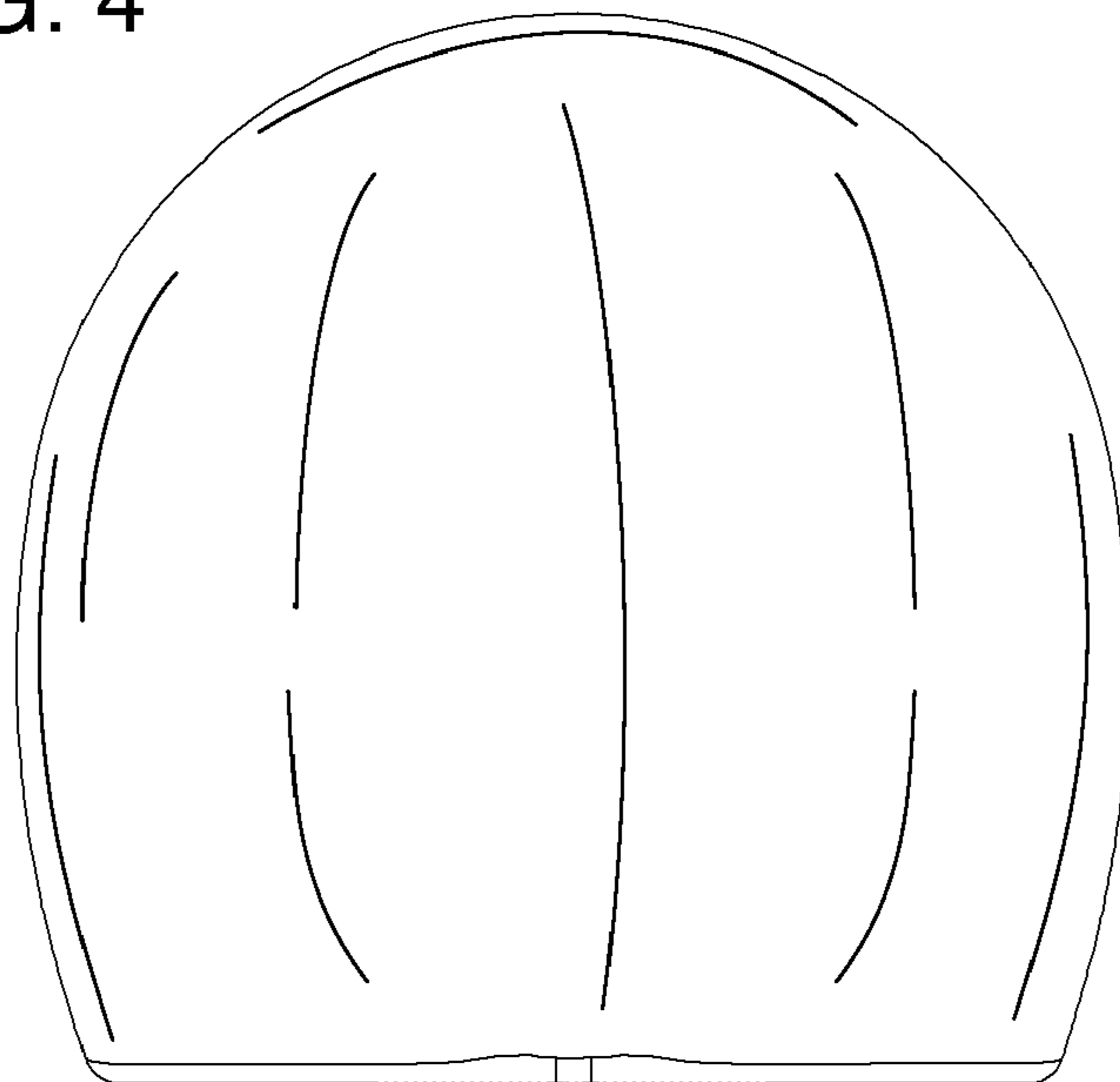

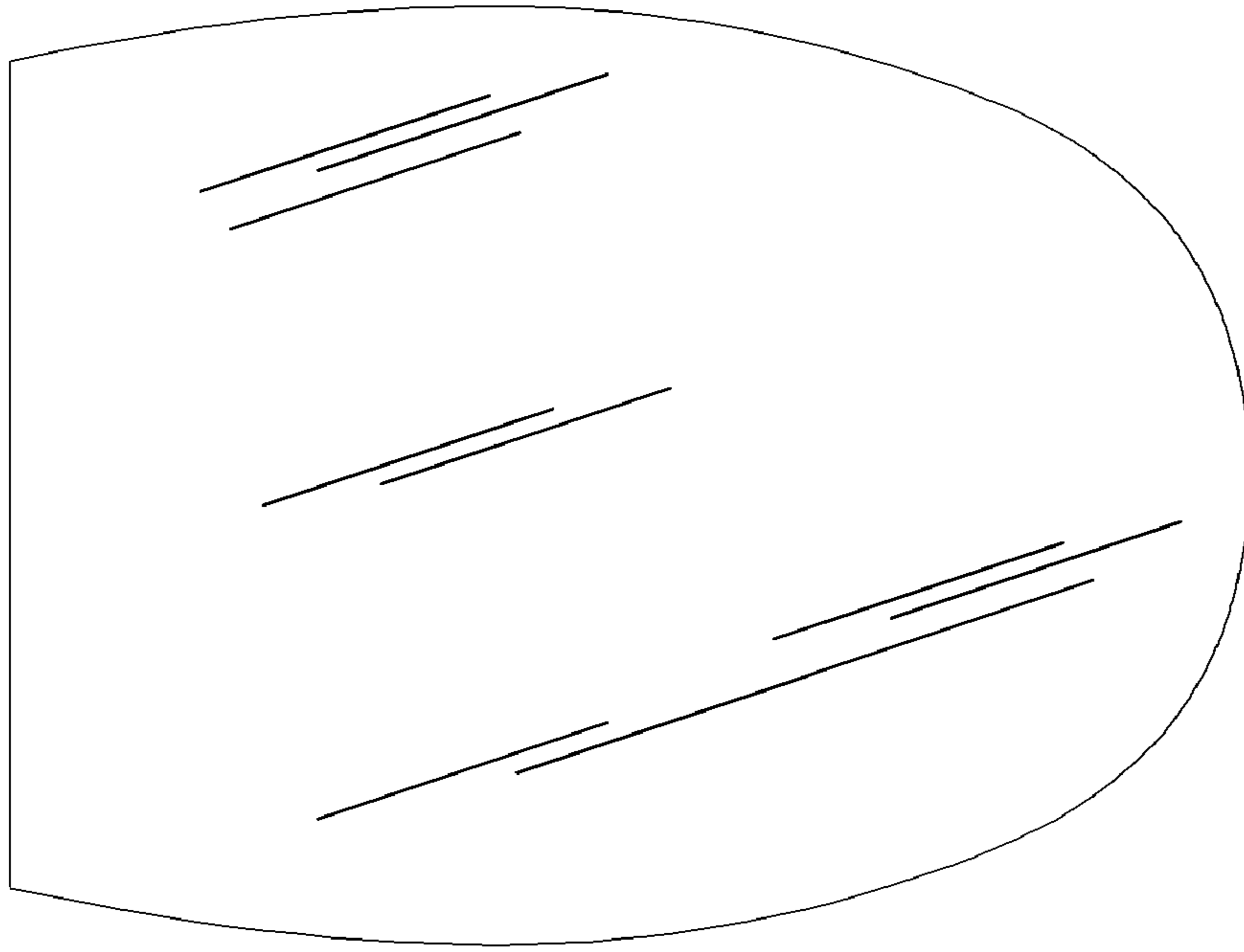

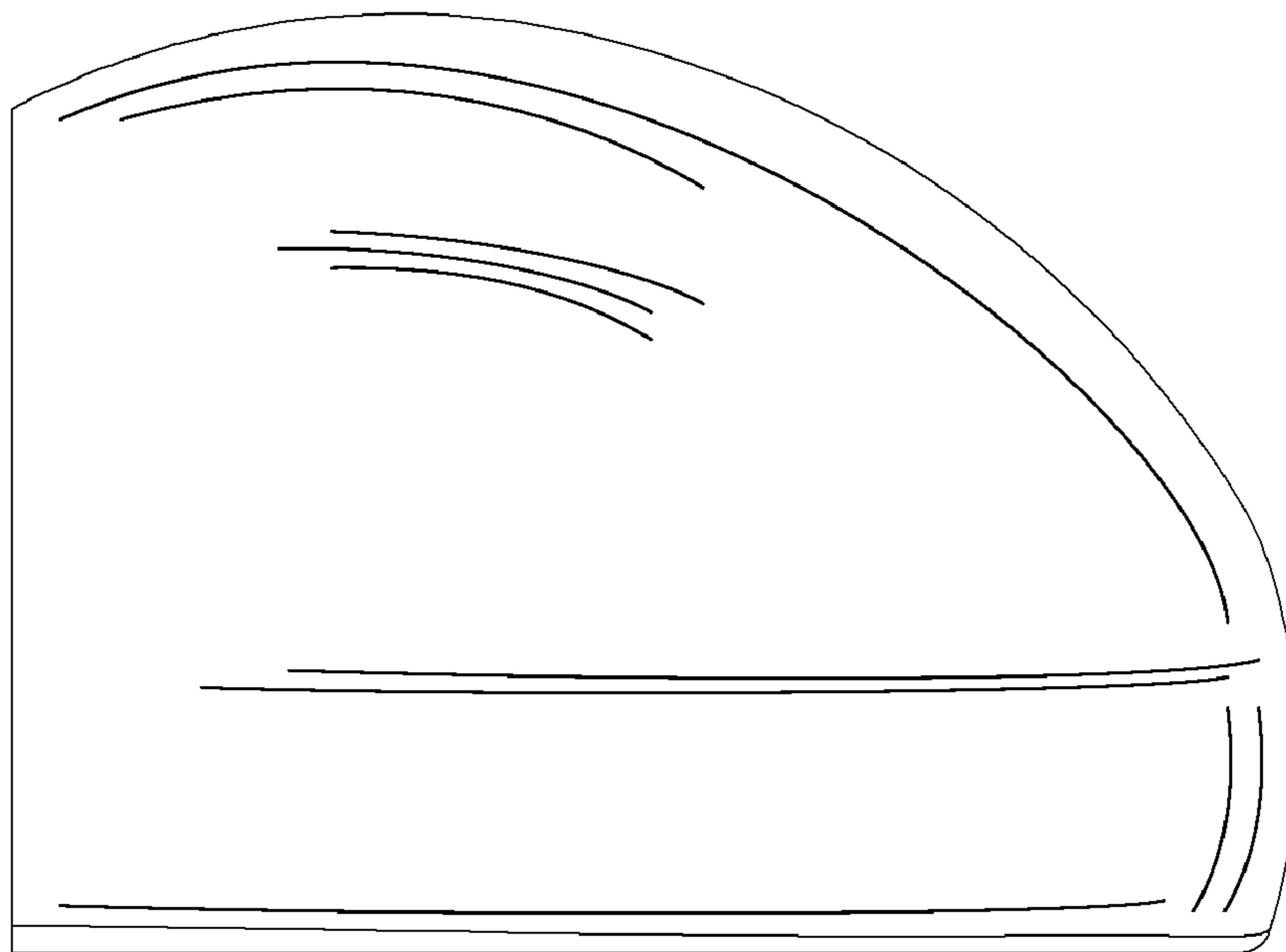
