(57) **CLAIM**

I claim the ornamental design for a mop, as shown and described.

DESCRIPTION

FIG. 1 is a front view showing an embodiment of my new design for a mop;

FIG. 3 is a right side view showing my new design shown in FIG. 1;

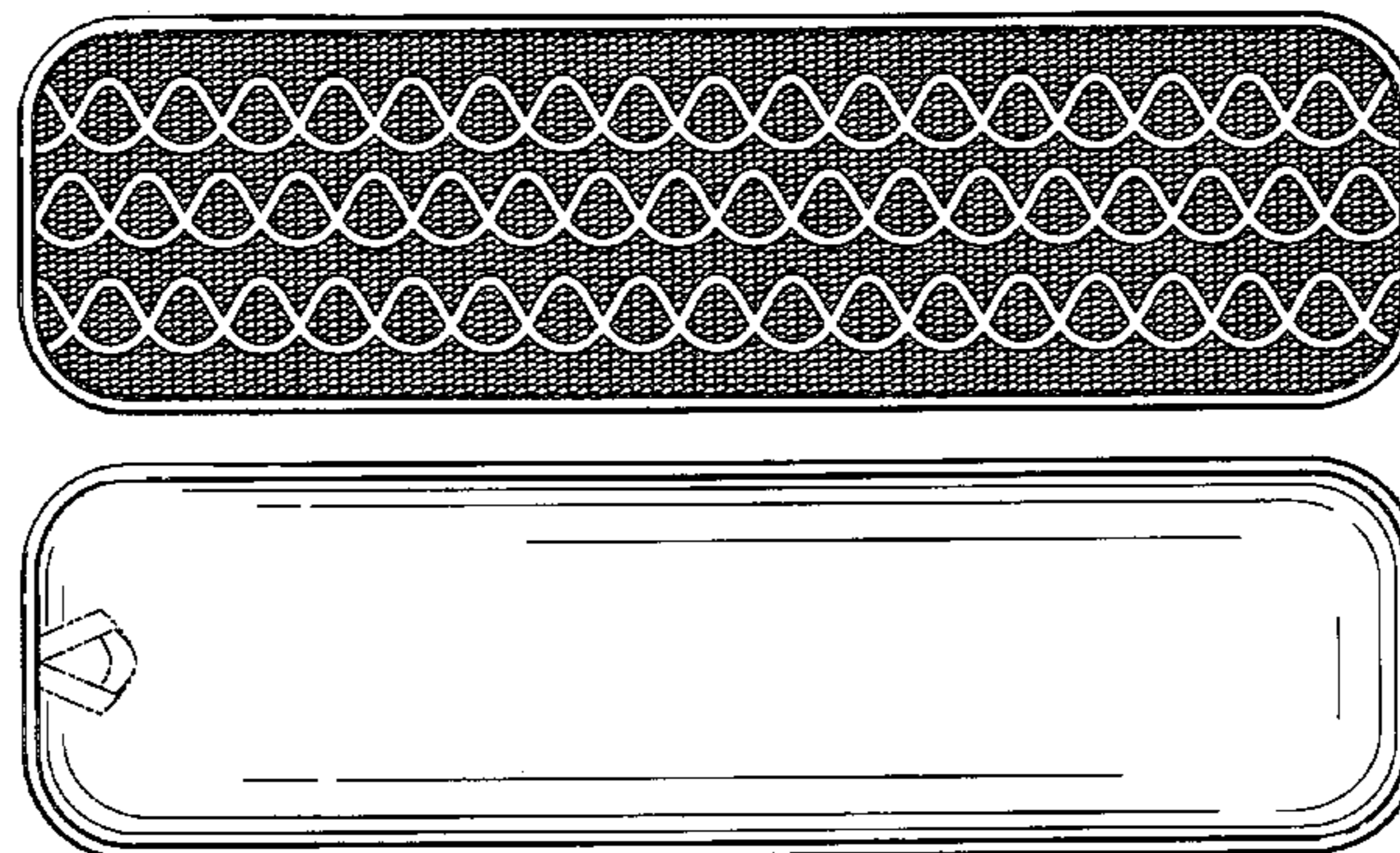
FIG. 4 is a left side view showing my new design shown in FIG. 1;

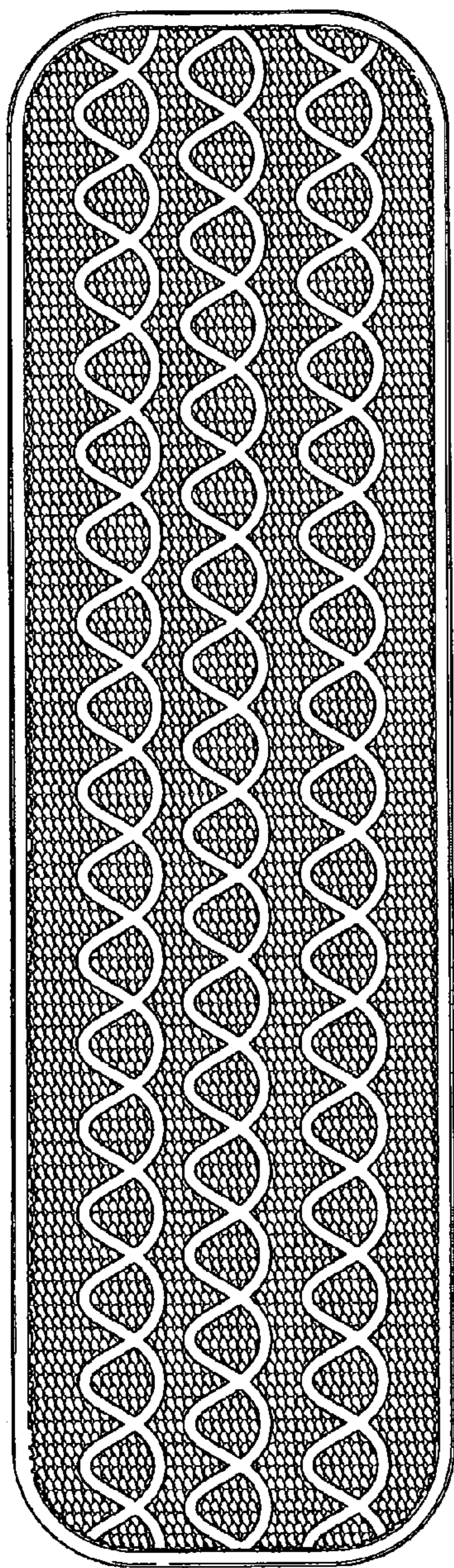

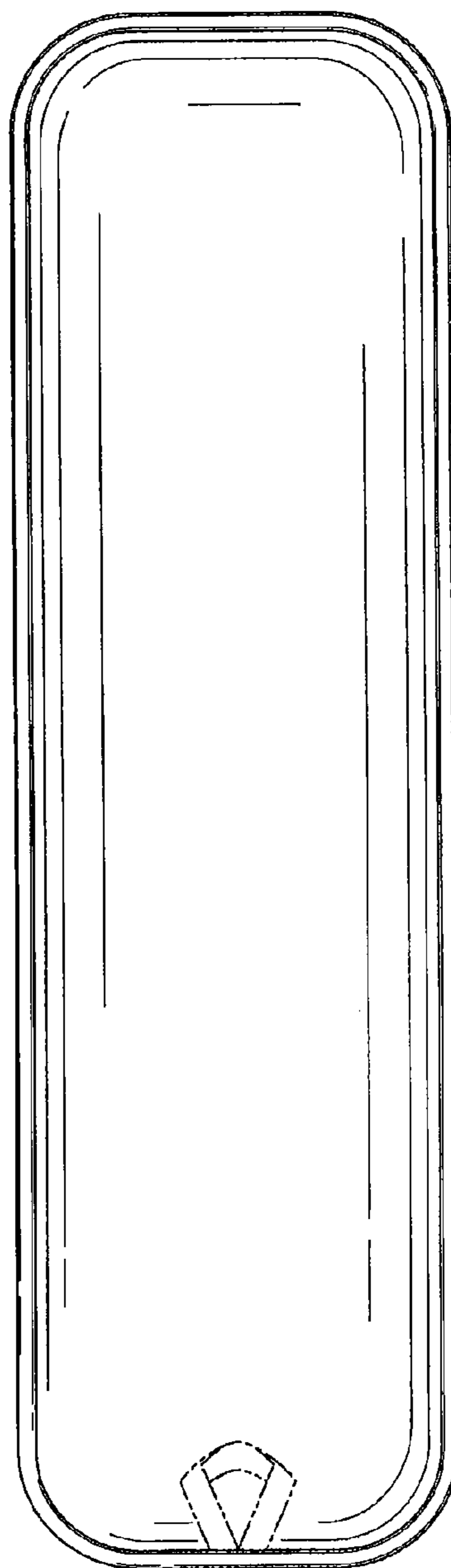

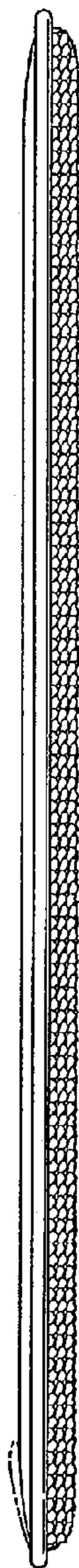

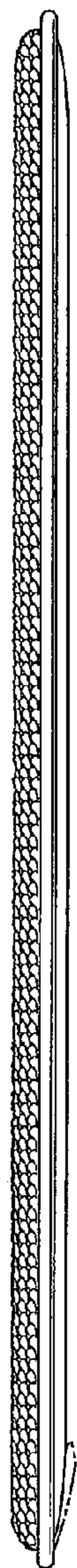
