FIG. 5 is a front view of the claimed design of FIG. 1;

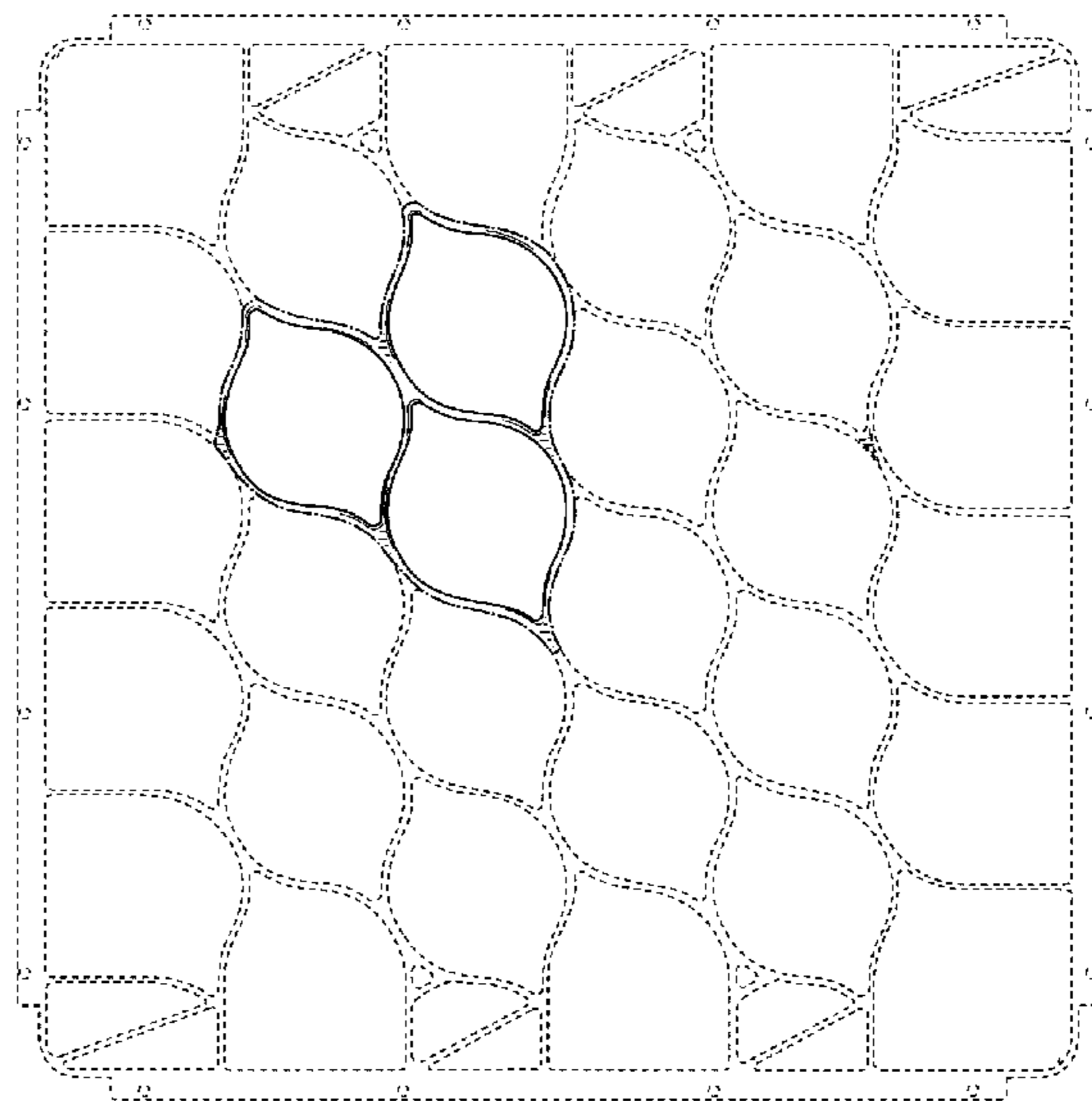
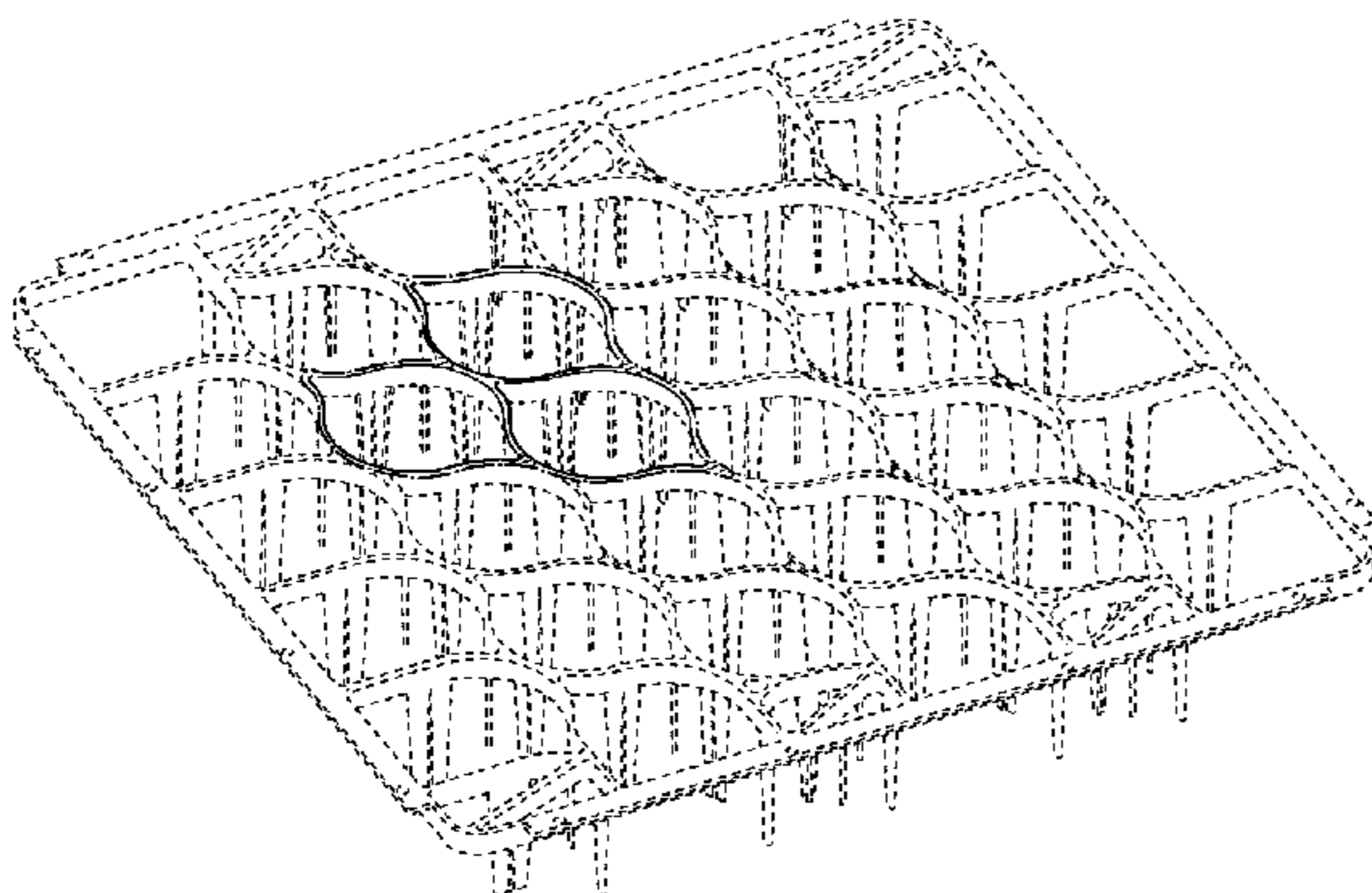
FIG. 6 is a rear view of the claimed design of FIG. 1;

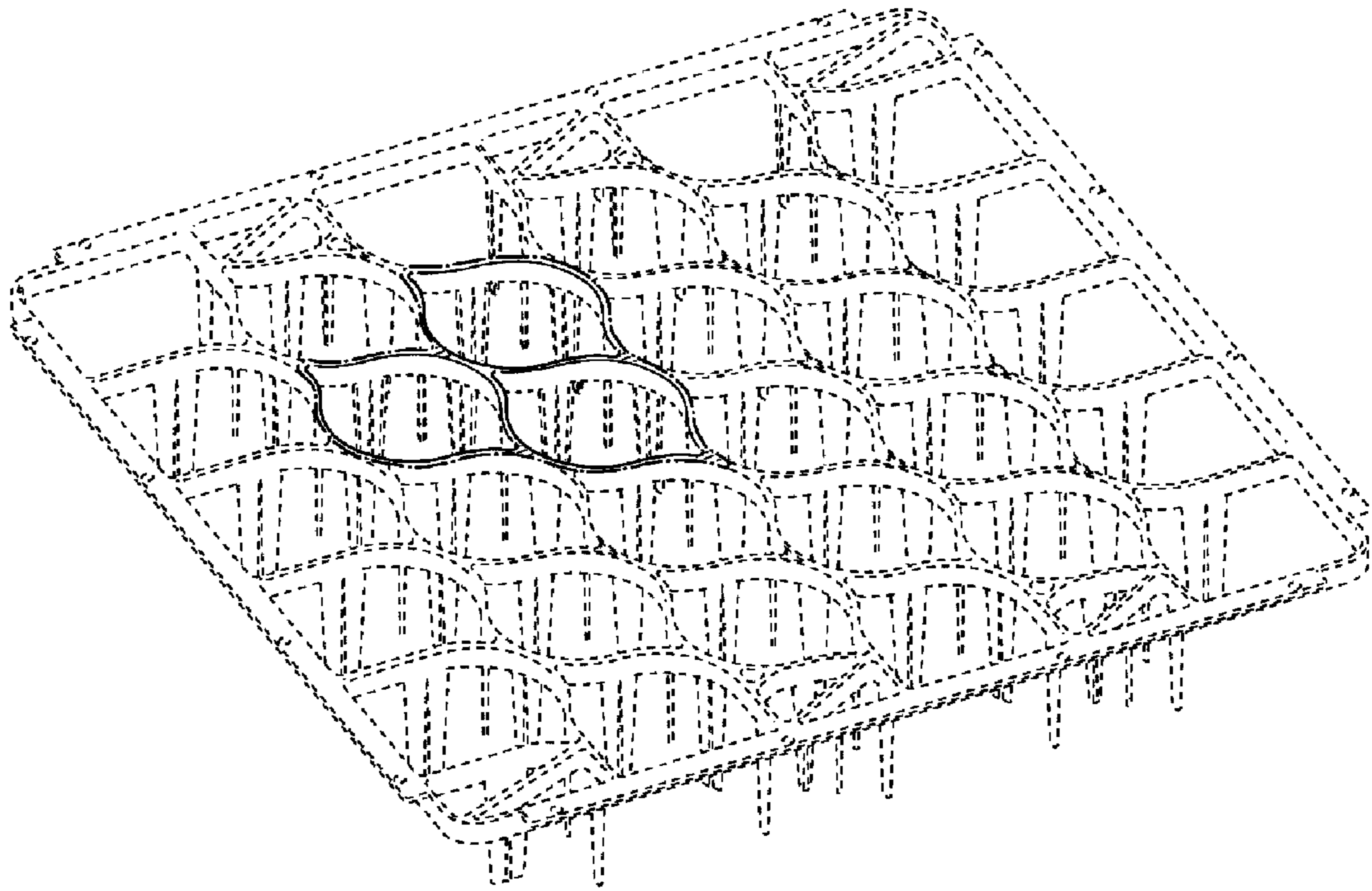

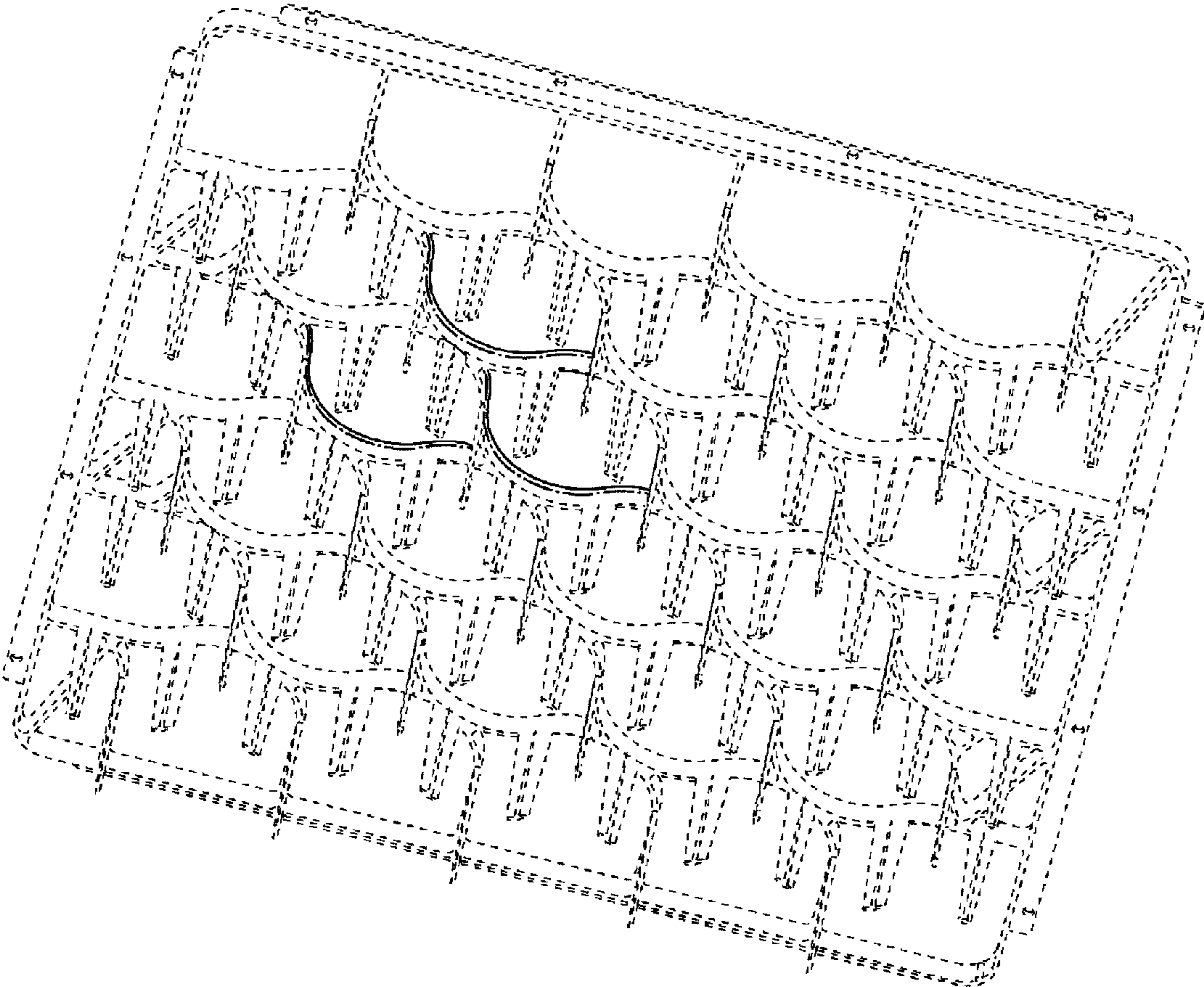

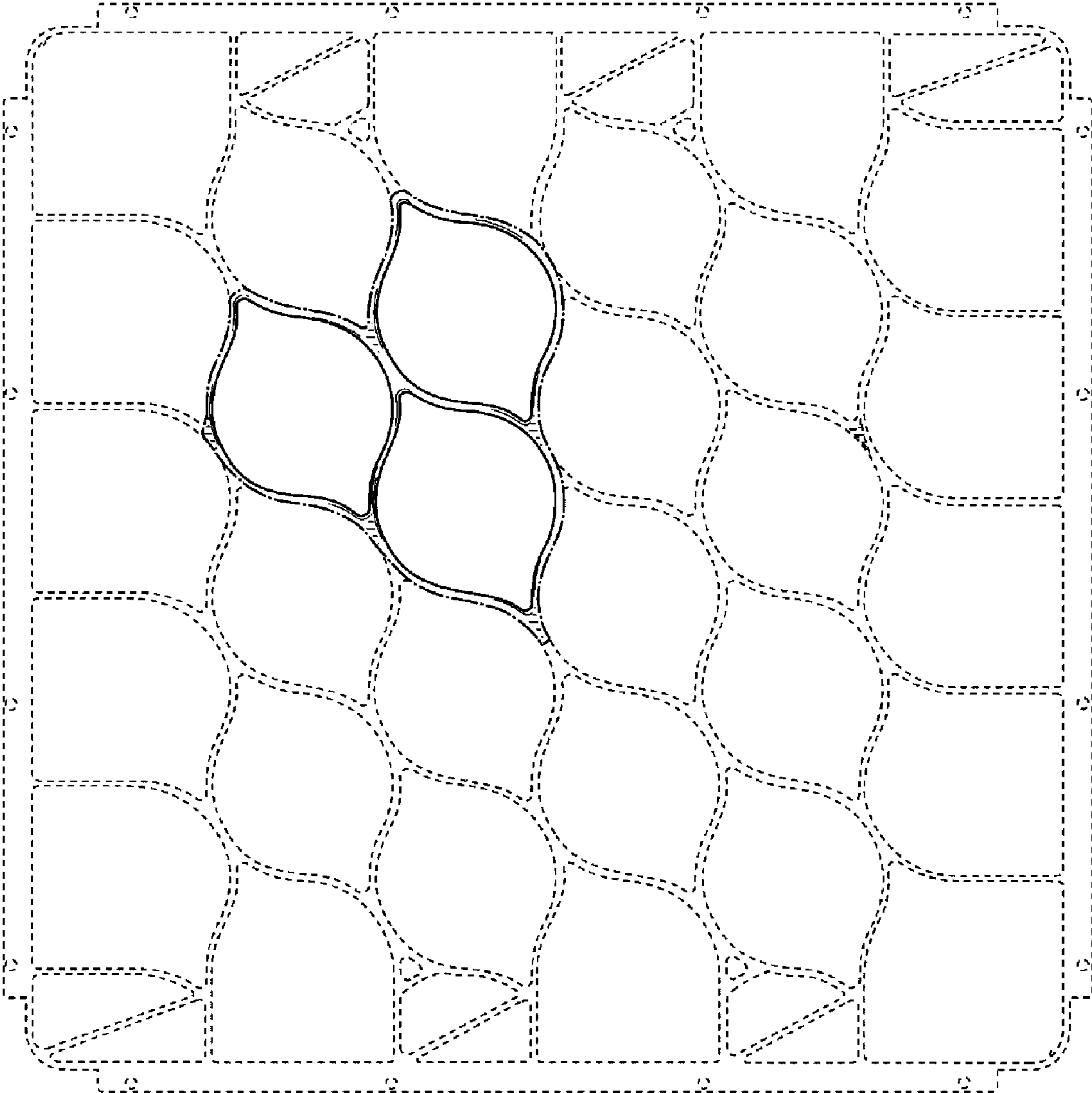

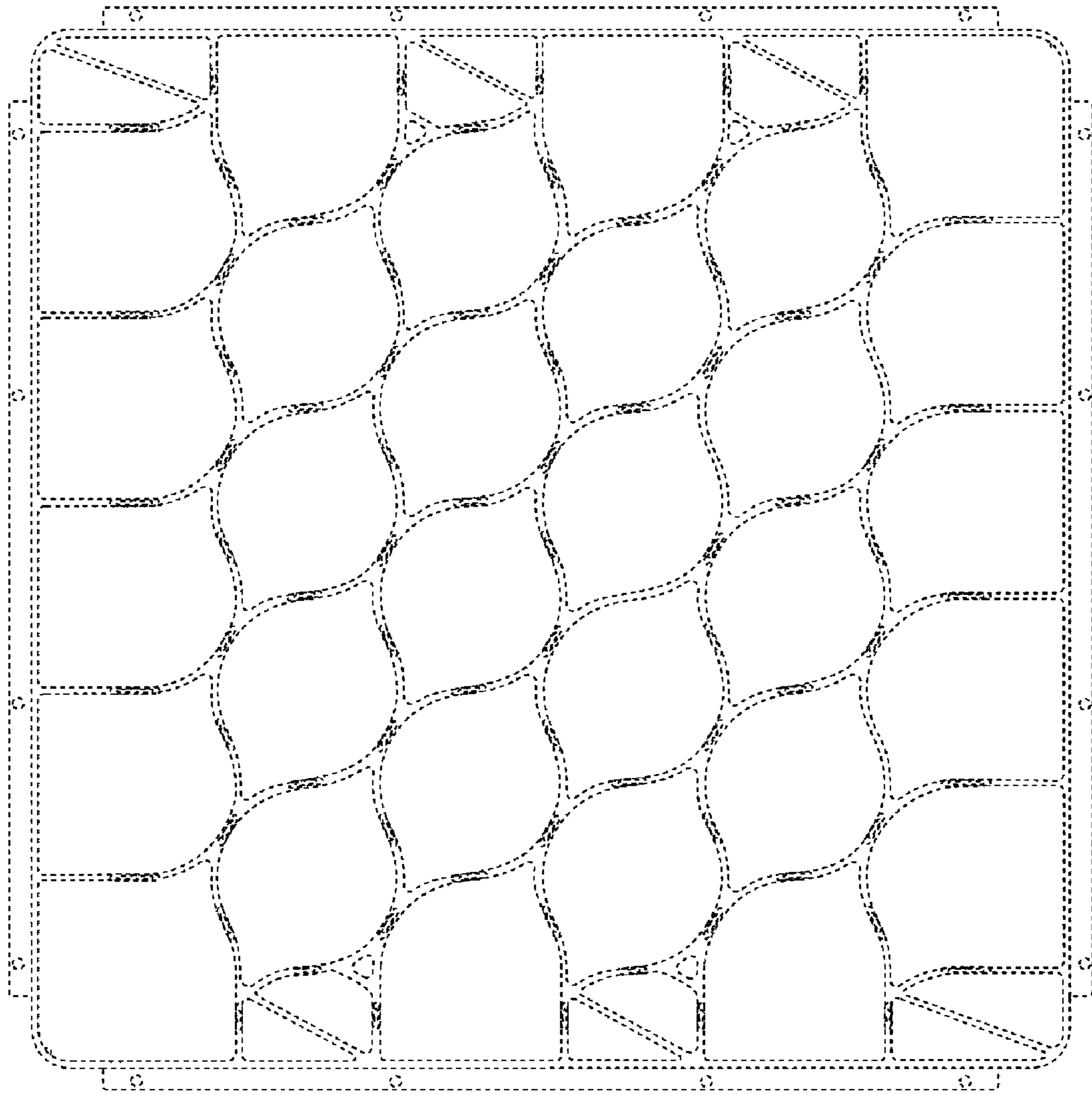

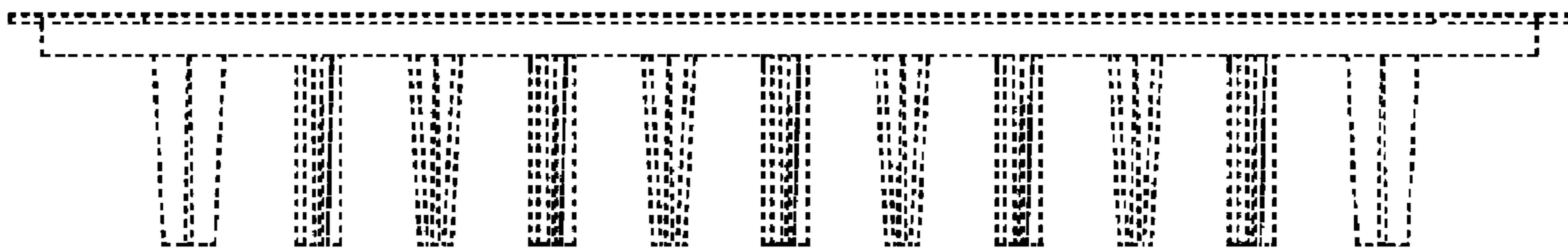

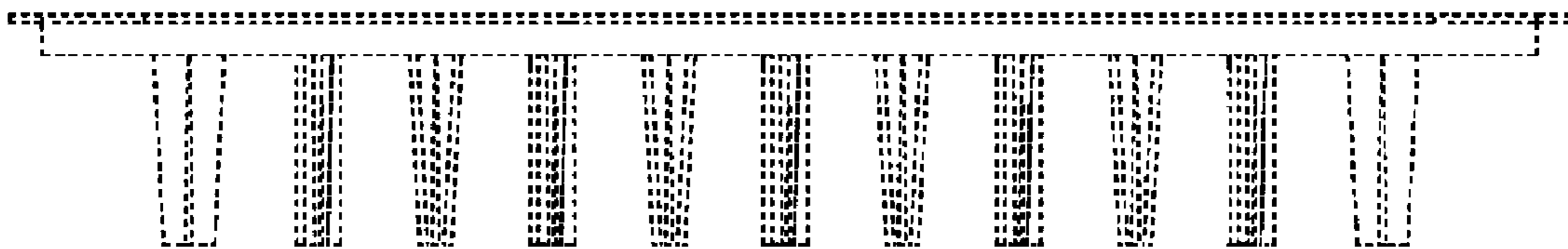

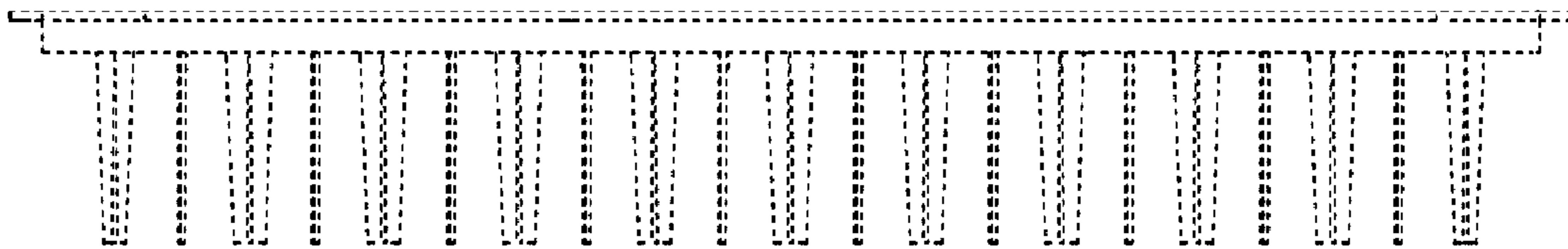

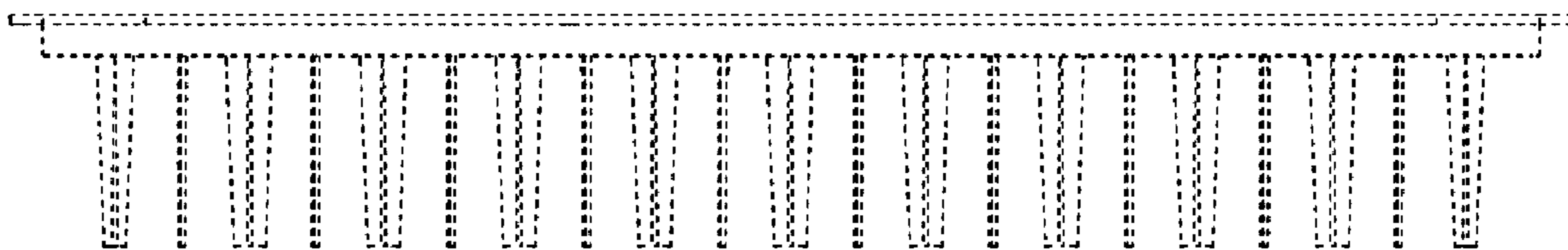
