FIG. 10 is a rear view of the design shown in FIG. 8;

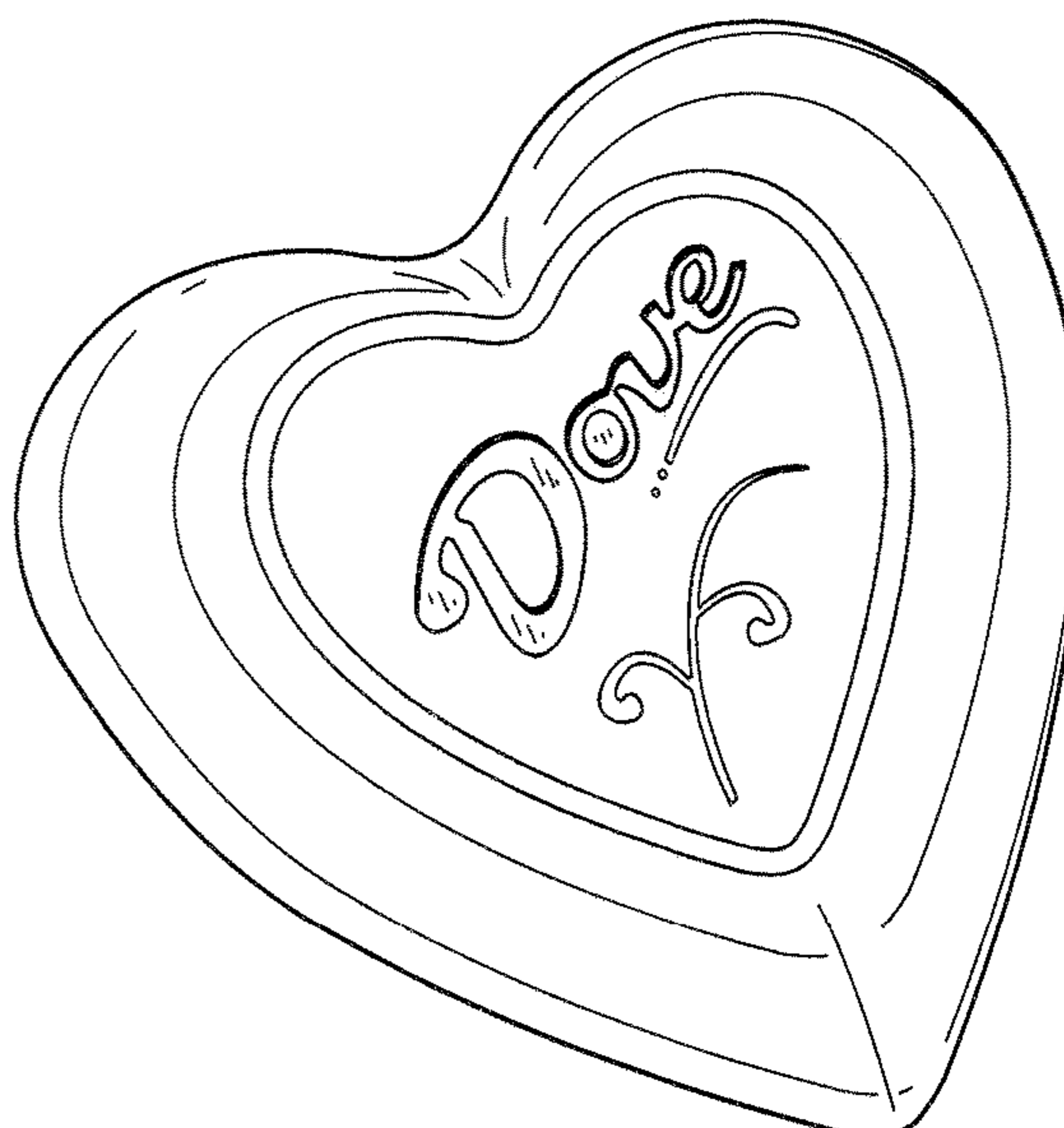
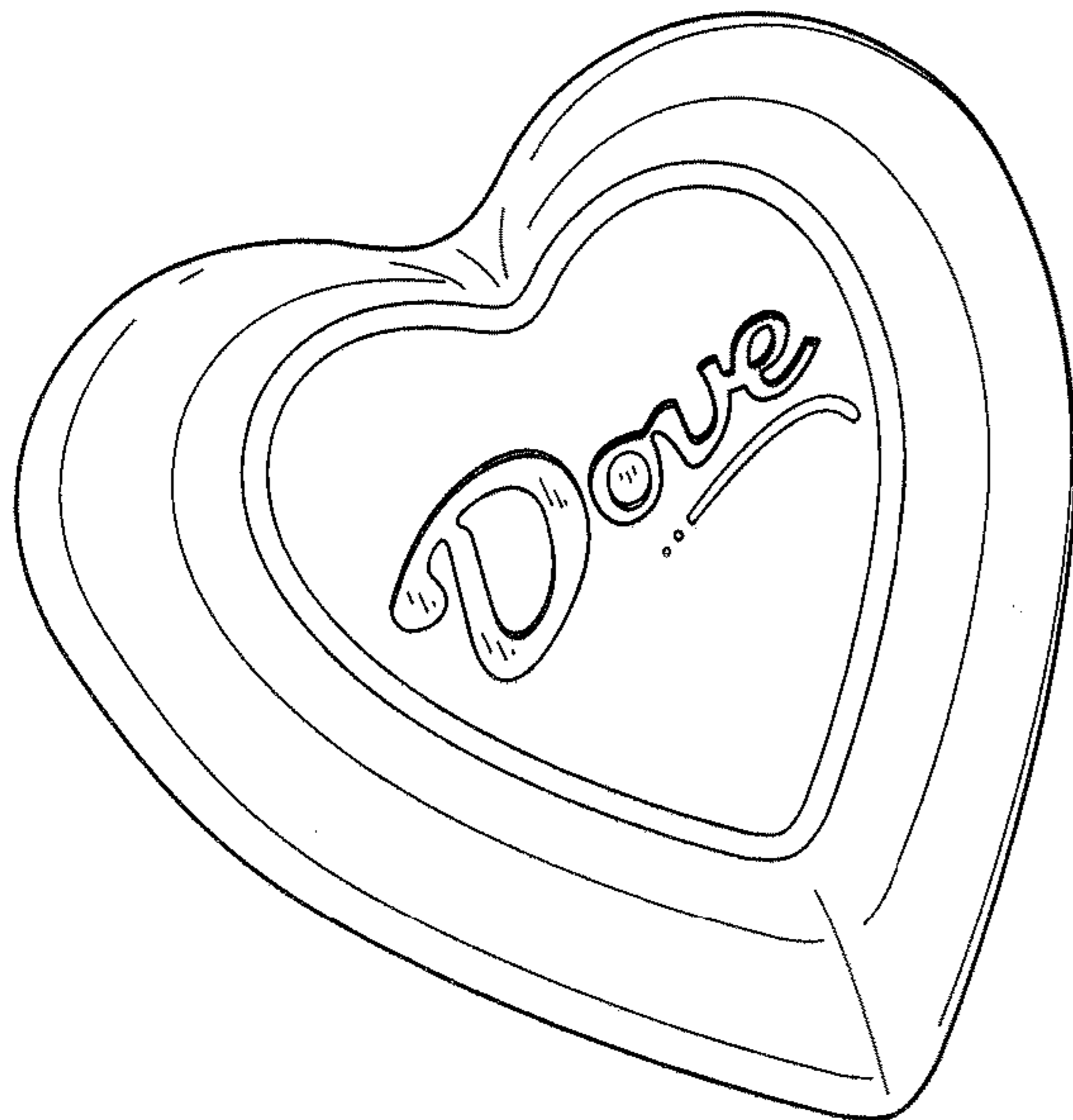
FIG. 11 is a left side view of the design shown in FIG. 8;

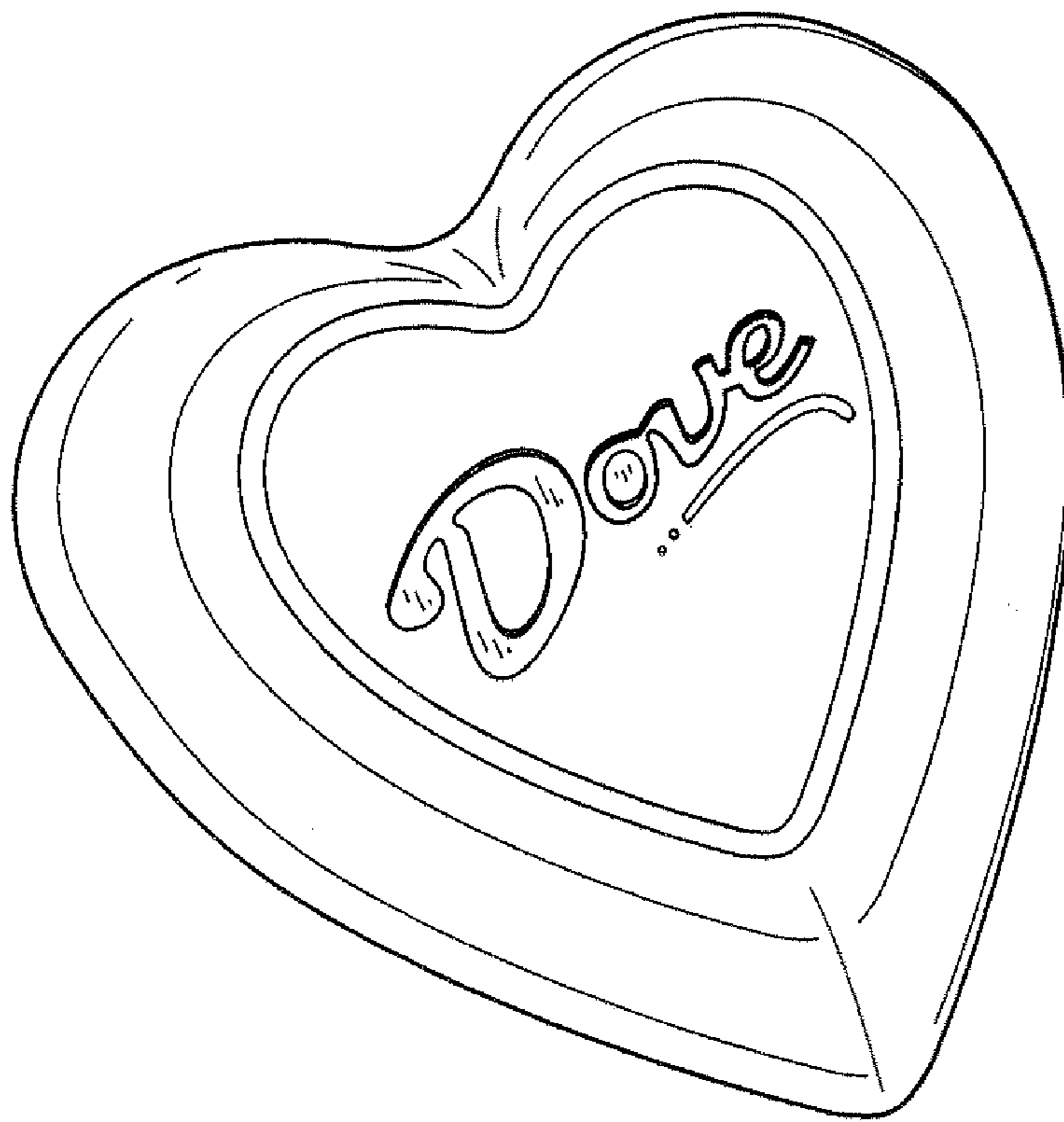

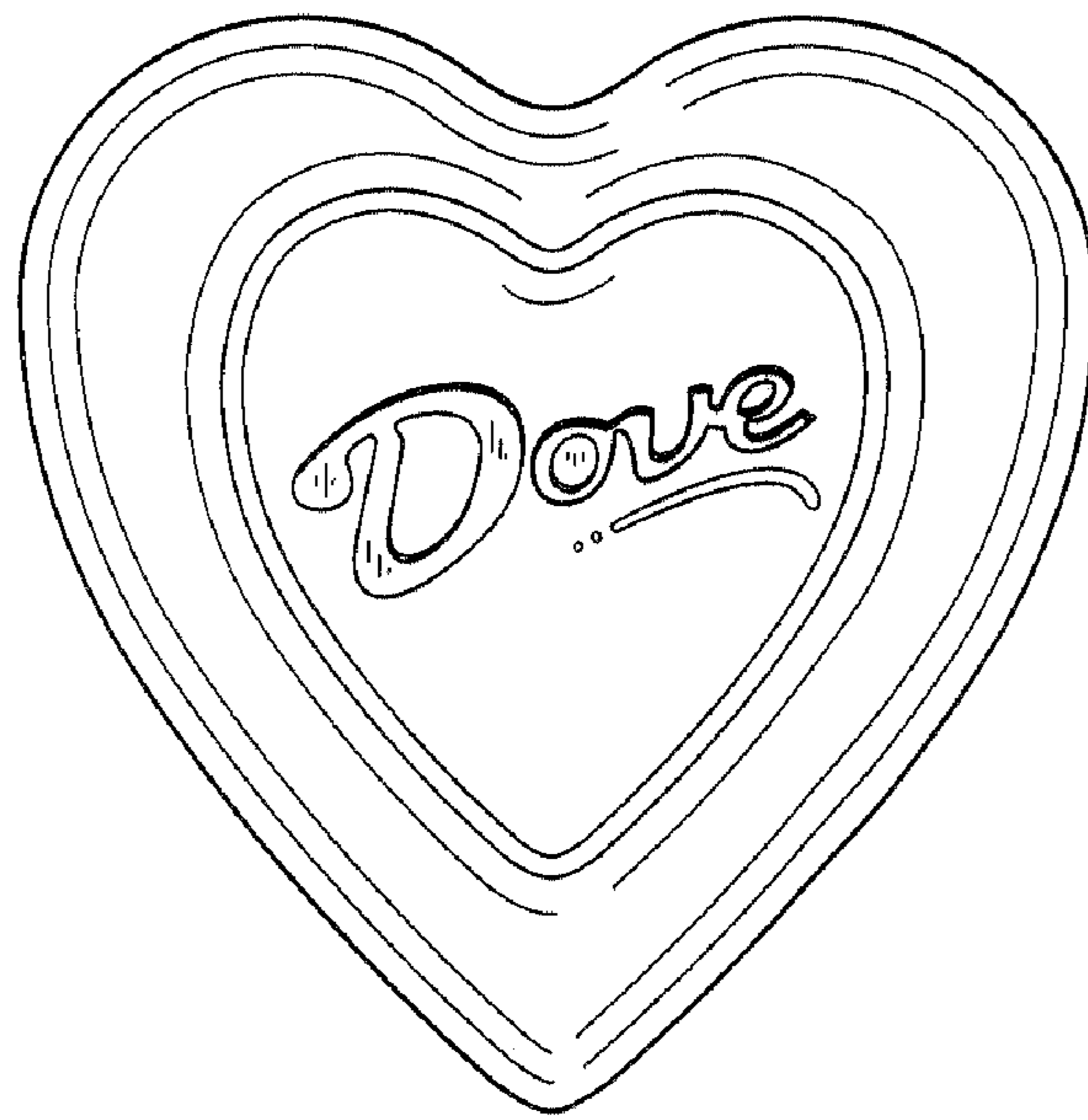

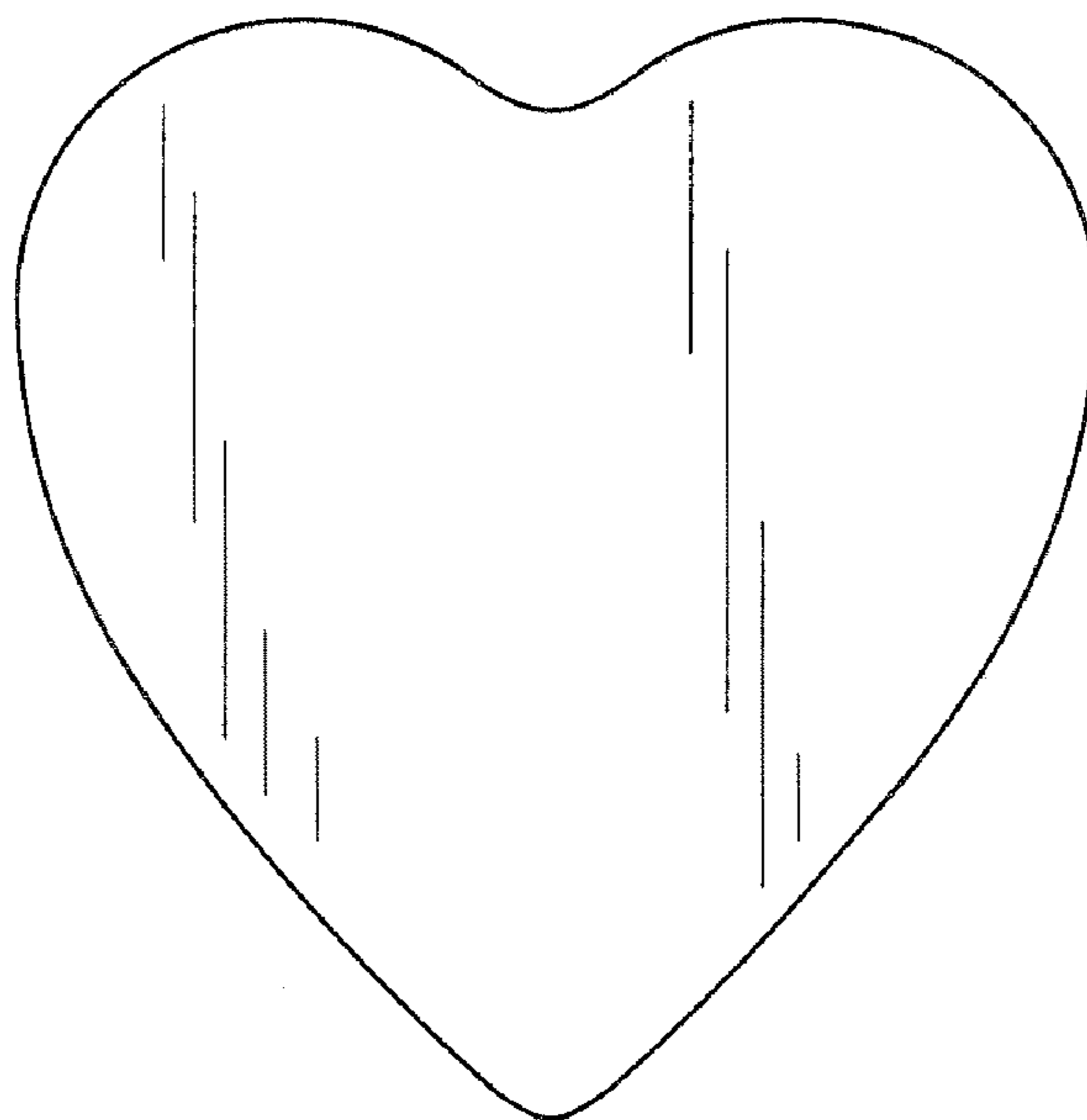

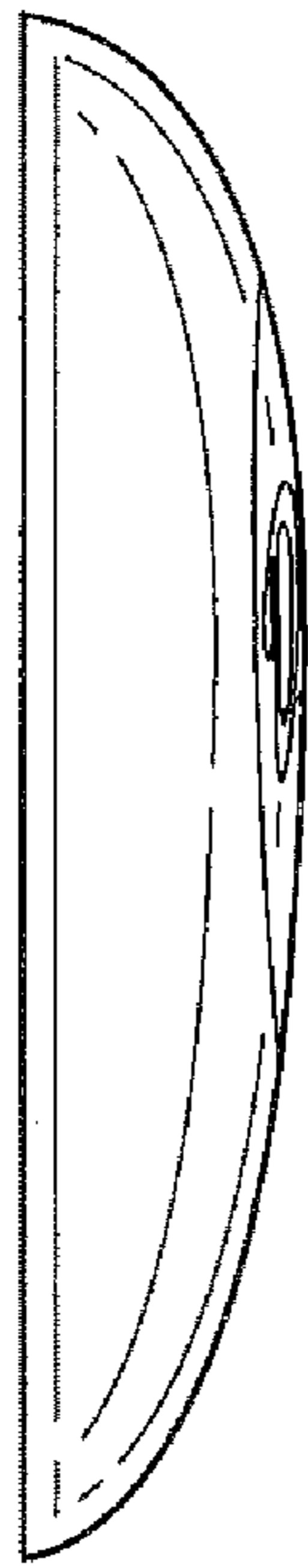

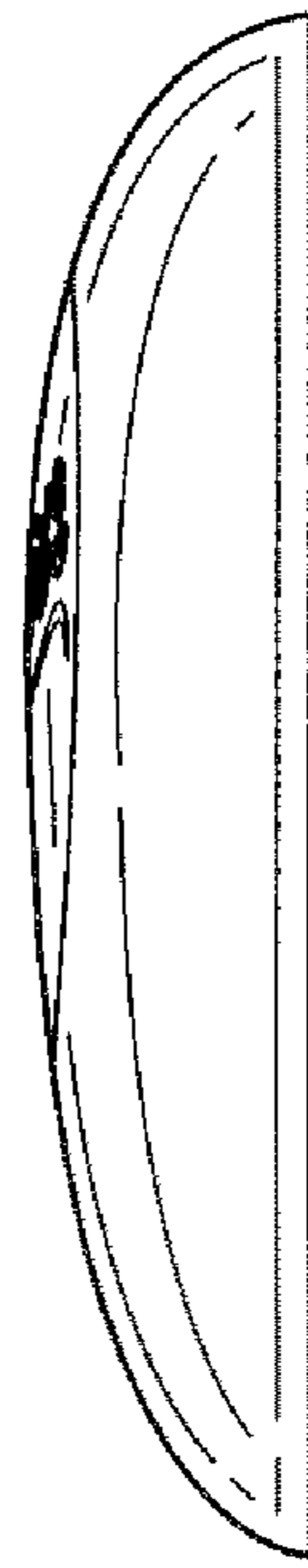

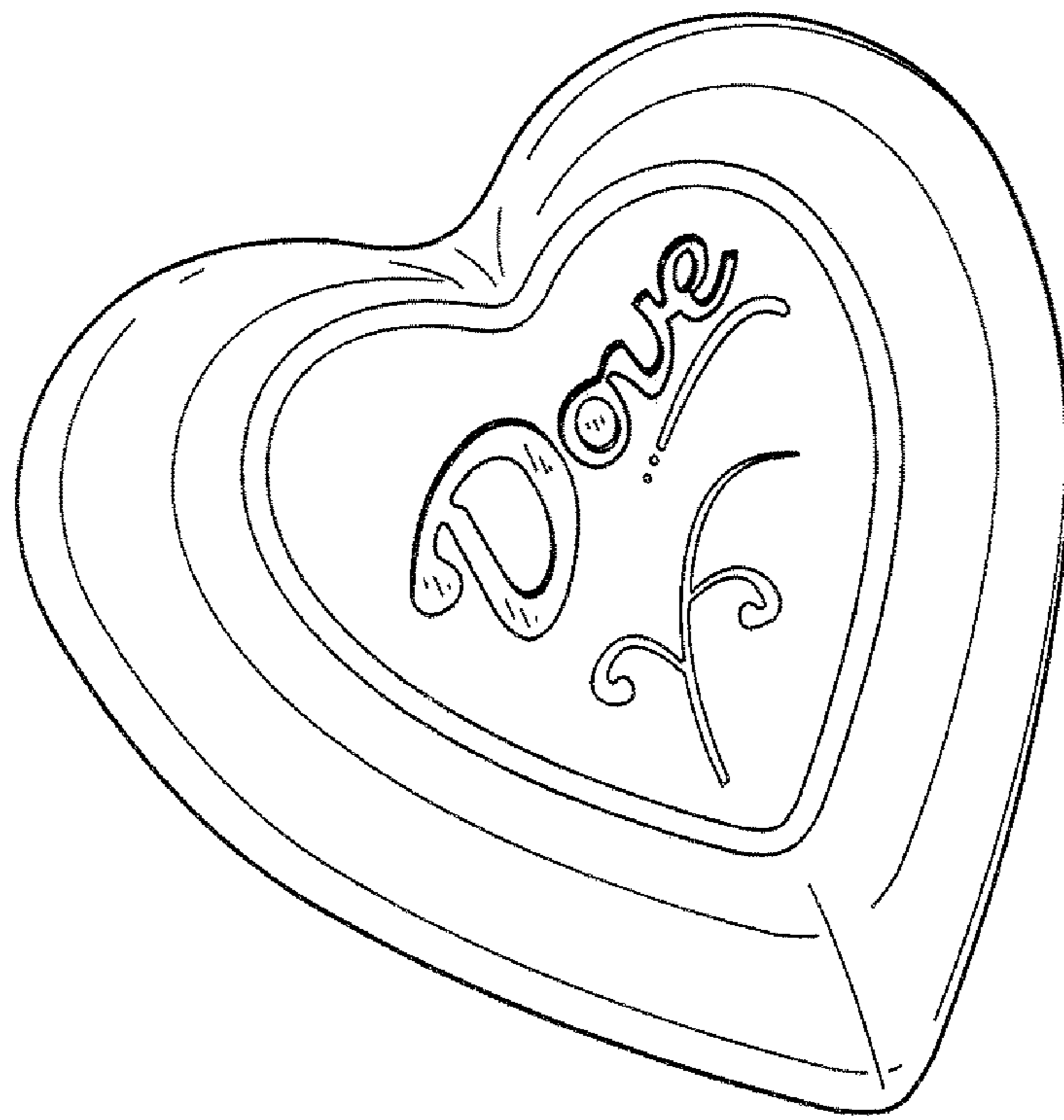

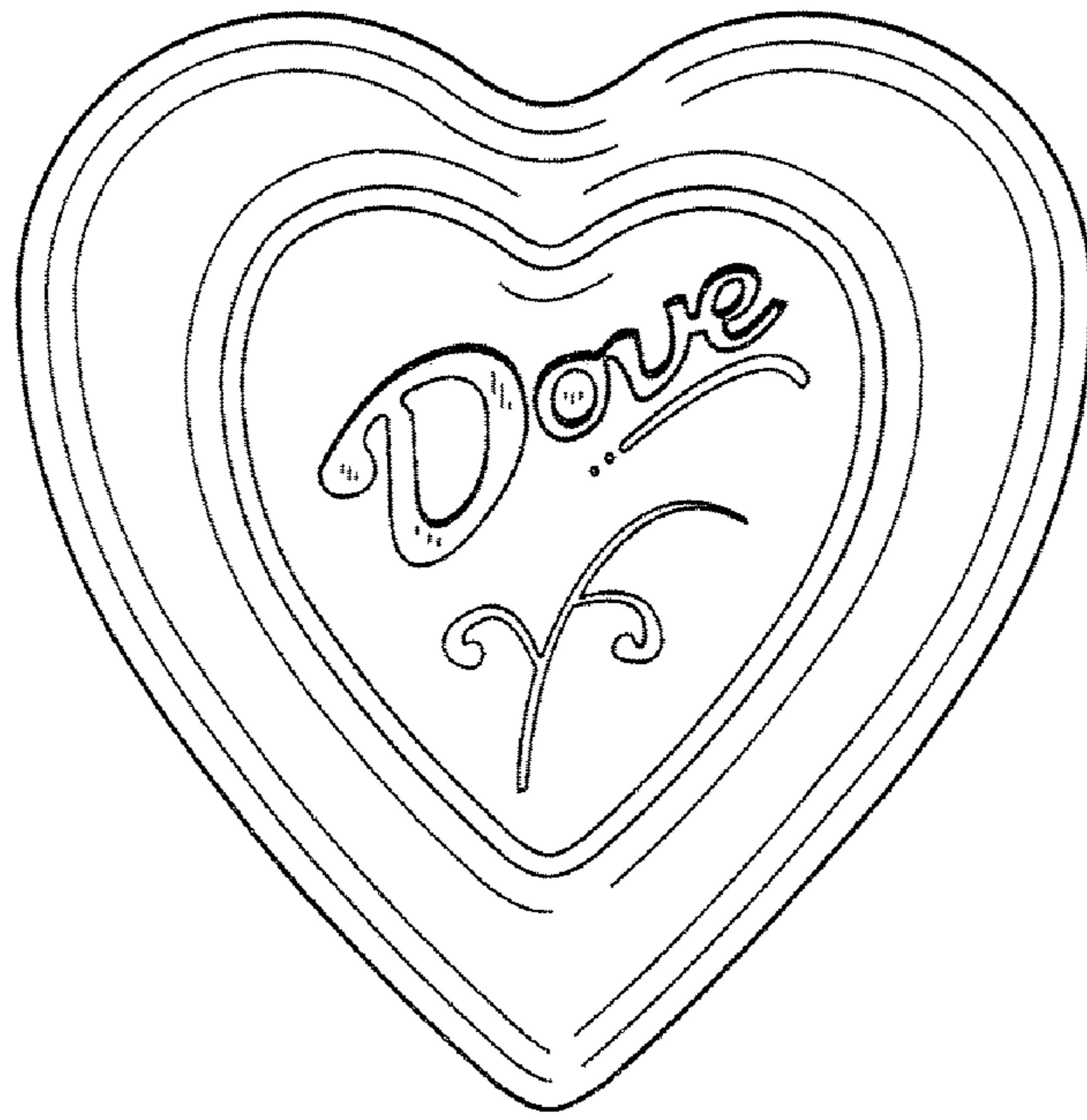

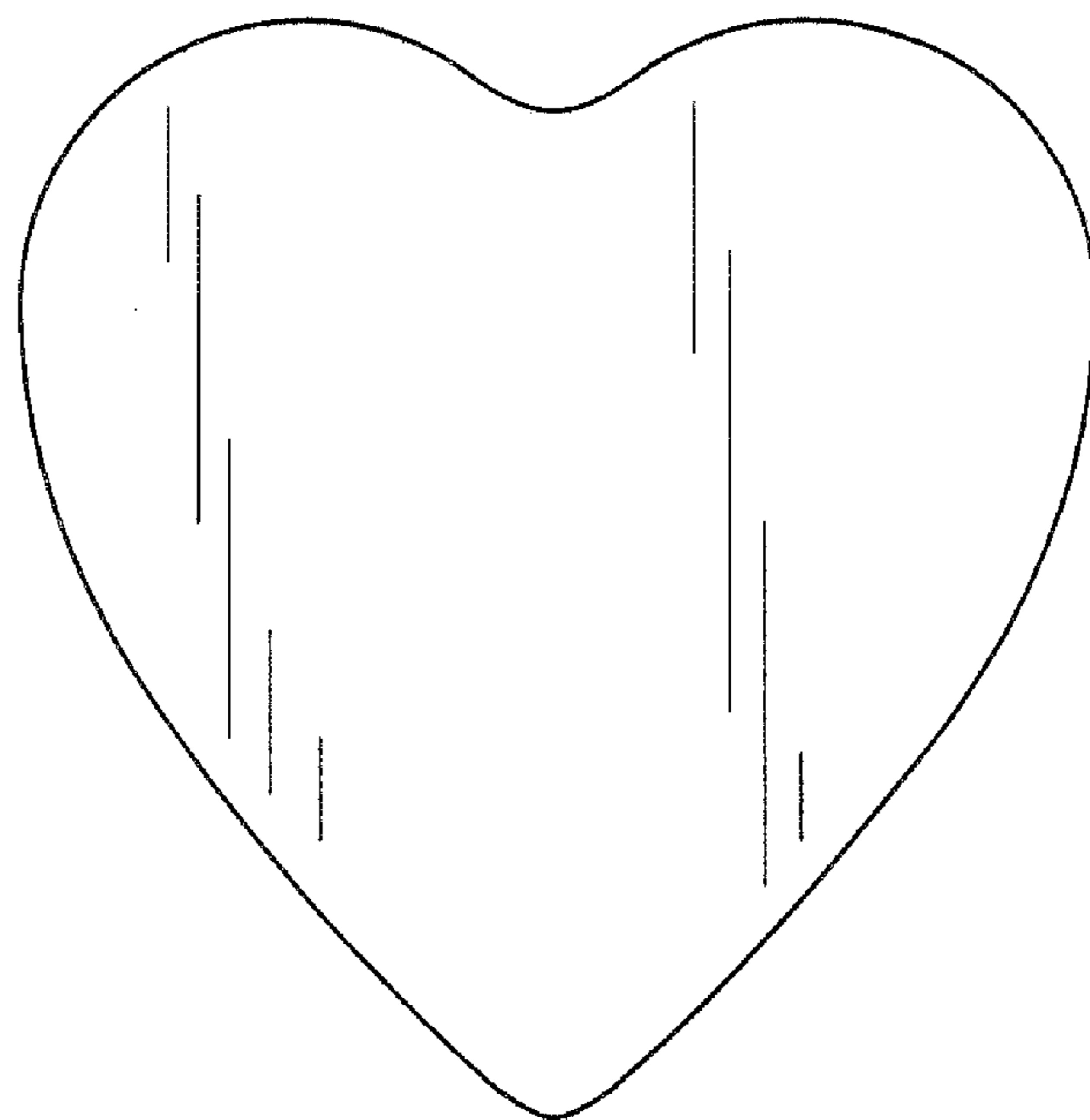

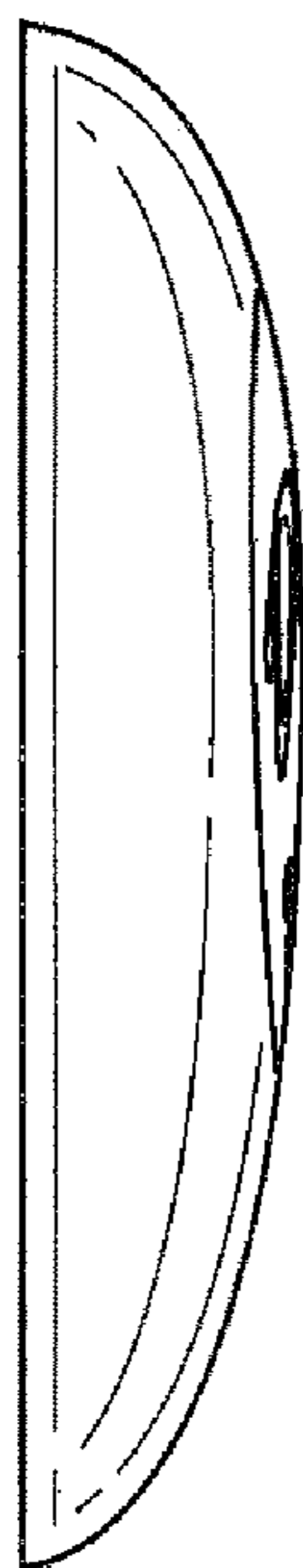
