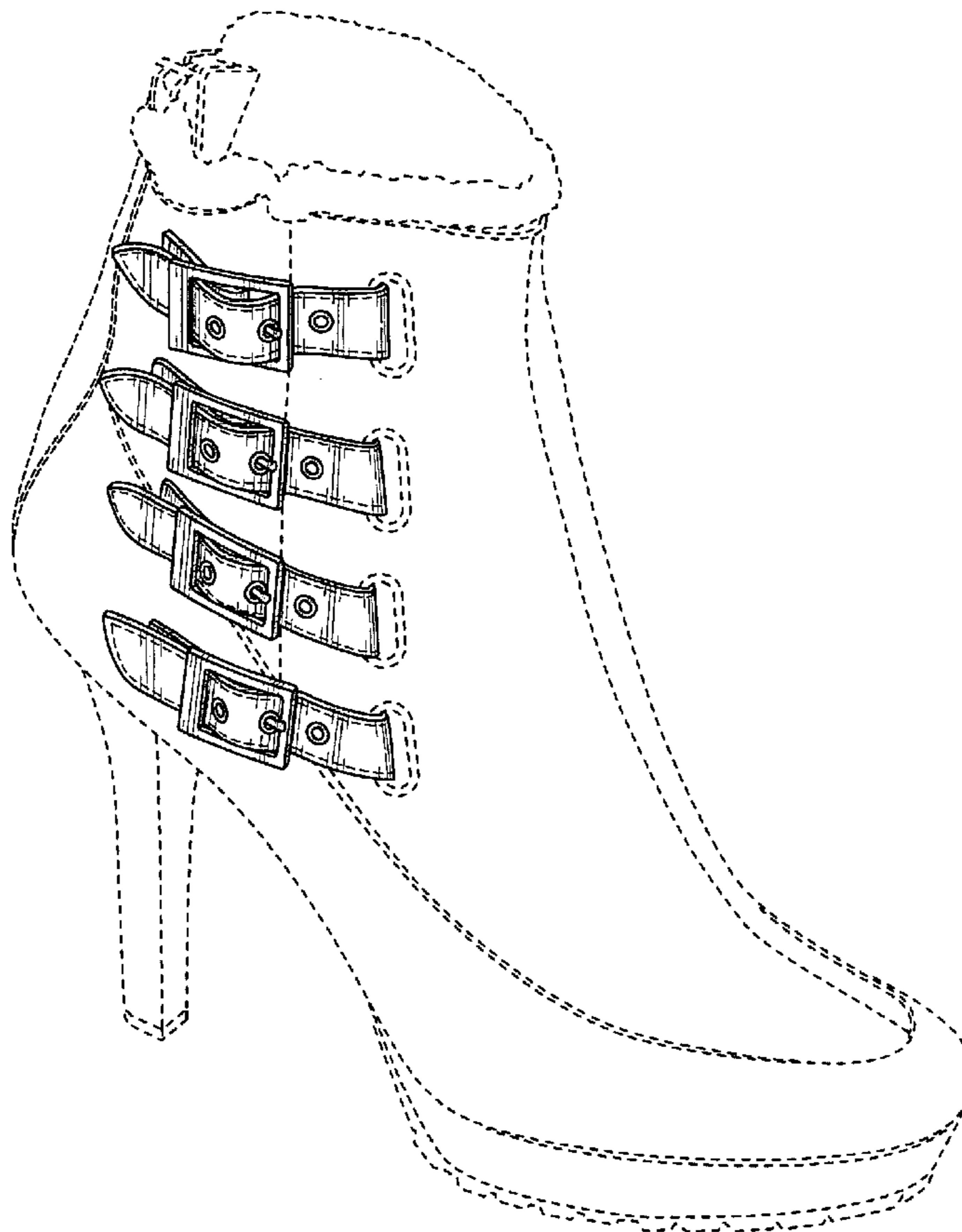
(57) **CLAIM**

The ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my footwear design;
FIG. 2 is a left side view of the footwear shown in FIG. 1;
FIG. 3 is a right side view of the footwear shown in FIG. 1;
FIG. 4 is a front view of the footwear shown in FIG. 1;
FIG. 5 is a rear view of the footwear shown in FIG. 1; and,
FIG. 6 is a top view of the footwear shown in FIG. 1.
The broken line showing of the sole, platform sole, lining, zipper, zipper cover, heel, heel cap, stitching, portions of the shoe upper, and eyelet holes is for illustrative purposes only and forms no part of the claimed design.

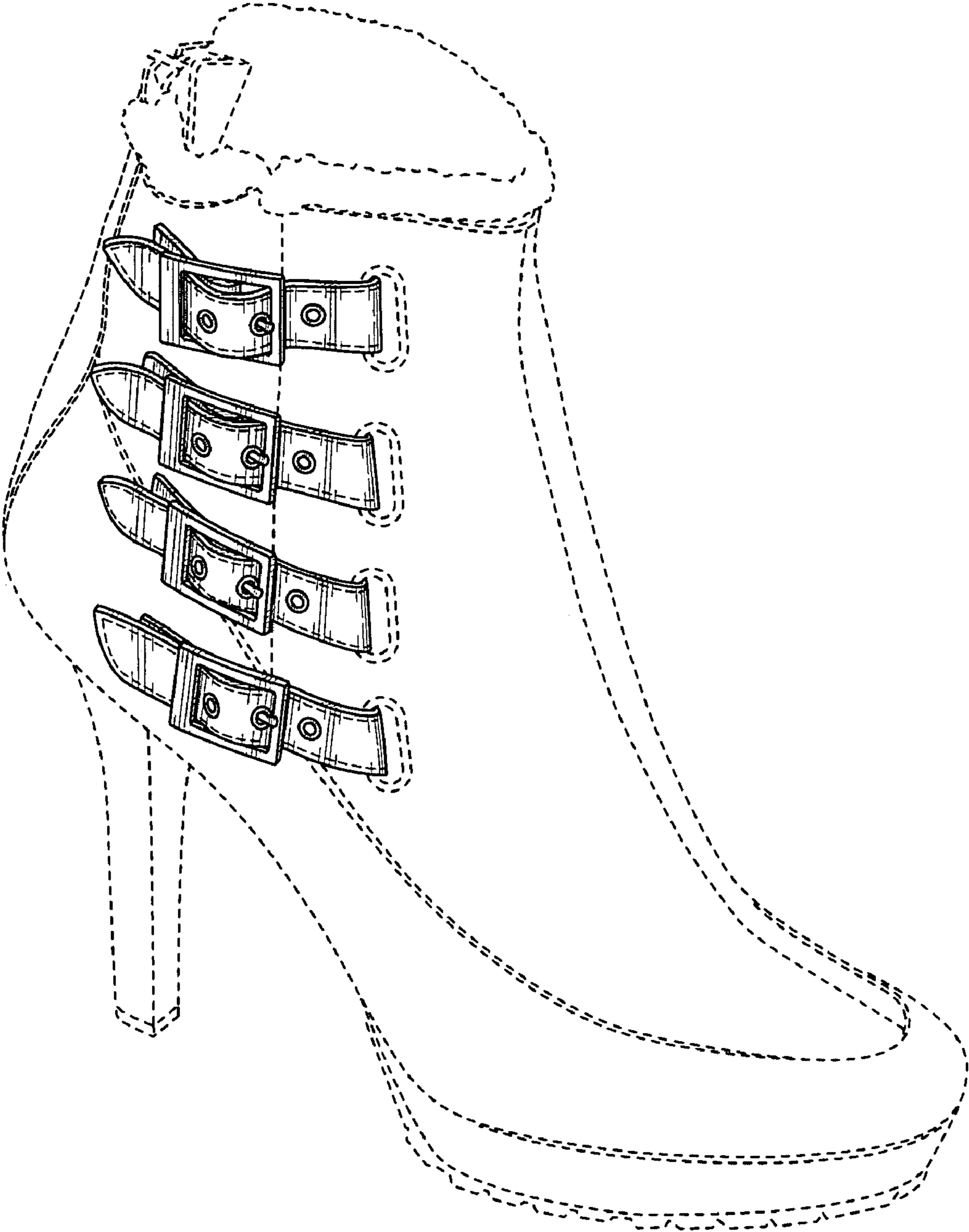

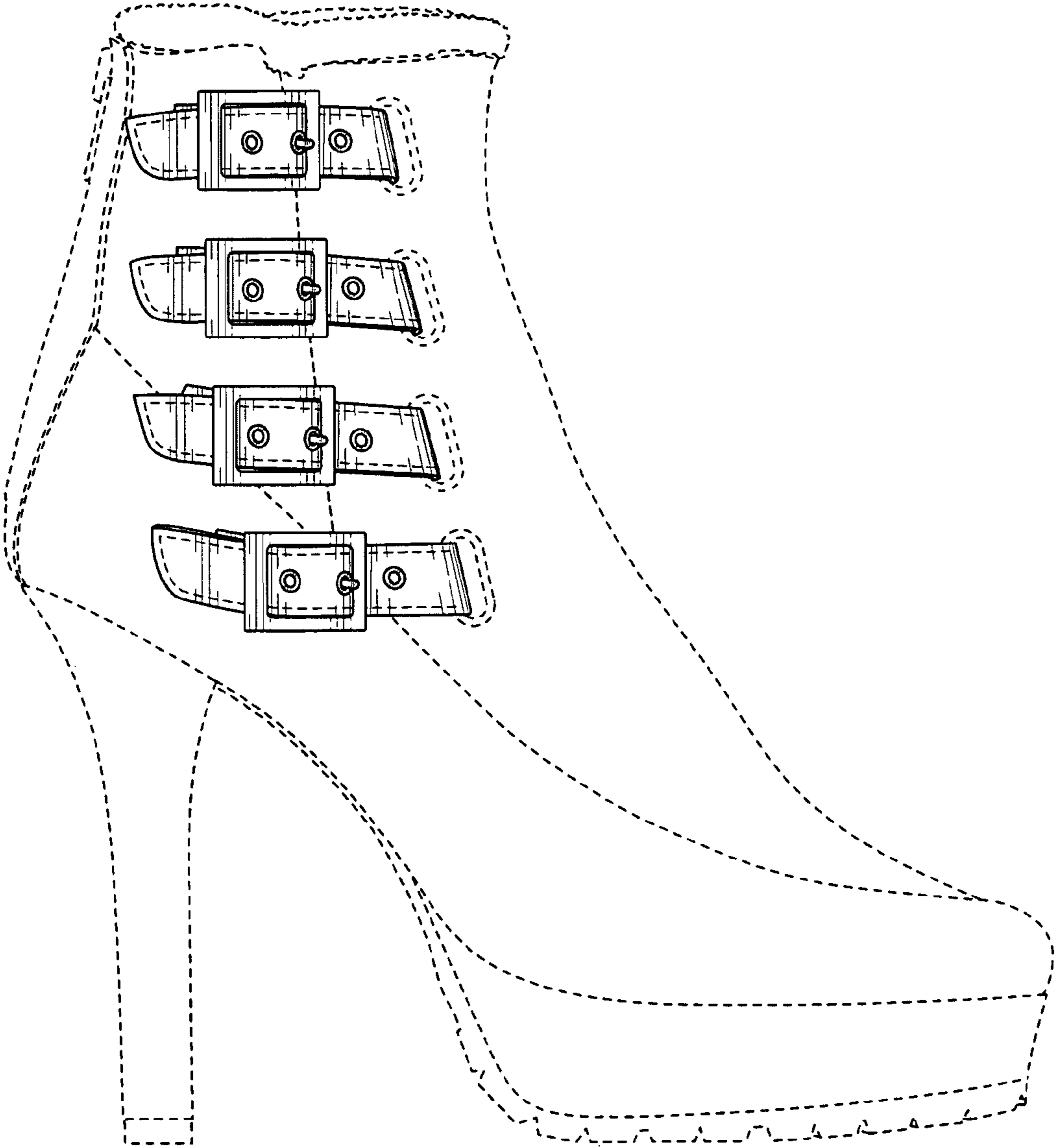

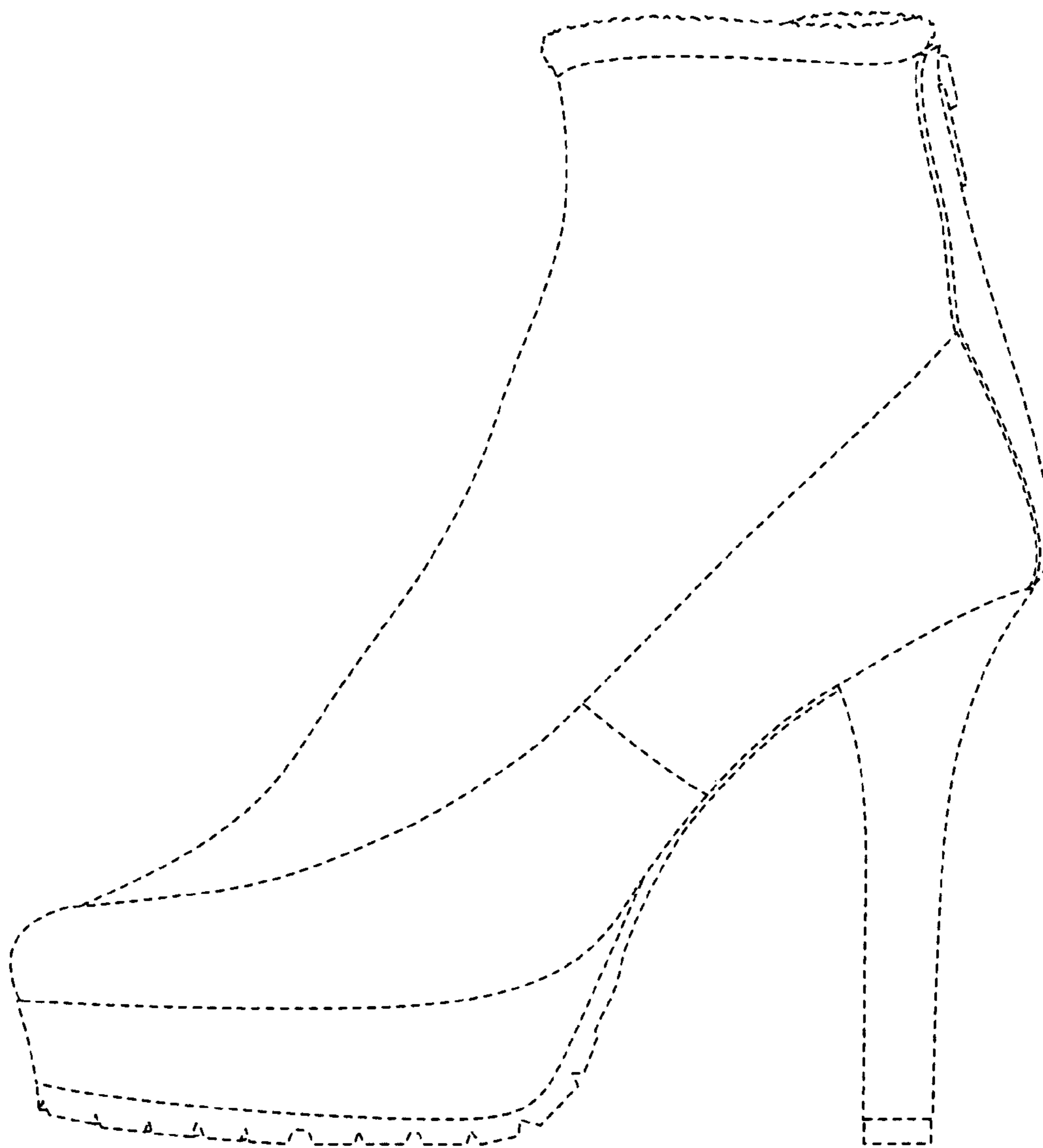

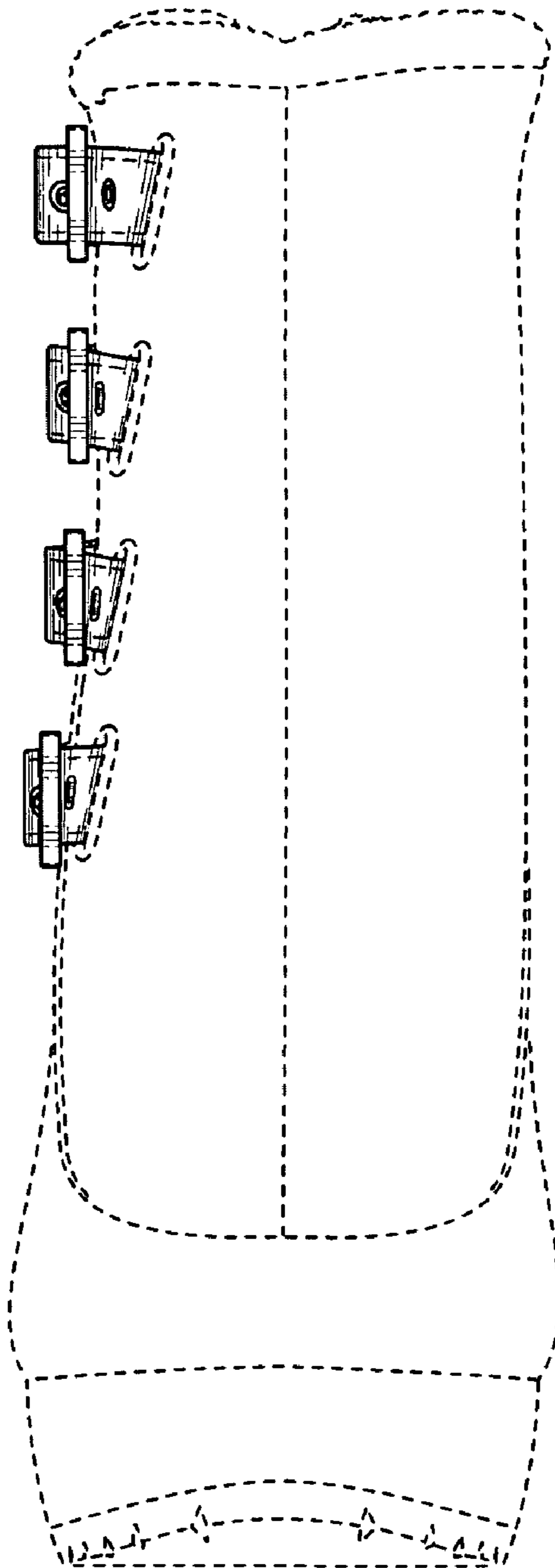

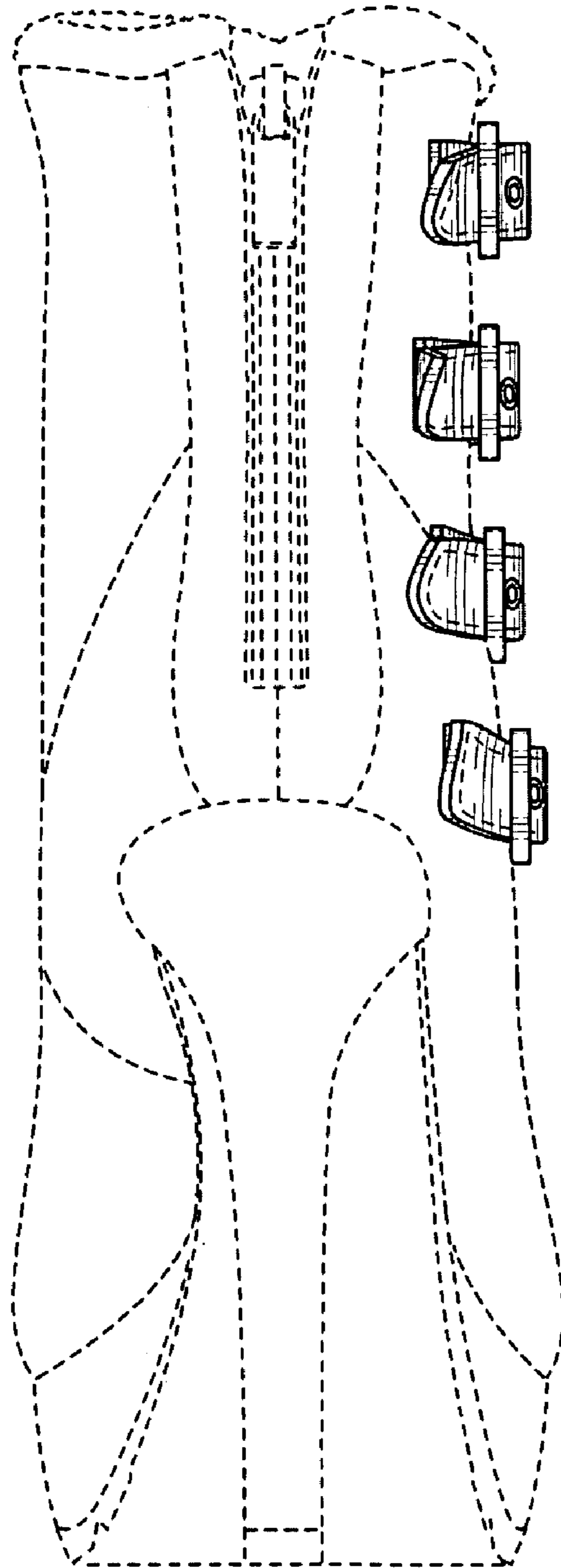

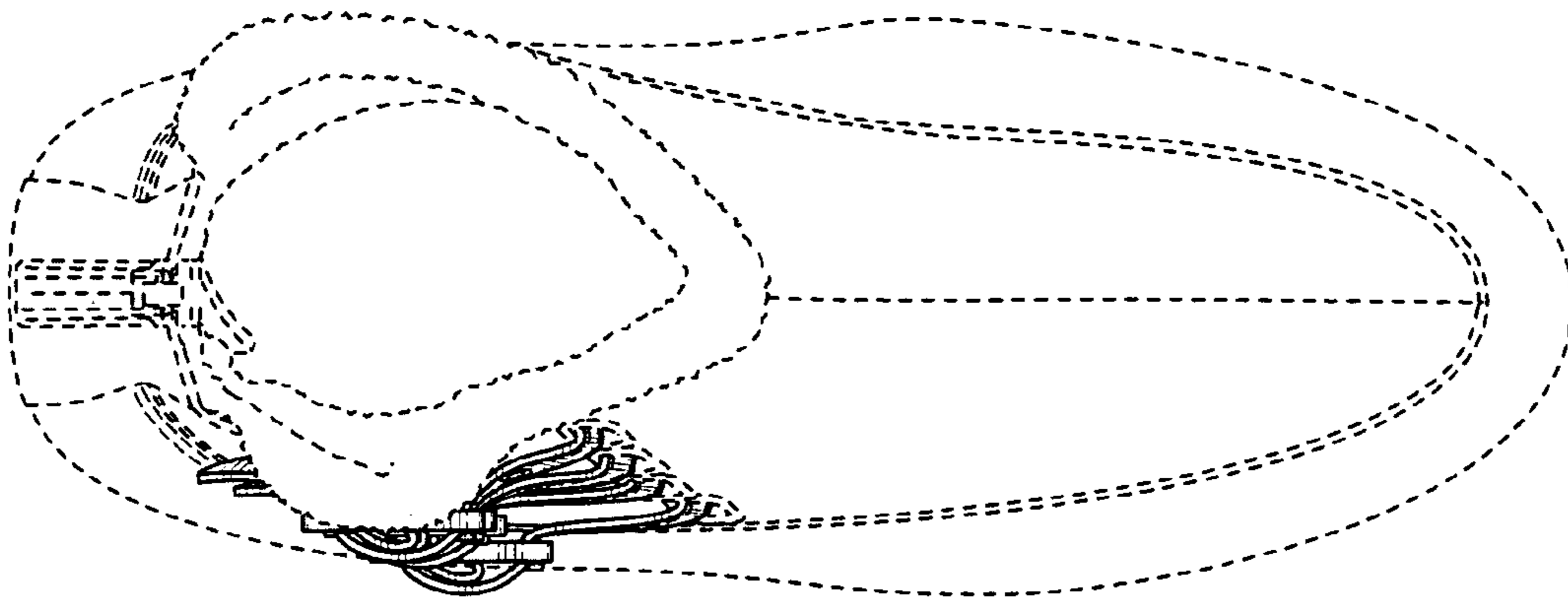
