(57) **CLAIM**

The ornamental design for a collapsible bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is an oblique front view in perspective of a collapsible bowl constructed in accordance with the invention, (illustrated in conjunction with a zipper handle shown in dotted lines and which is not part of the invention),

FIG. 2 is a front elevation view of the bowl illustrated in FIG. 1;

FIG. 3 is a top plan view of the bowl illustrated in FIG. 1;

FIG. 4 is a right side elevation view of the bowl illustrated in FIG. 1, the left side being substantially identical;

FIG. 5 is a rear elevation view of the bowl illustrated in FIG. 1;

FIG. 6 is a bottom plan view of the bowl illustrated in FIG. 1;

FIG. 7 is an oblique front view in perspective of the bowl of FIG. 1 in its fully collapsed configuration;

FIG. 8 is a front elevation view of the bowl illustrated in FIG. 1 in its fully collapsed configuration, the rear view being substantially identical;

FIG. 9 is a top plan view of the bowl illustrated in FIG. 1 in its fully collapsed configuration;

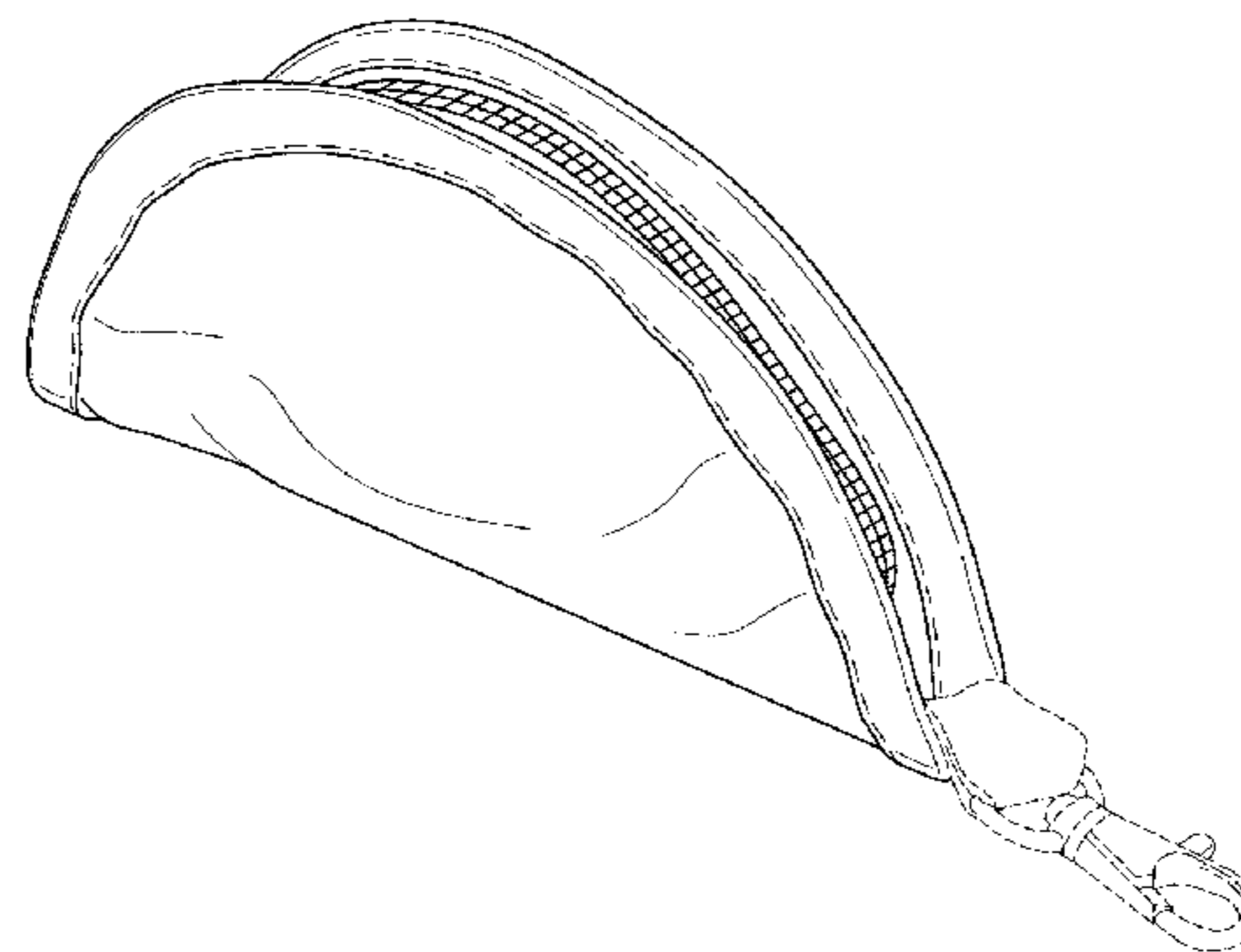
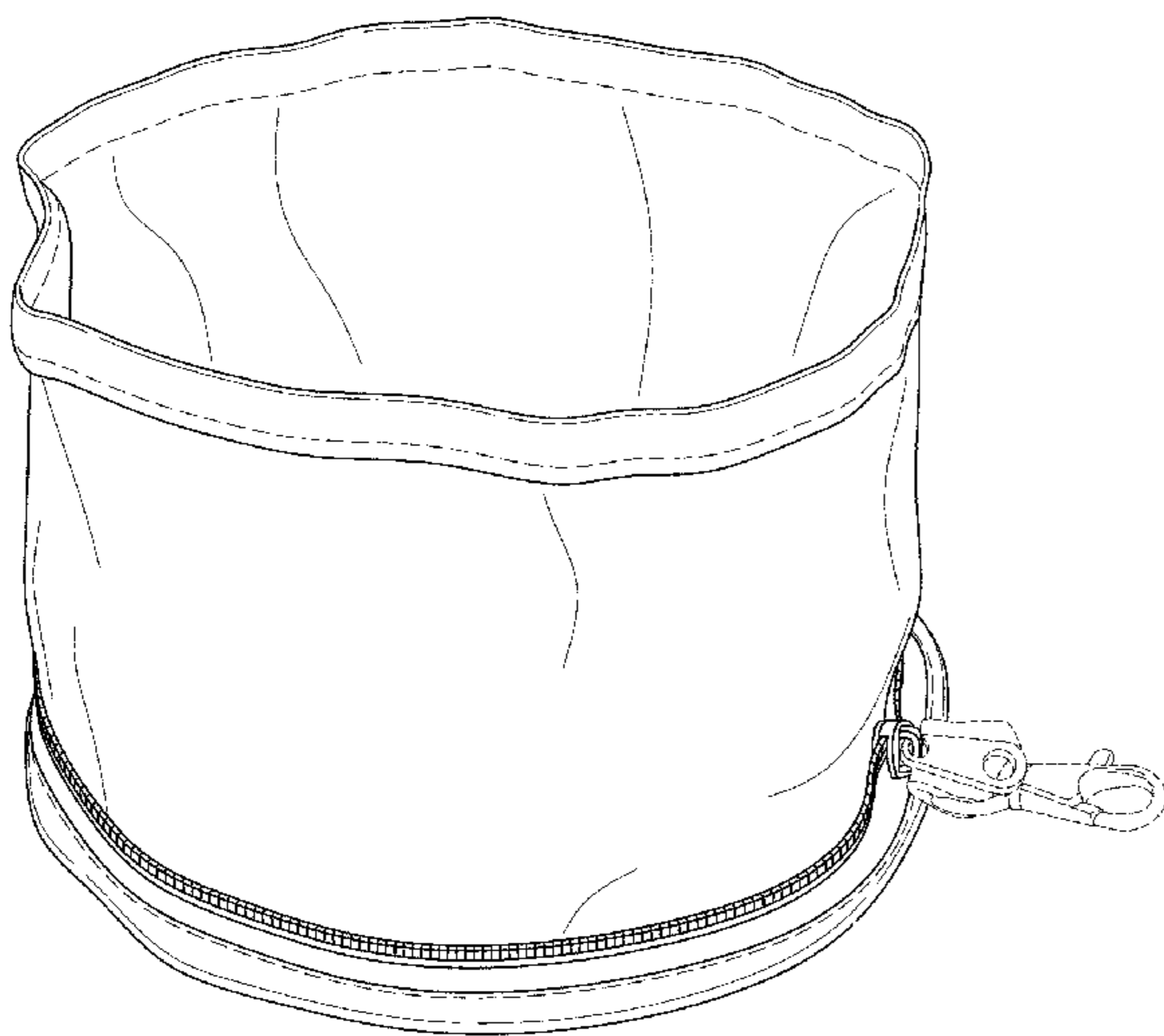
FIG. 10 is a left side elevation view of the bowl illustrated in FIG. 1 in its fully collapsed configuration;

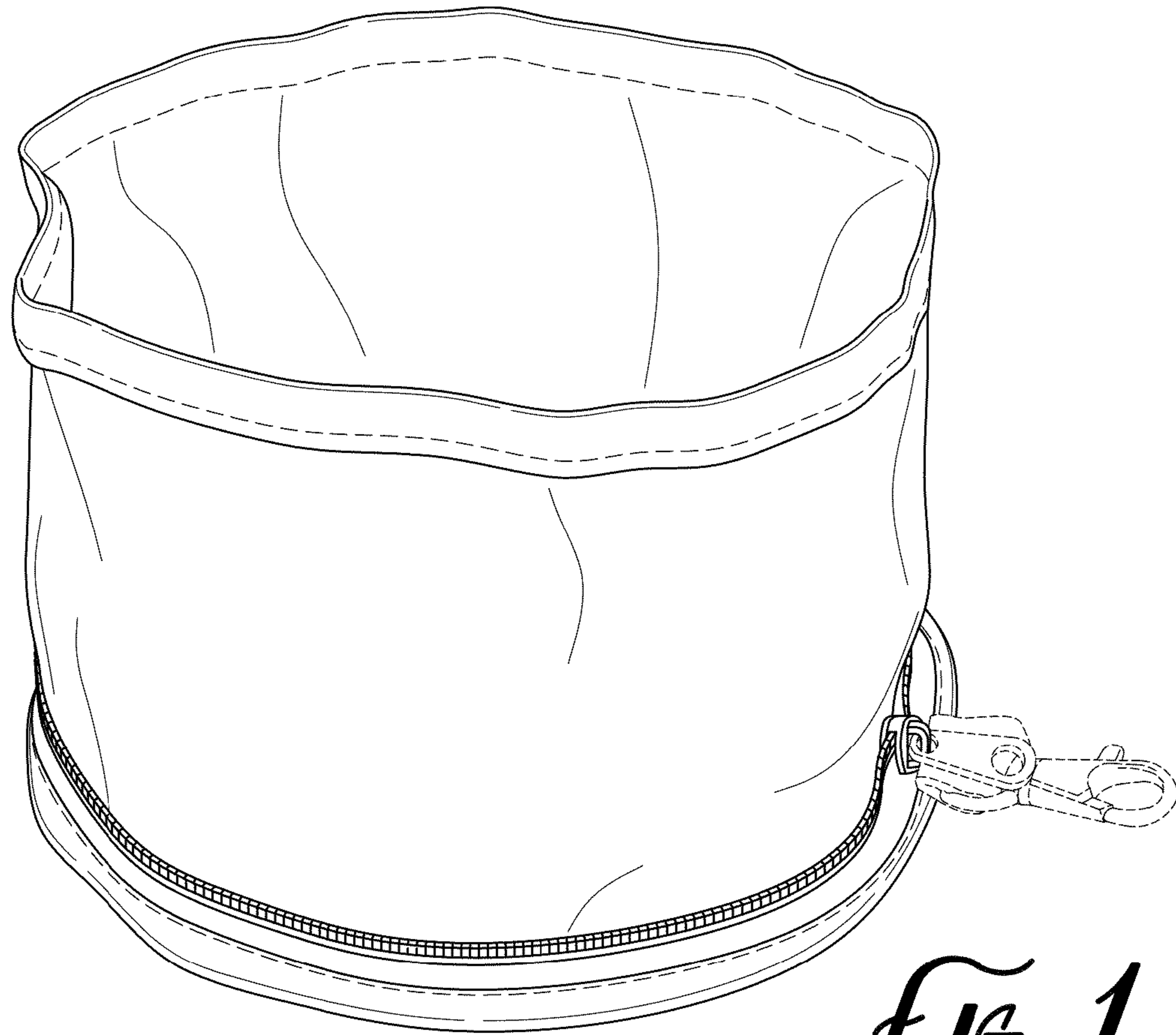
FIG. 11 is a right side elevation view of the bowl illustrated in FIG. 1 in its fully collapsed configuration; and,

FIG. 12 is a bottom plan view of the bowl illustrated in FIG. 1 in its fully collapsed configuration.

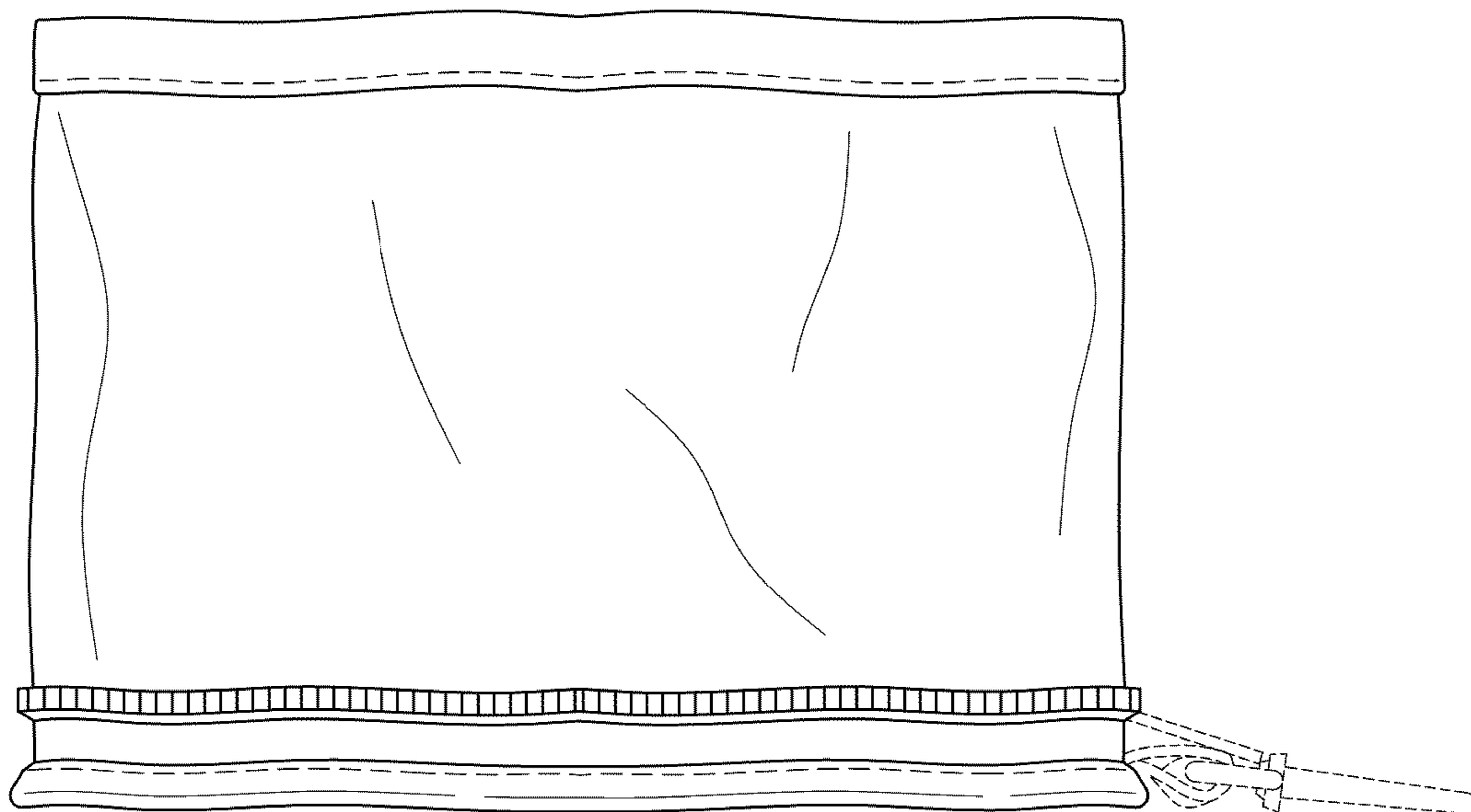

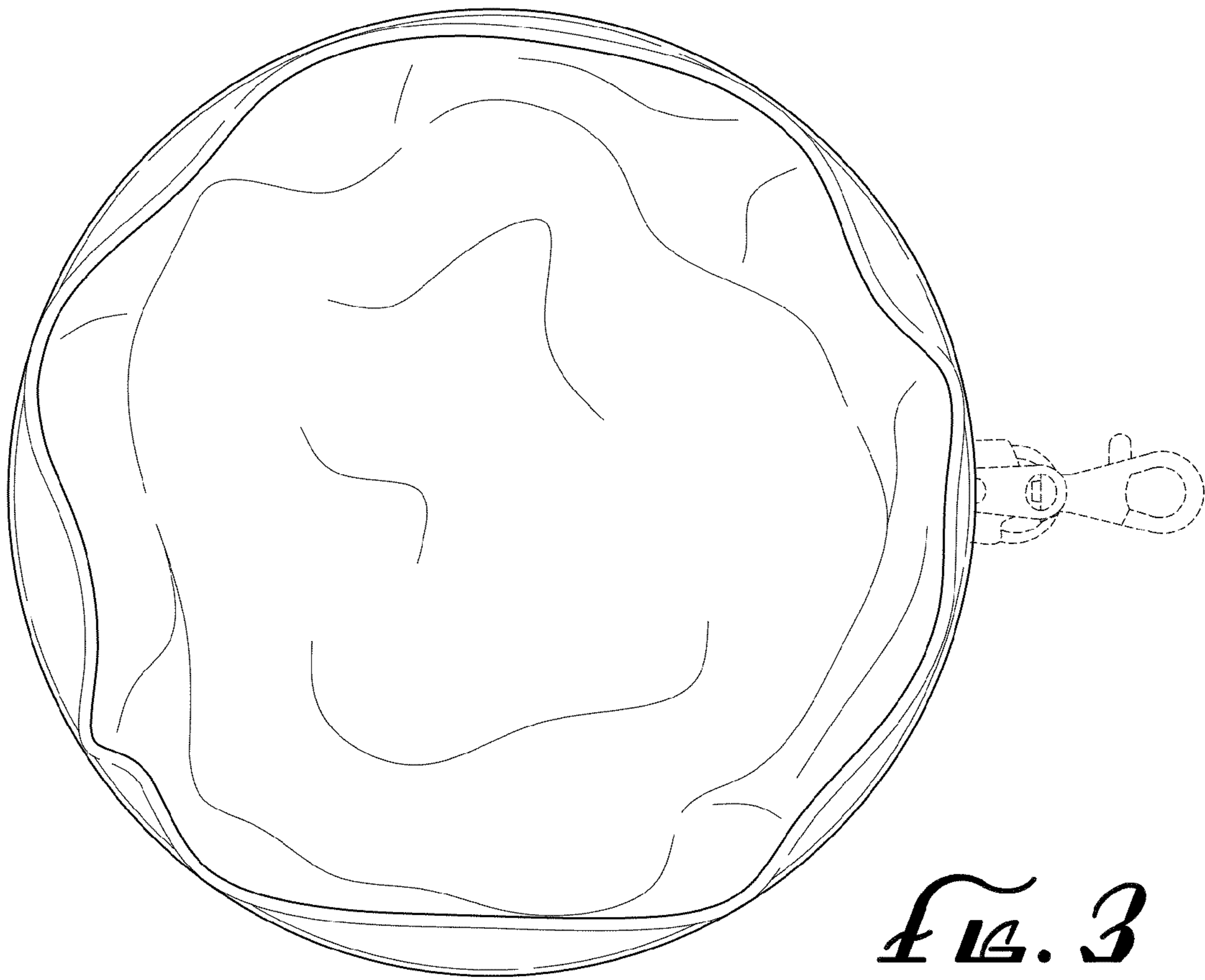




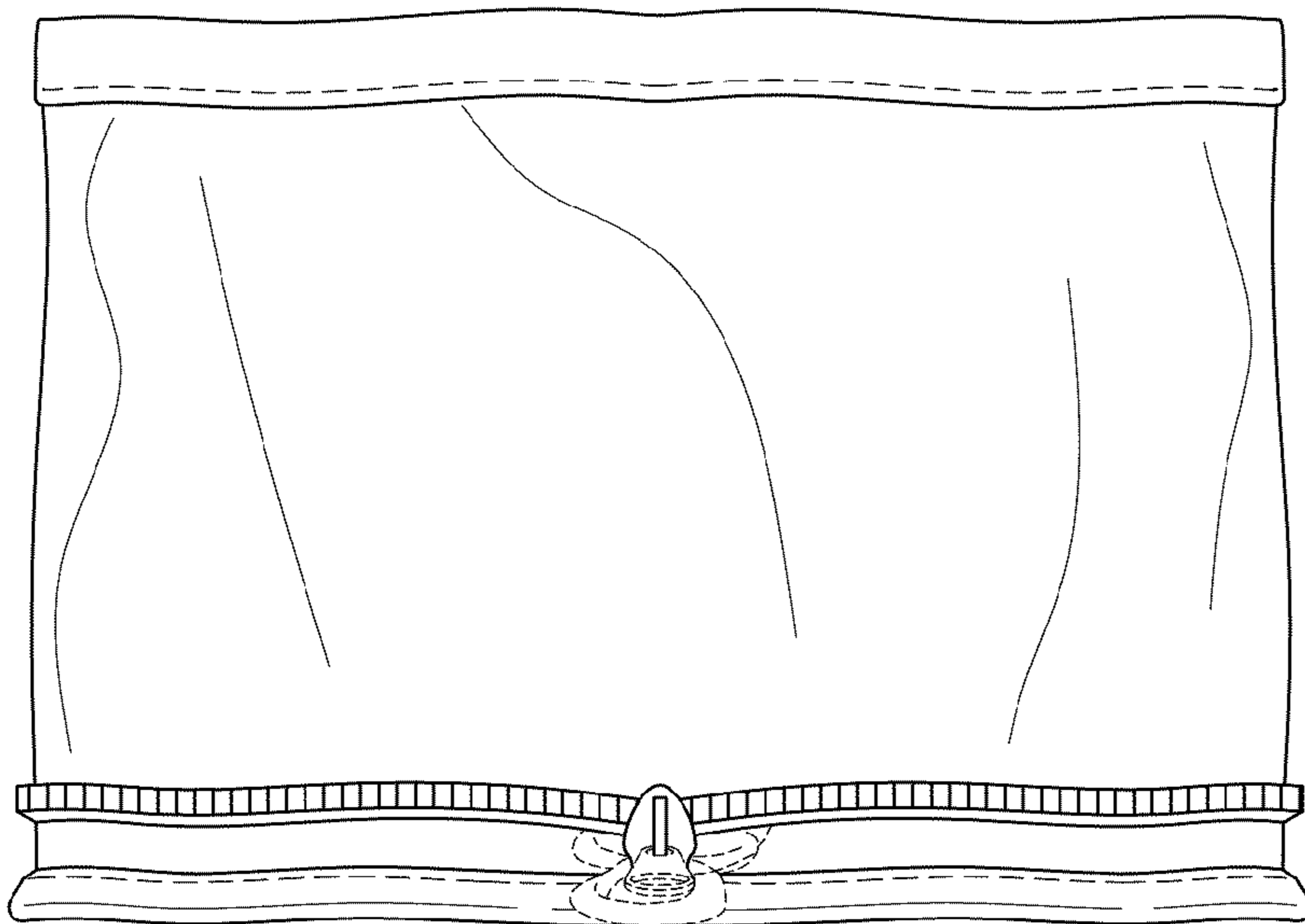

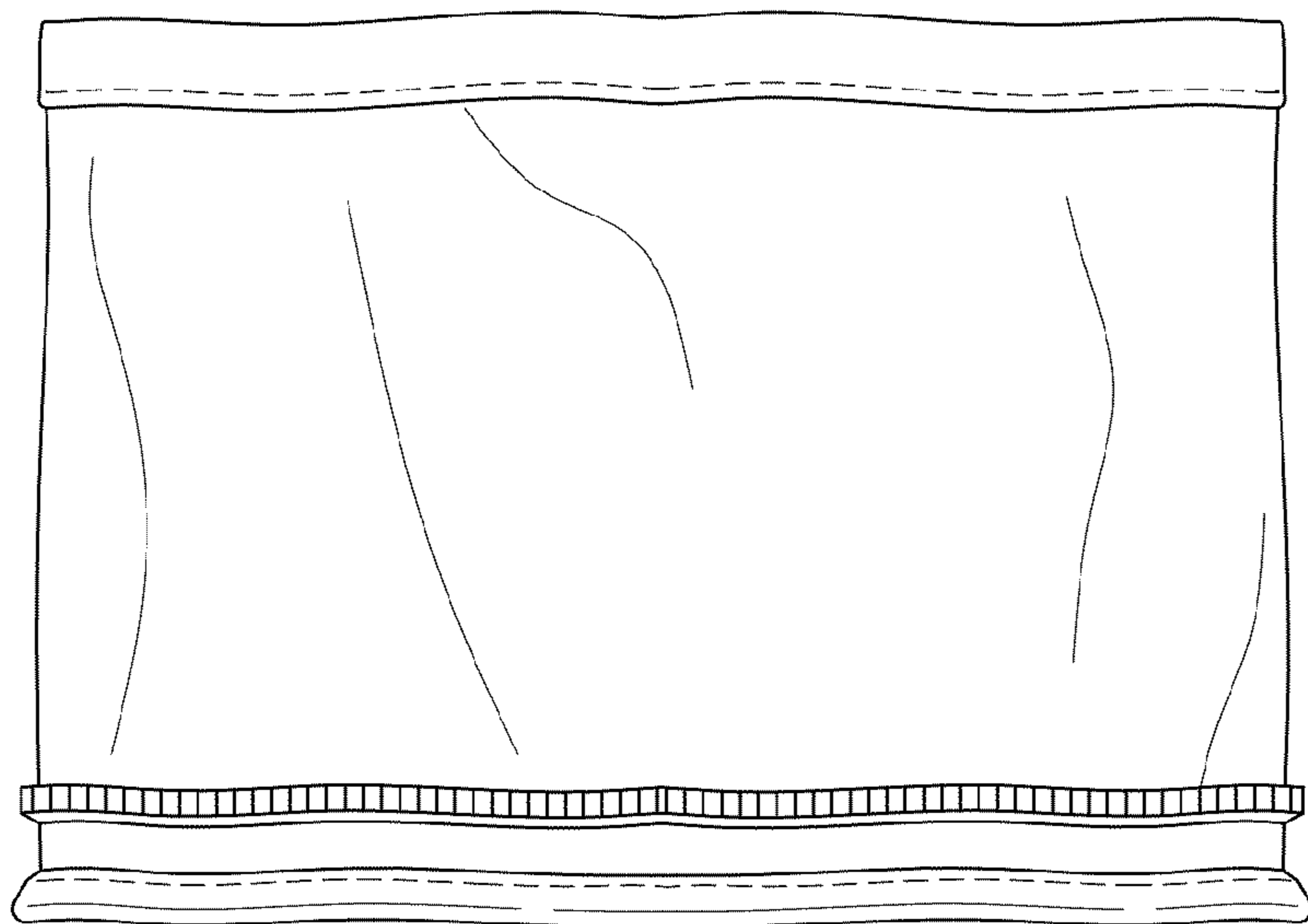

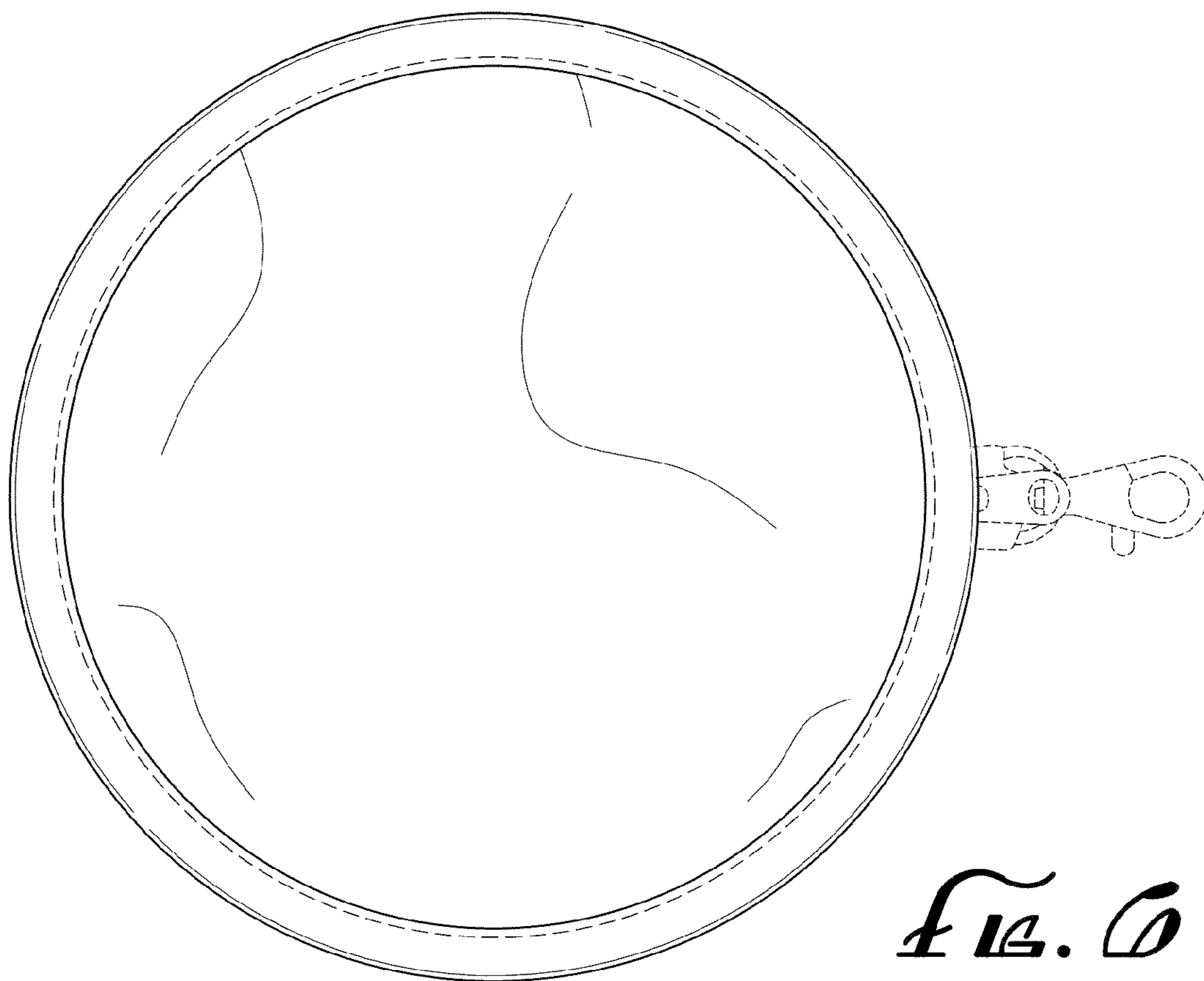

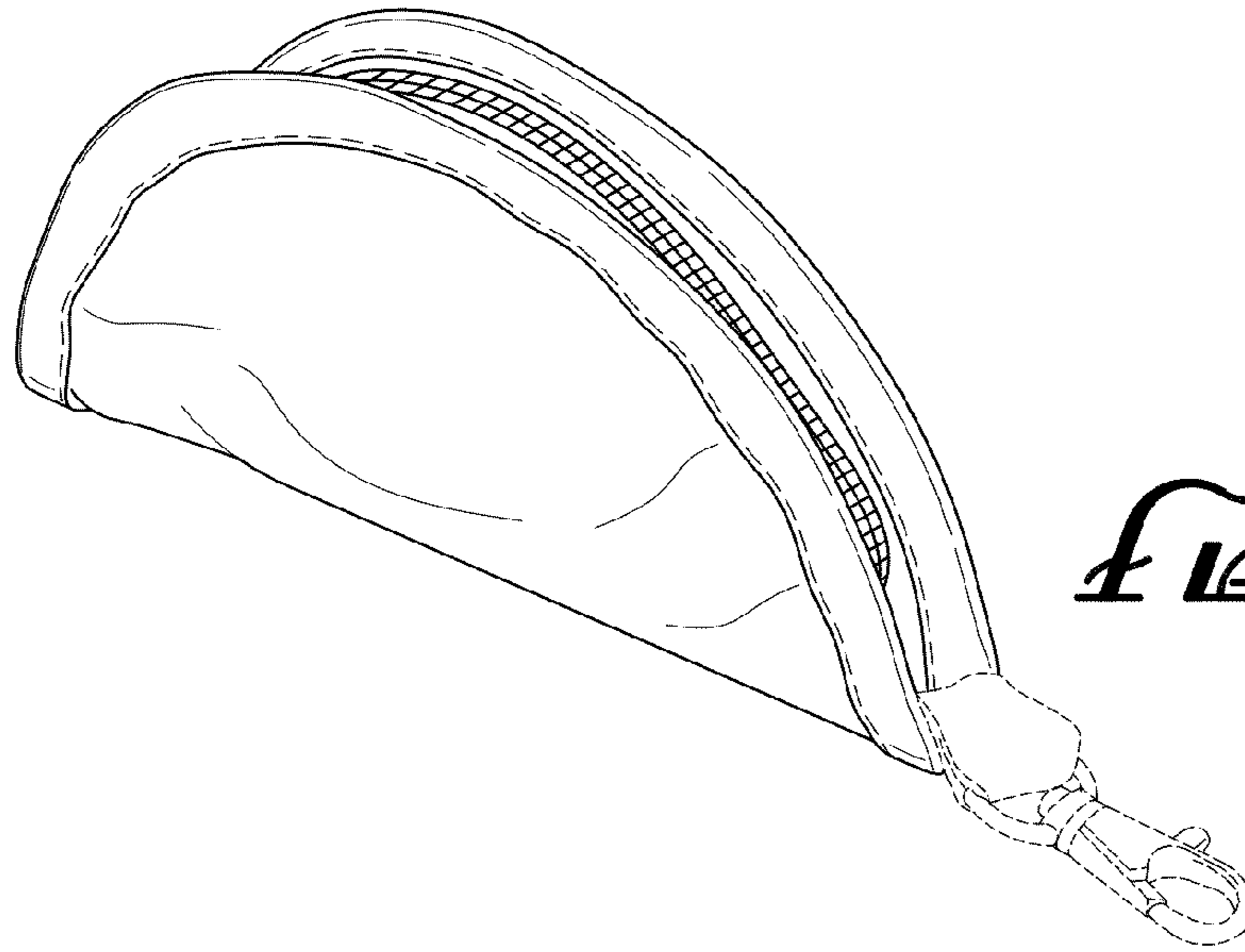

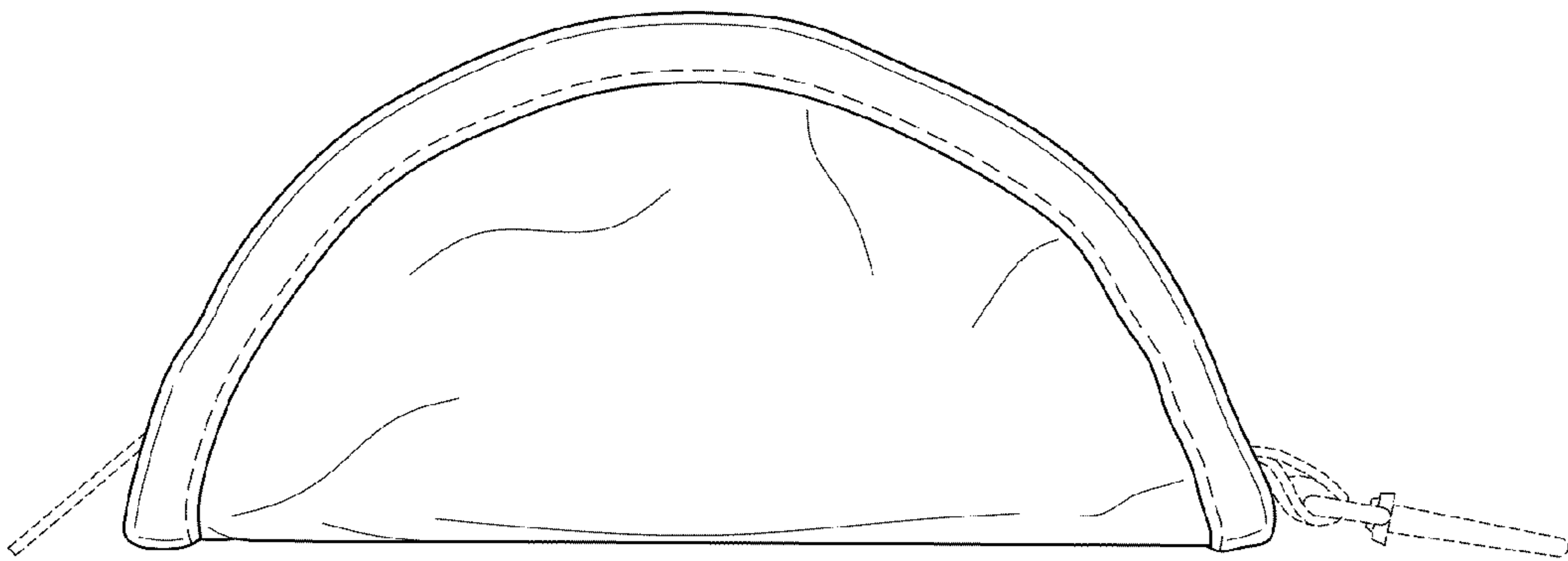

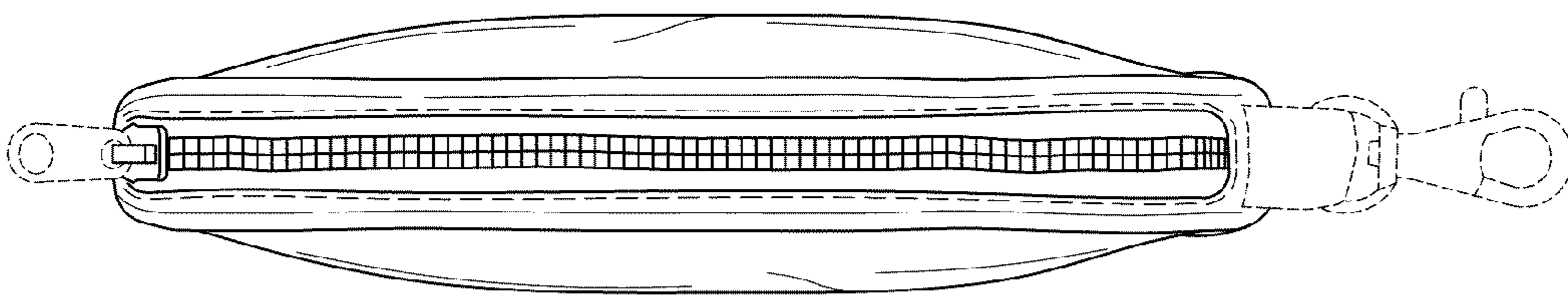

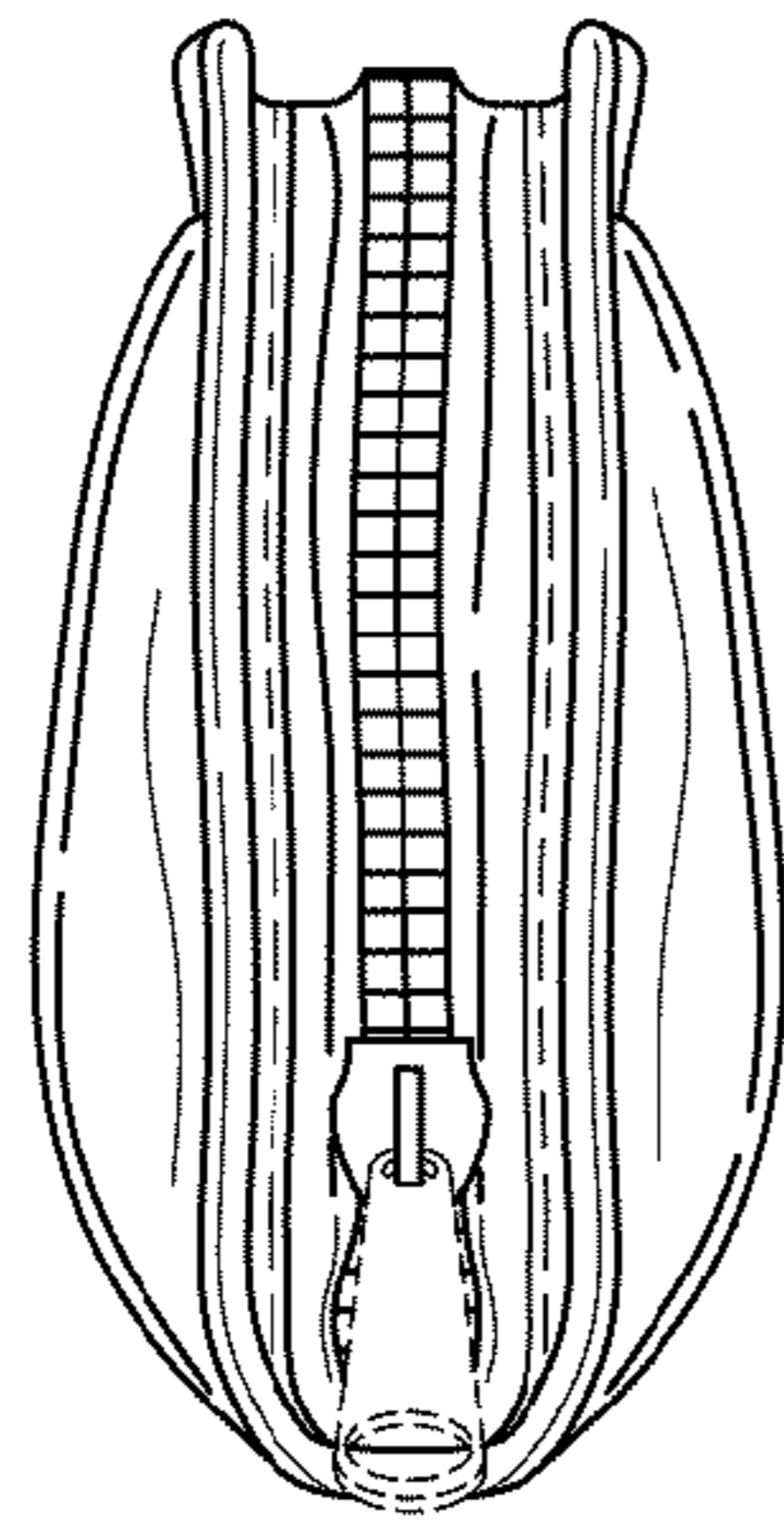

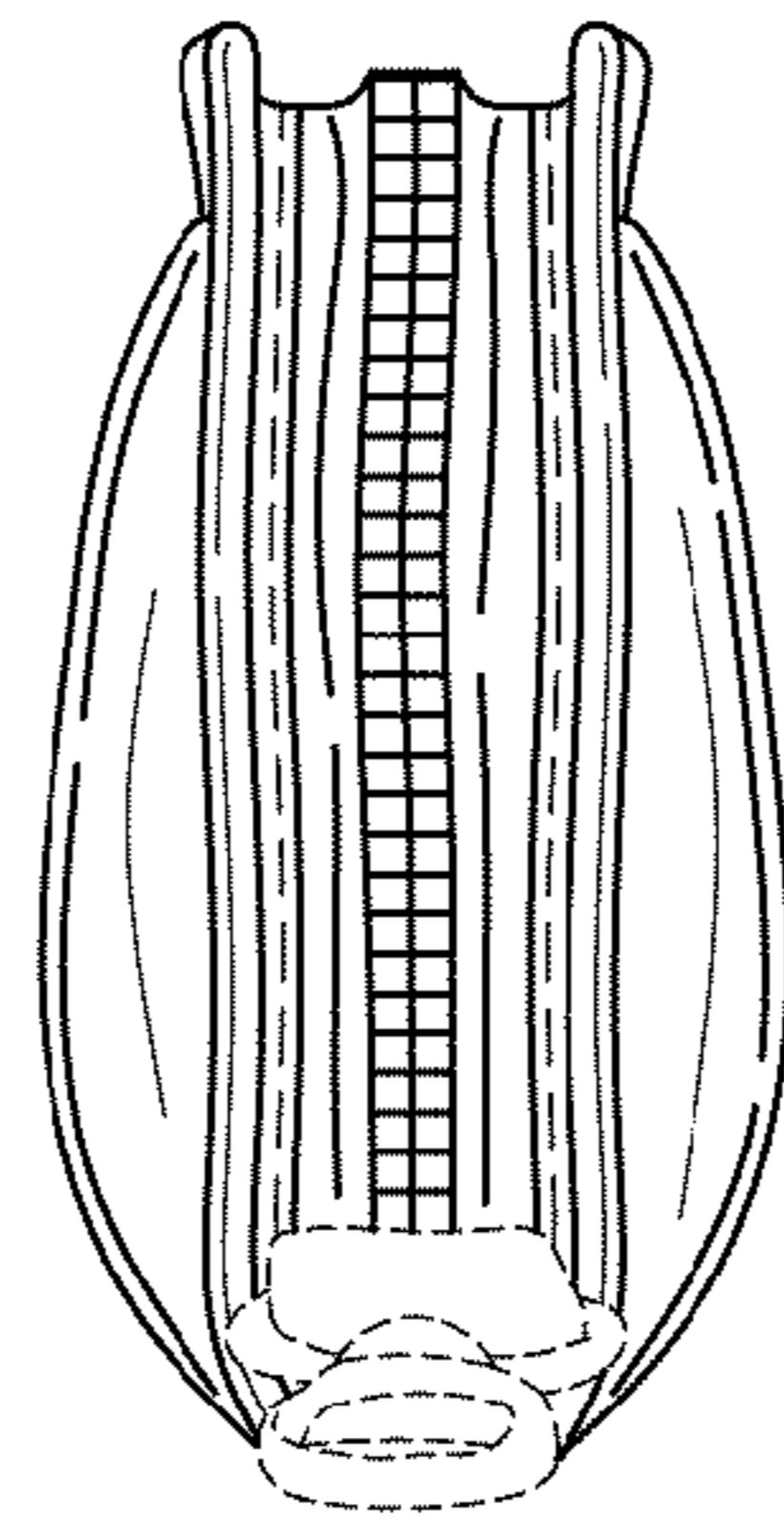

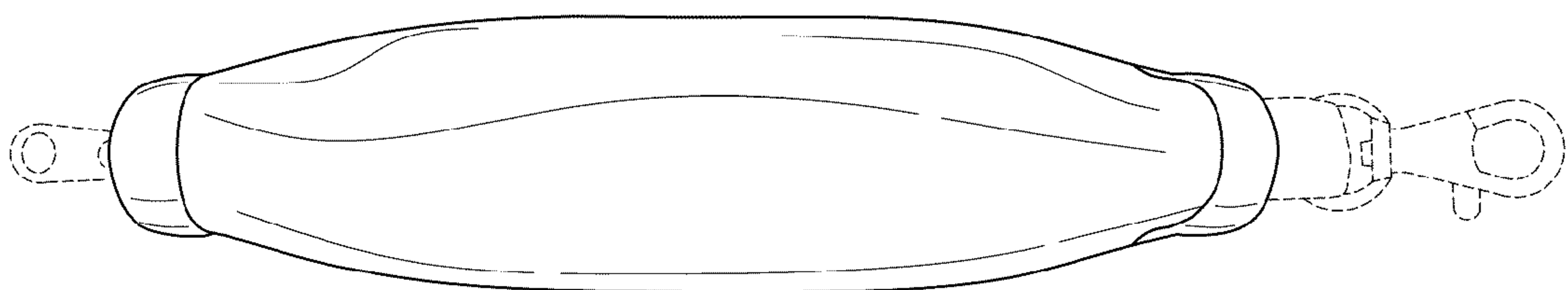
