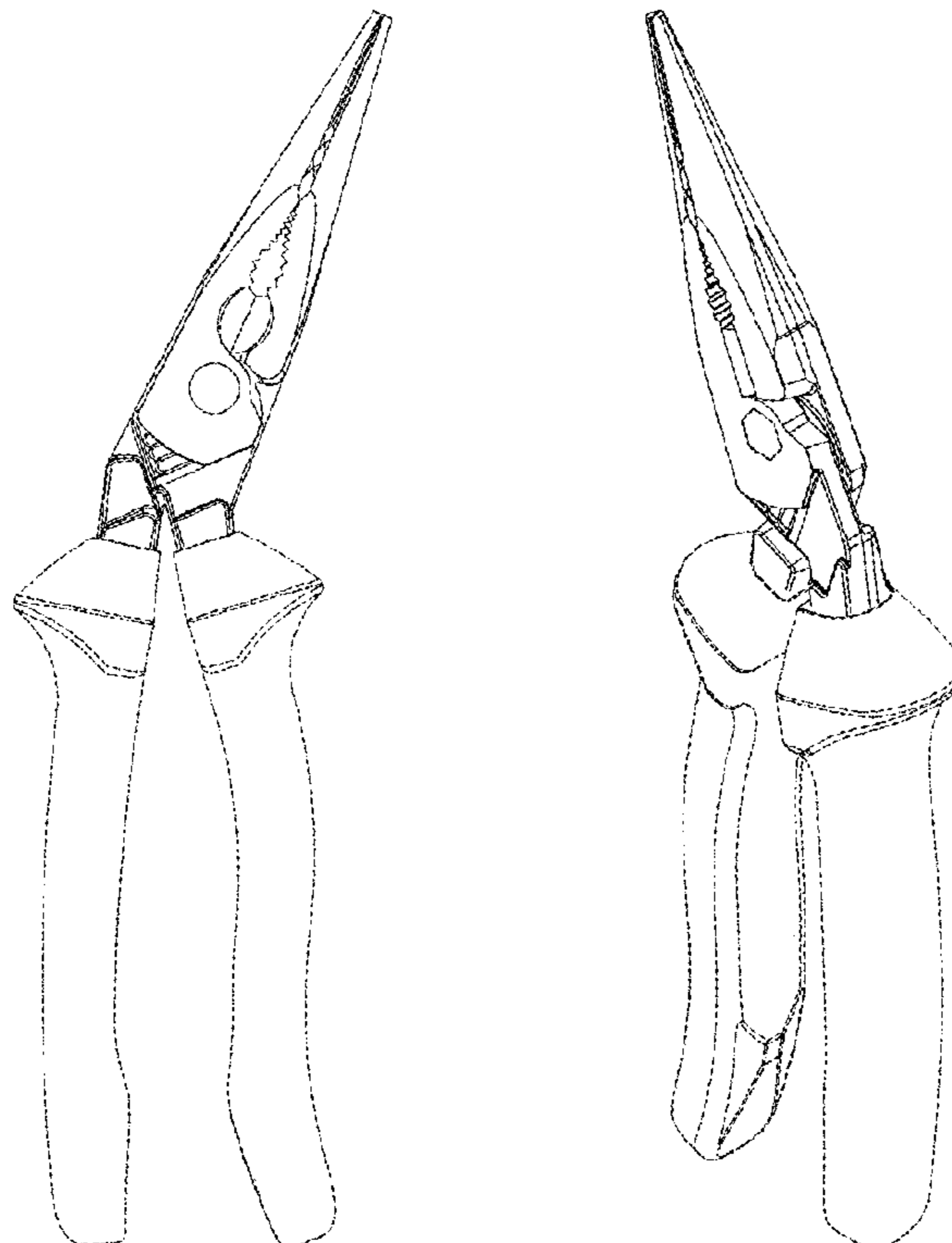
(57) **CLAIM**

The ornamental design for pliers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a pliers.  
FIG. 2 is a rear elevational view of the pliers of FIG. 1.  
FIG. 3 is a right elevational view of the pliers of FIG. 1.  
FIG. 4 is a left elevational view of the pliers of FIG. 1.  
FIG. 5 is a top plane view of the pliers of FIG. 1.  
FIG. 6 is a bottom plane view of the pliers of FIG. 1; and,  
FIG. 7 is a perspective view of the pliers of FIG. 1.  
The broken lines showing the handle grips of the pliers are not claimed as part of the inventive design.

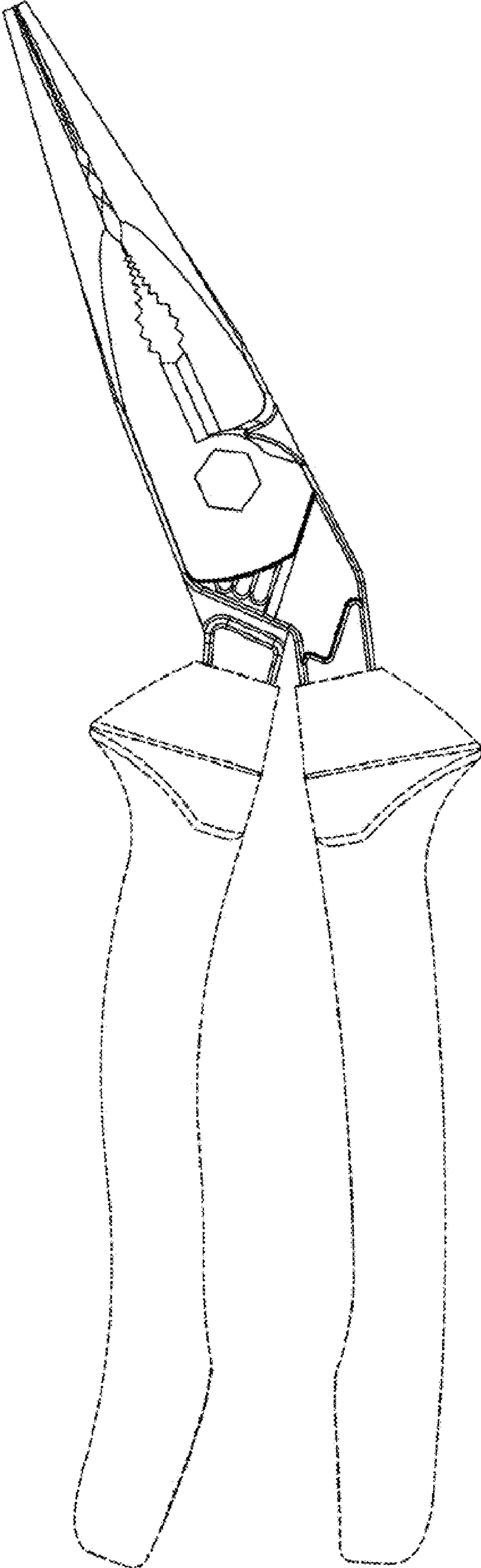

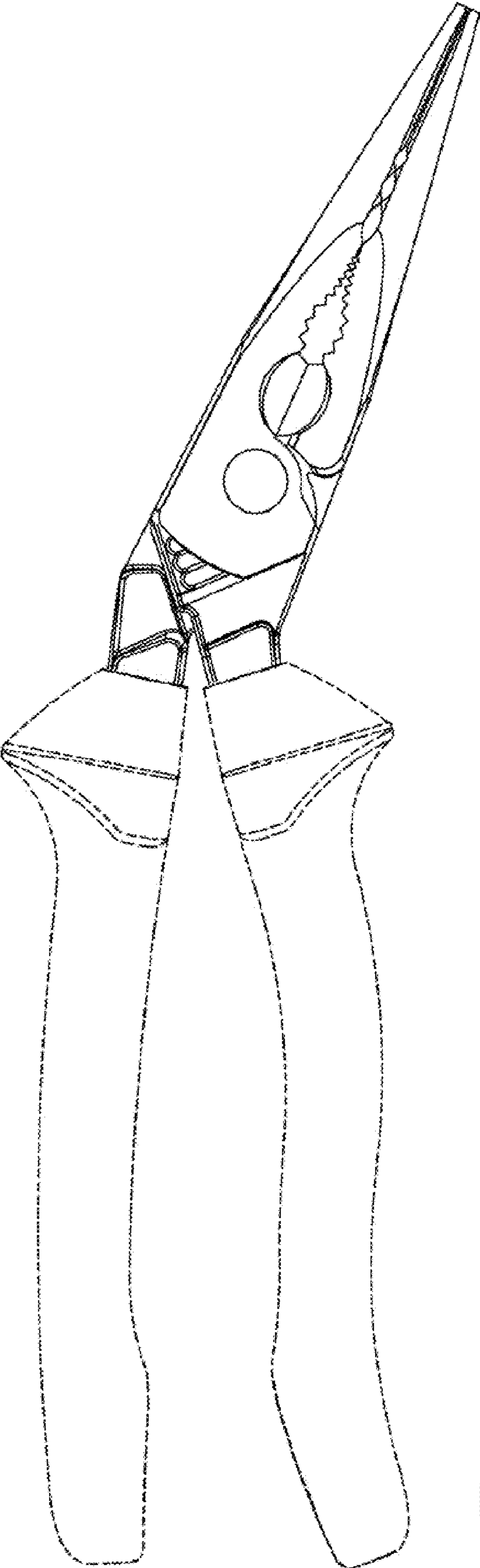

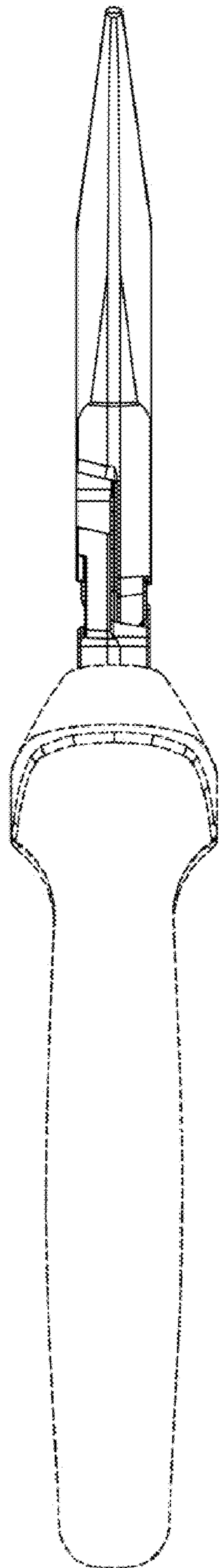

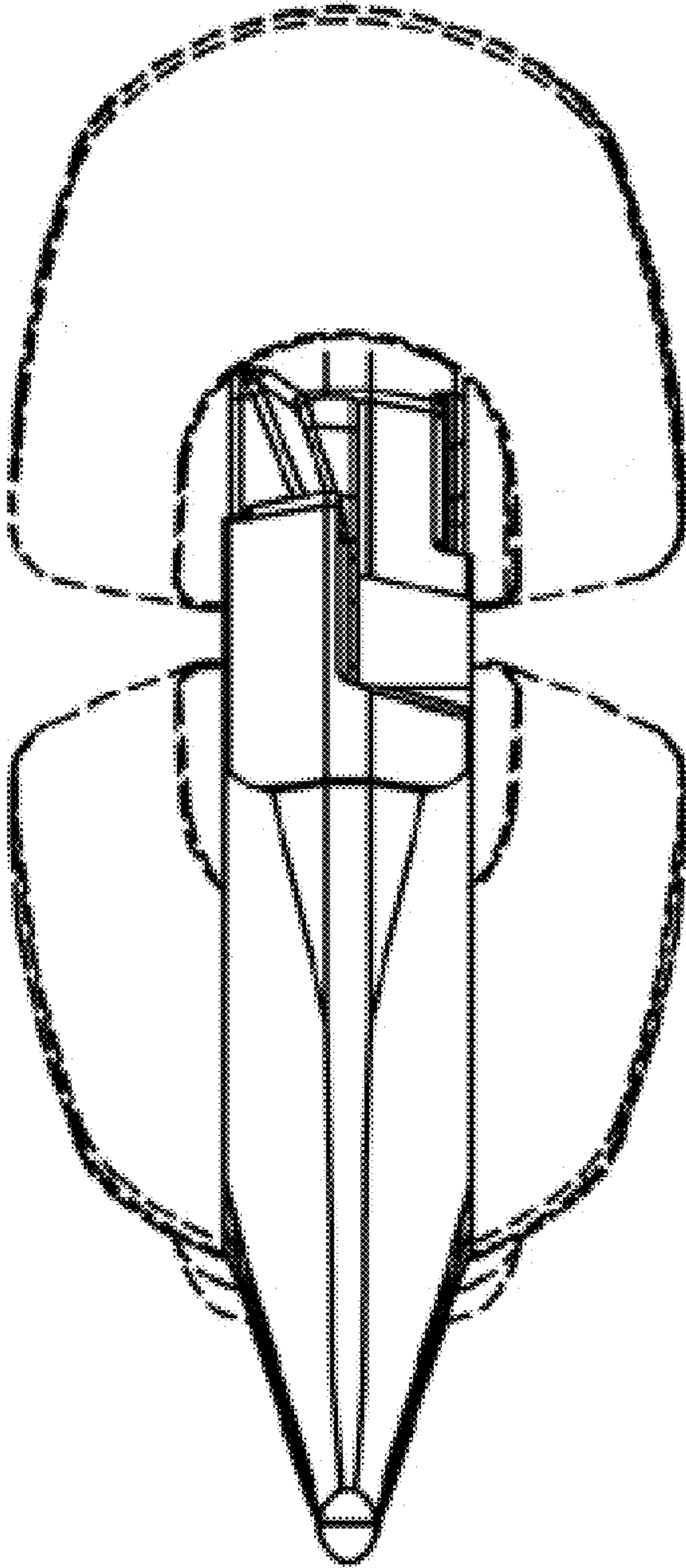

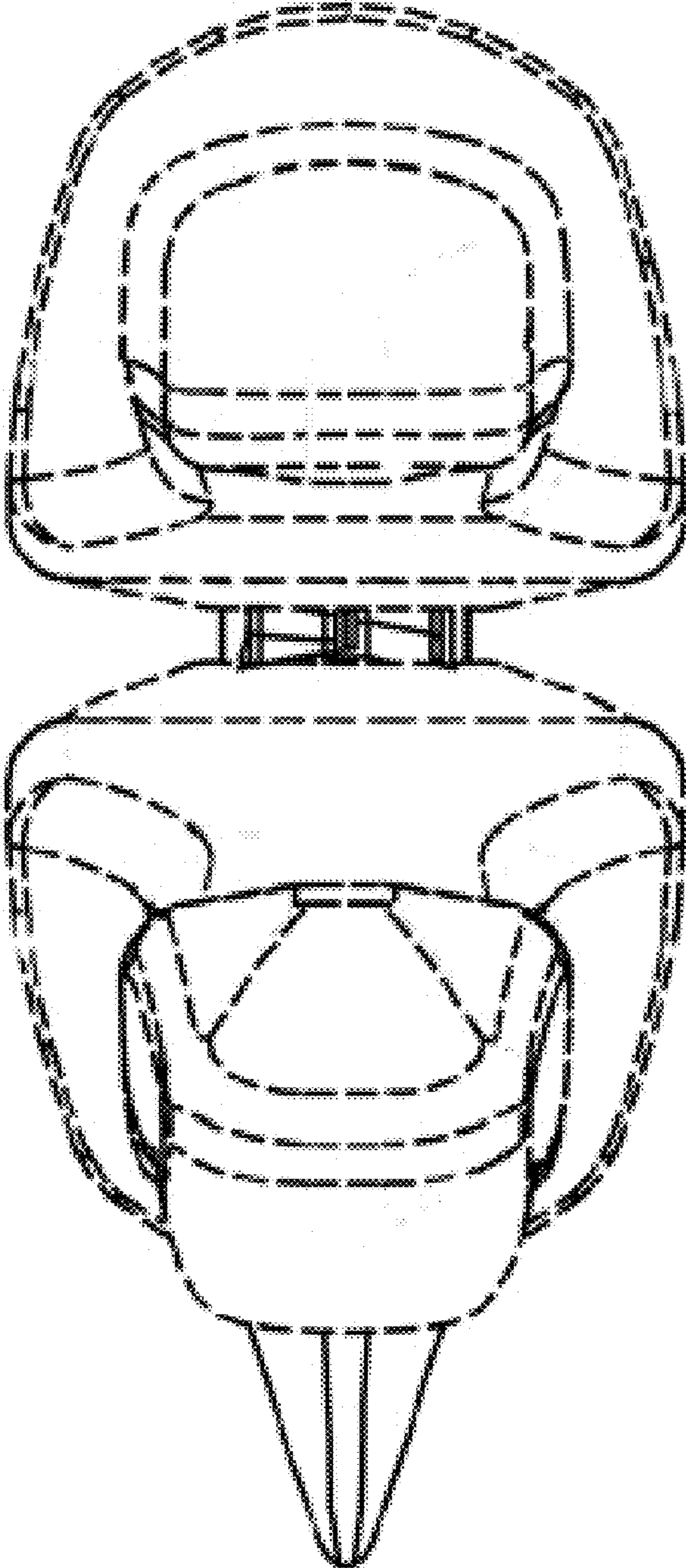

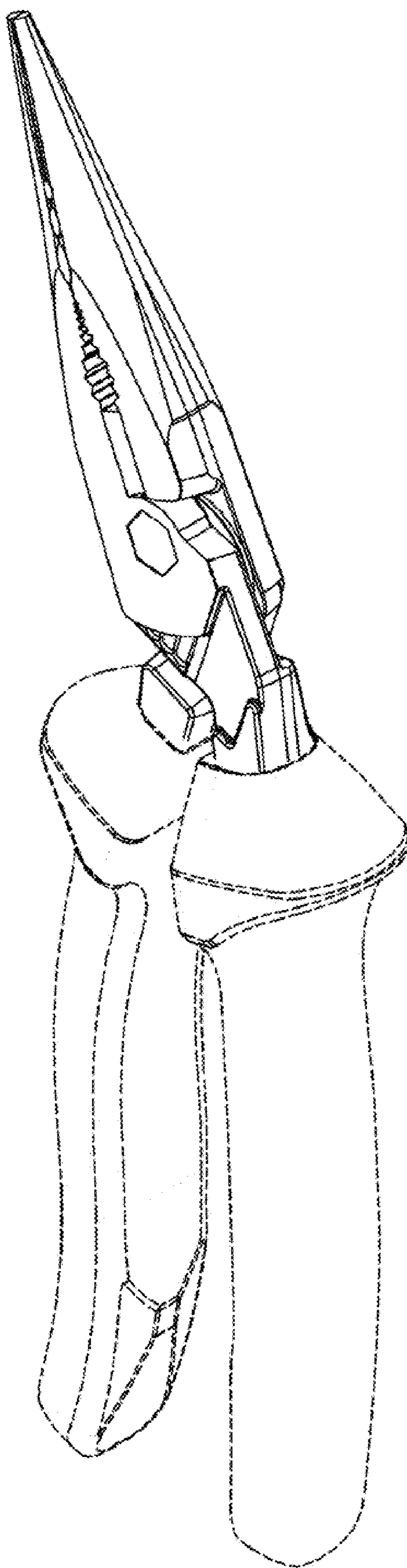
