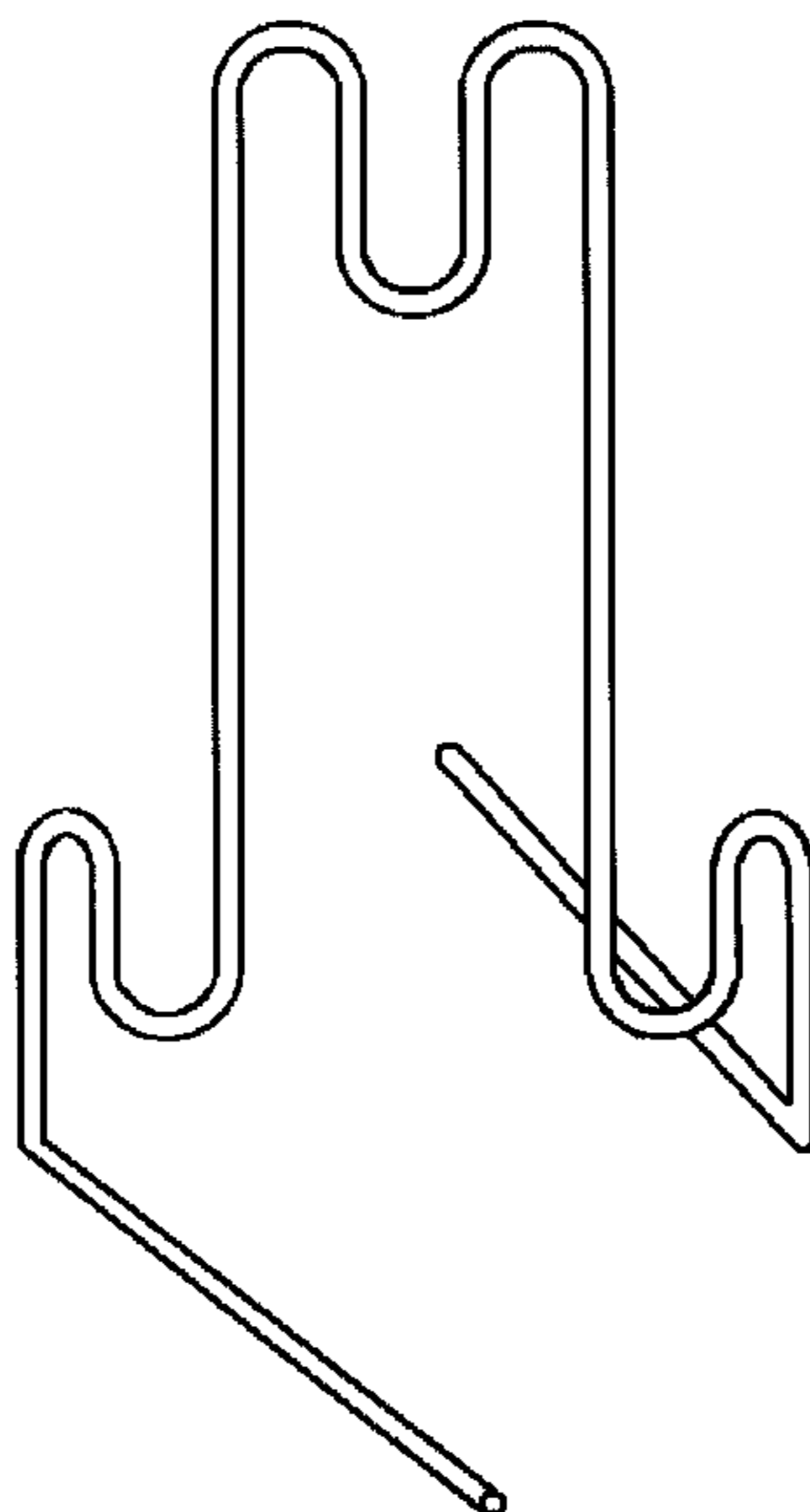
(57) **CLAIM**

The ornamental design for a rebar chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the rebar chair showing my new design;  
FIG. 2 is a side elevation view of the rebar chair, the opposite side being a mirror image thereof;  
FIG. 3 is a front elevation view of the rebar chair; and,

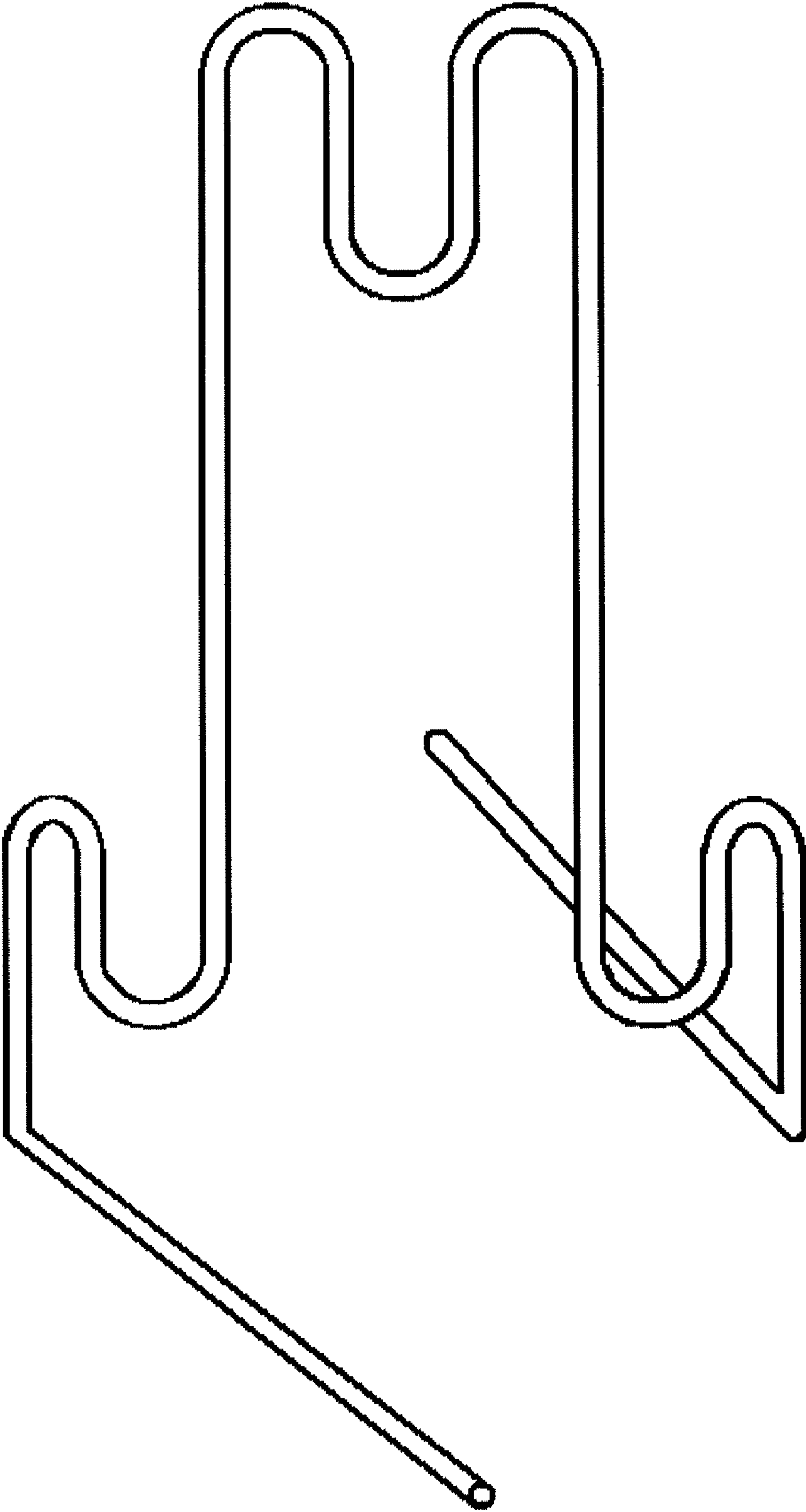

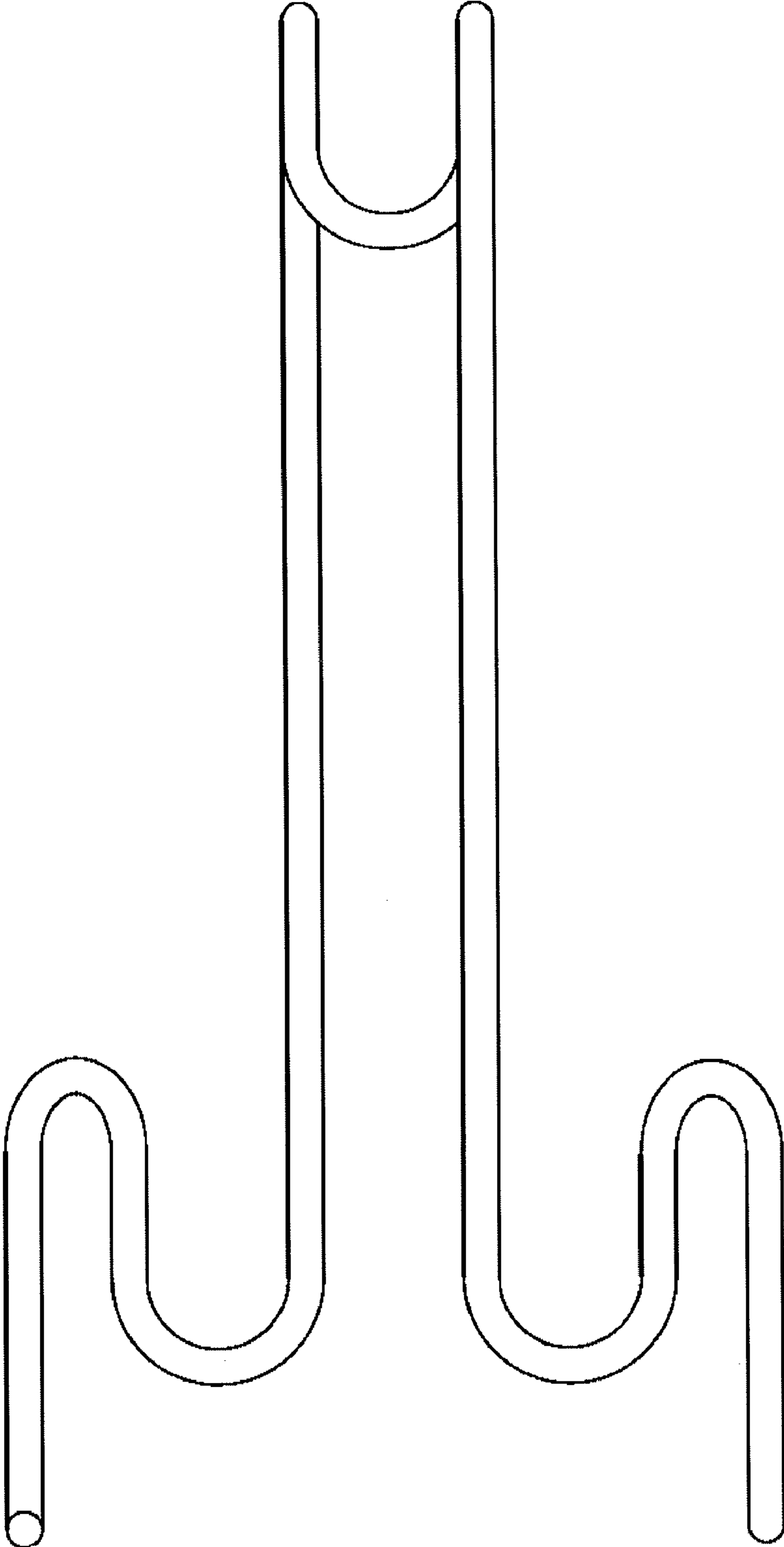

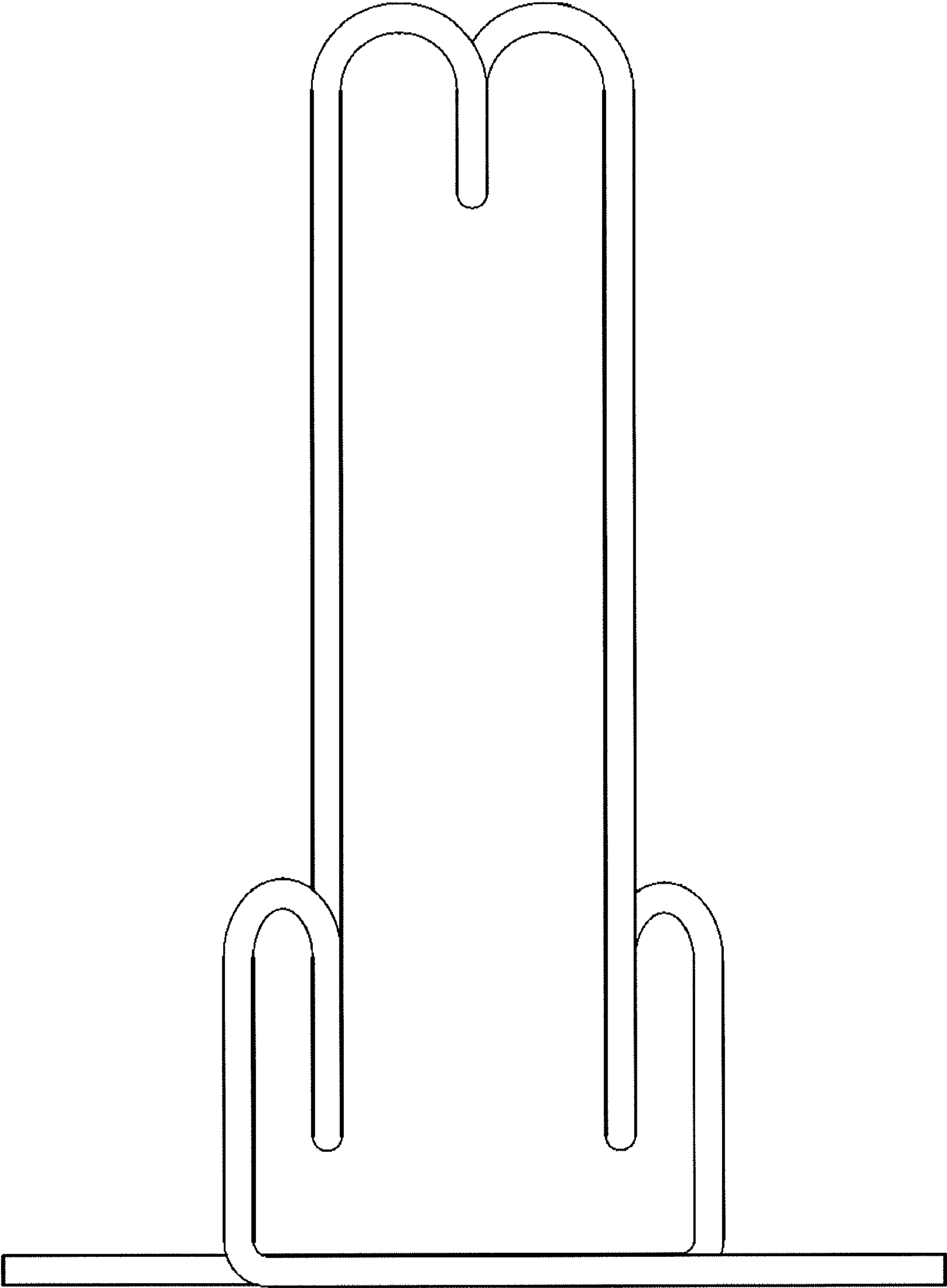

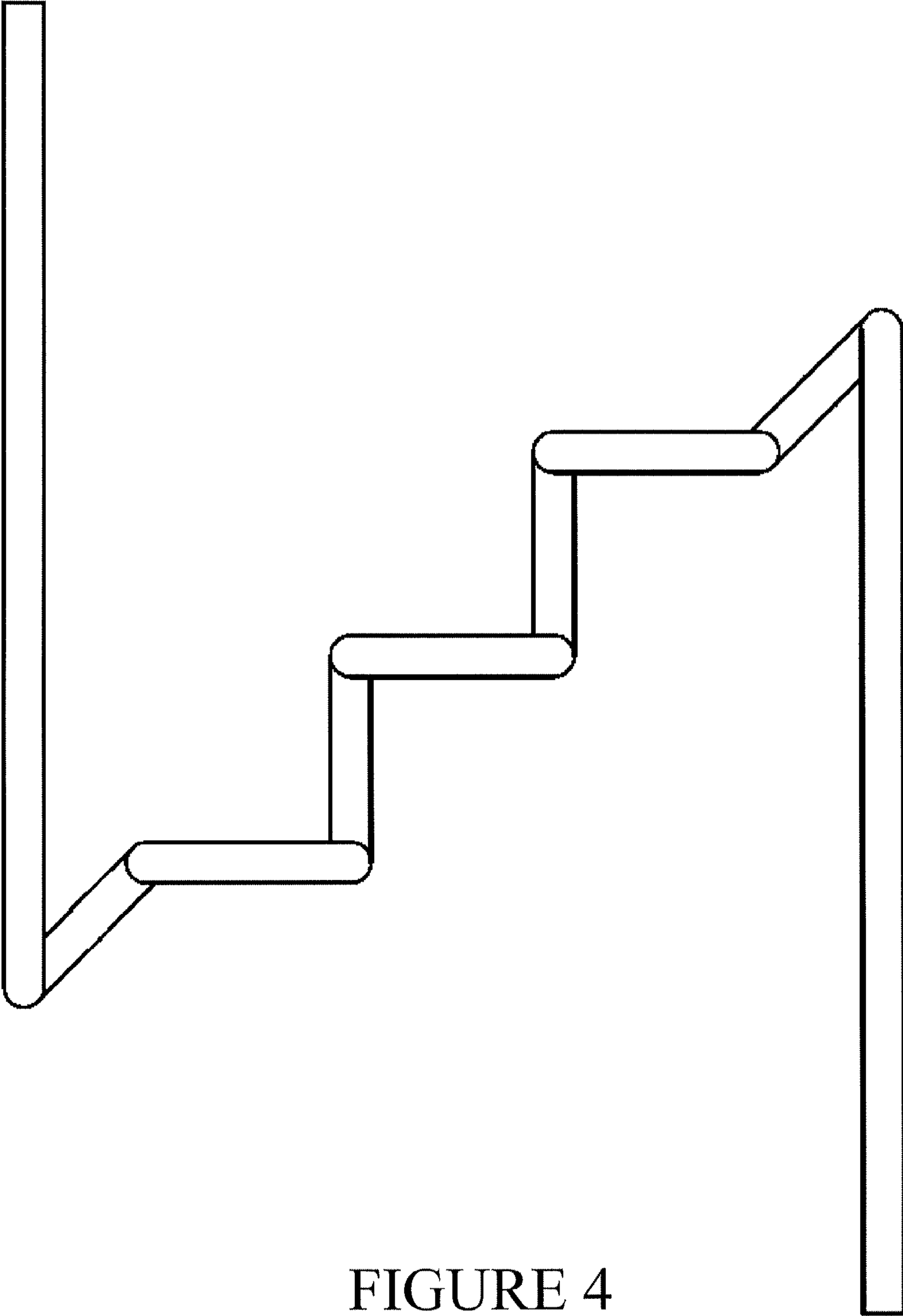
