The ornamental design for a combined container and label, as shown and described.

DESCRIPTION

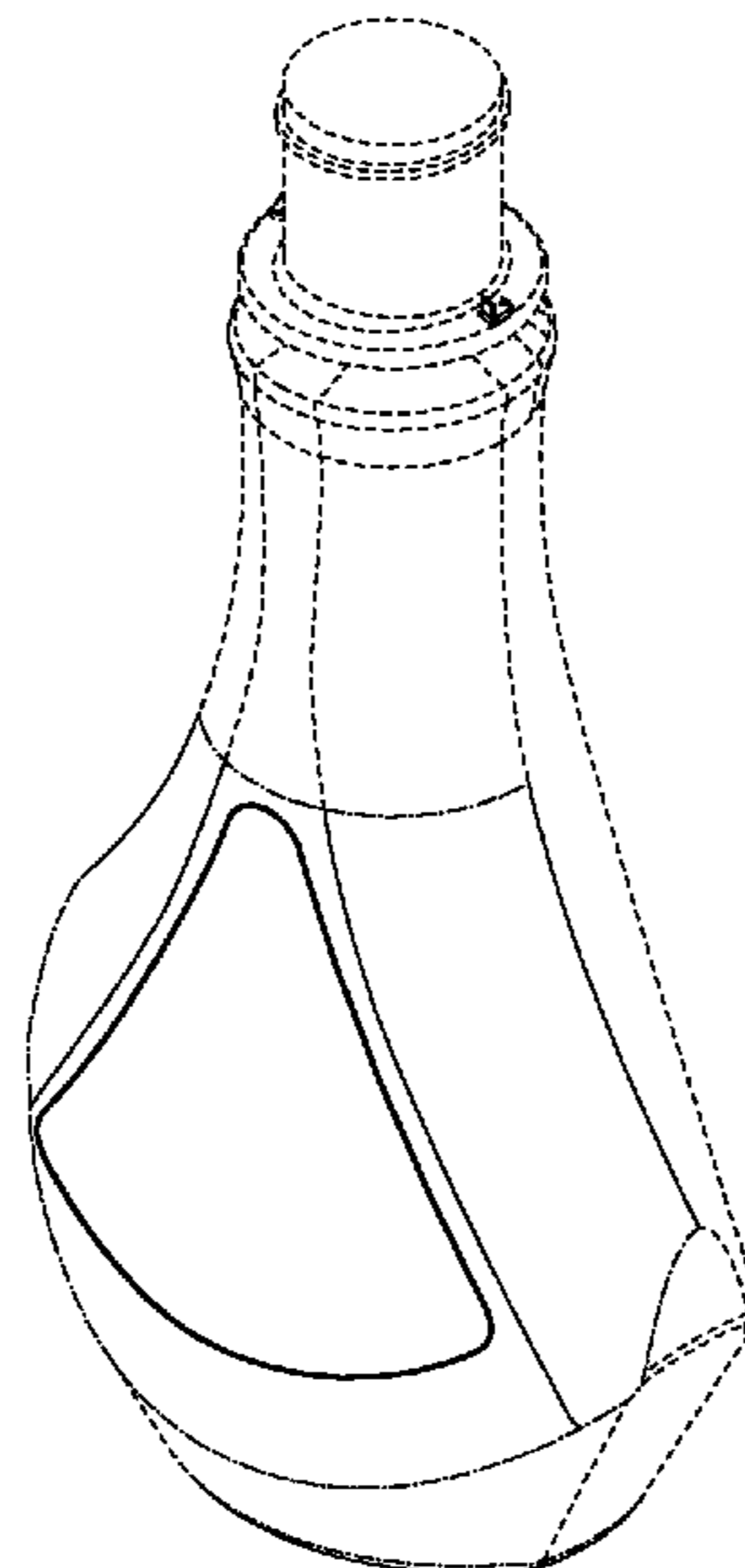

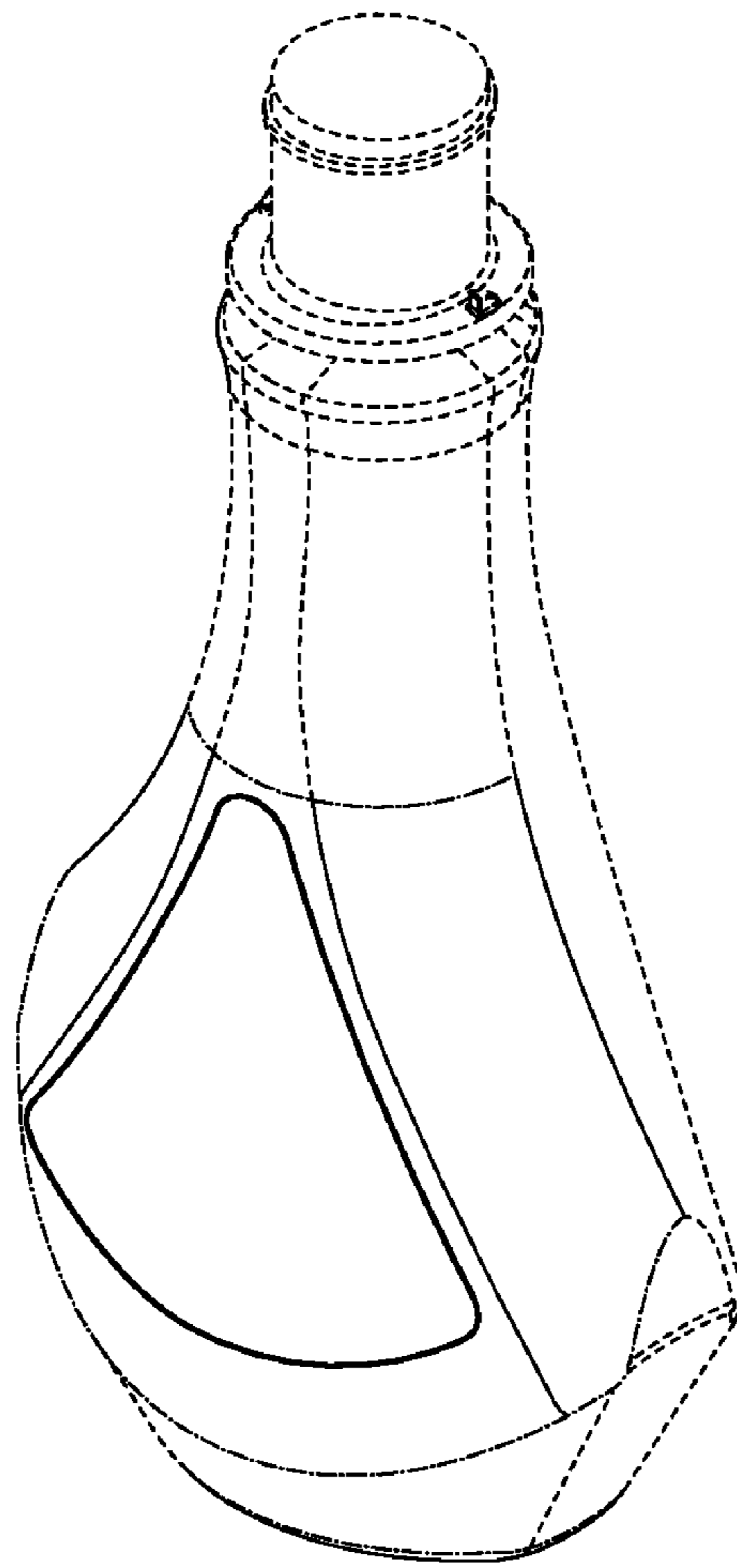

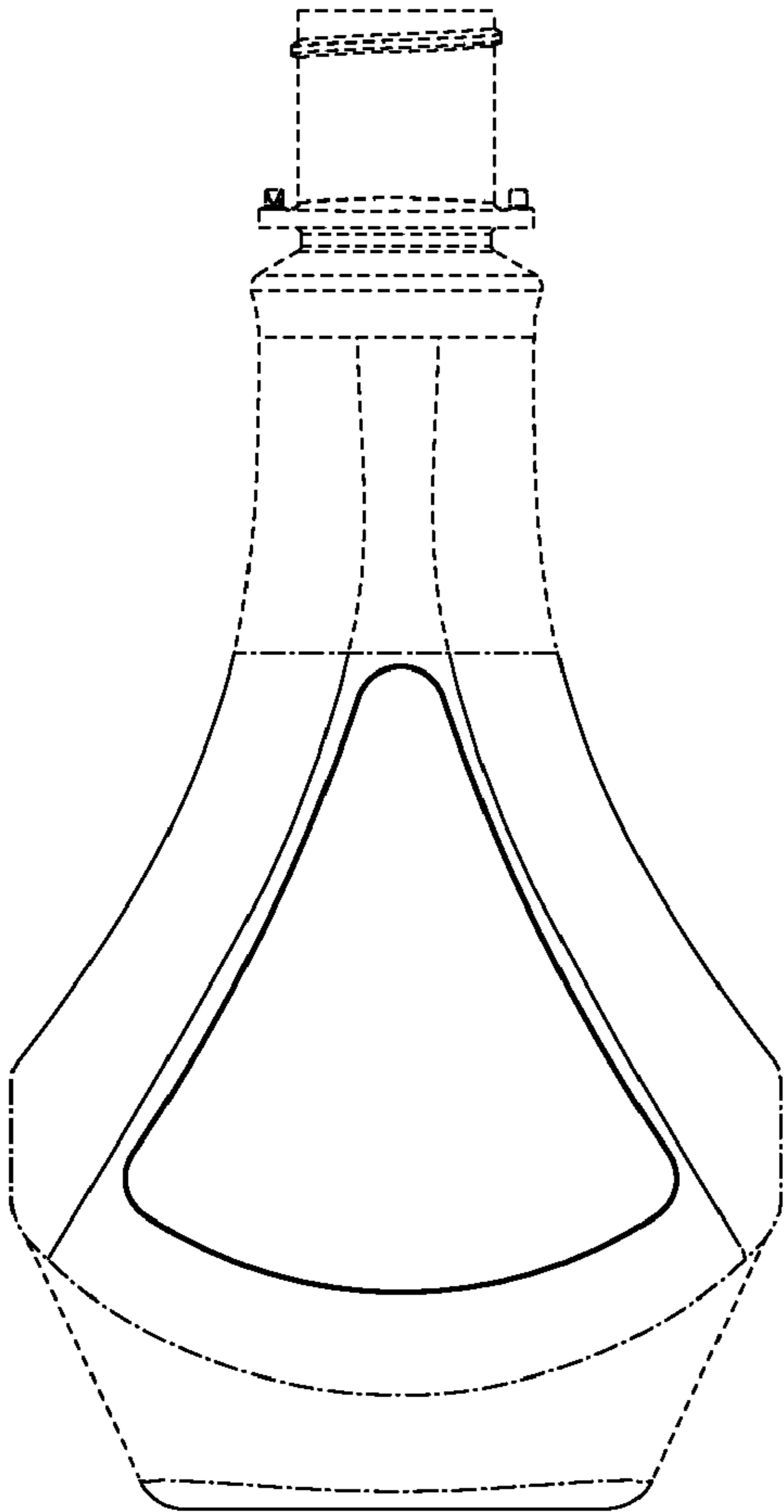

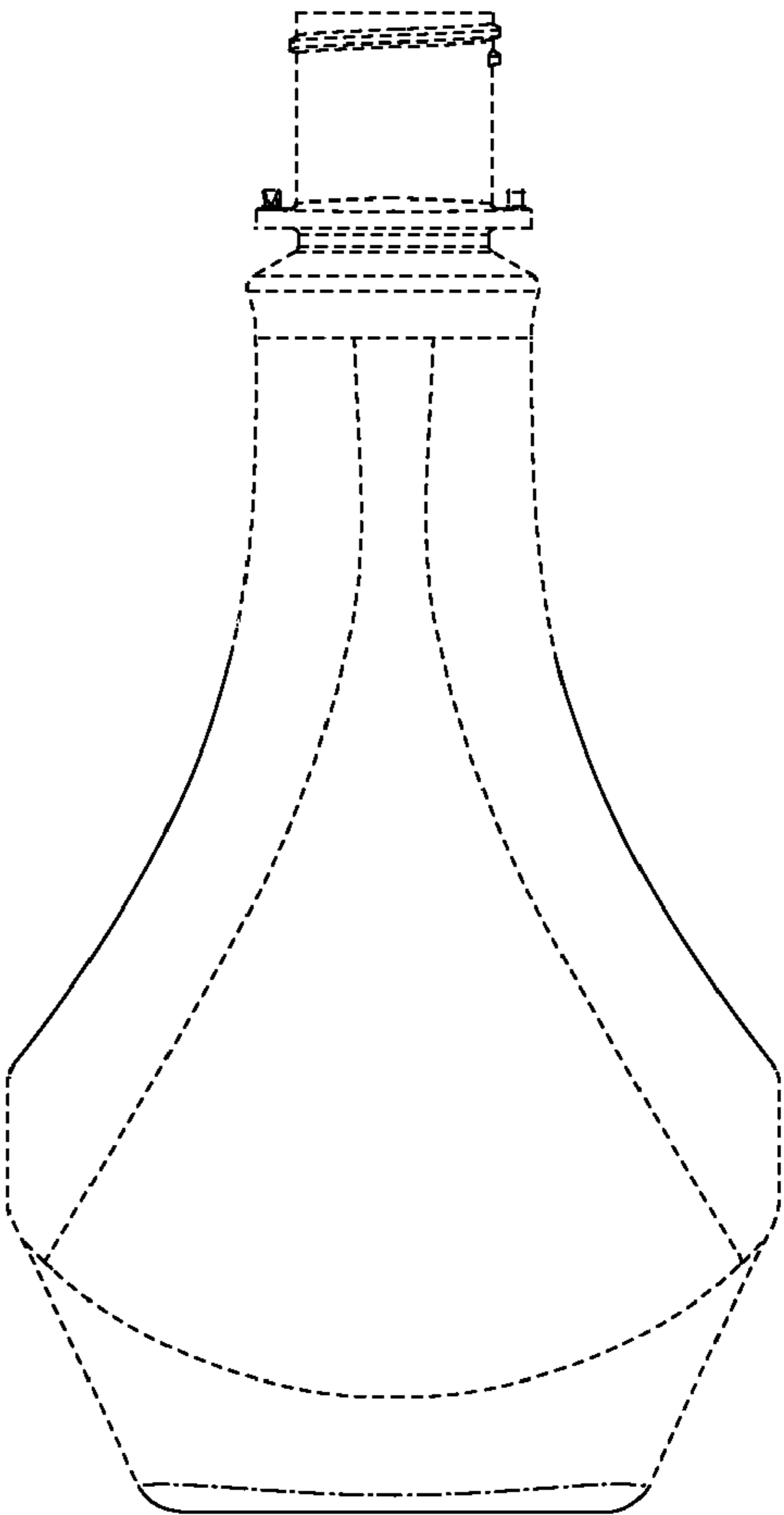

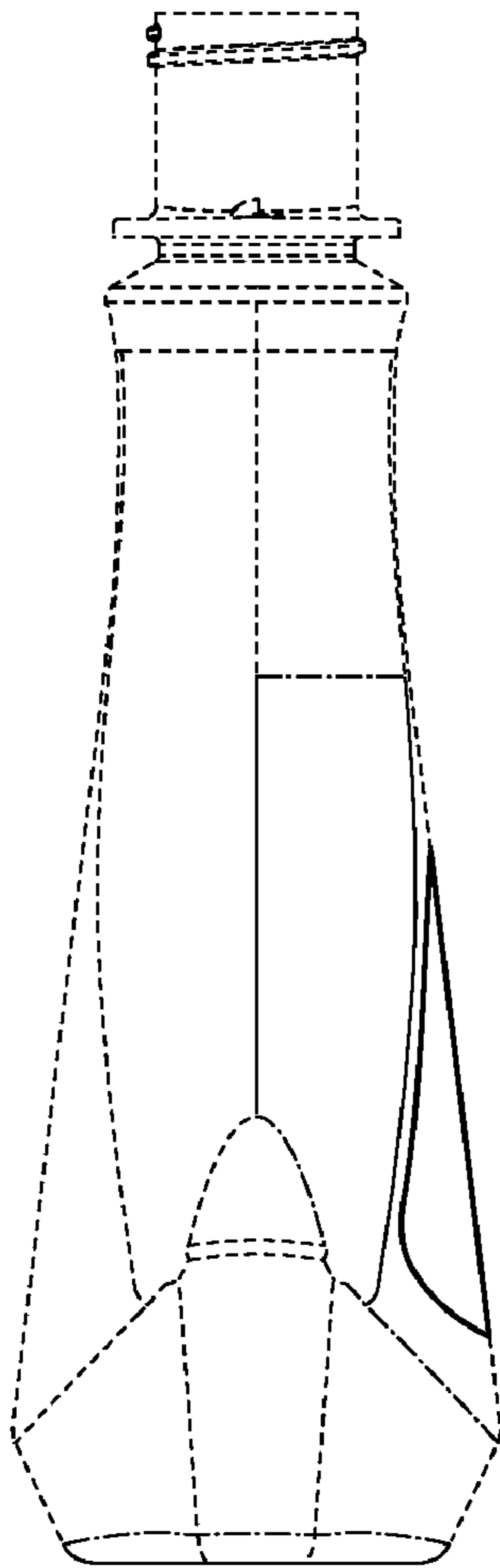

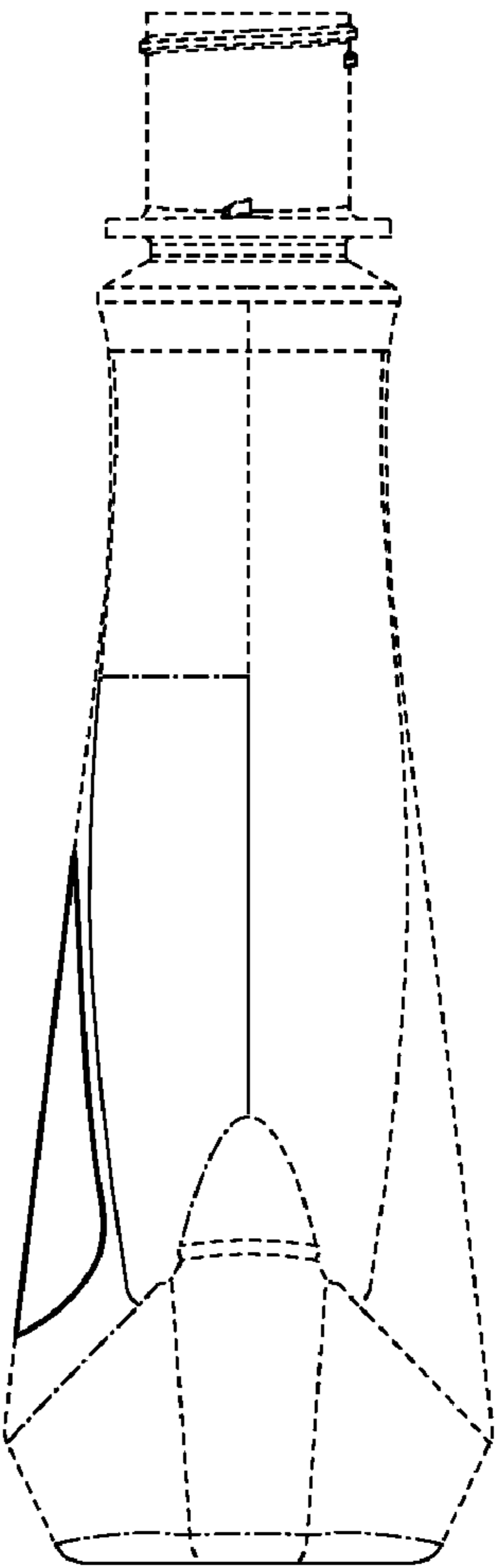

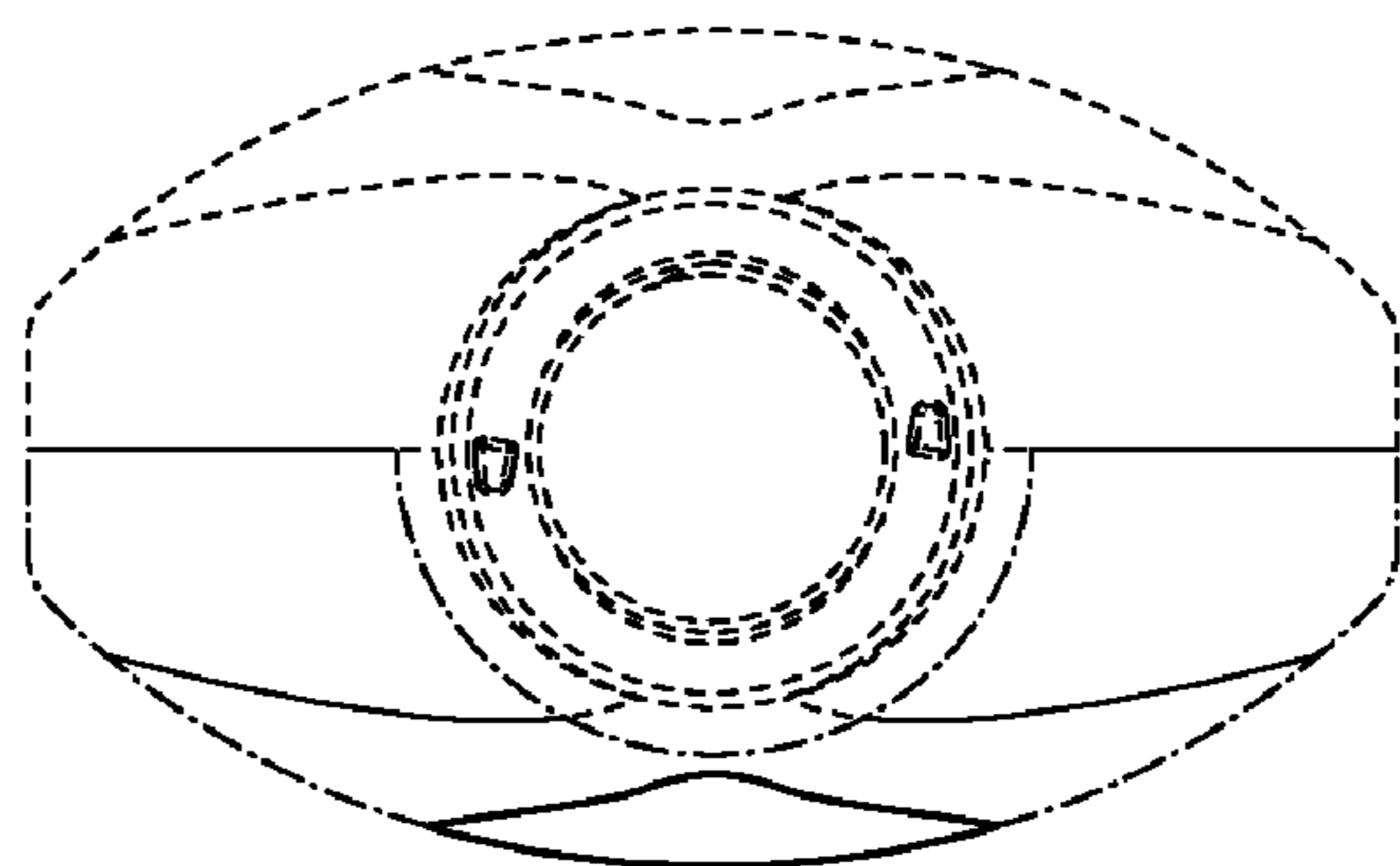

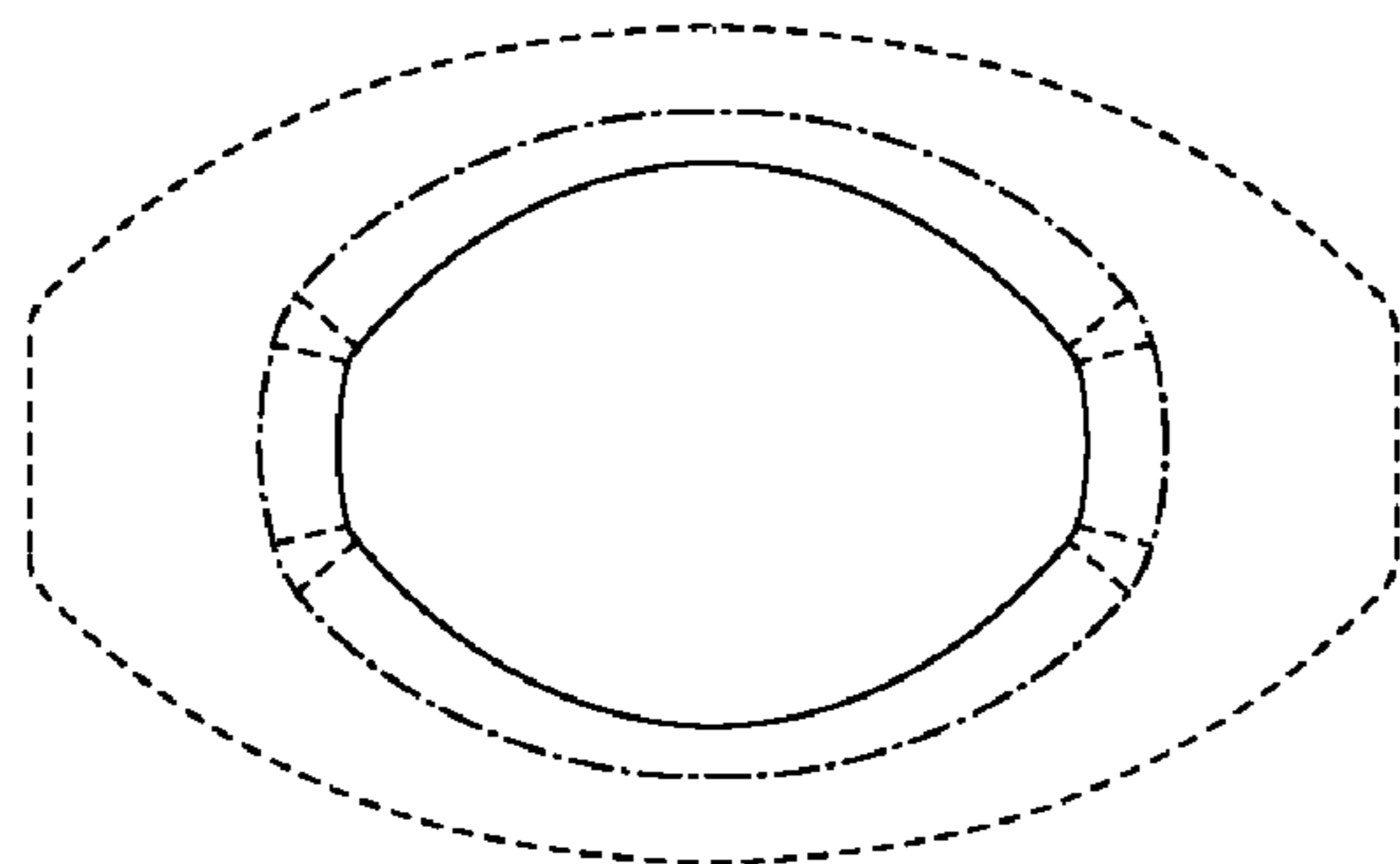
