FIG. 2 is a top view of the packaging;

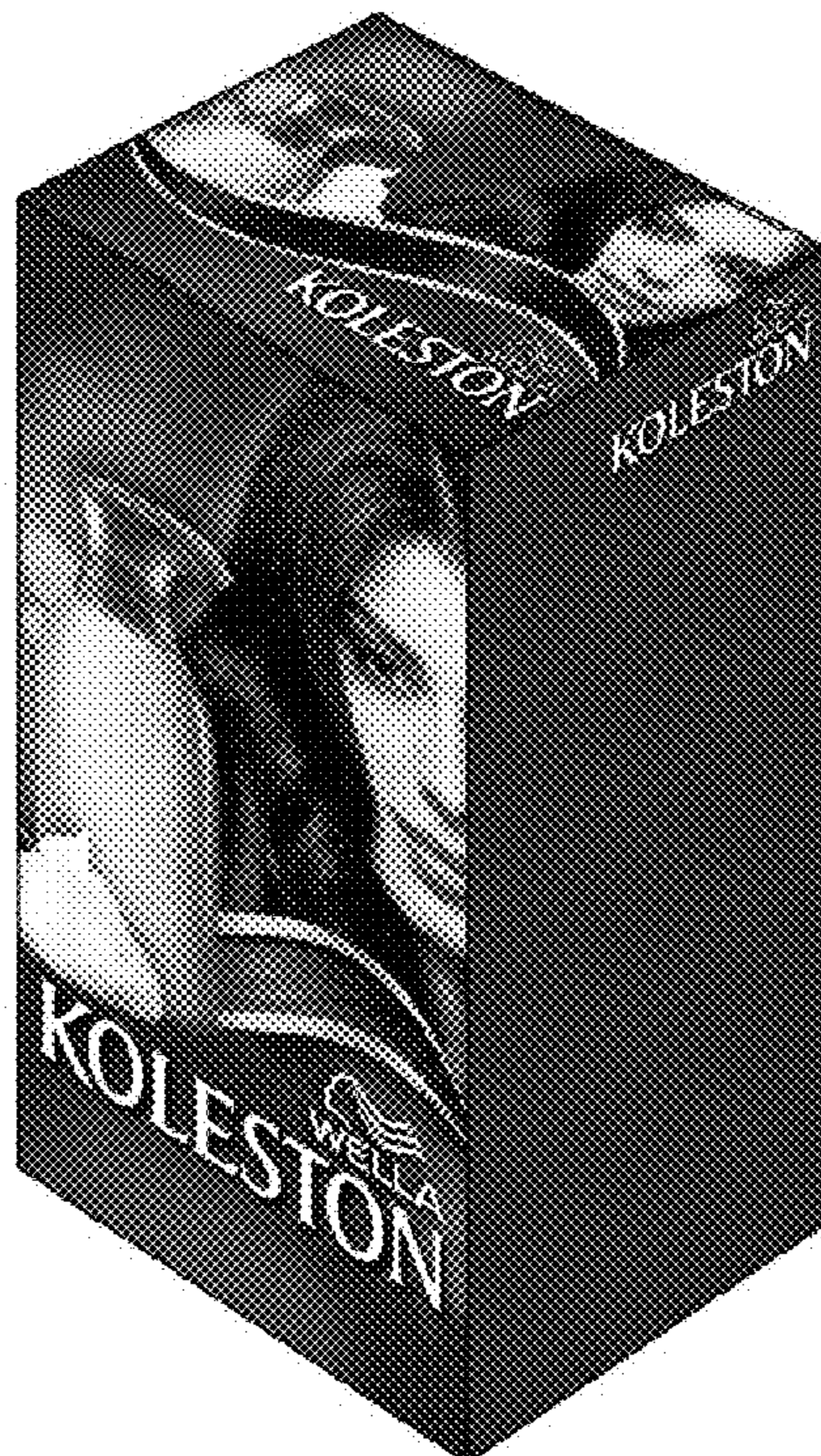
FIG. 3 is a front view of the packaging;

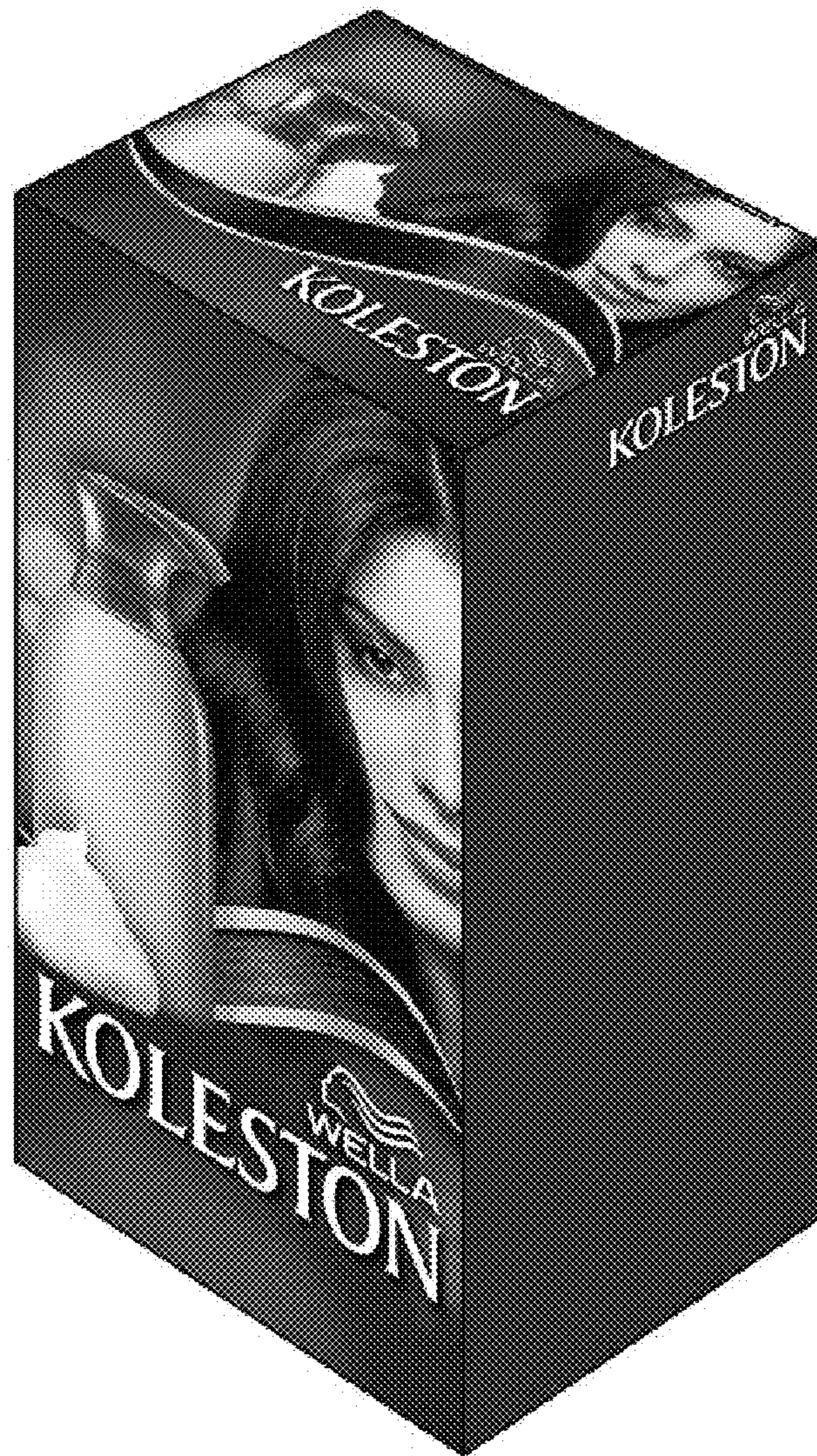

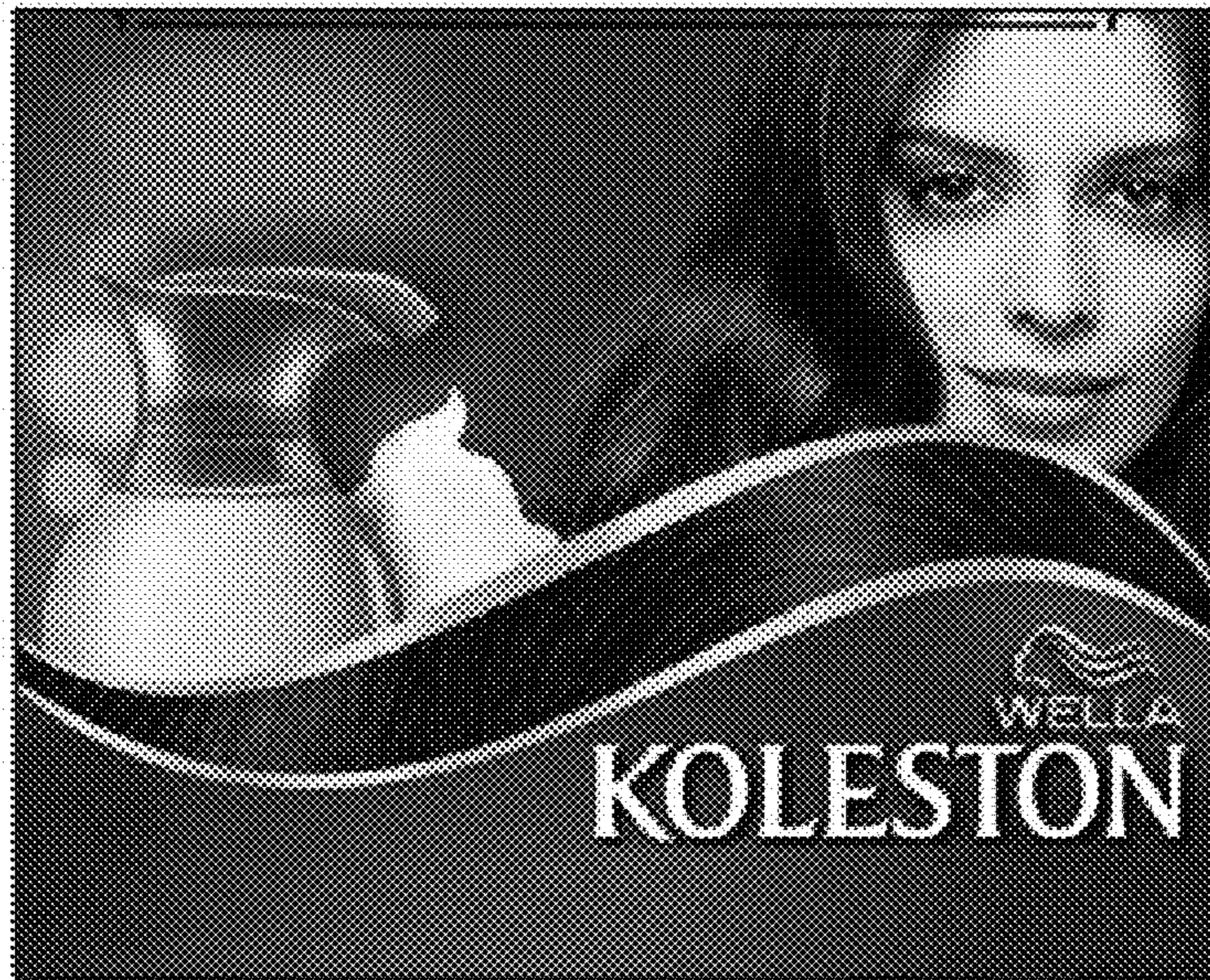

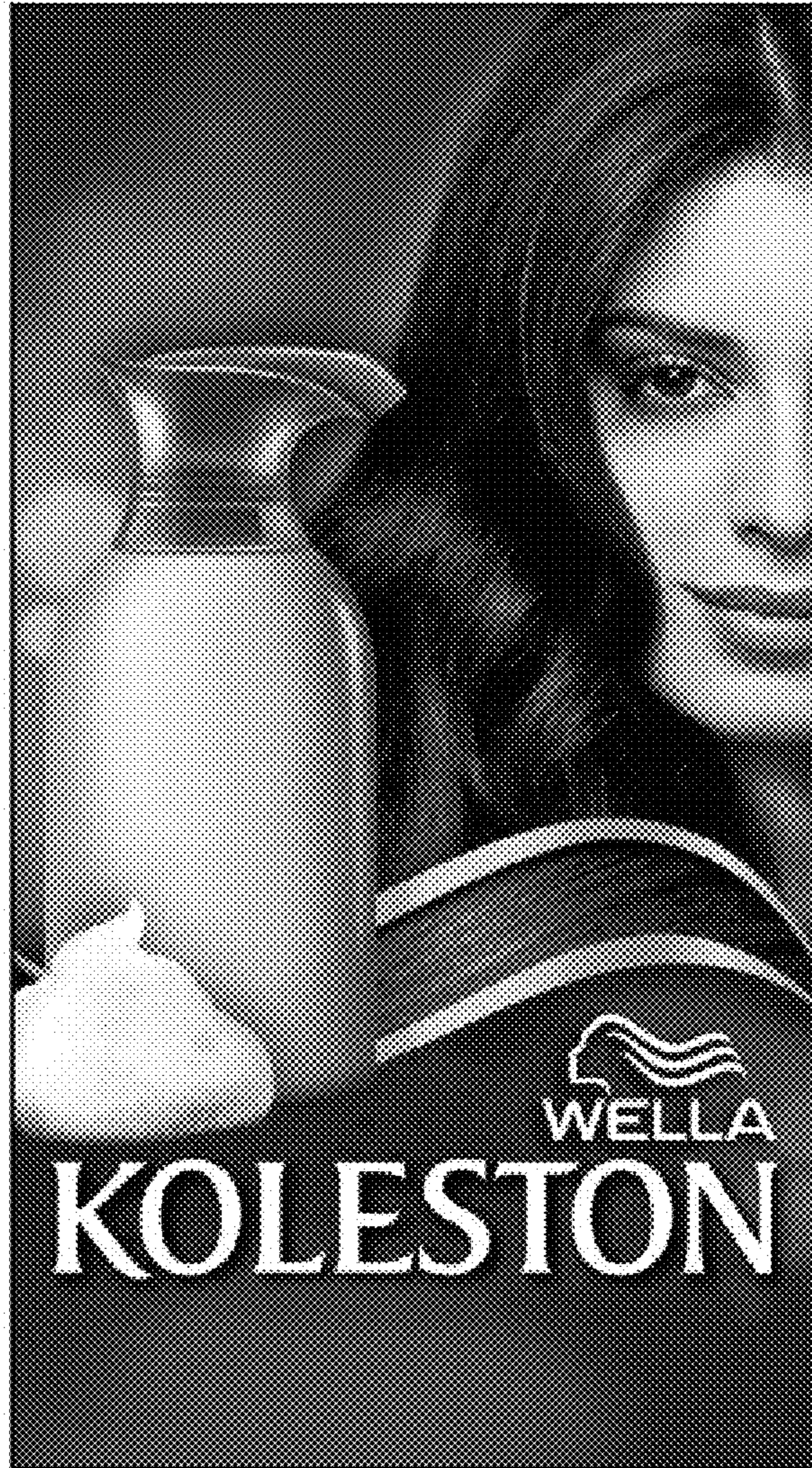

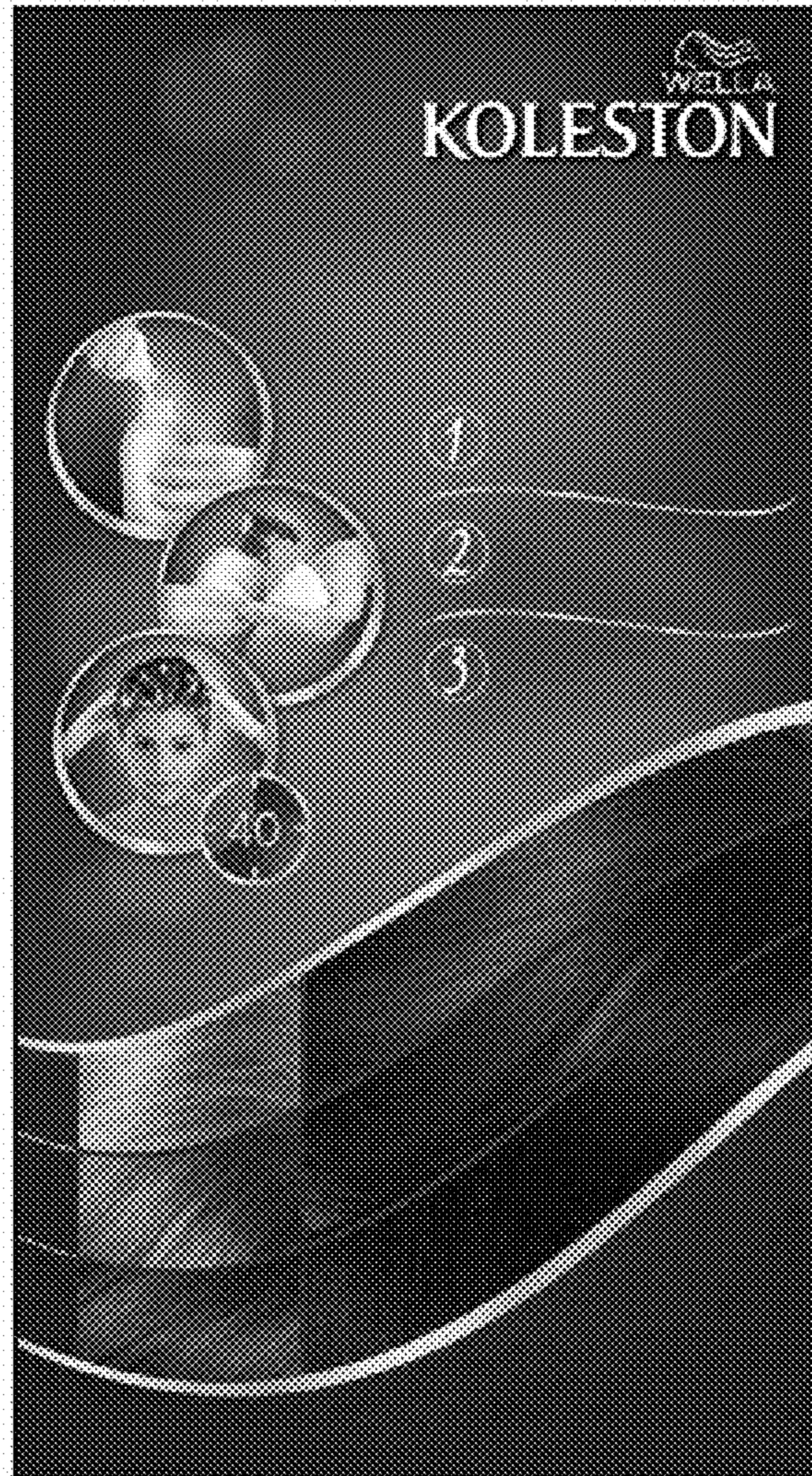

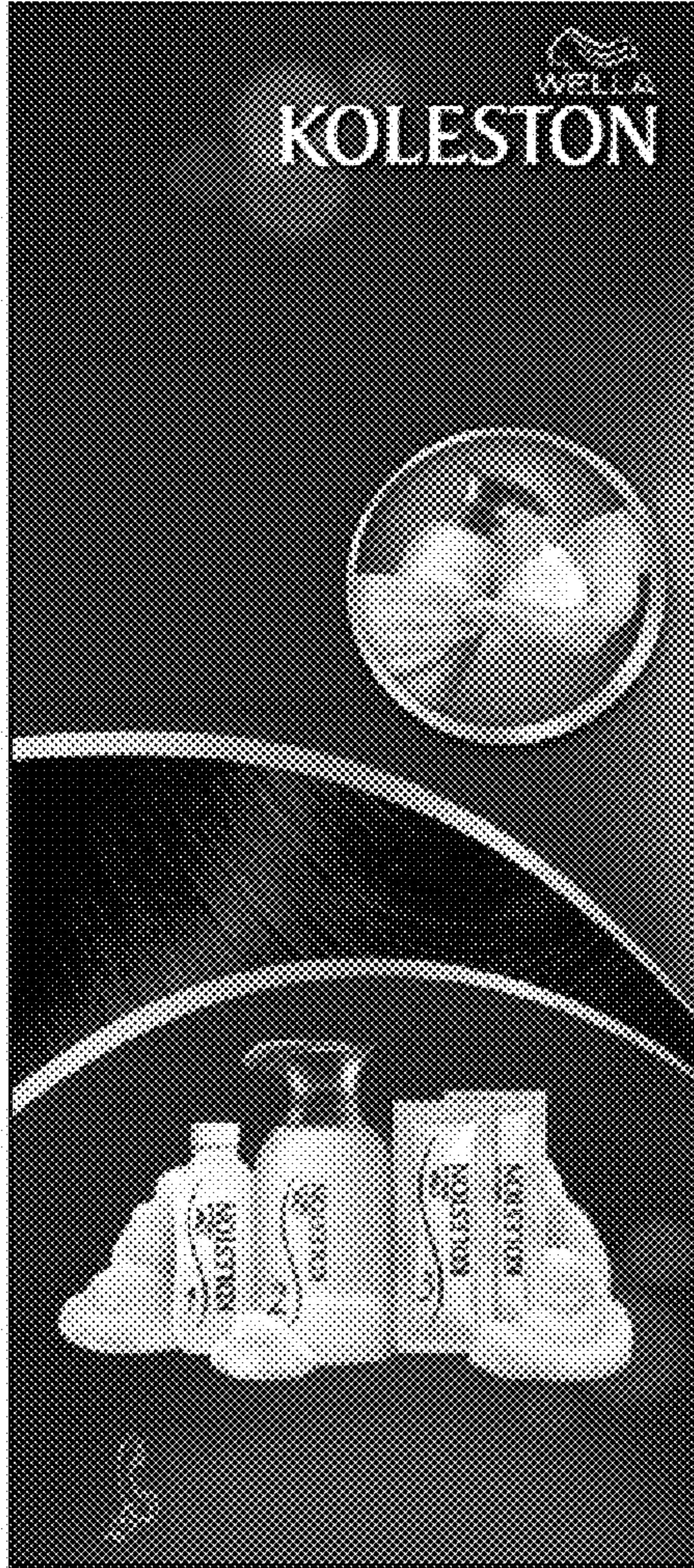
