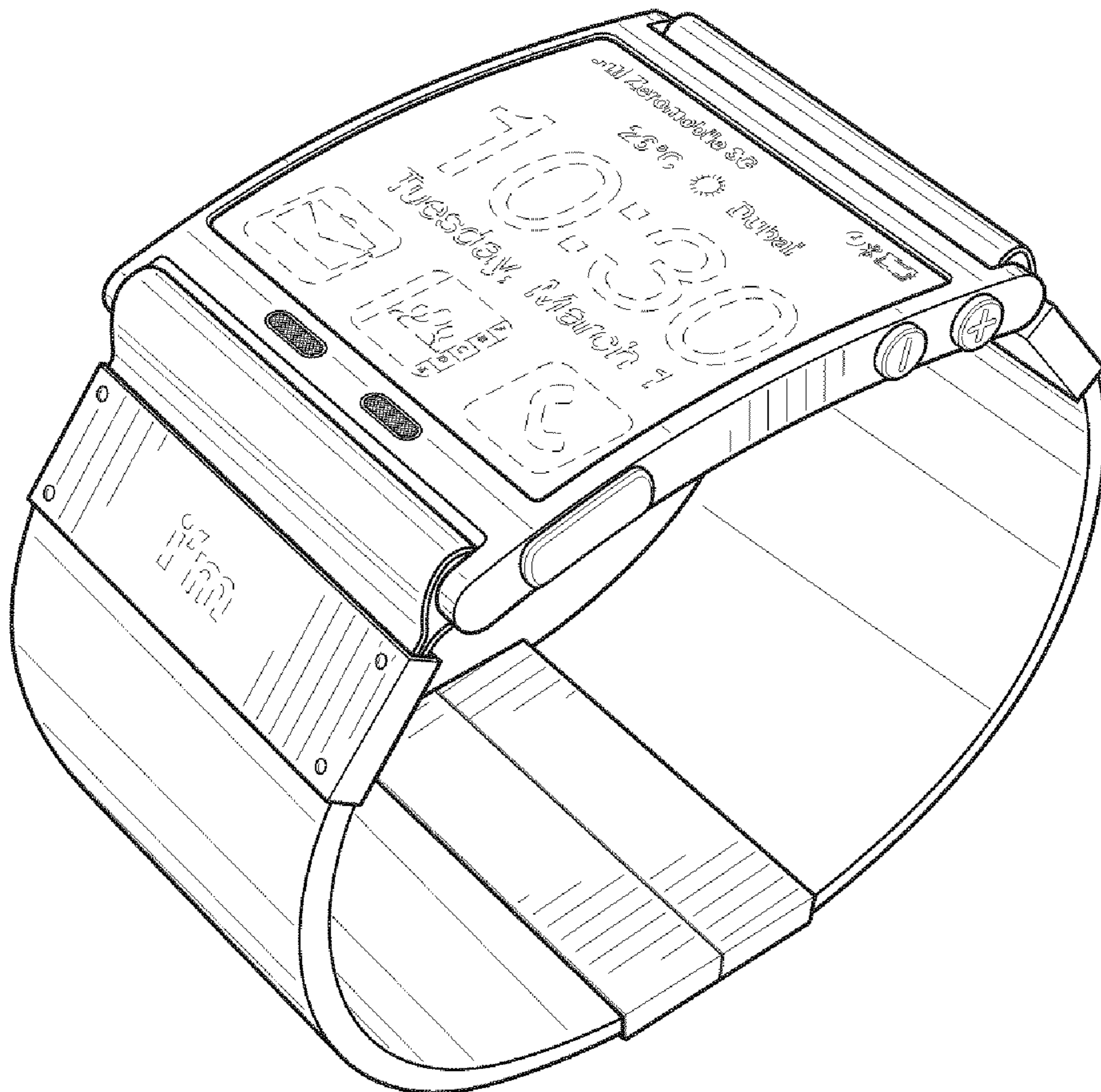
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper perspective view of the wrist watch showing our new design;
FIG. 2 is a top plan view thereof;

FIG. 4 is a front elevation view thereof;
FIG. 5 is a side elevation view thereof;

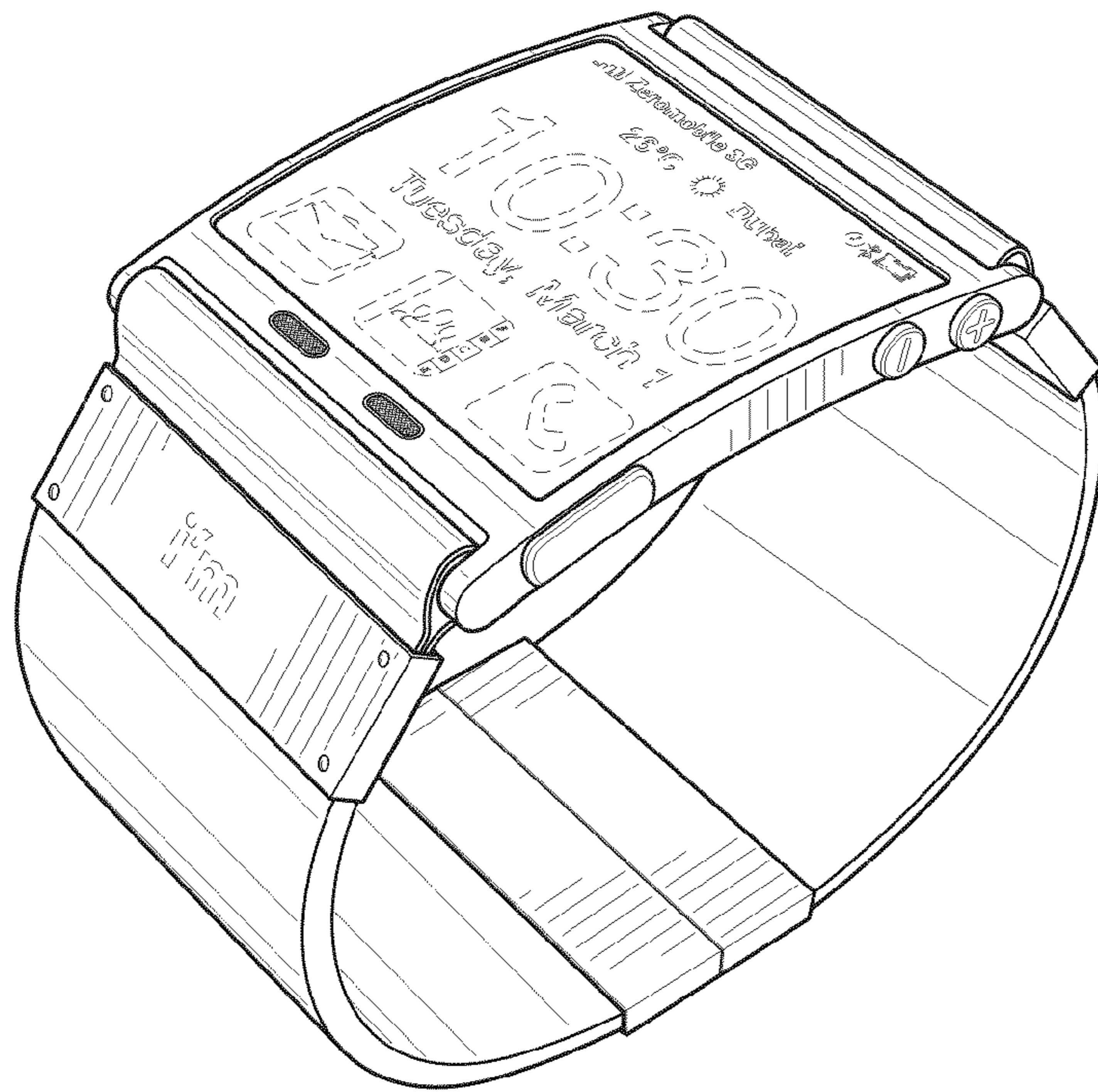

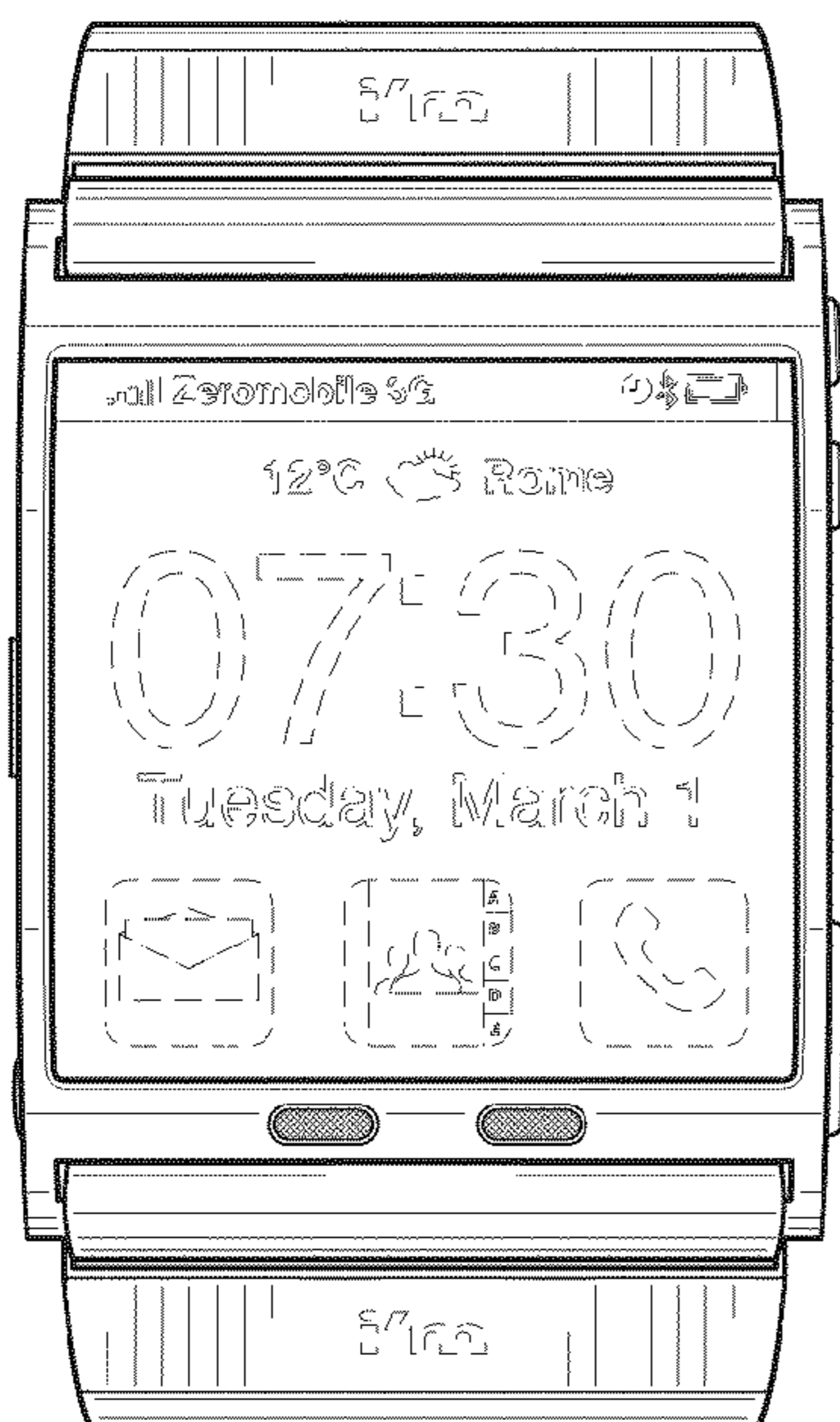

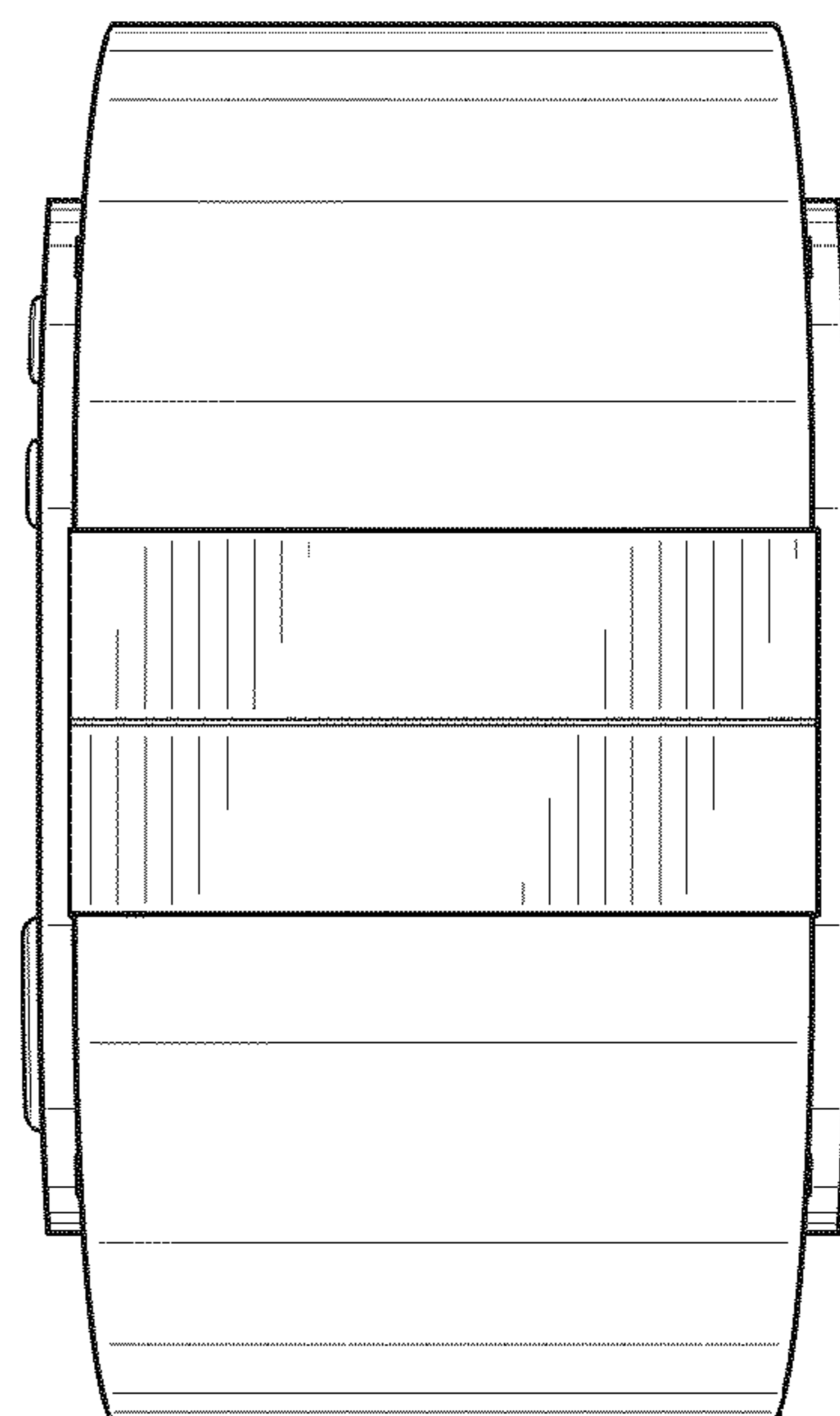

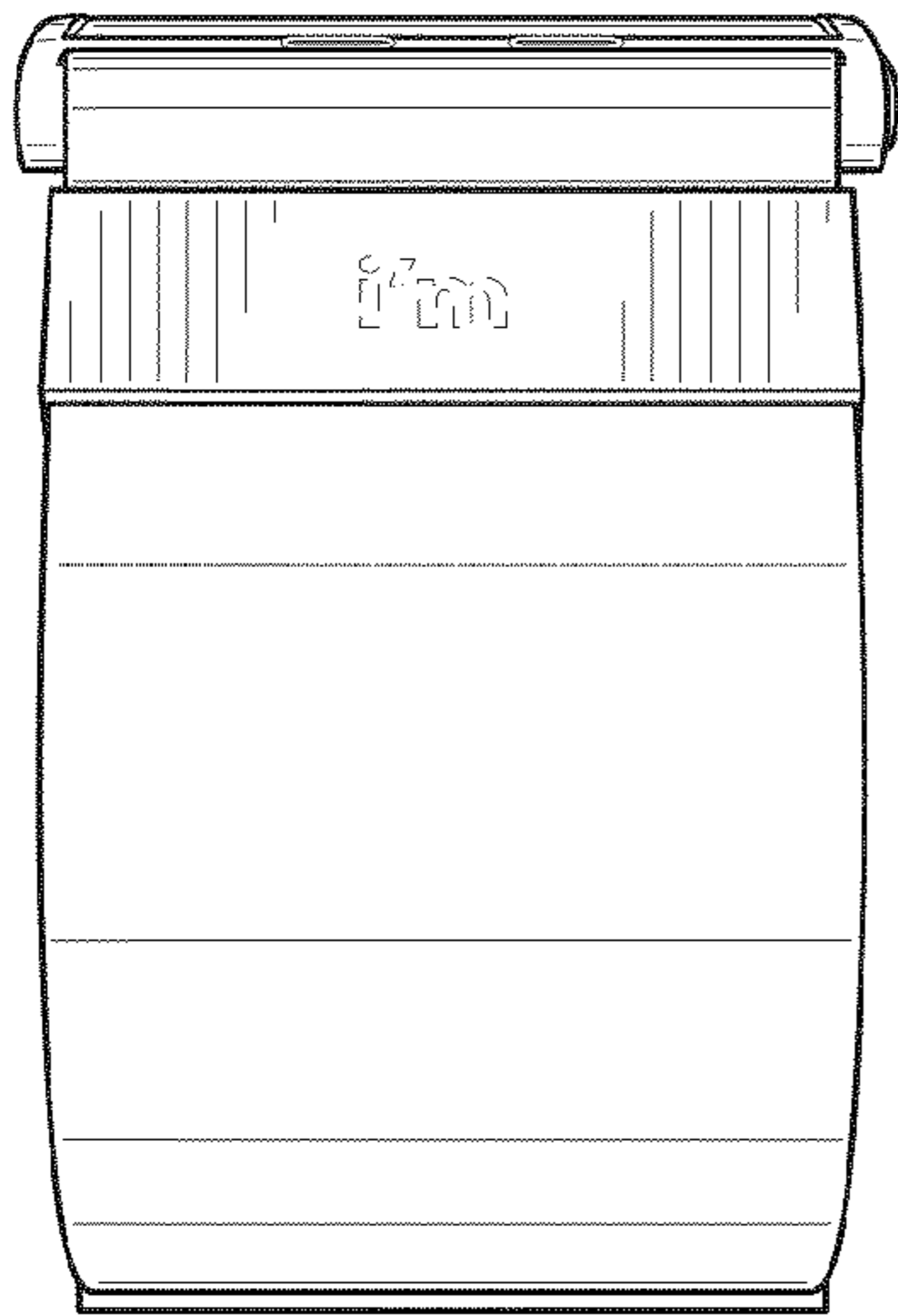

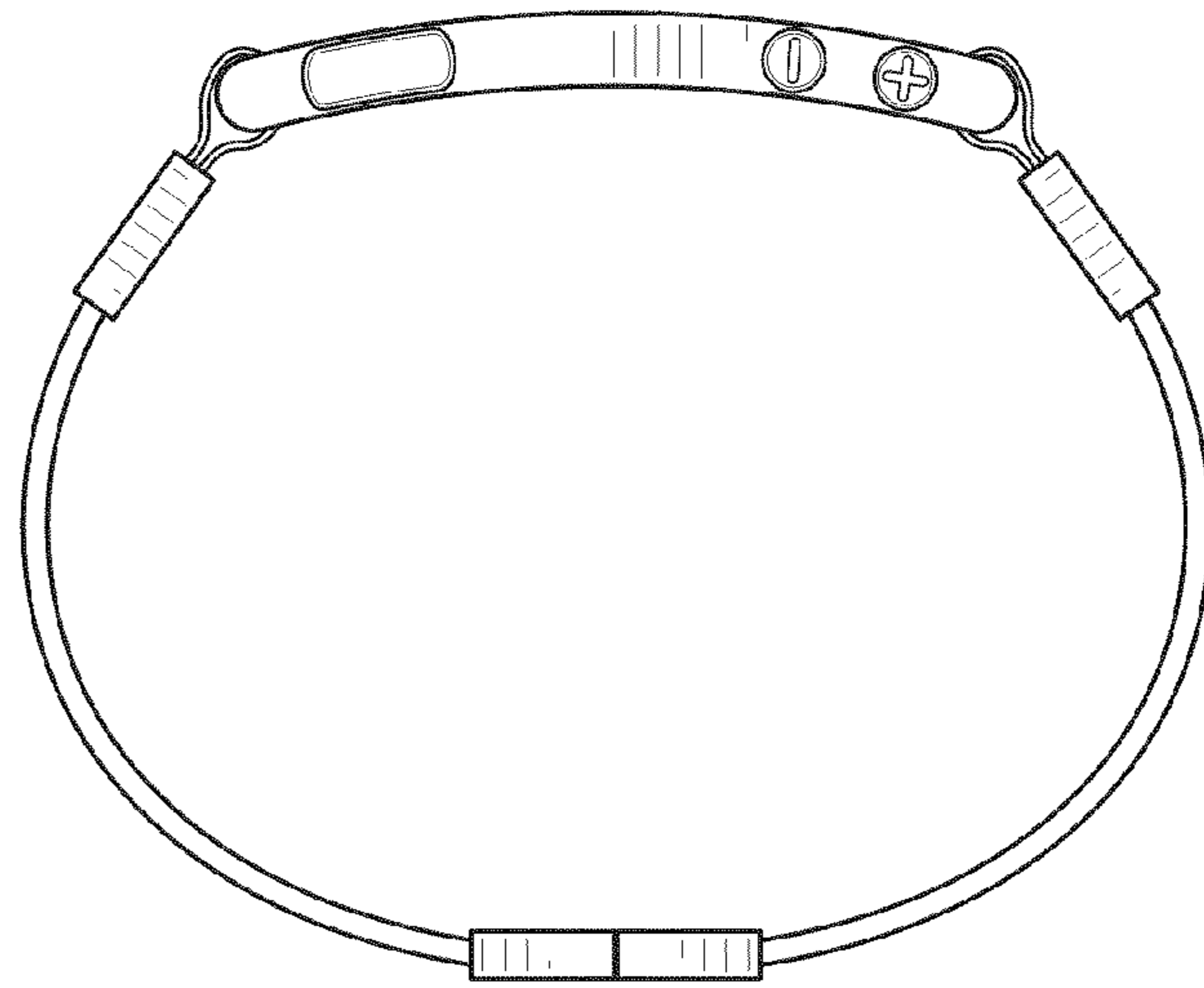

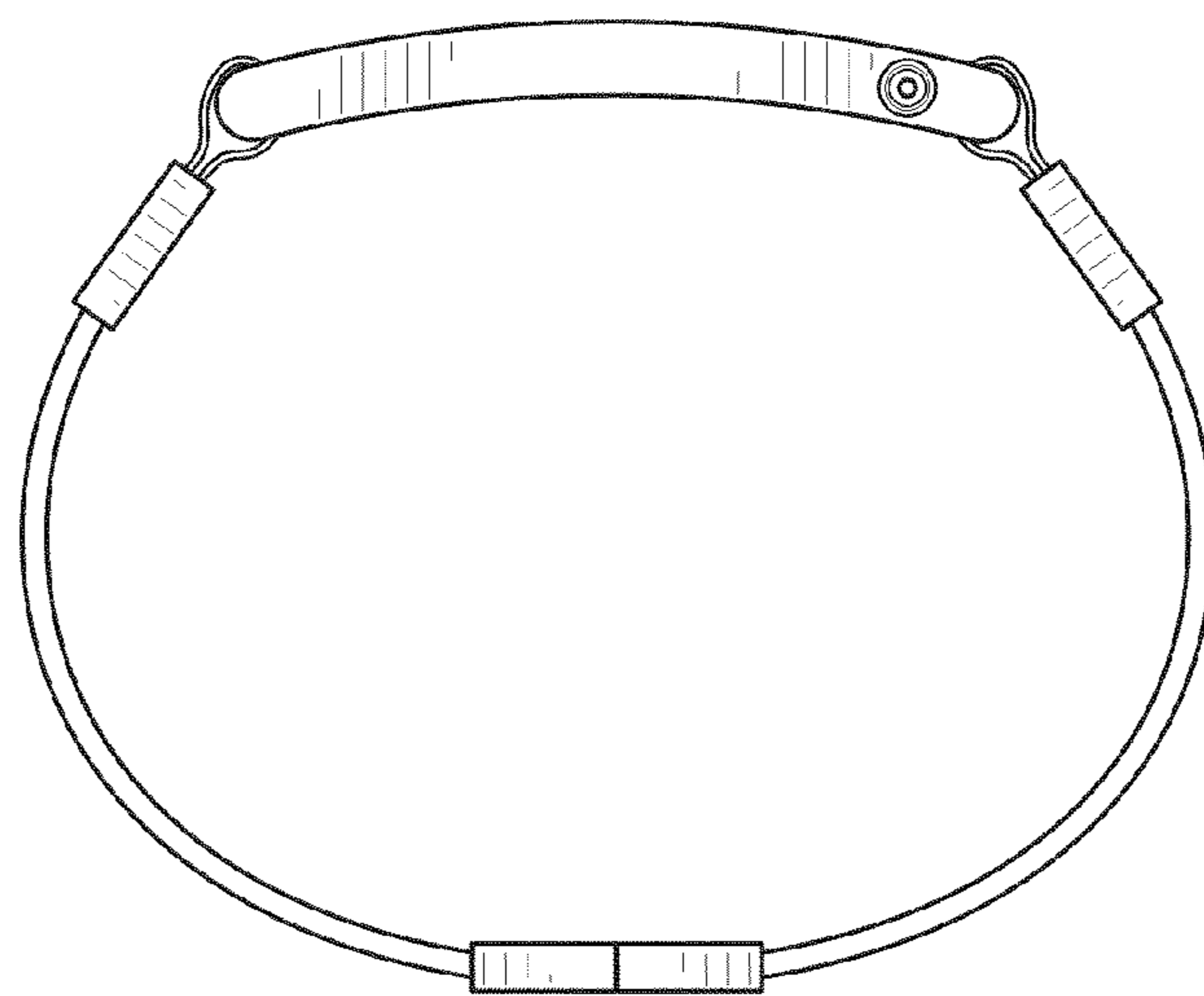

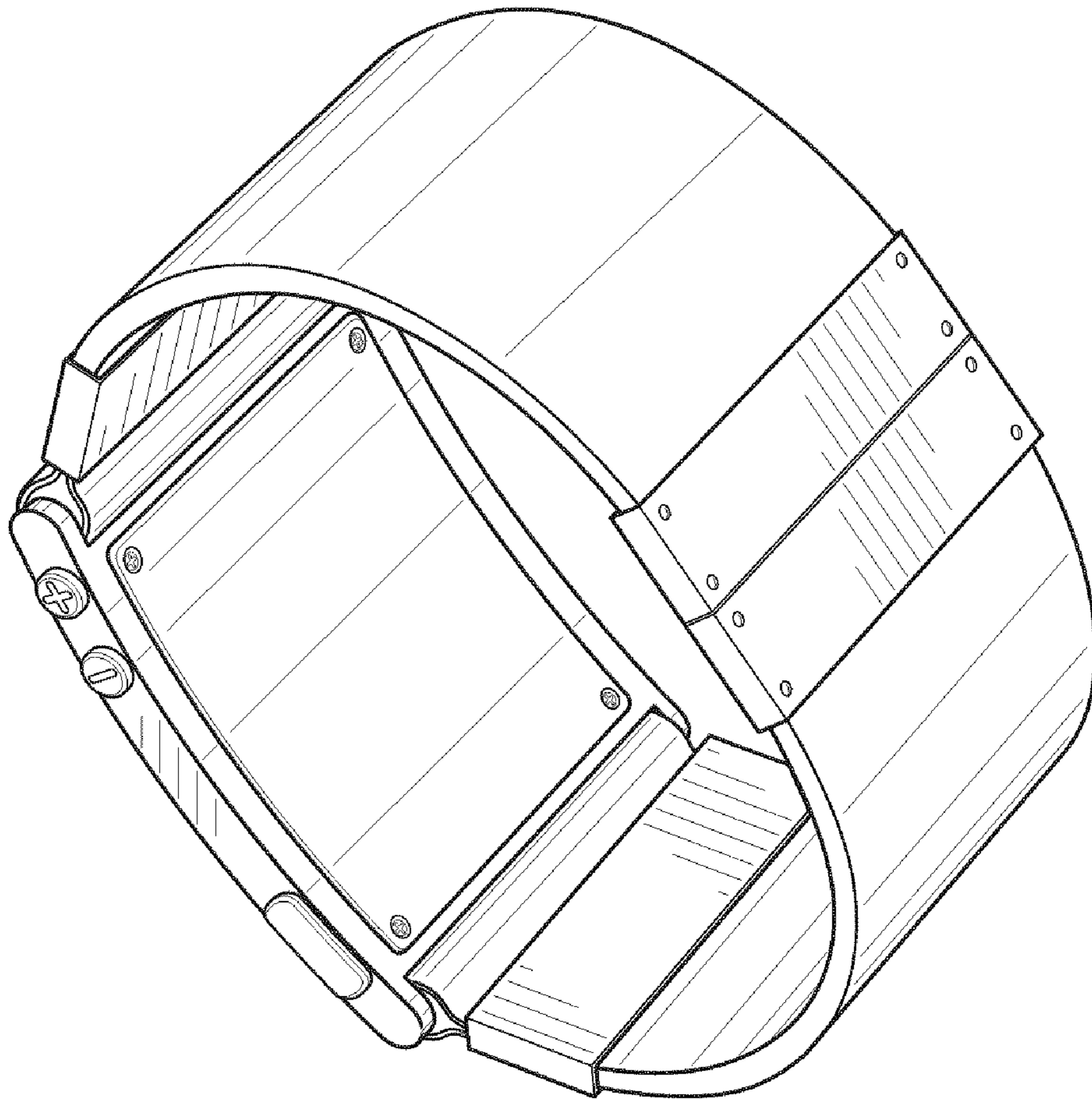
