DESCRIPTION

FIG. 1 is a front view of a watch showing our new design;

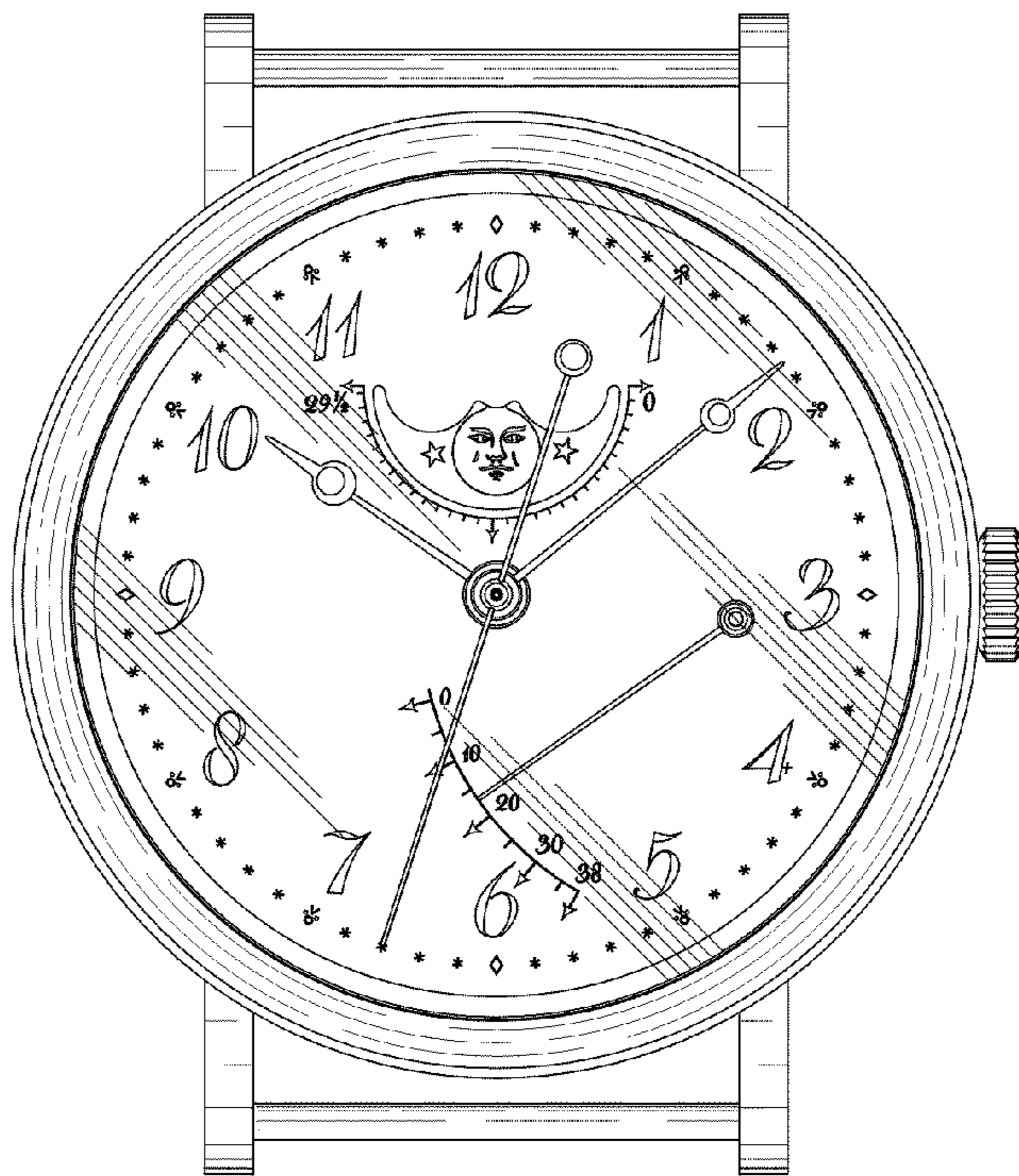

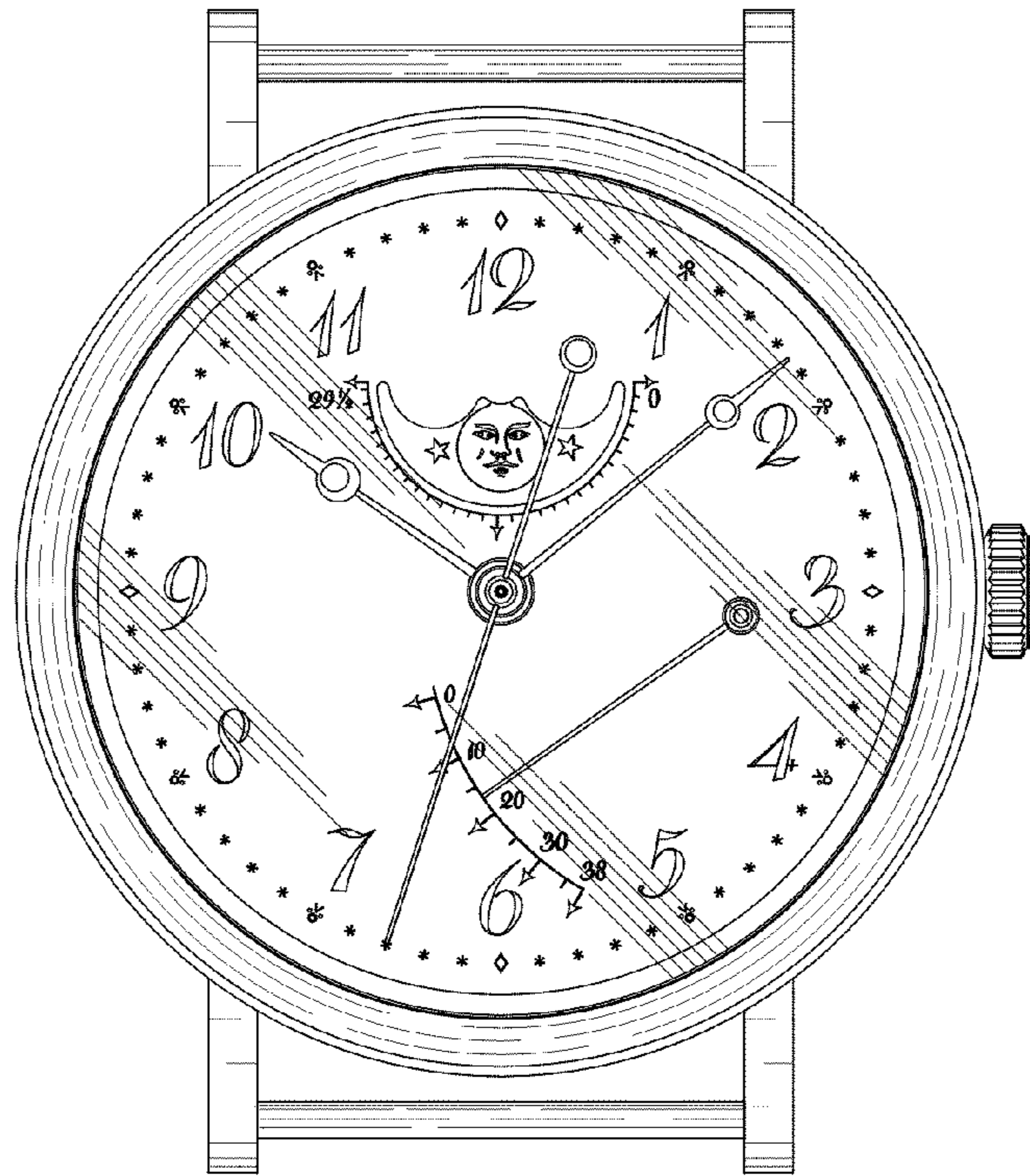

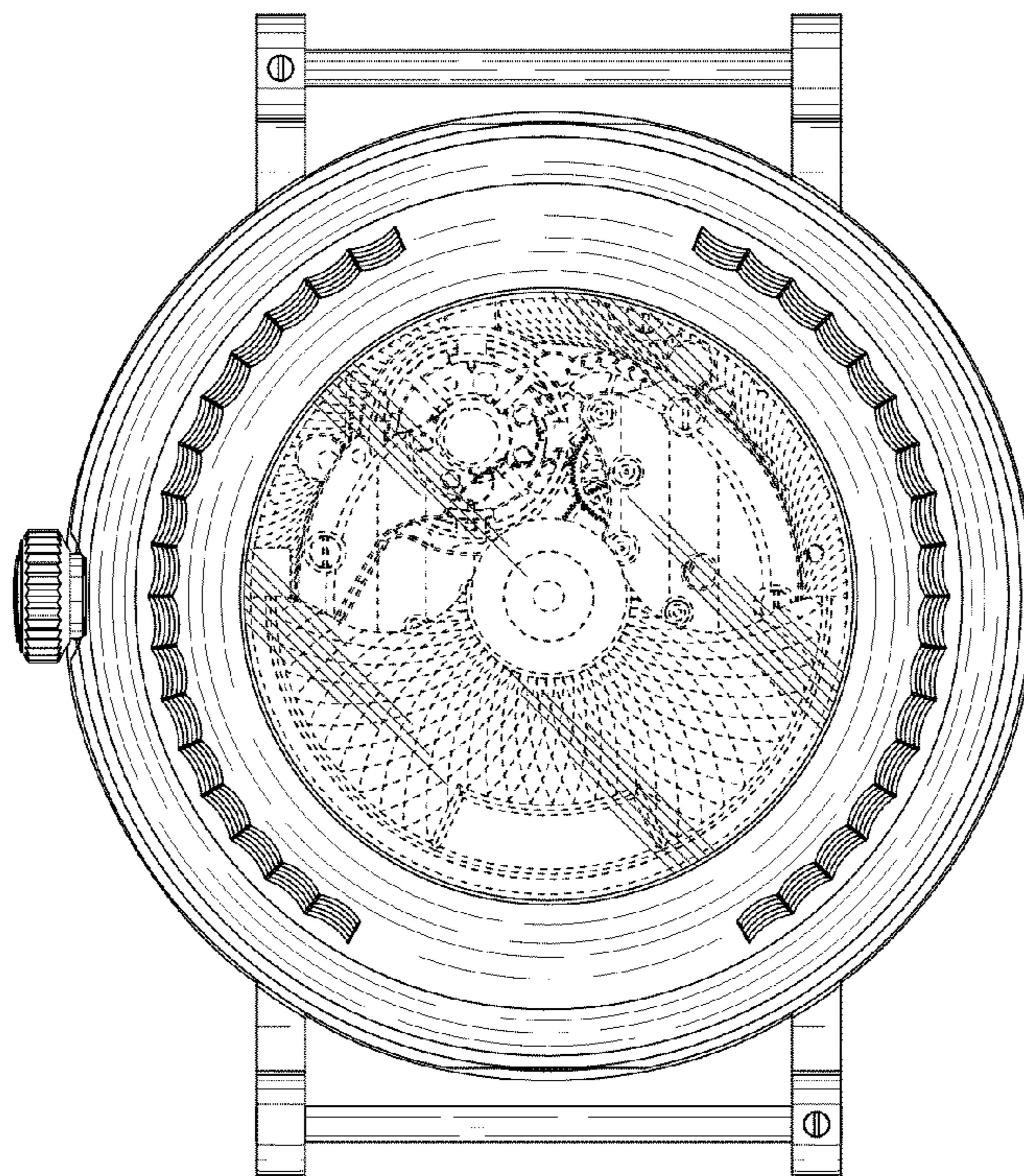

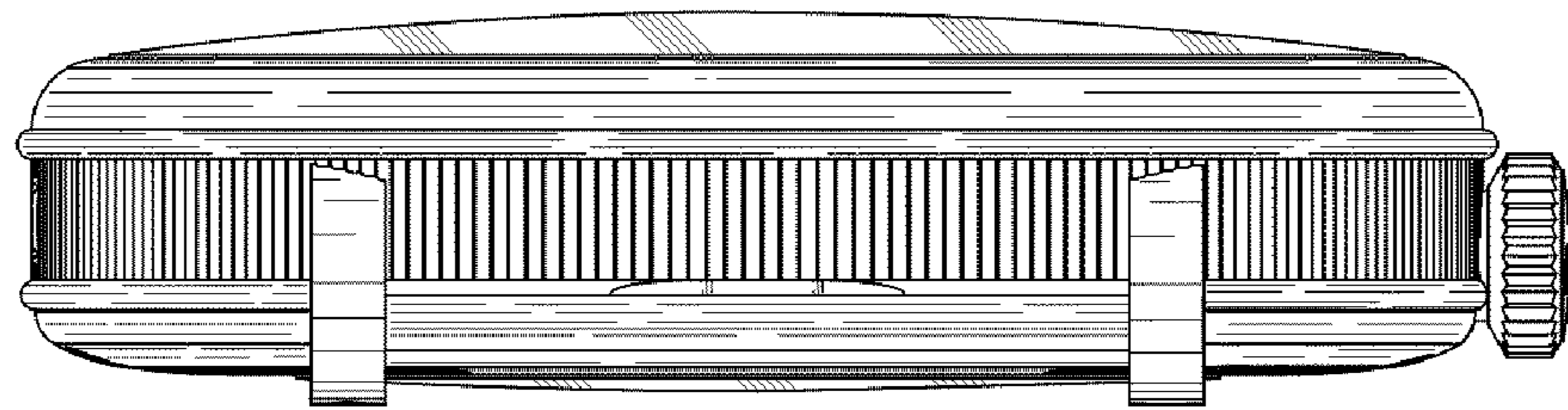

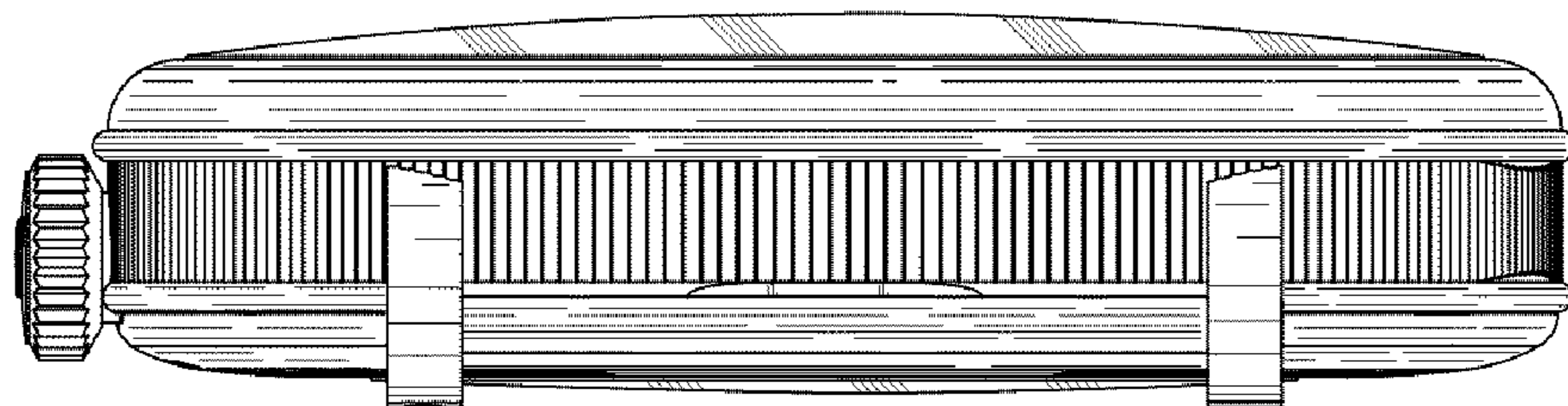

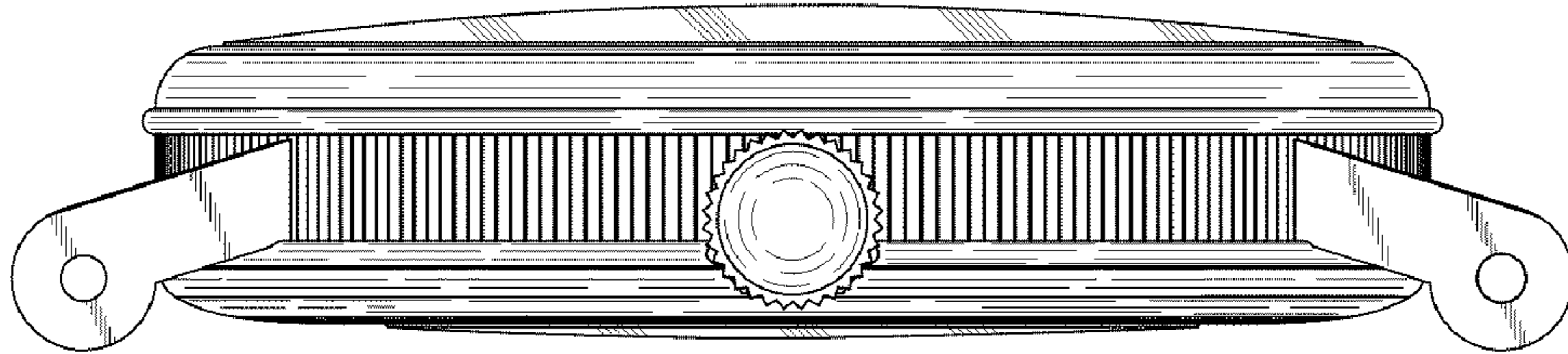

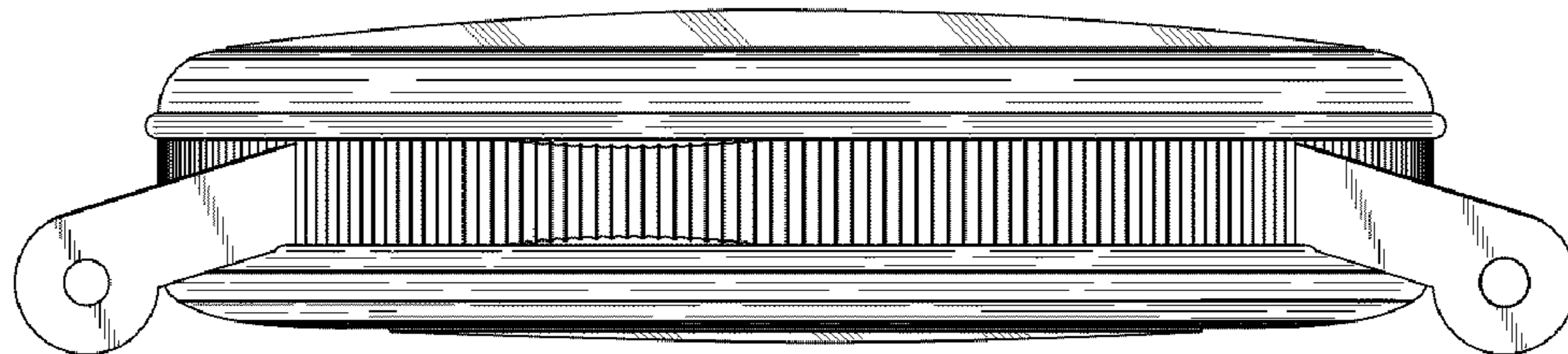
