(57) **CLAIM**

The ornamental design for a child alert transmitter and key
fob receiver set for a car seat, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a child alert transmitter and
key fob receiver set for a car seat showing our new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a right elevation view thereof;
FIG. 4 is a left elevation view thereof;
FIG. 5 is a top plan view thereof;

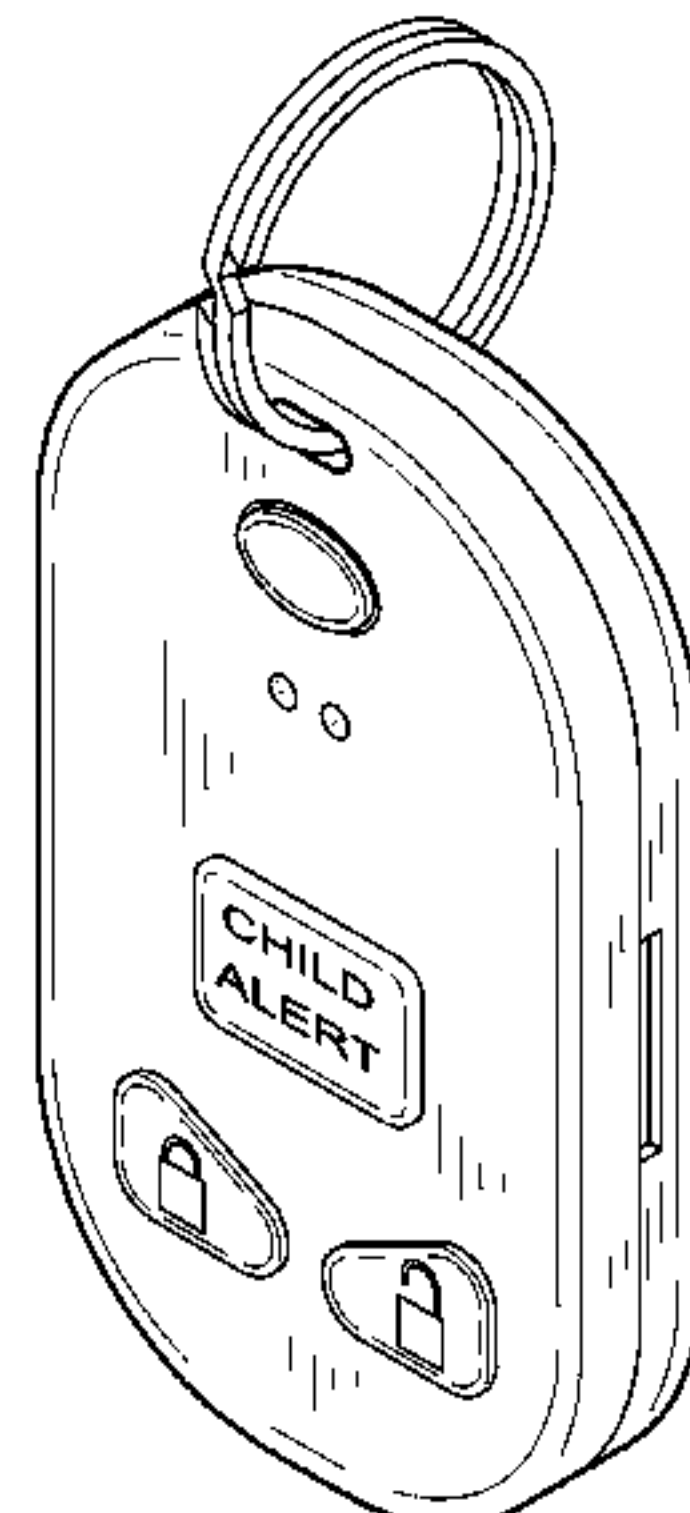
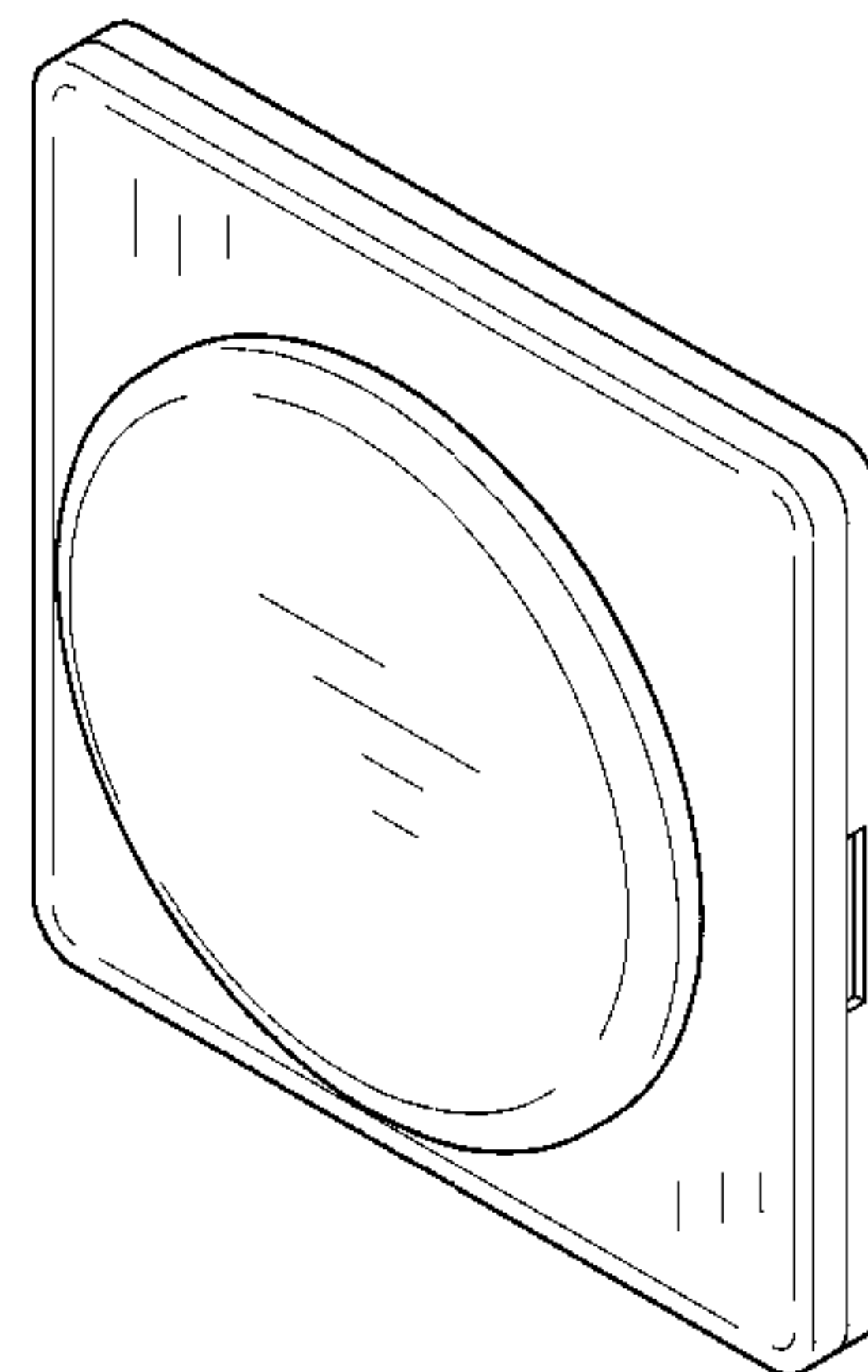
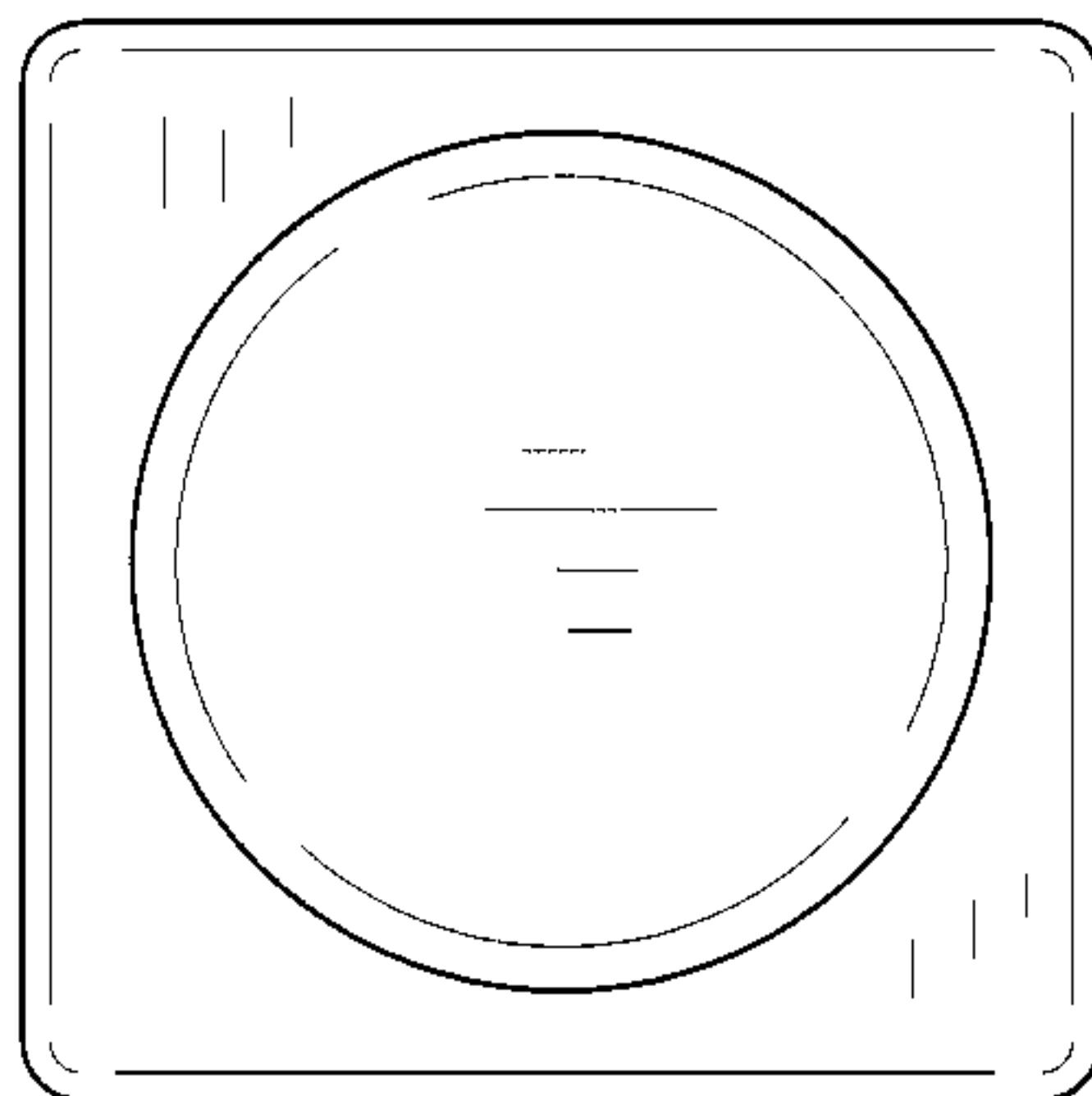

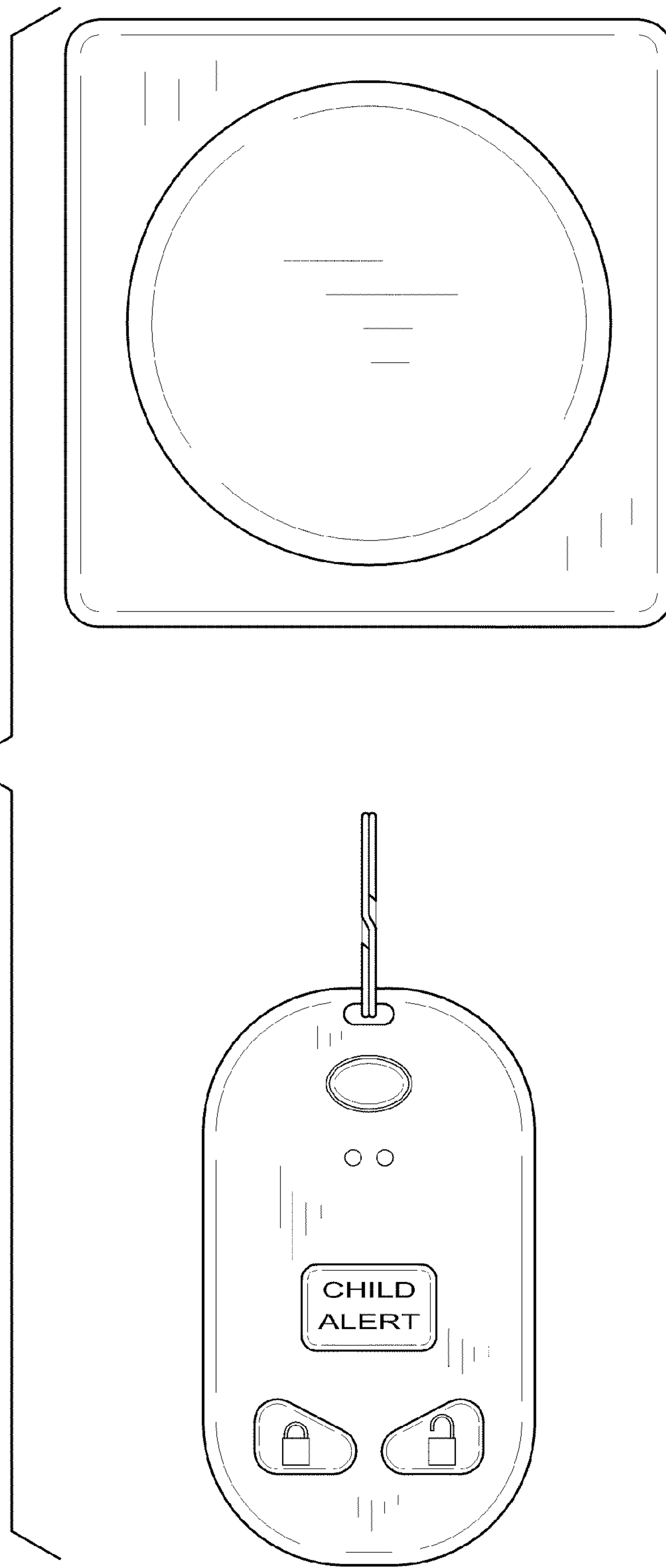
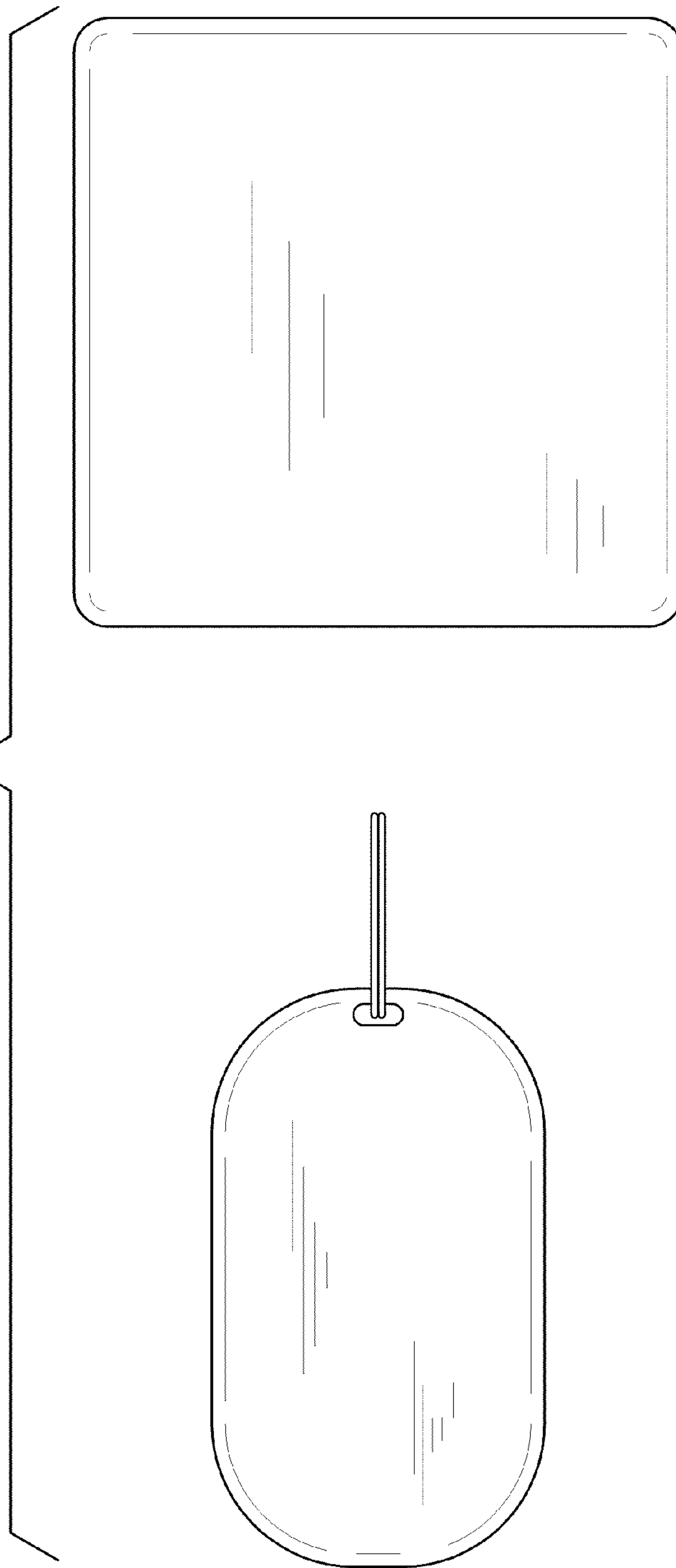

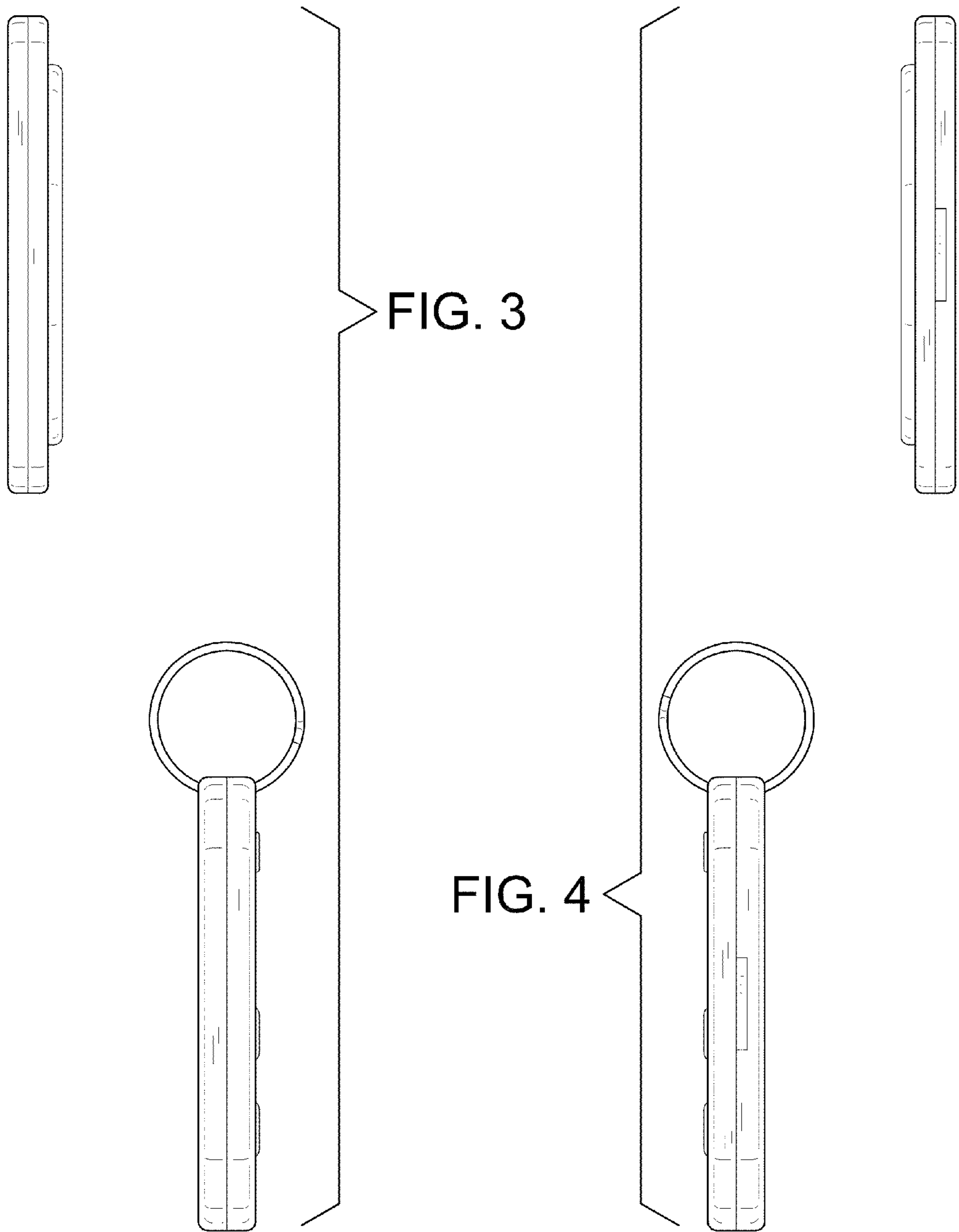

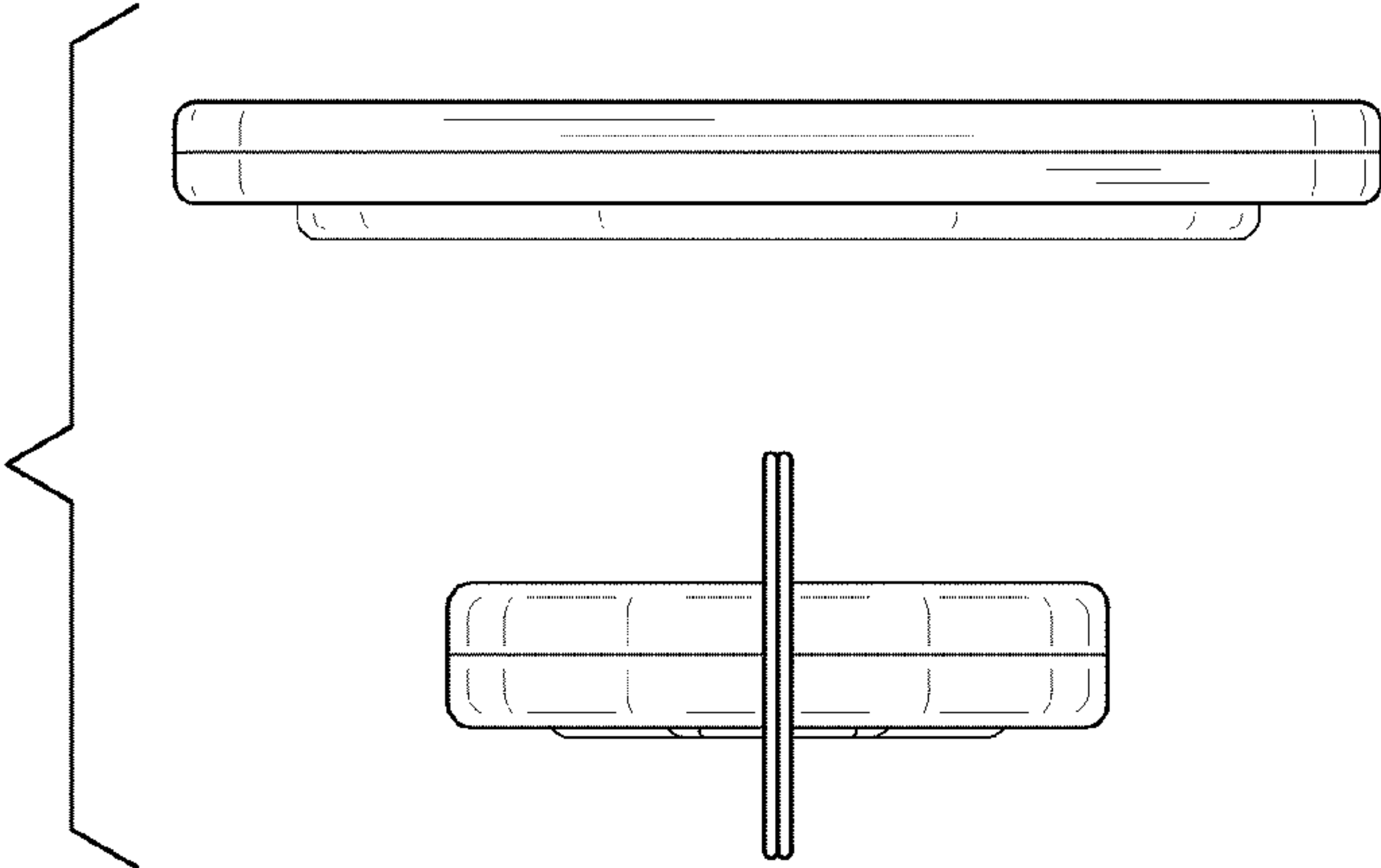

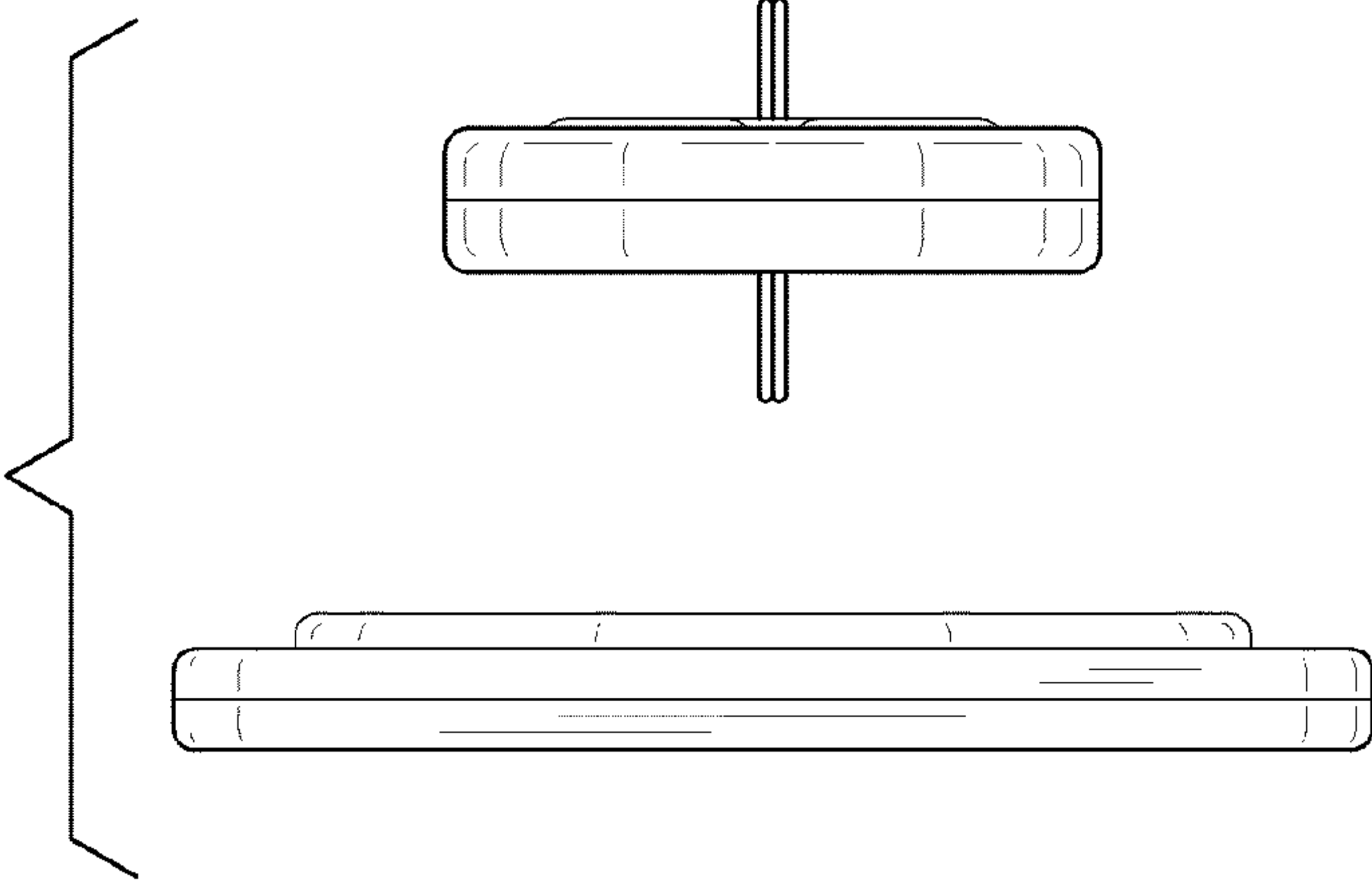
