The ornamental design of an A-pillar air deflector for a truck, as shown and described herein.

DESCRIPTION

FIG. 13 is a bottom view thereof;

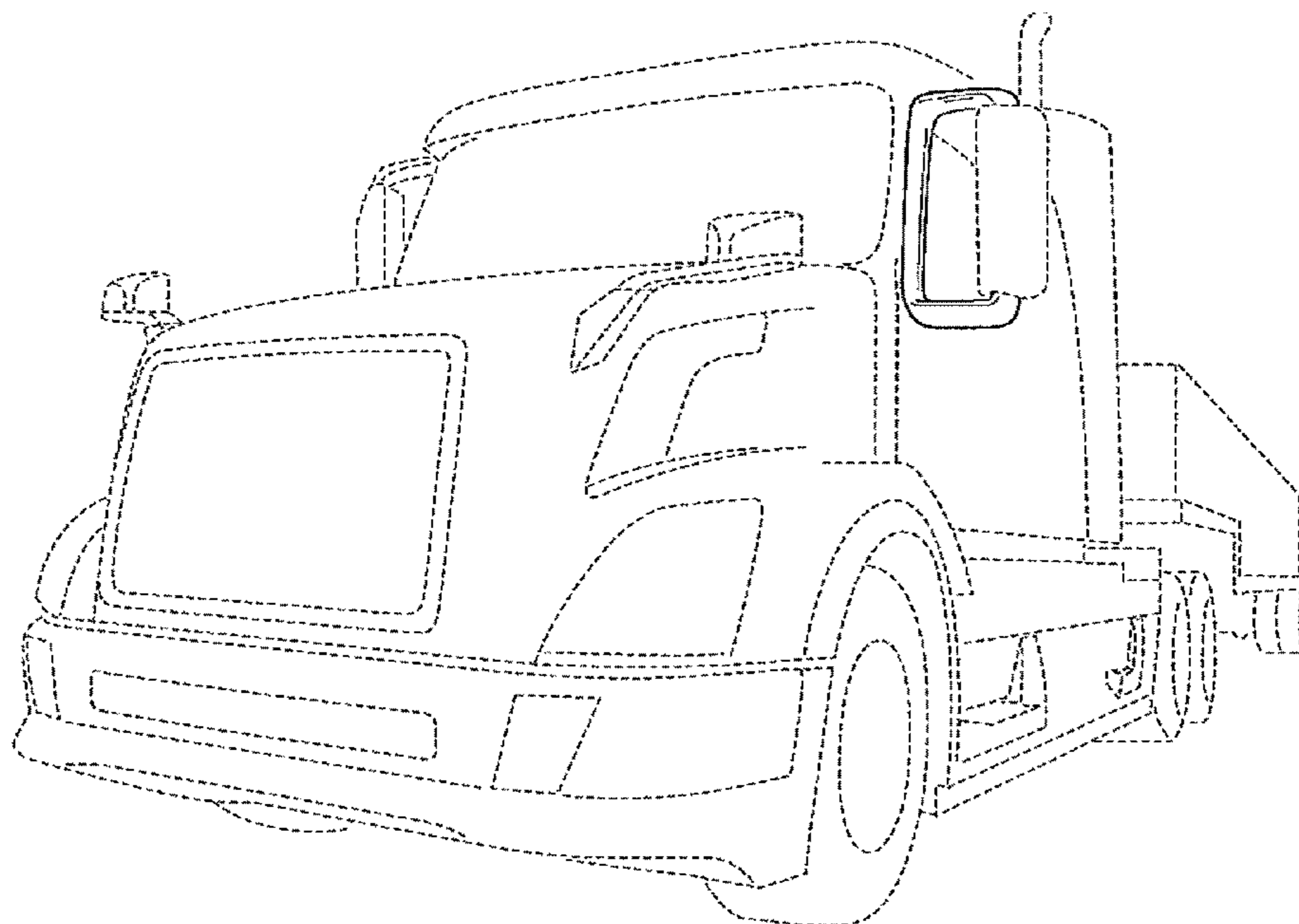
FIG. 14 is a front view thereof;

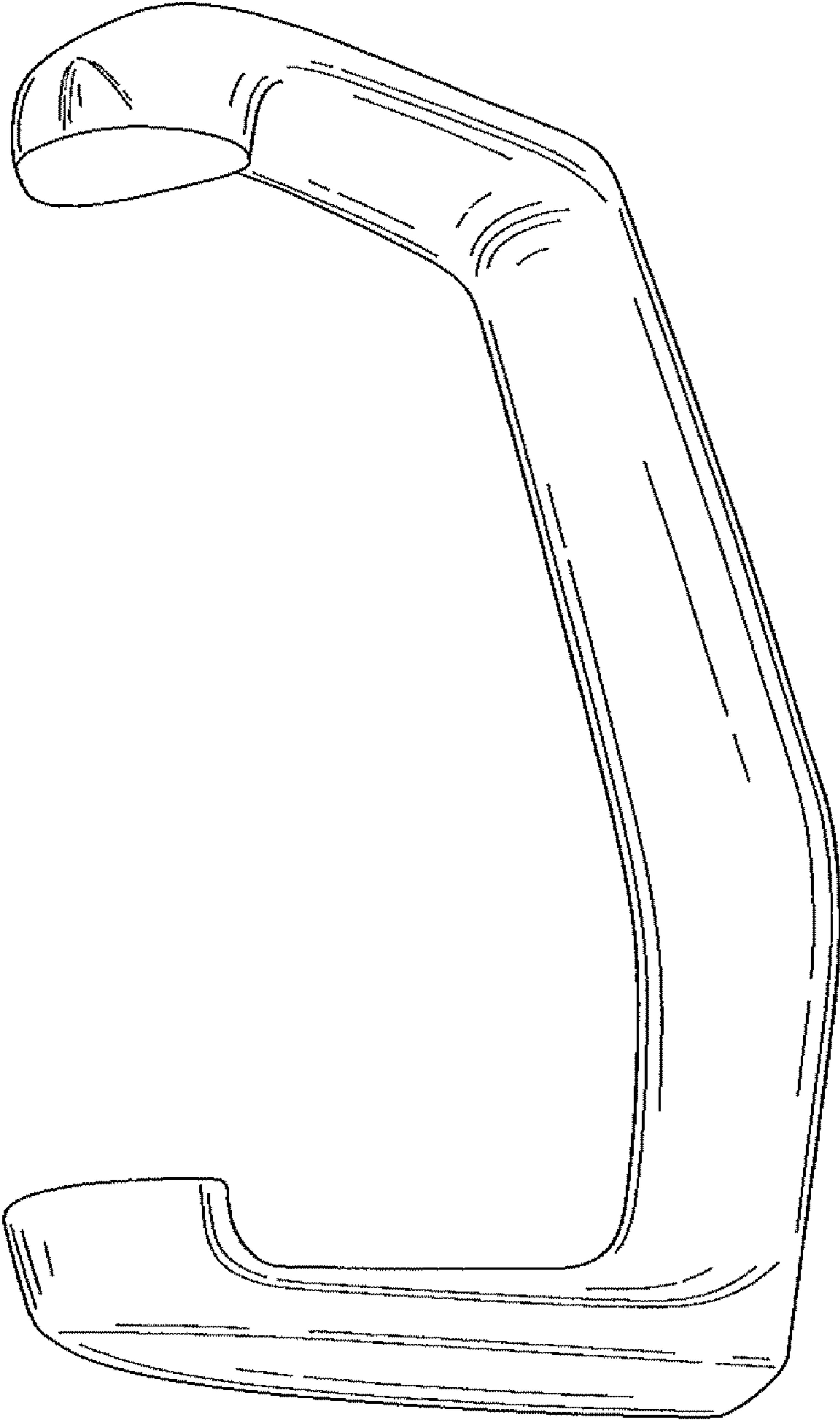

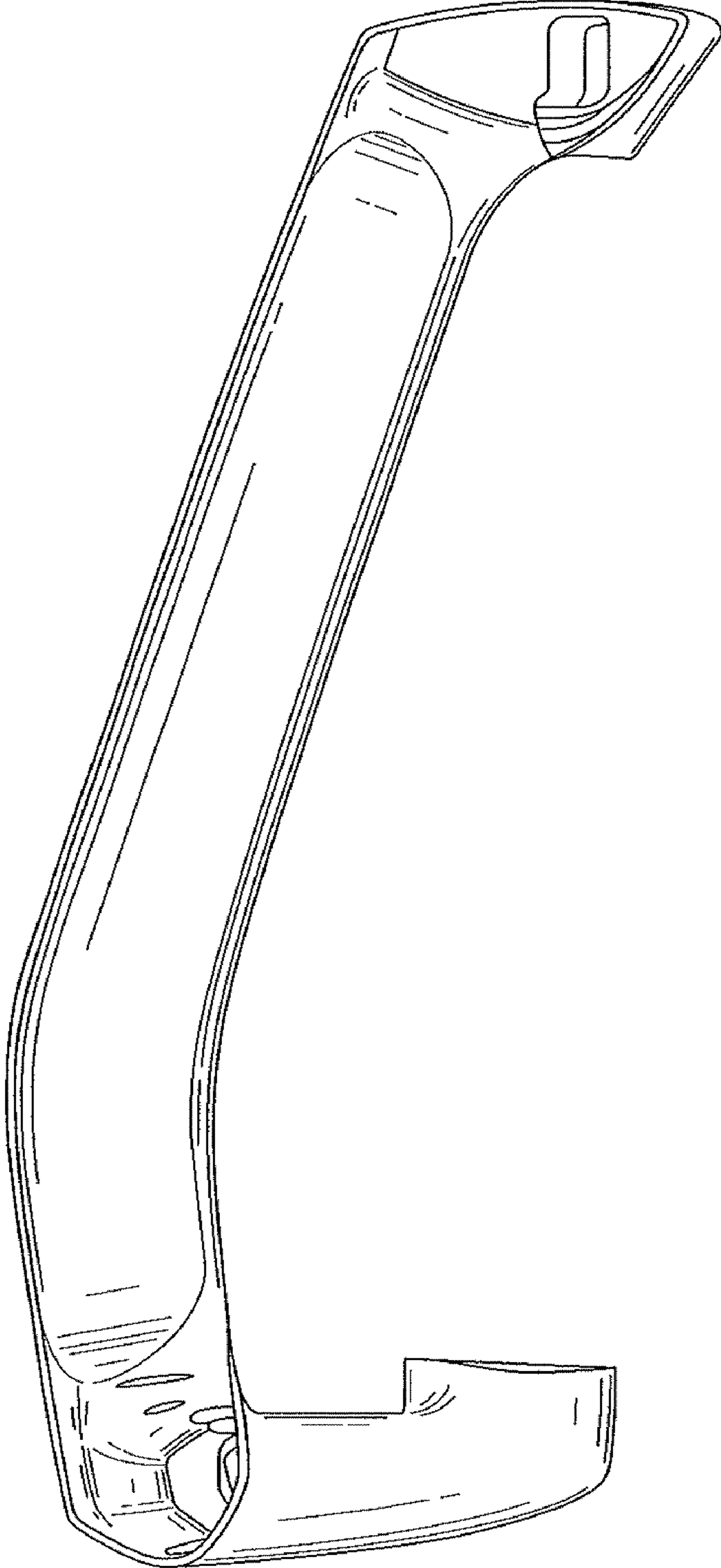

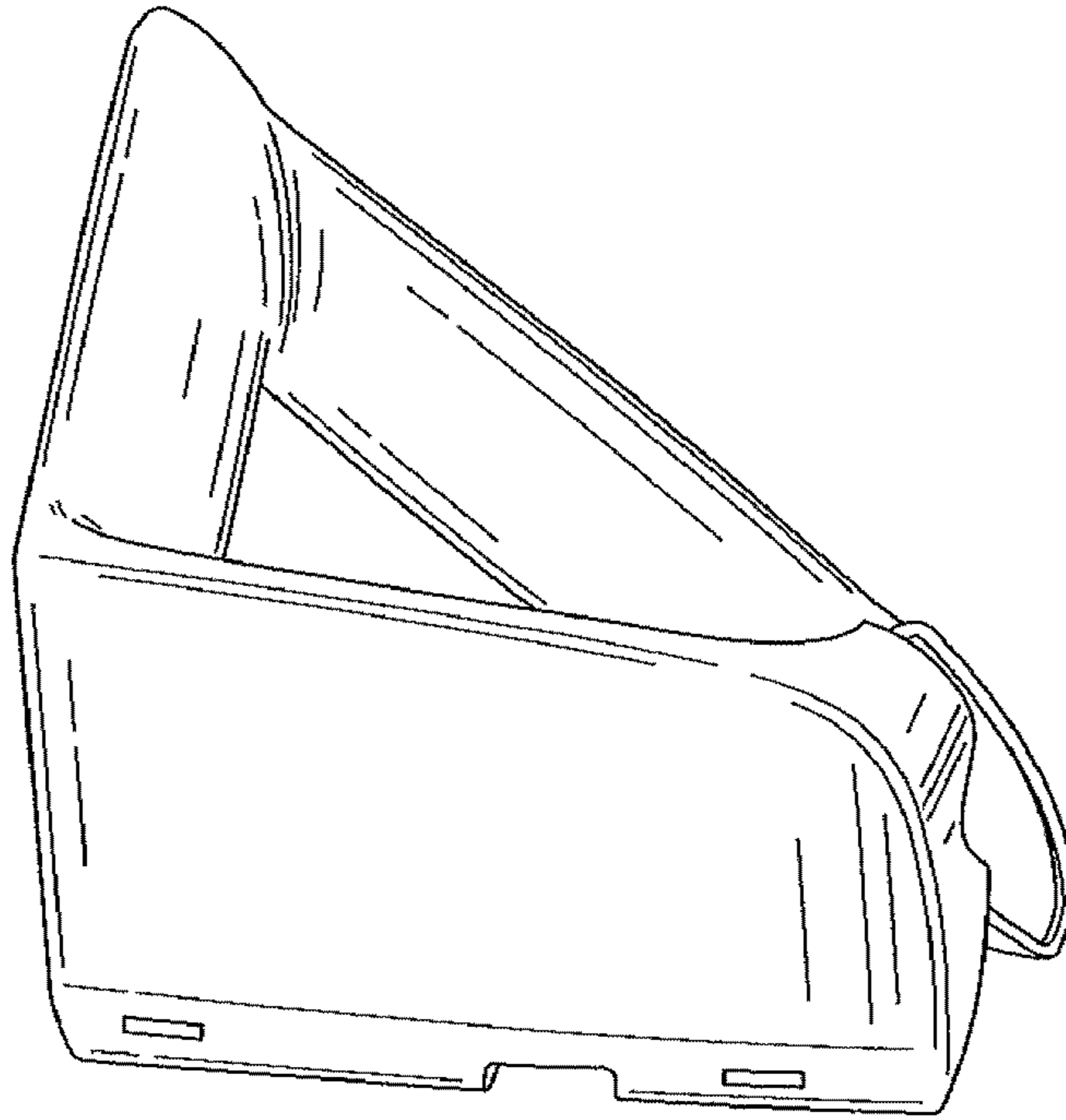

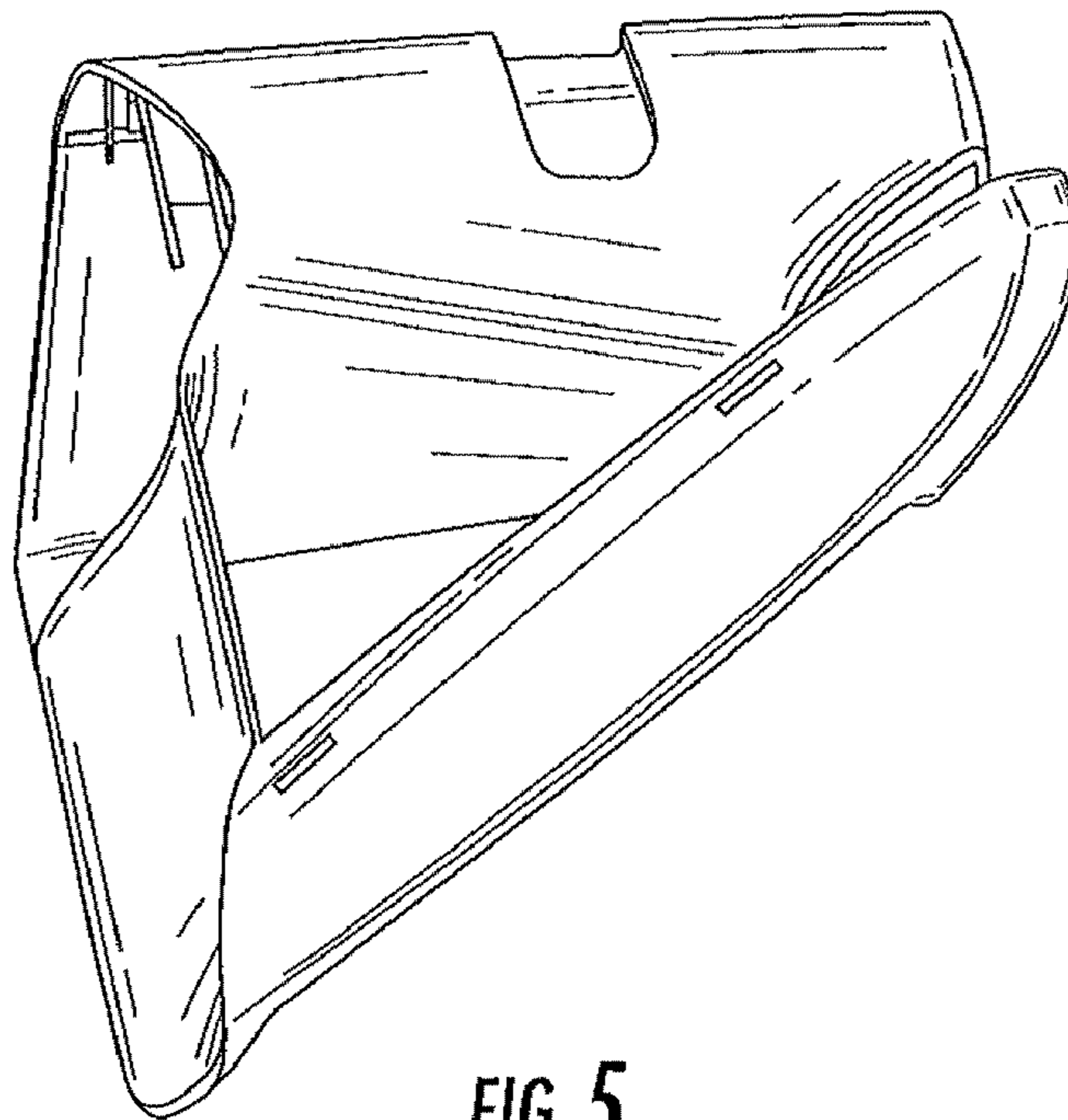

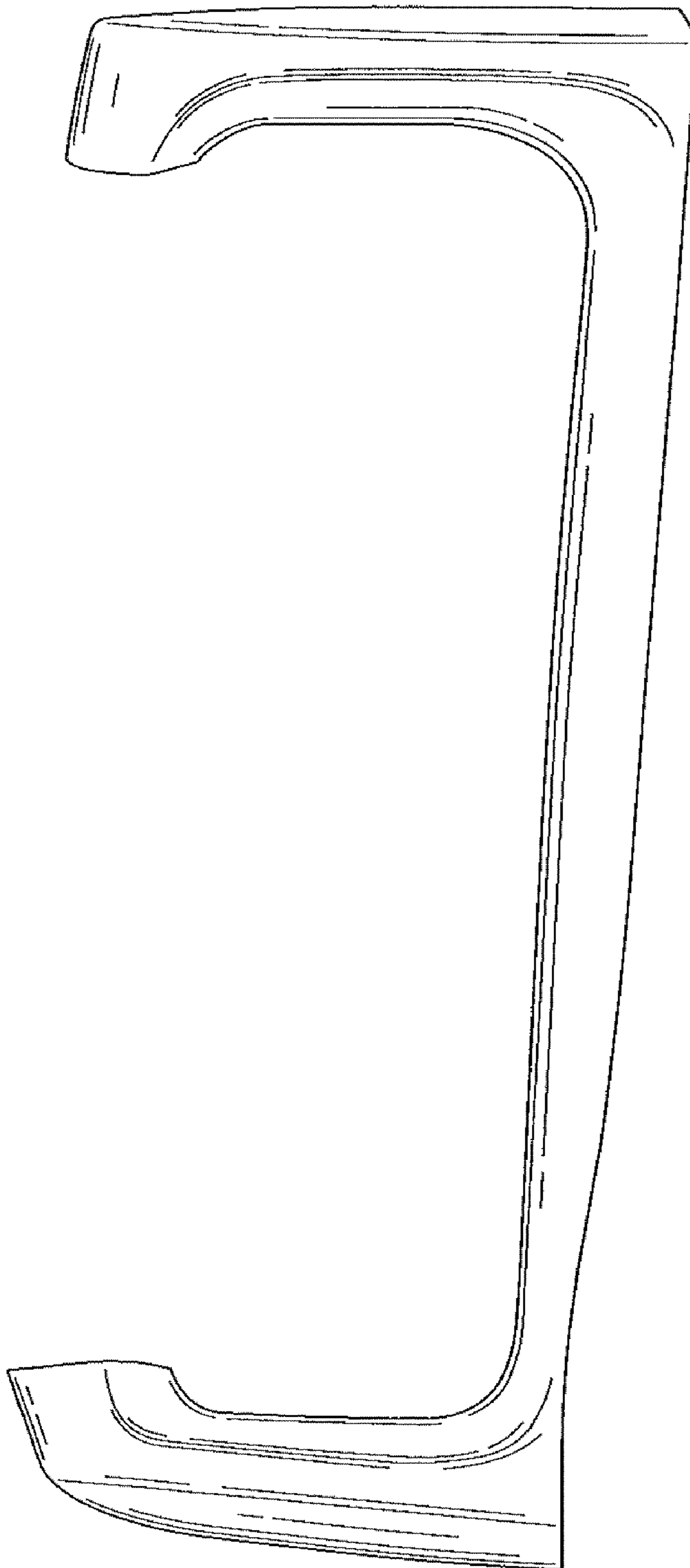

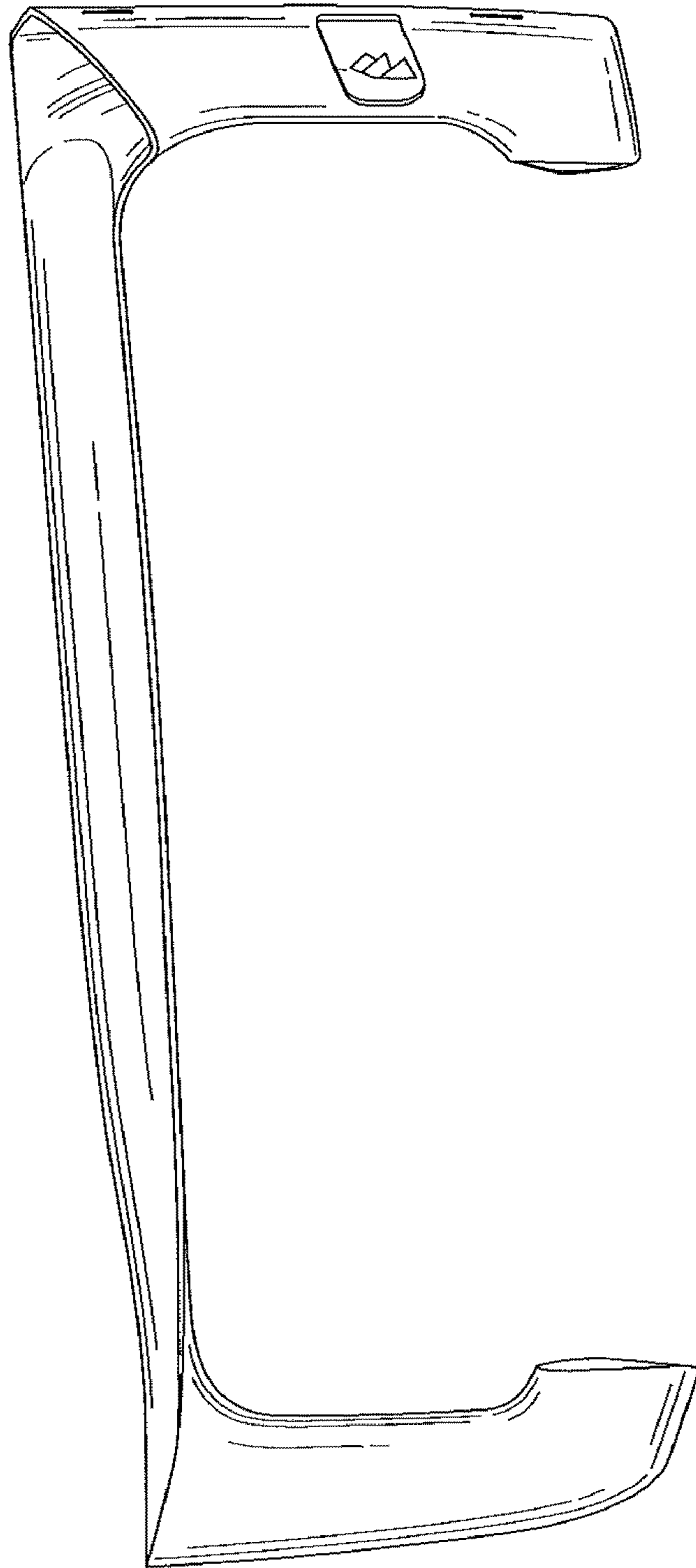

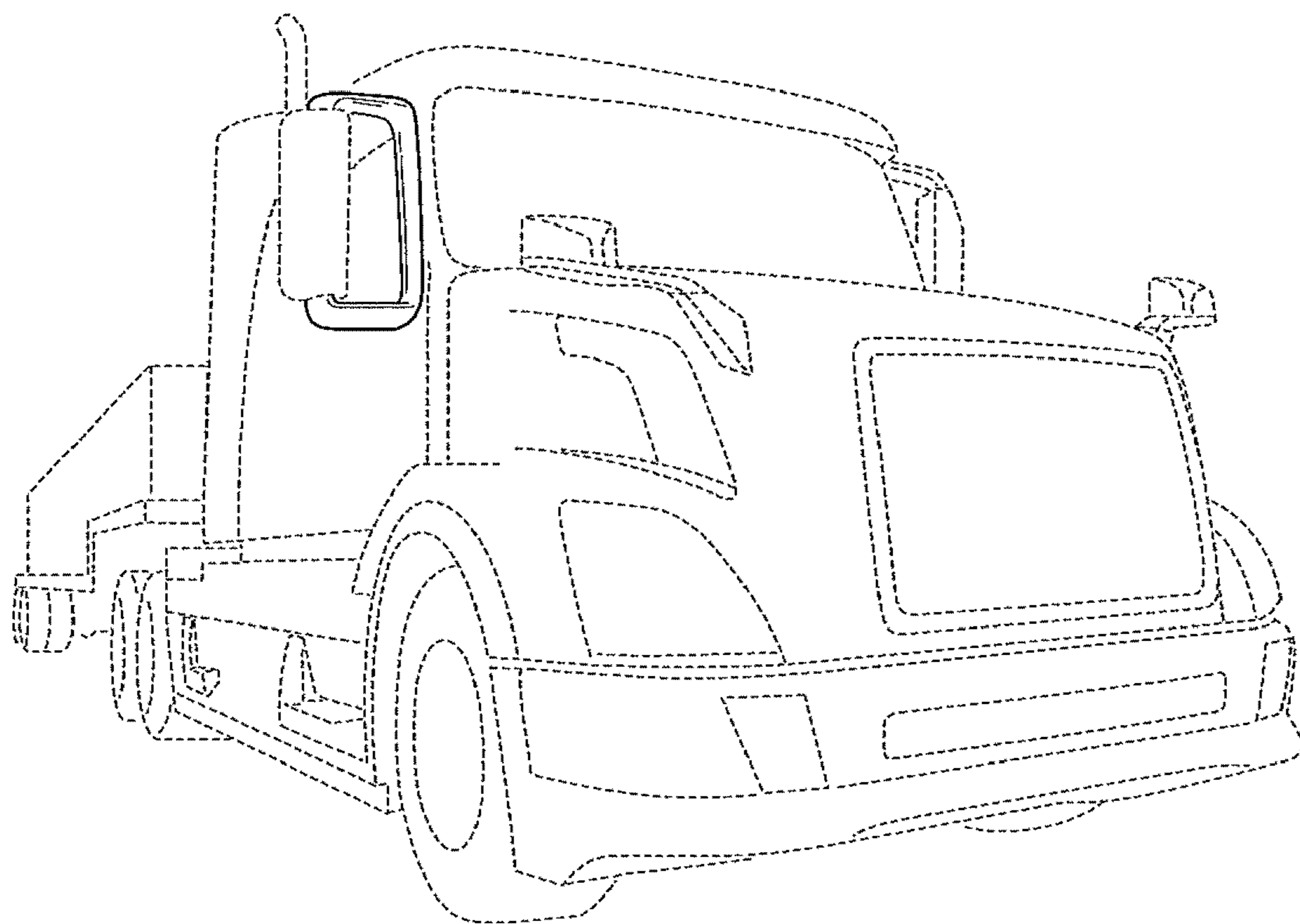

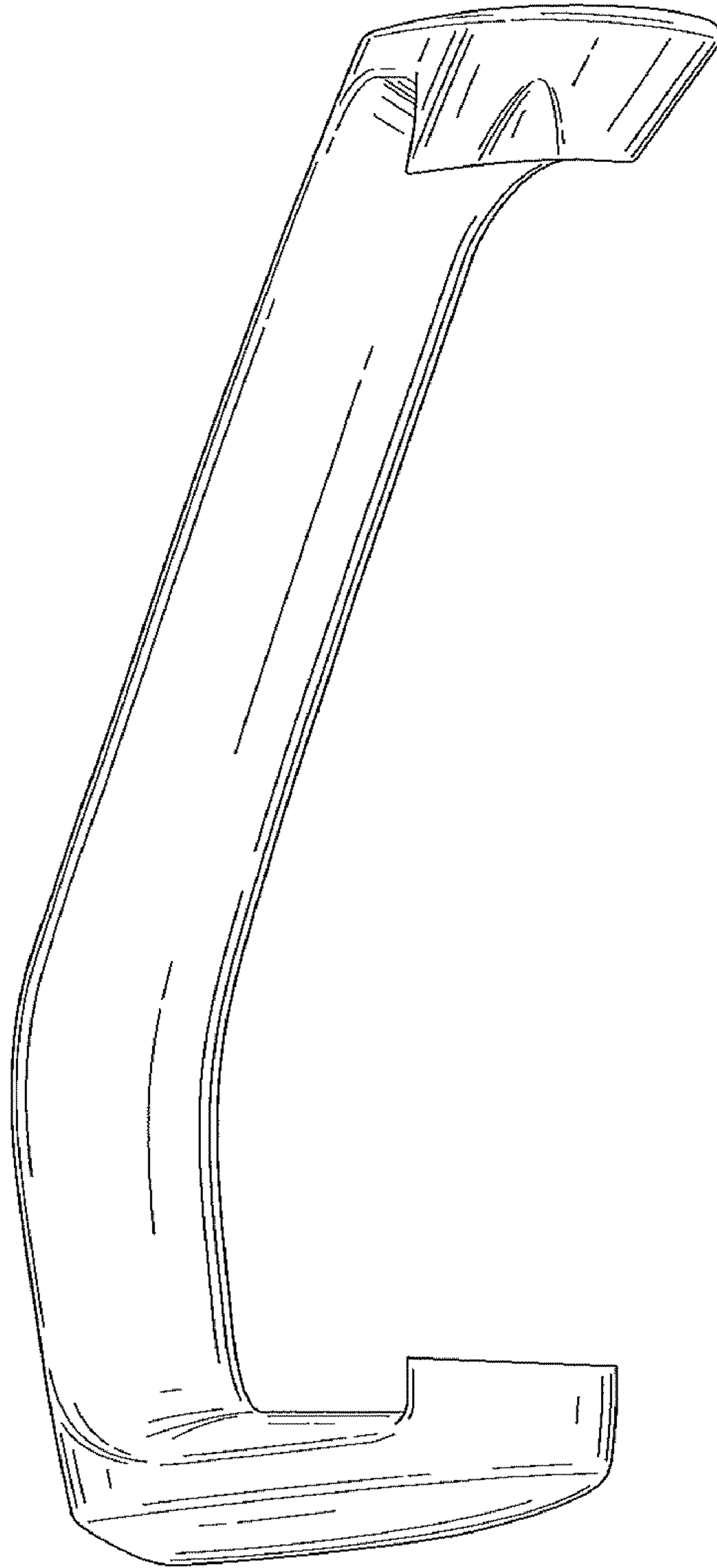

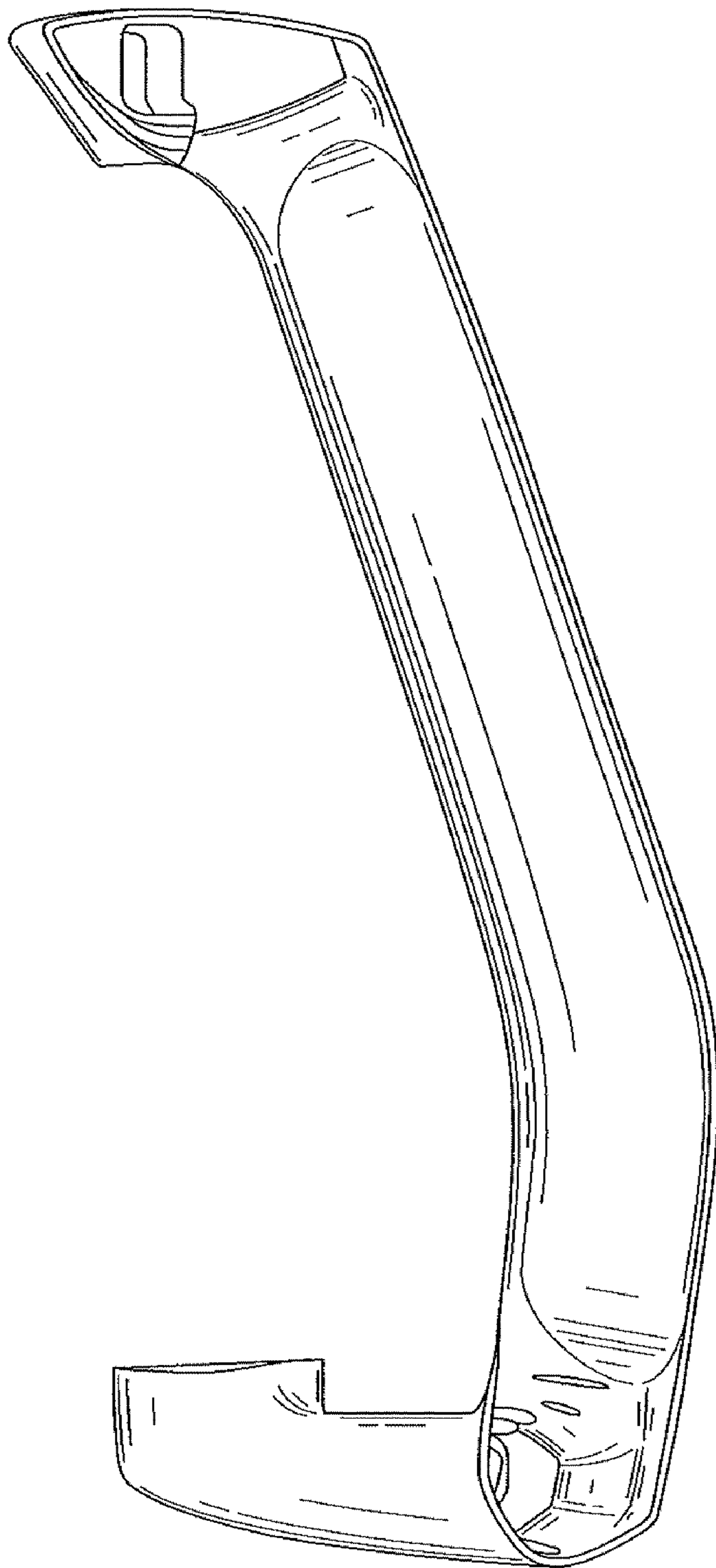

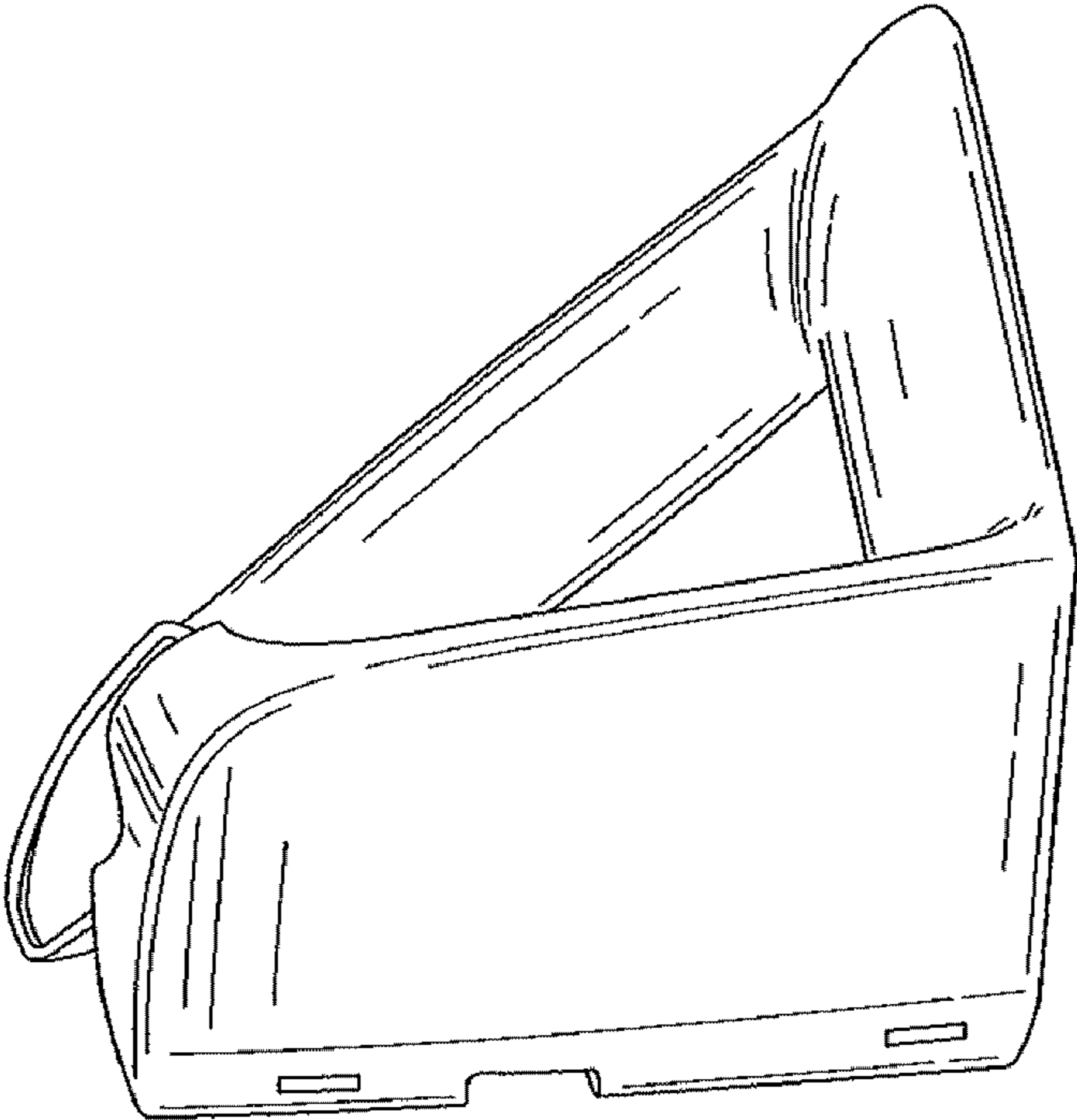

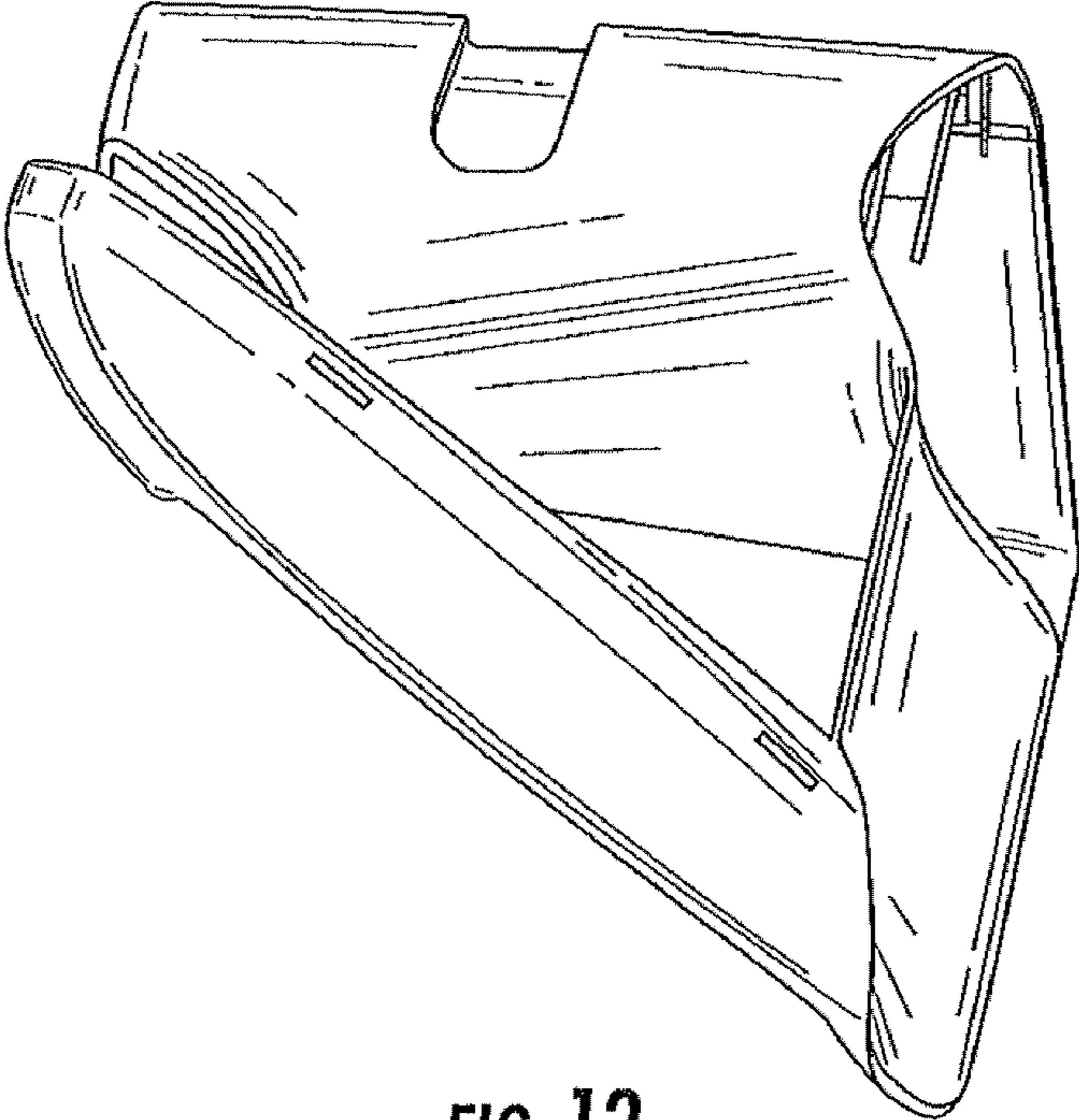

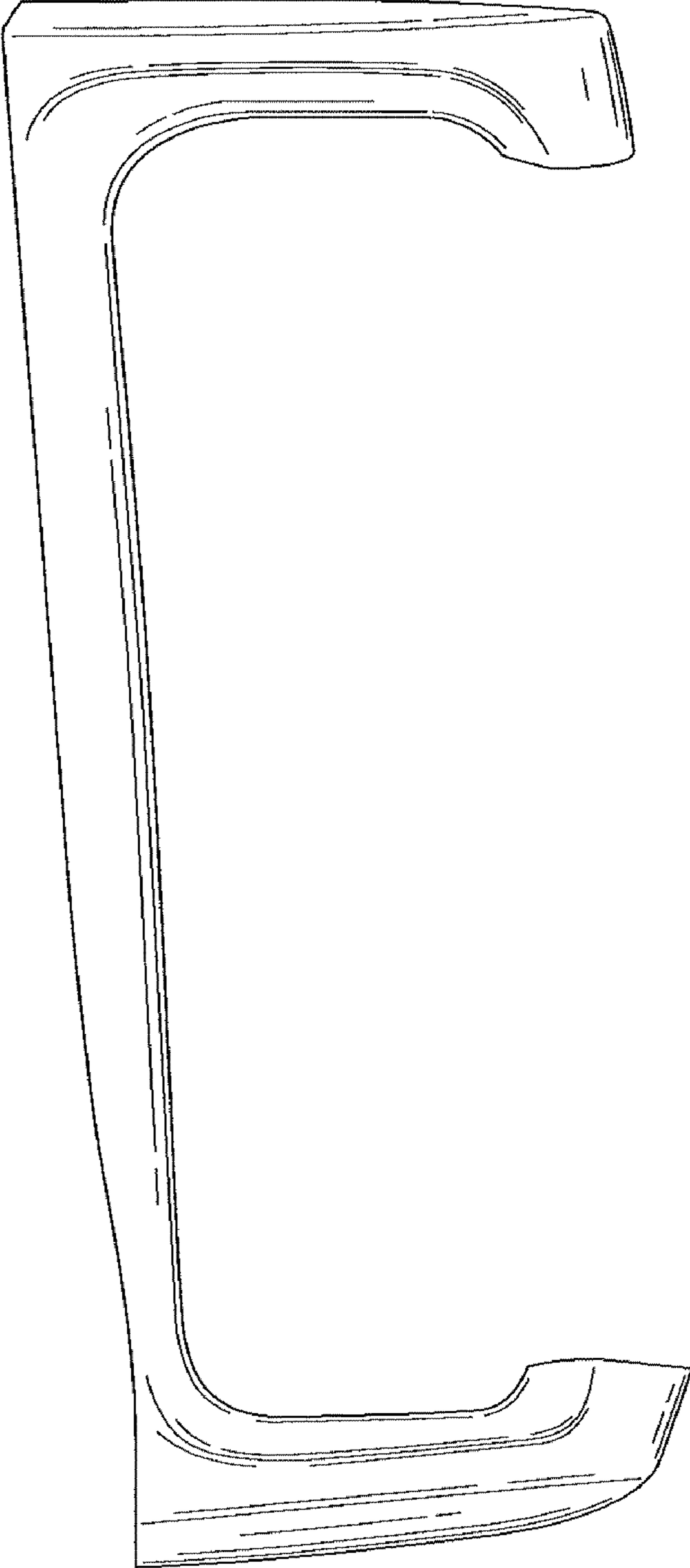

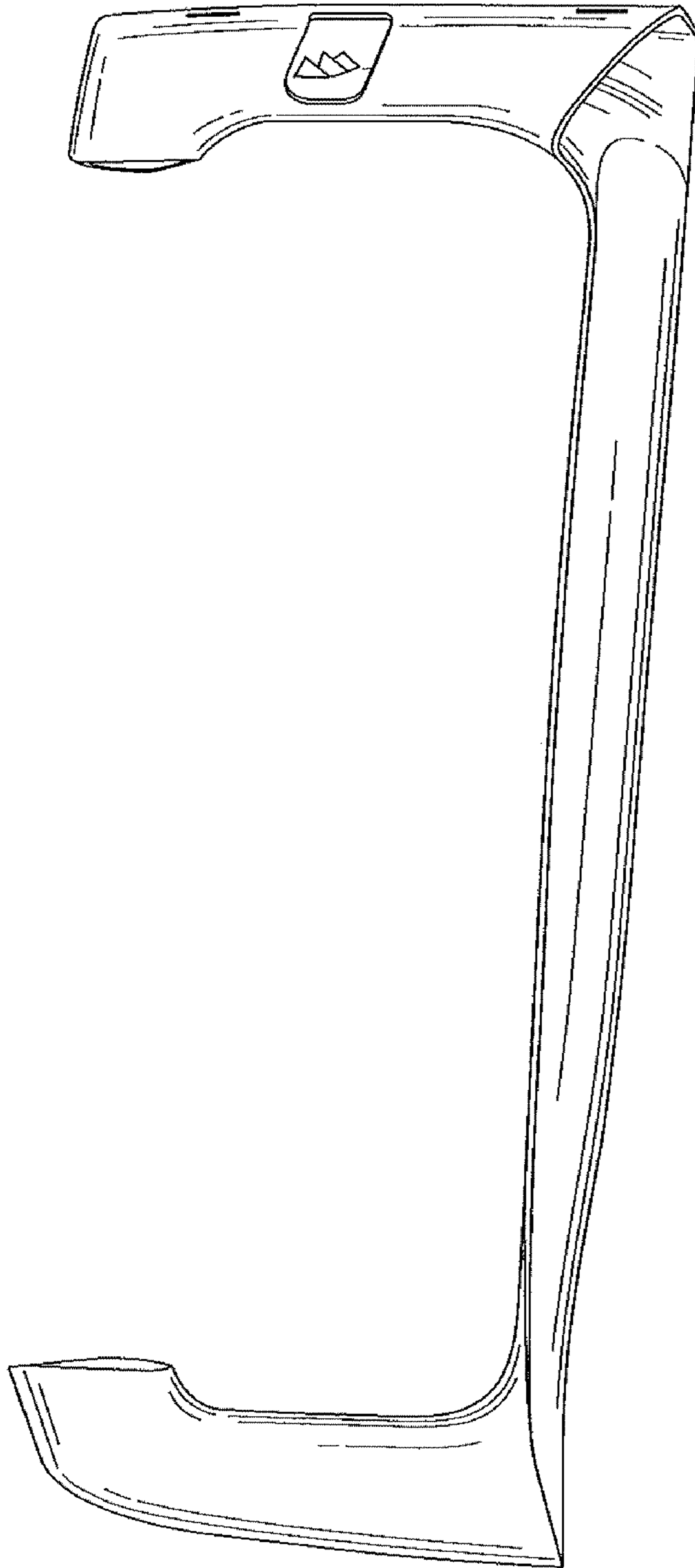

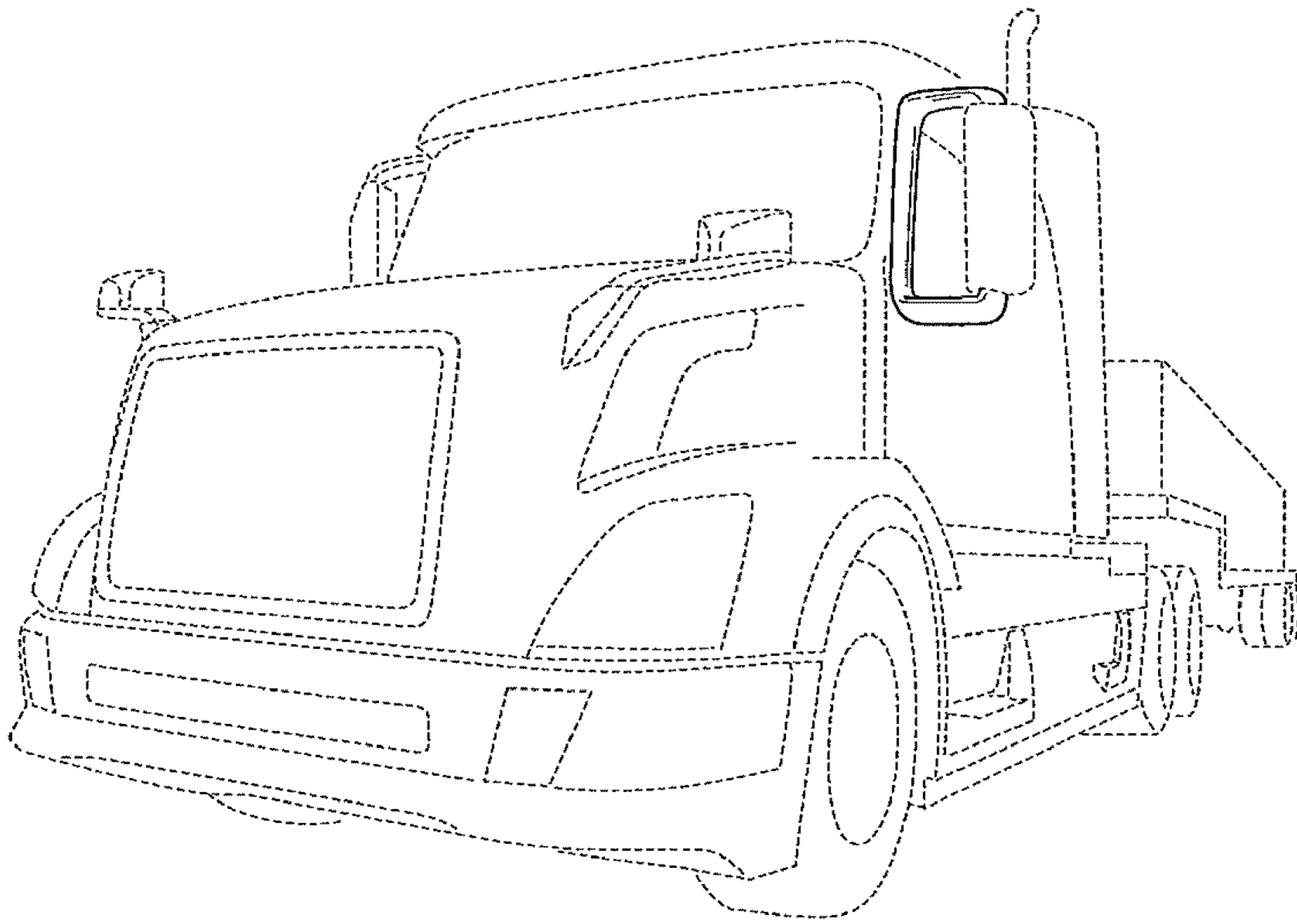
