(57) **CLAIM**

The ornamental design for a solar-powered electronic reader cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a solar-powered electronic reader cover according to the present invention.

FIG. 2 is a rear perspective view of a solar-powered electronic reader cover according to the present invention.

FIG. 3 is a front elevation view of a solar-powered electronic reader cover according to the present invention.

FIG. 4 is a right side elevation view of a solar-powered electronic reader cover according to the present invention.

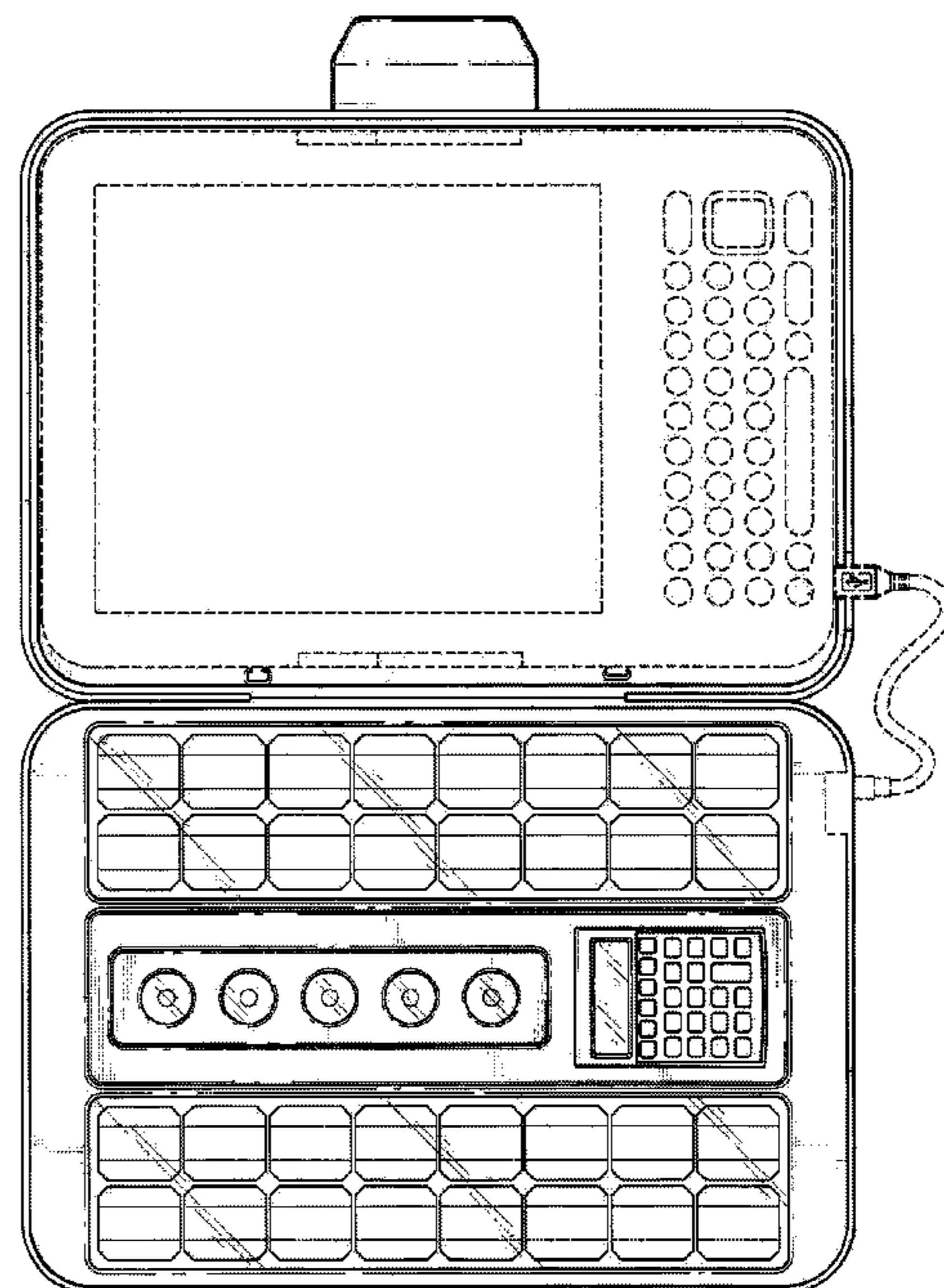
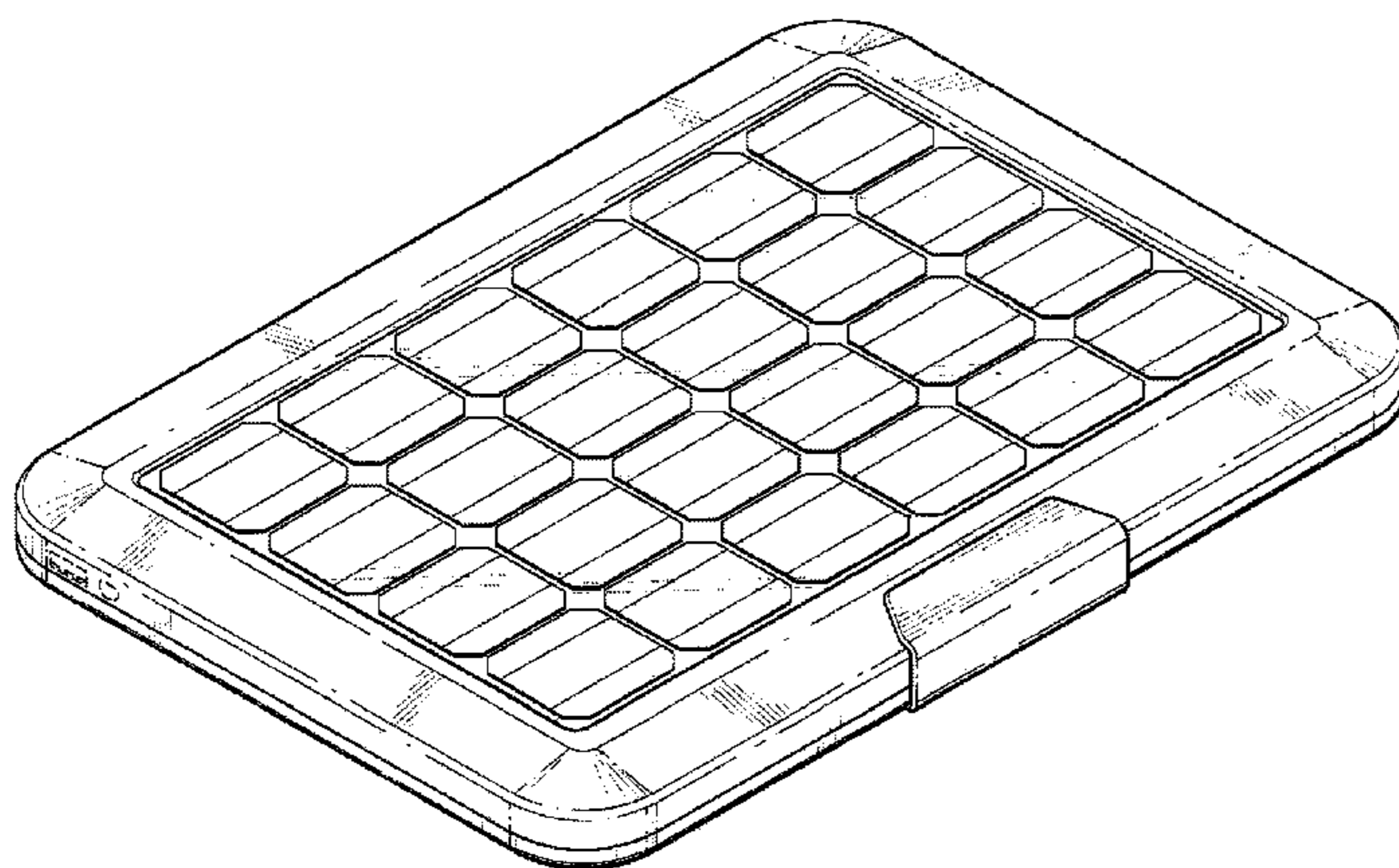
FIG. 5 is a left side elevation view of a solar-powered electronic reader cover according to the present invention.

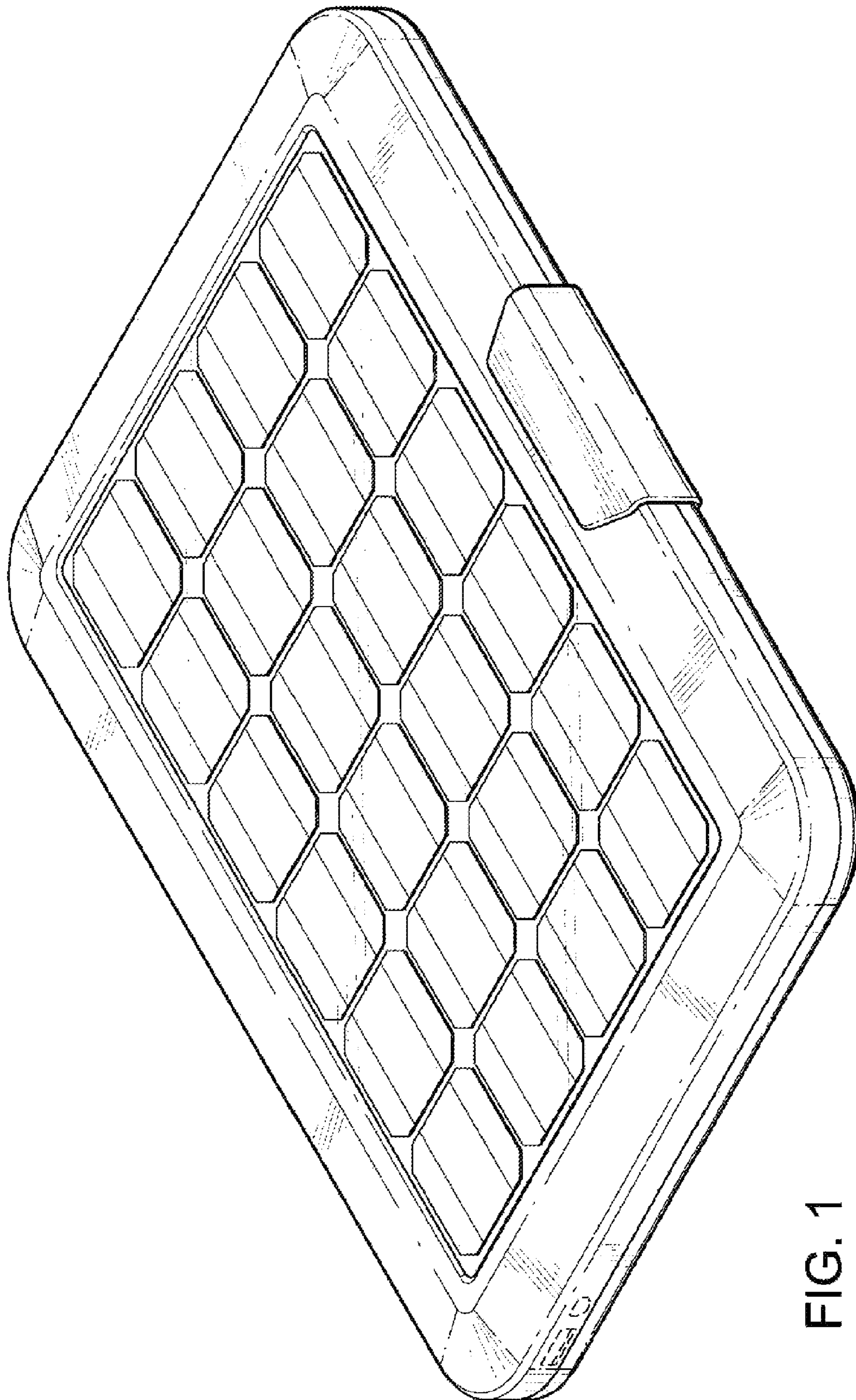

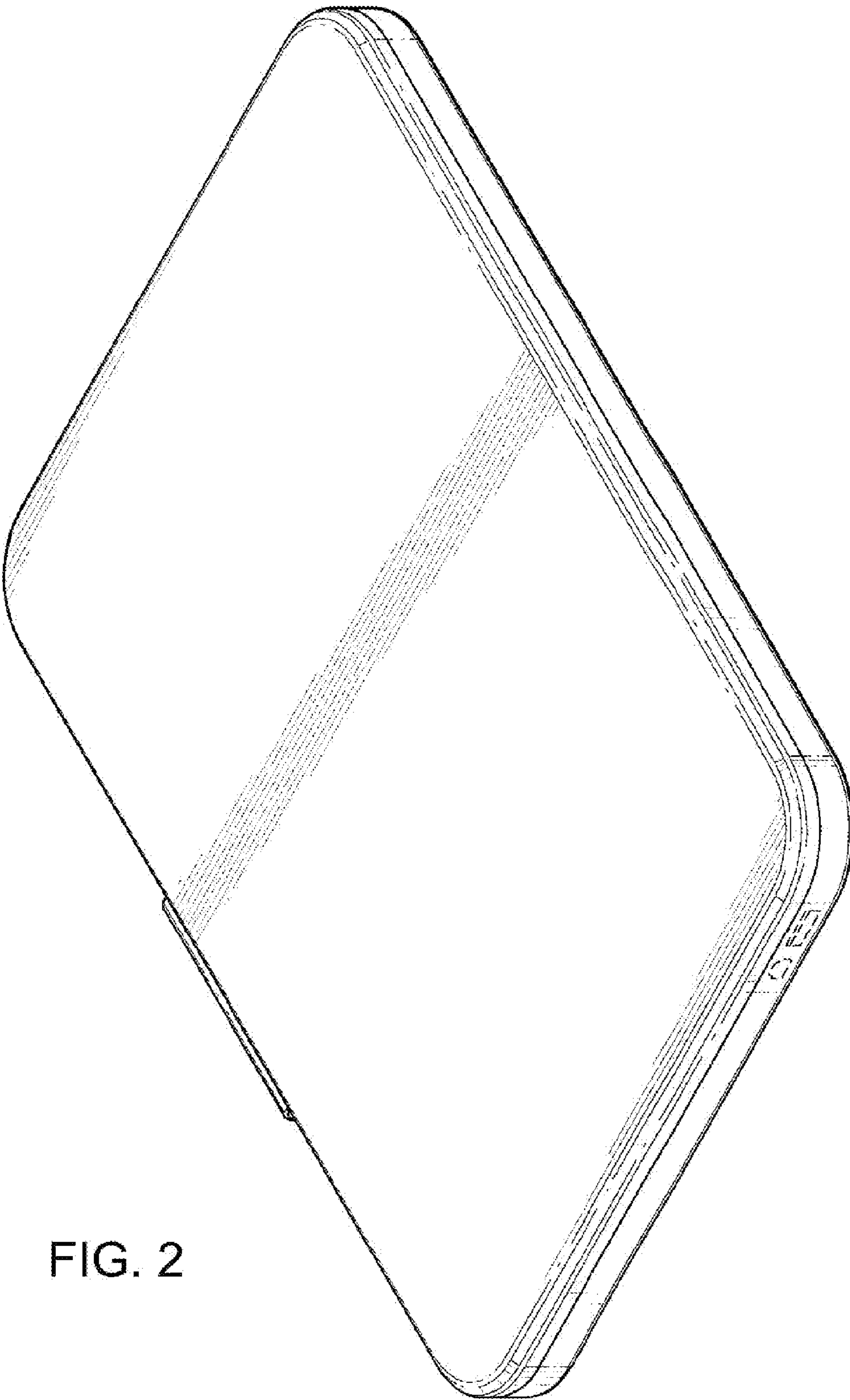

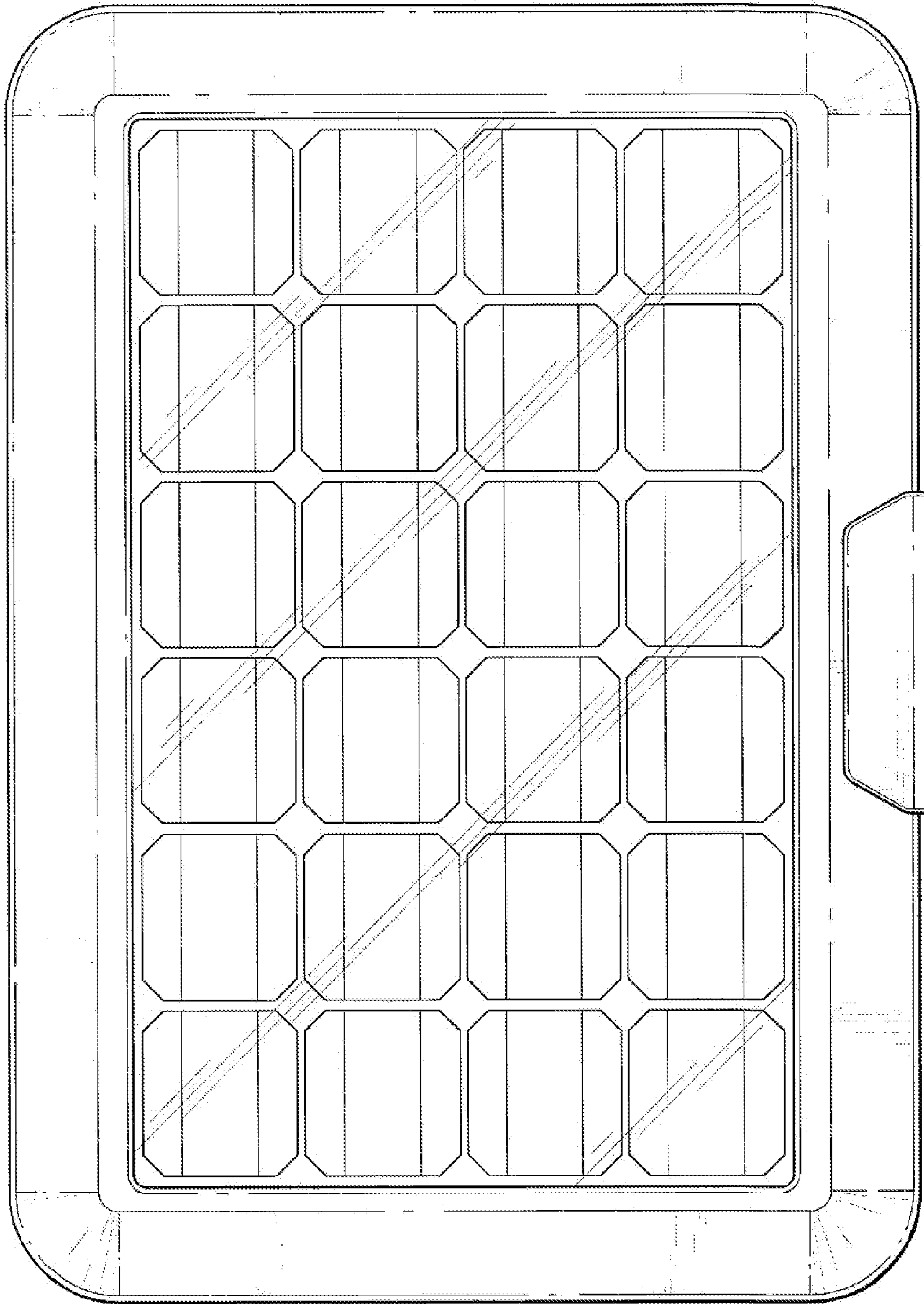

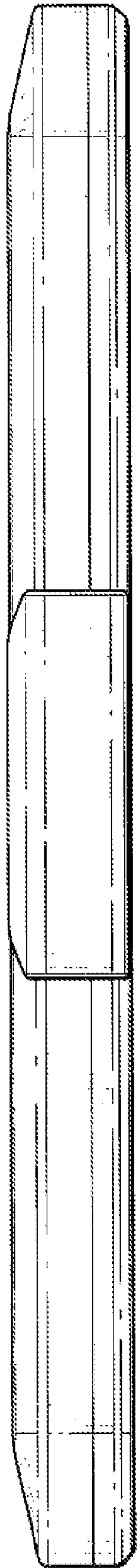

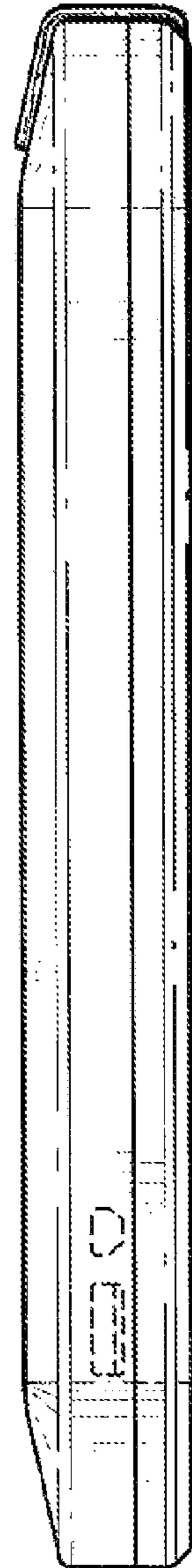

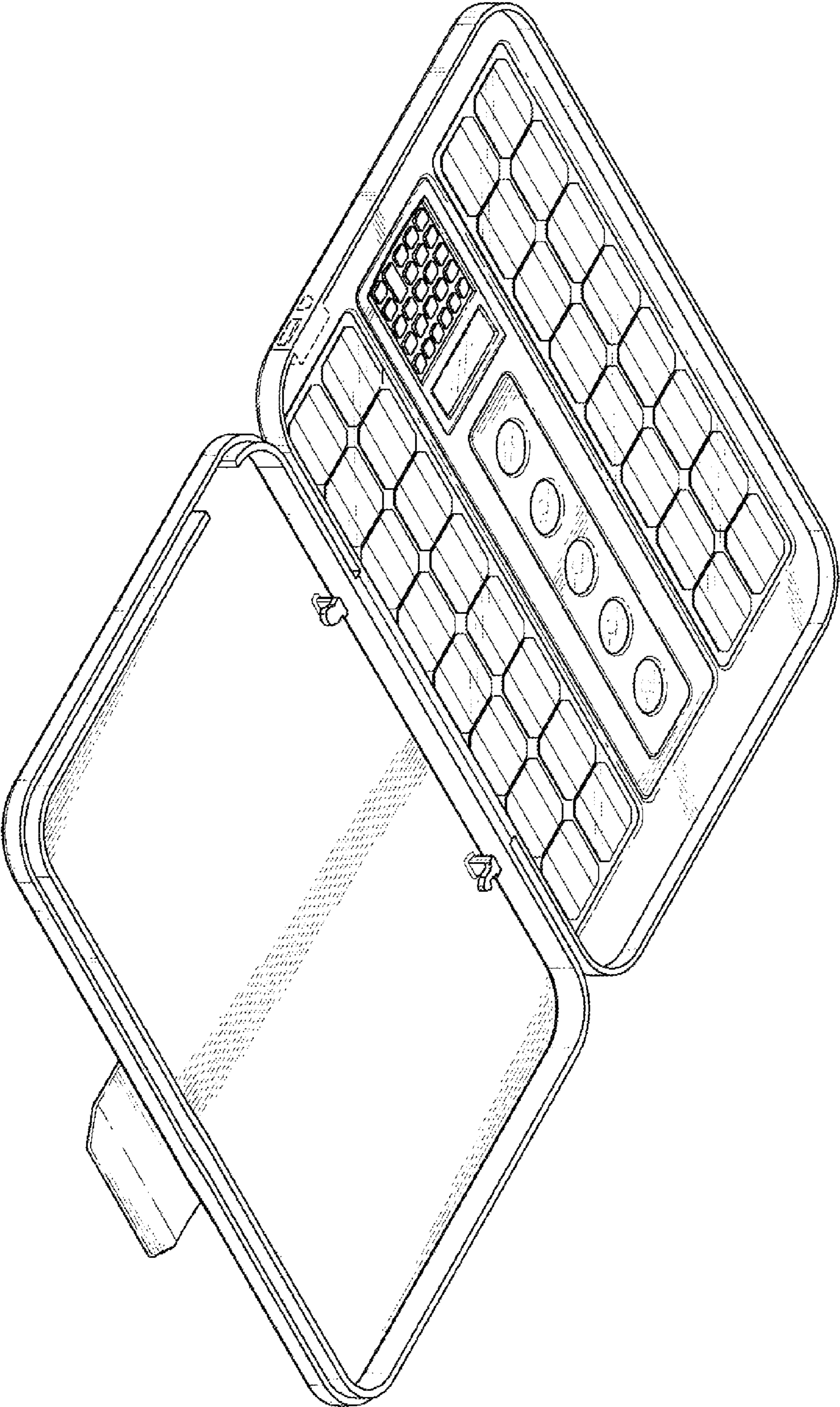

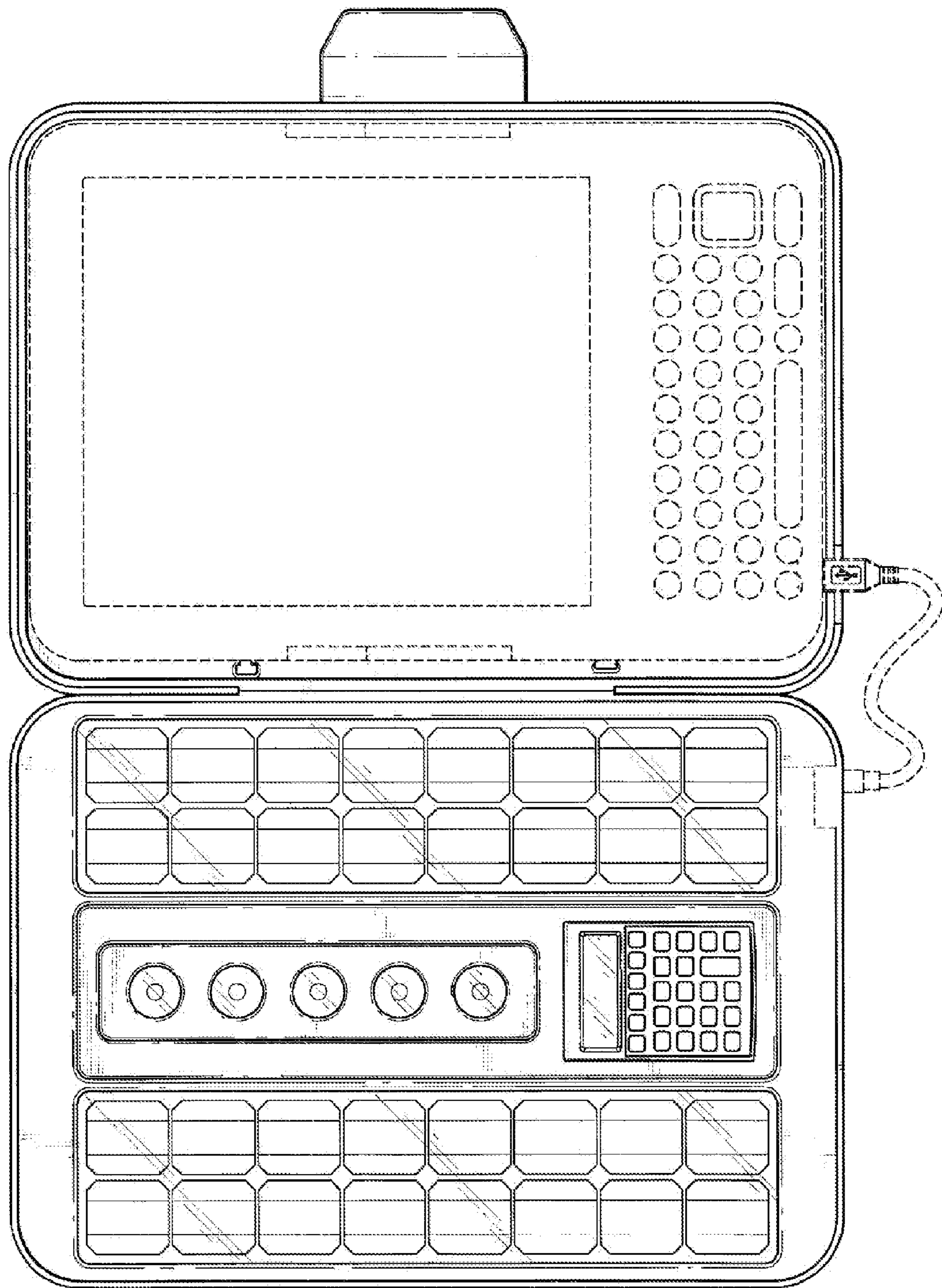
