(57) **CLAIM**

The ornamental design for a protective case for portable handheld electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a protective case for portable handheld electronic device showing the new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a front plan view thereof; FIG. 4 is a rear plan view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a left side view thereof. The broken lines depict a portable handheld electronic device, which forms no part of the claimed design.

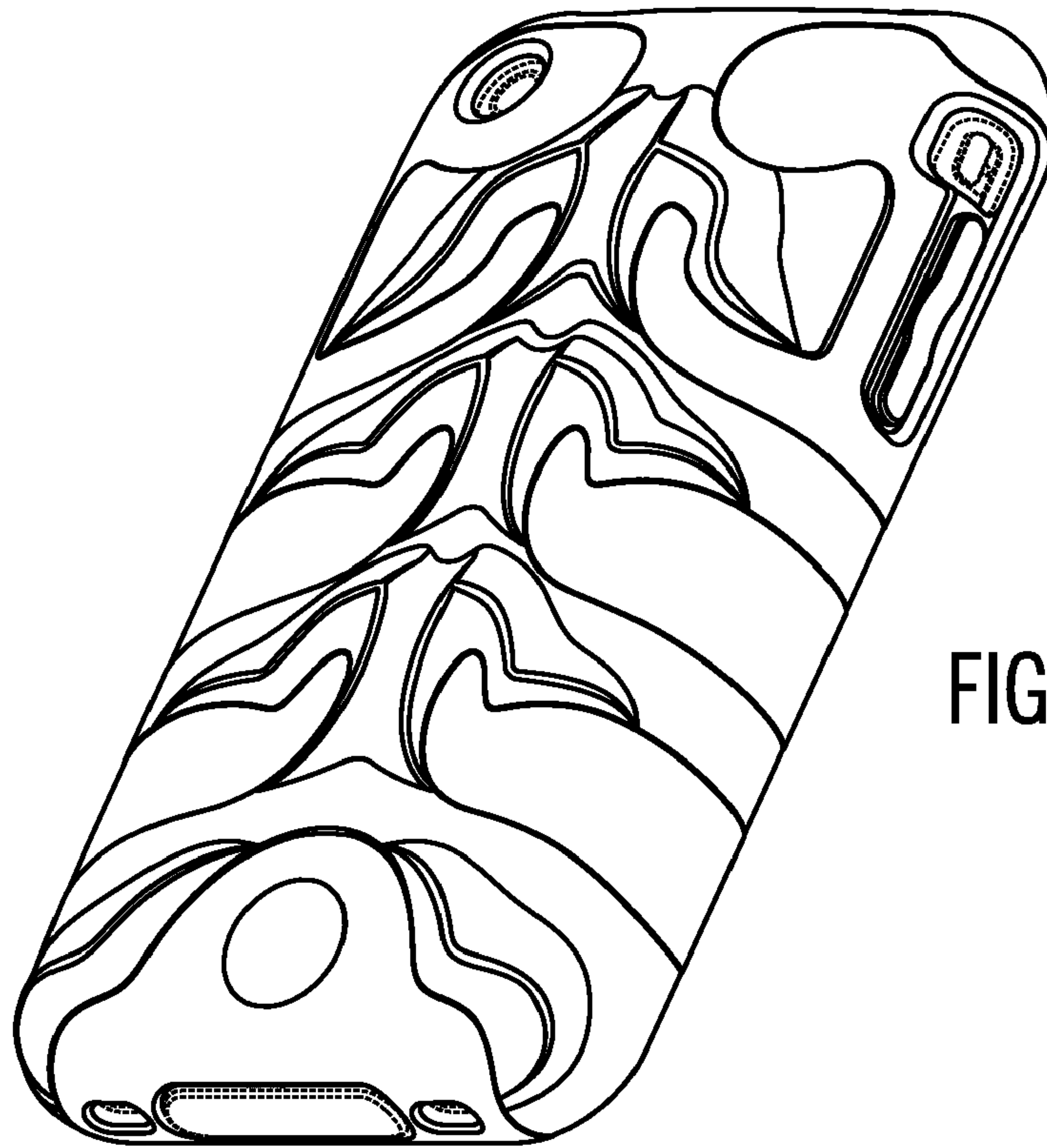

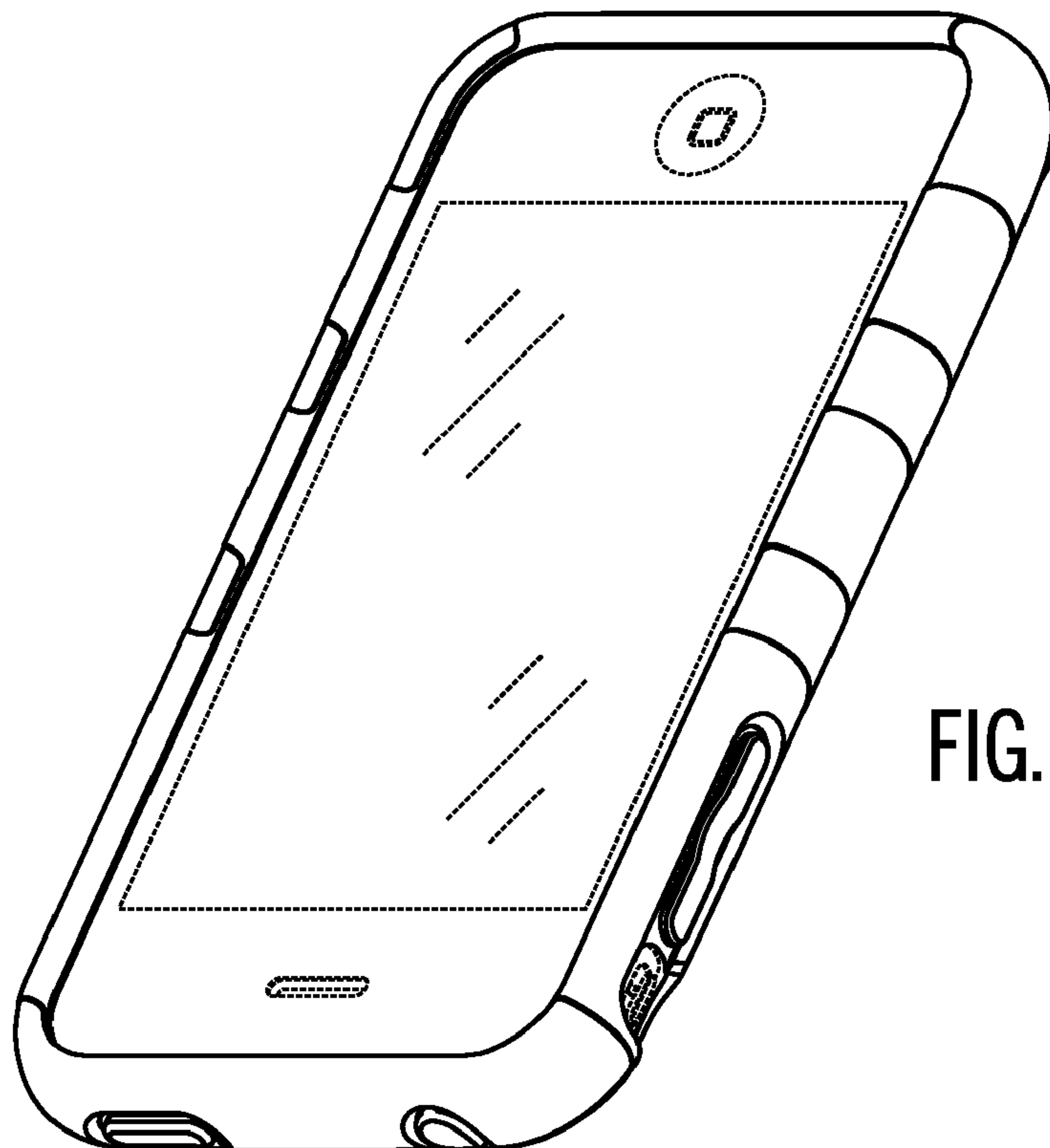

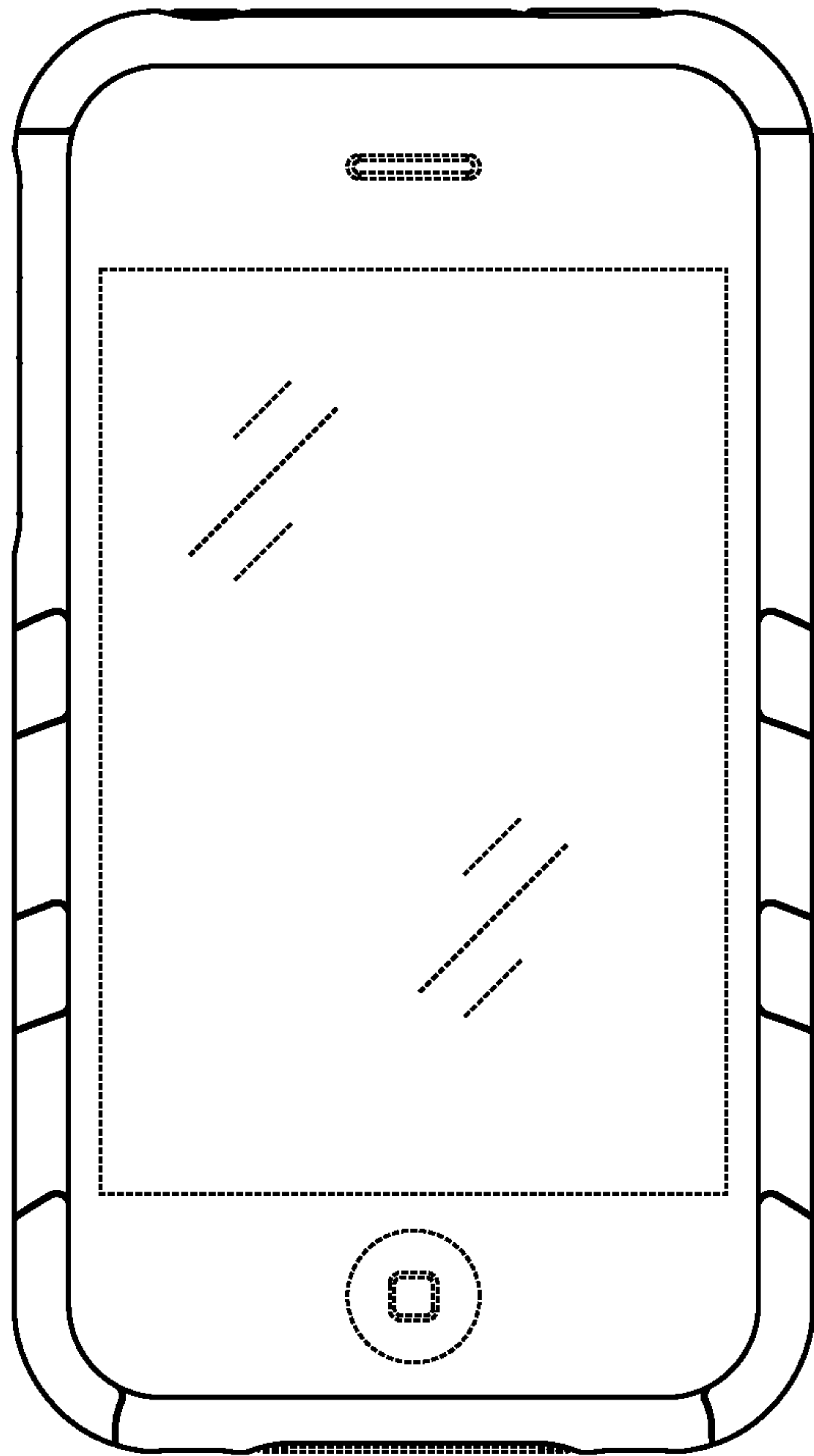

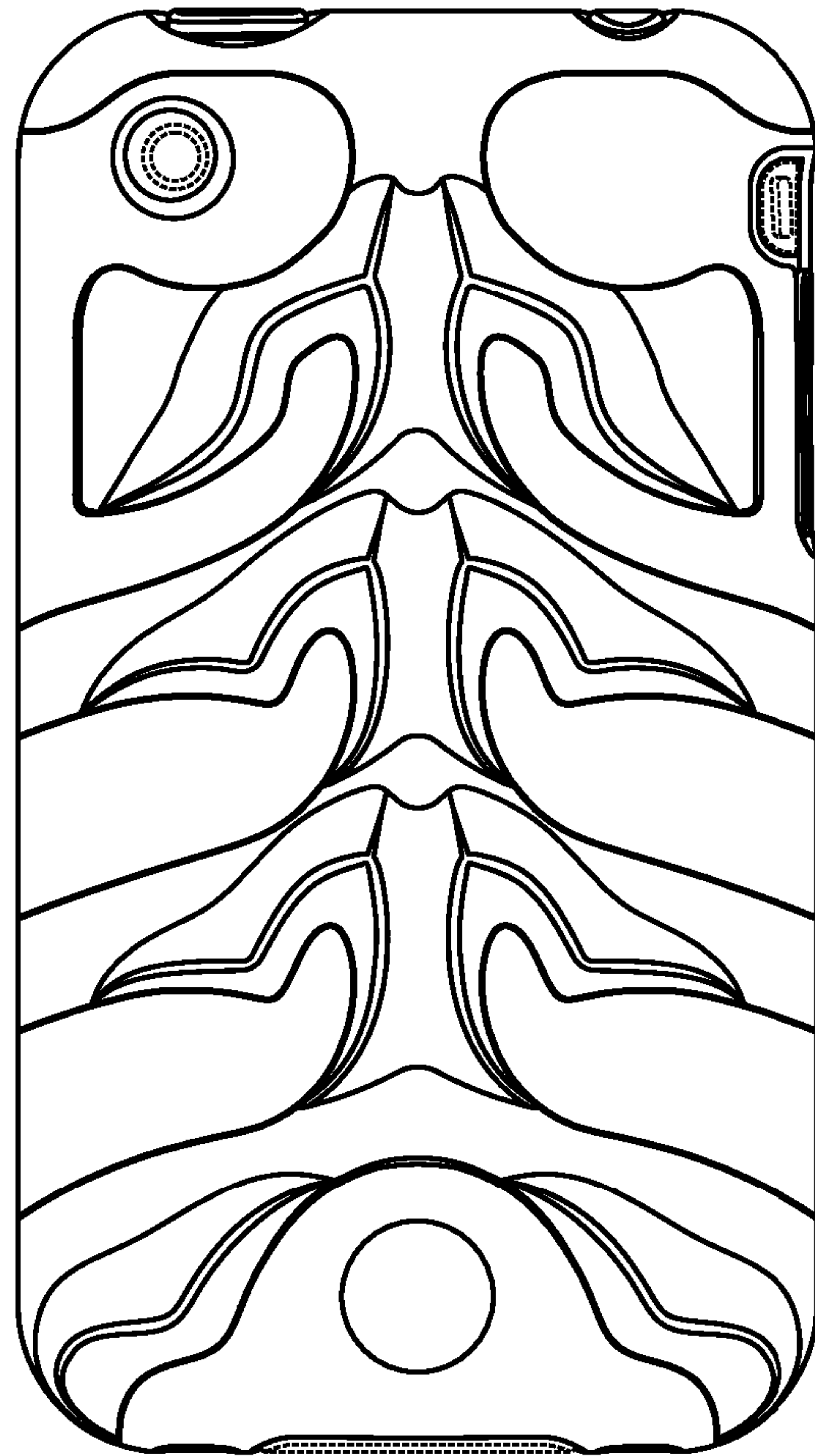

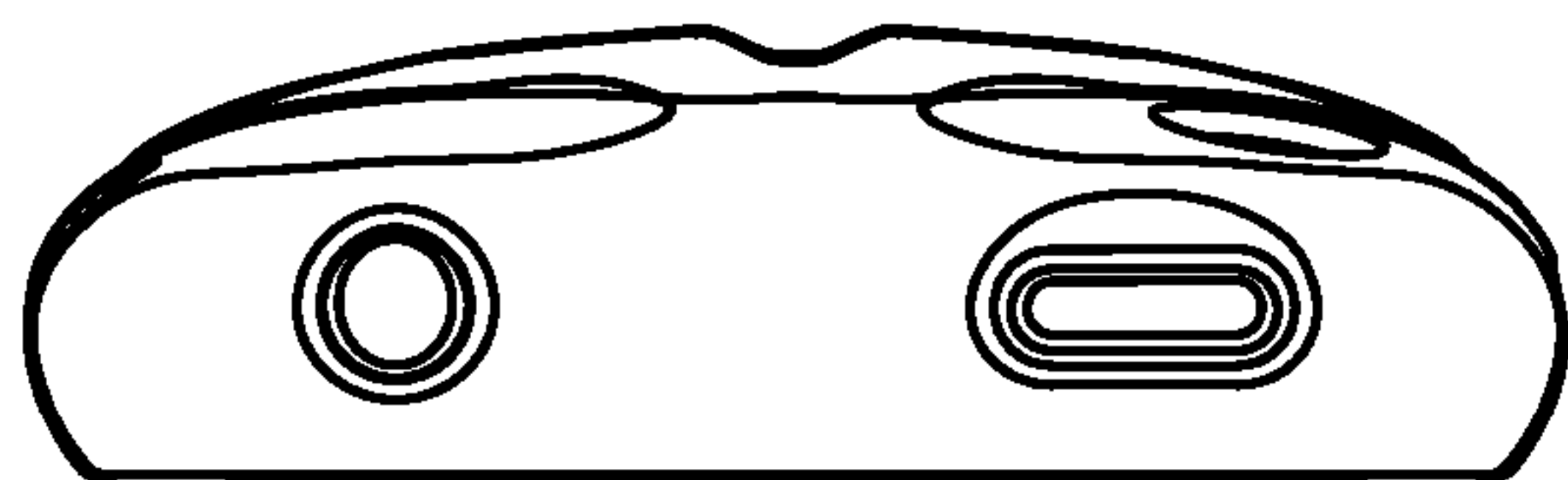

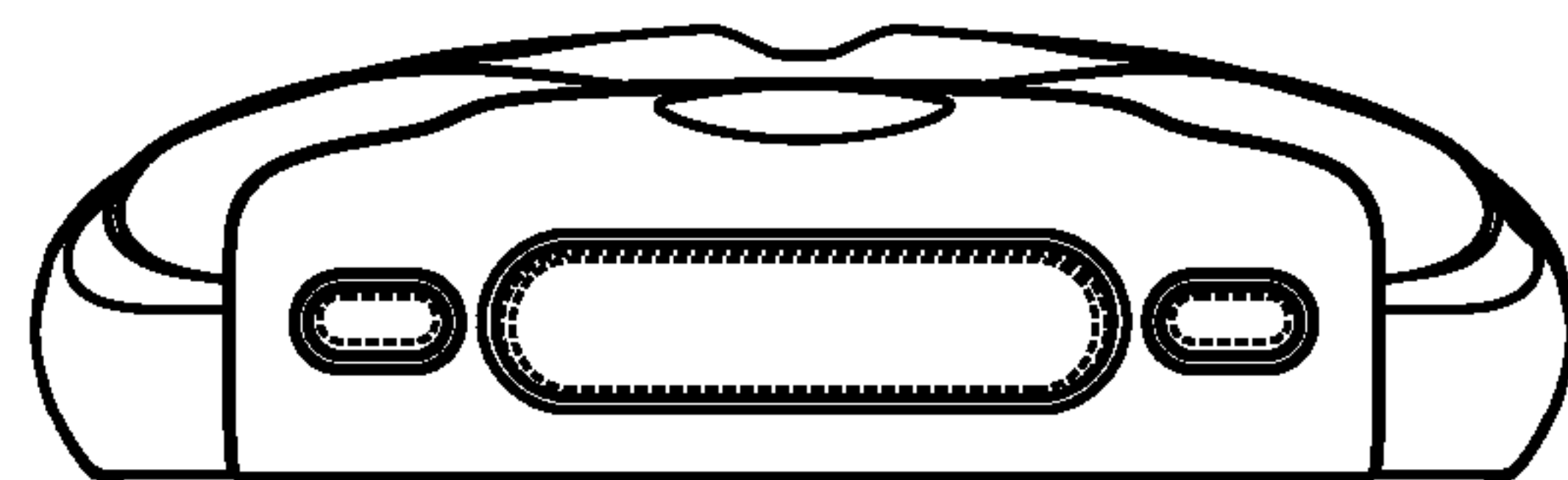

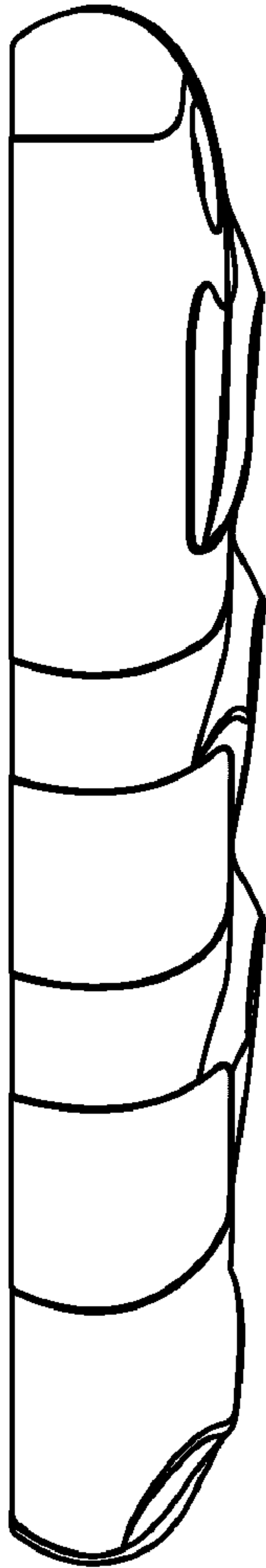

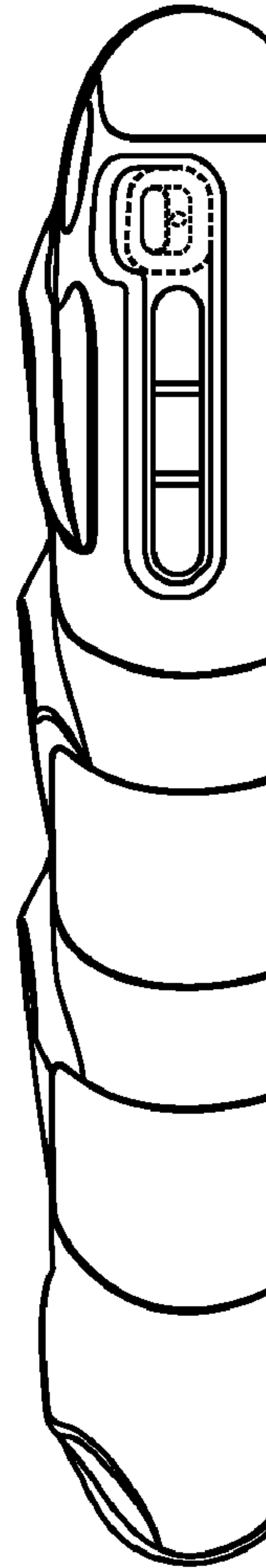
