FIG. 19 is the nineteenth image thereof;

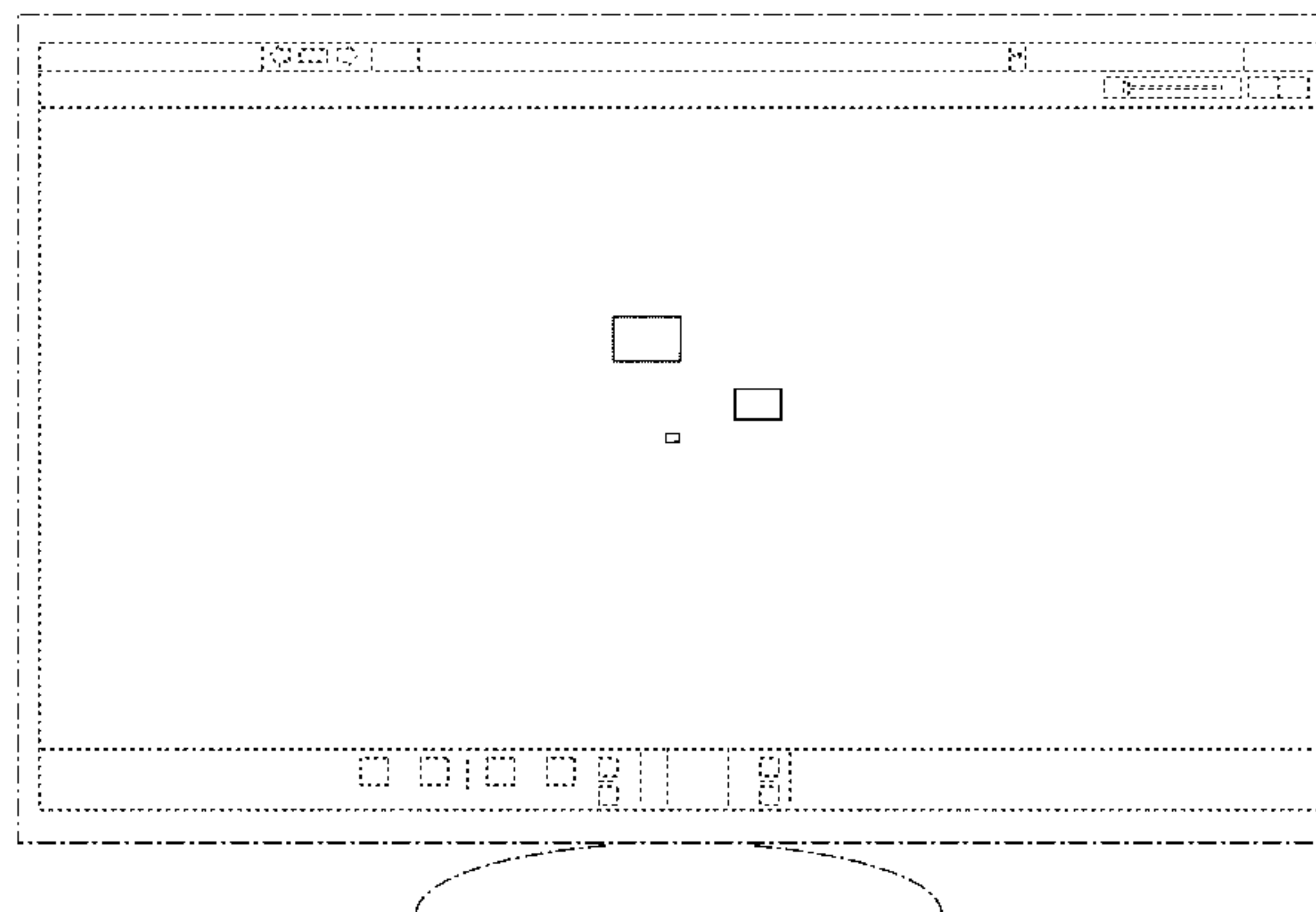
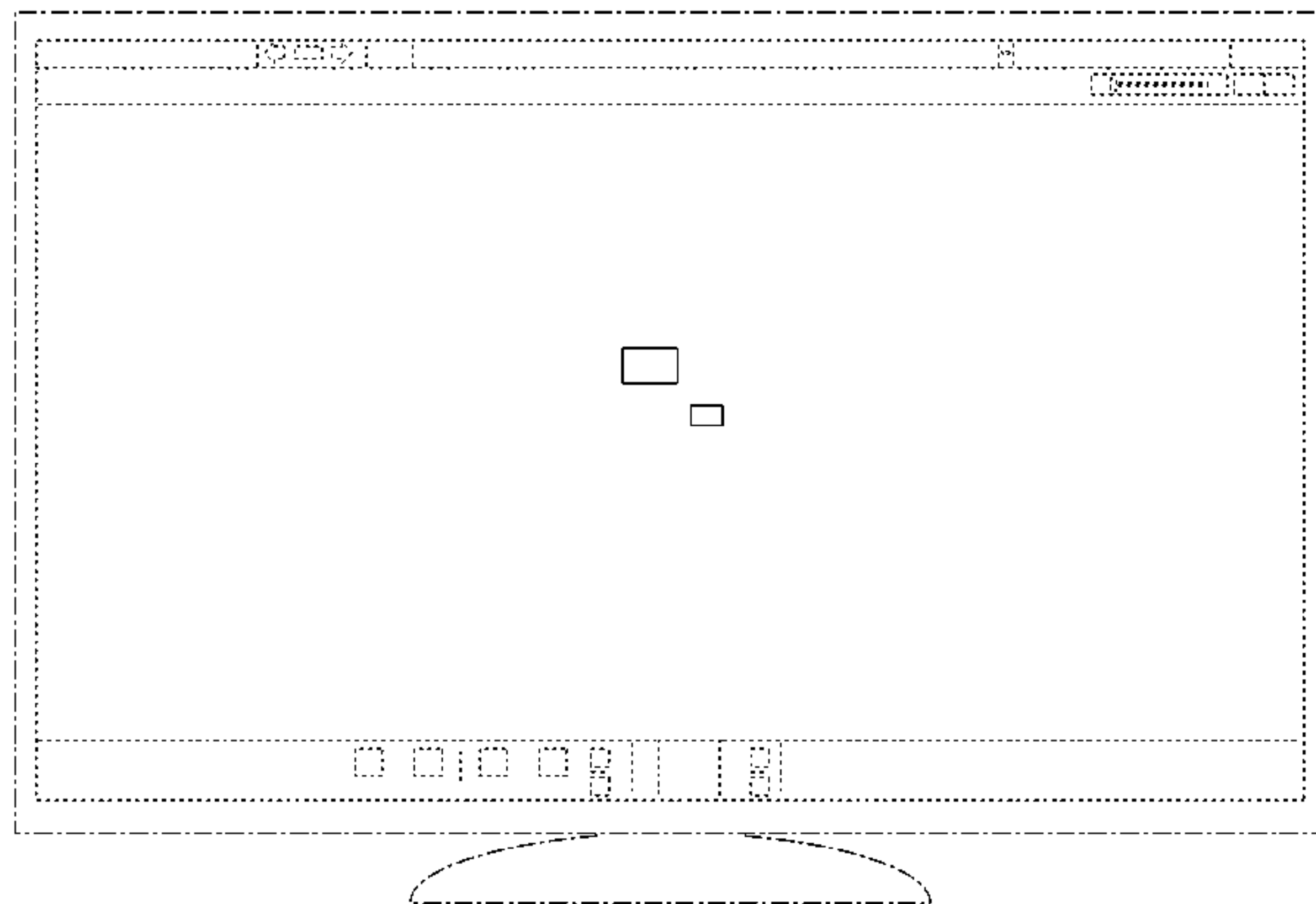
FIG. 20 is the twentieth image thereof;

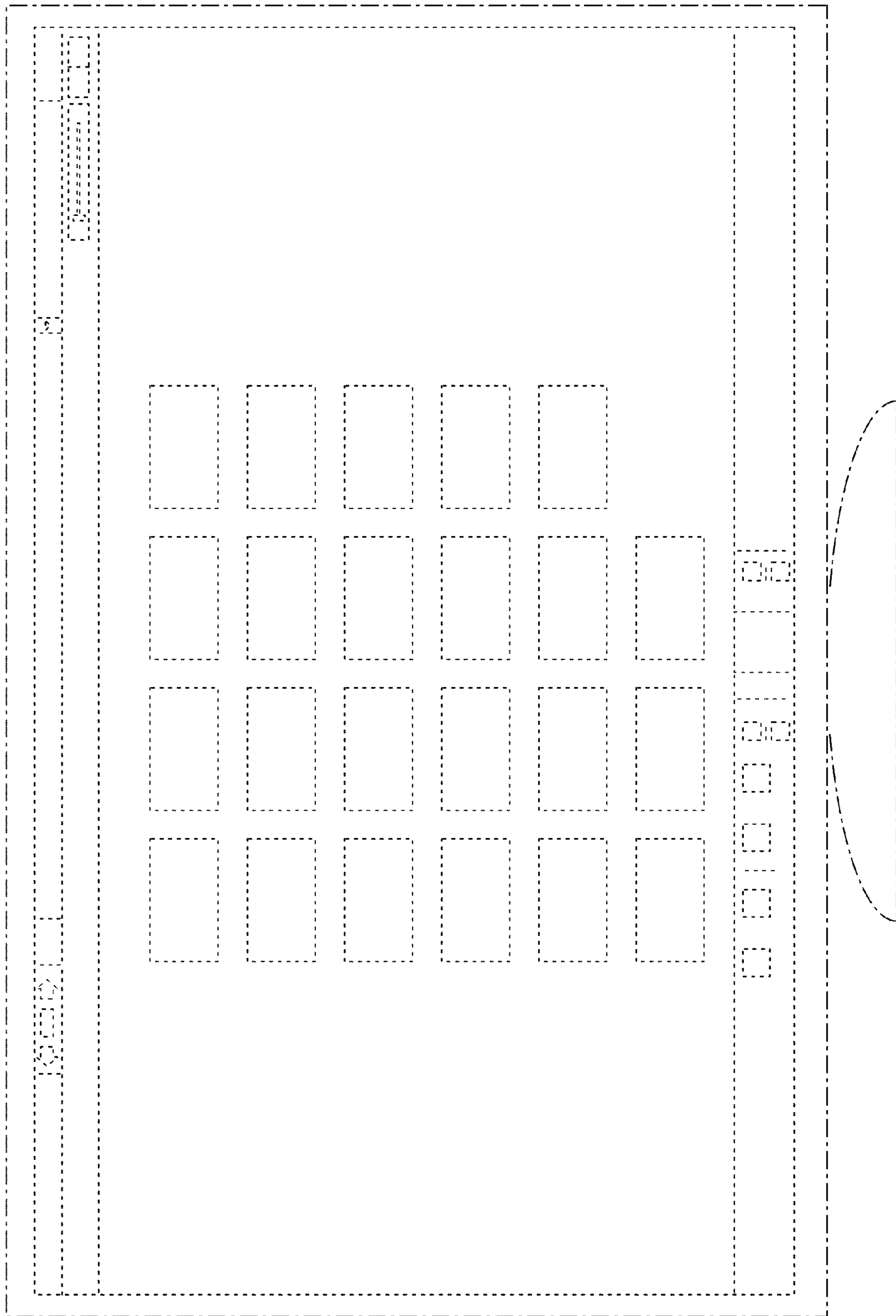

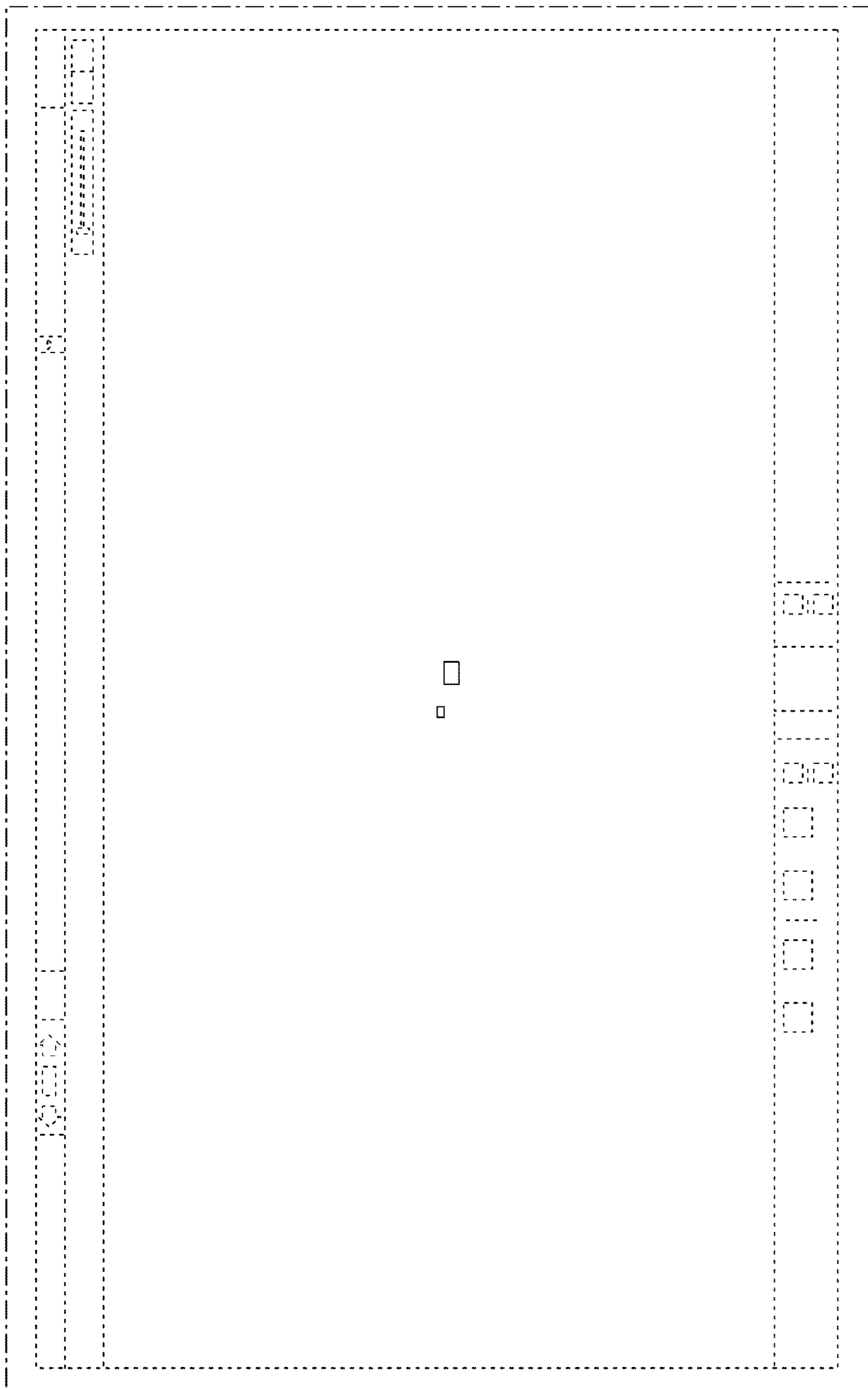

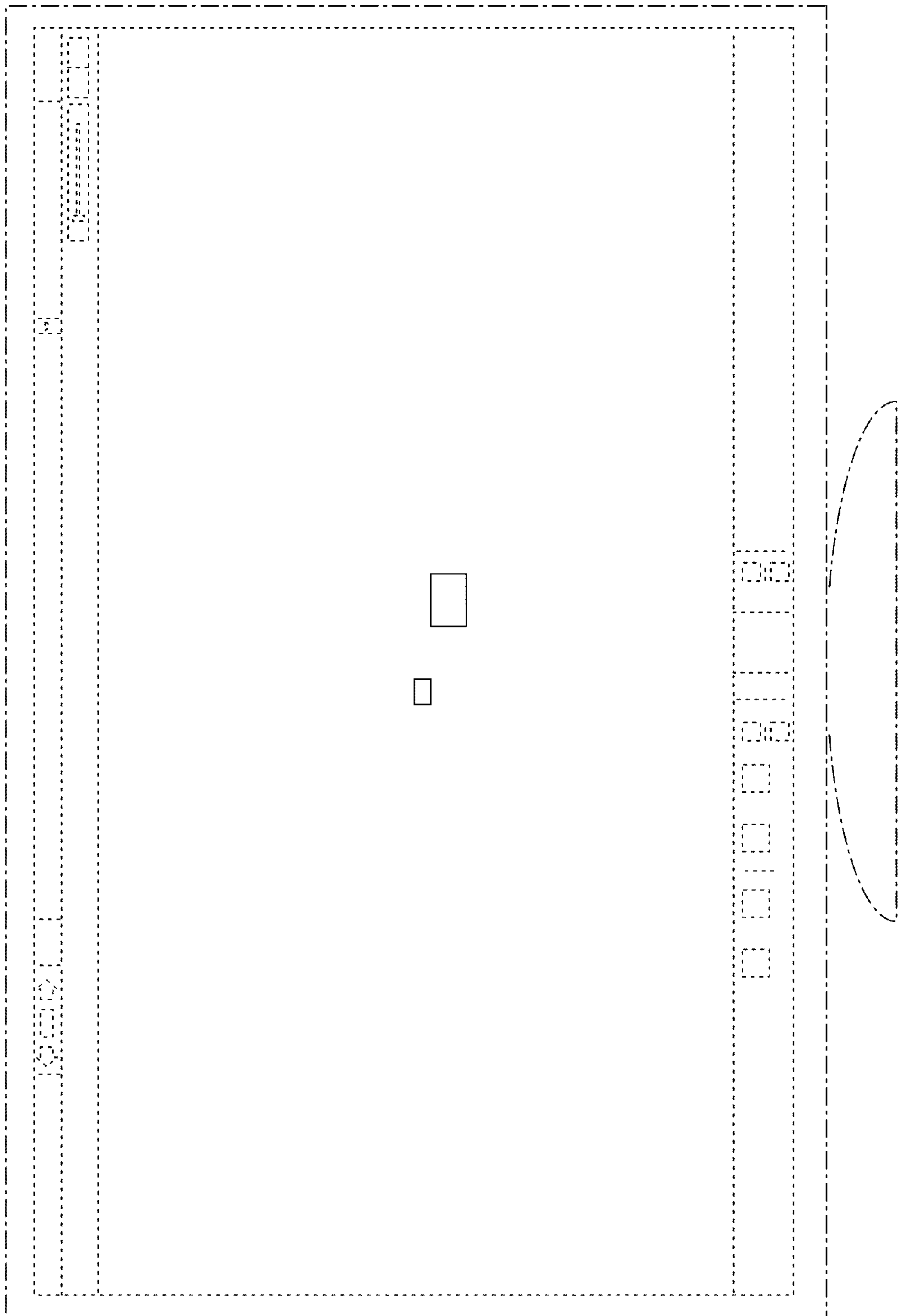

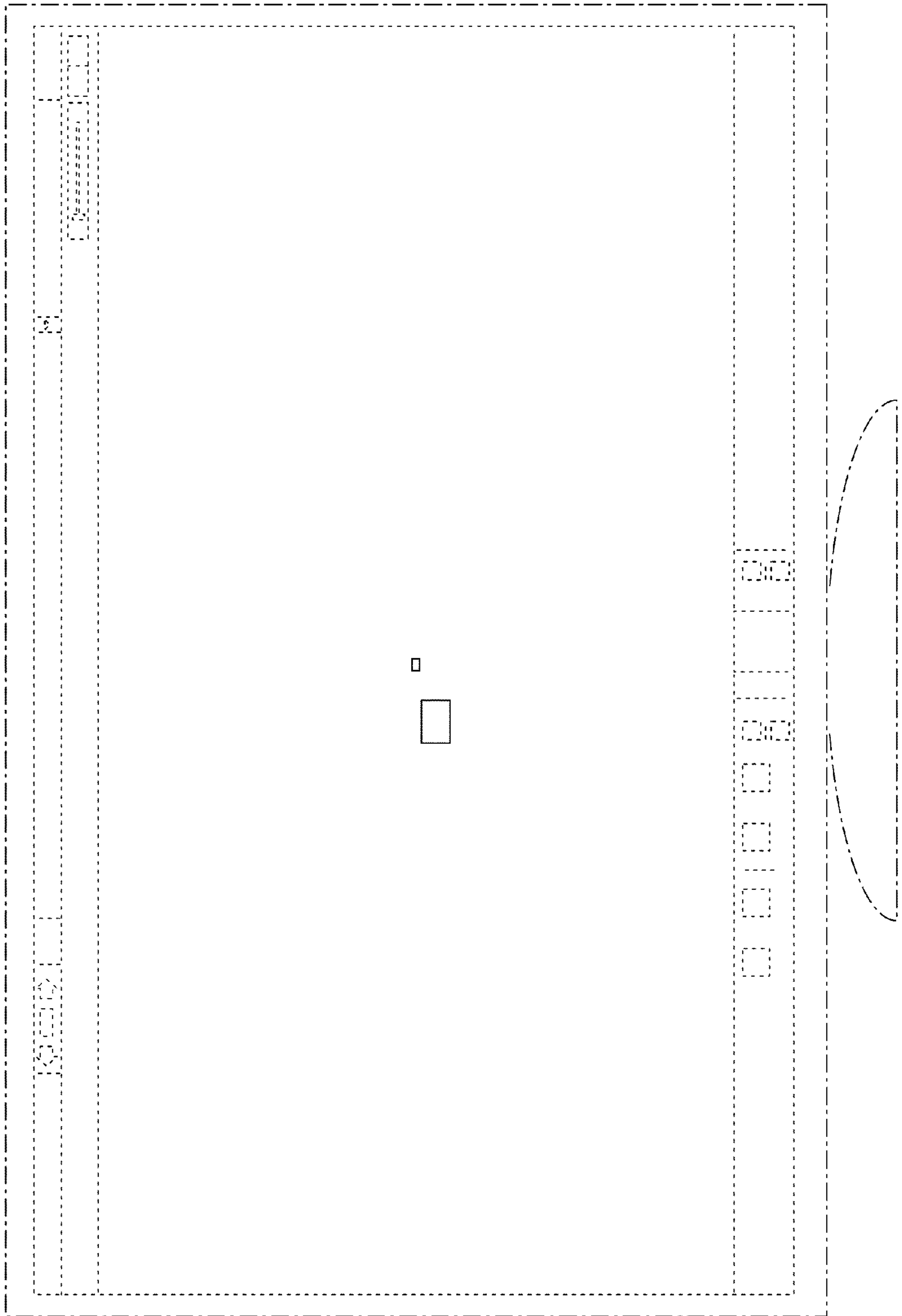

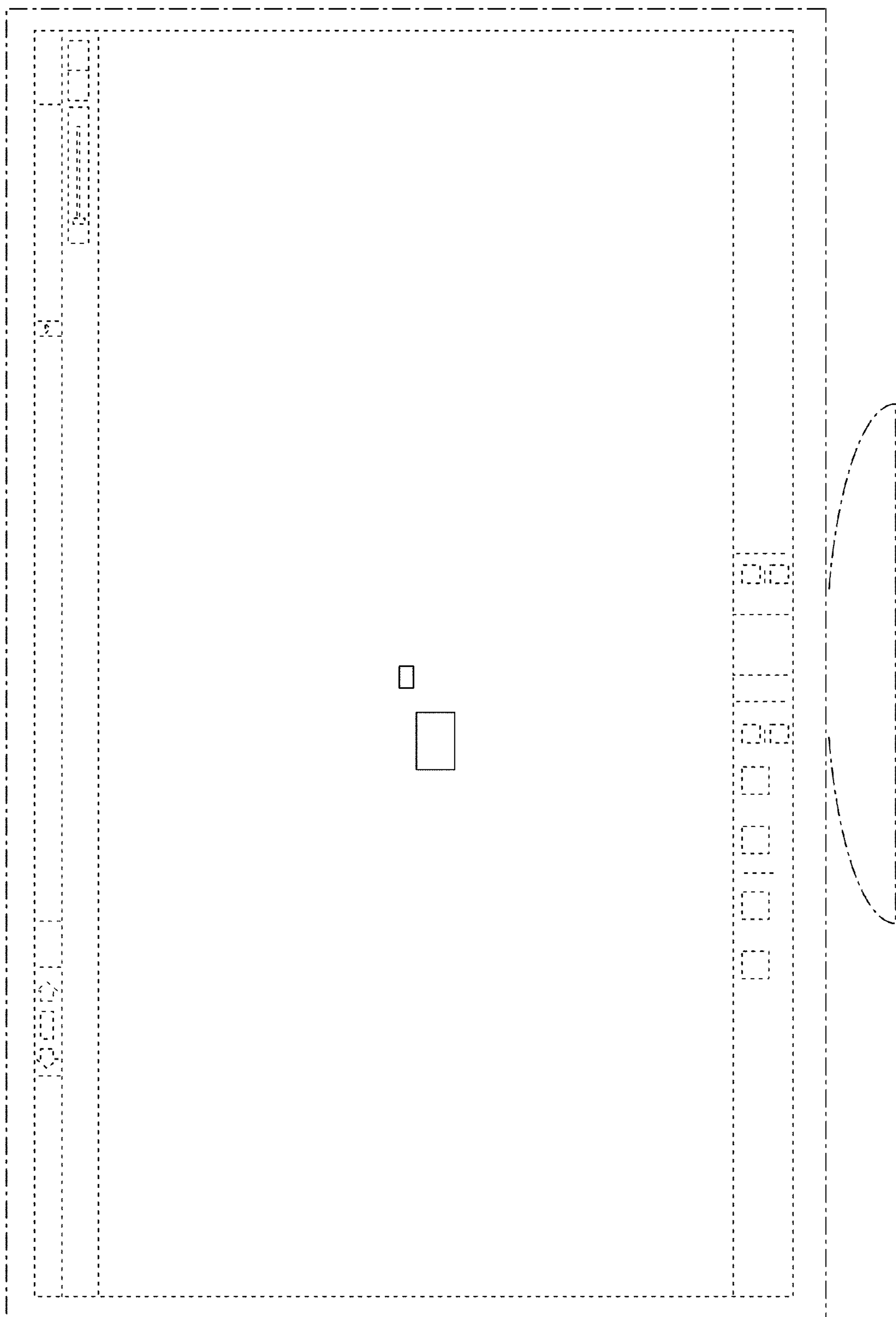

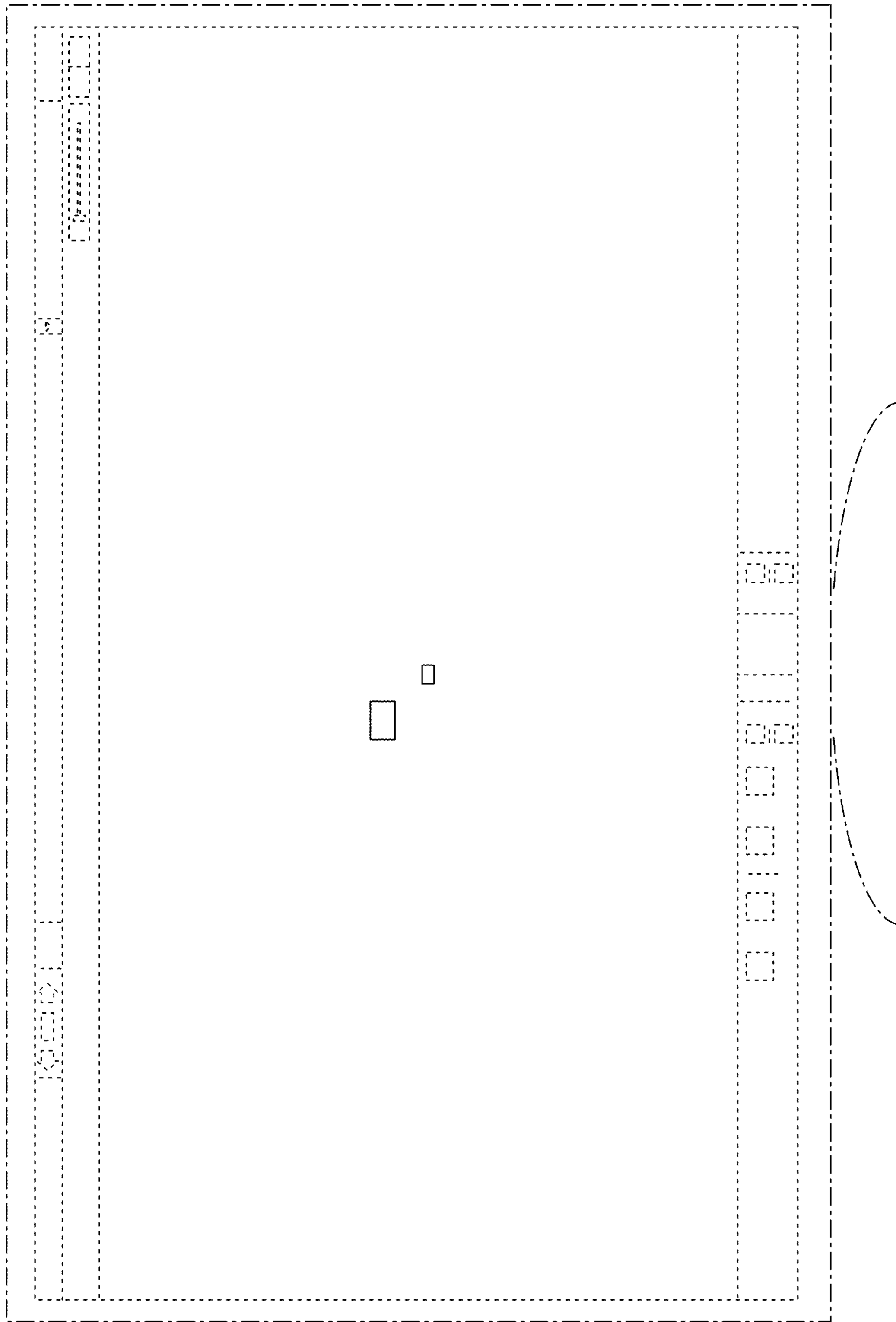

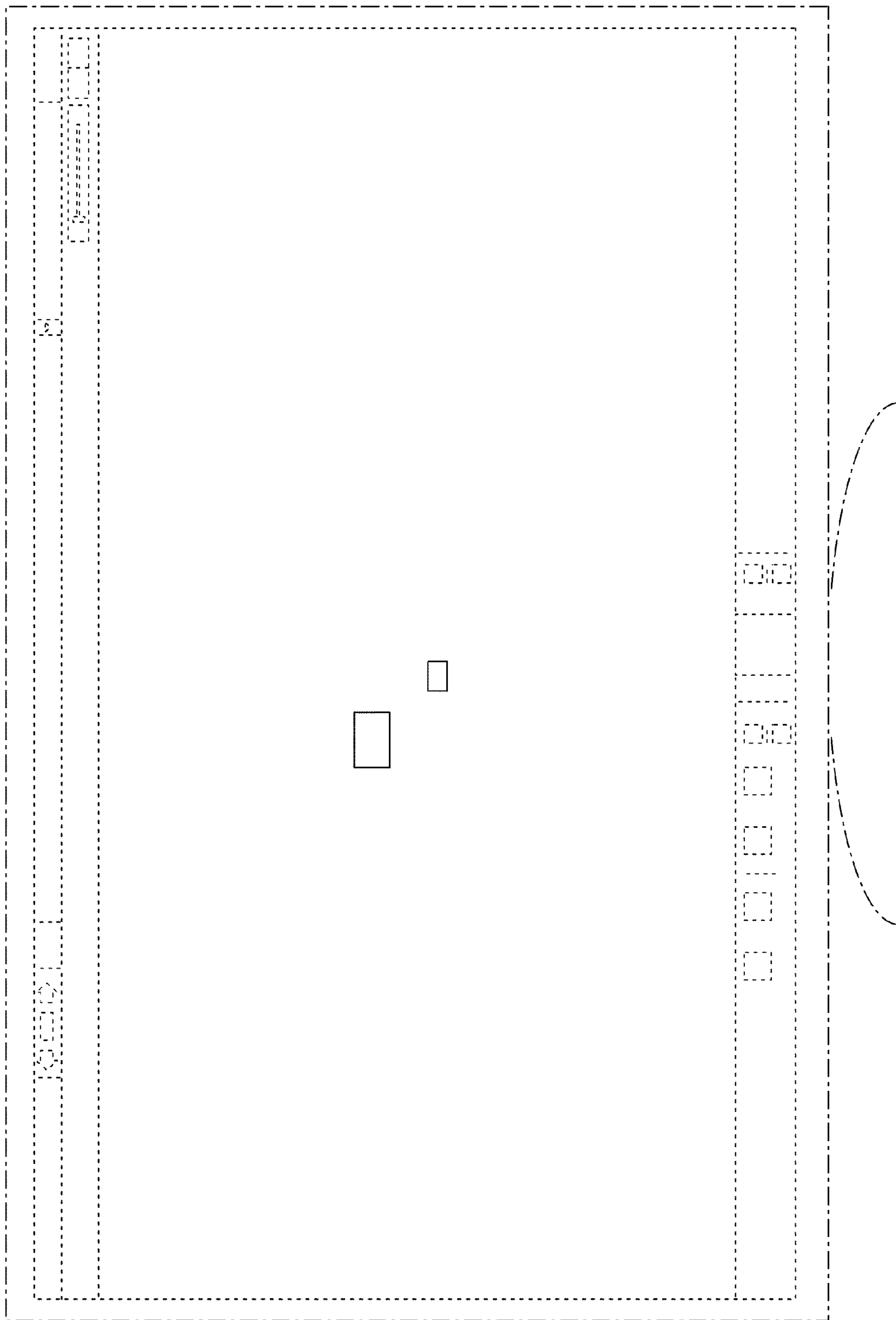

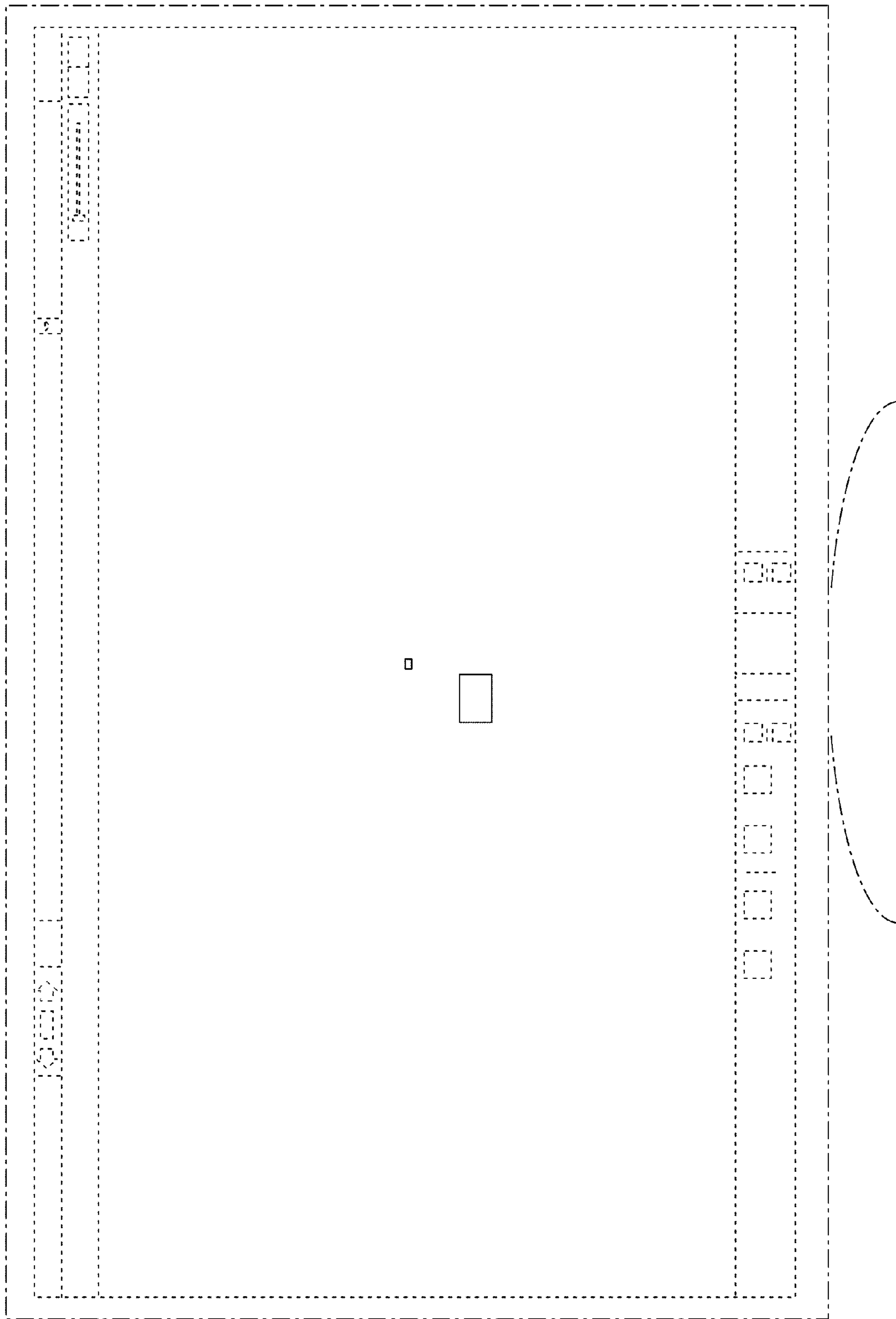

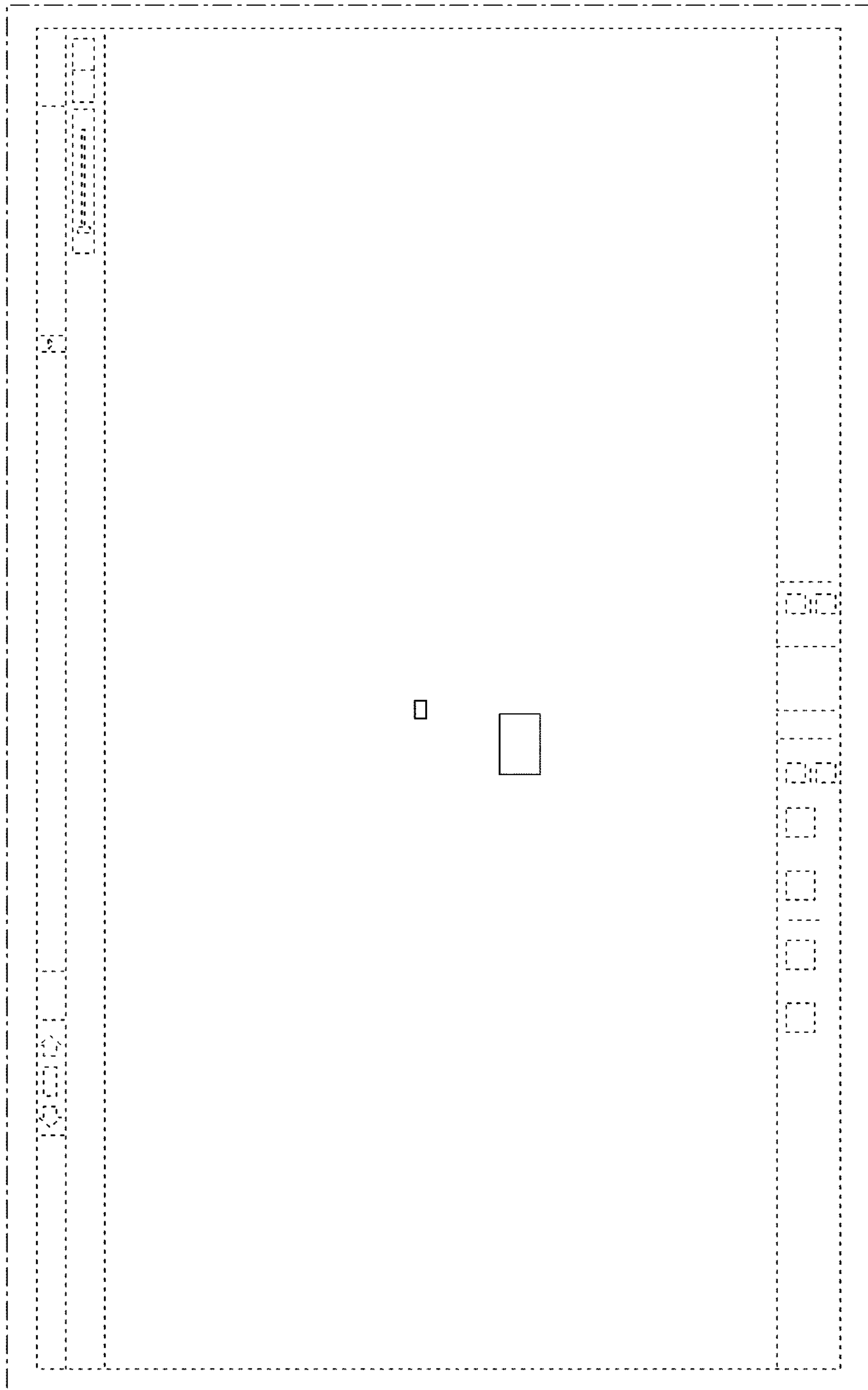

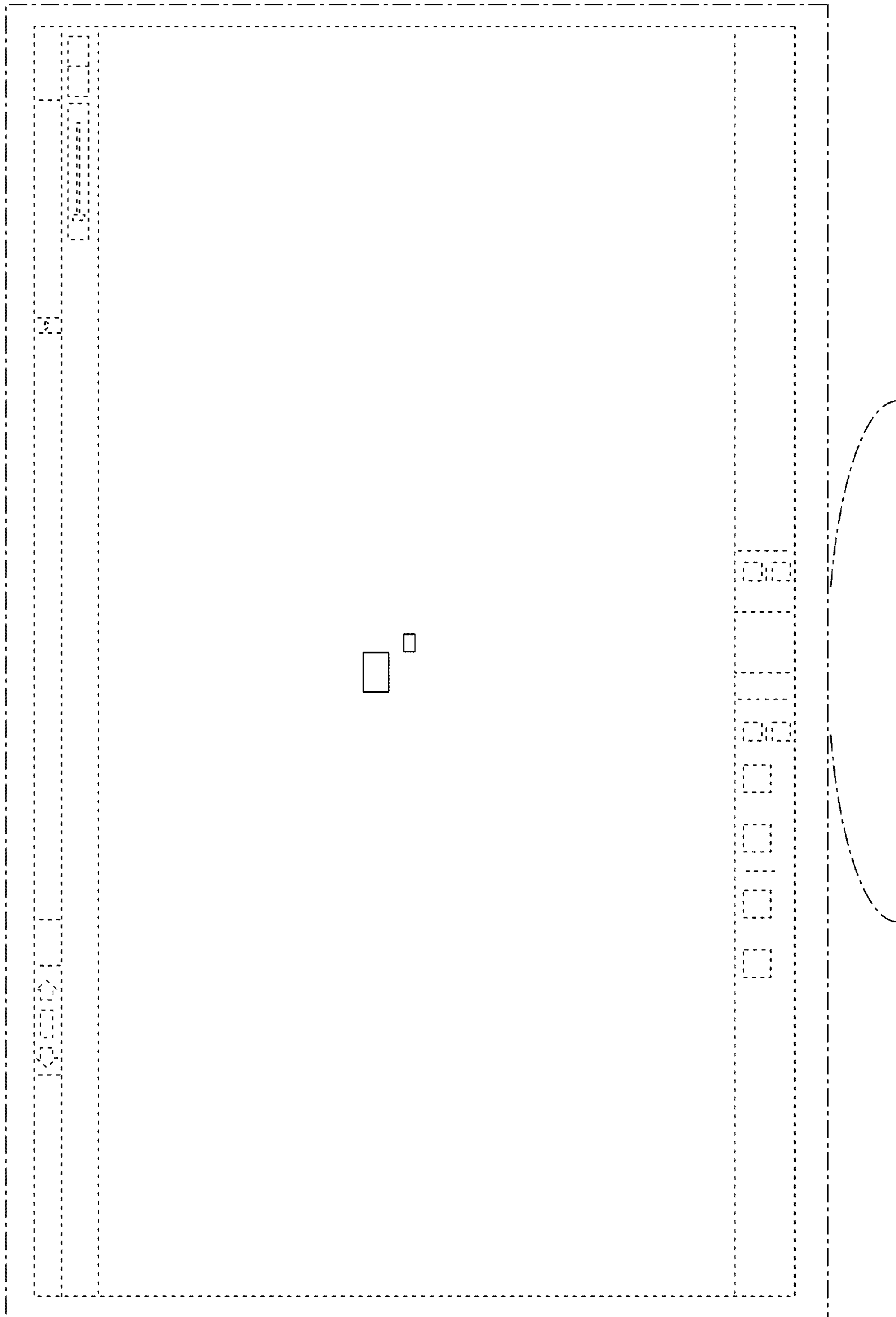

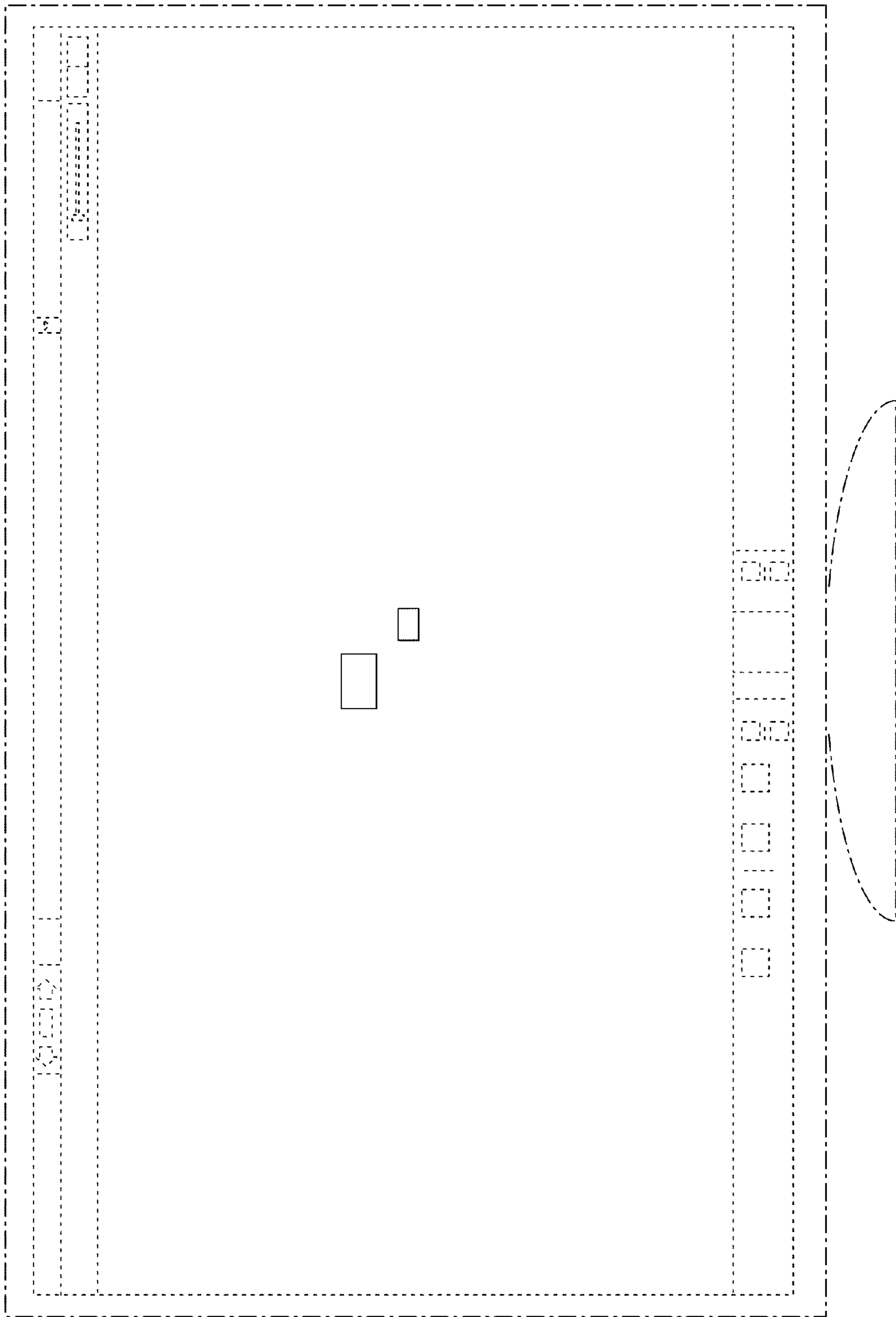

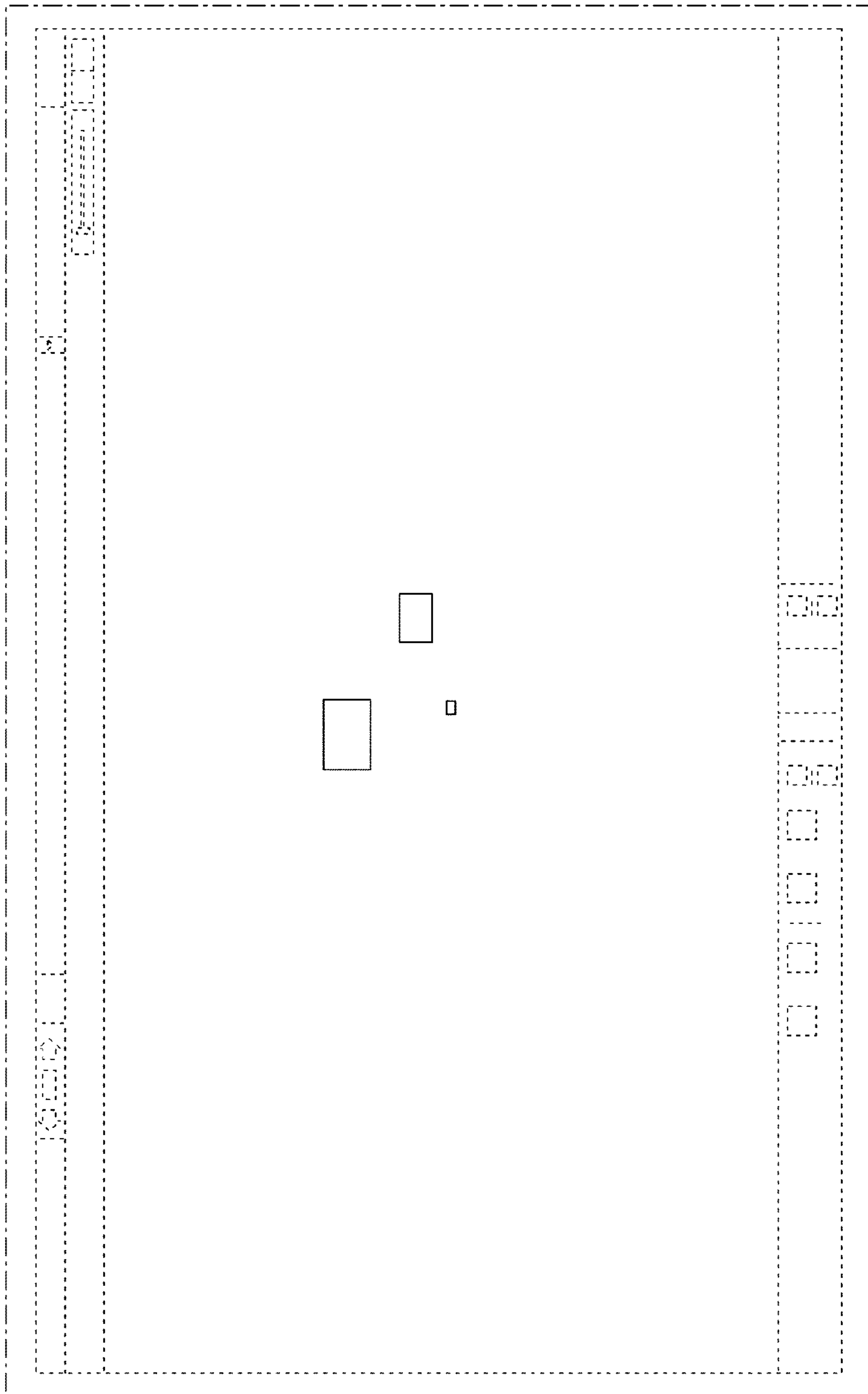

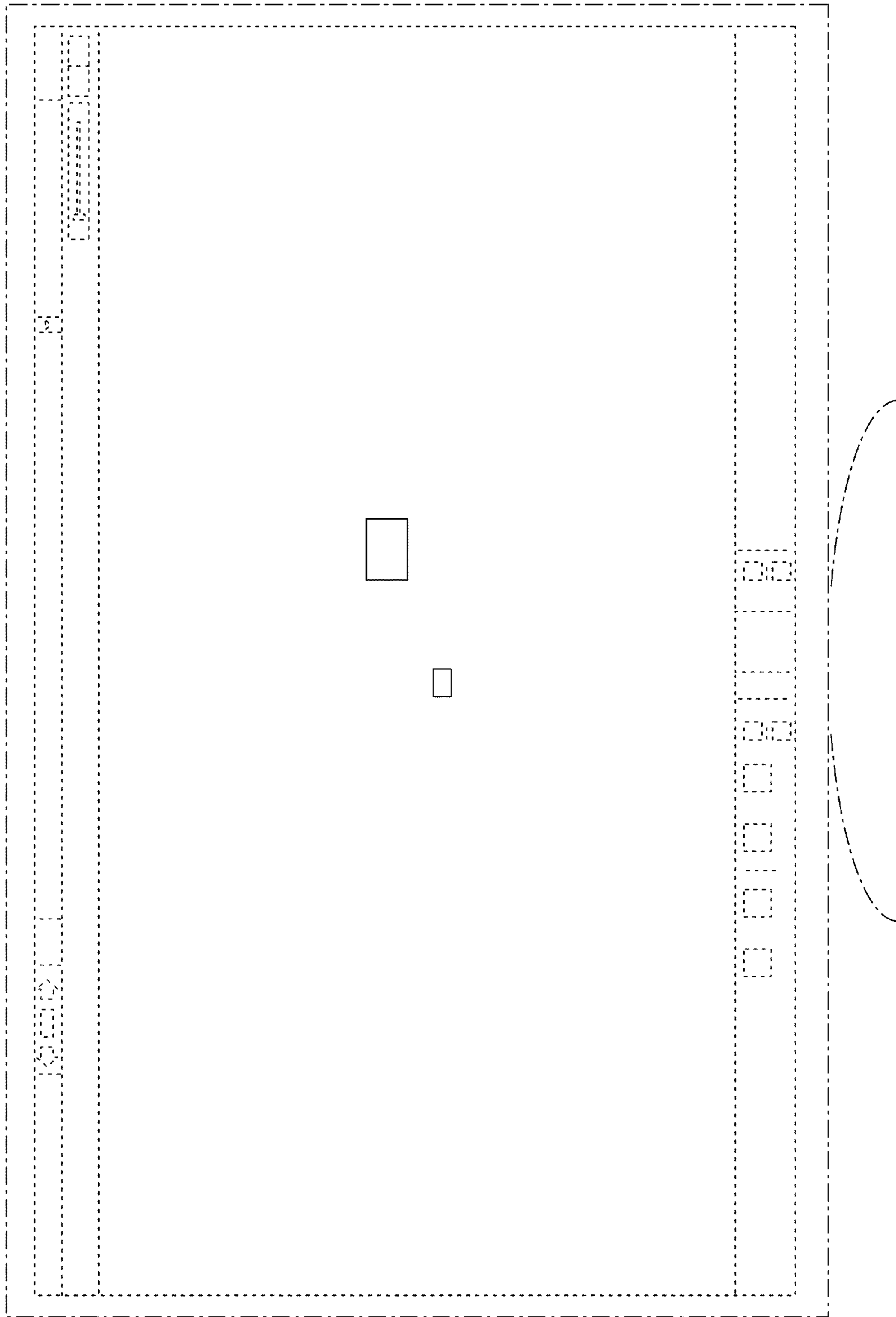

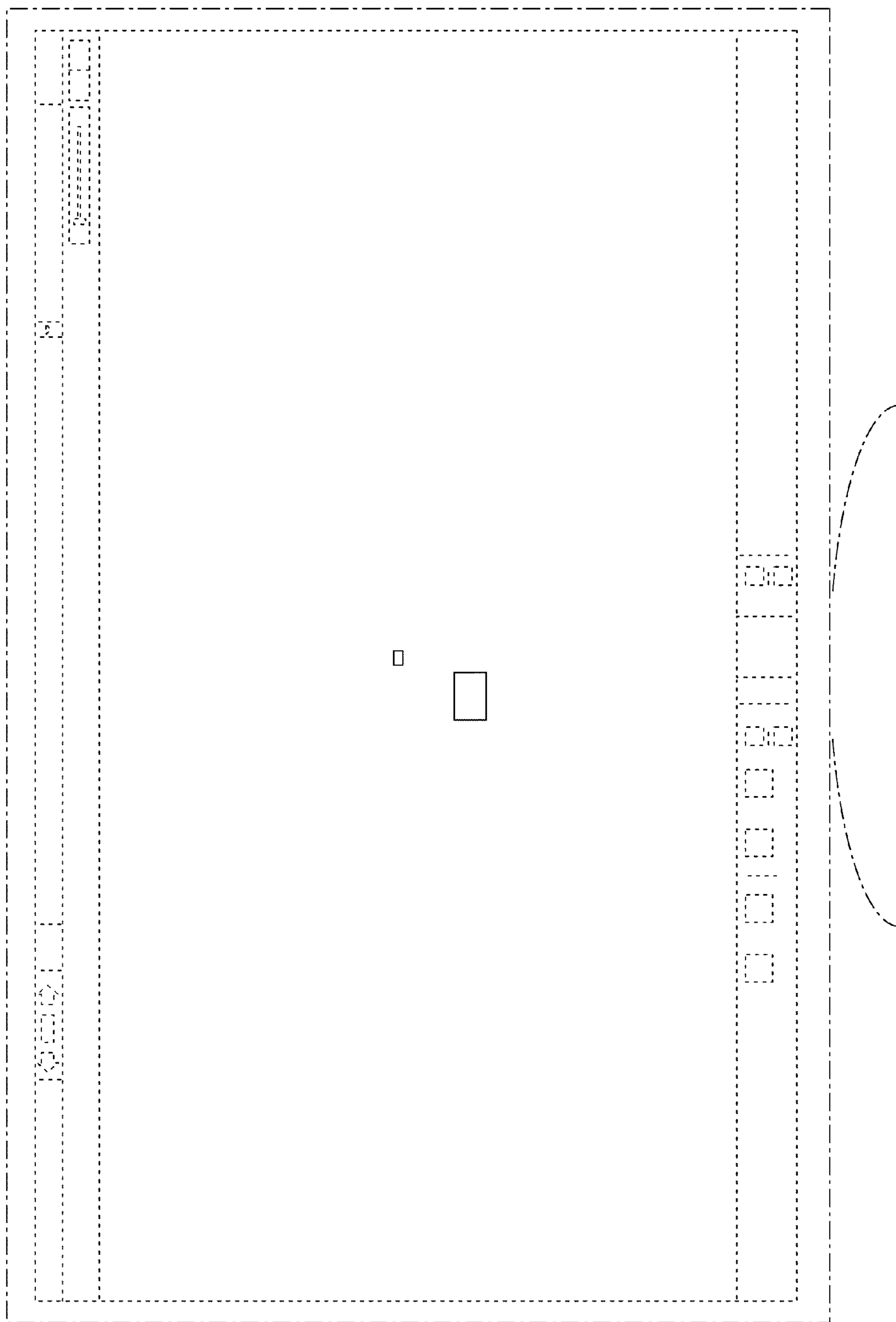

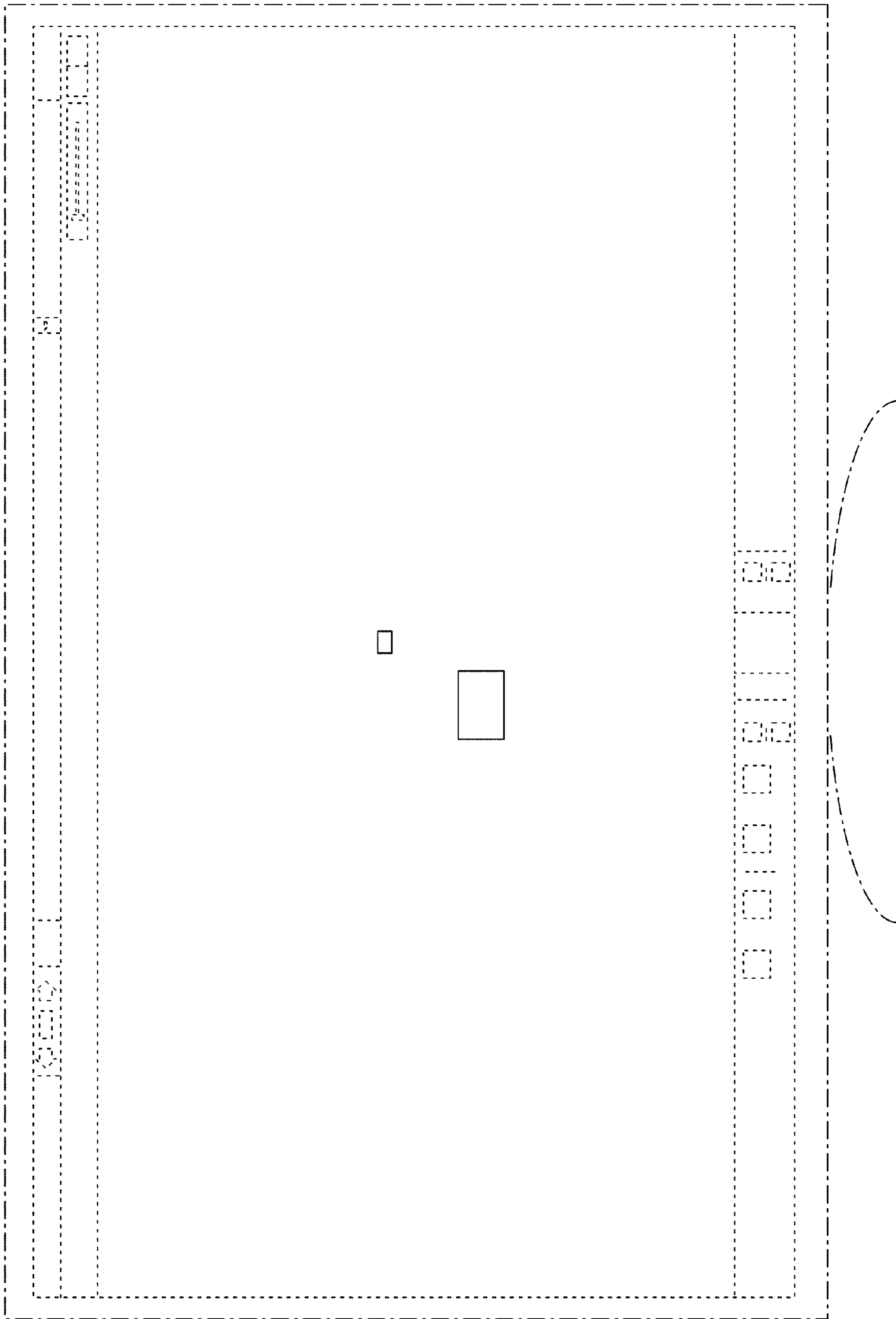

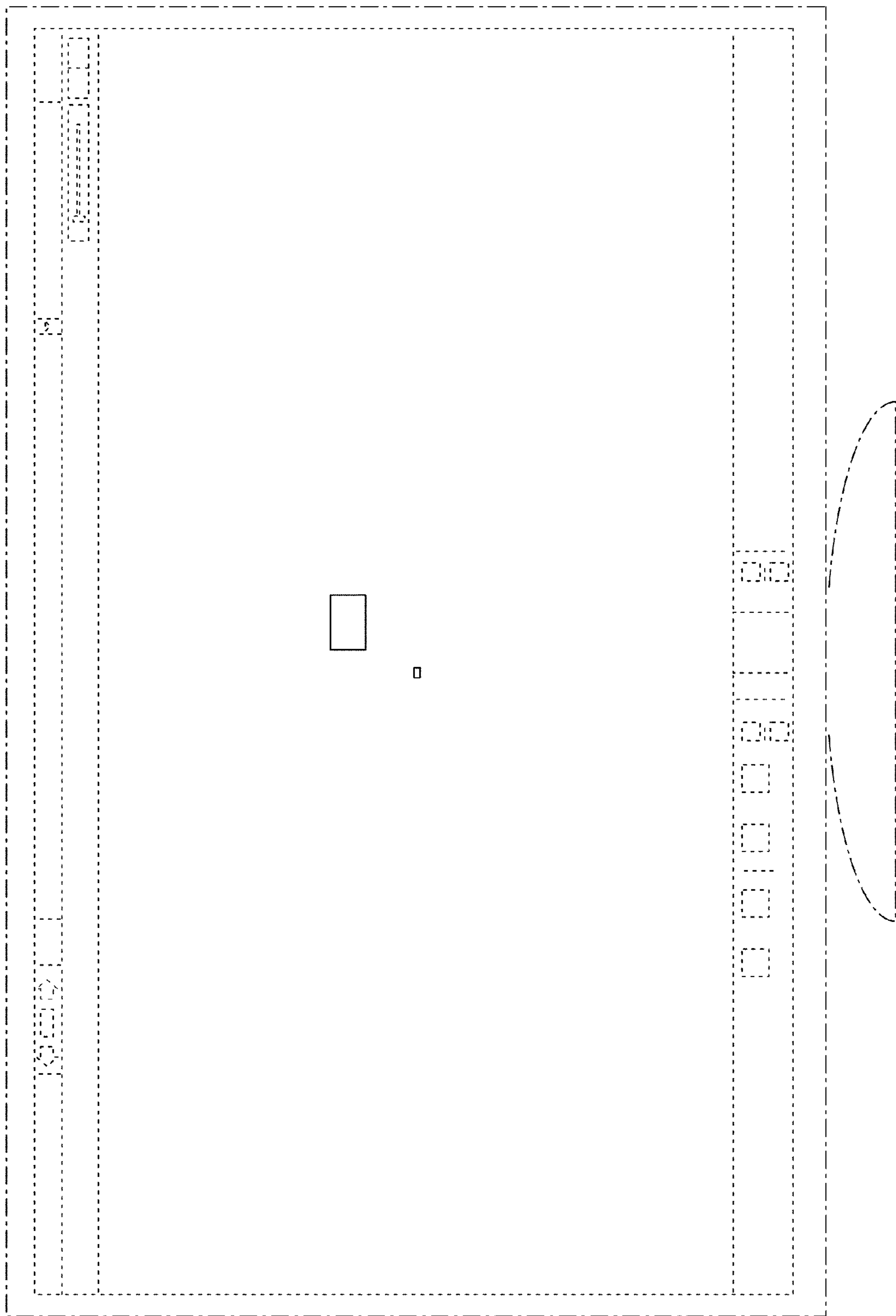

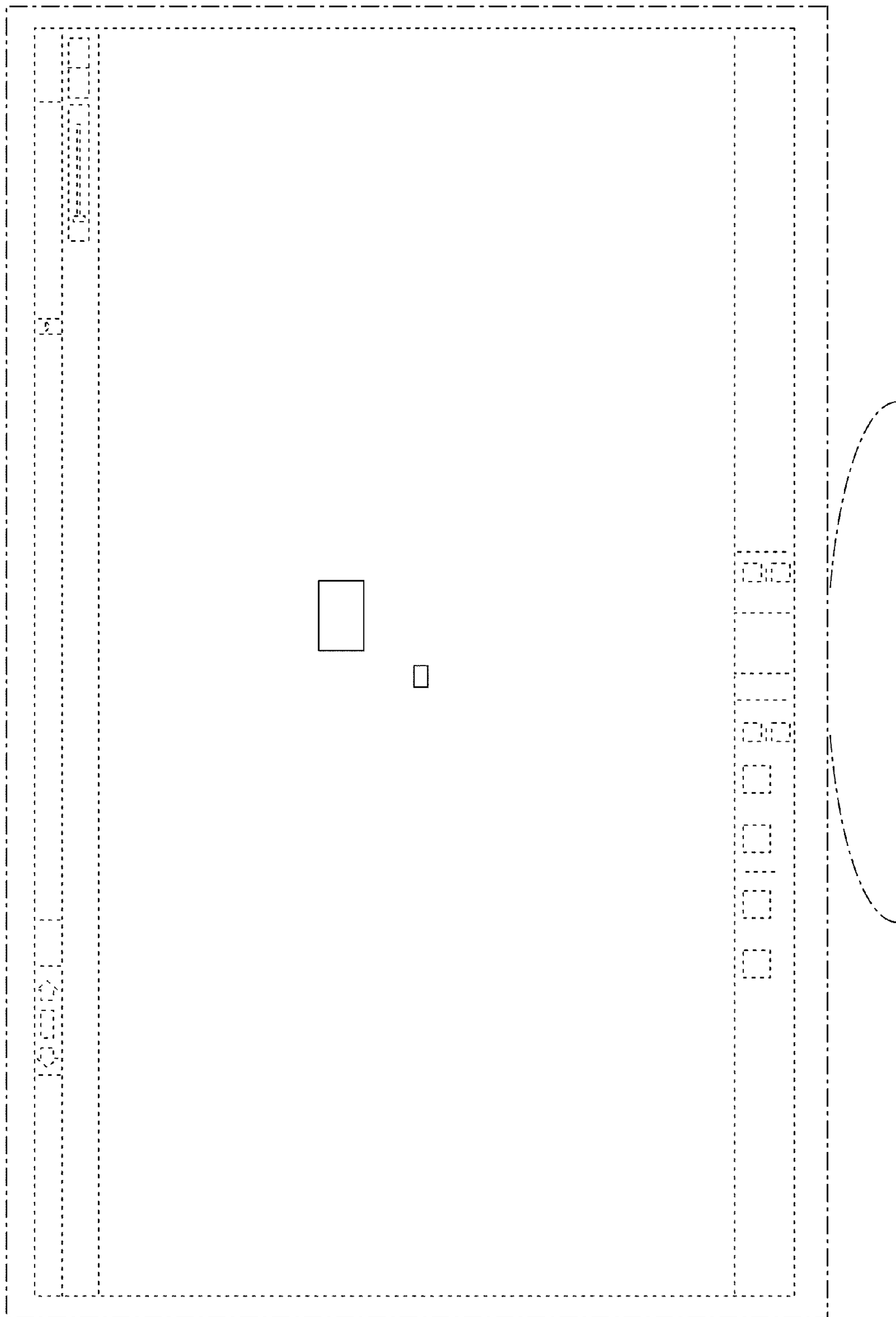

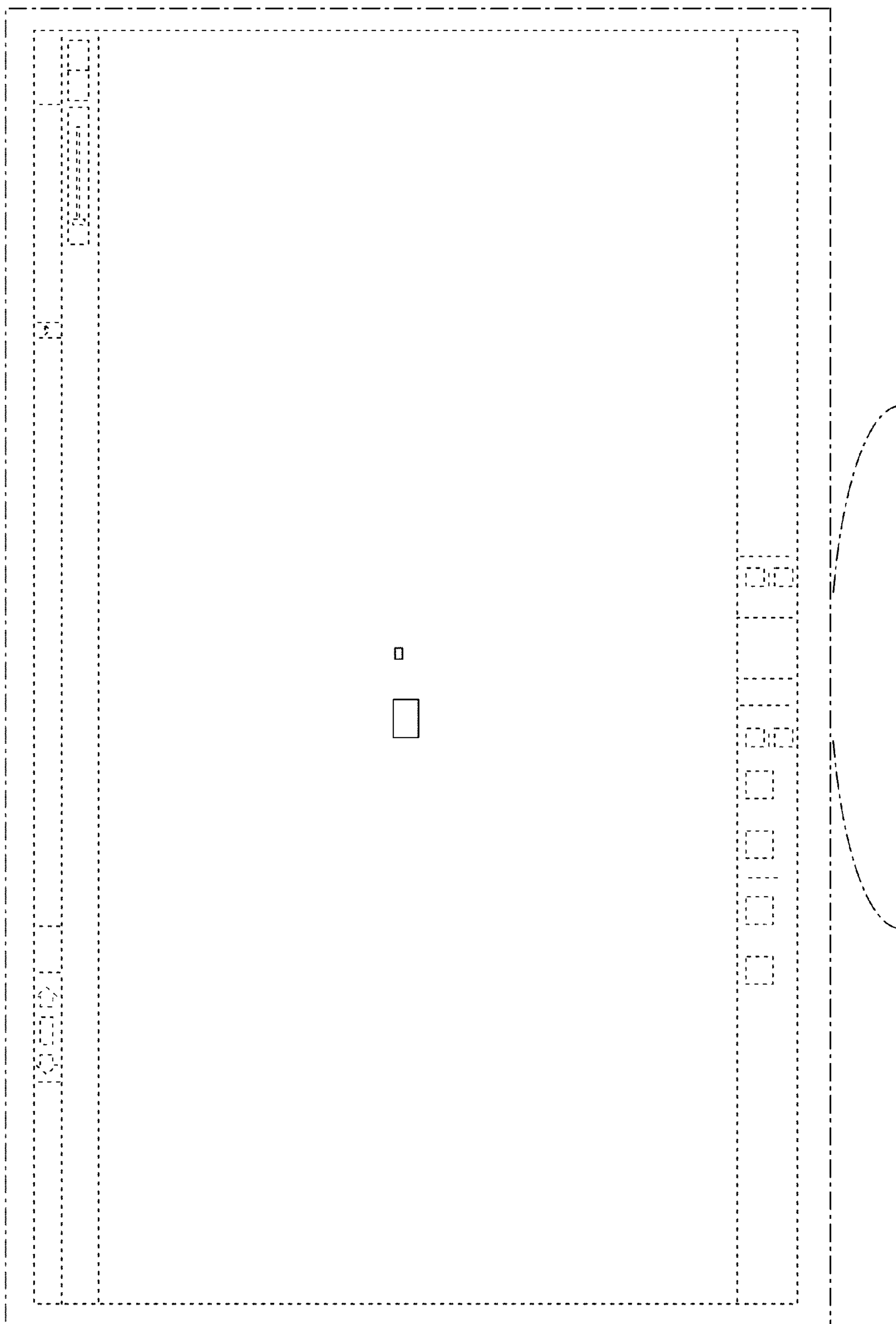

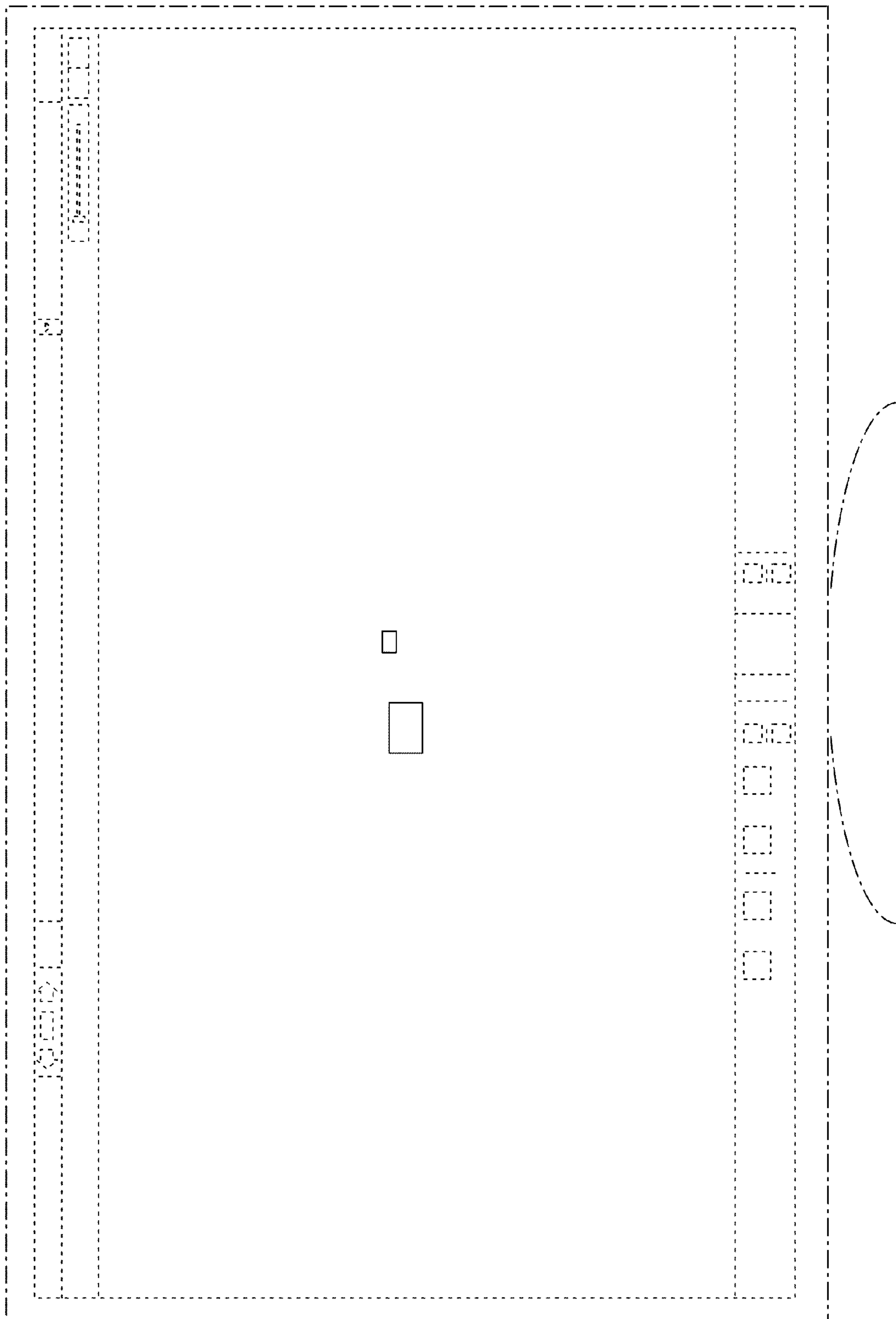

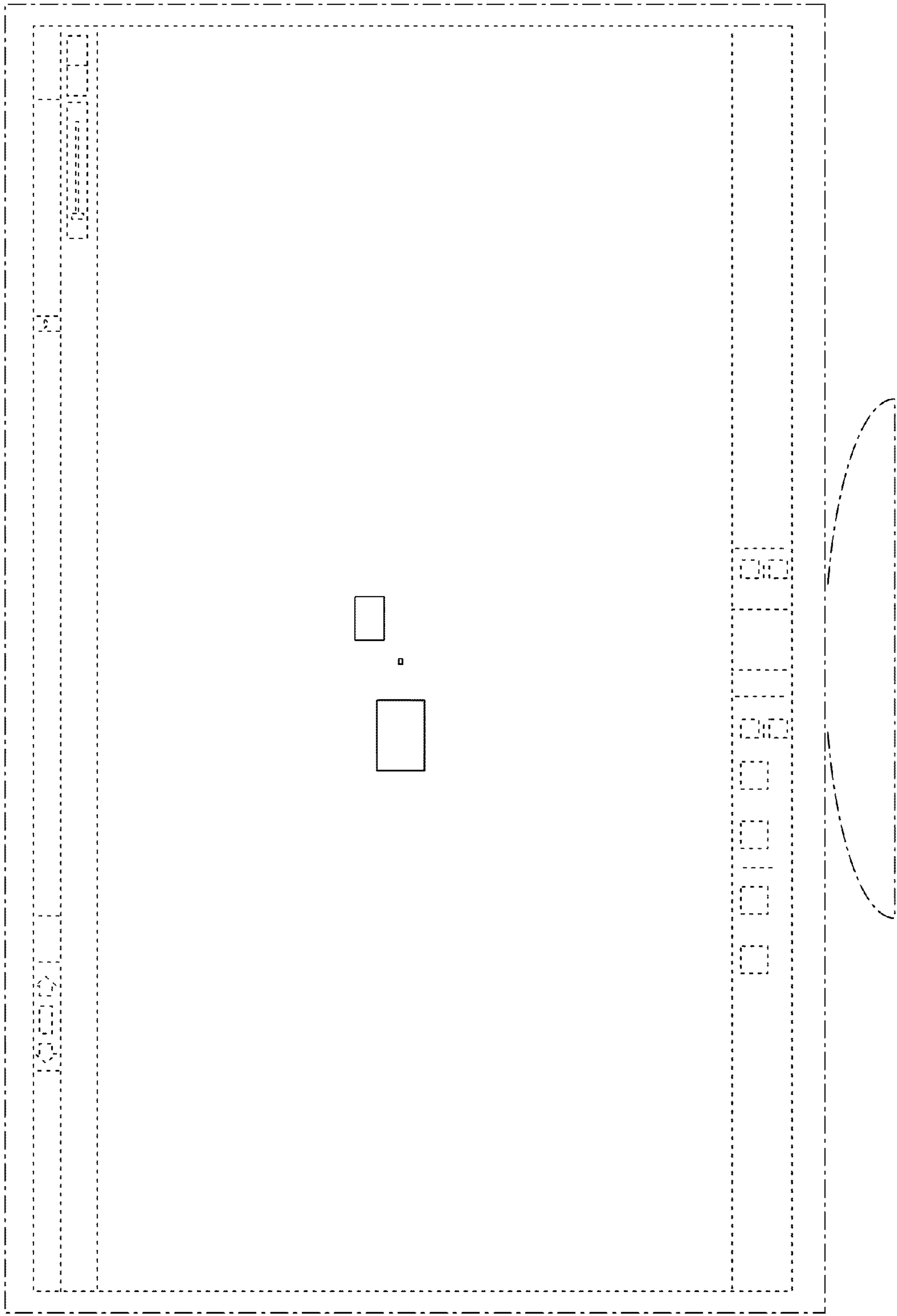

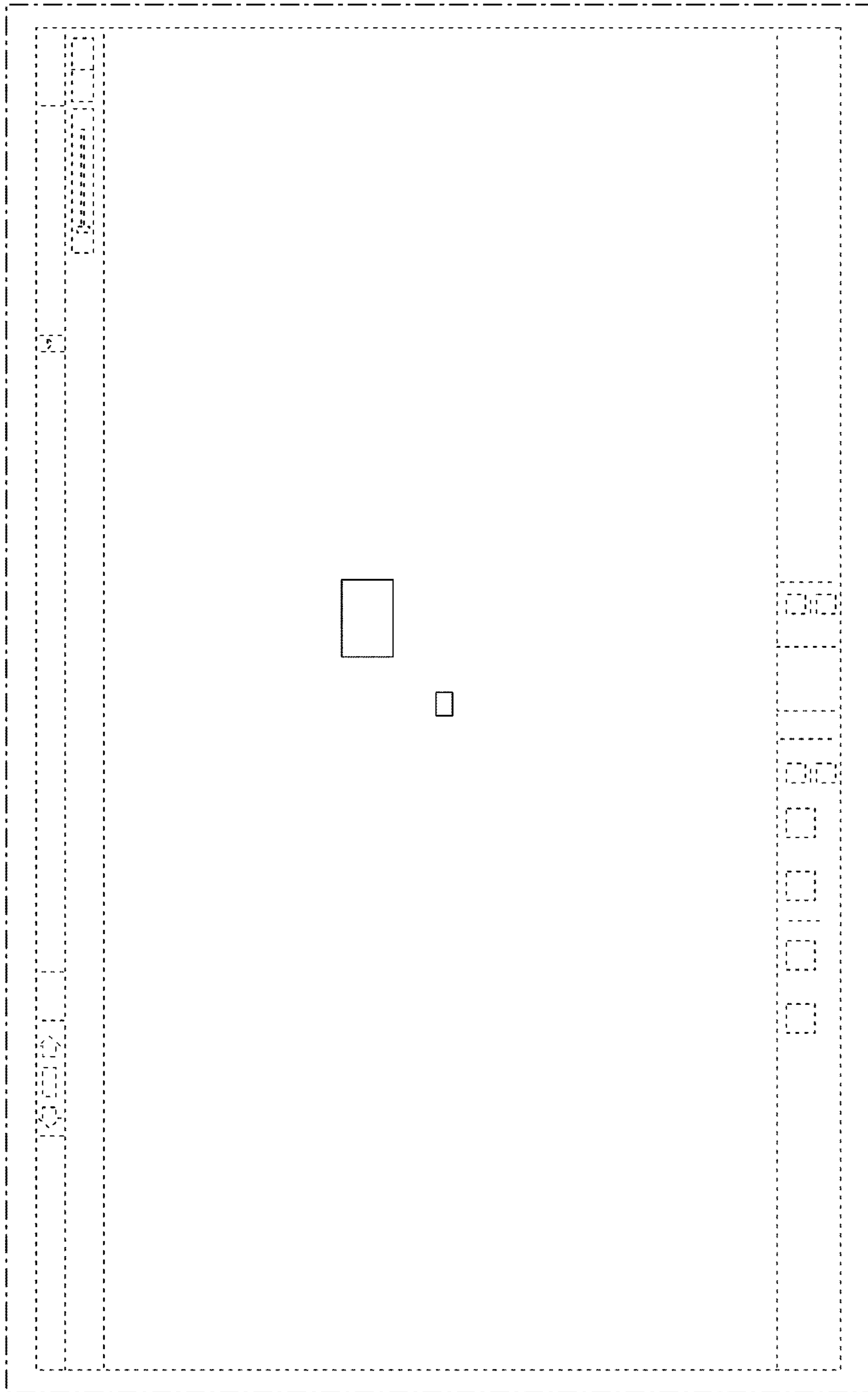

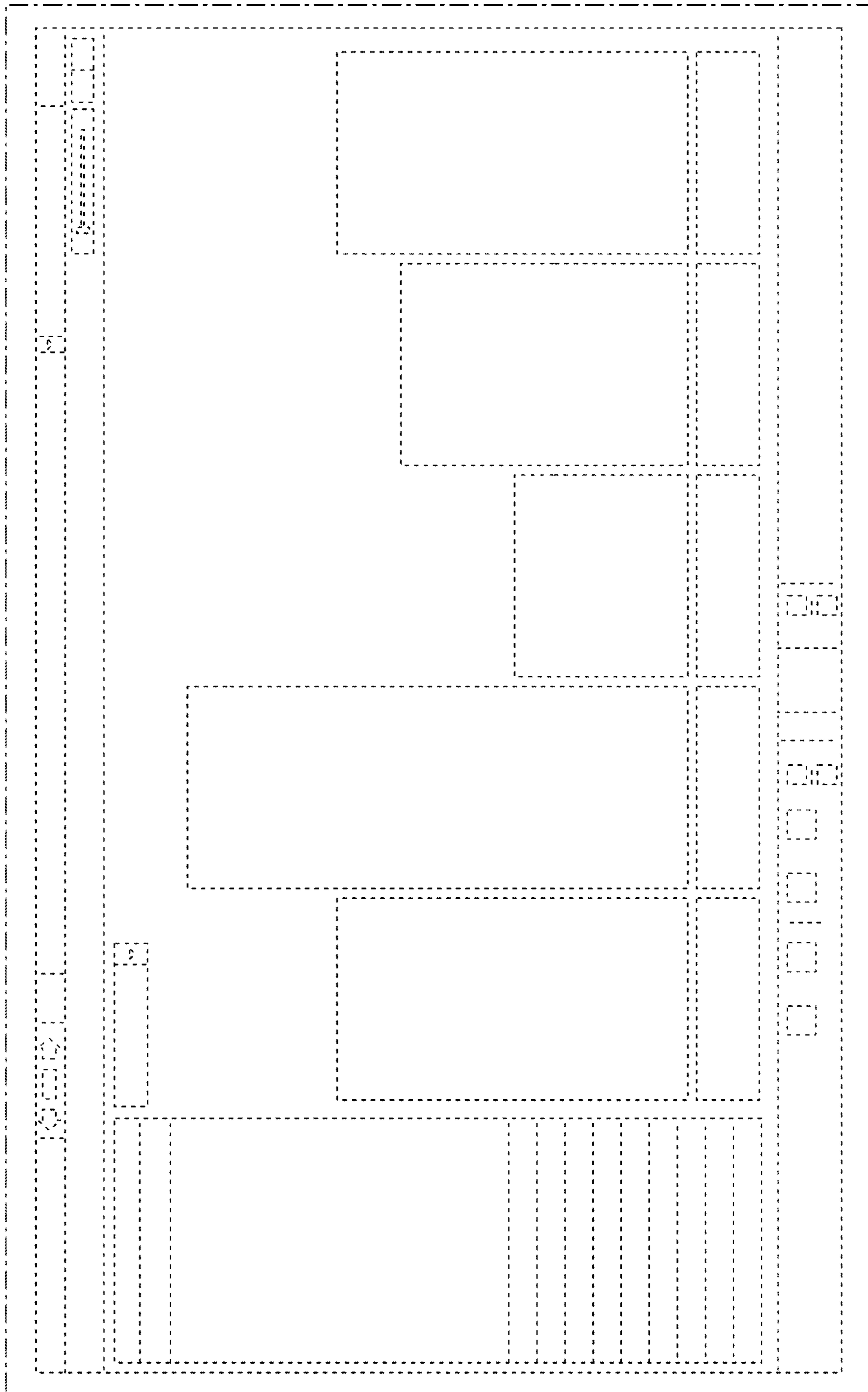
