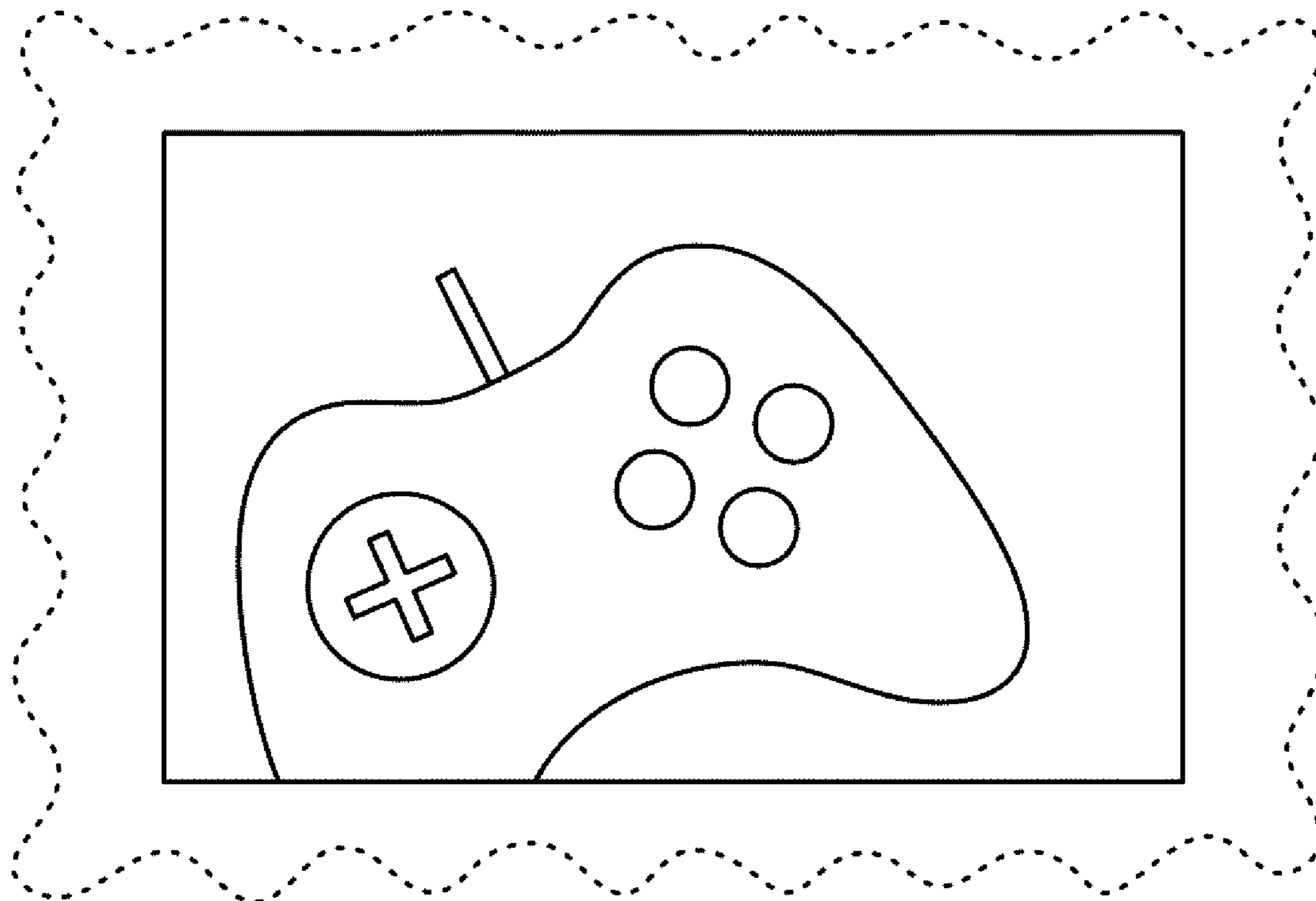
The ornamental design for an display screen with an icon, as shown and described.

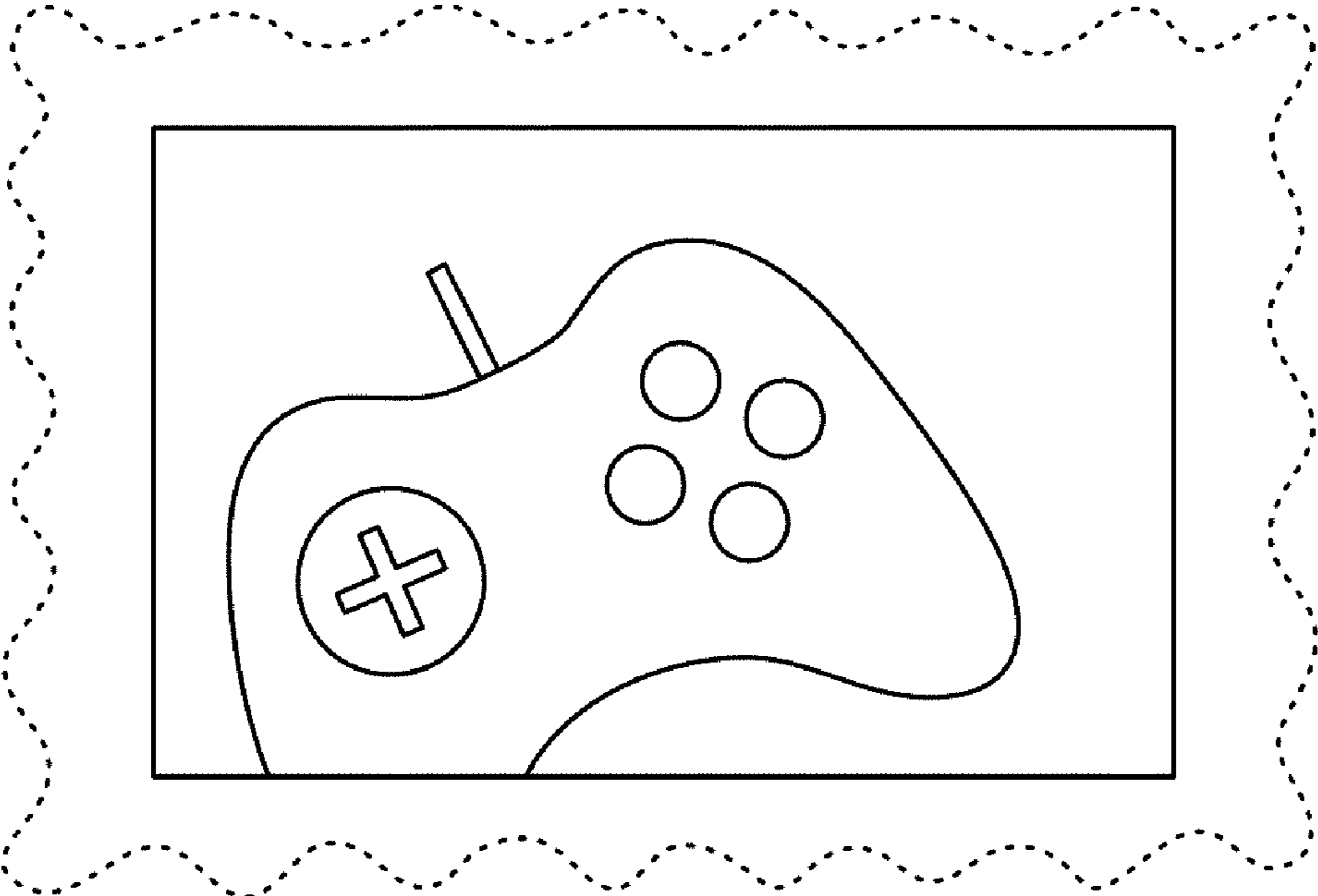
DESCRIPTION
