(57) **CLAIM**

The ornamental design for a display screen with an icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with an icon showing the new design;

FIG. 2 is a front view of an alternative embodiment of a display screen with an icon which reflects the icon for a display screen of FIG. 1 shown in mirror image;

FIG. 3 is front view of the embodiment of FIG. 1, shown in the context with different unclaimed environment;

FIG. 4 is a front view of the embodiment of FIG. 2, shown in the context with different unclaimed environment;

FIG. 5 is a front view of an alternative embodiment of a display screen with an icon showing the design;

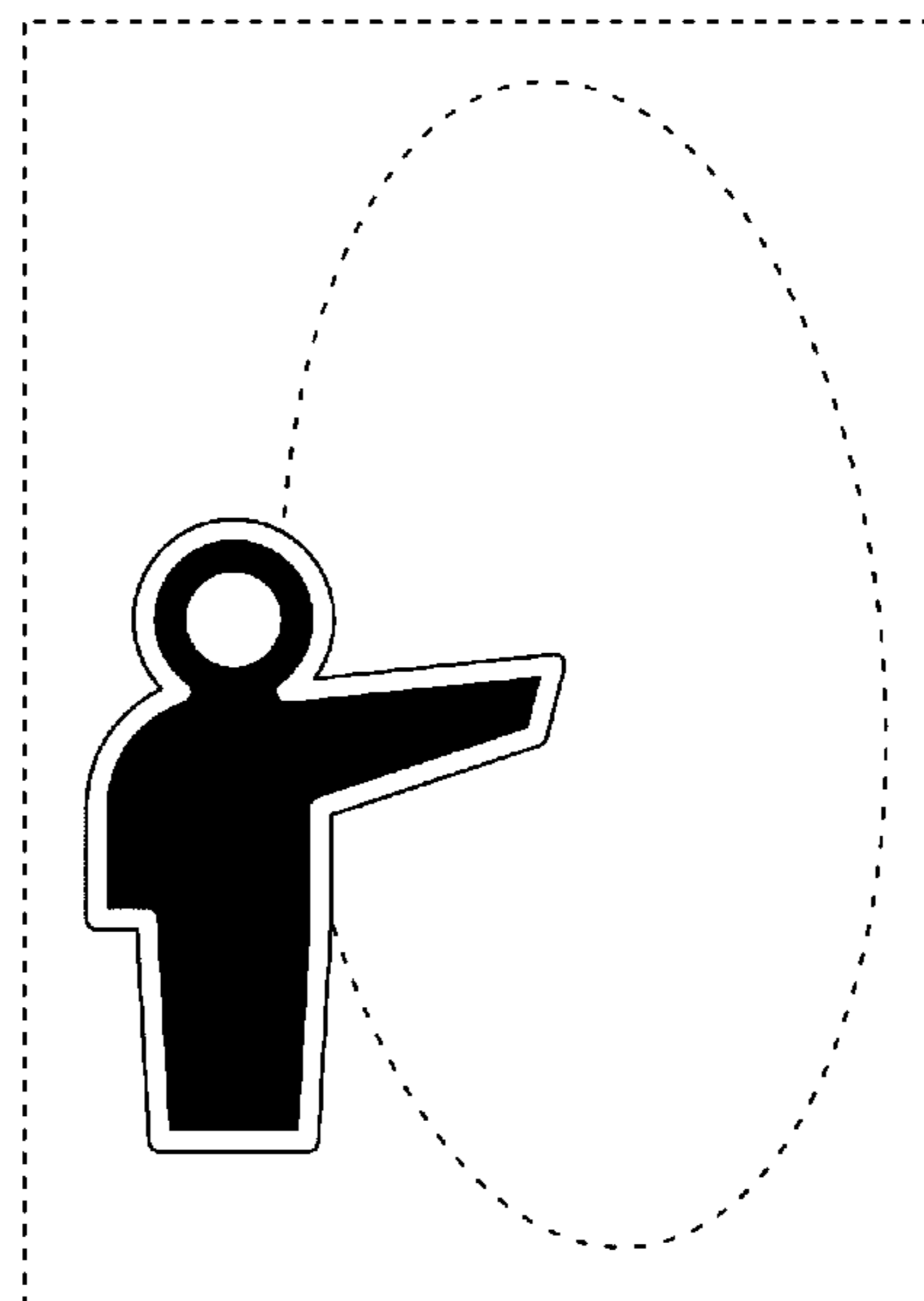
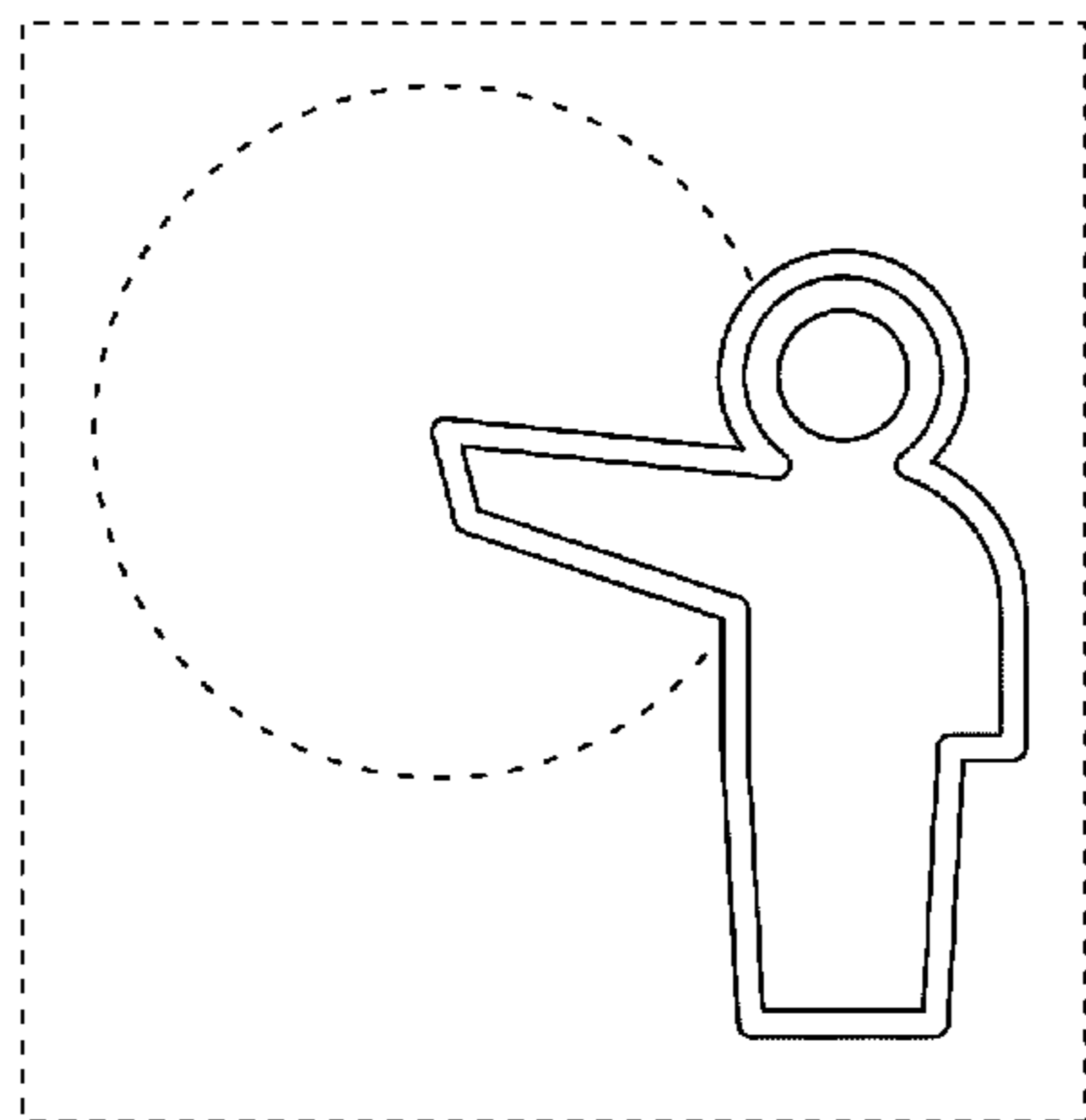
FIG. 6 is a front view of an alternative embodiment of a display screen with an icon which reflects the icon for a display screen of FIG. 5 shown in mirror image;

FIG. 7 is a front view of the embodiment of FIG. 5, shown in the context with different unclaimed environment; and,

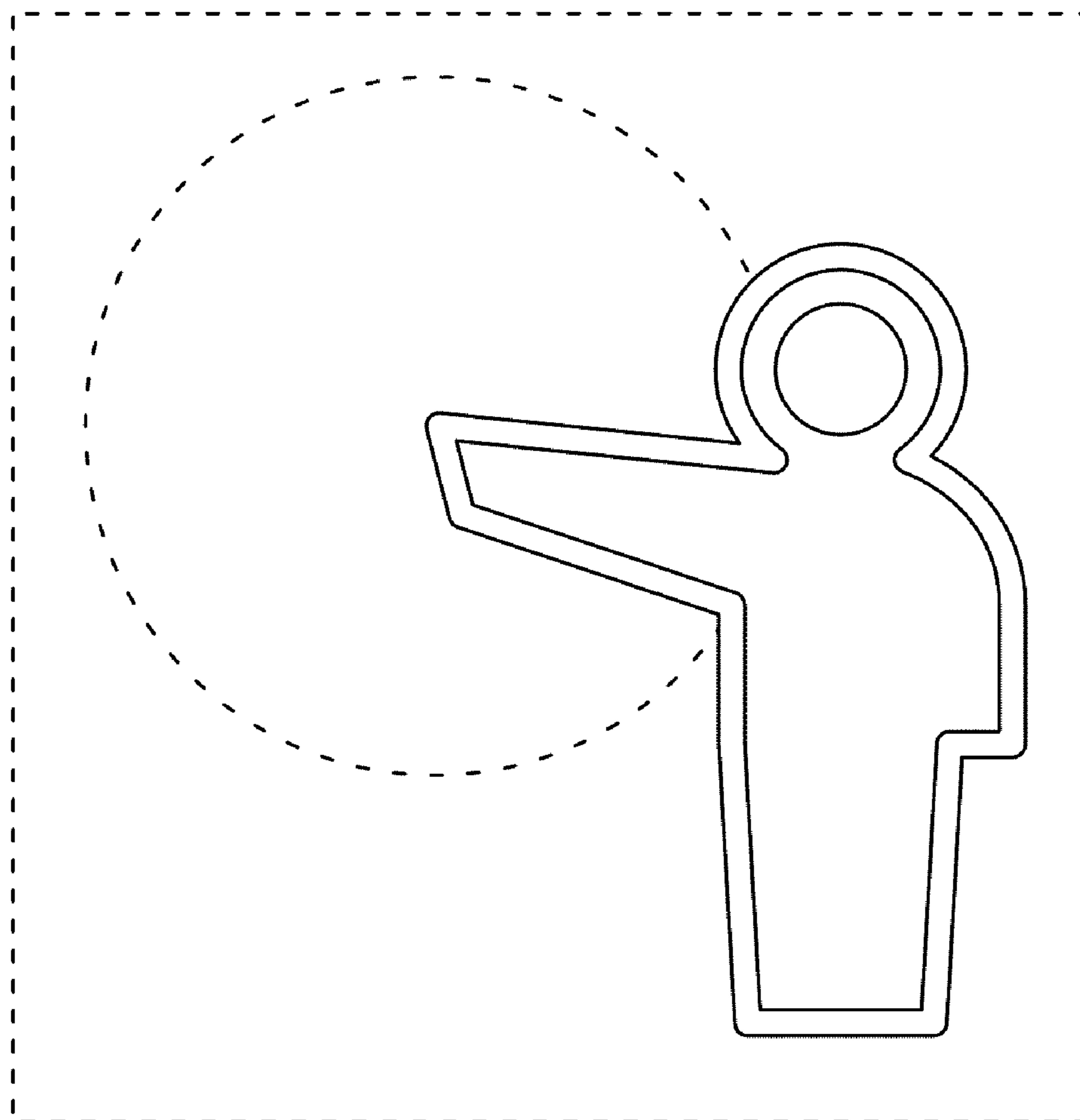

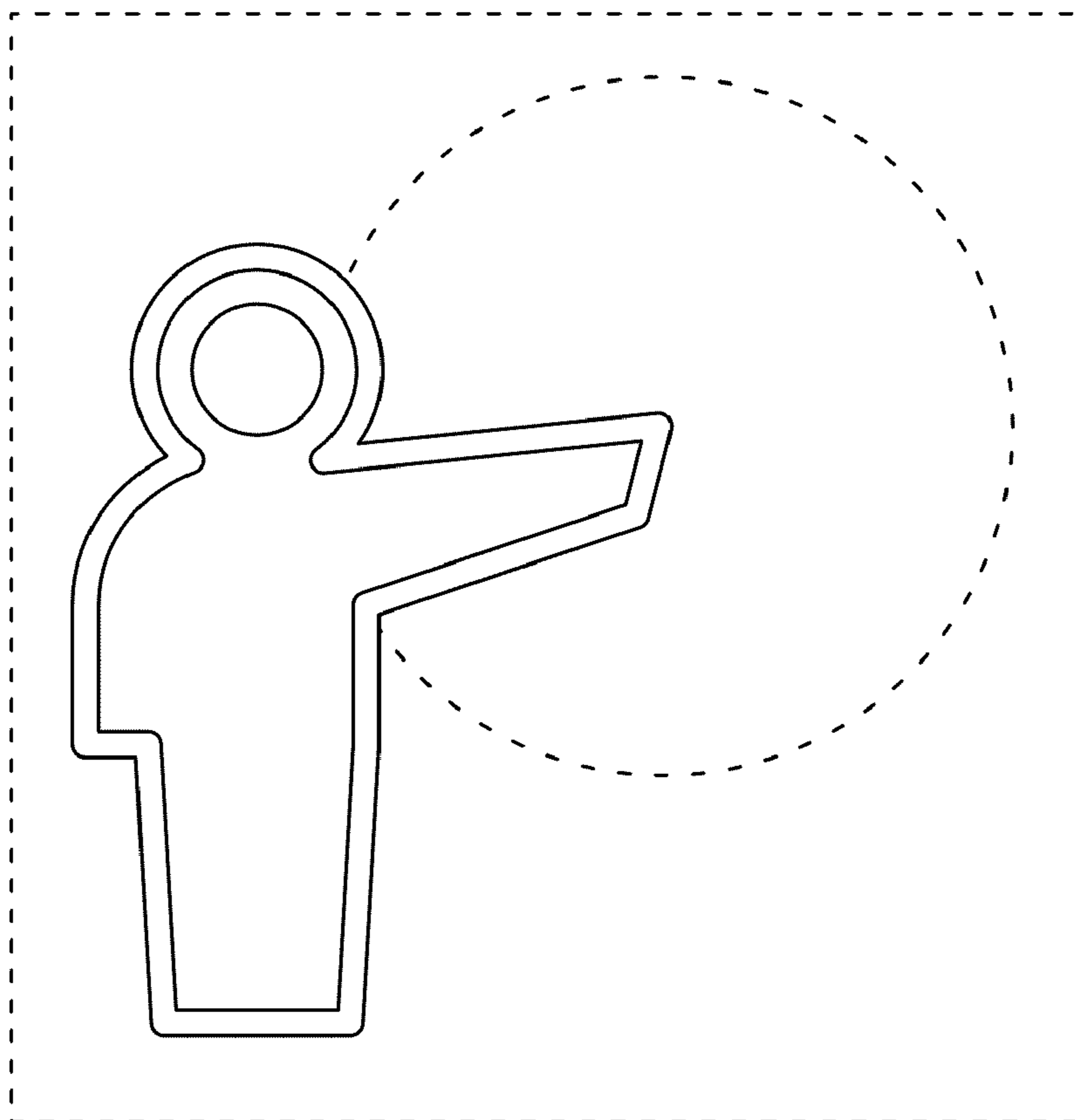

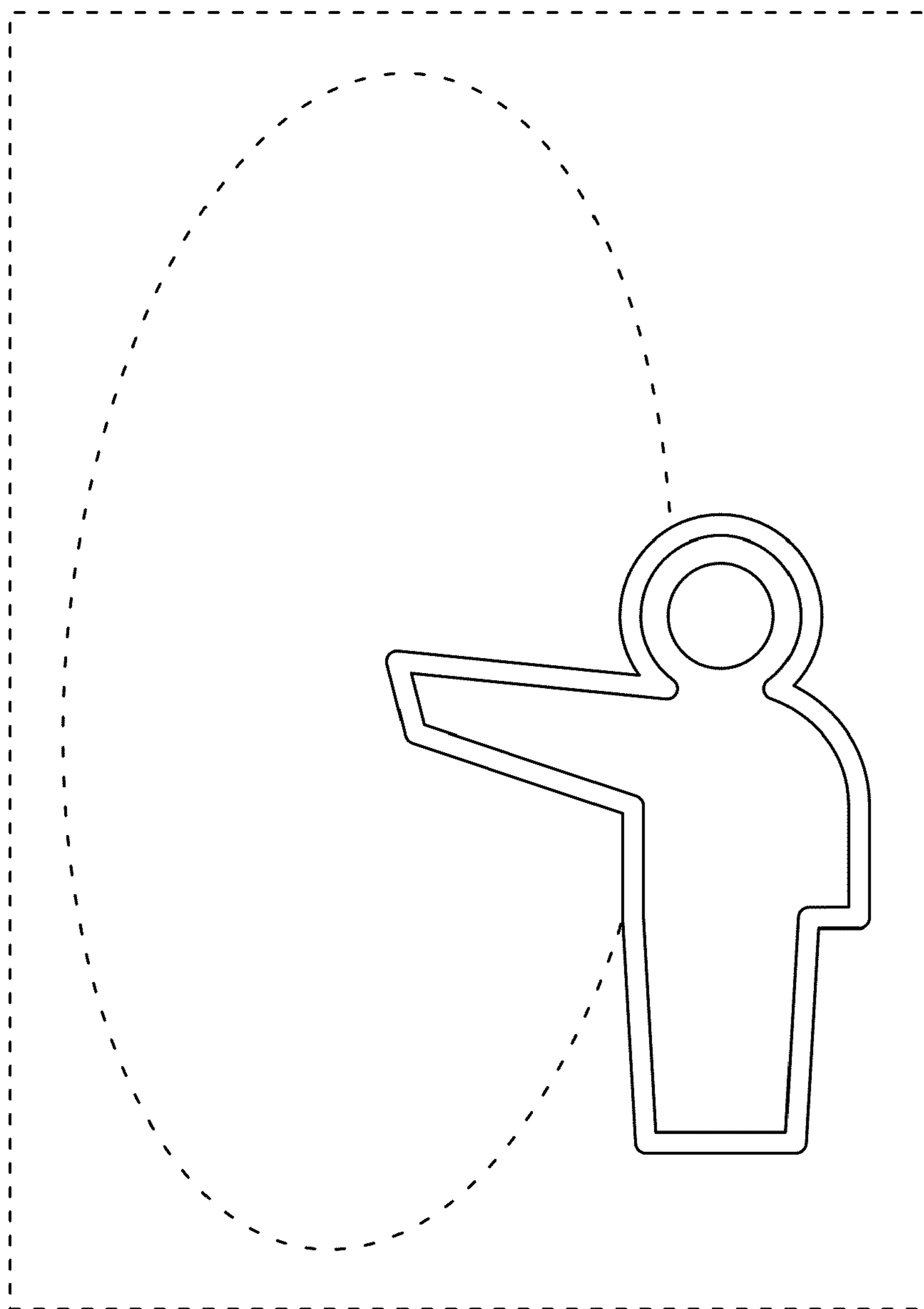

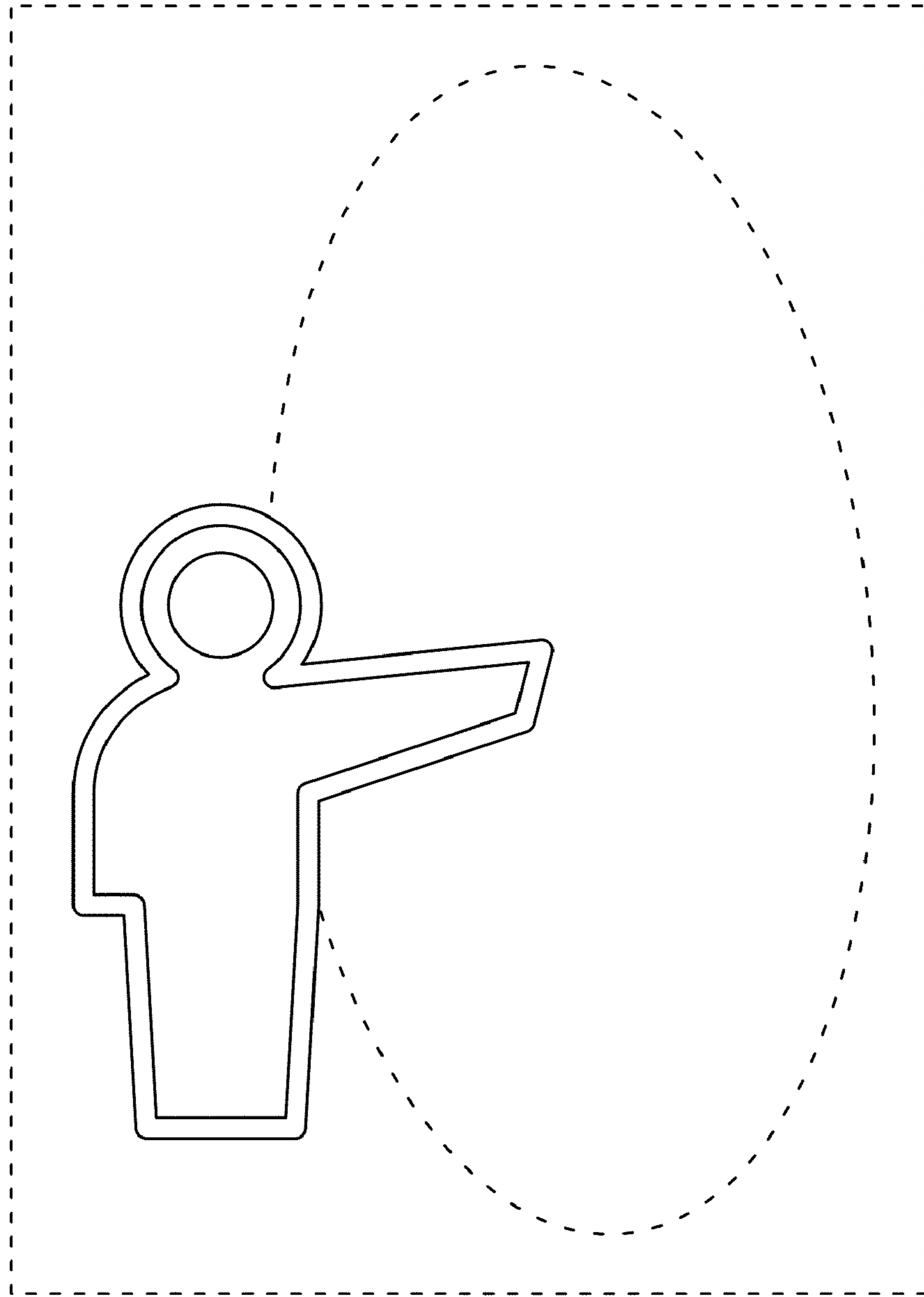

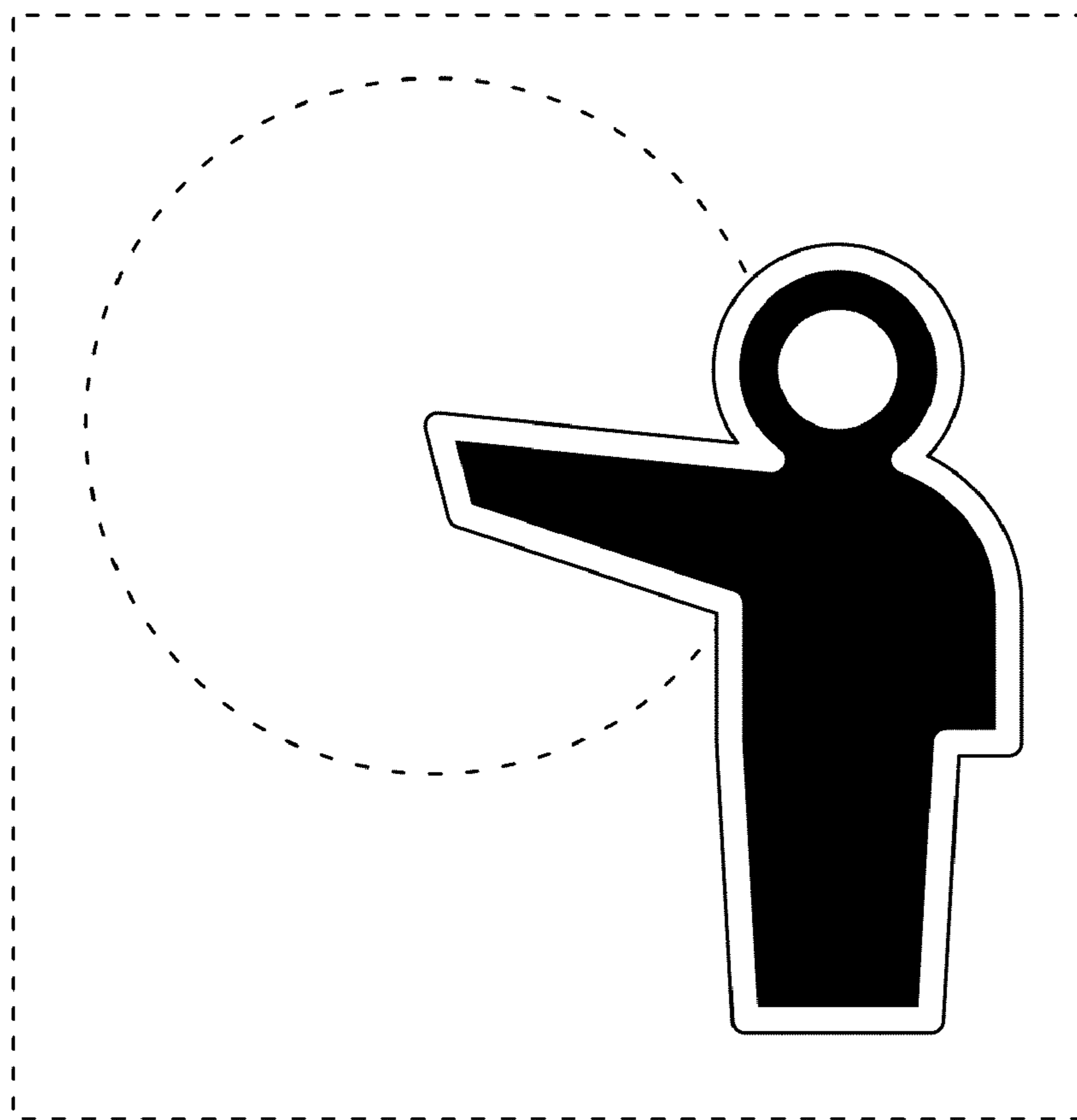

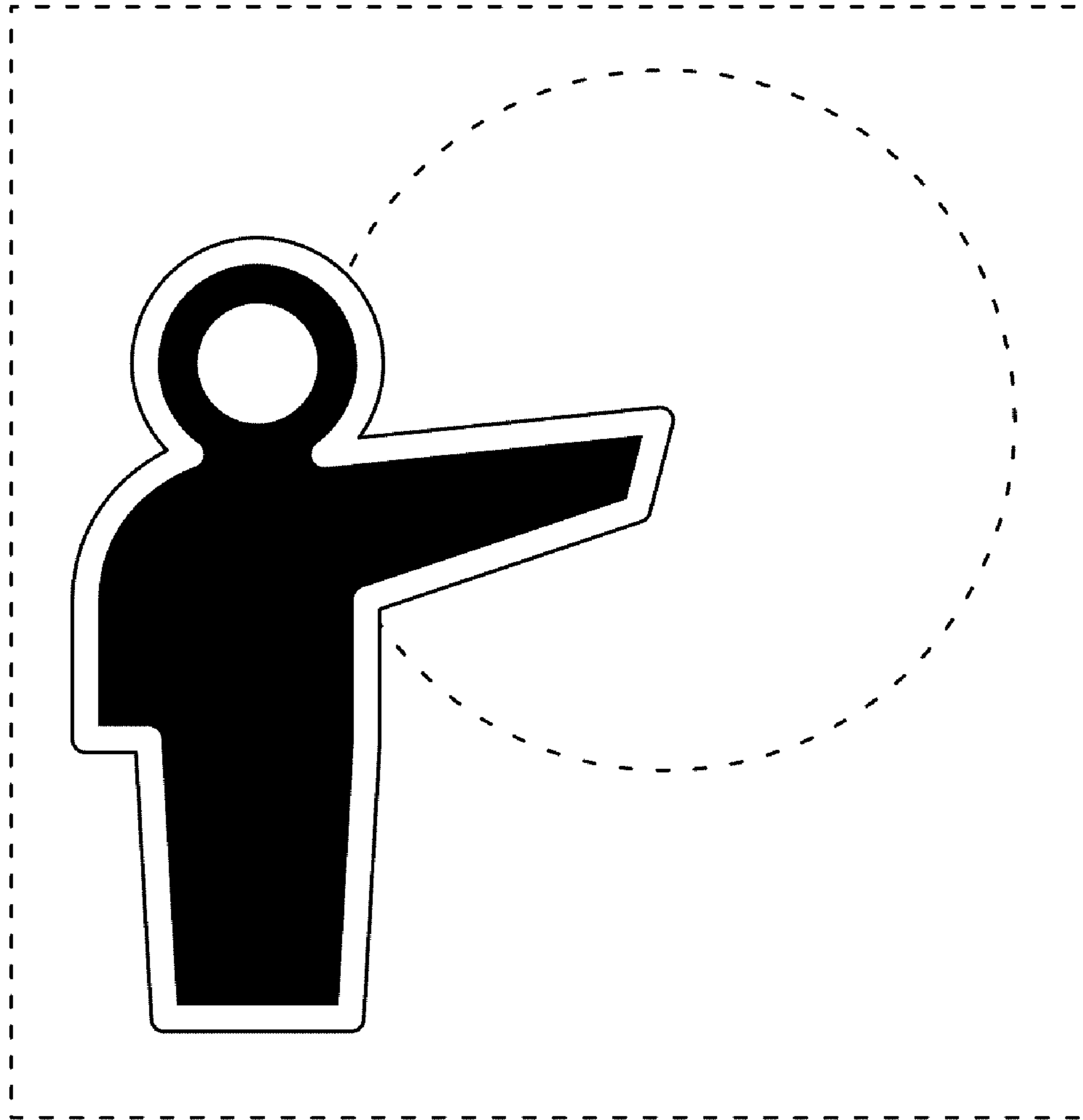

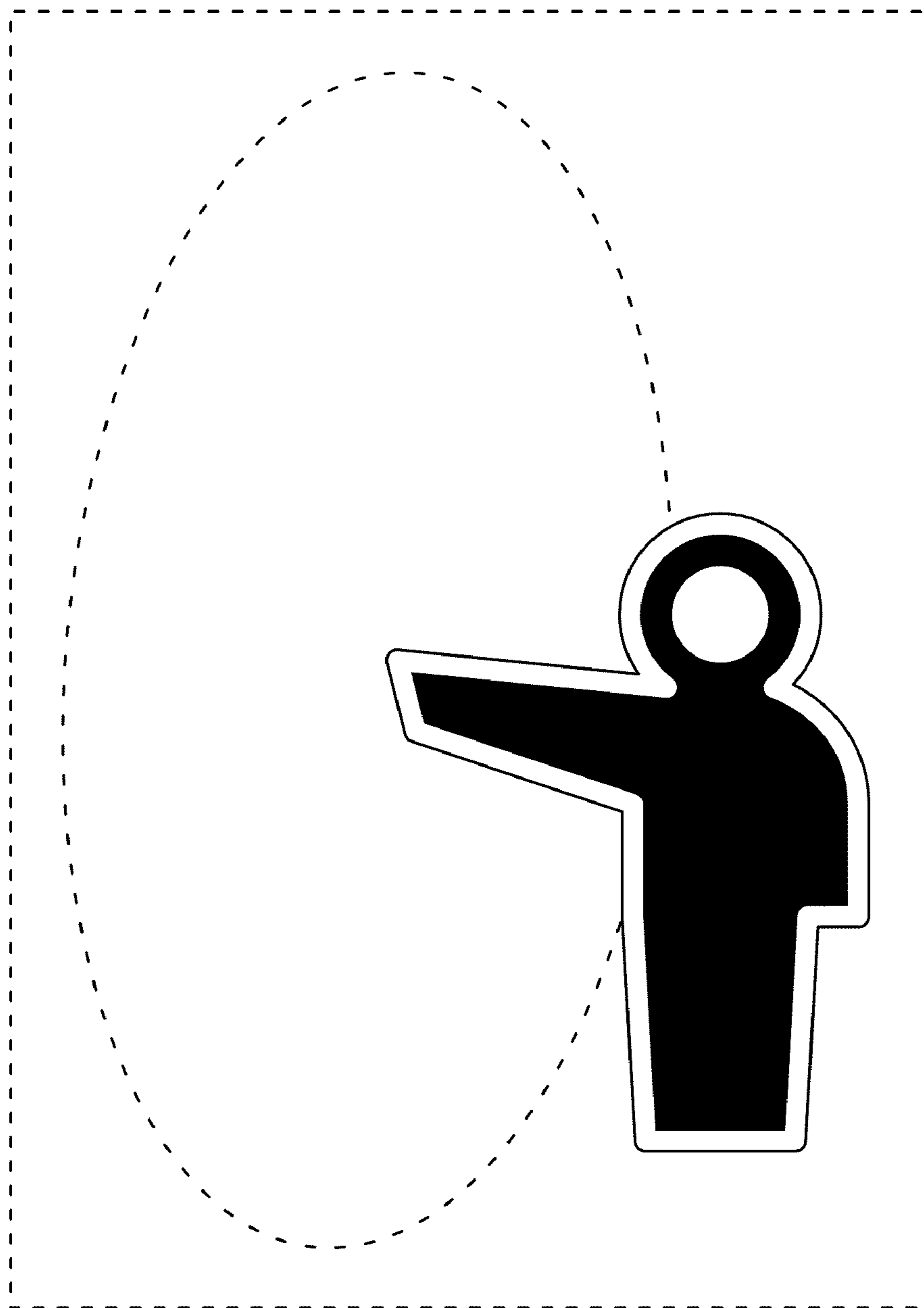

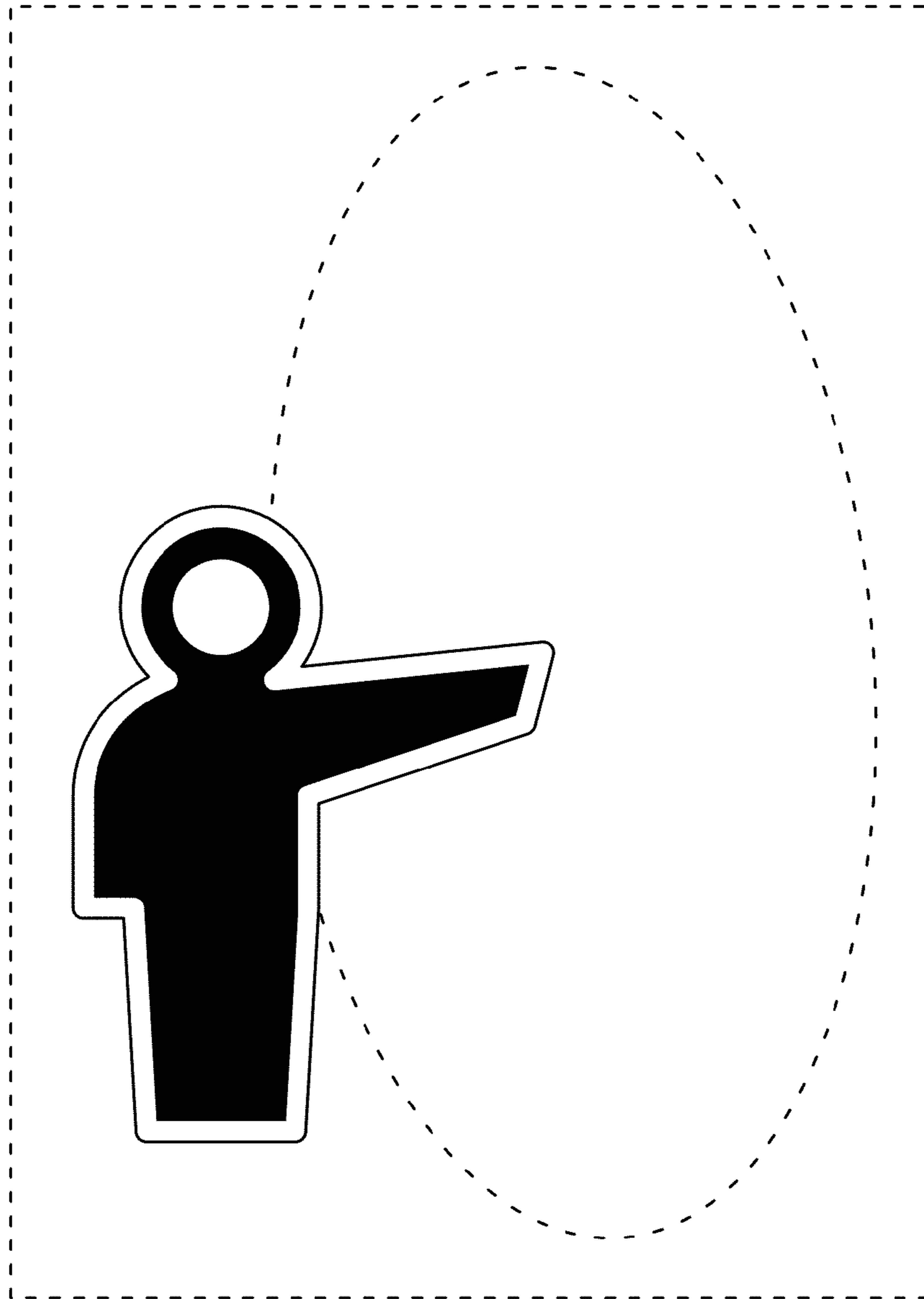
