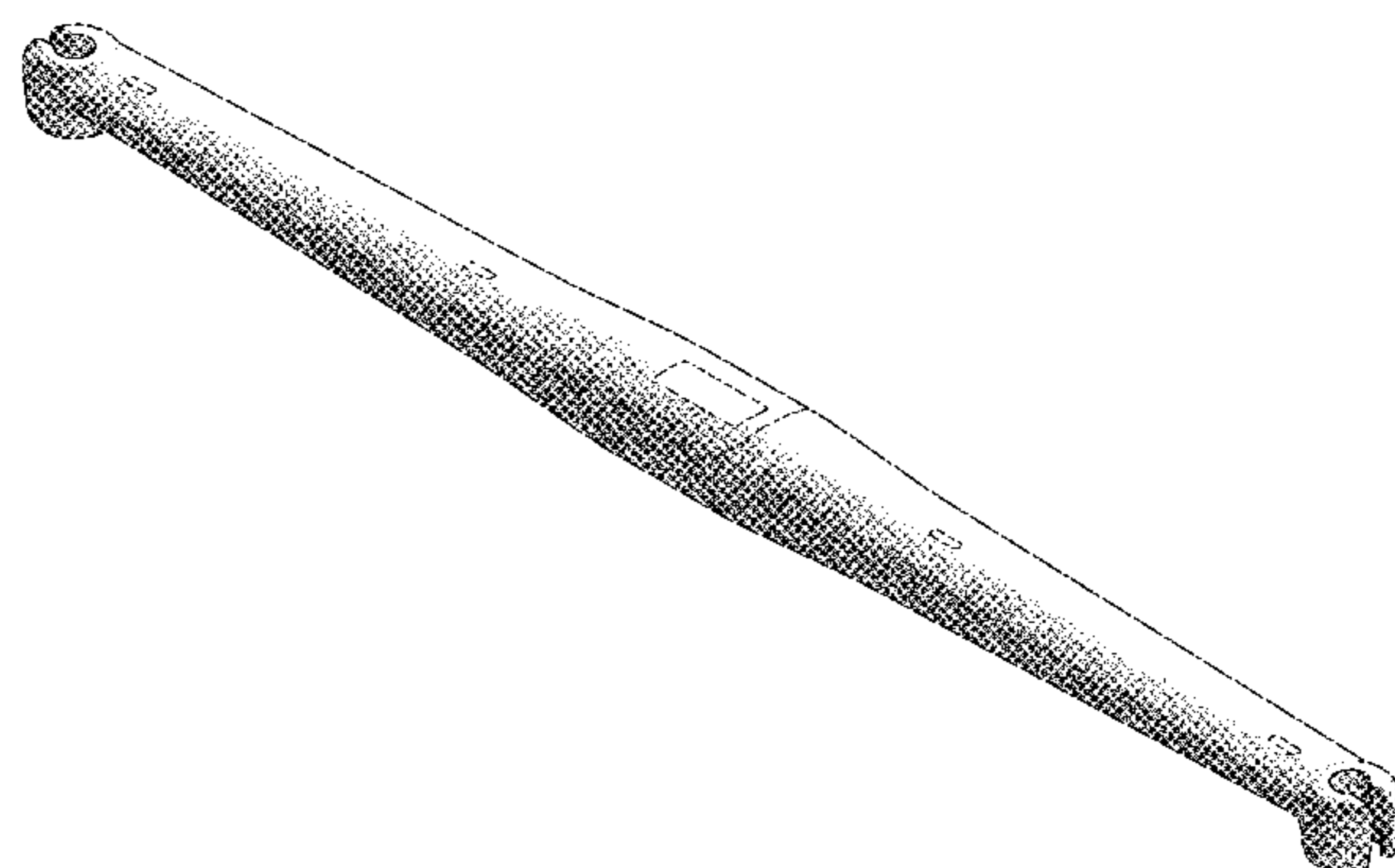
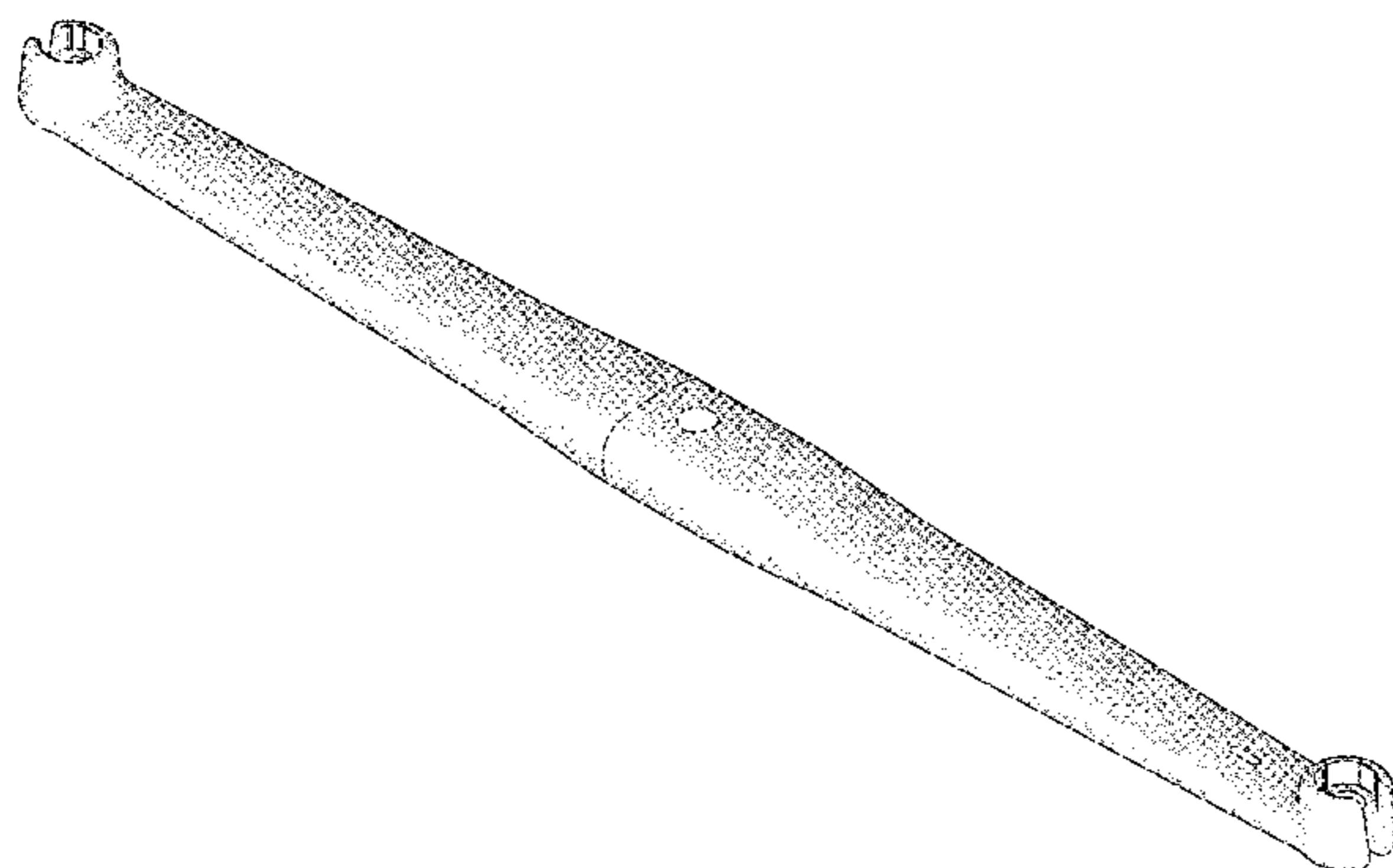
(57) **CLAIM**

The ornamental design for an exercise bar apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a personal exercise system showing my new design;  
FIG. 2 is a perspective view of another end thereof;  
FIG. 3 is a first side view thereof;  
FIG. 4 is a second side view thereof;  
FIG. 5 is an enlarged first end view thereof, the second end being a mirror image of the first end;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.

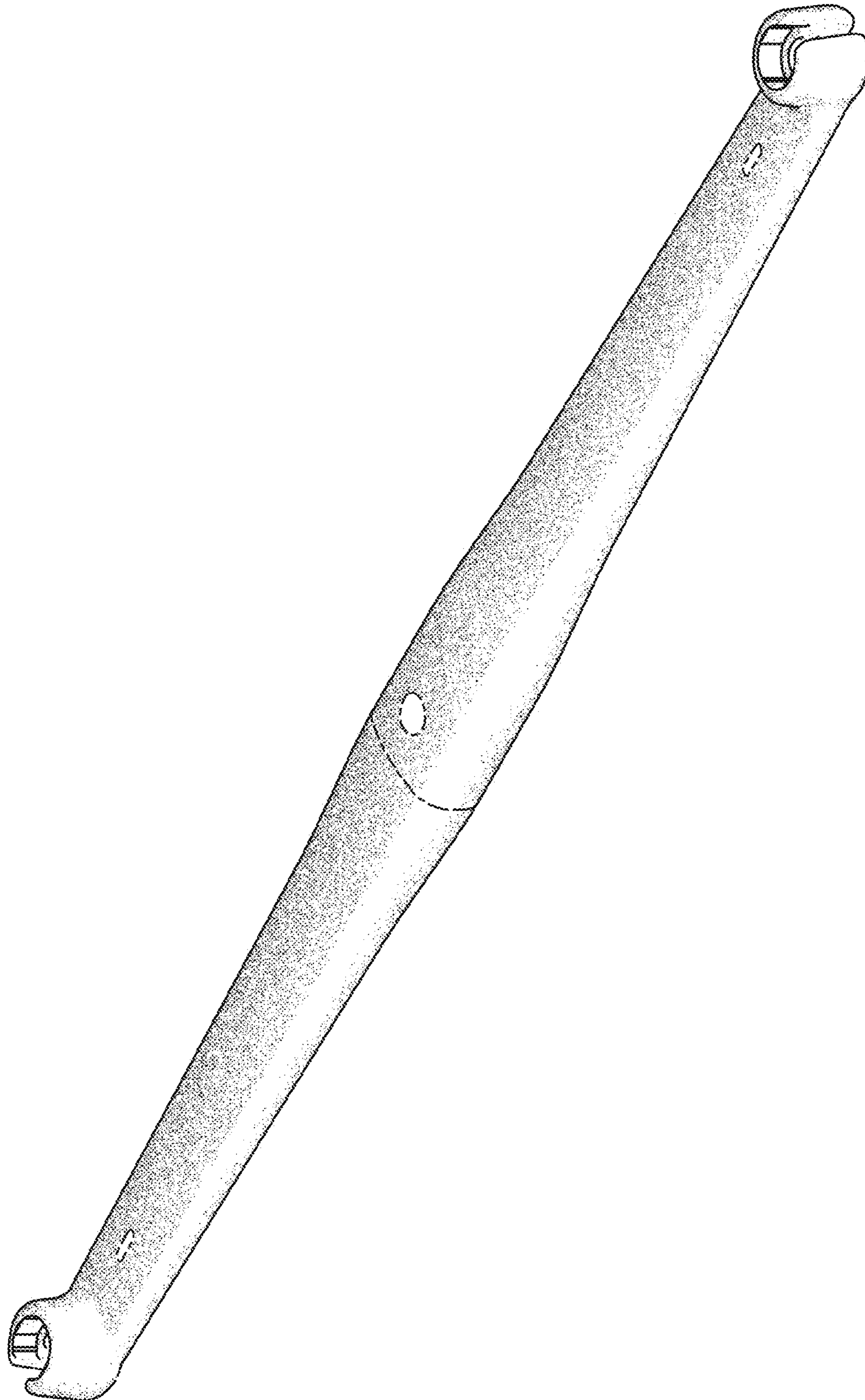

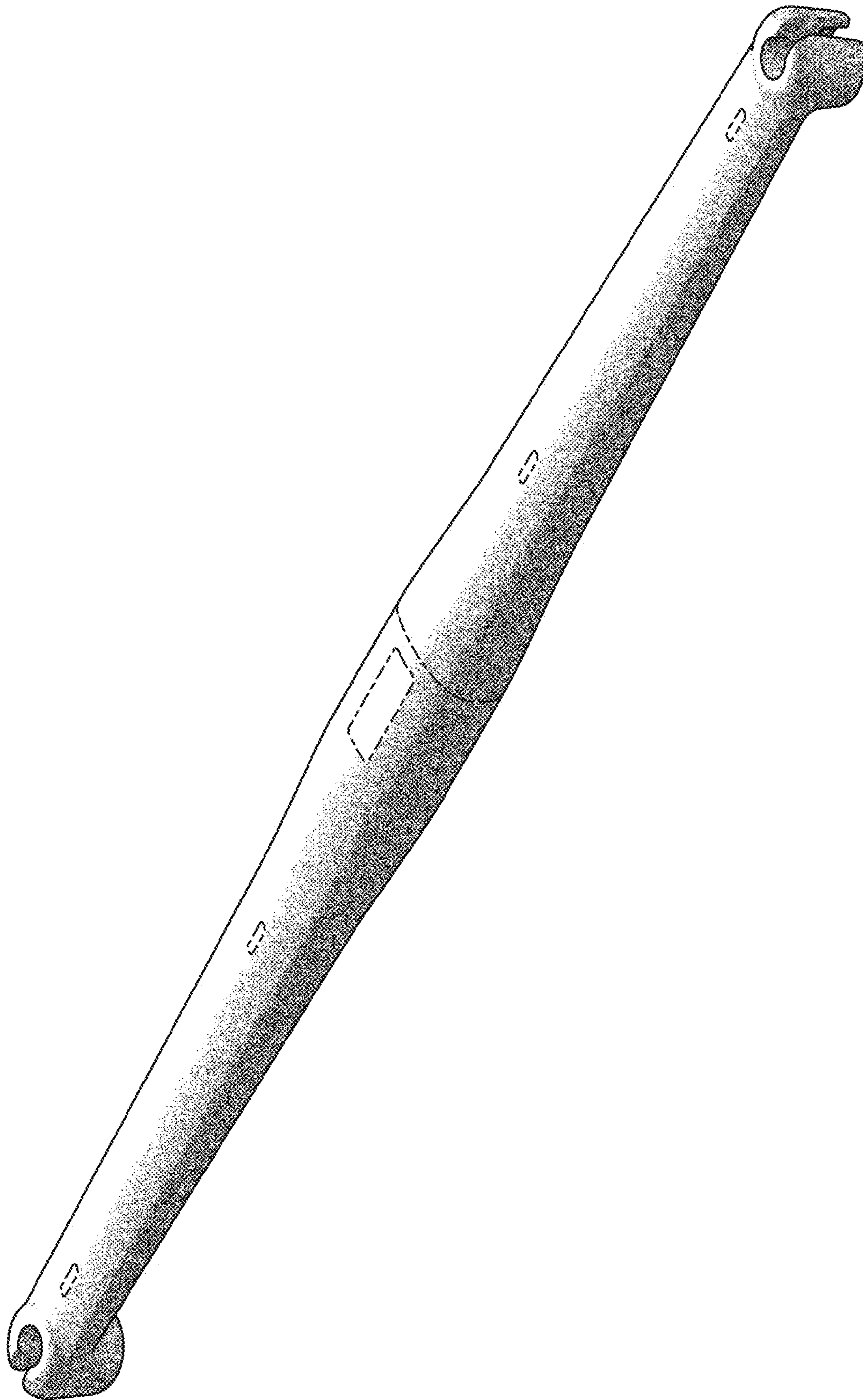

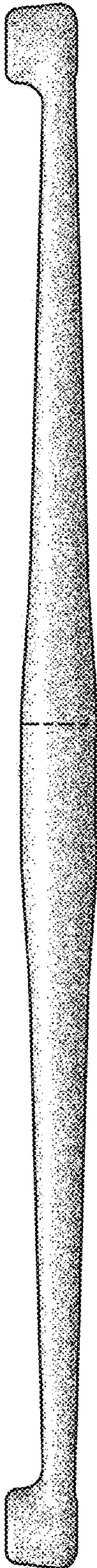

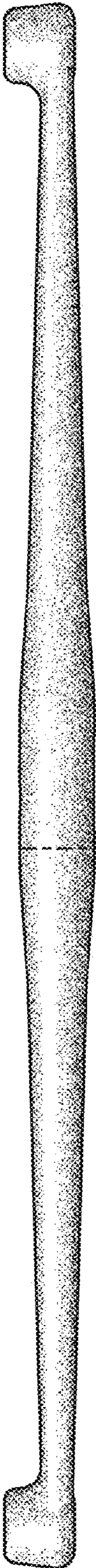

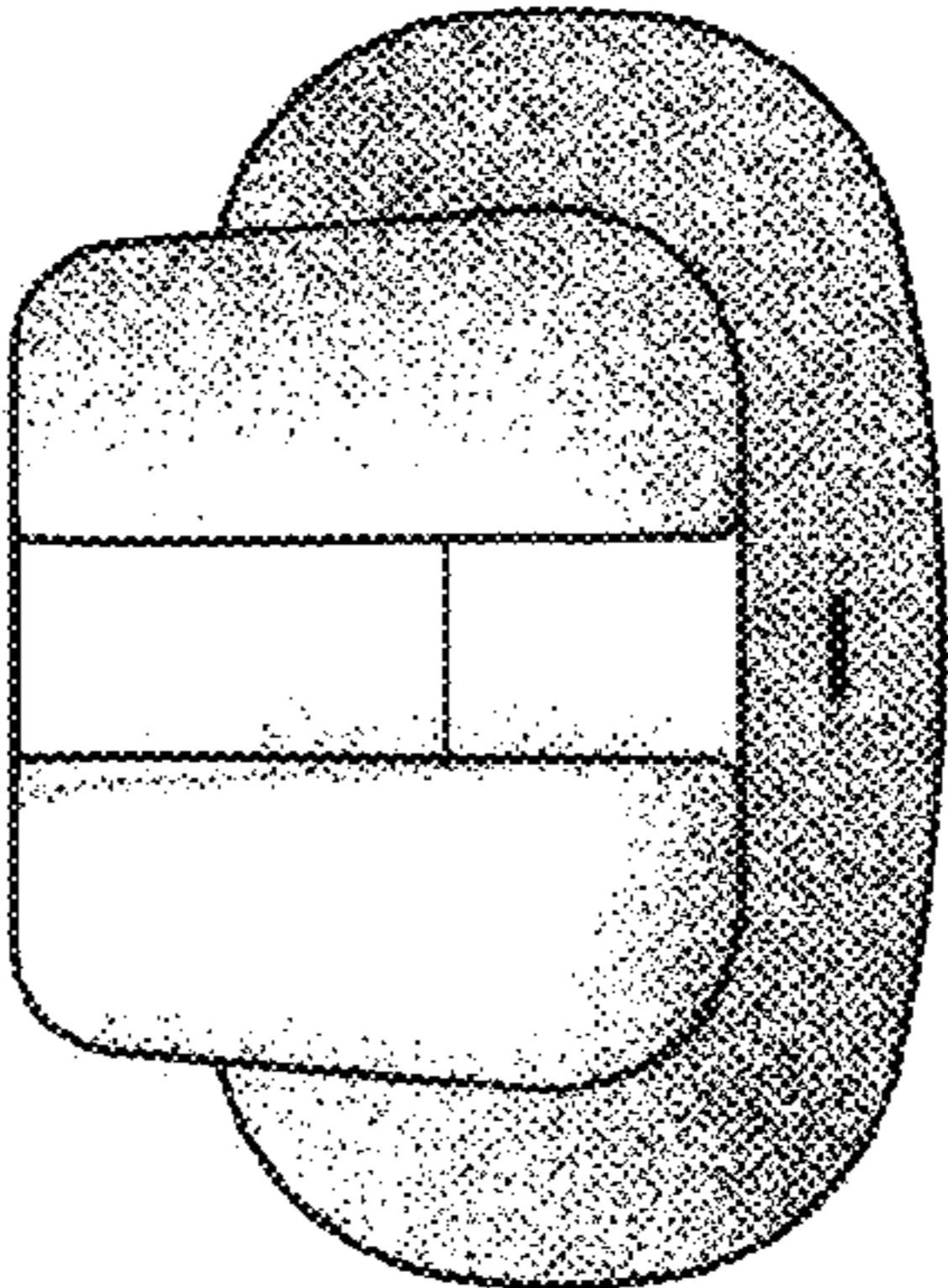
