(57) **CLAIM**

The ornamental design for a hybrid-type golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 illustrates a rear perspective view of a hybrid-type golf club head that shows two substantially v-shaped grooves and a slight indentation at the top edge of the golf club head;

FIG. 2 illustrates an angled, rear perspective view of a hybrid-type golf club head that shows two substantially v-shaped grooves;

FIG. 3 illustrates an angled, bottom perspective view of a hybrid-type golf club head;

FIG. 4 illustrates an angled, rear perspective view of a hybrid-type golf club head that shows two substantially v-shaped grooves and a slight indentation at the top edge of the golf club head;

FIG. 5 illustrates an angled, rear perspective view of a hybrid-type golf club head that shows two substantially v-shaped grooves and a slight indentation at the top edge of the golf club head;

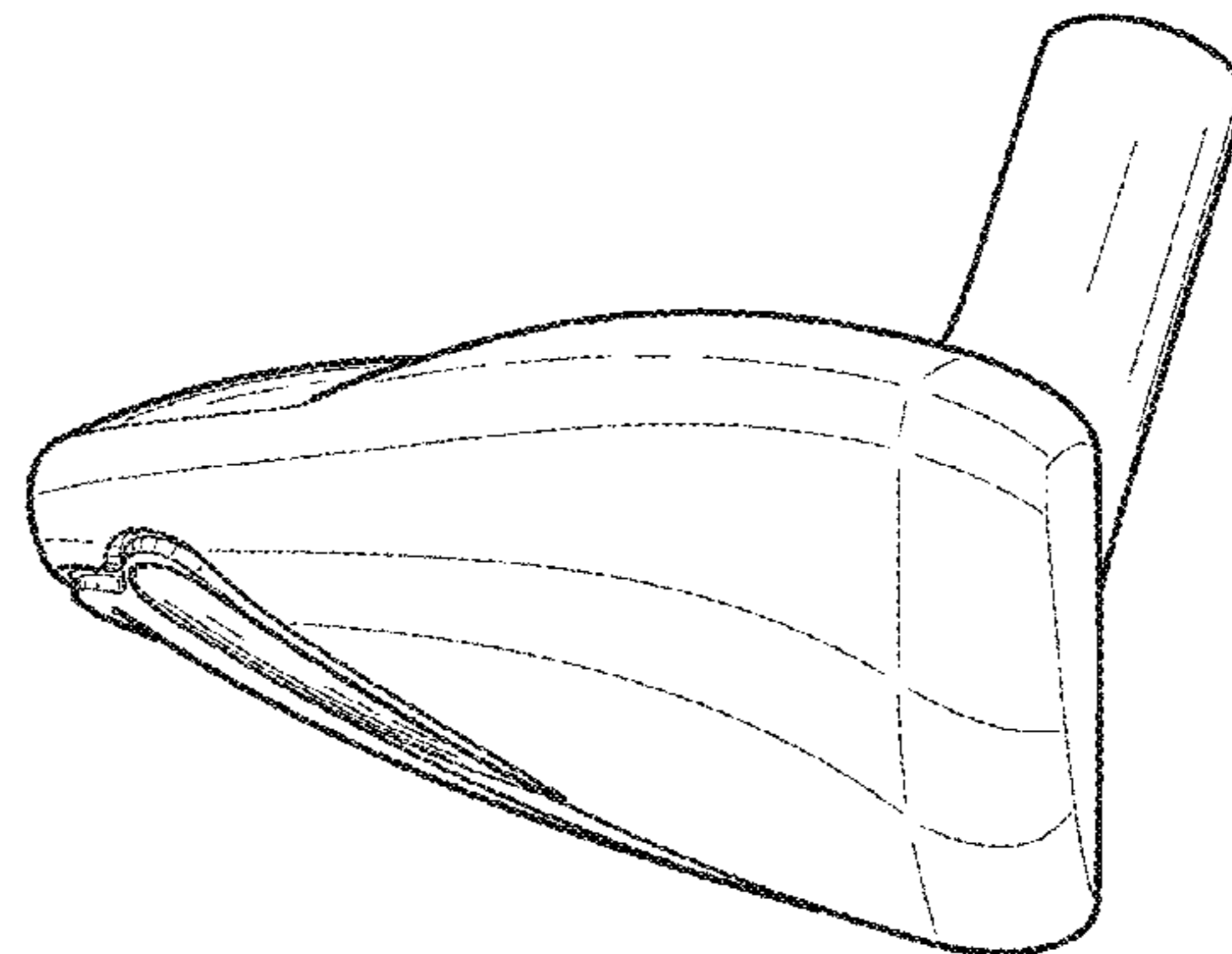
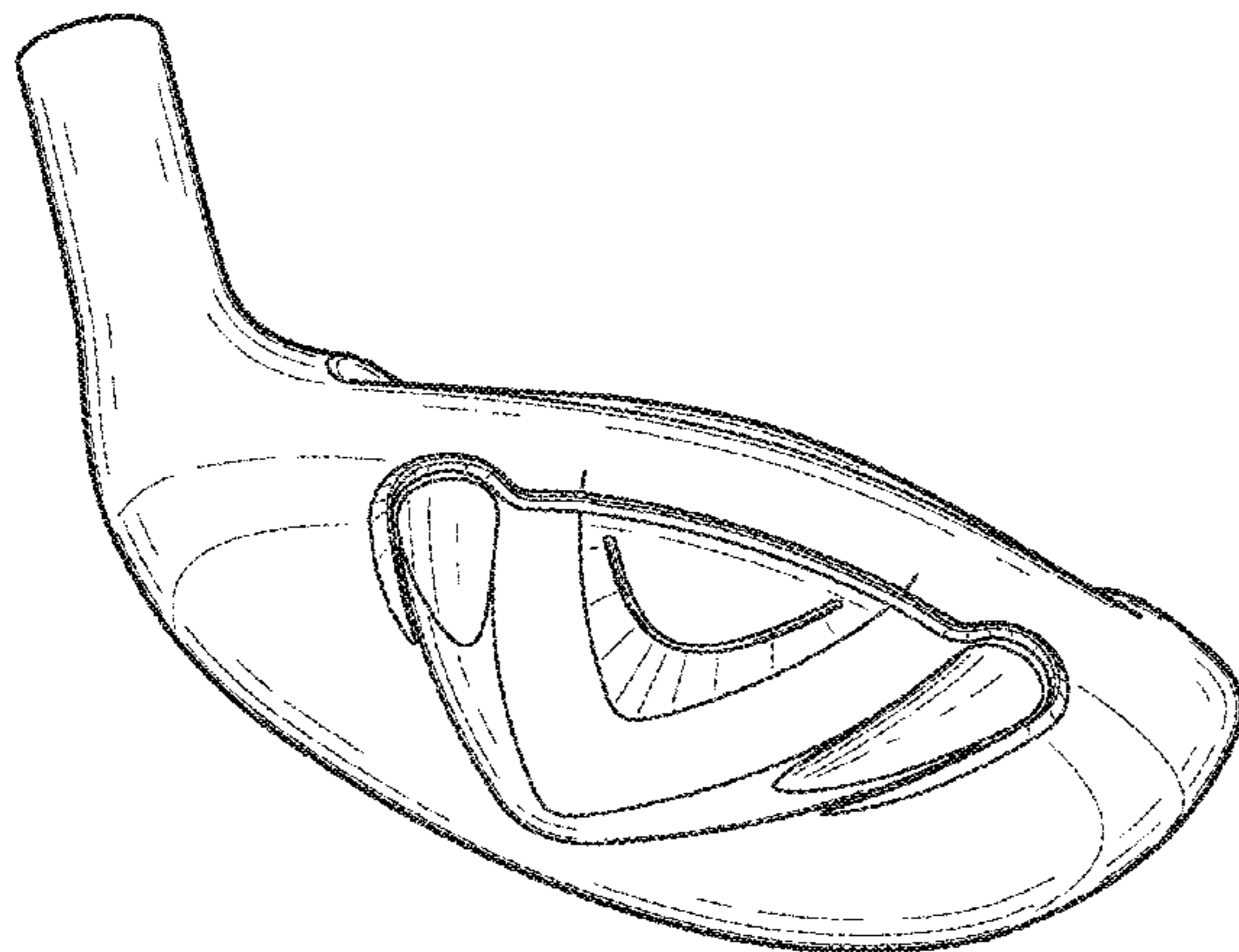
FIG. 6 illustrates an angled, rear perspective view of a hybrid-type golf club head that shows two substantially v-shaped grooves;

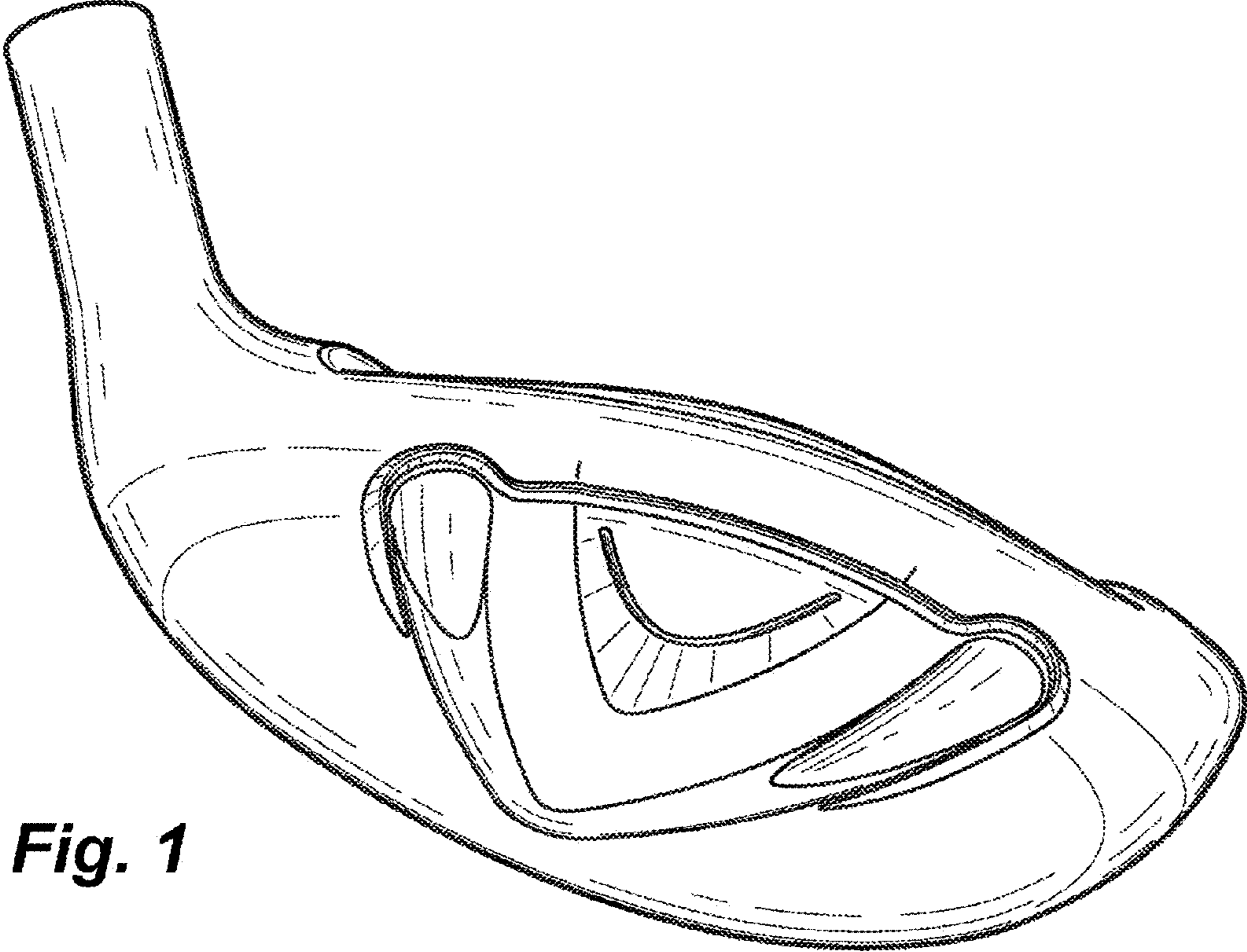
FIG. 7 illustrates an angled, rear perspective view of a hybrid-type golf club head that shows two substantially v-shaped grooves; and,

FIG. 8 illustrates an angled, top perspective view of a hybrid-type golf club head that shows a slight indentation at the top edge of the golf club head.

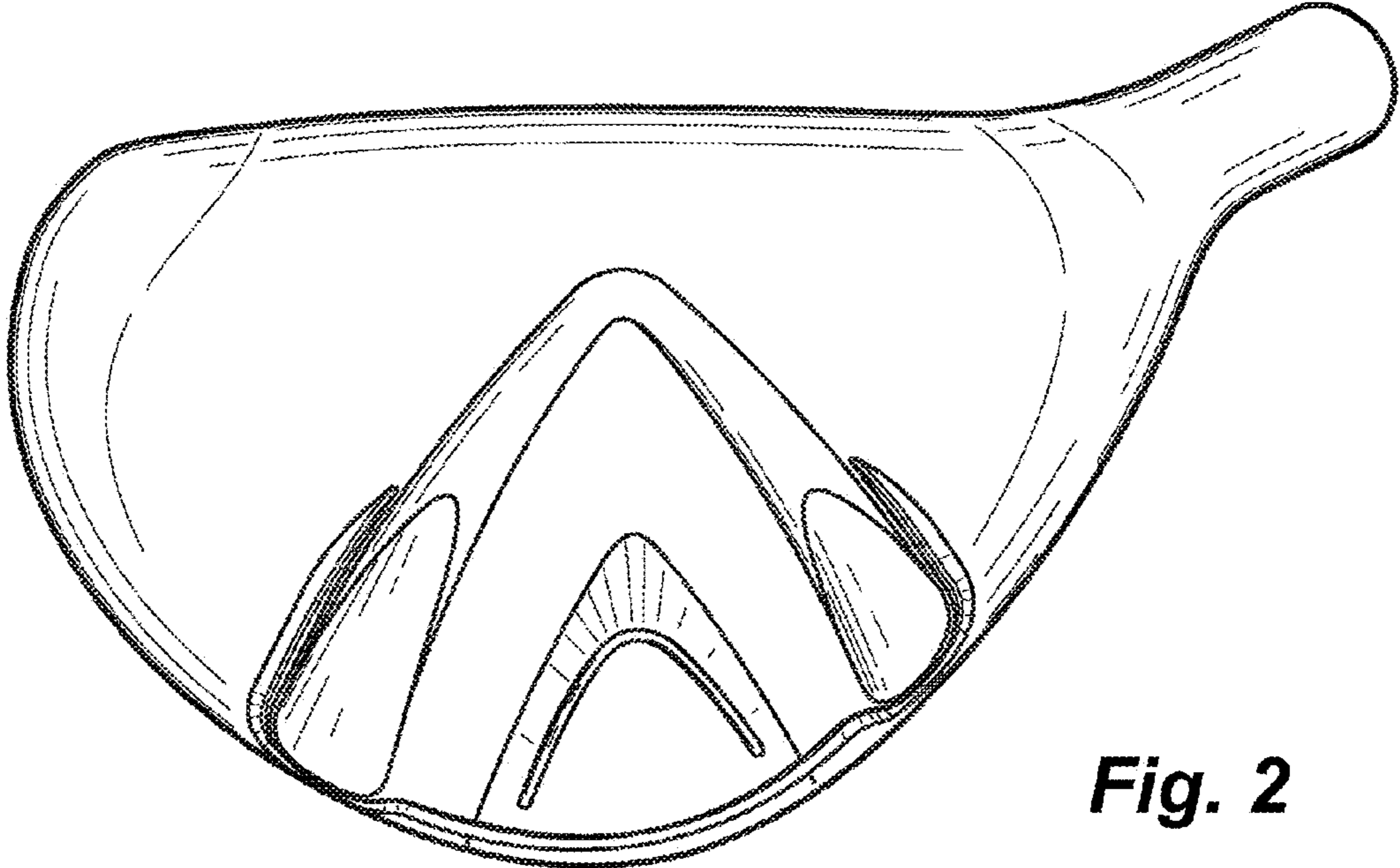
The broken, dashed lines shown in the various figures depicting embodiments of the invention are included for the purpose of illustrating environment and do not form any part of the claimed design.

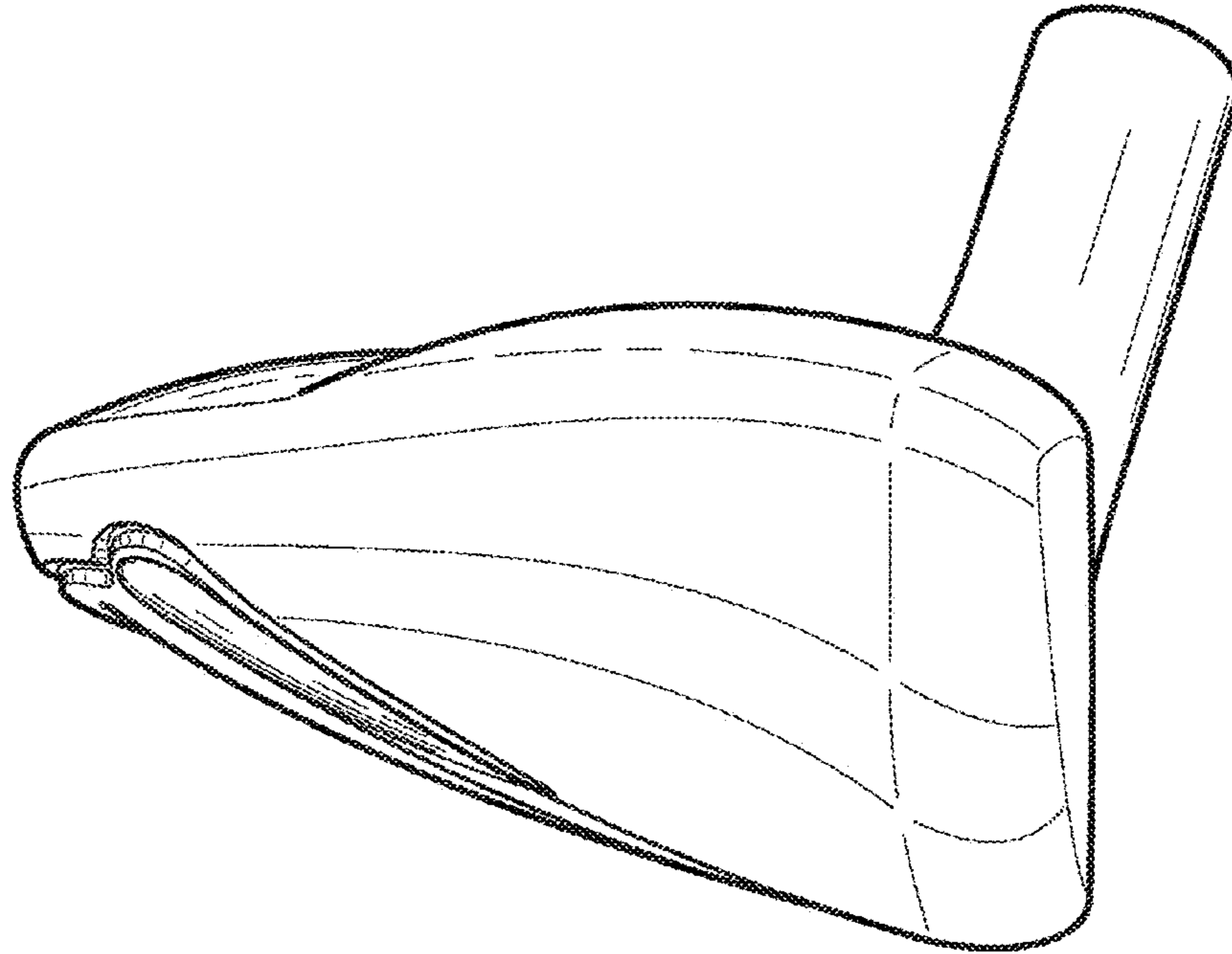




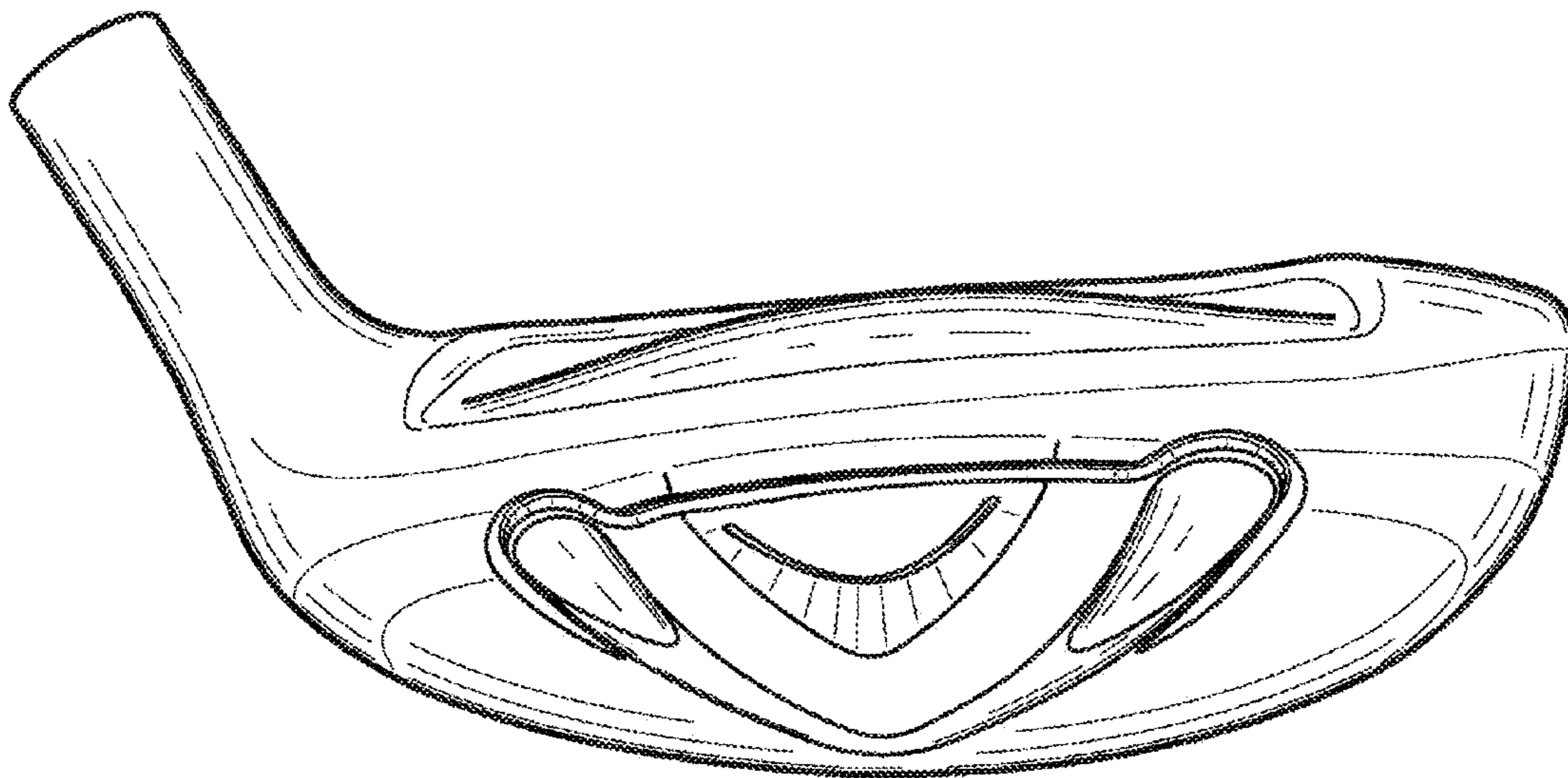

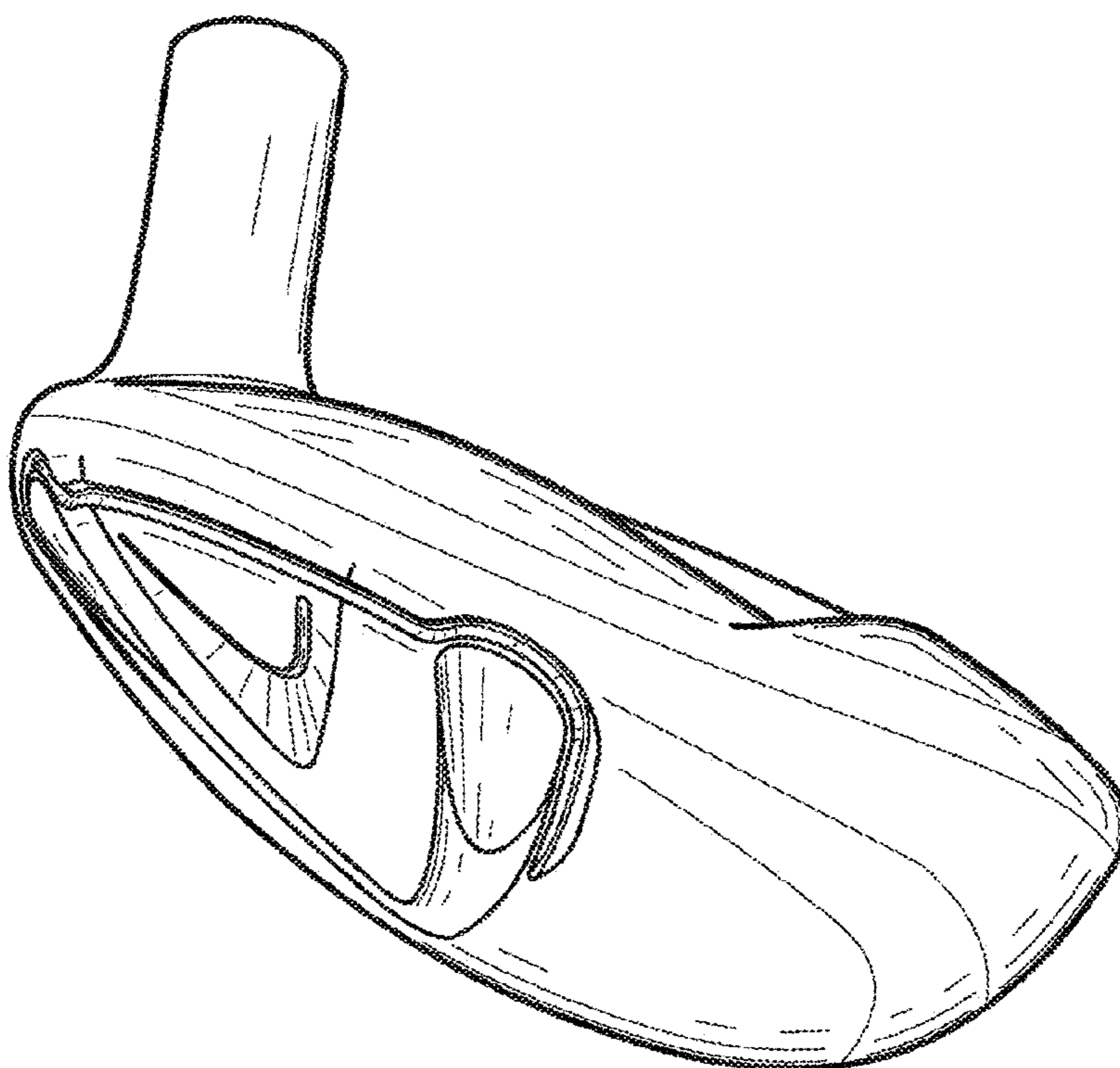

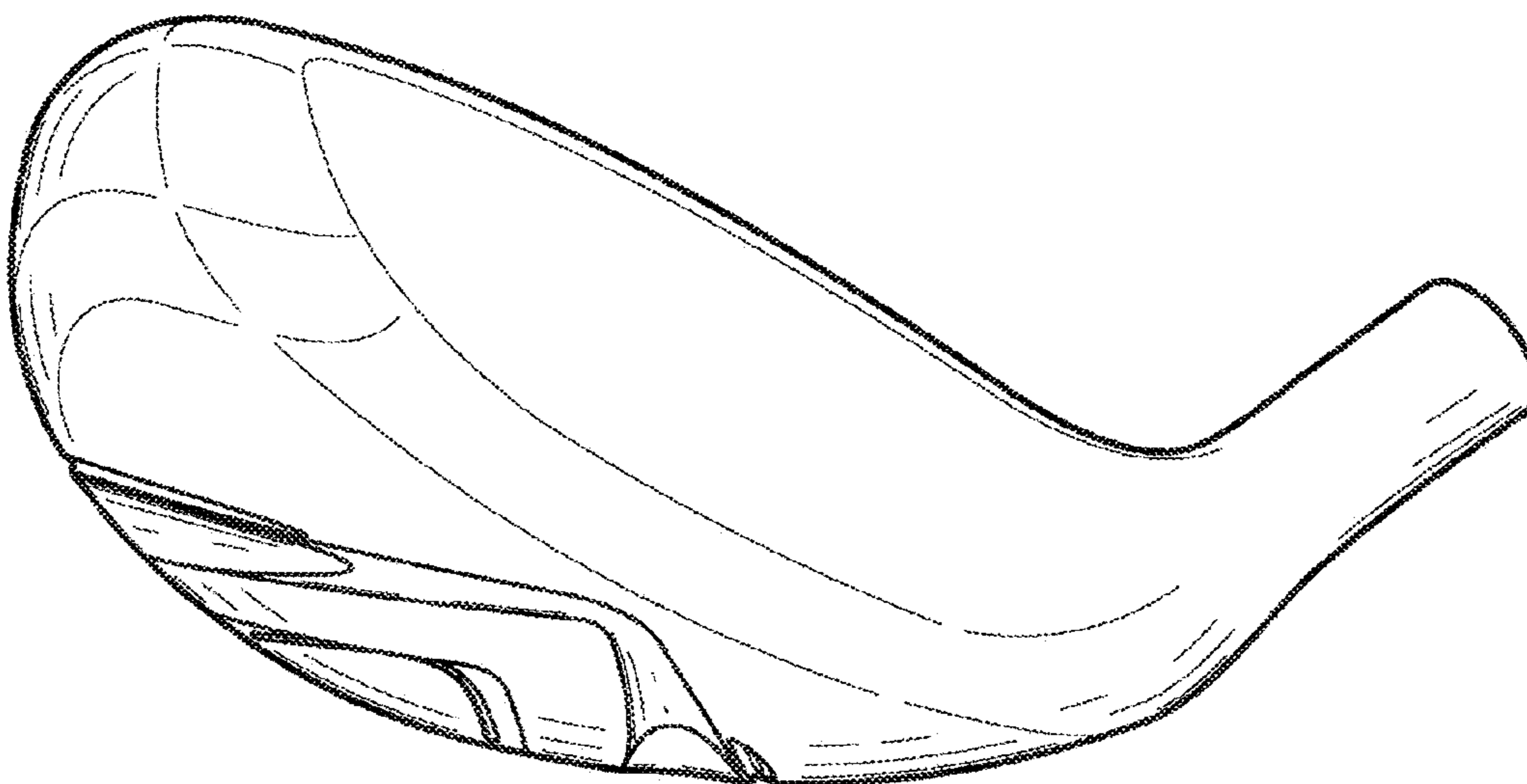

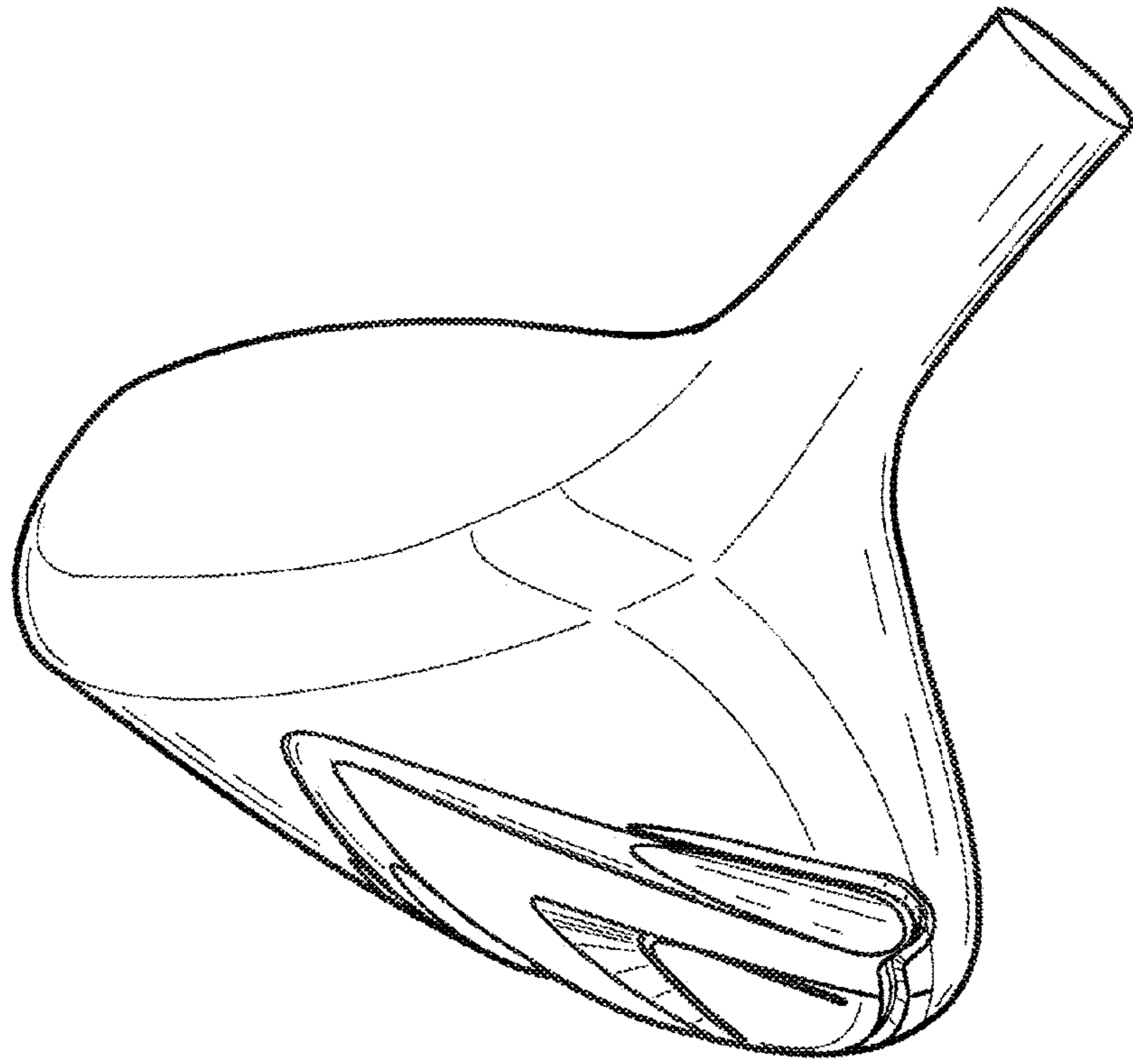

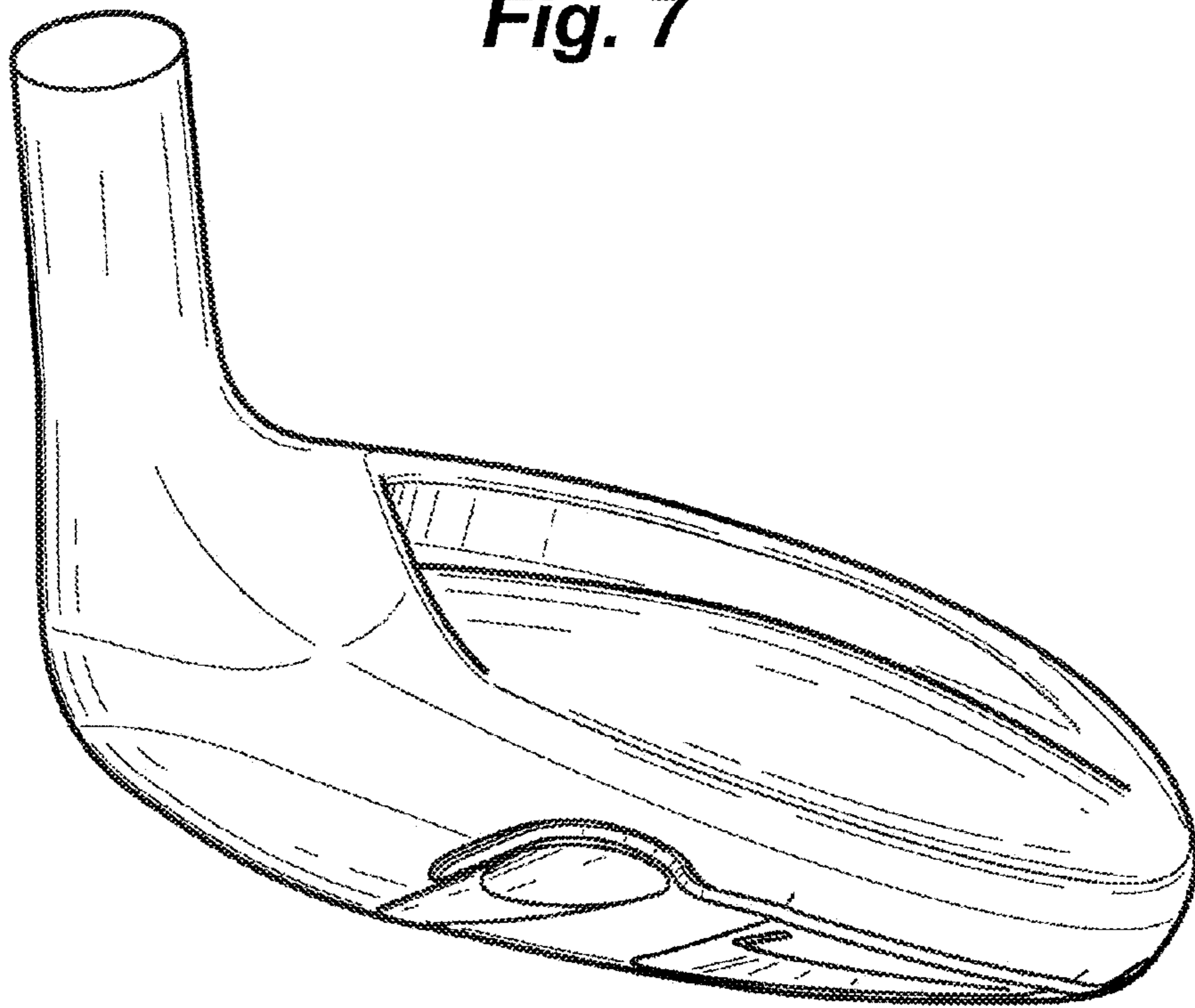
