(57) **CLAIM**

The ornamental design for a shingle roof panel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shingle roof panel in accordance with our design;

FIG. 2 is another perspective view of the shingle roof panel in accordance with the embodiment of our design;

FIG. 3 is a top plan view of the shingle roof panel in accordance with the embodiment of our design;

FIG. 4 is a front elevation view of the shingle roof panel in accordance with the embodiment of our design;

FIG. 5 is a left side elevation view of the shingle roof panel in accordance with the embodiment of our design, the opposite side being a mirror image;

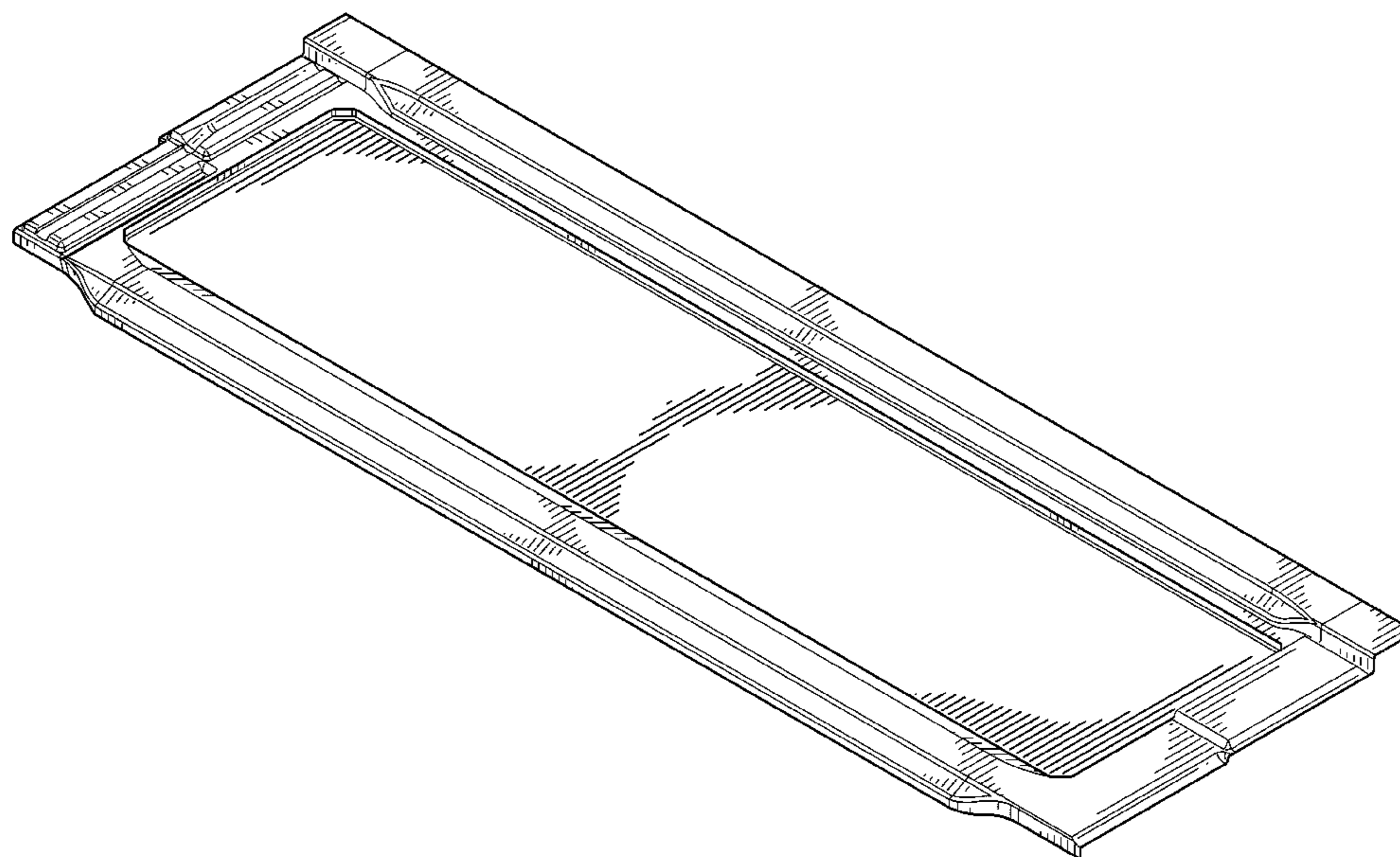
FIG. 6 is a right side elevation view of the shingle roof panel in accordance with the embodiment of our design, the opposite side being a mirror image;

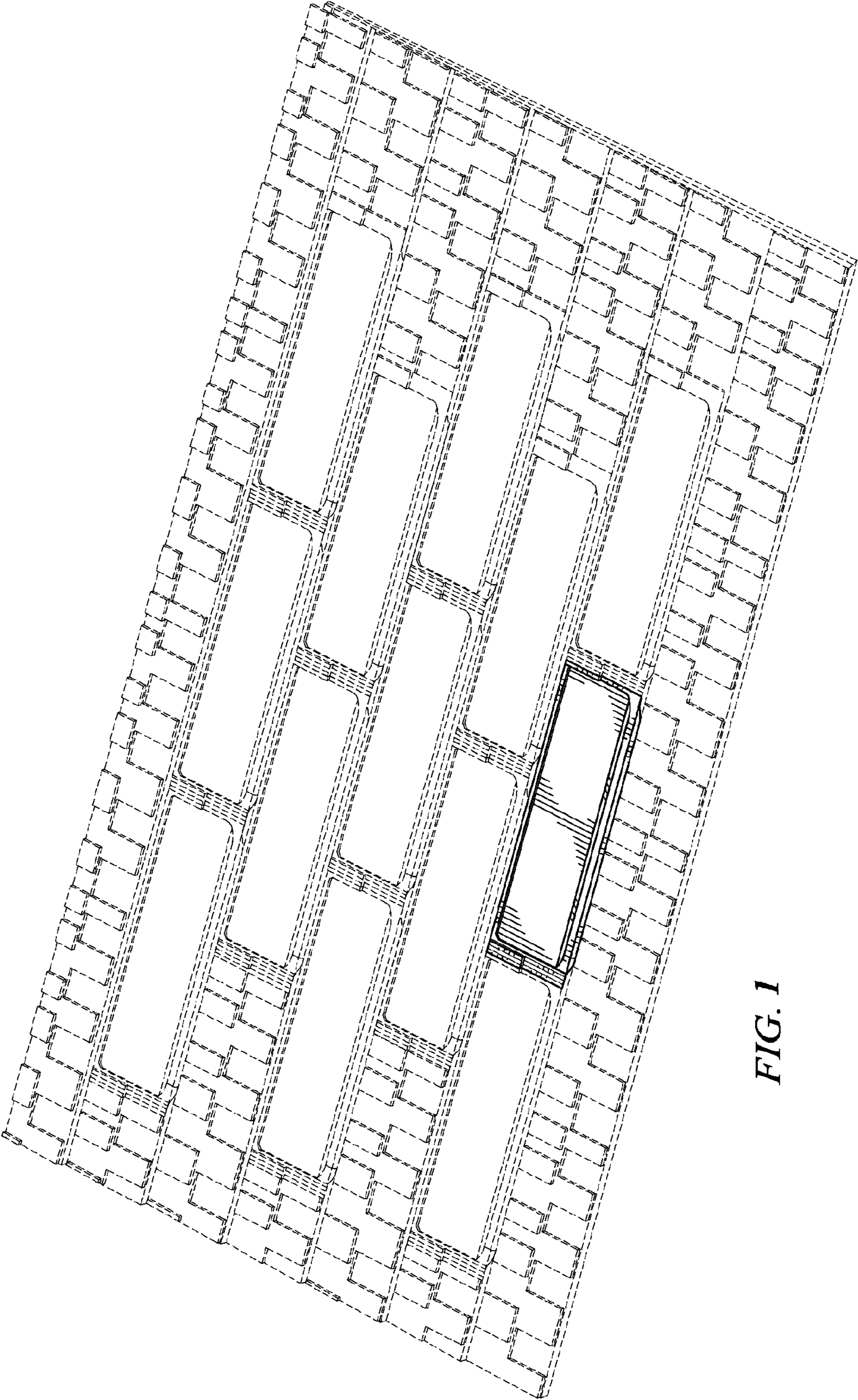

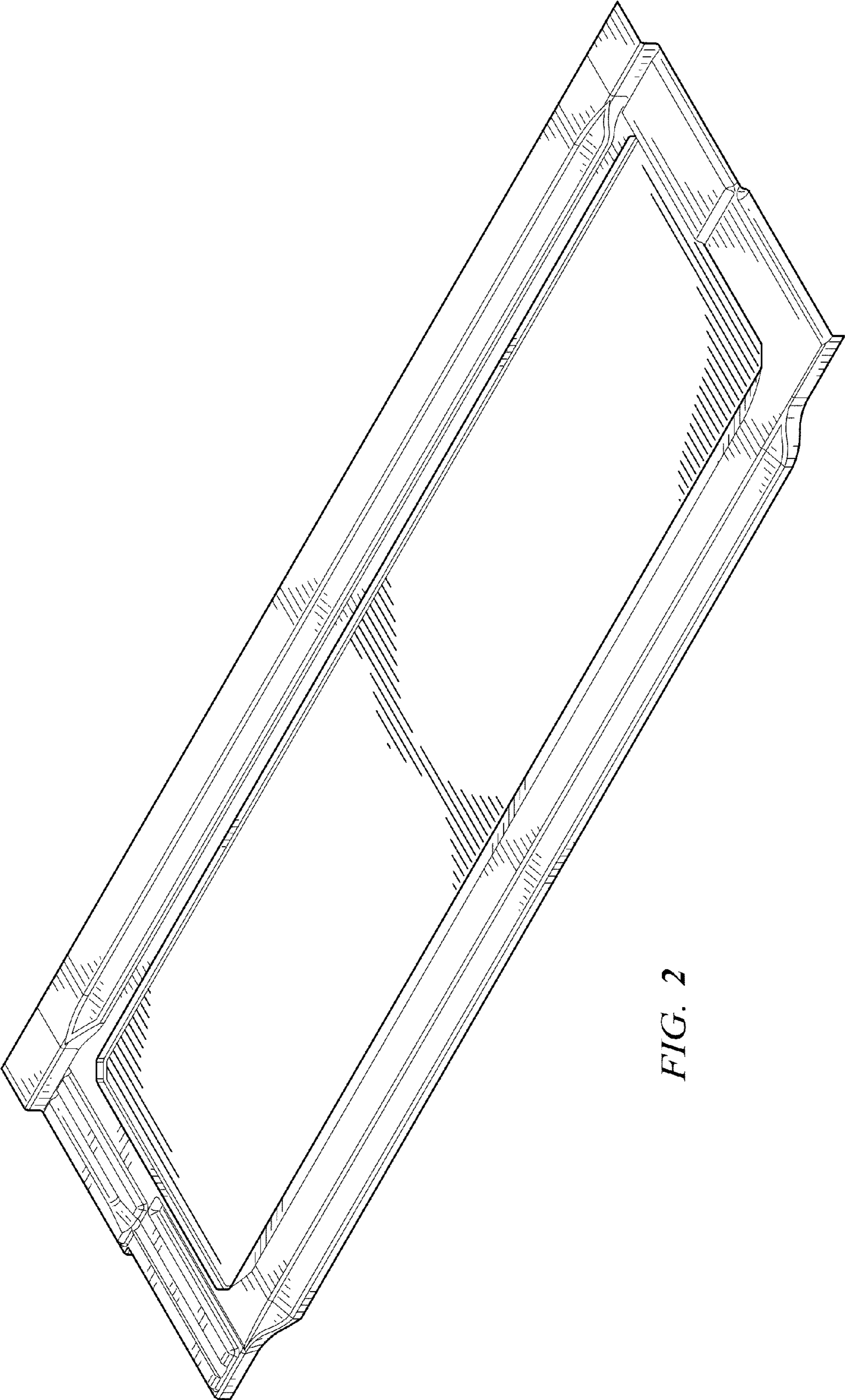

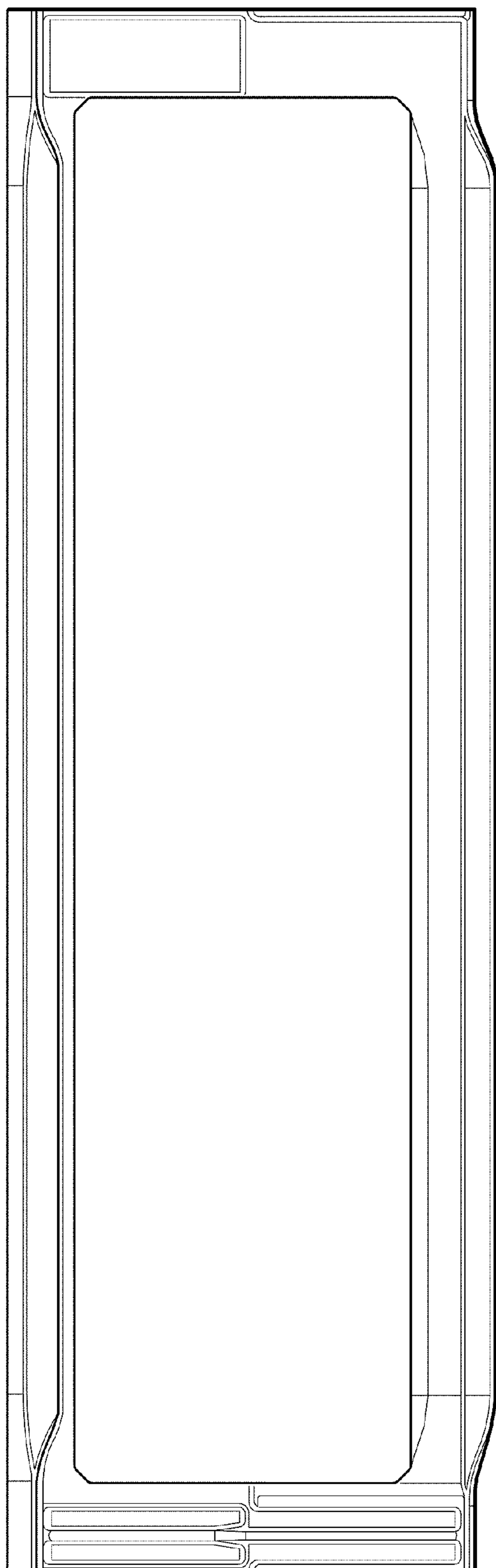

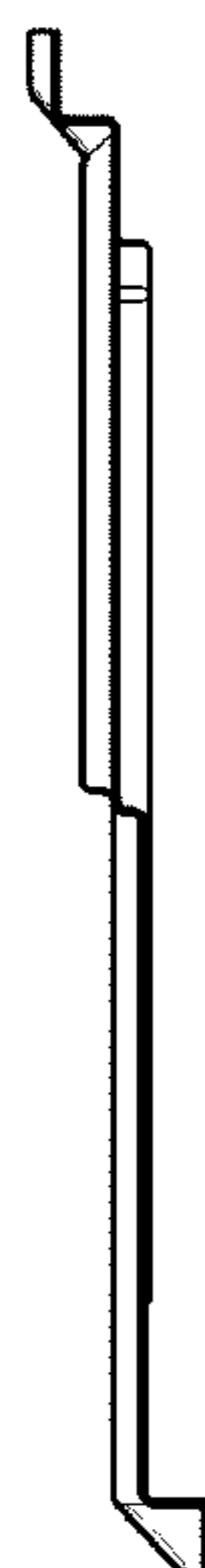

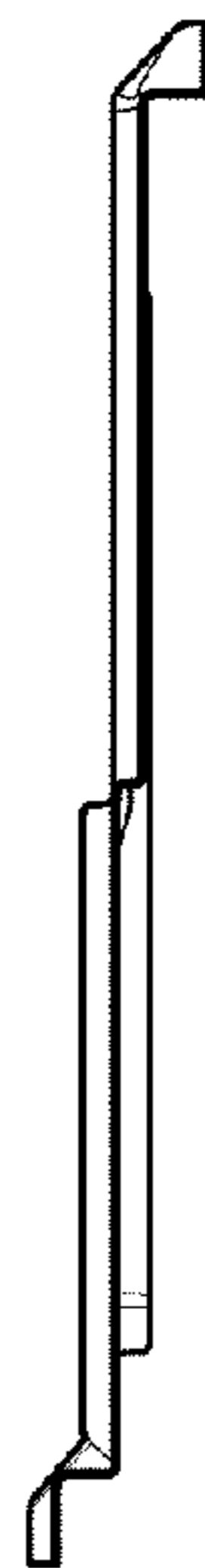

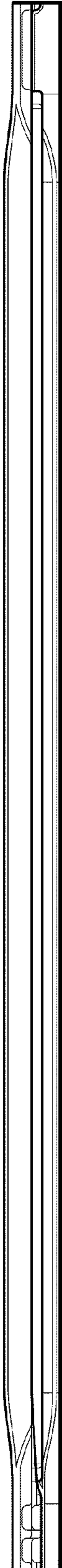

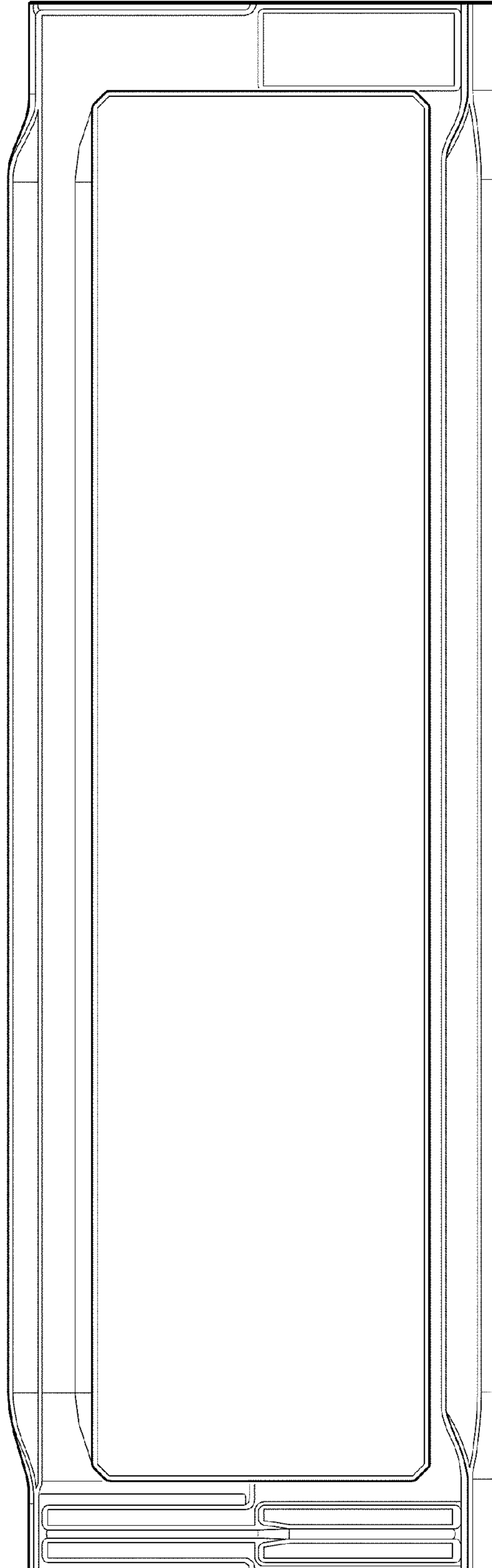
