(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a light fixture in accordance with my design;

FIG. 2 is a side elevation view of the light fixture in accordance with my design, the opposite view being a mirror image of that shown;

FIG. 3 is a bottom plan view of the light fixture in accordance with my design; and,

FIG. 4 is a front elevation view of the light fixture in accordance with my design, the opposite view being a mirror image of that shown.

Each lamp in FIGS. 1-4 is rotatable and adjustable about its fixed position.

The portions of the light fixture shown broken away in FIGS. 1-4 are to depict non-specific length.

The broken-line disclosure of elements is understood to represent portions of the article in which the design is embodied, but which form no part of the claimed design.
