(57) **CLAIM**

The ornamental design for a stadium desk lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a stadium desk lamp with an area for an applied surface treatment showing a first embodiment of the design;

FIG. 2 is a front perspective view of a stadium desk lamp showing a second embodiment of the design;

FIG. 3 is a front elevation view of the stadium desk lamp of FIG. 1;

FIG. 4 is a front elevation view of the stadium desk lamp of FIG. 2;

FIG. 5 is a rear elevation view of the stadium desk lamps of FIGS. 1 and 2;

FIG. 6 is a left side elevation view of the stadium desk lamps of FIGS. 1 and 2, and the right side is a mirror image;

FIG. 7 is a top plan view of the stadium desk lamp of FIG. 1;

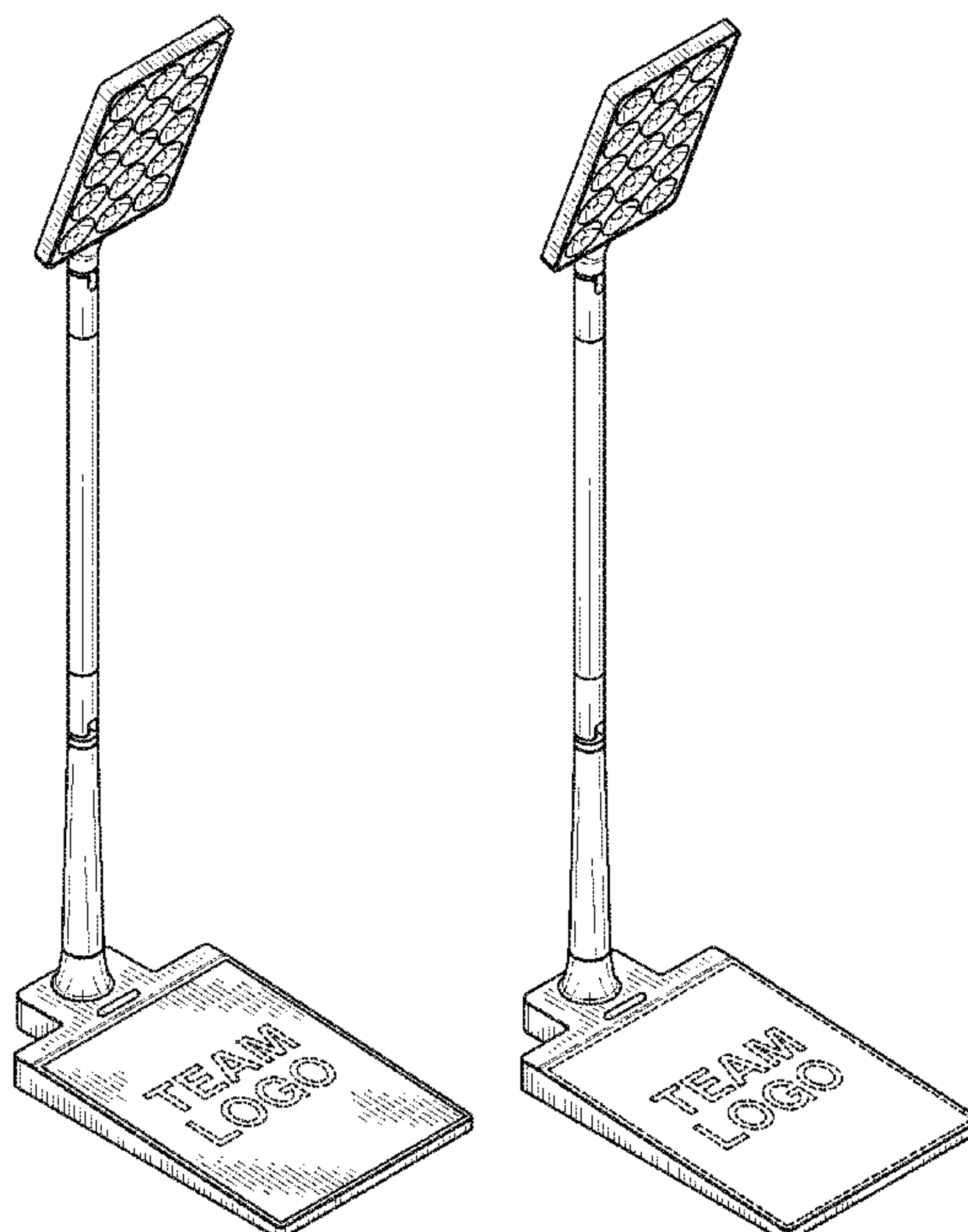
FIG. 8 is a top plan view of the stadium desk lamp of FIG. 2;

FIG. 9 is a bottom plan view of the stadium desk lamps of FIGS. 1 and 2; and,

FIG. 10 is an additional left side elevation view of the stadium desk lamps of FIGS. 1 and 2 showing a rotation of the neck elements.

The text in broken lines that reads SURFACE TREATMENT AREA, and/or TEAM LOGO, and/or TEAM INDICIA in FIGS. 1, 2, 7, and 8 forms no part of the claimed design. The light bulbs shown in broken lines in FIGS. 1, 2, 3, and 4 form no part of the claimed design. The surface treatment area shown in broken lines in FIGS. 2, 4, and 8 forms no part of the claimed design.

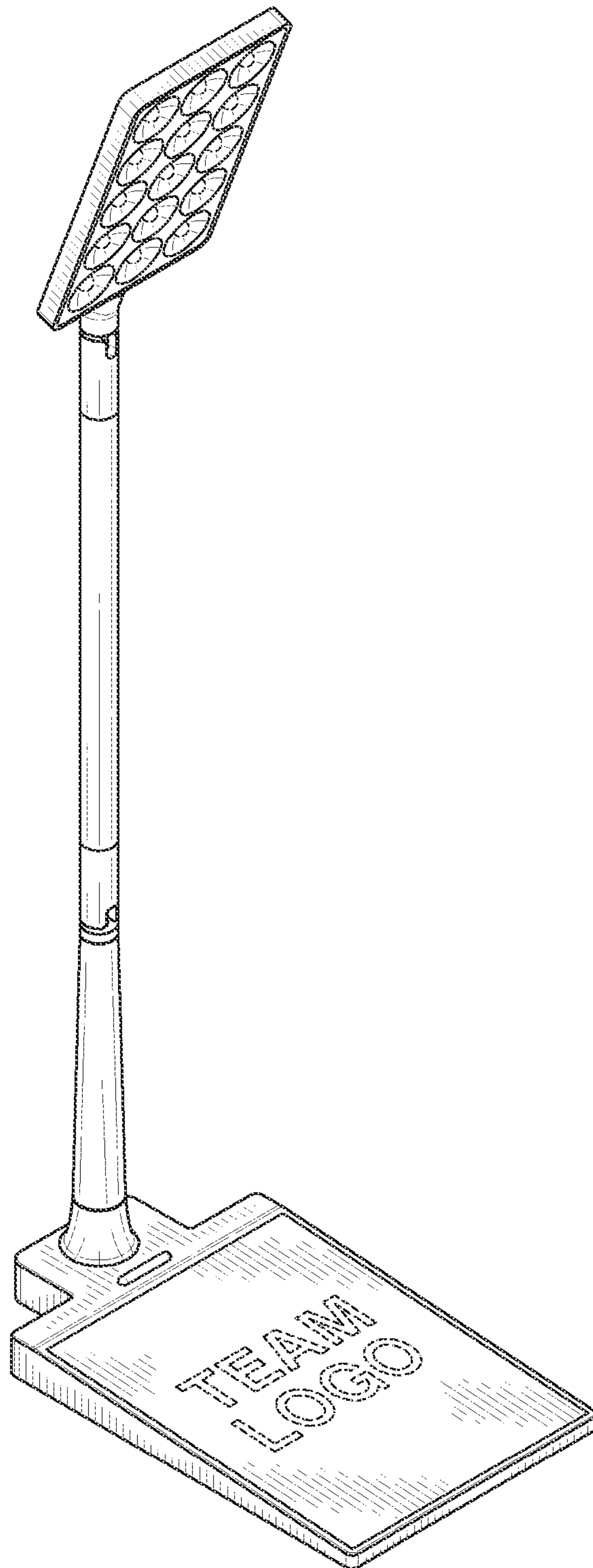

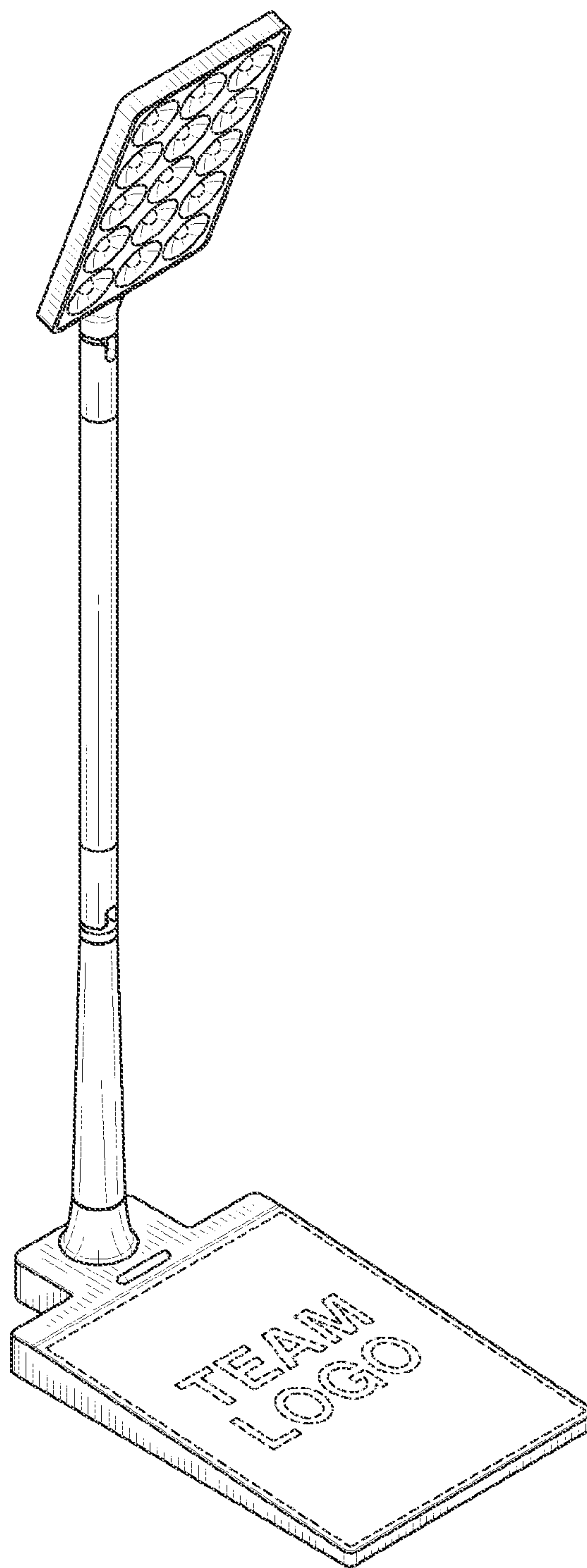

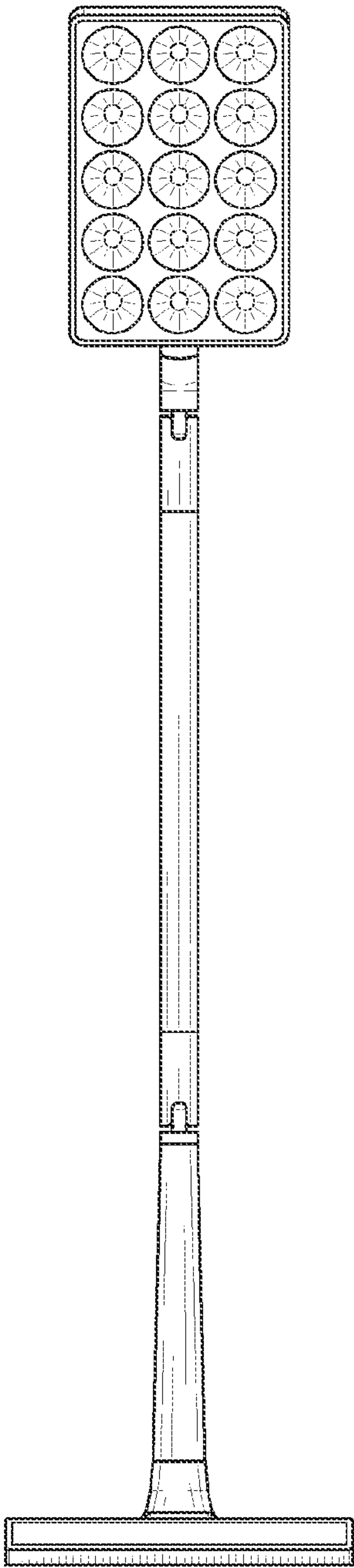

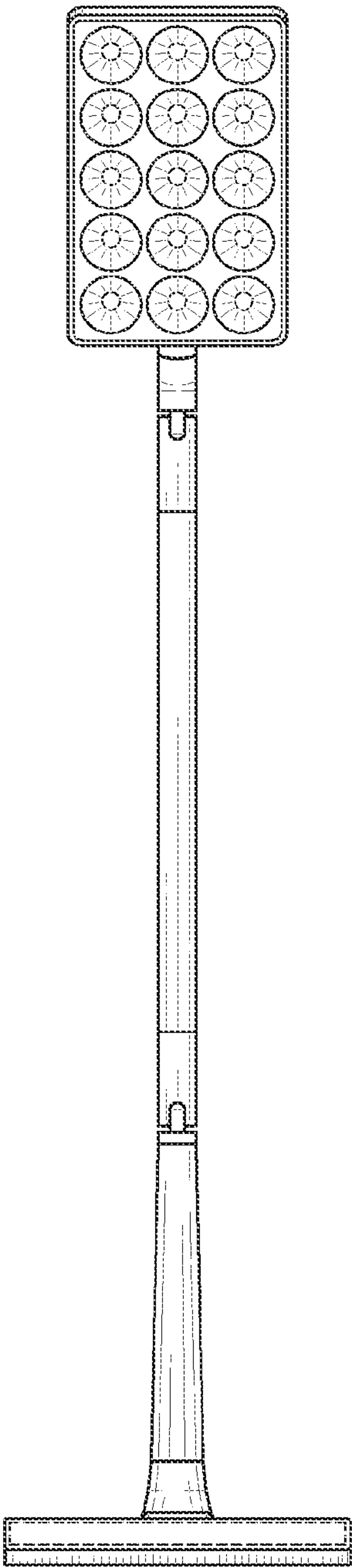

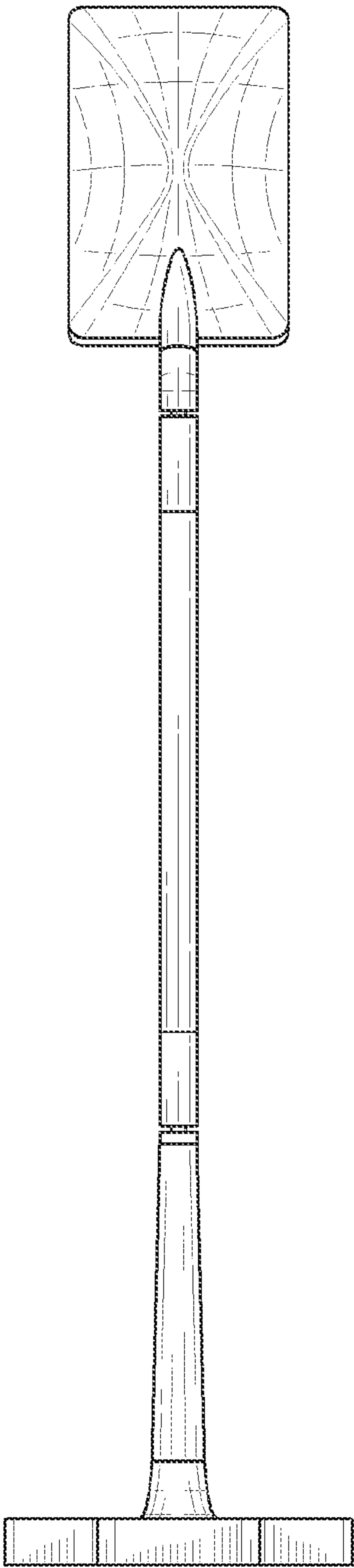

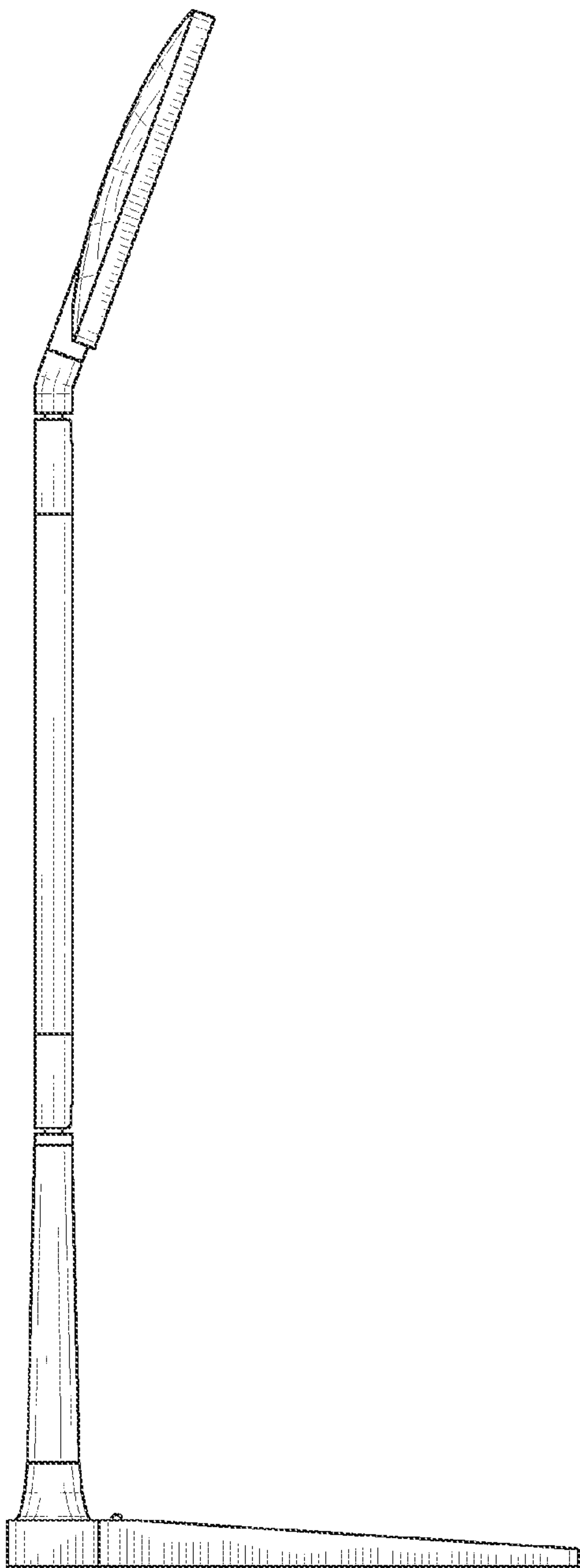

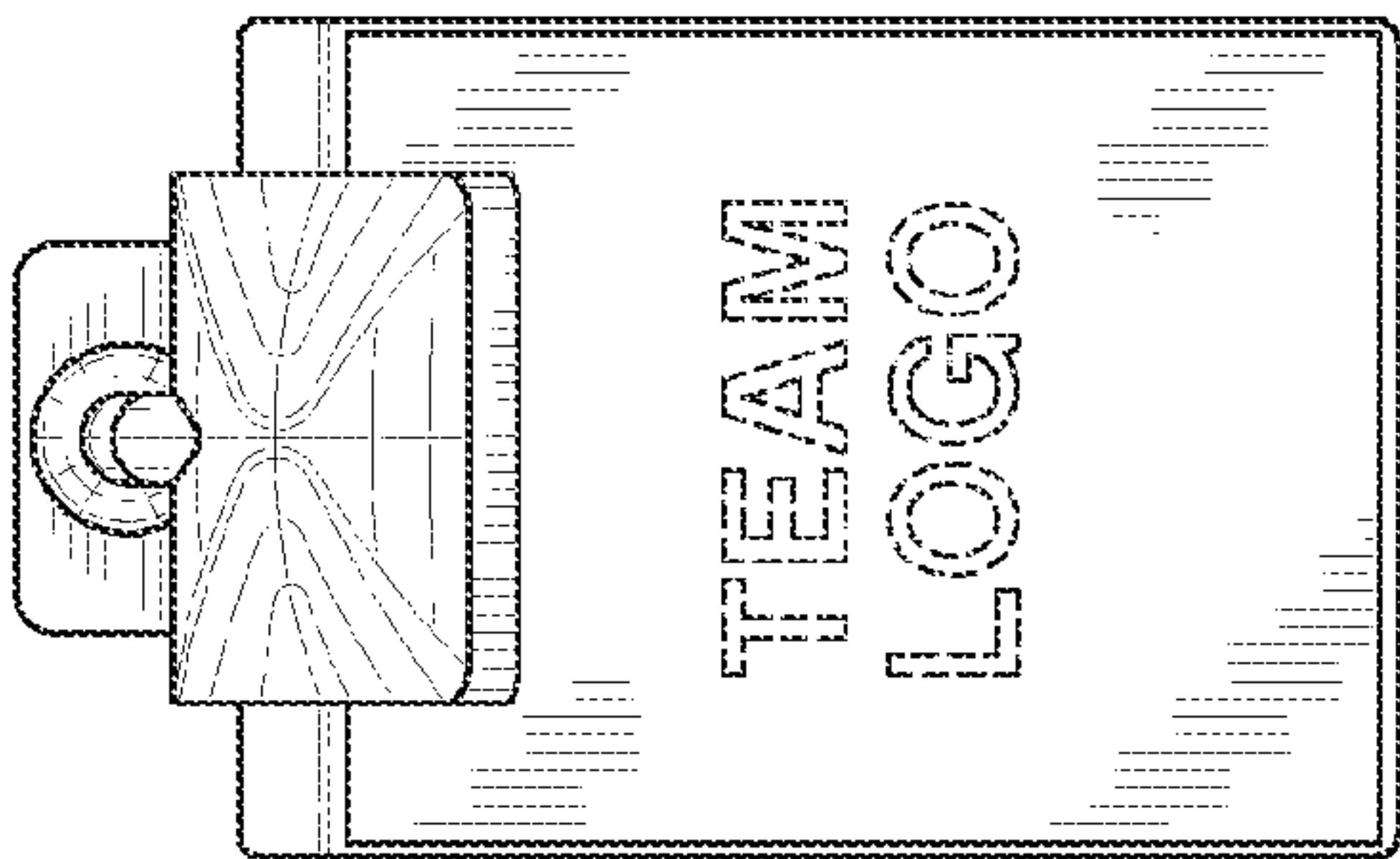

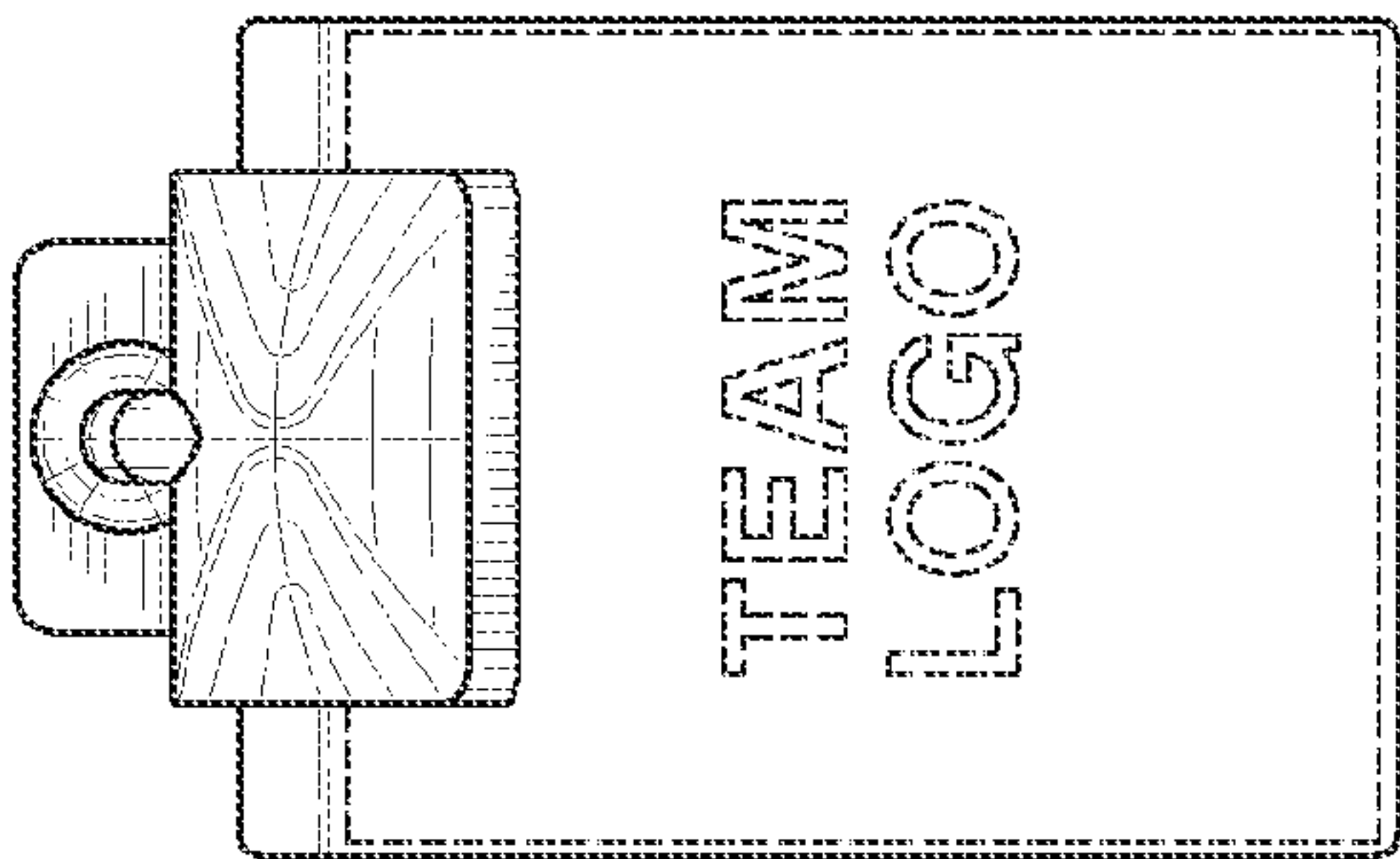

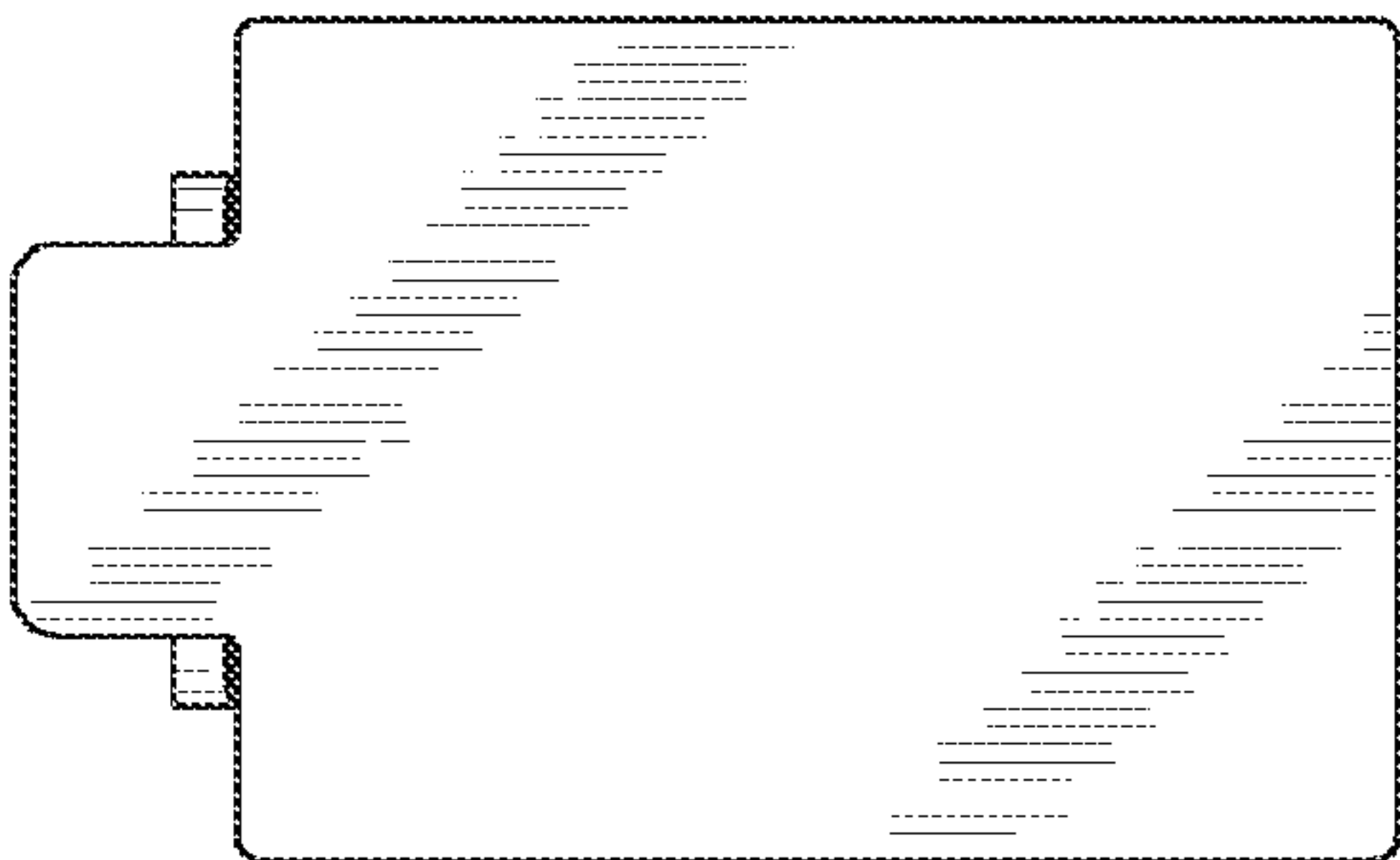

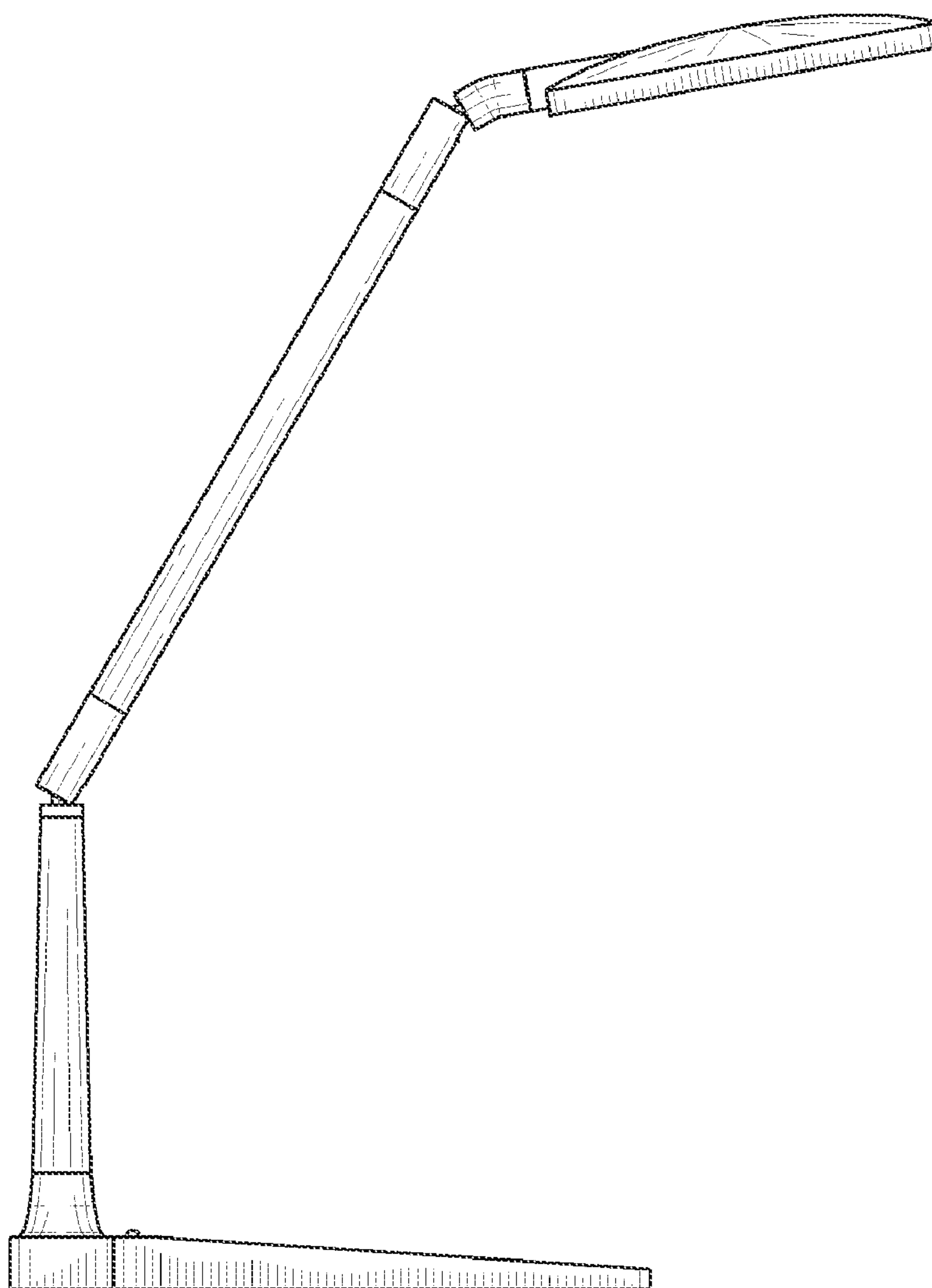
